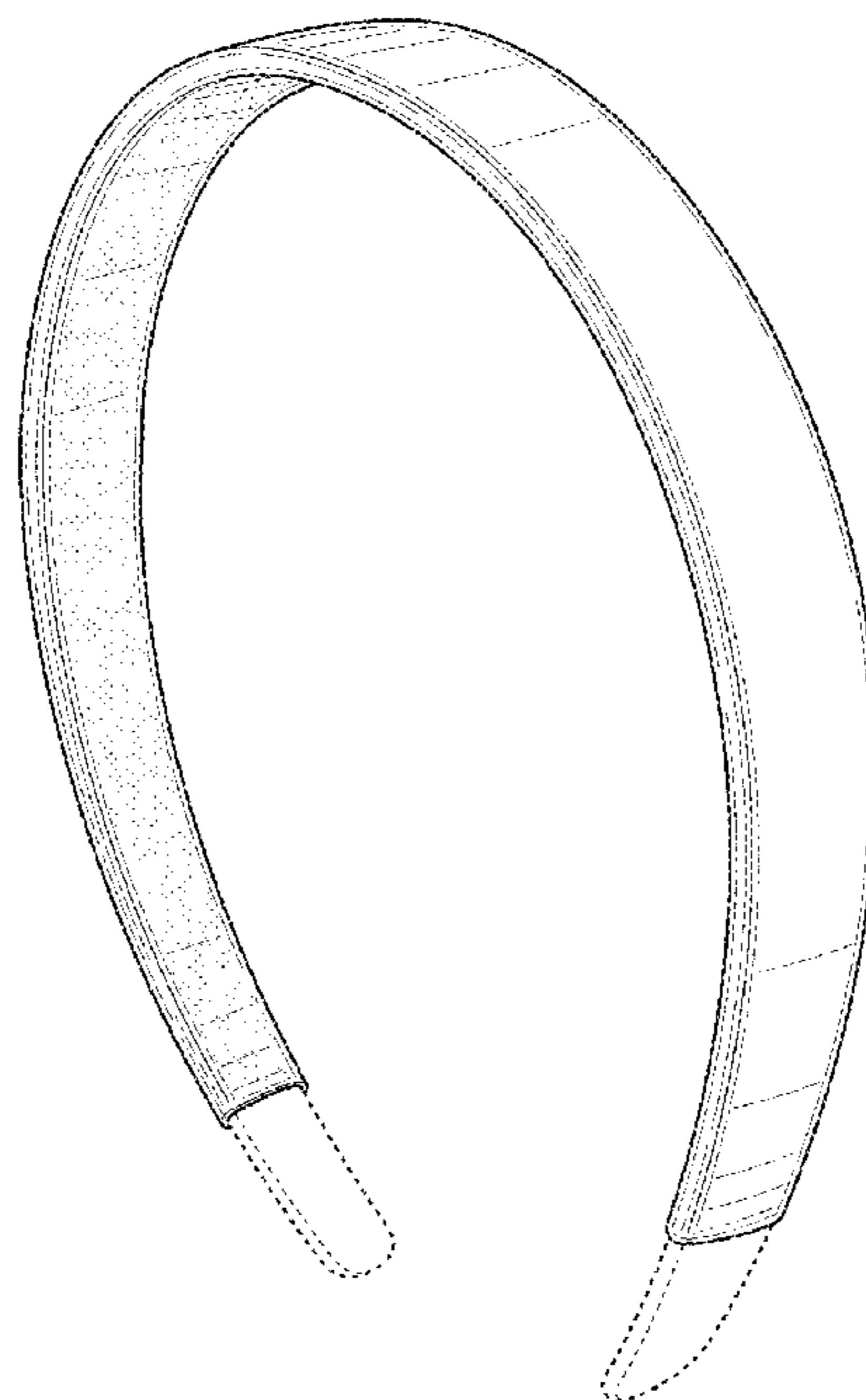
(57) **CLAIM**

The ornamental design for a reversible hair band cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the reversible hair band cover showing my new design;
 FIG. 2 is a front elevation view thereof;
 FIG. 3 is a rear elevation view thereof;
 FIG. 4 is a right elevation view thereof;
 FIG. 5 is a left elevation view thereof;
 FIG. 6 is a top plan view thereof; and

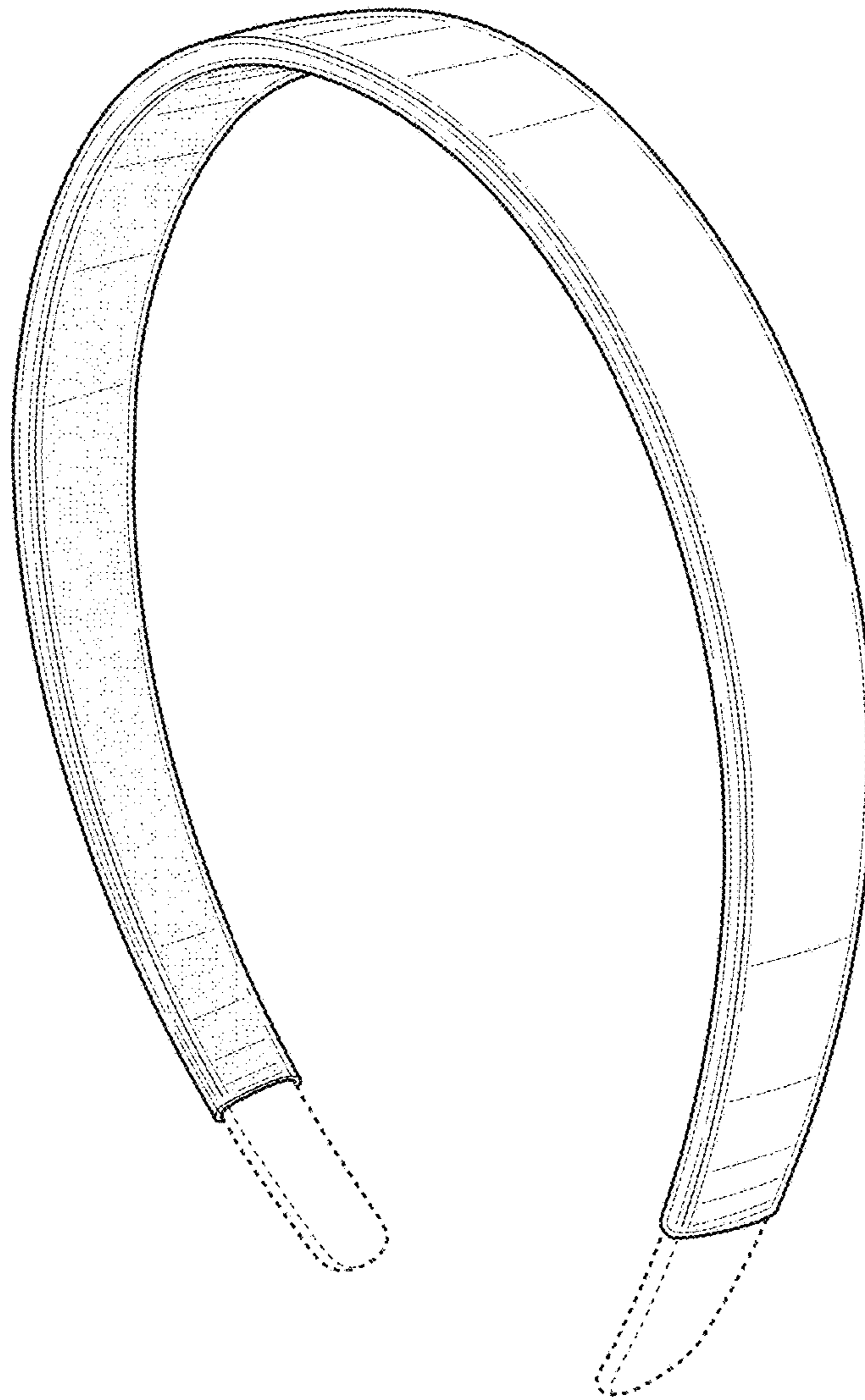

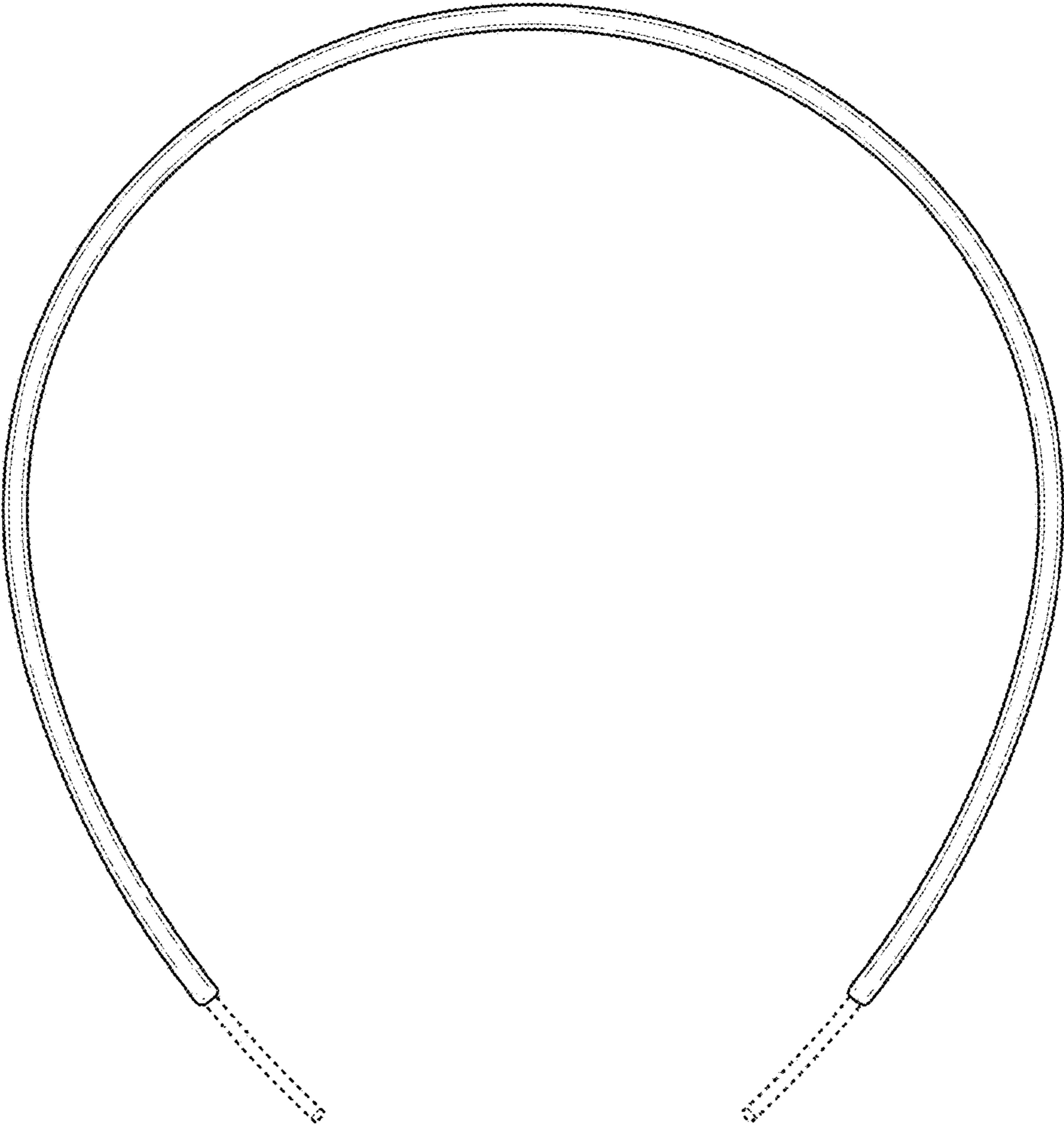

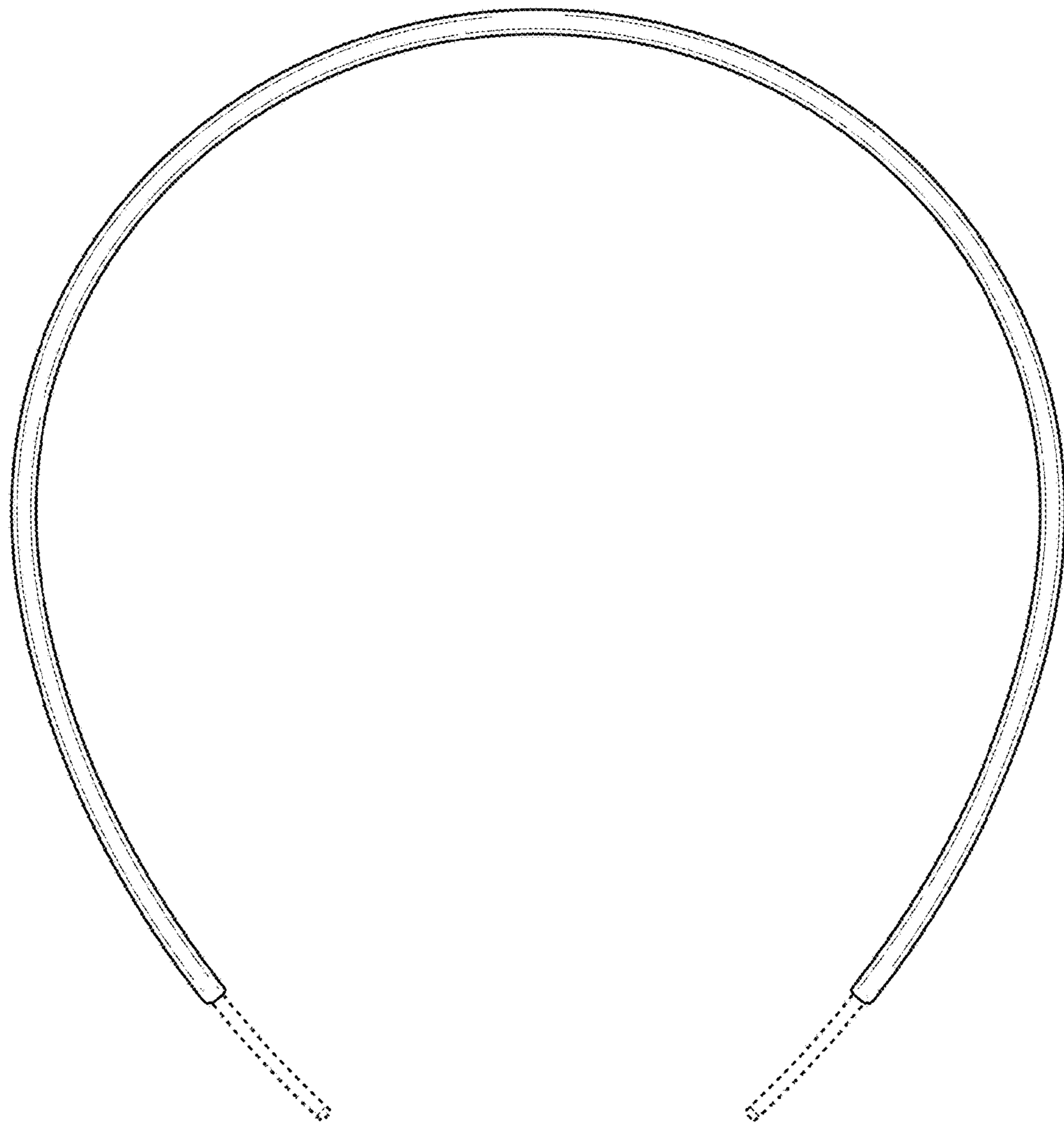

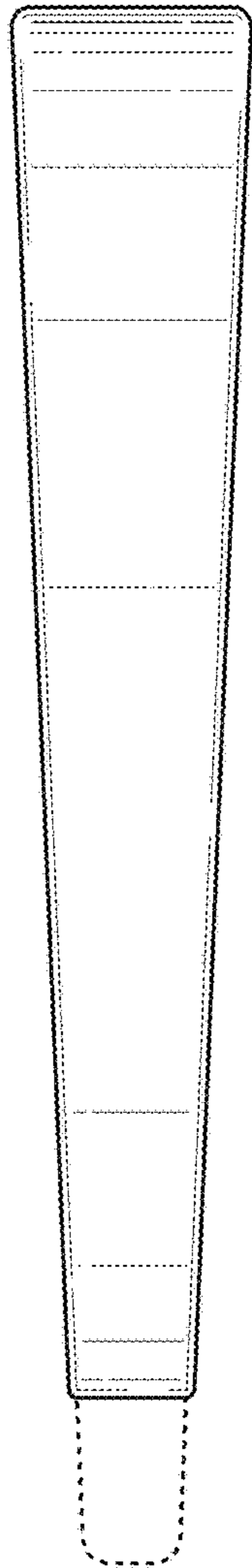

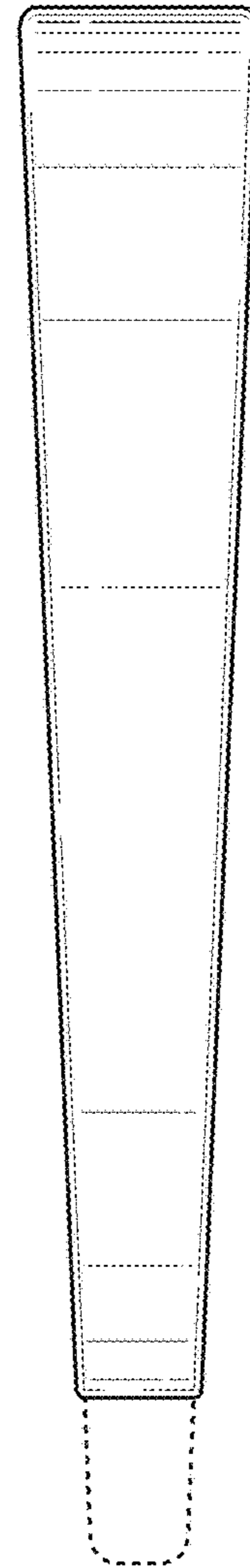

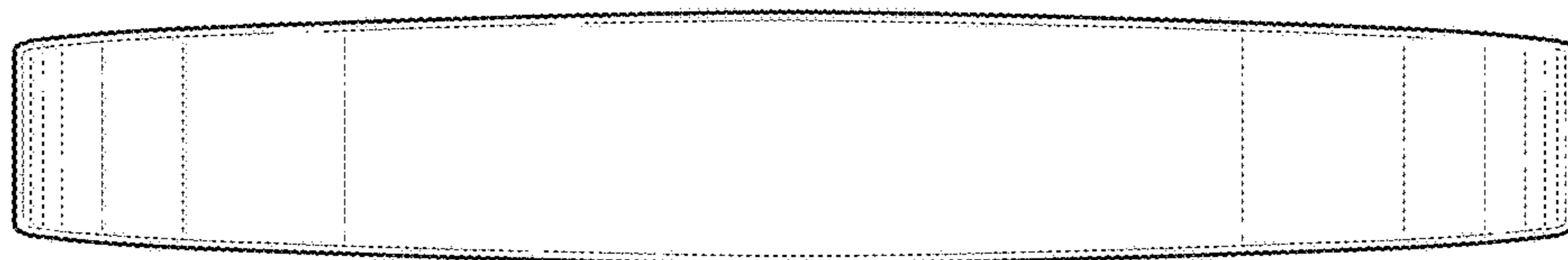

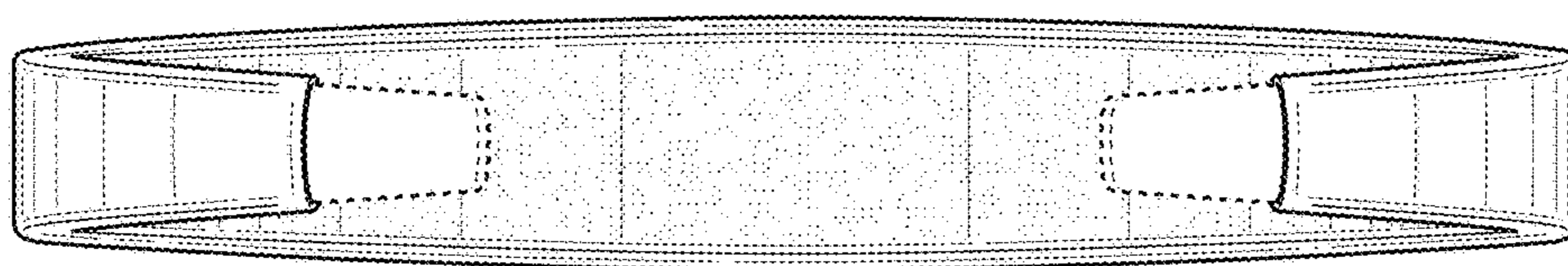

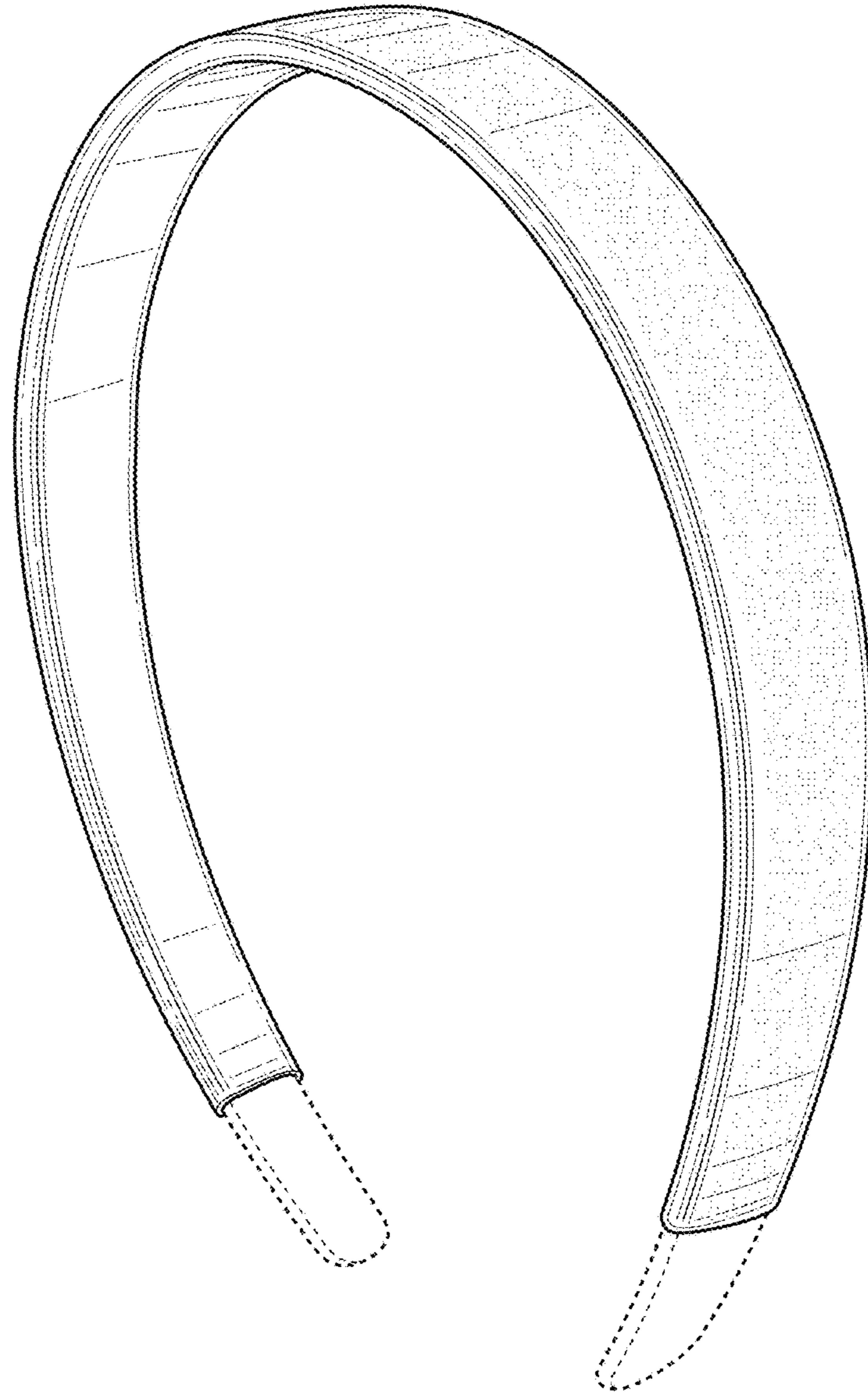
