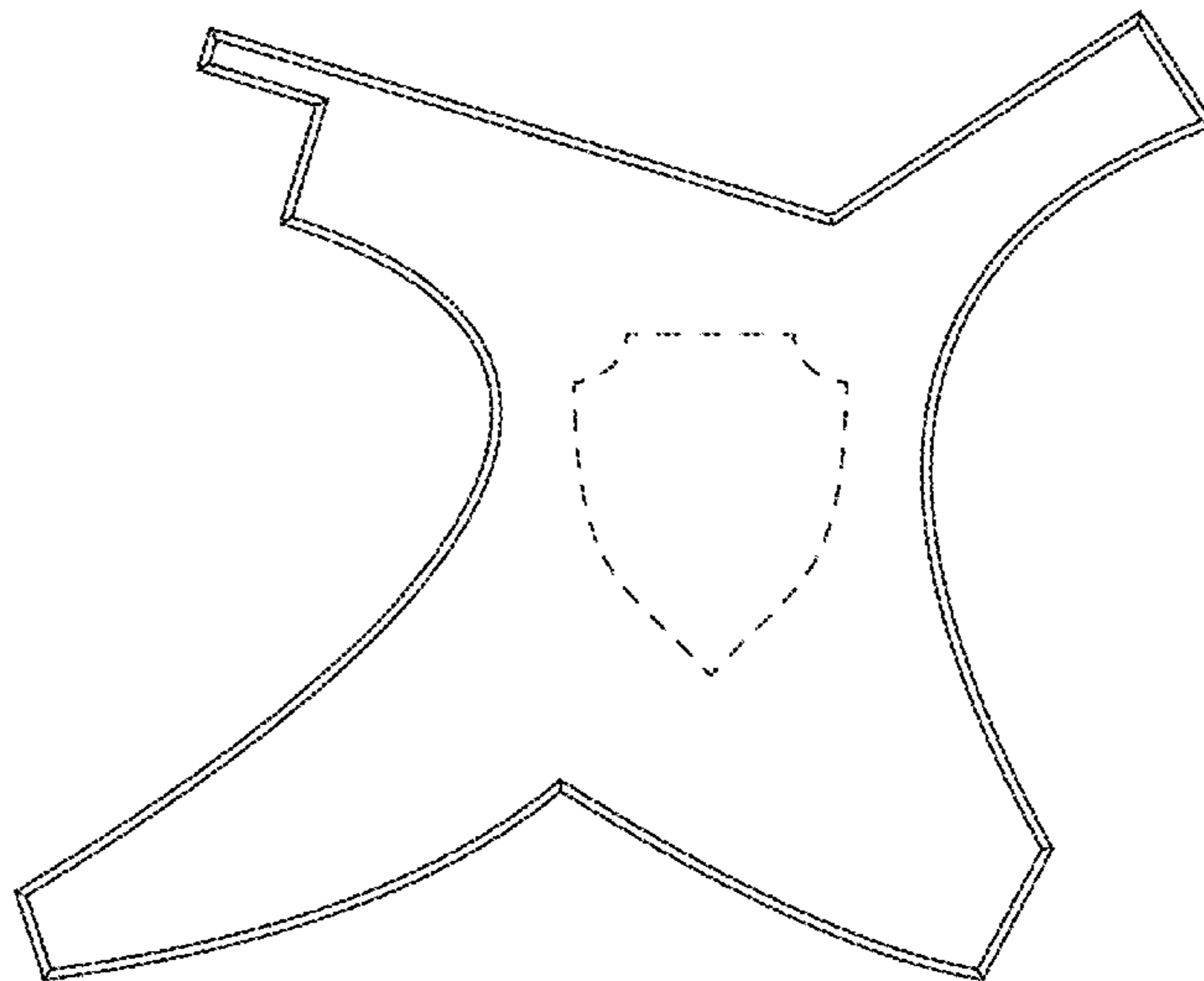
(57) **CLAIM**

What is claimed is the ornamental design for a facial hair trim guide, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a facial hair trim guide;
FIG. 2 is a left side view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a top view thereof; and,
FIG. 6 is a bottom view thereof.
The broken lines illustrate a portion of the facial hair trim guide and form no part of the claimed design.

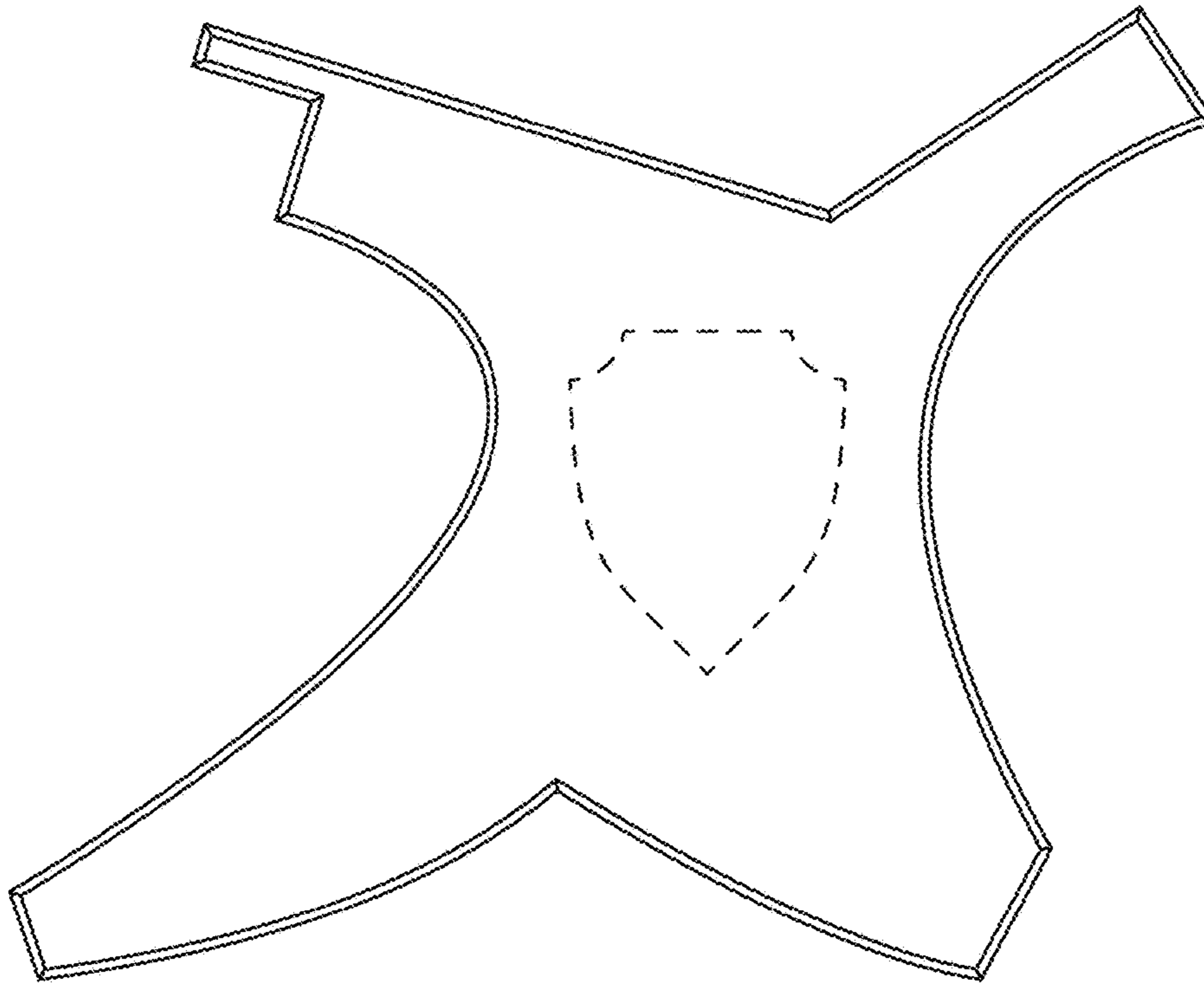

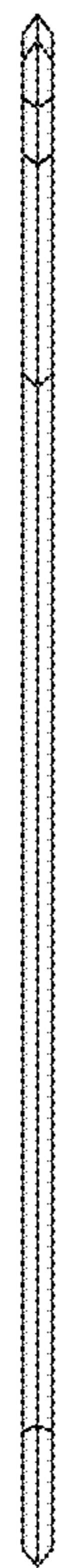
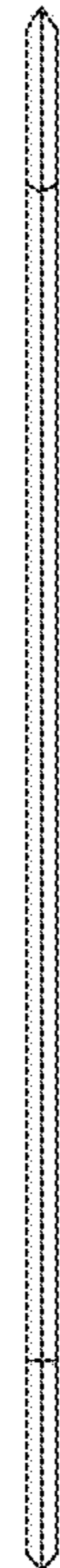

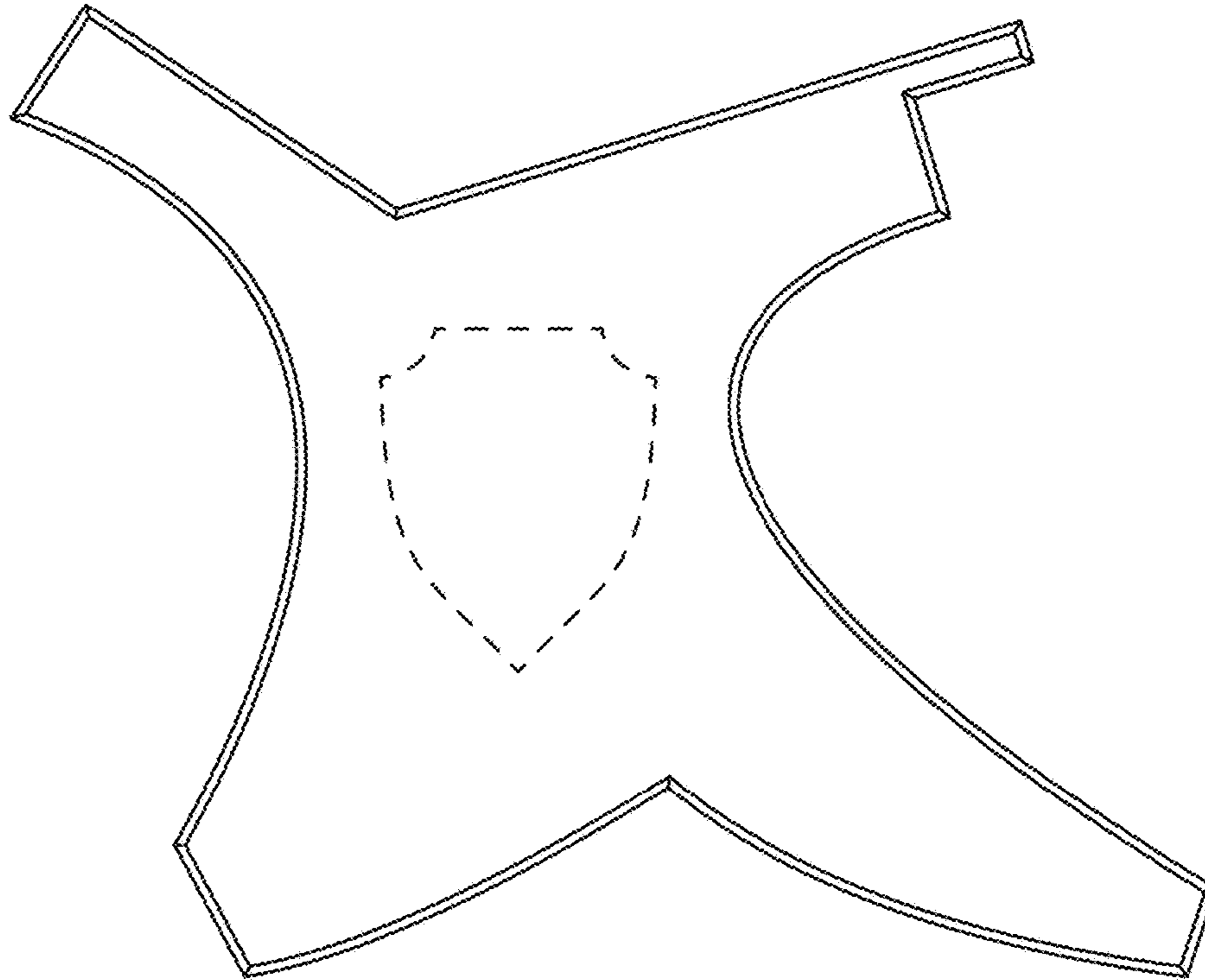

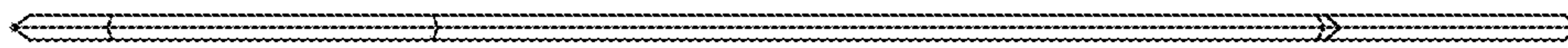

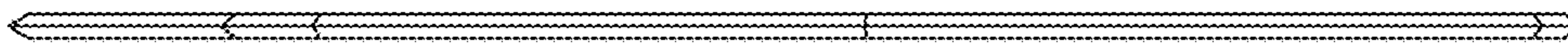
