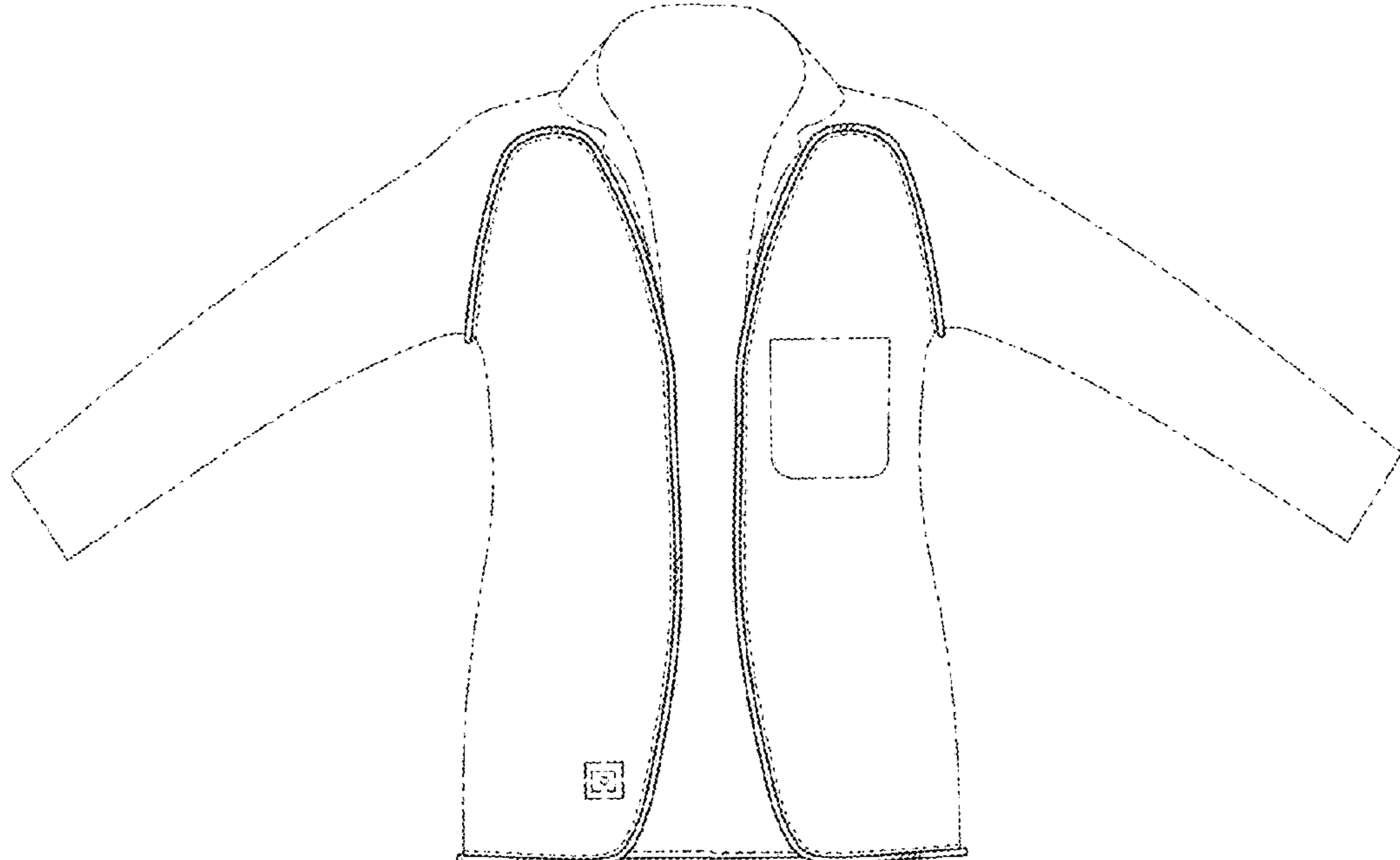
(57) **CLAIM**

The ornamental design for a safety jacket with luminous silhouette, as shown and described.

DESCRIPTION

FIG. 1 is a top view of a safety jacket with luminous silhouette, it being understood that only the luminous silhouette of the safety jacket with luminous silhouette is being claimed, according to the present invention;
 FIG. 2 is a front view of FIG. 1;
 FIG. 3 is a rear view of FIG. 1;
 FIG. 4 is a bottom view of FIG. 1;
 FIG. 5 is a first side view of FIG. 1; and,
 FIG. 6 is a second side view of FIG. 1.
 The dashed broken lines illustrate environmental structure and form no part of the claimed design.

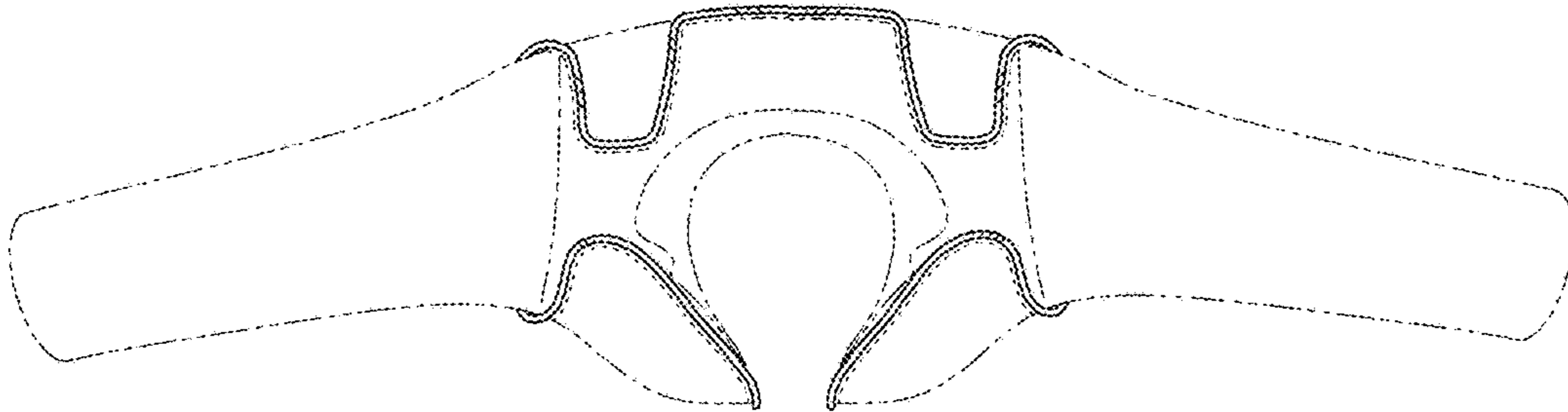

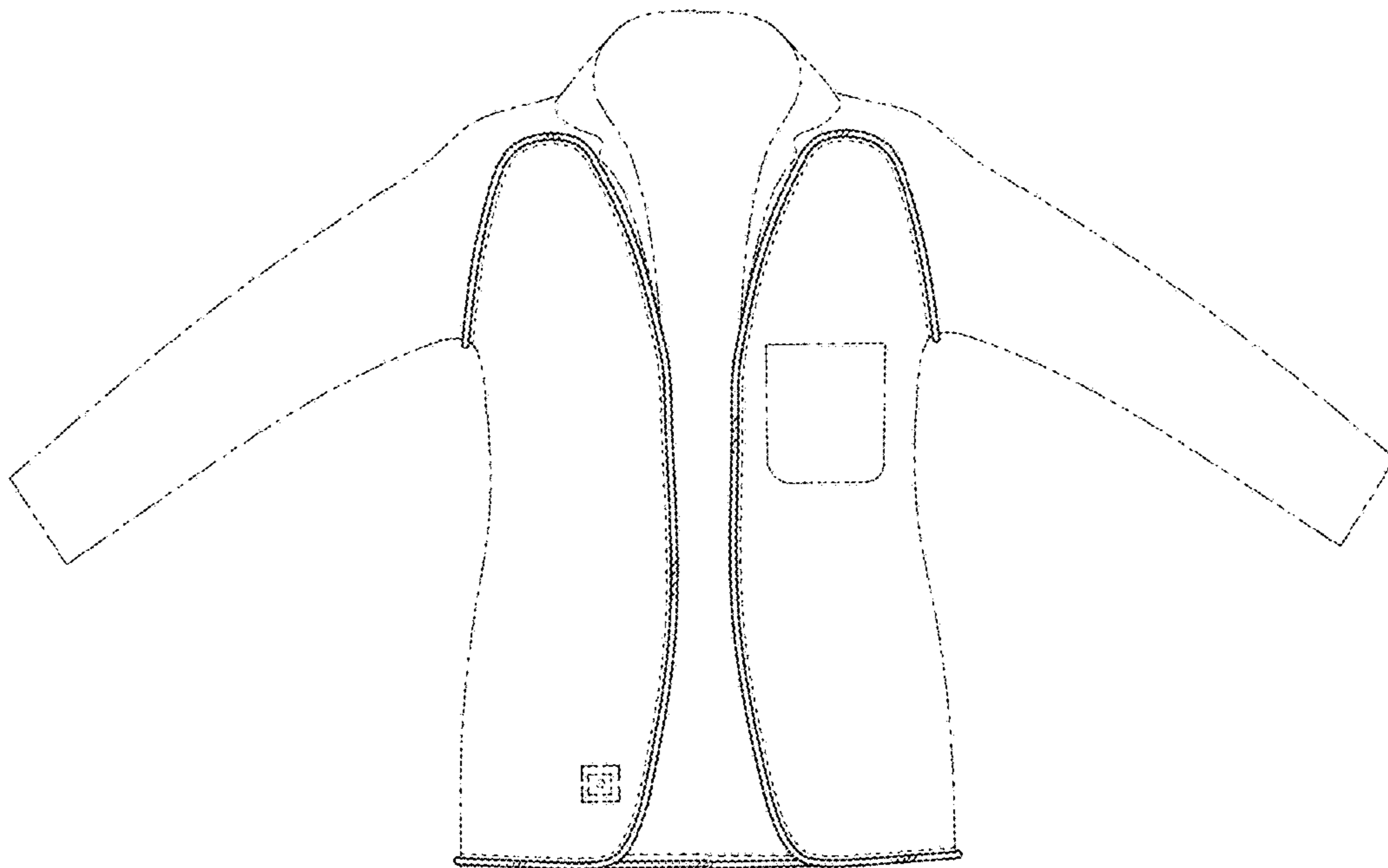

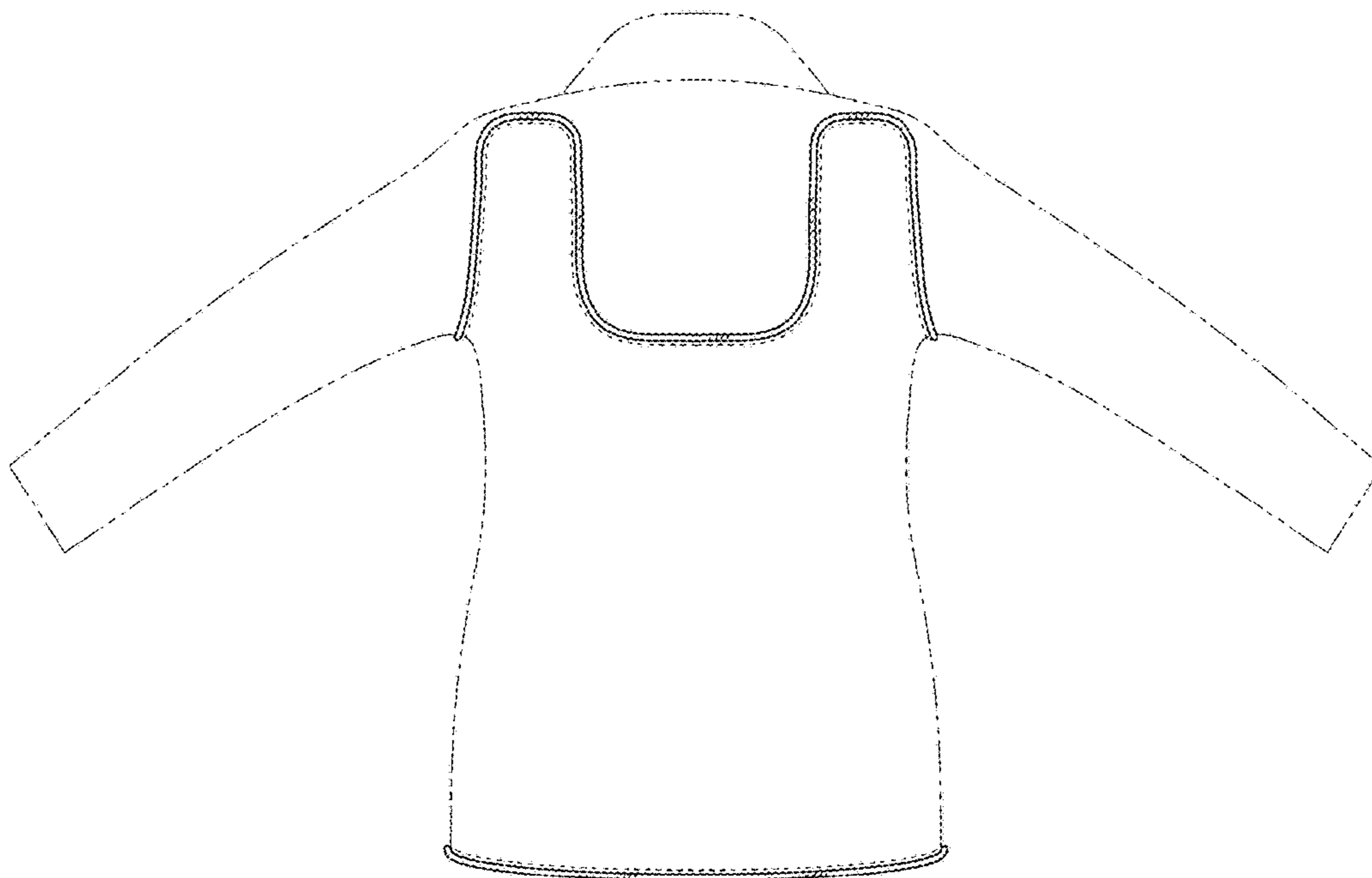

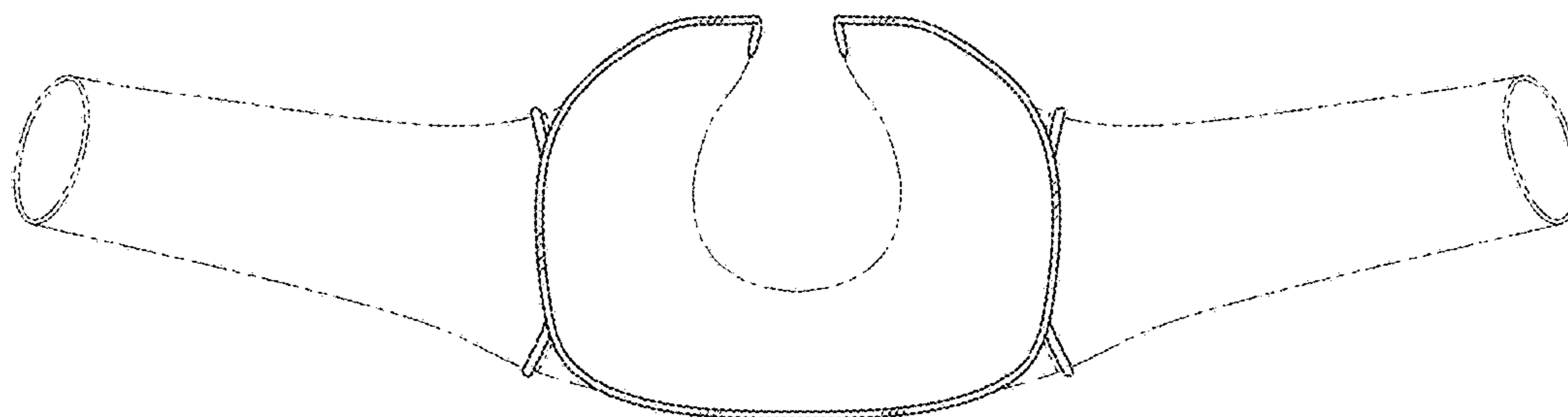

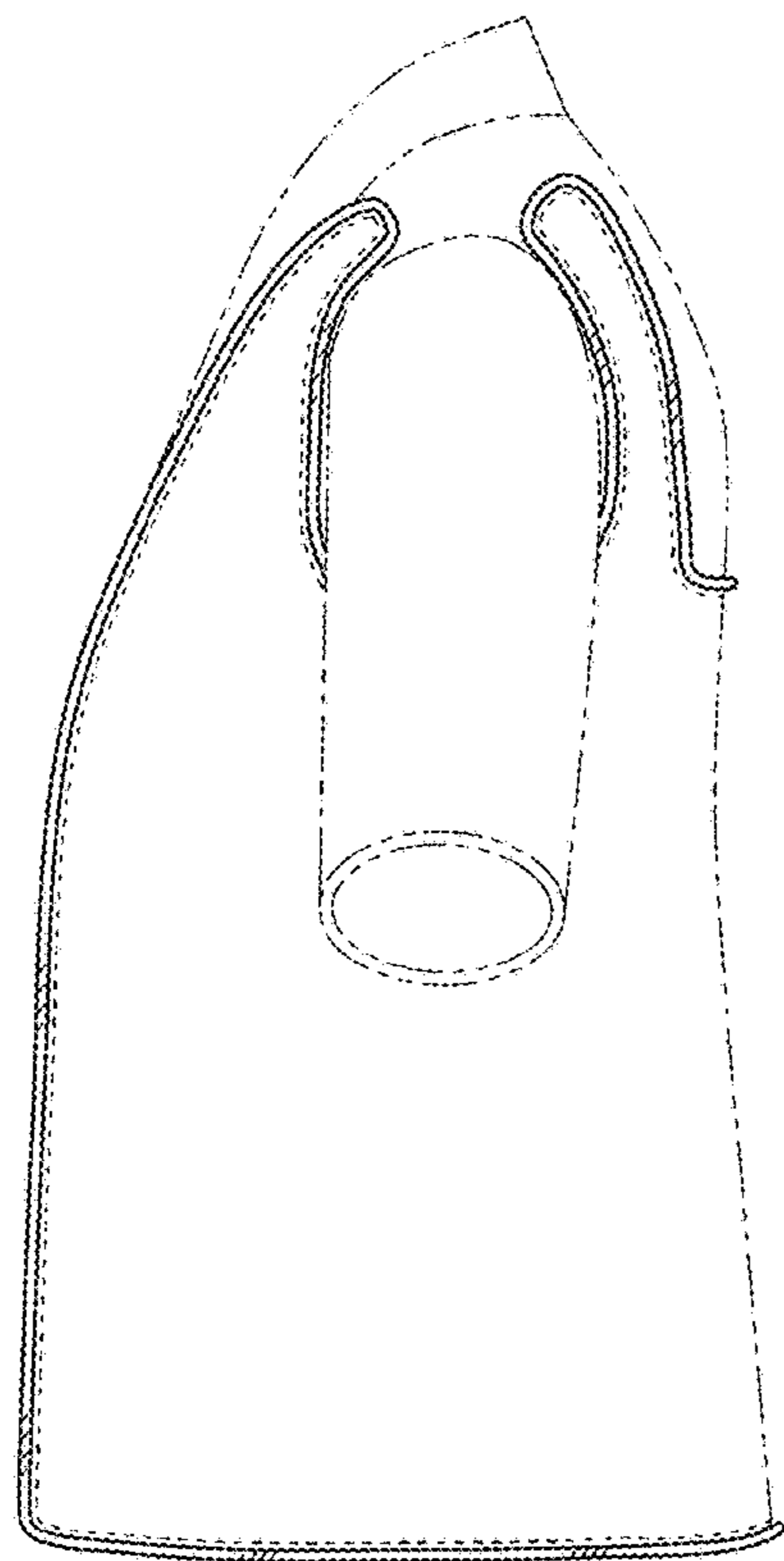

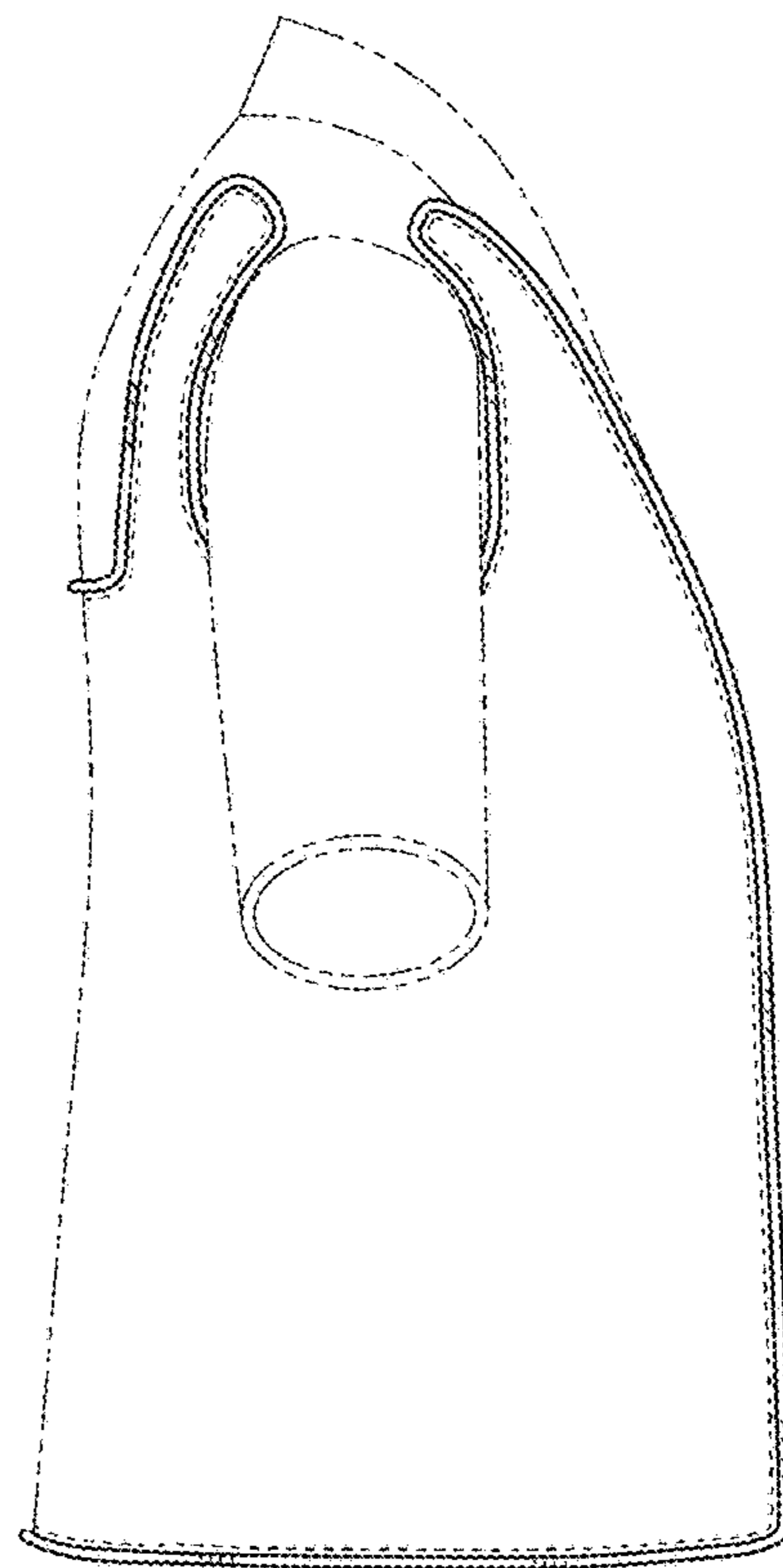
