(57) **CLAIM**

We claim the ornamental design for a pet feeder mat, as  
shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view showing our design of the pet  
feeder mat.

FIG. 2 is a top view thereof.

FIG. 3 is the bottom view thereof.

FIG. 4 is a right side sectional view thereof.

FIG. 5 is a left side sectional view thereof.

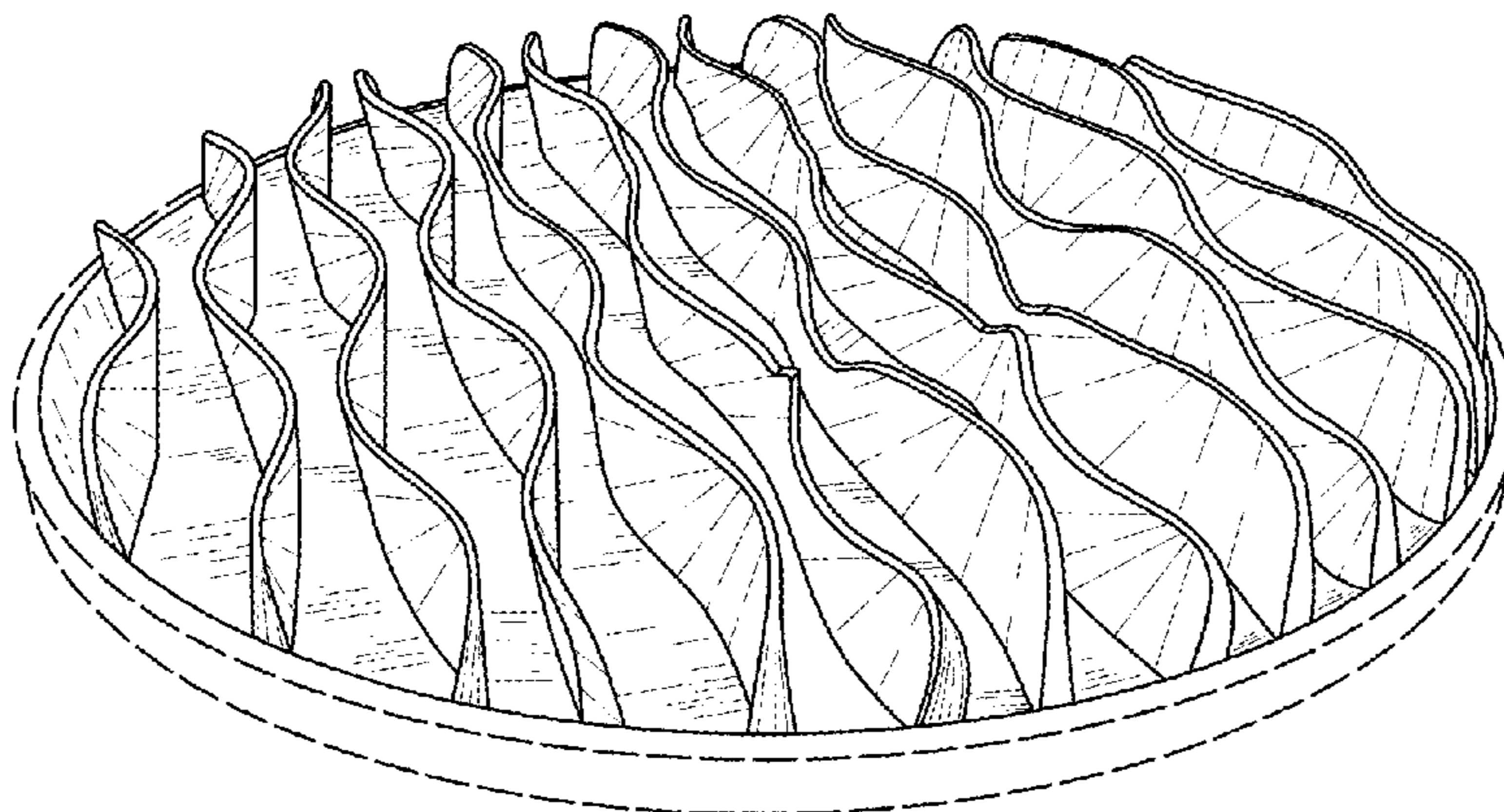
FIG. 6 is a front sectional view thereof; and,

FIG. 7 is a rear sectional view thereof.

The broken lines depict features of the pet feeder mat that  
form no part of the claimed design, but are shown for  
purposes of illustration.

This design invention relates to a flexible silicone pet feeder  
mat which is shaped with ridges and channels so that an  
animal eats slowly, and wherein the mat is easily trans-  
ported, stored and cleaned.

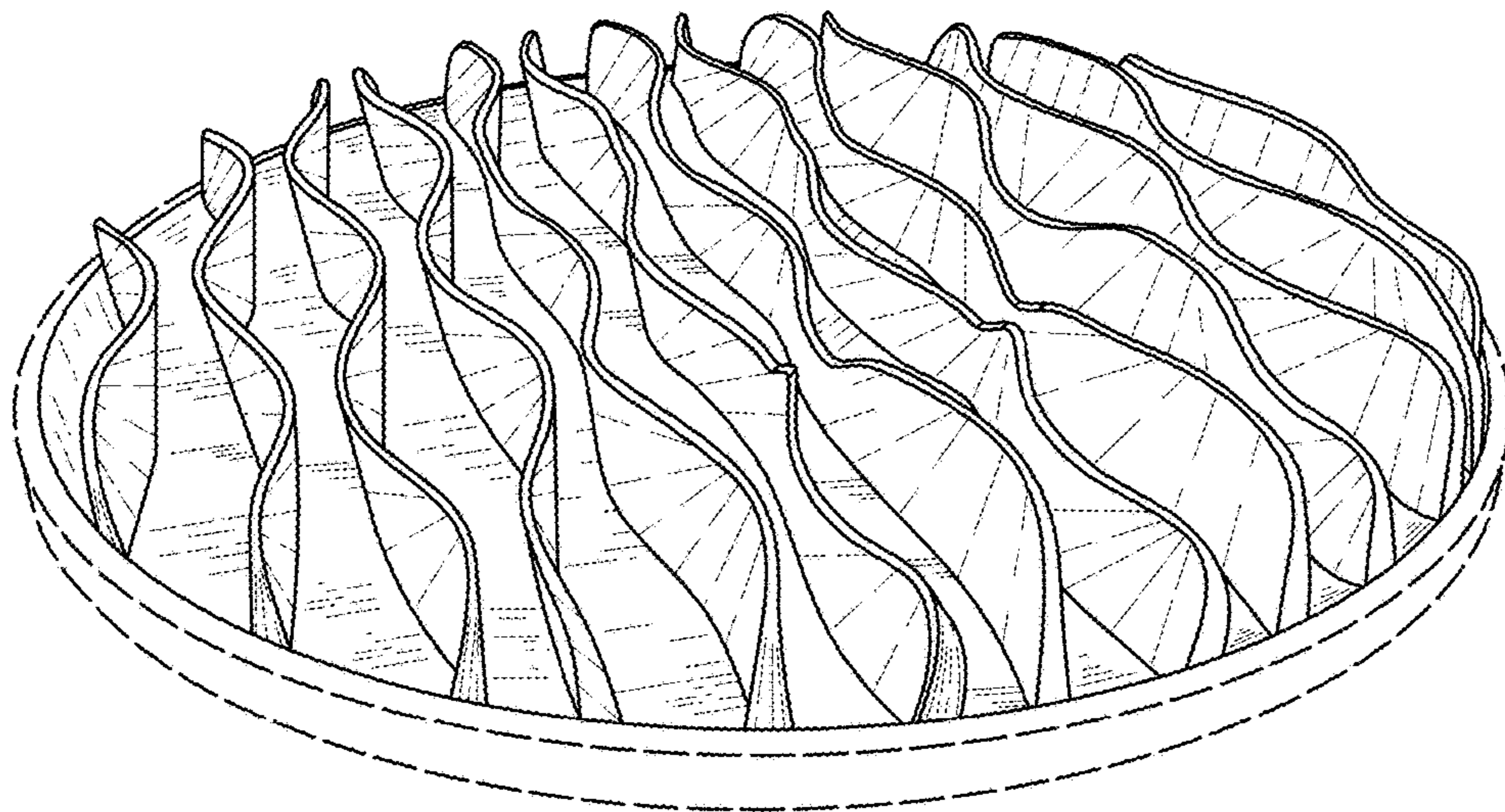

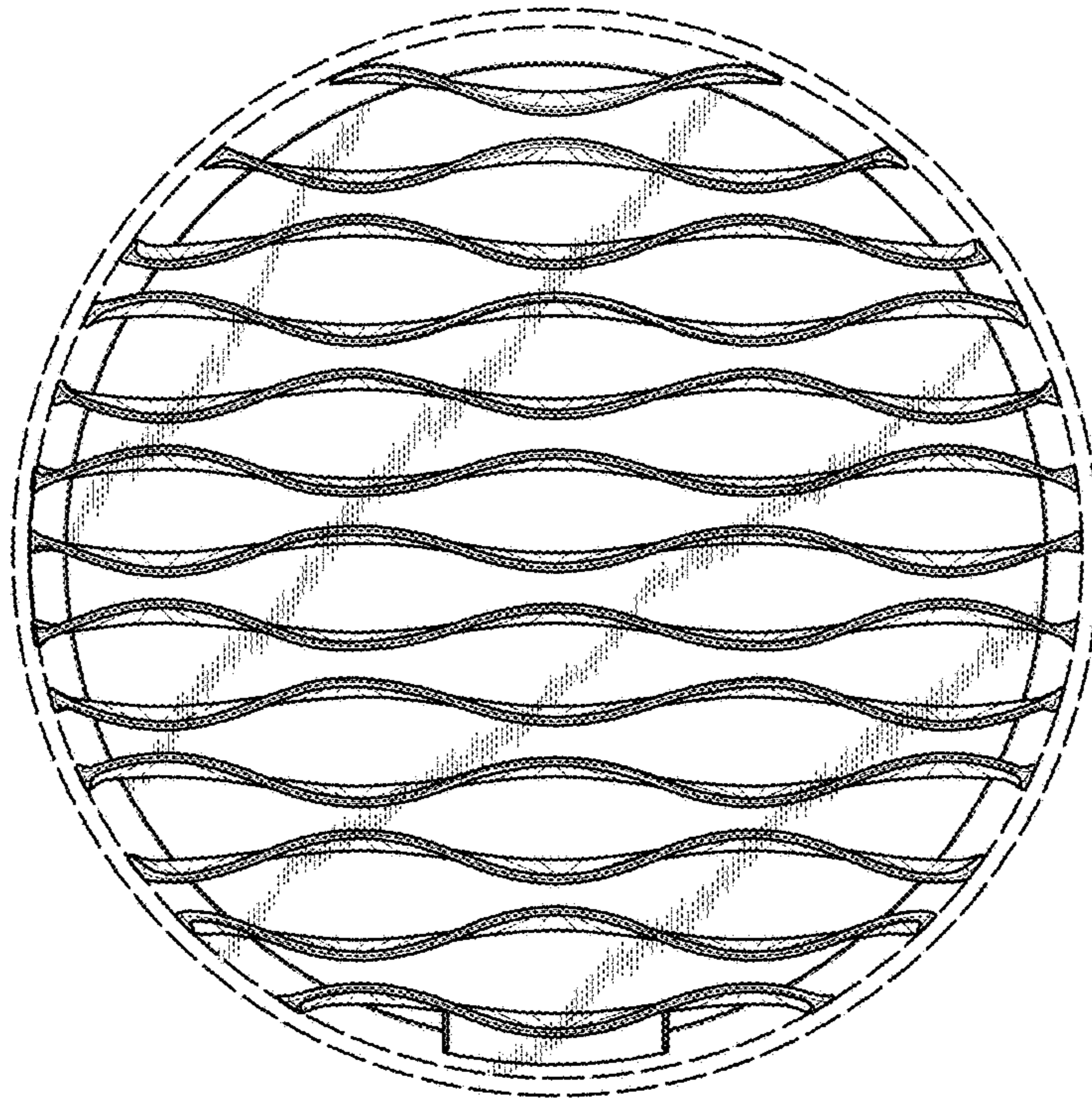

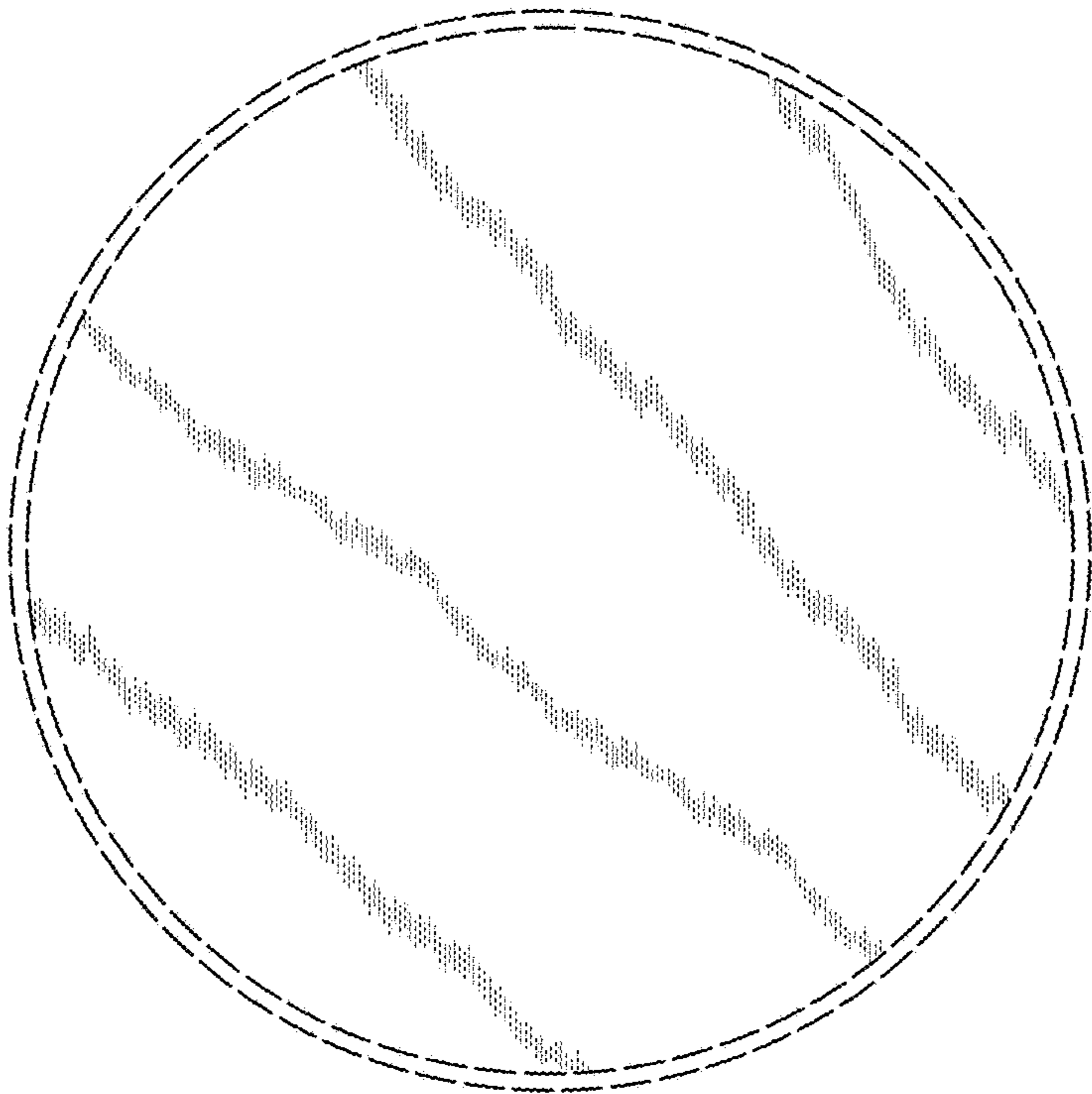

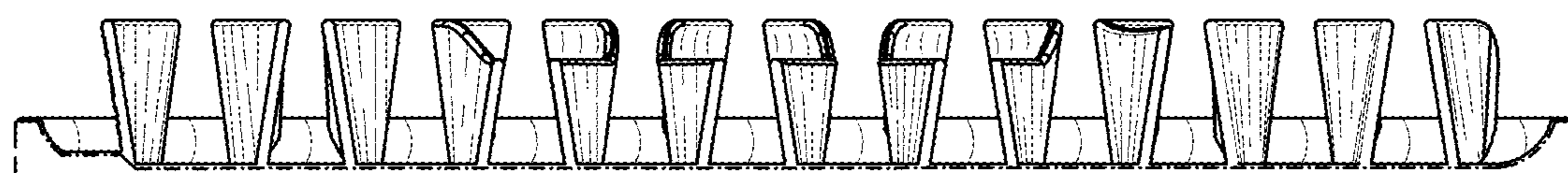

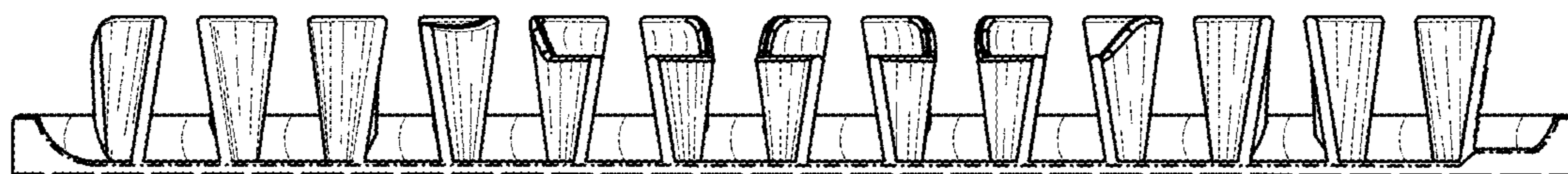

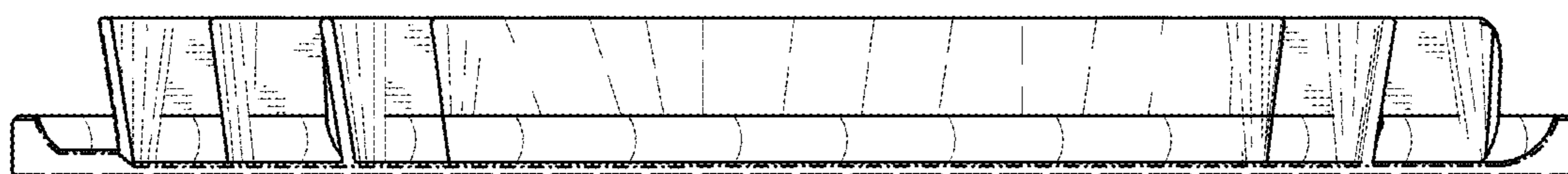

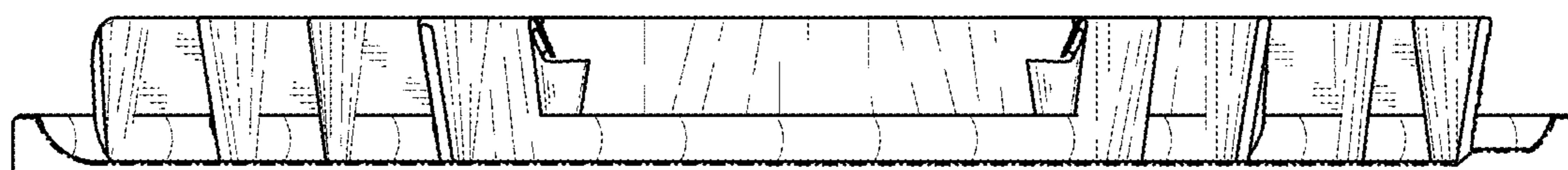
