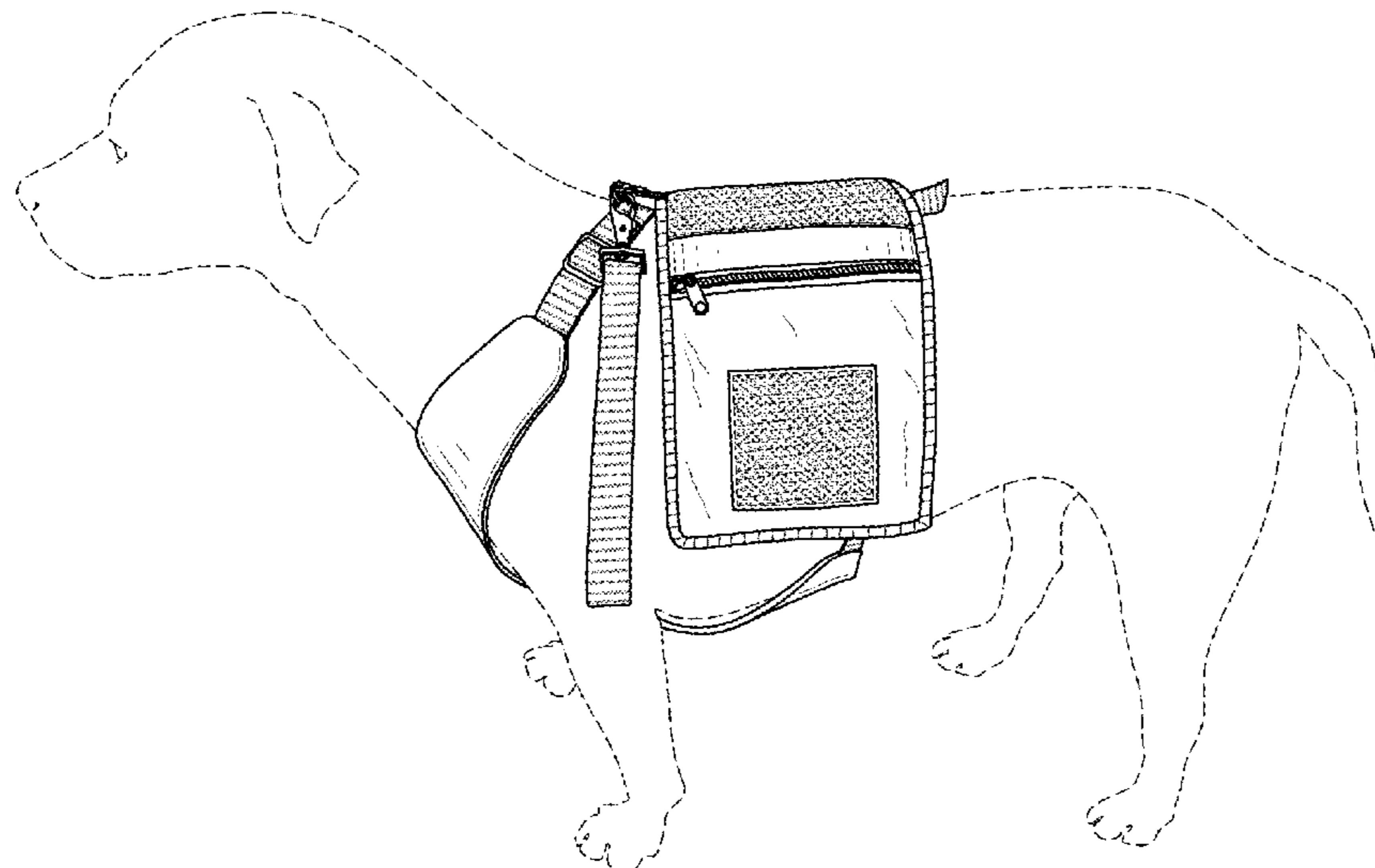
(57) **CLAIM**

The ornamental design for a dog harness, as shown and described.

DESCRIPTION

FIG. 1 is a top left perspective view of a dog harness, showing my new design in condition of use; FIG. 2 is a top plan view of the dog harness of FIG. 1; FIG. 3 is a bottom plan view thereof; FIG. 4 is a front elevation view thereof; FIG. 5 is a rear elevation view thereof; FIG. 6 is a left elevation view thereof; and, FIG. 7 is a right elevation view thereof. The broken lines showing a dog in FIG. 1 depict environmental subject matter and form no part of the claimed design.

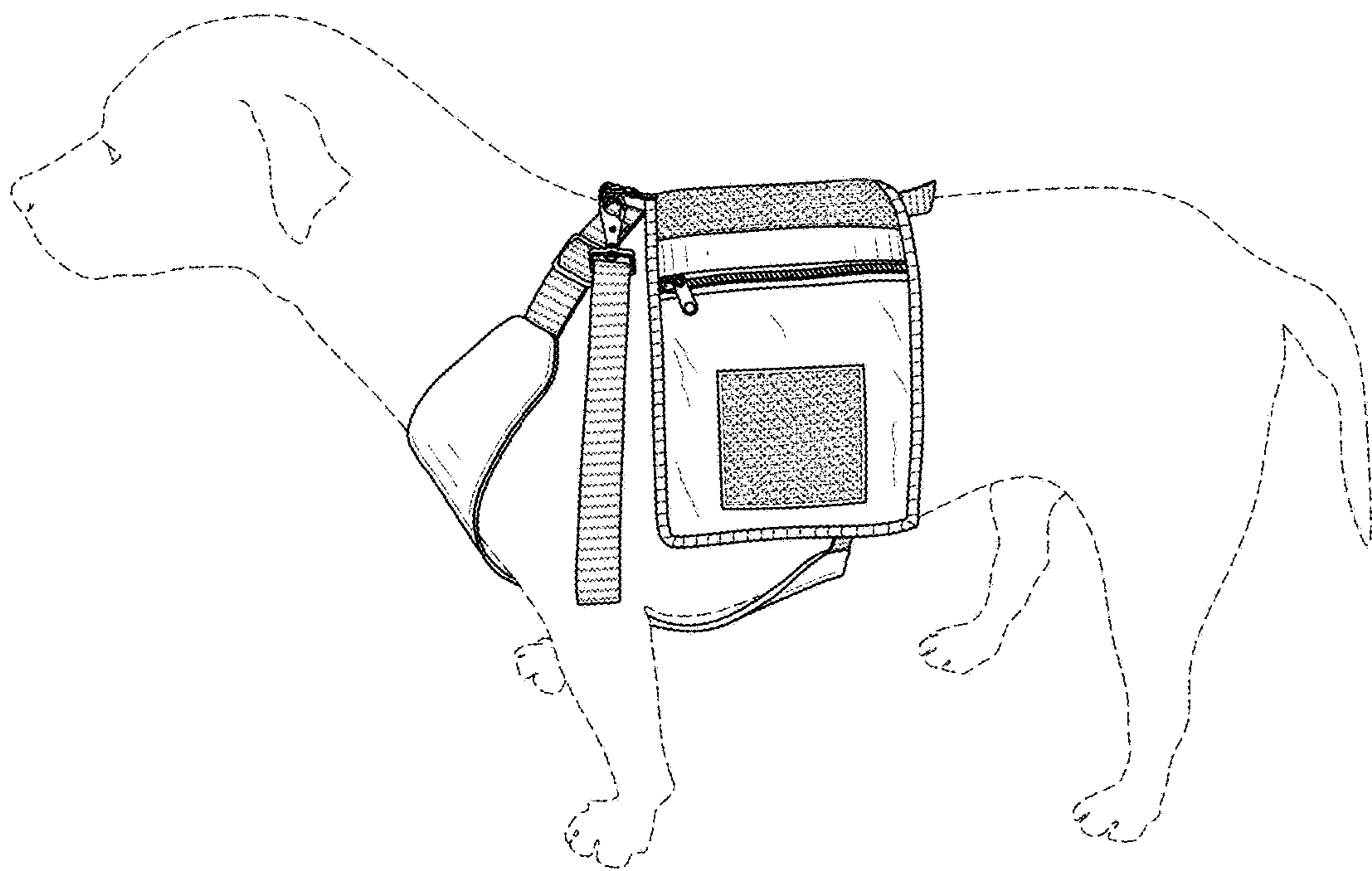

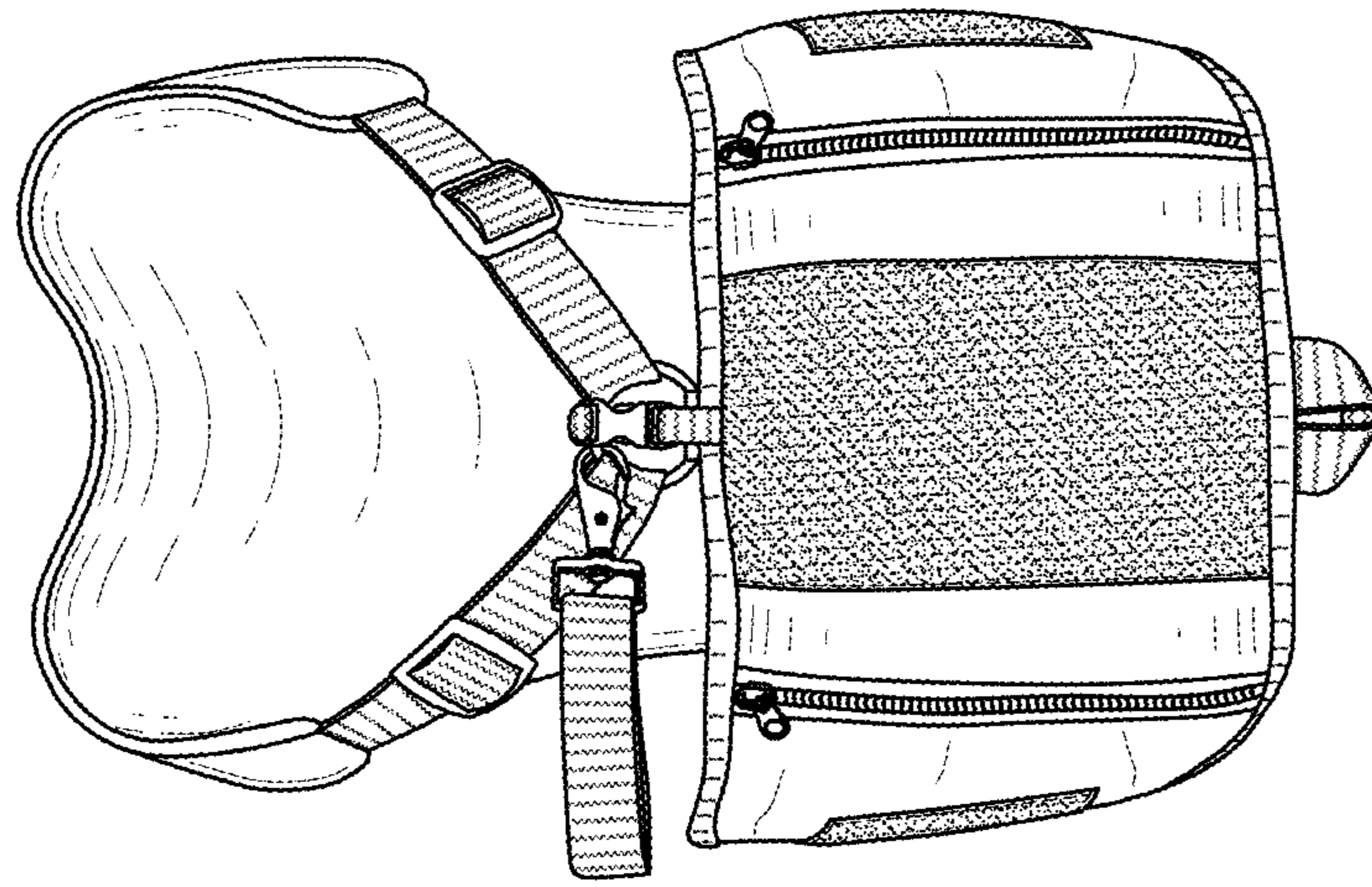

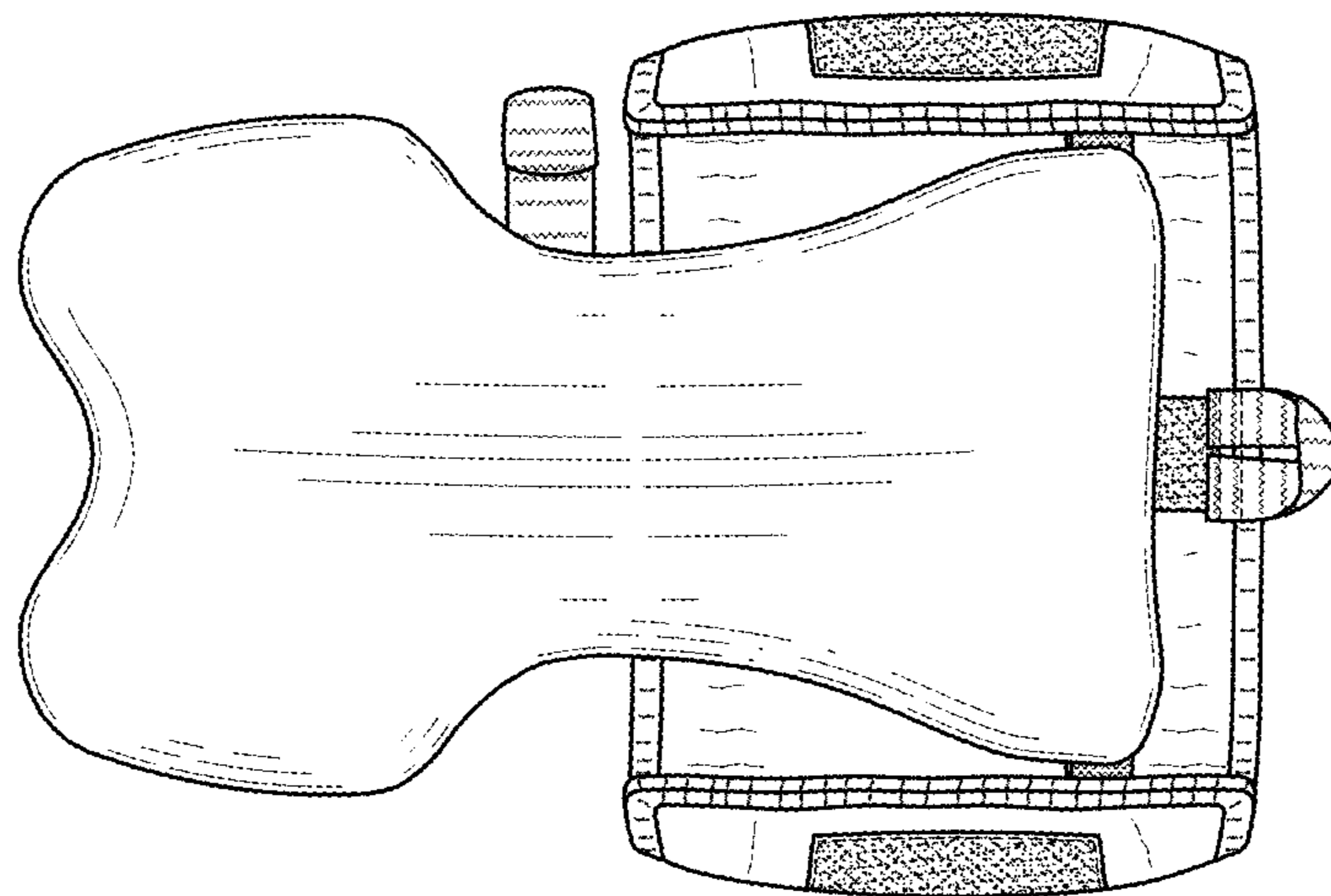

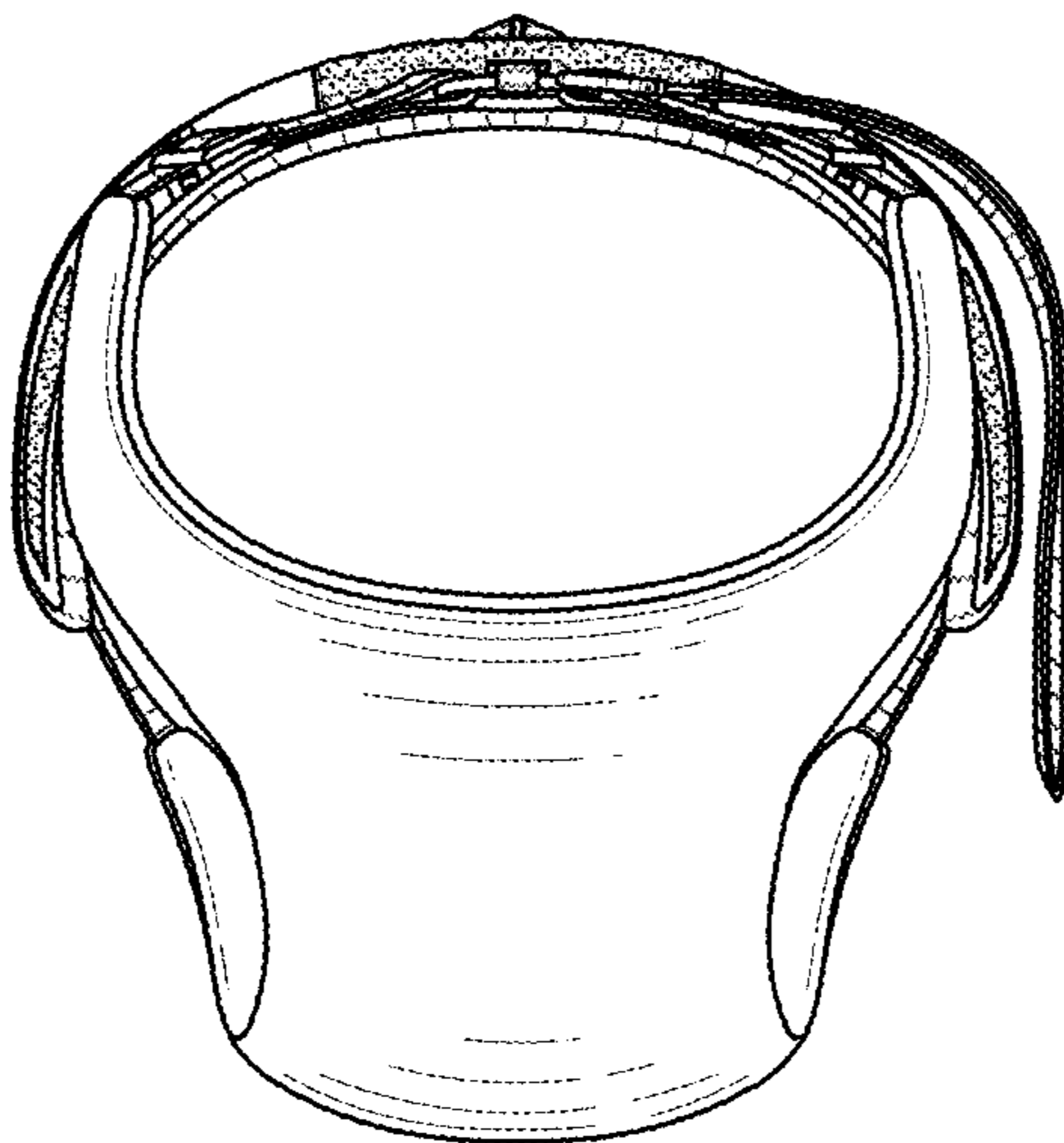

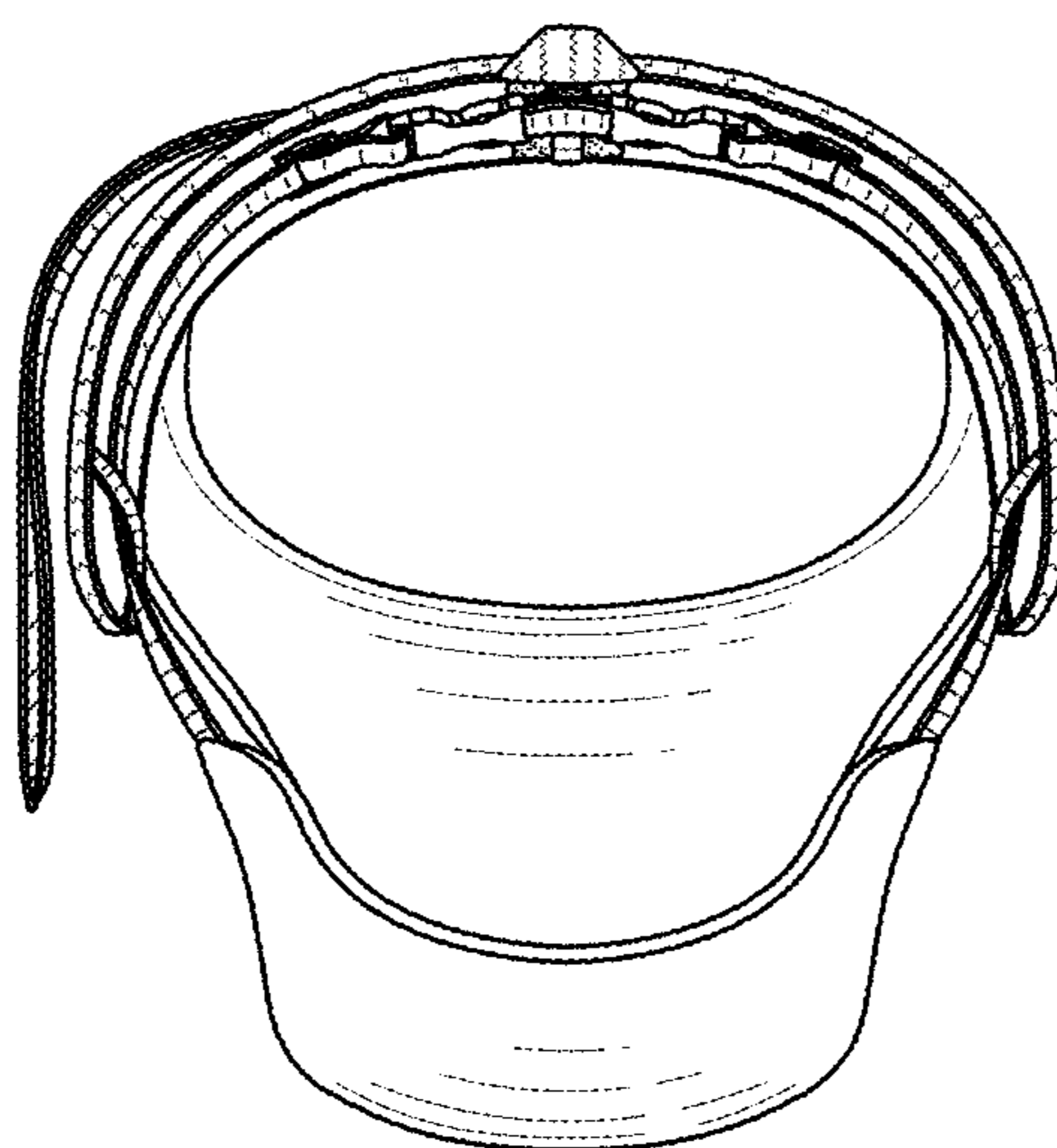

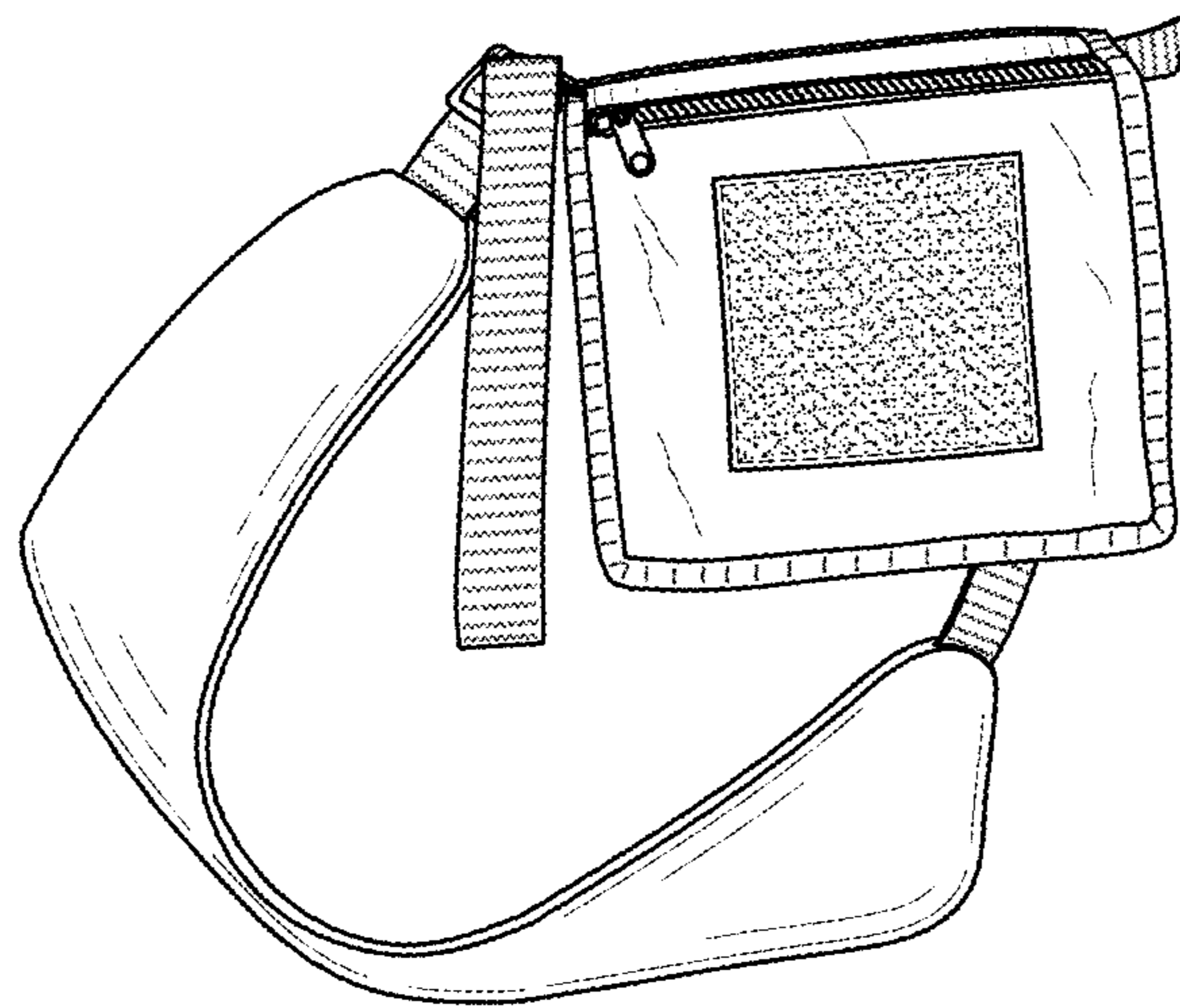

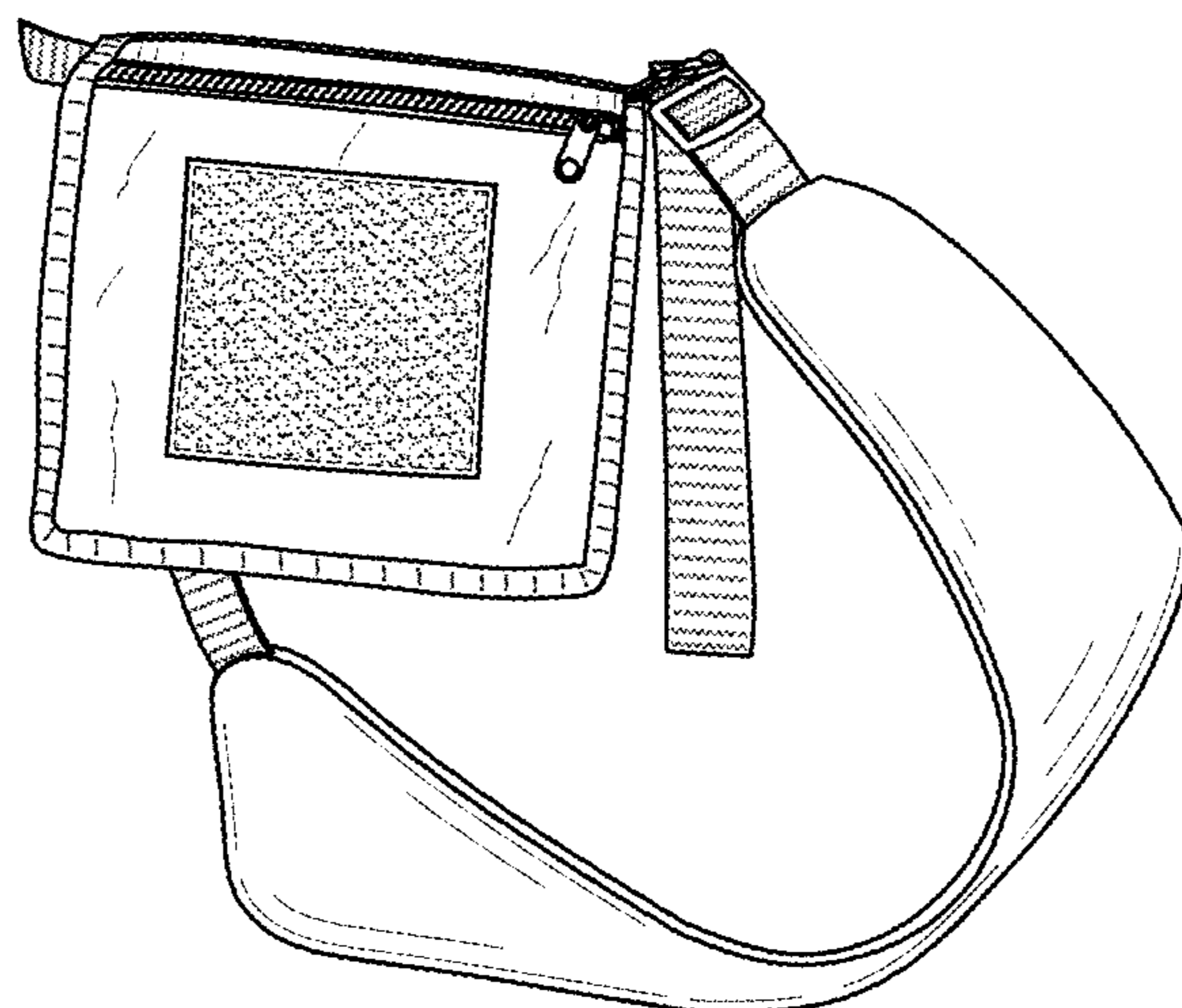
