DESCRIPTION

FIG. 1 is a bottom perspective view of a first embodiment of an iron soleplate;
FIG. 2 is a bottom edge view thereof;
FIG. 3 is a side view thereof;
FIG. 4 is a bottom view thereof;
FIG. 5 is a bottom perspective view of a second embodiment of the iron soleplate of FIG. 1; and,

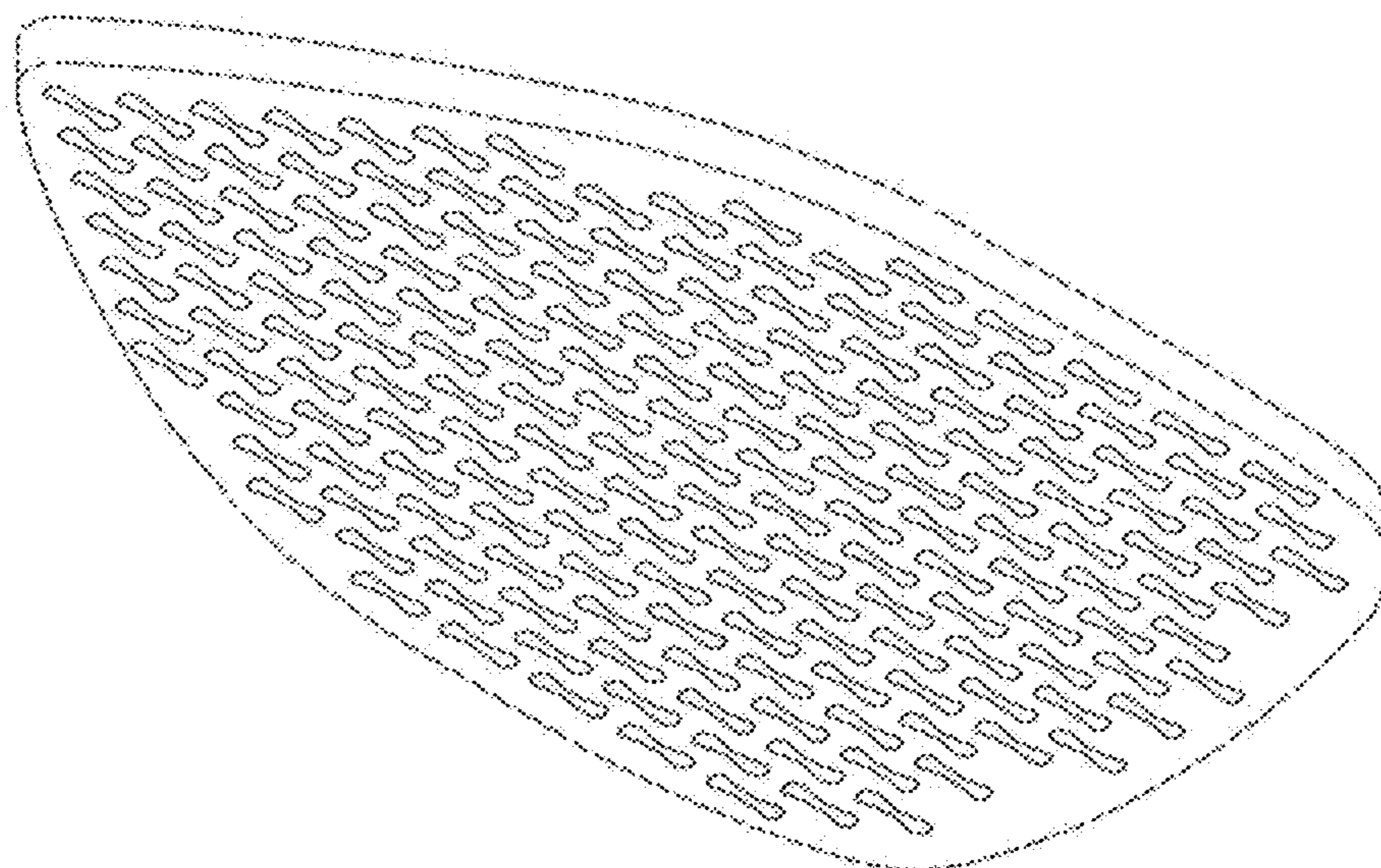

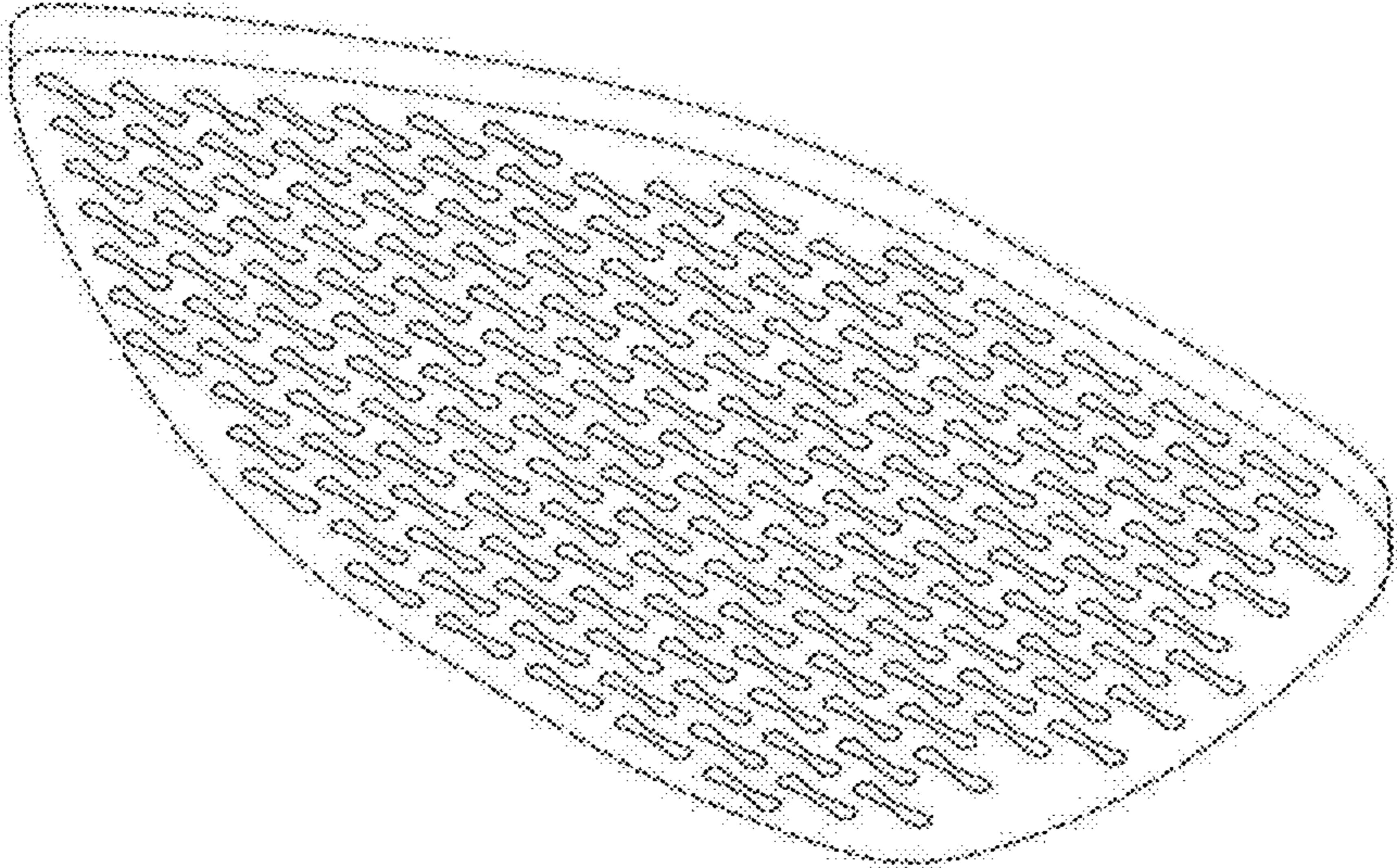

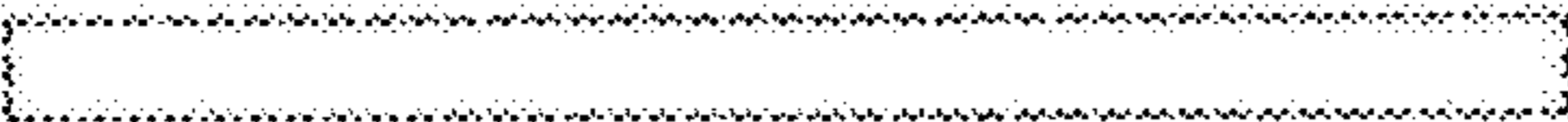

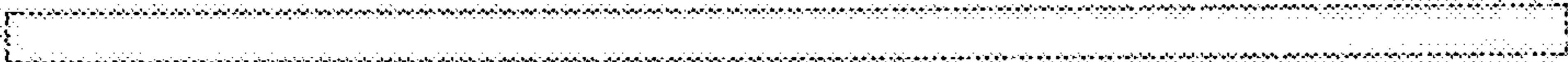

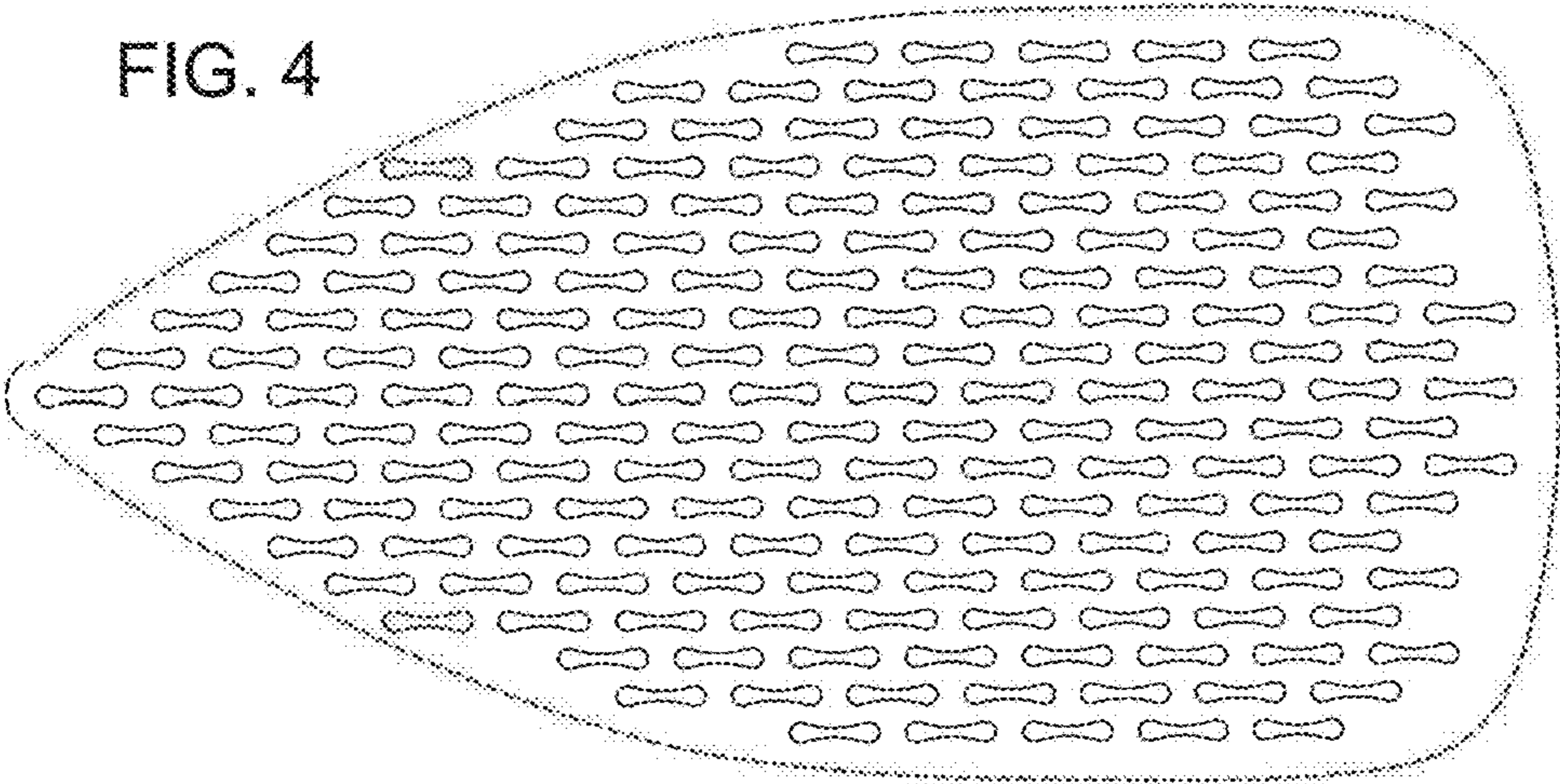

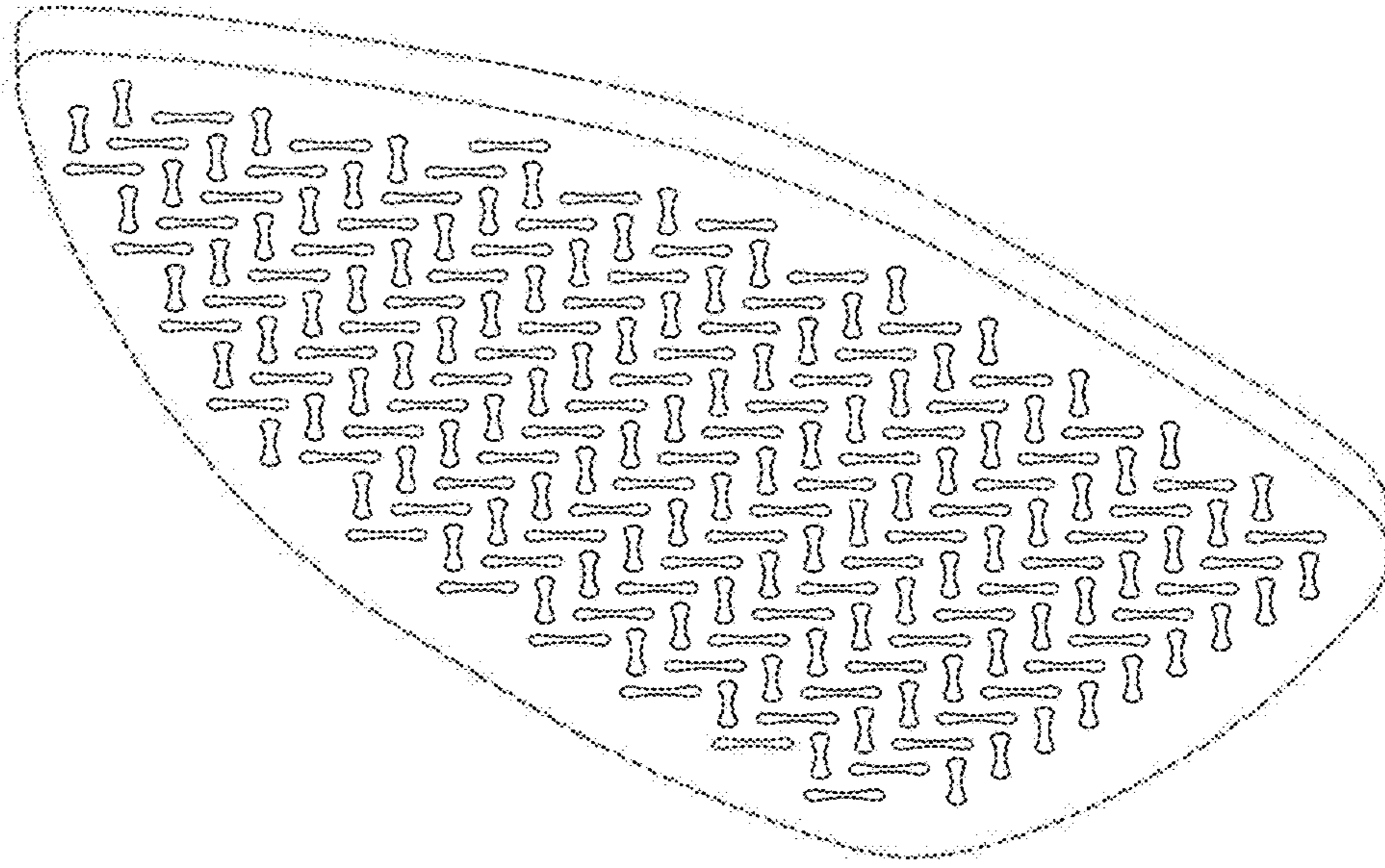
