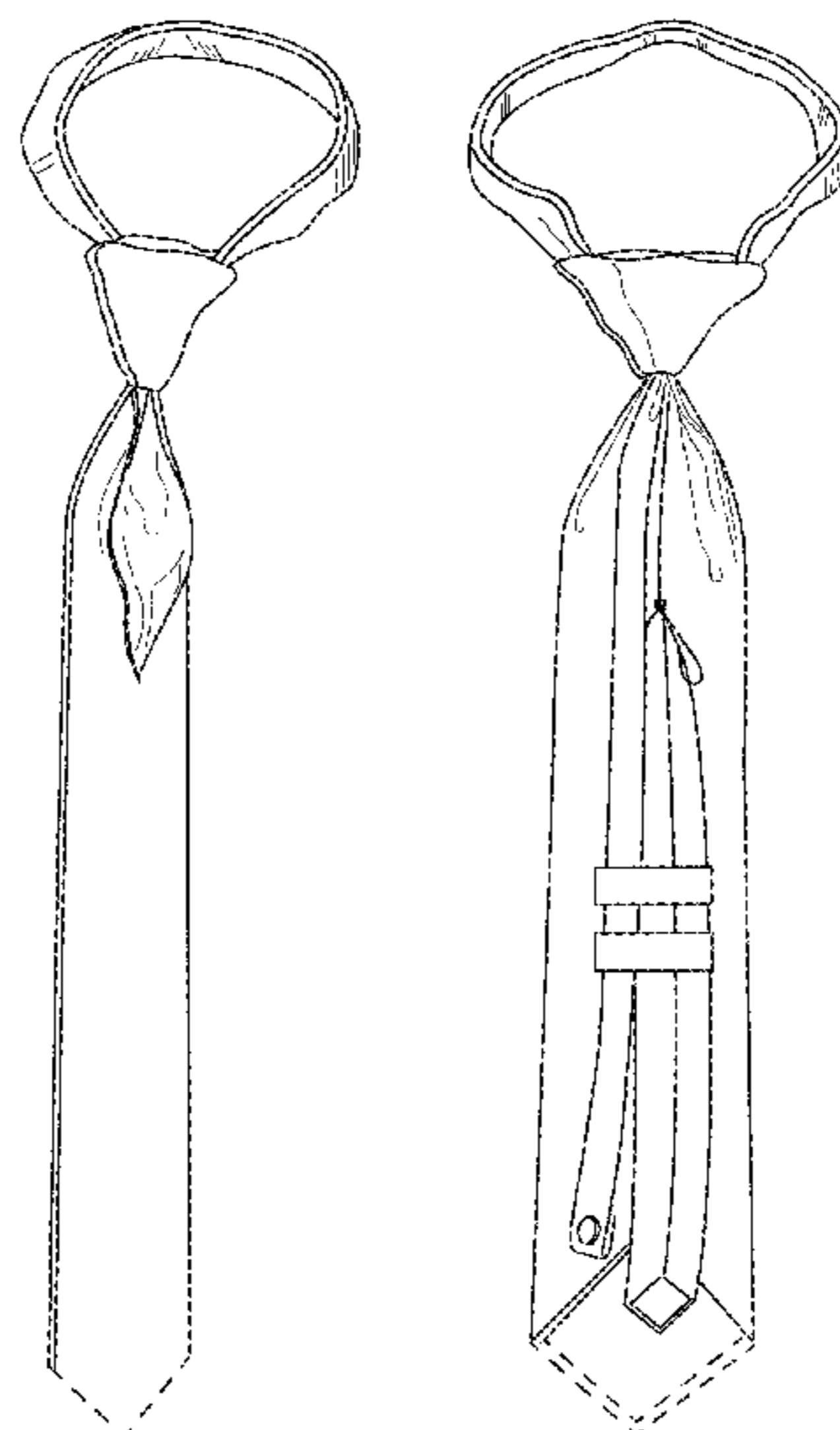
(57) **CLAIM**

The ornamental design for a necktie, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a necktie tied in a first configuration;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a bottom plan view thereof;  
 FIG. 4 is a right-side elevational view thereof;  
 FIG. 5 is a rear elevational view thereof;  
 FIG. 6 is a left-side elevational view thereof;  
 FIG. 7 is a front isometric view thereof, showing my design;  
 FIG. 8 is a back isometric view thereof, wherein the front and rear tails are repositioned slightly so as to show features of the necktie not clearly visible in other views;  
 FIG. 9 is a top plan view of the necktie tied in a second configuration;  
 FIG. 10 is a front elevational view thereof;  
 FIG. 11 is a bottom plan view thereof;  
 FIG. 12 is a right-side elevational view thereof;  
 FIG. 13 is a rear elevational view thereof;  
 FIG. 14 is a left-side elevational view thereof;  
 FIG. 15 is a front isometric view thereof, showing my design;  
 FIG. 16 is a back isometric view thereof, wherein the tail portions are repositioned slightly so as to show features of the necktie not clearly visible in other views;  
 FIG. 17 is an enlarged view of FIG. 1;  
 FIG. 18 is an enlarged view of FIG. 3;  
 FIG. 19 is an enlarged view of FIG. 9; and,  
 FIG. 20 is an enlarged view of FIG. 11.  
 The broken lines represent environmental structure and form no part of the claimed design.

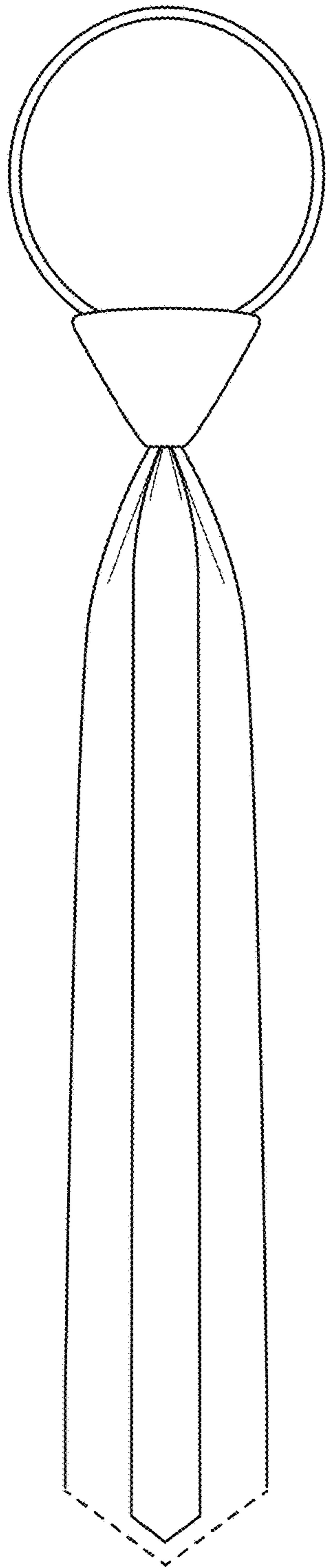

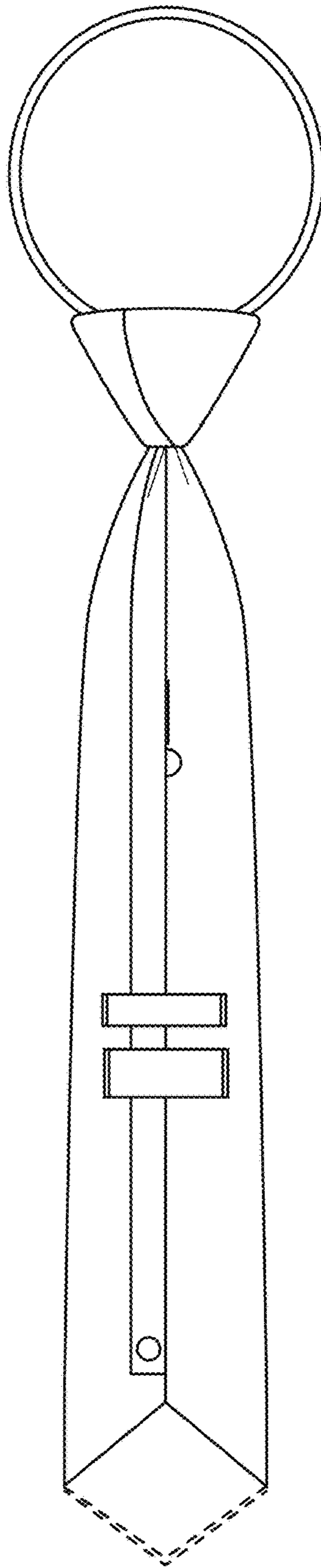

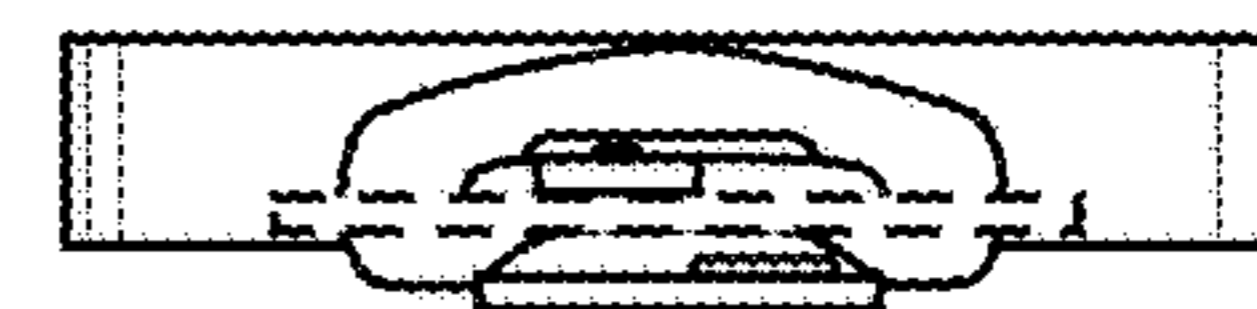

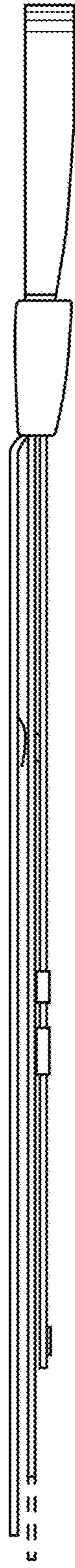

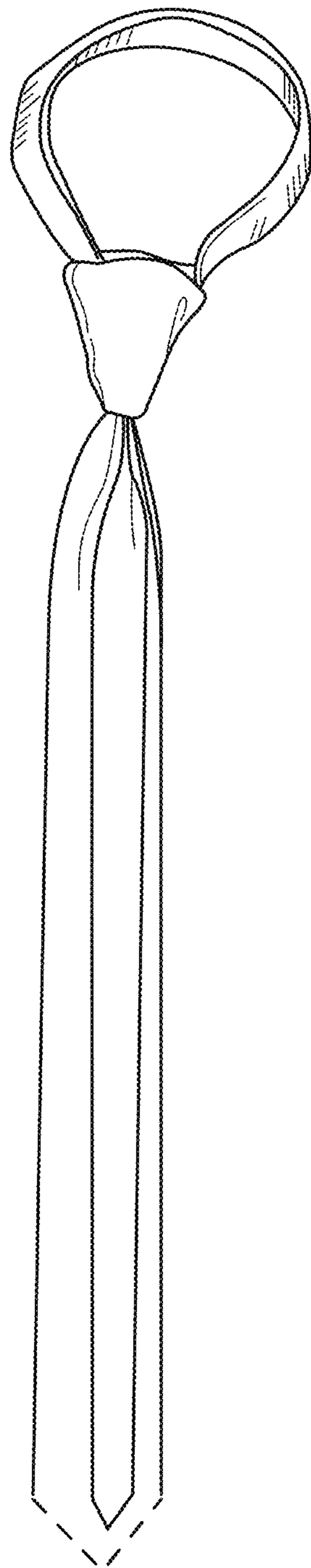

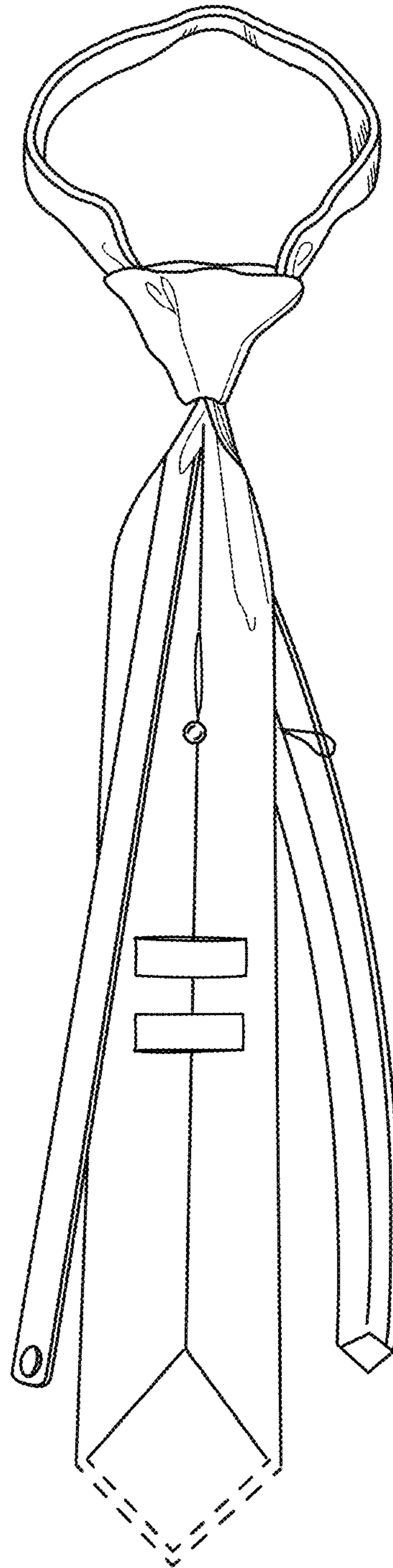

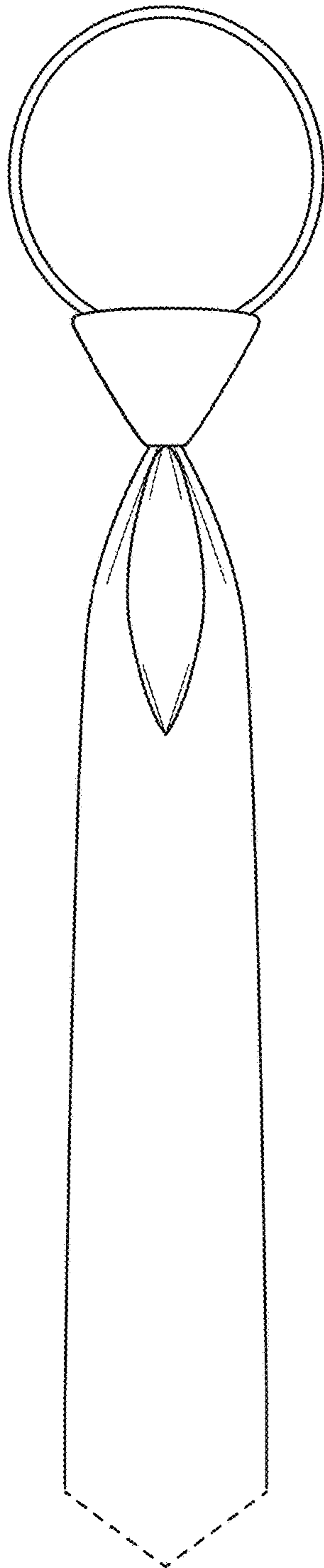

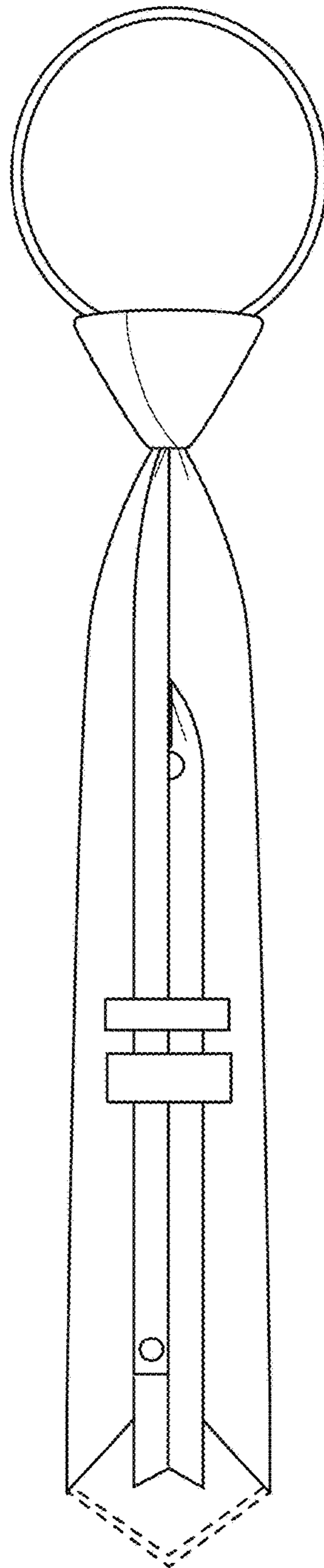

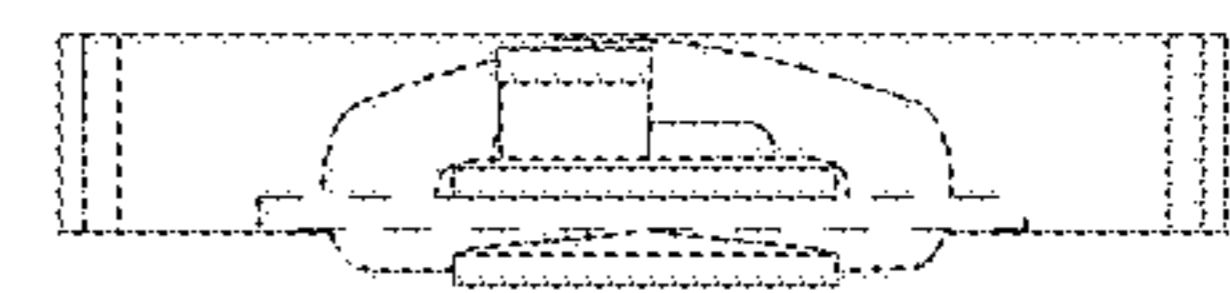

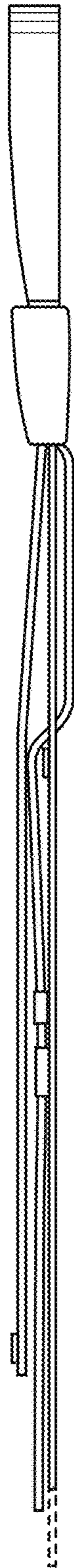

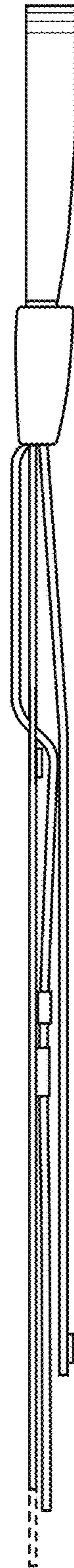

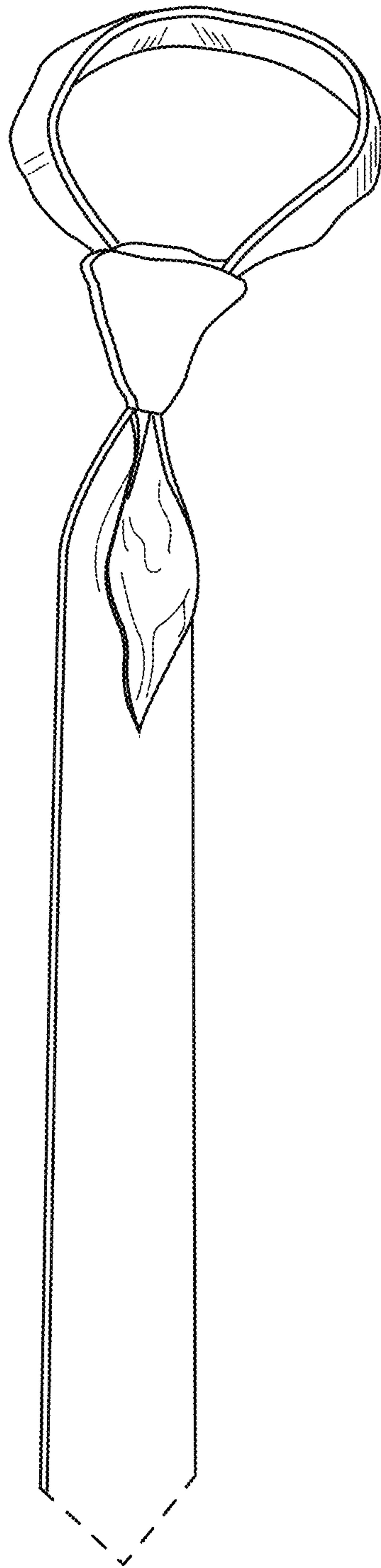

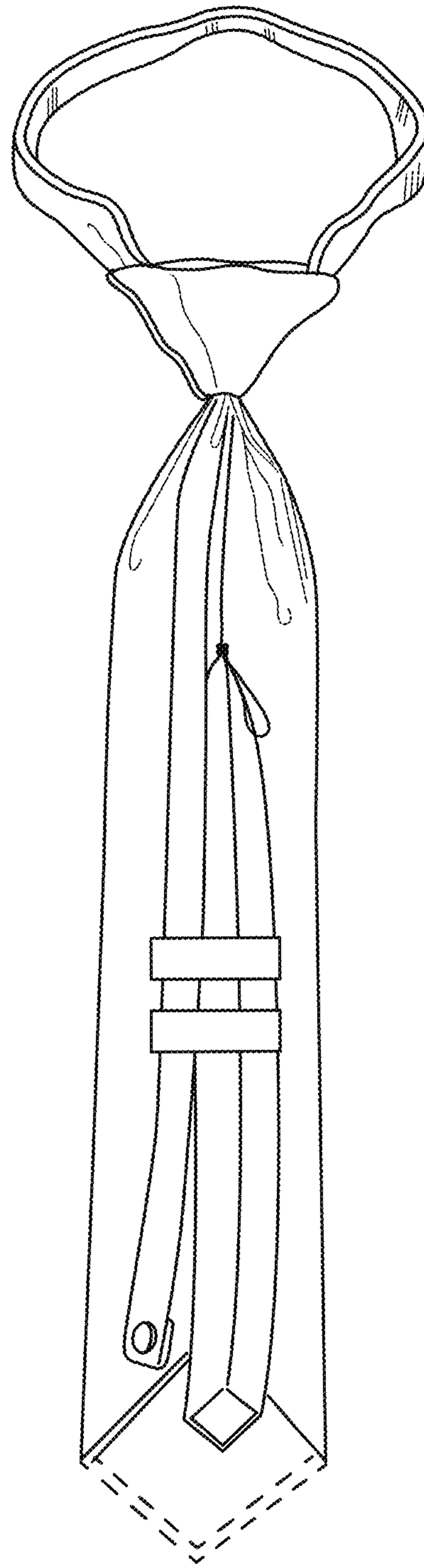

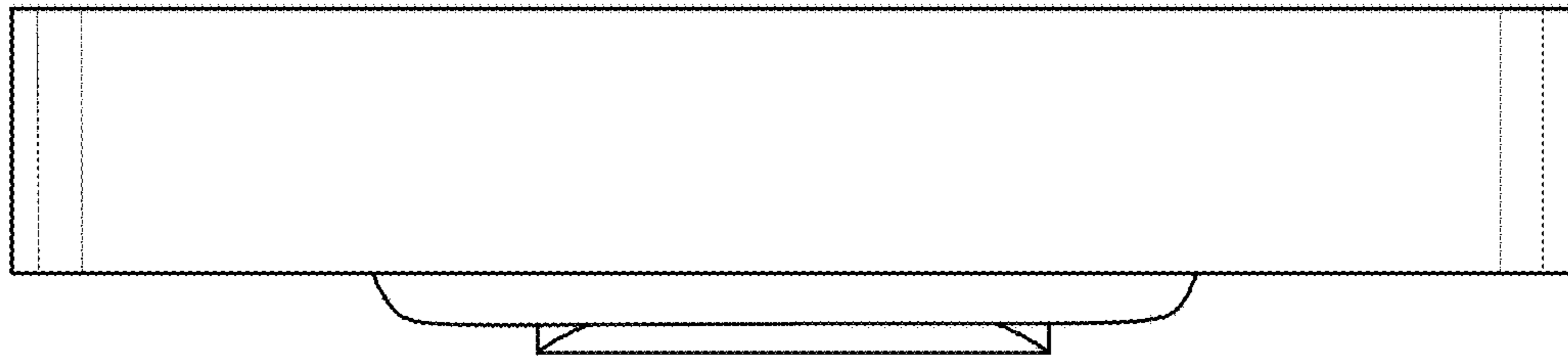

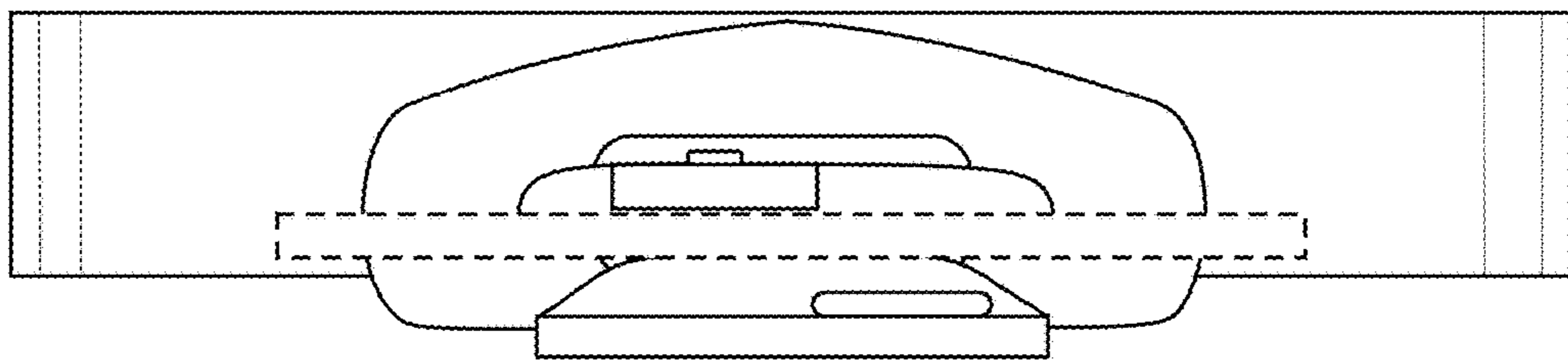

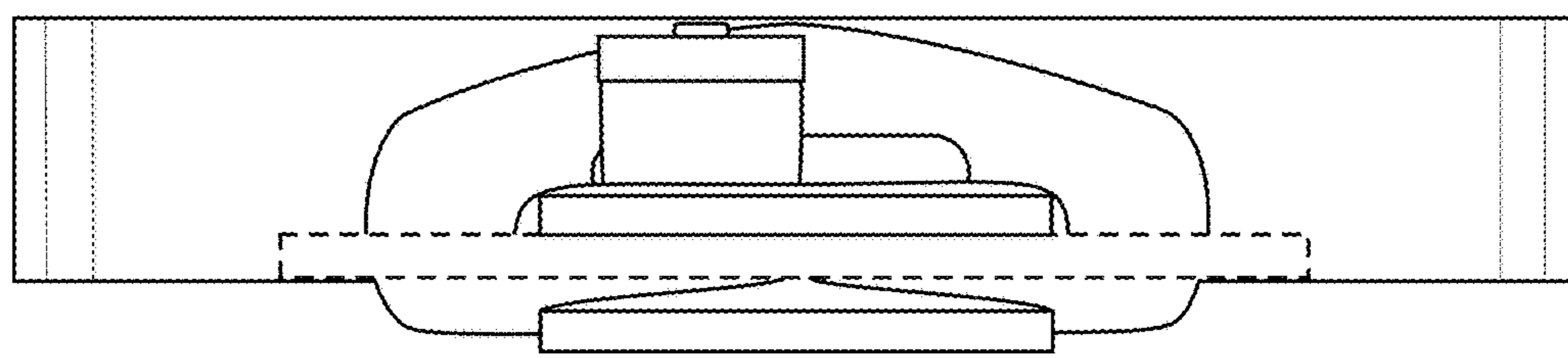
