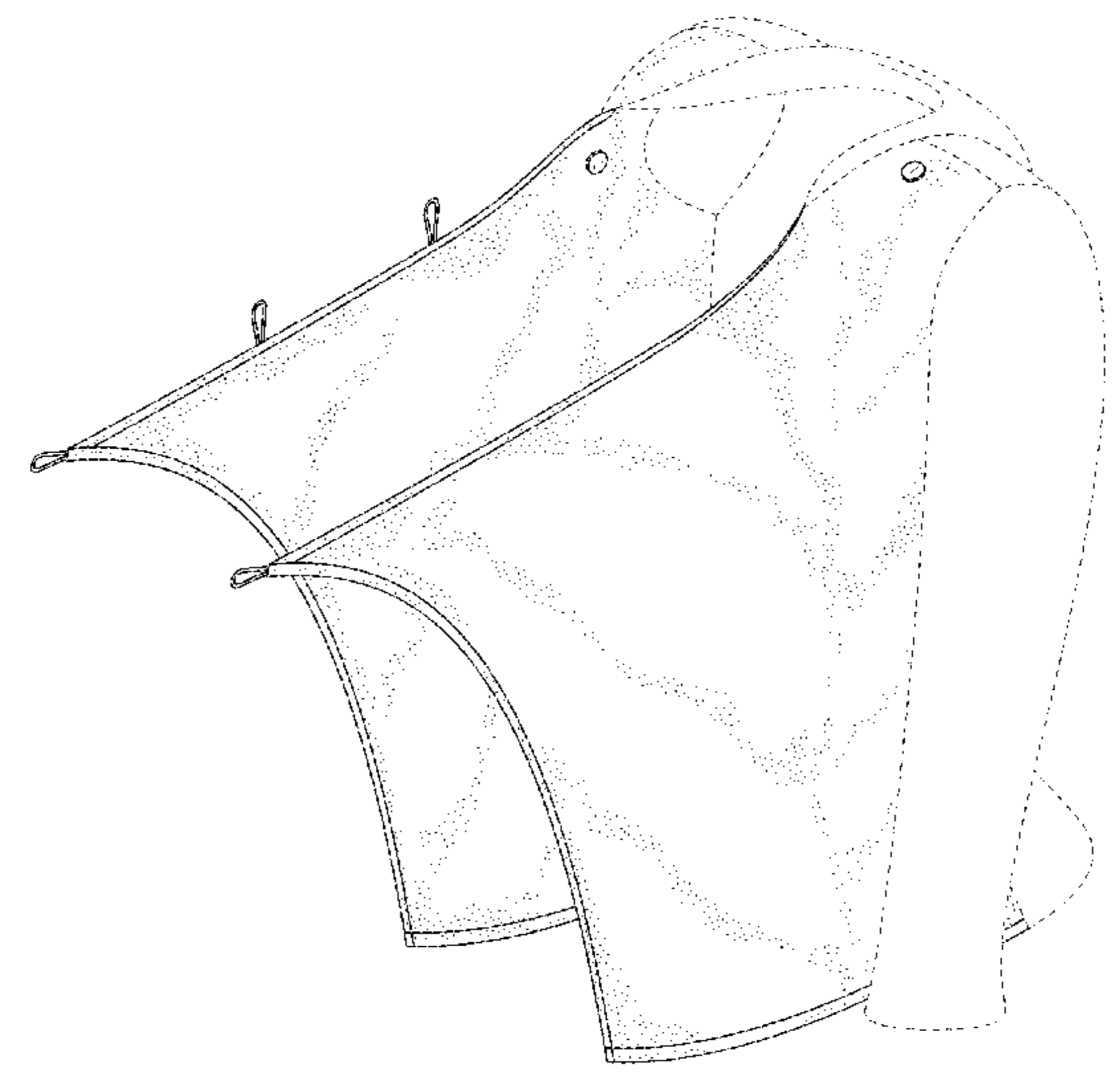

(57) **CLAIM**
The ornamental design for a nursing garment, as shown and described.

DESCRIPTION
FIG. 1 is a perspective view of the nursing garment showing my new design;
FIG. 2 is a perspective view from the opposite angle thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a back side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a left plan view thereof;
FIG. 7 is a perspective view thereof showing the nursing garment in a first worn state; and,
FIG. 8 is front view thereof showing the nursing garment in a second worn state.
The broken lines shown in the drawings illustrate portions of the nursing garment that form no part of the claimed design.

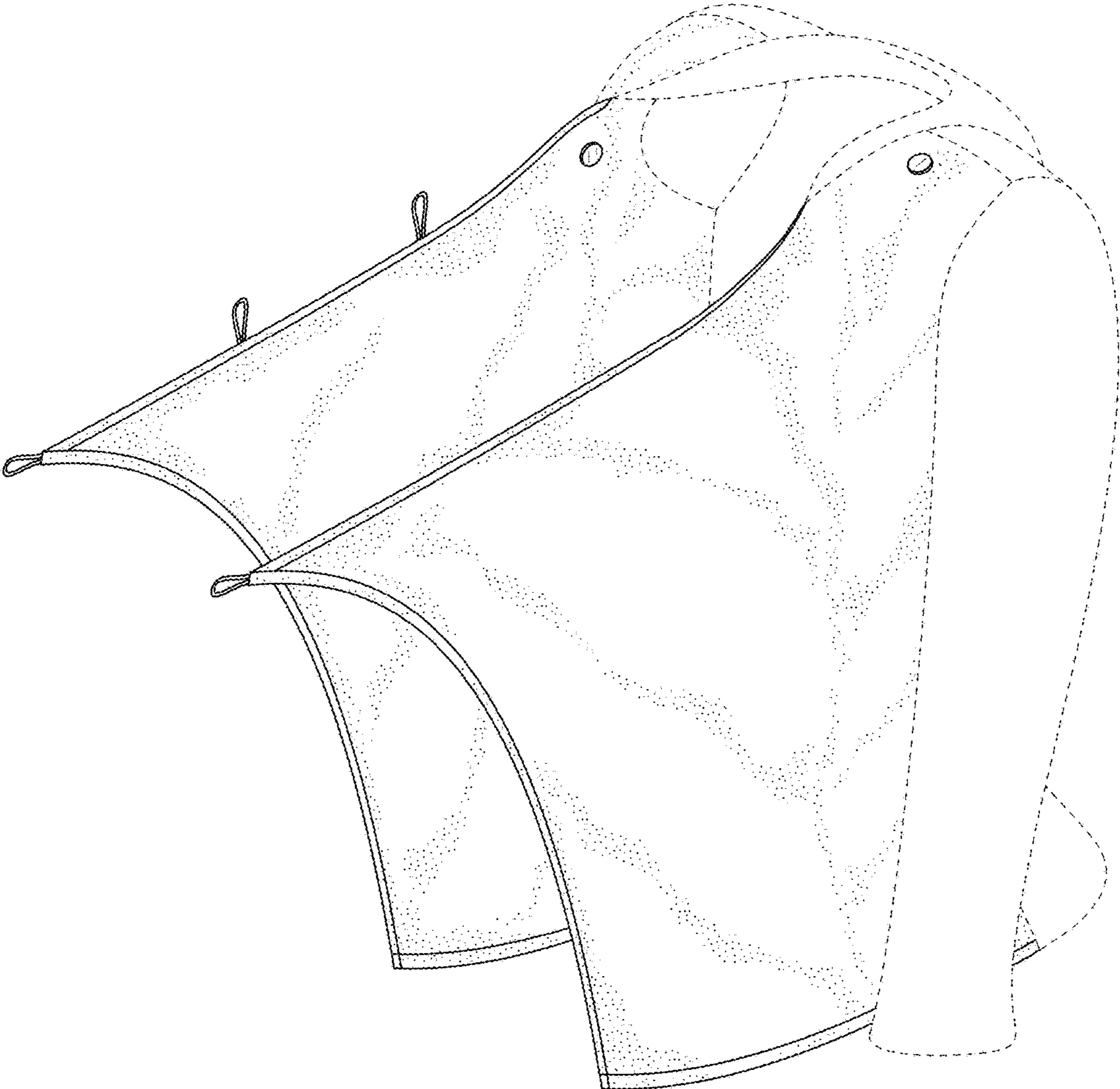

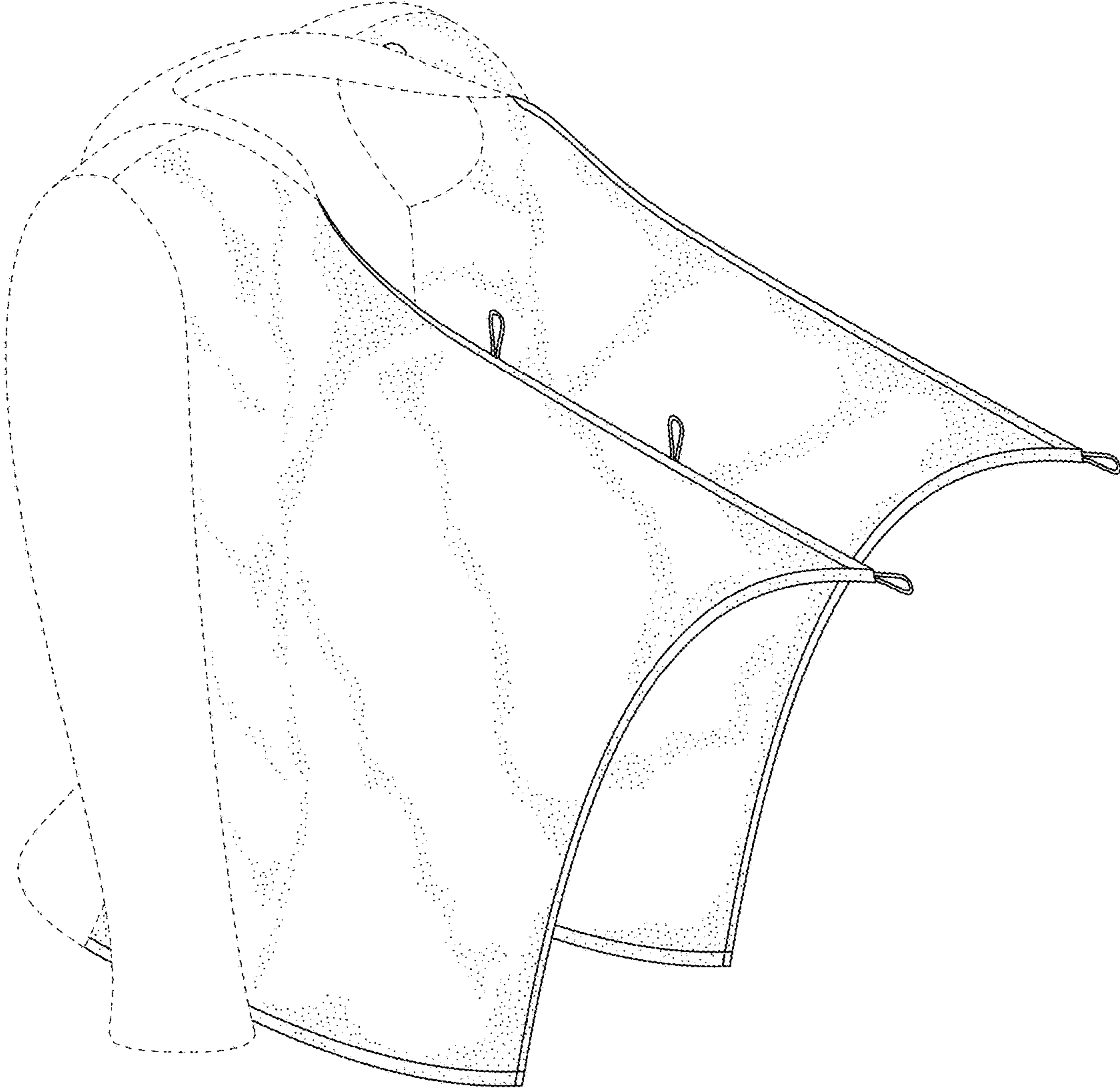

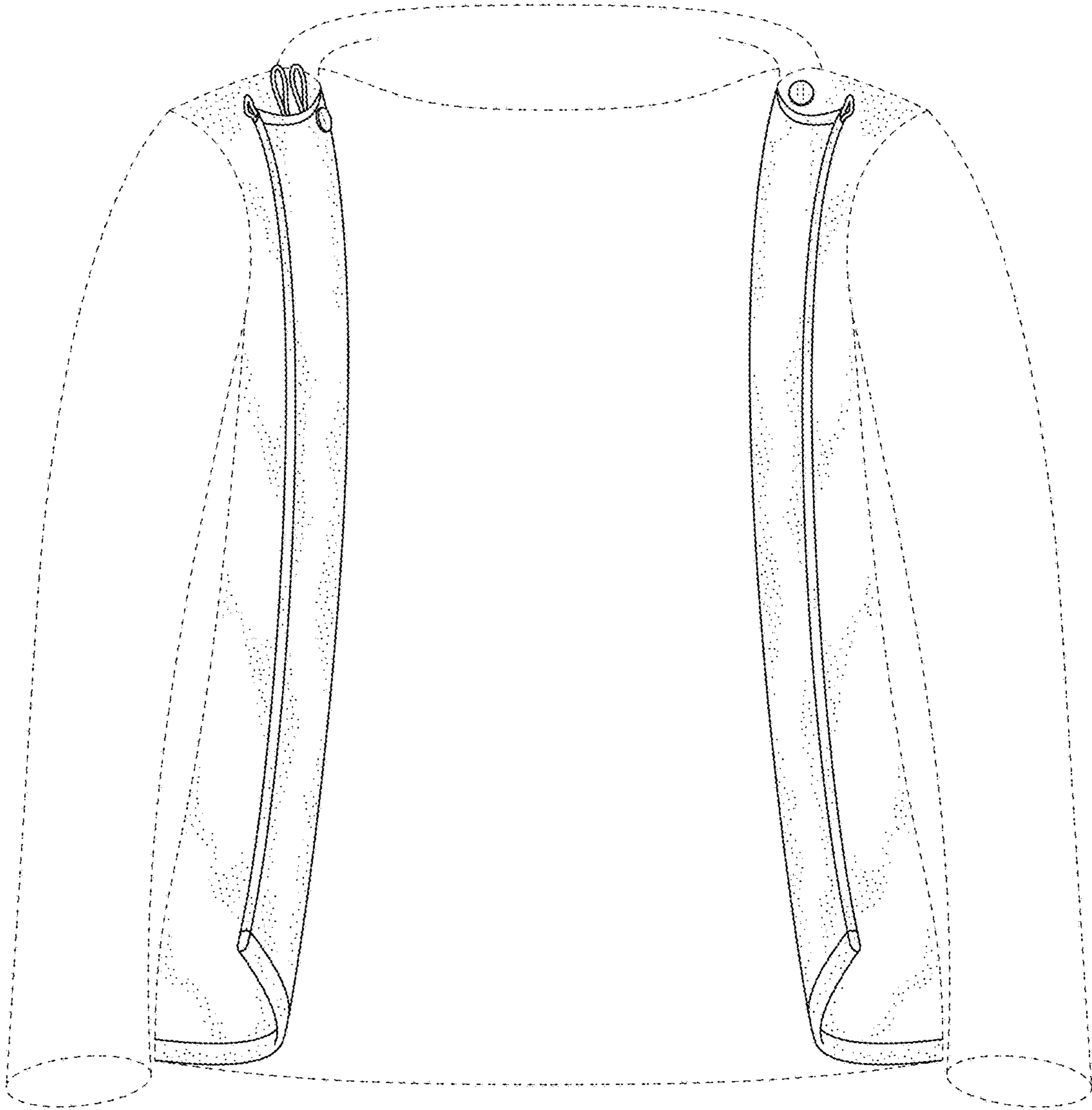

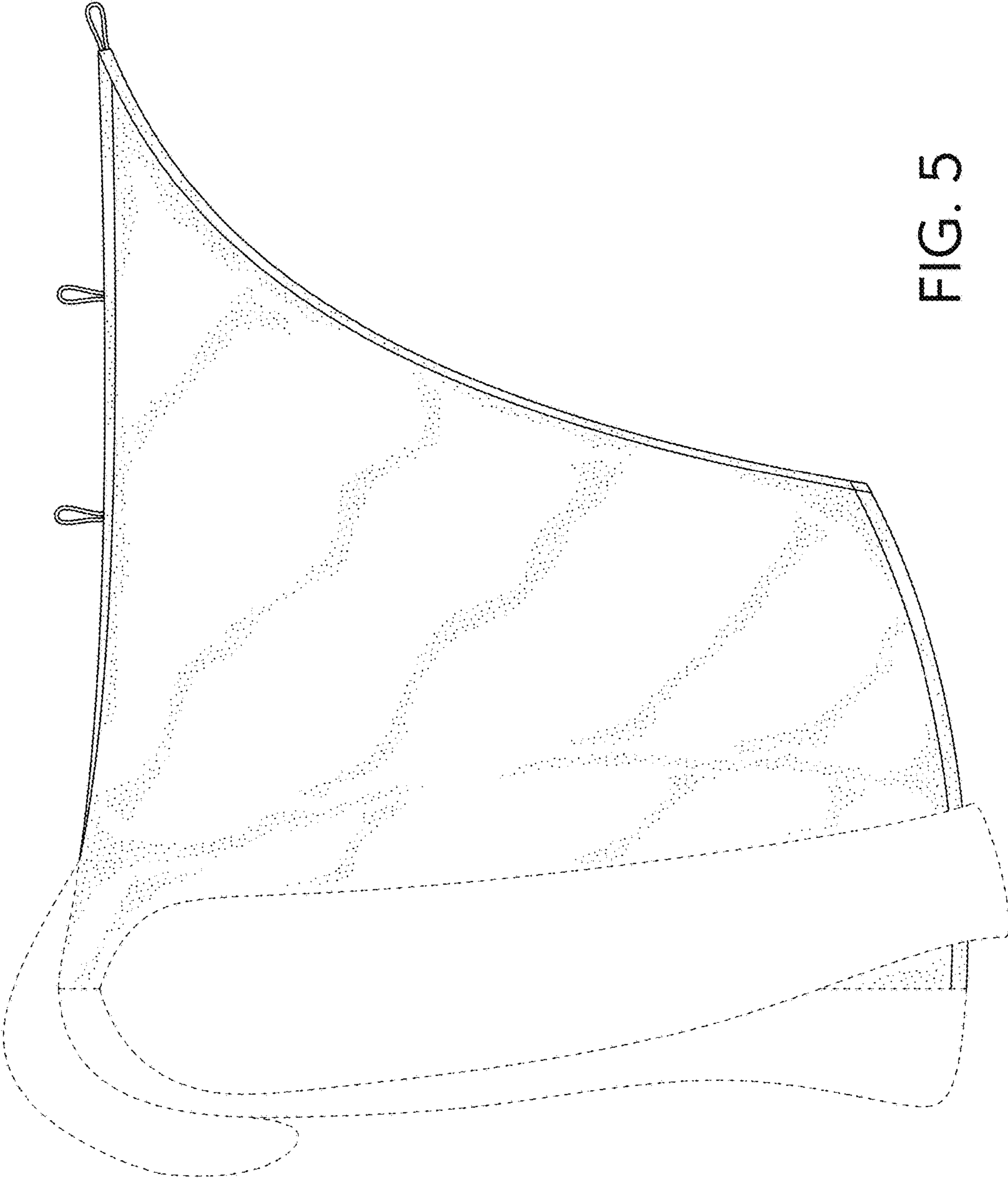

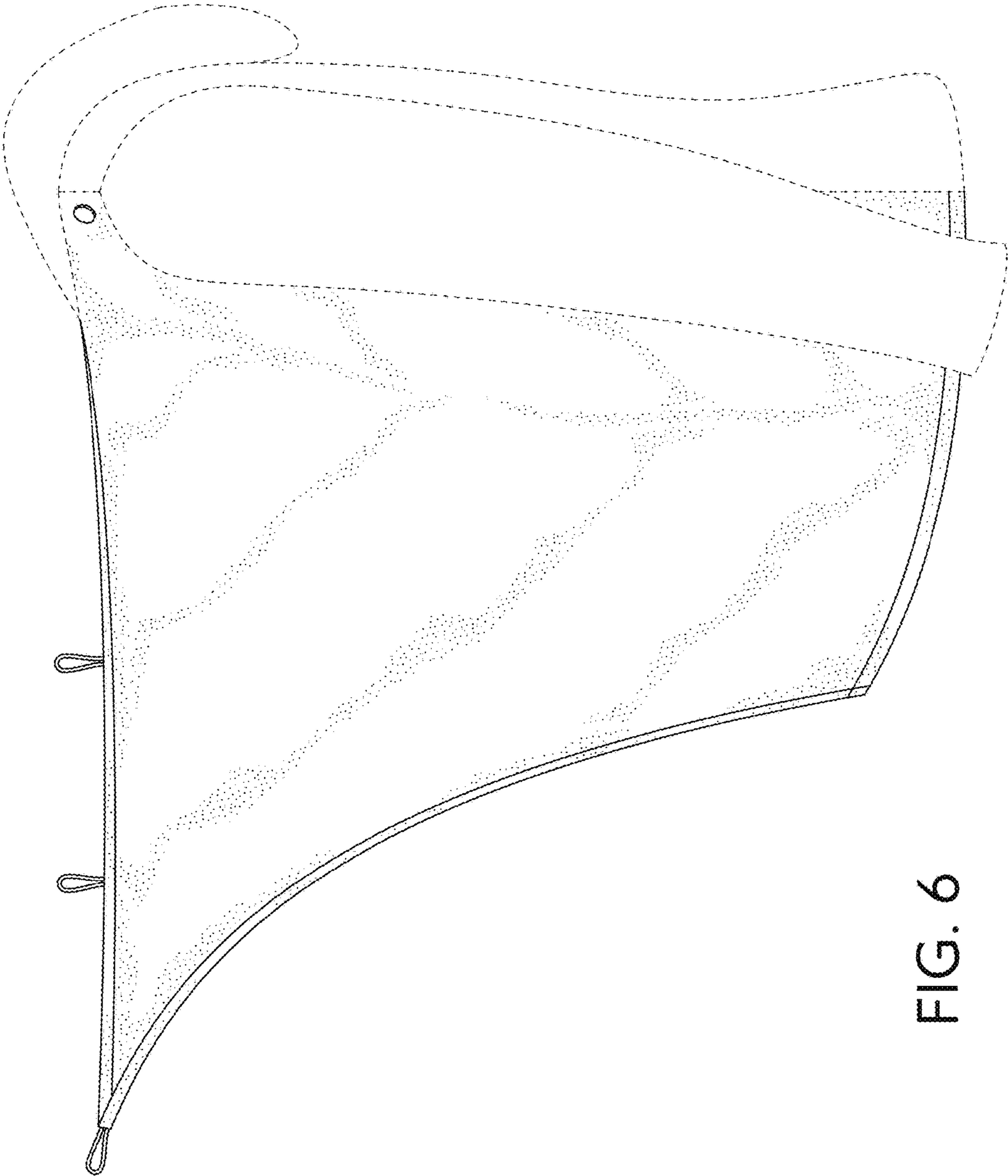

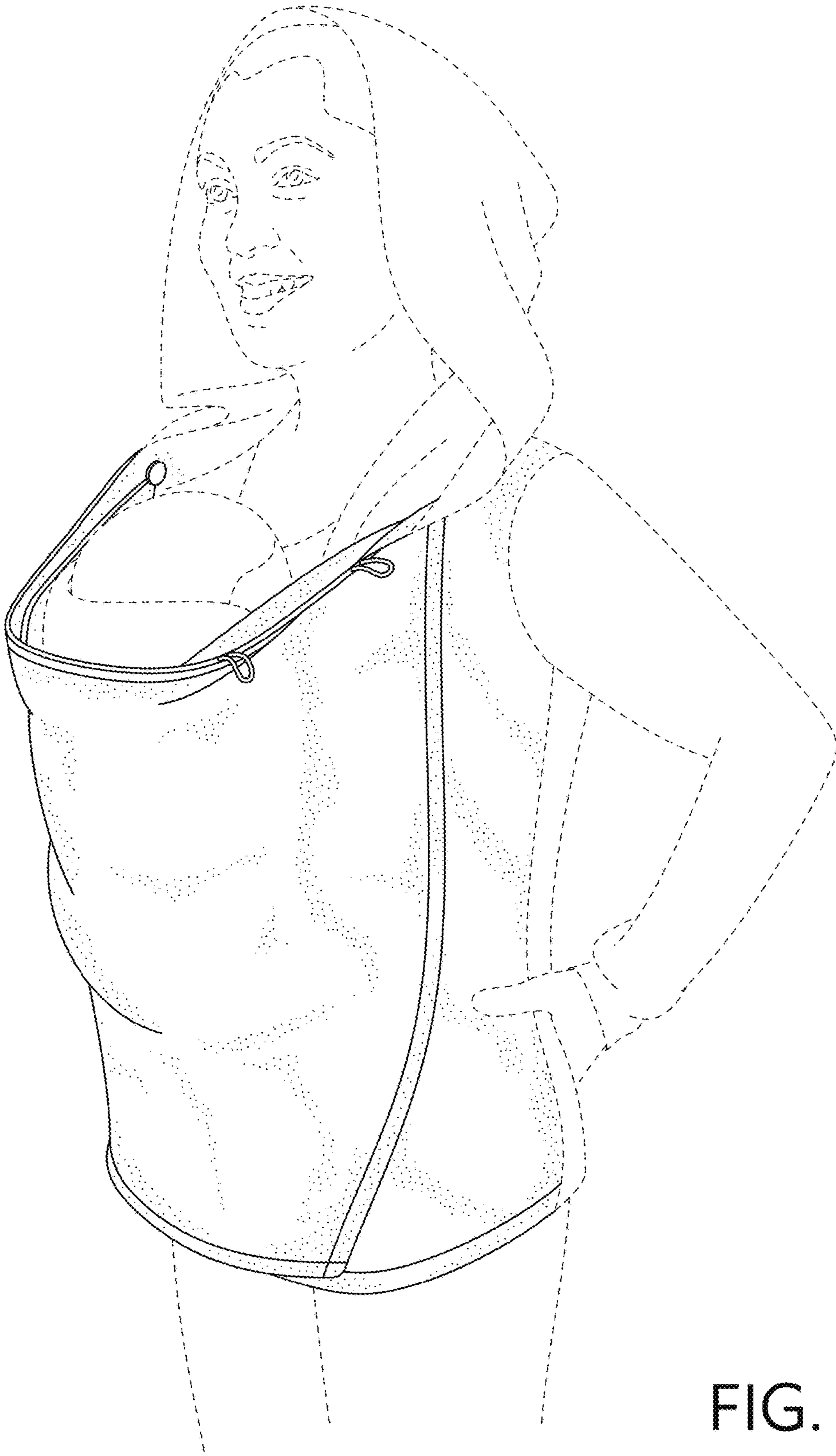

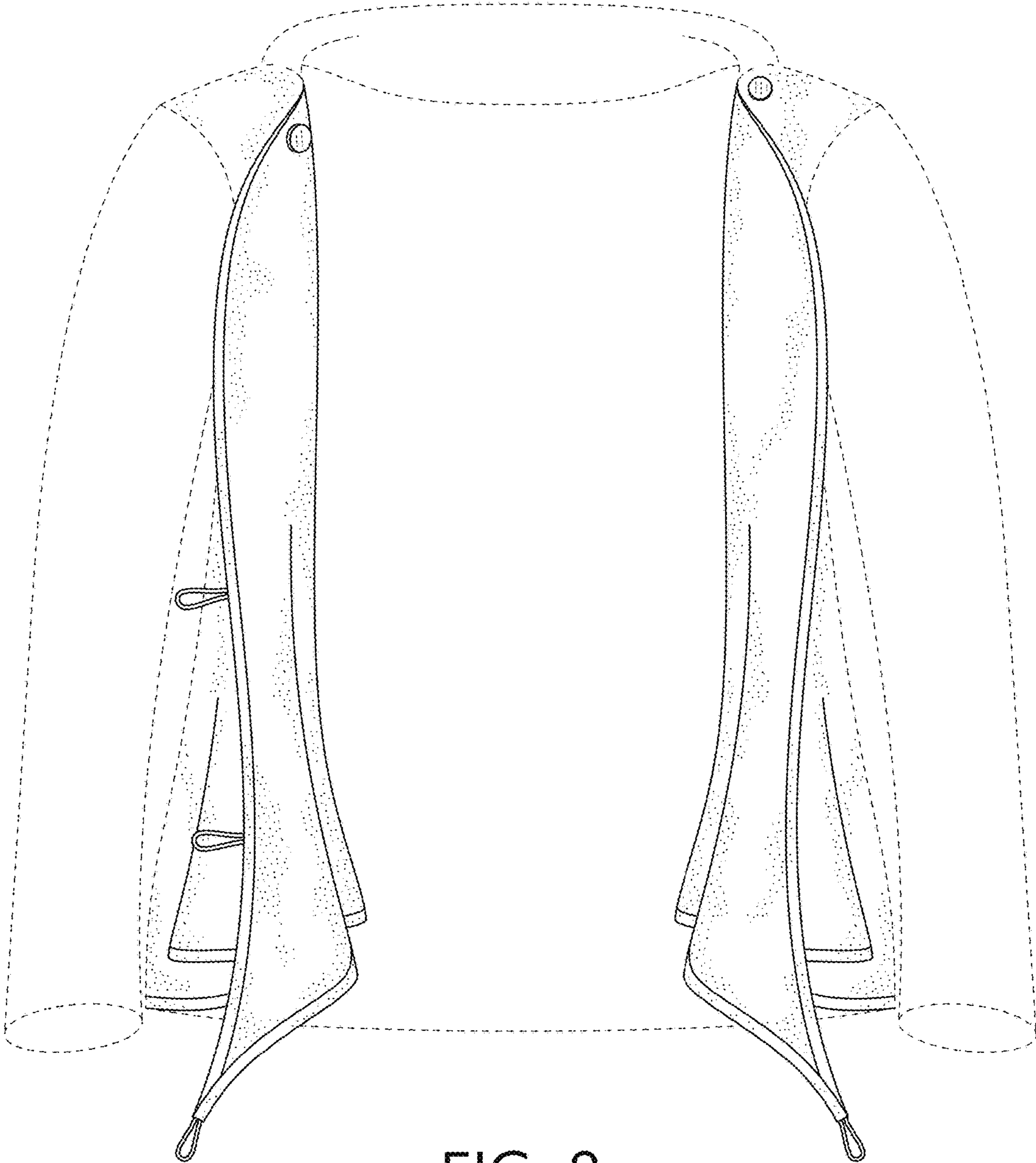
