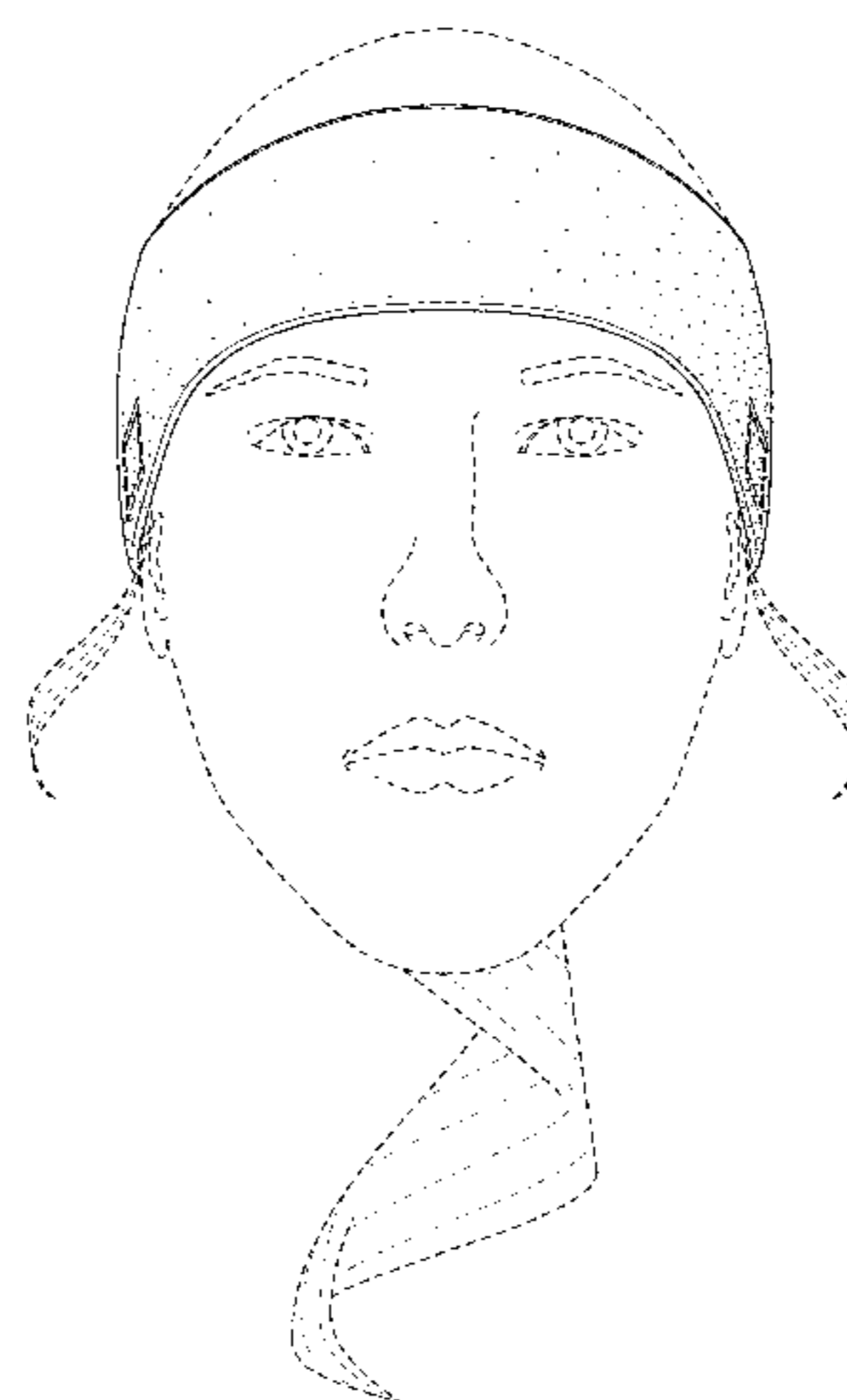
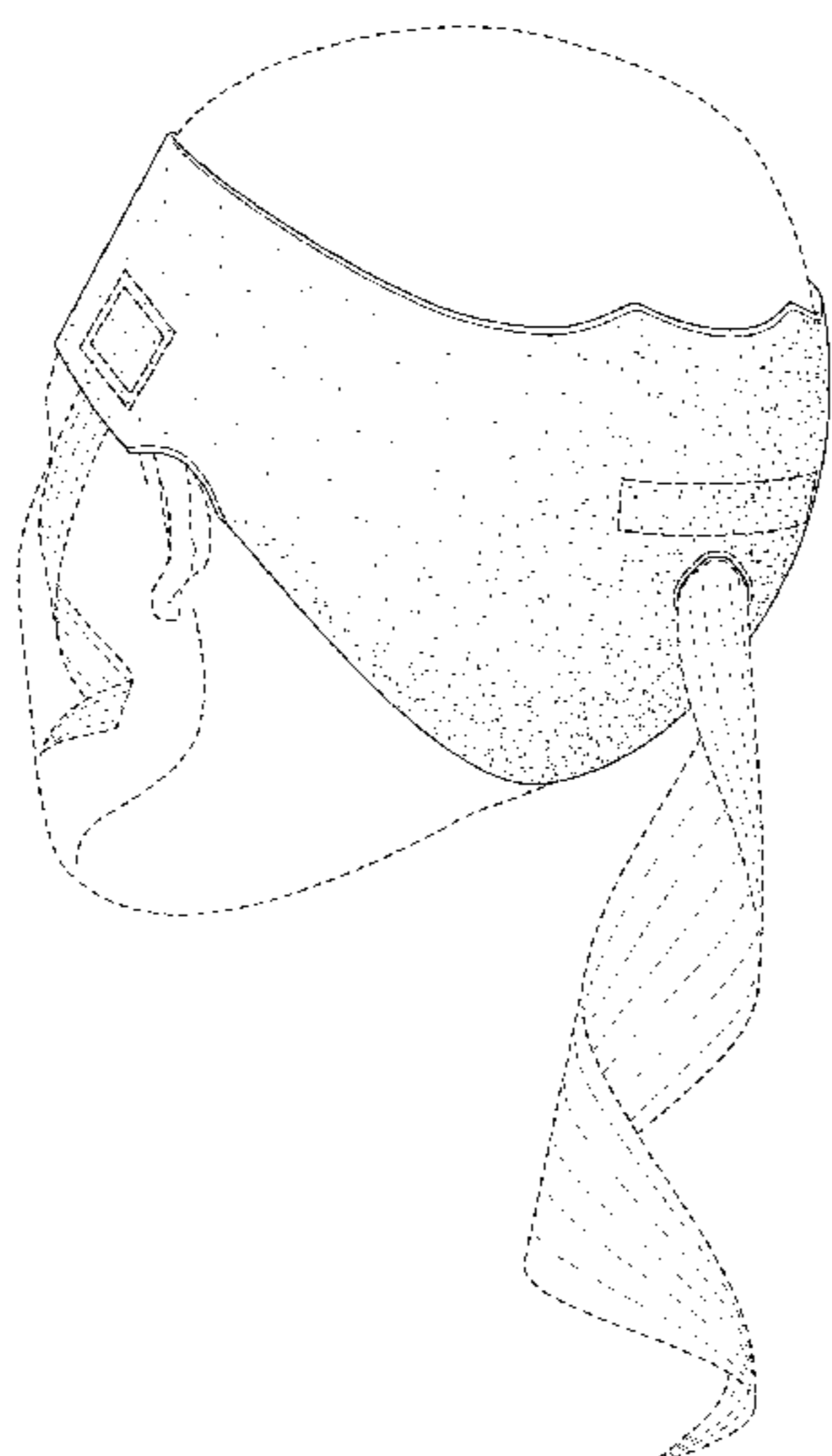
(57) **CLAIM**

The ornamental design for a headband, as shown and described.

DESCRIPTION

FIG. 1 is a left, rear perspective view of a headband;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a right side elevation view thereof;
FIG. 5 is a left side perspective view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a front left prospective view showing the nature and environmental use thereof, worn under a baseball hat.
The broken lines in the drawings represent environmental structure that form no part of the claimed design.

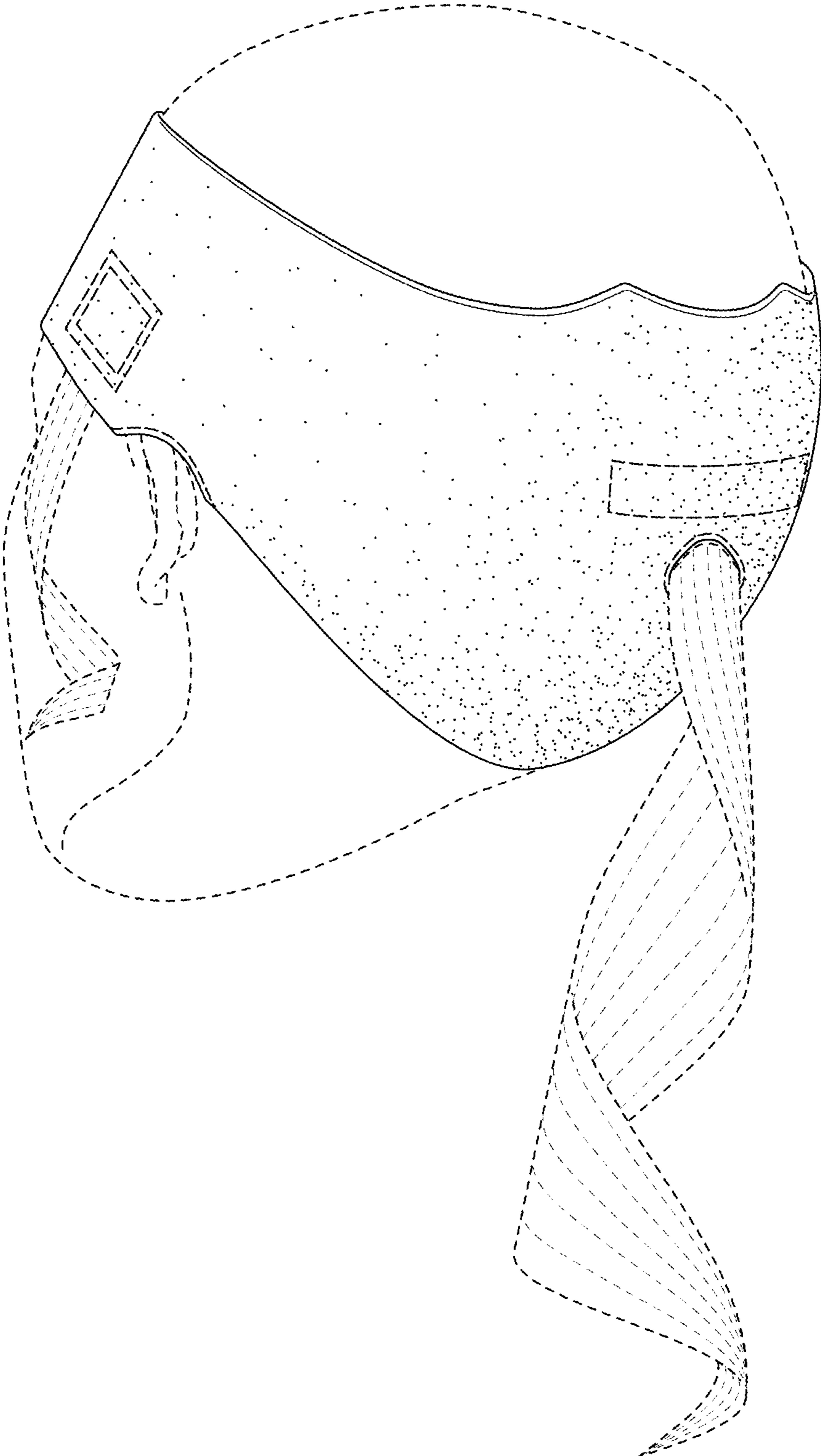

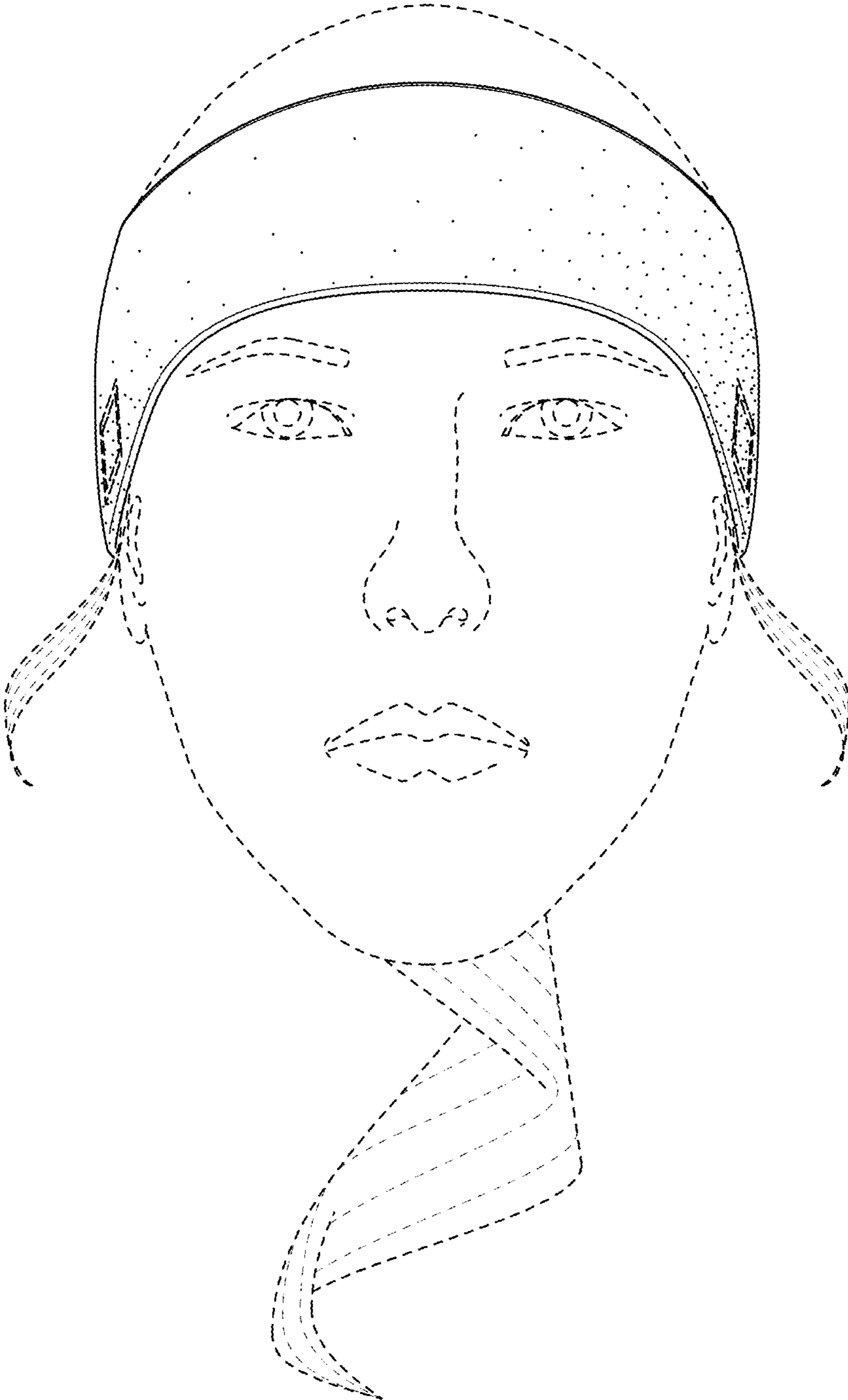

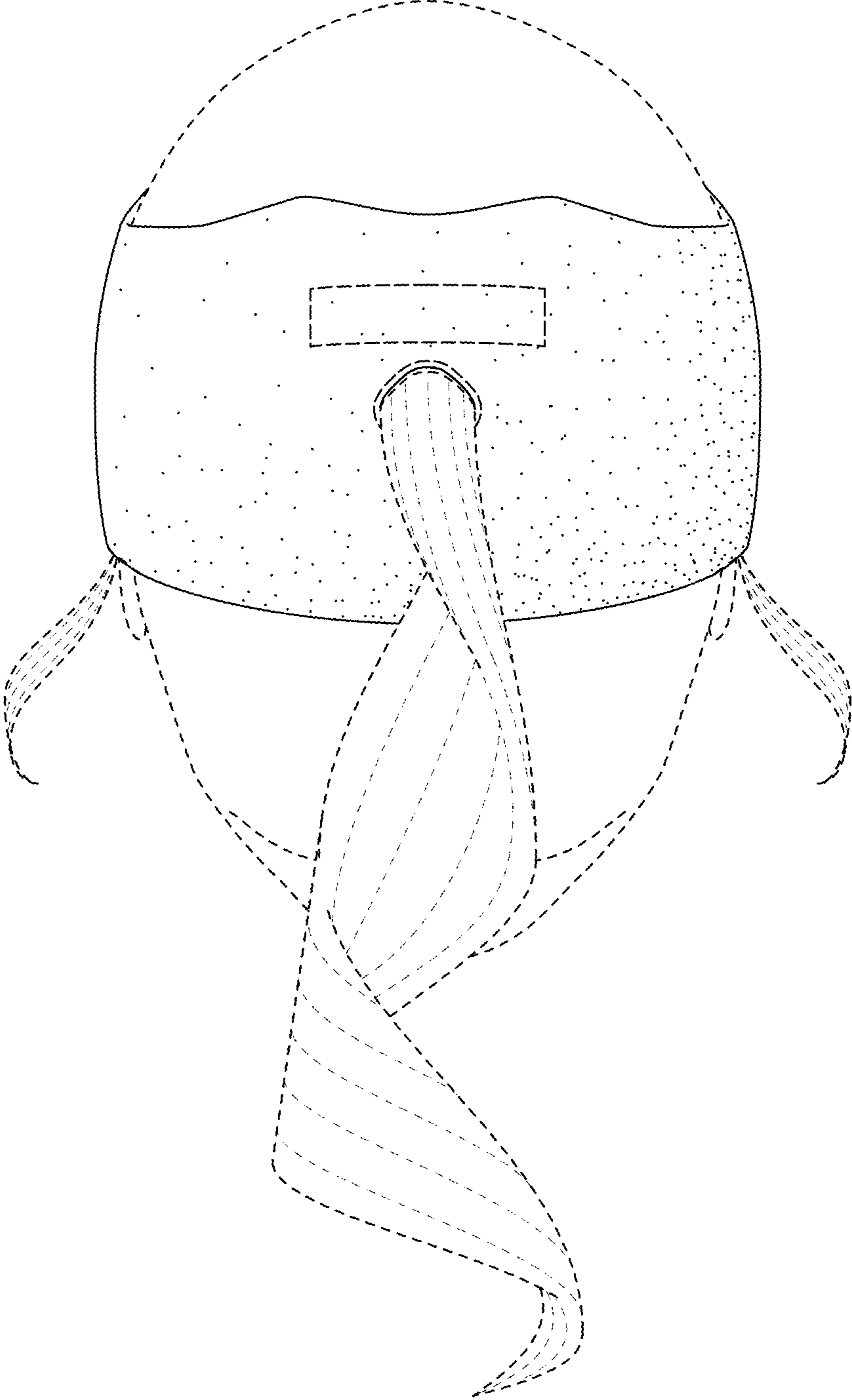

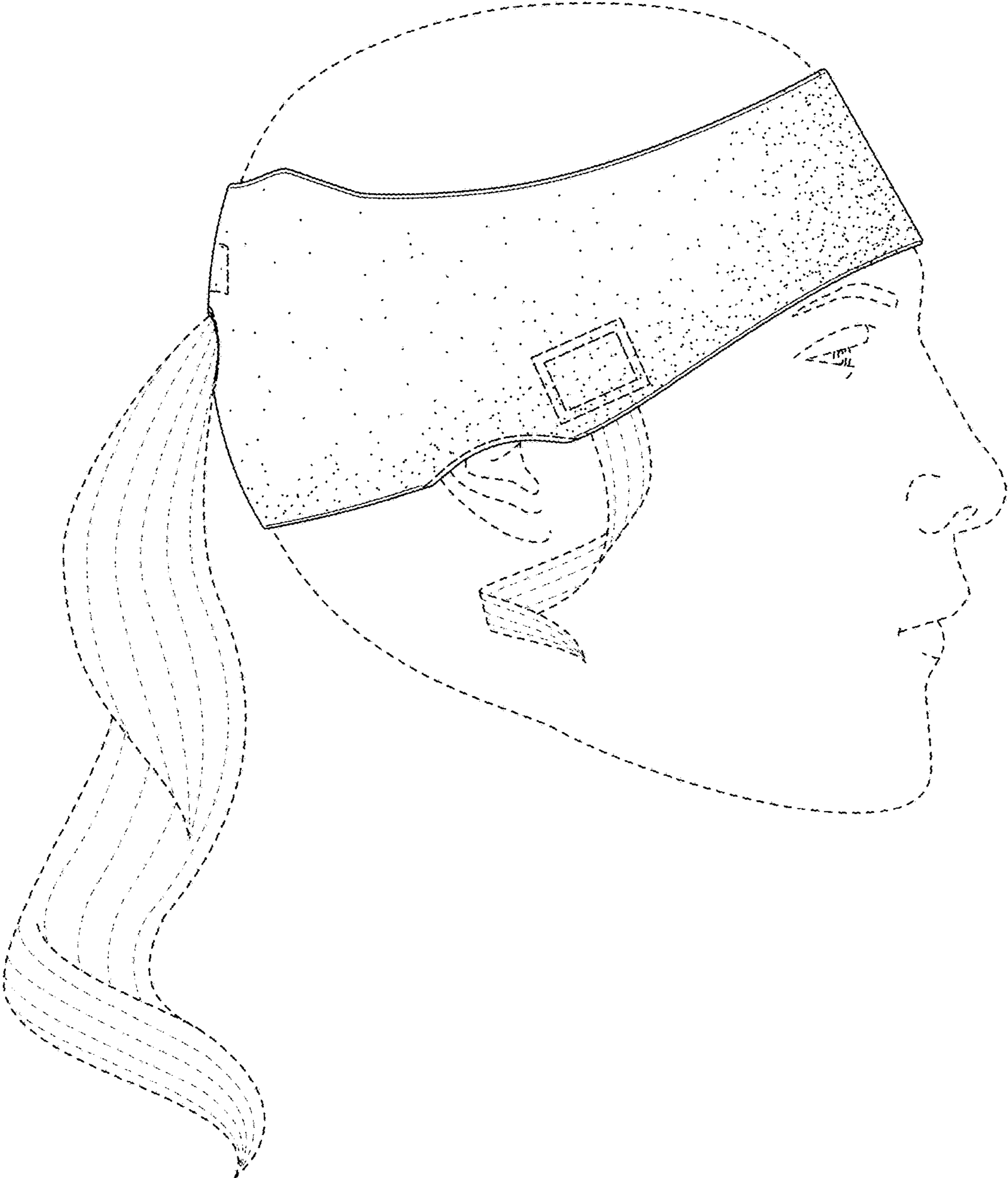

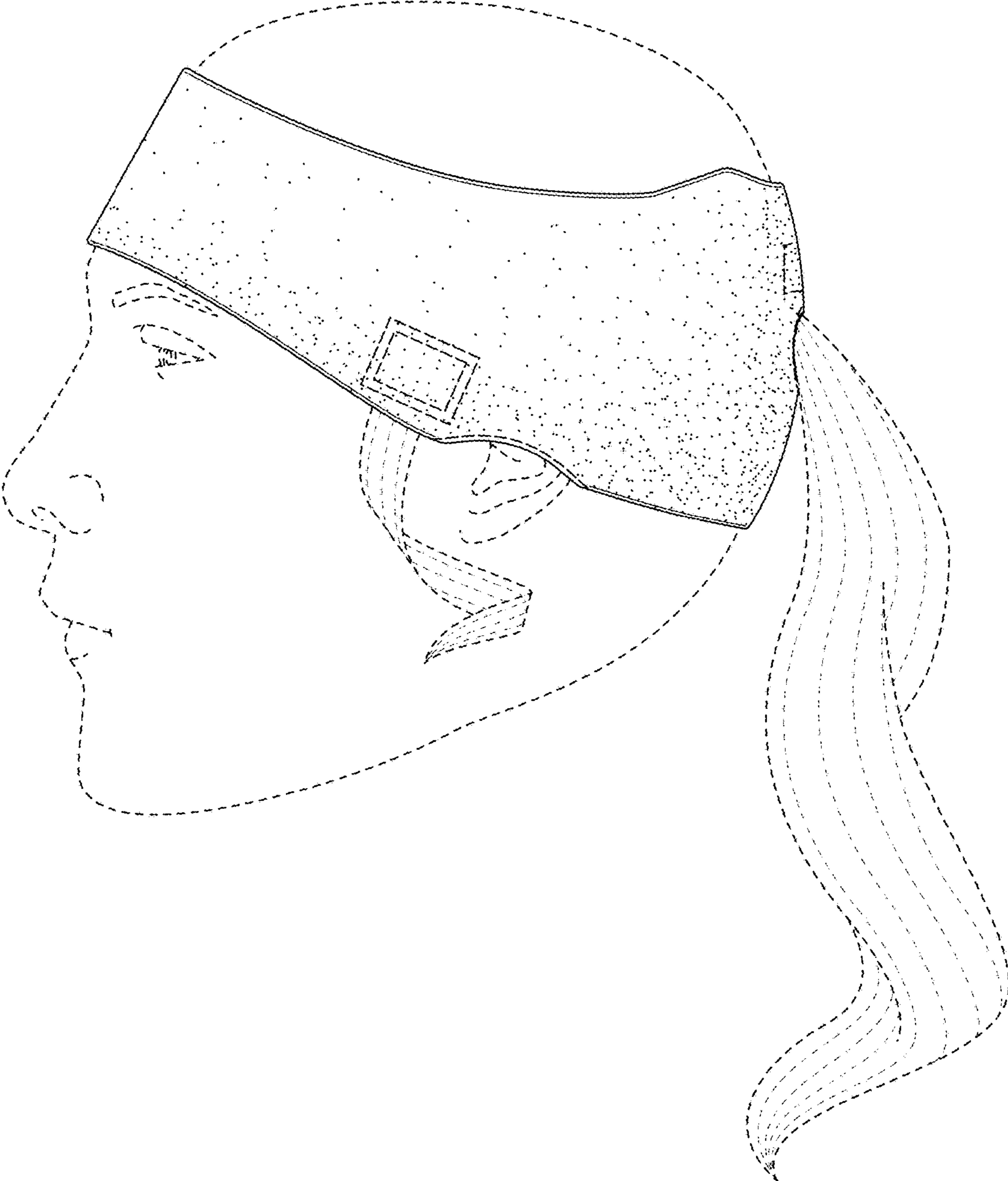

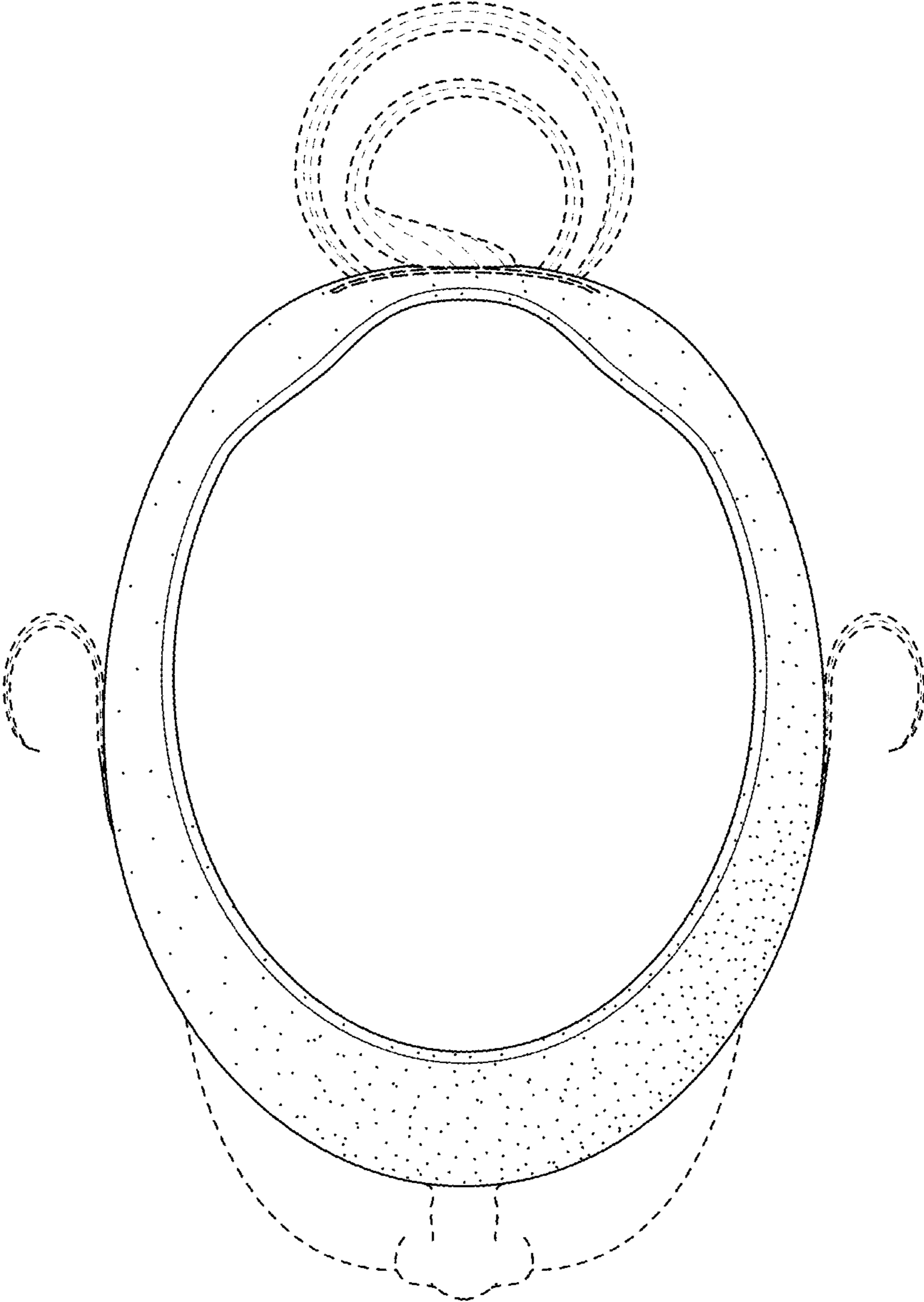

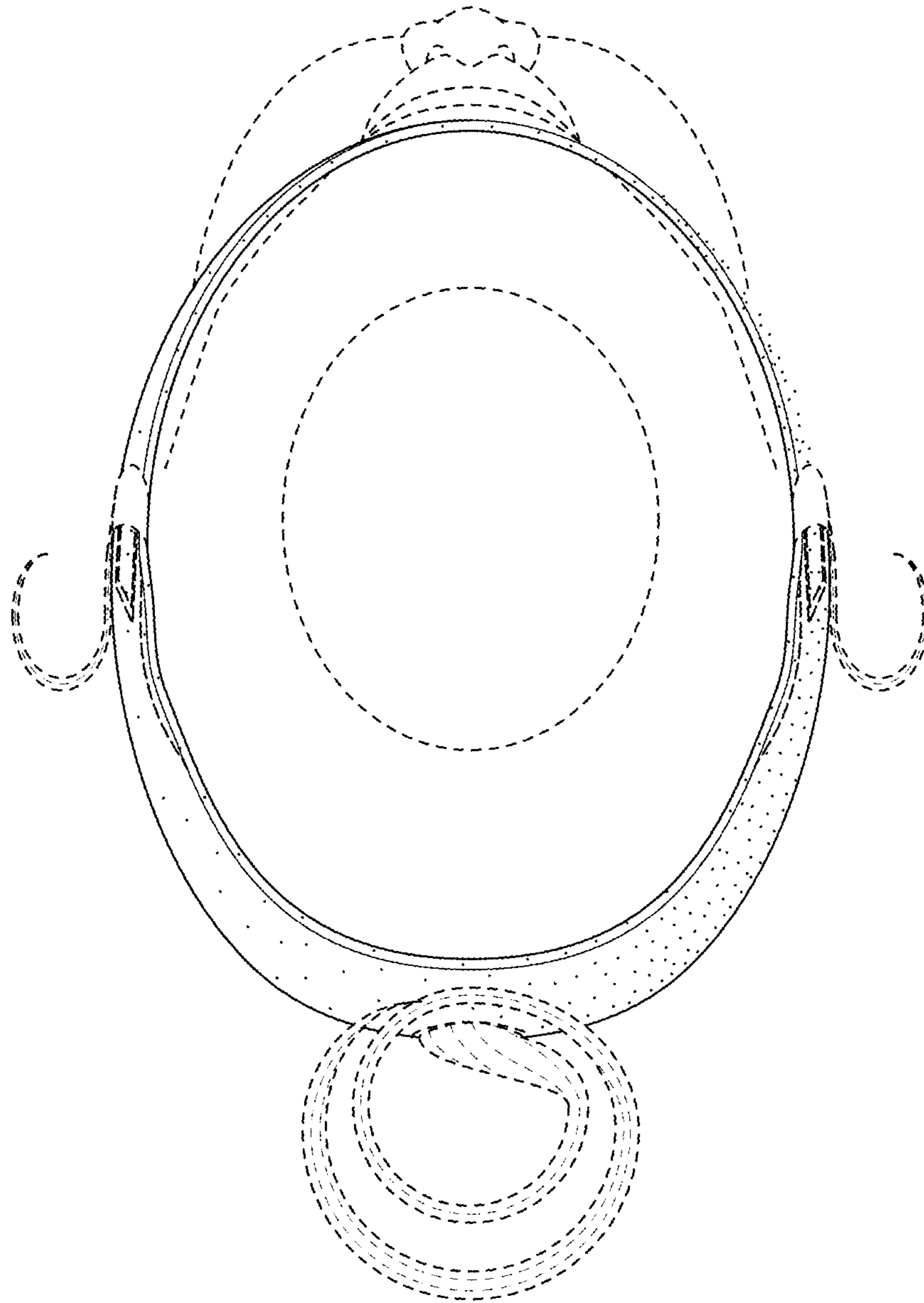

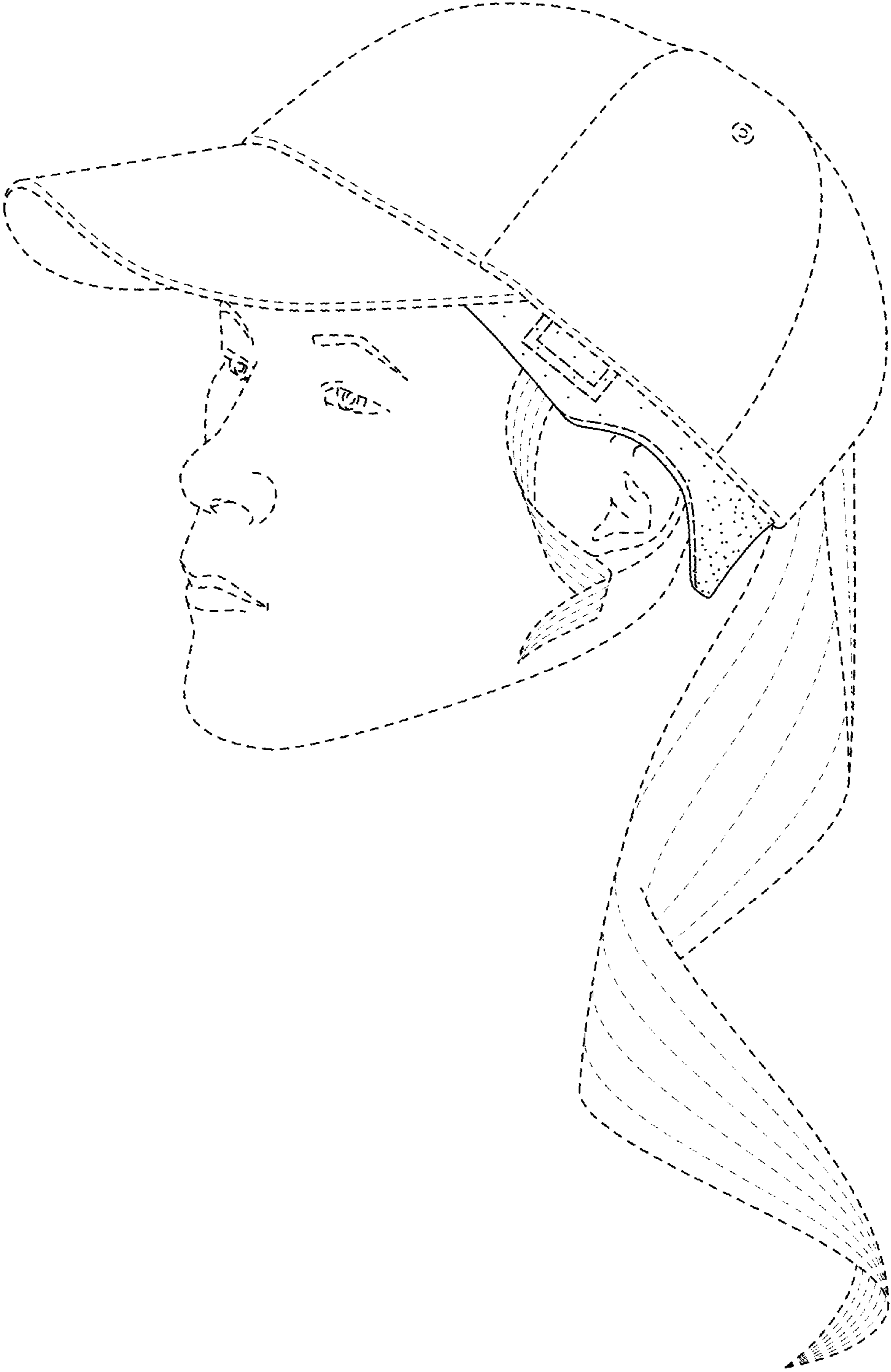
