The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe outsole showing my new design;

FIG. 2 is a bottom view thereof;

FIG. 3 is a rear perspective view thereof;

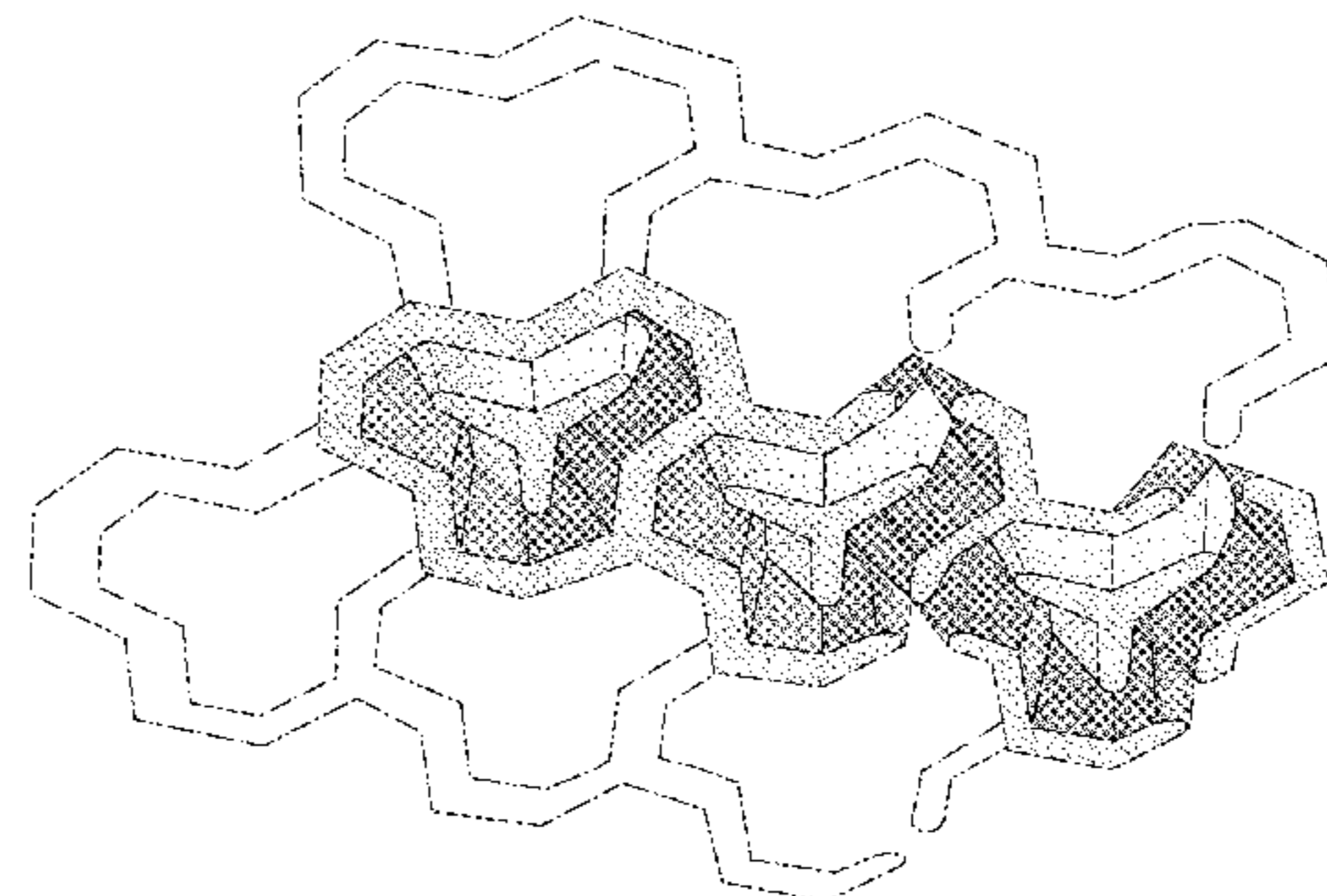
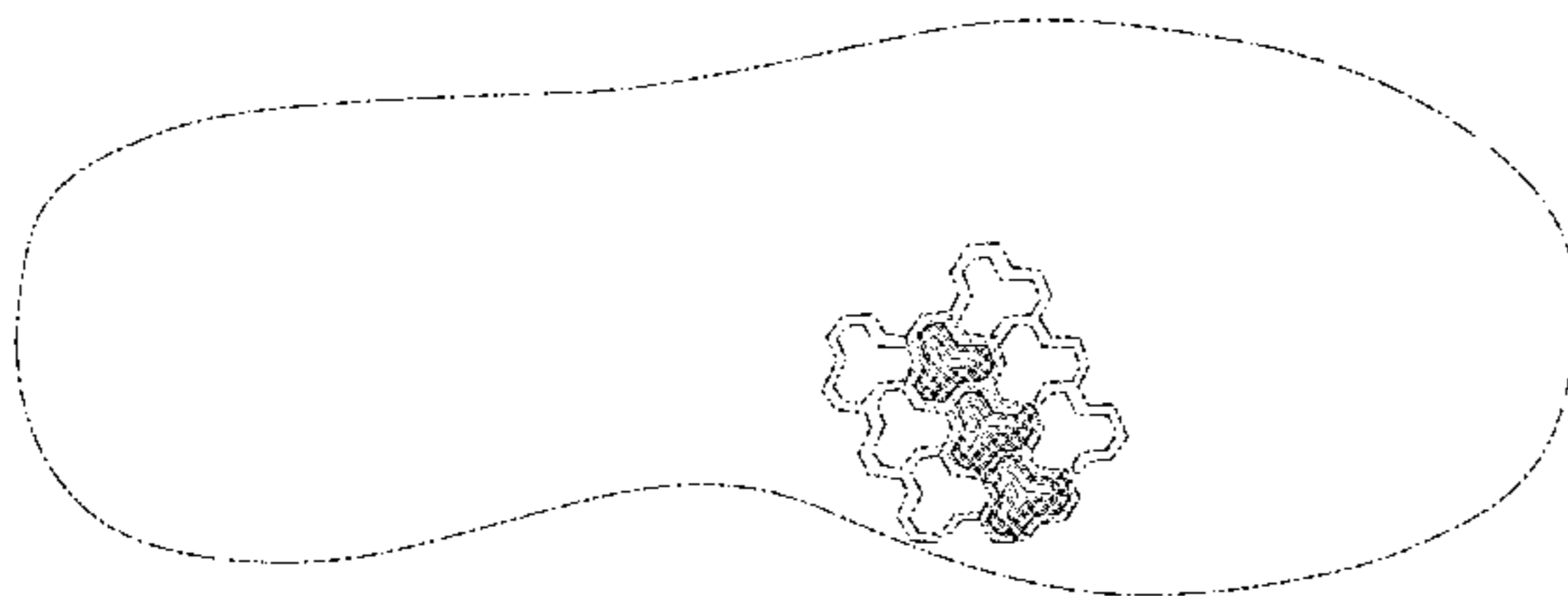
FIG. 4 is an enlarged view of the claimed region of FIG. 1, shown in isolation from the remainder of the shoe for clarity purposes;

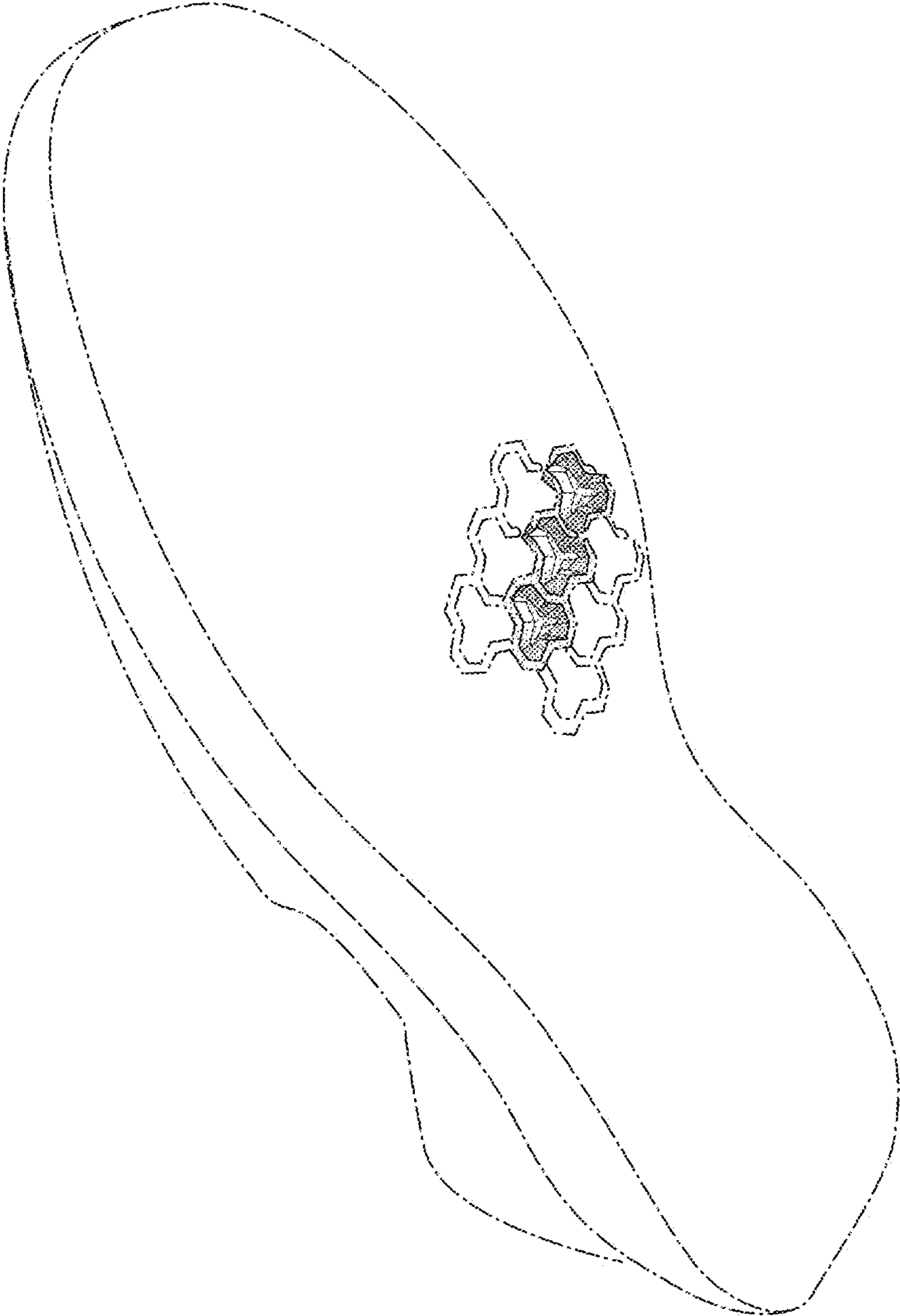

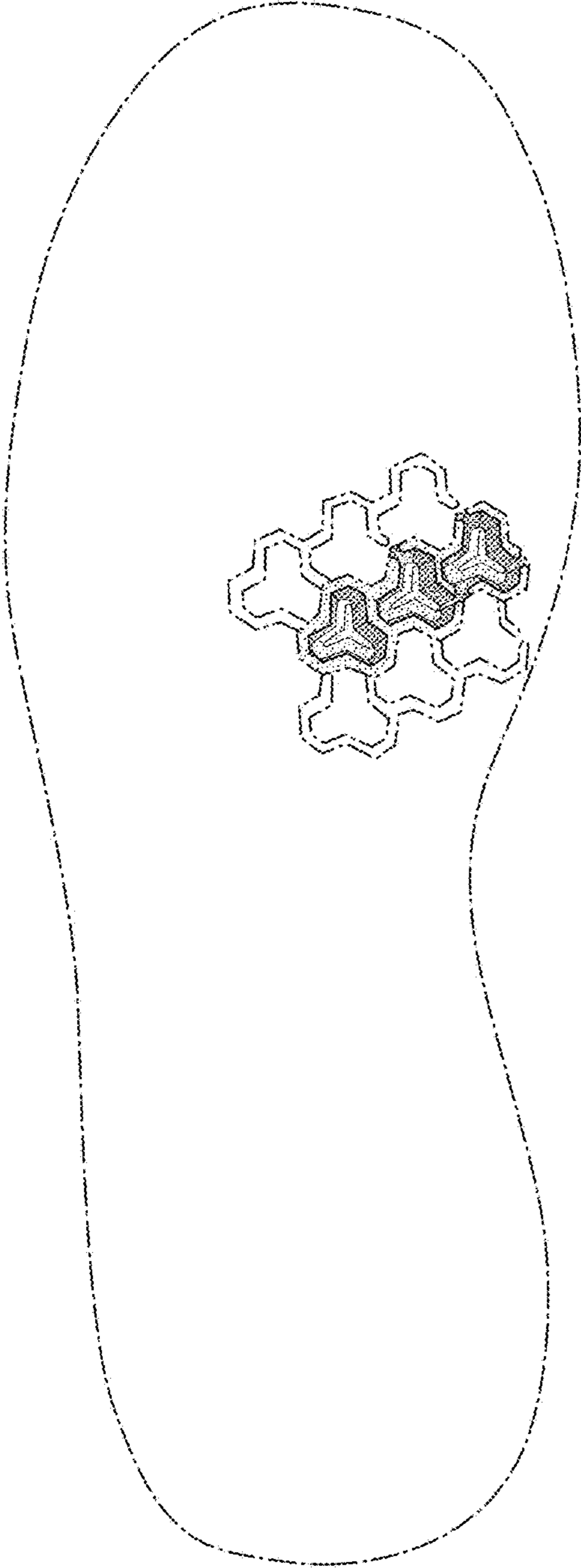

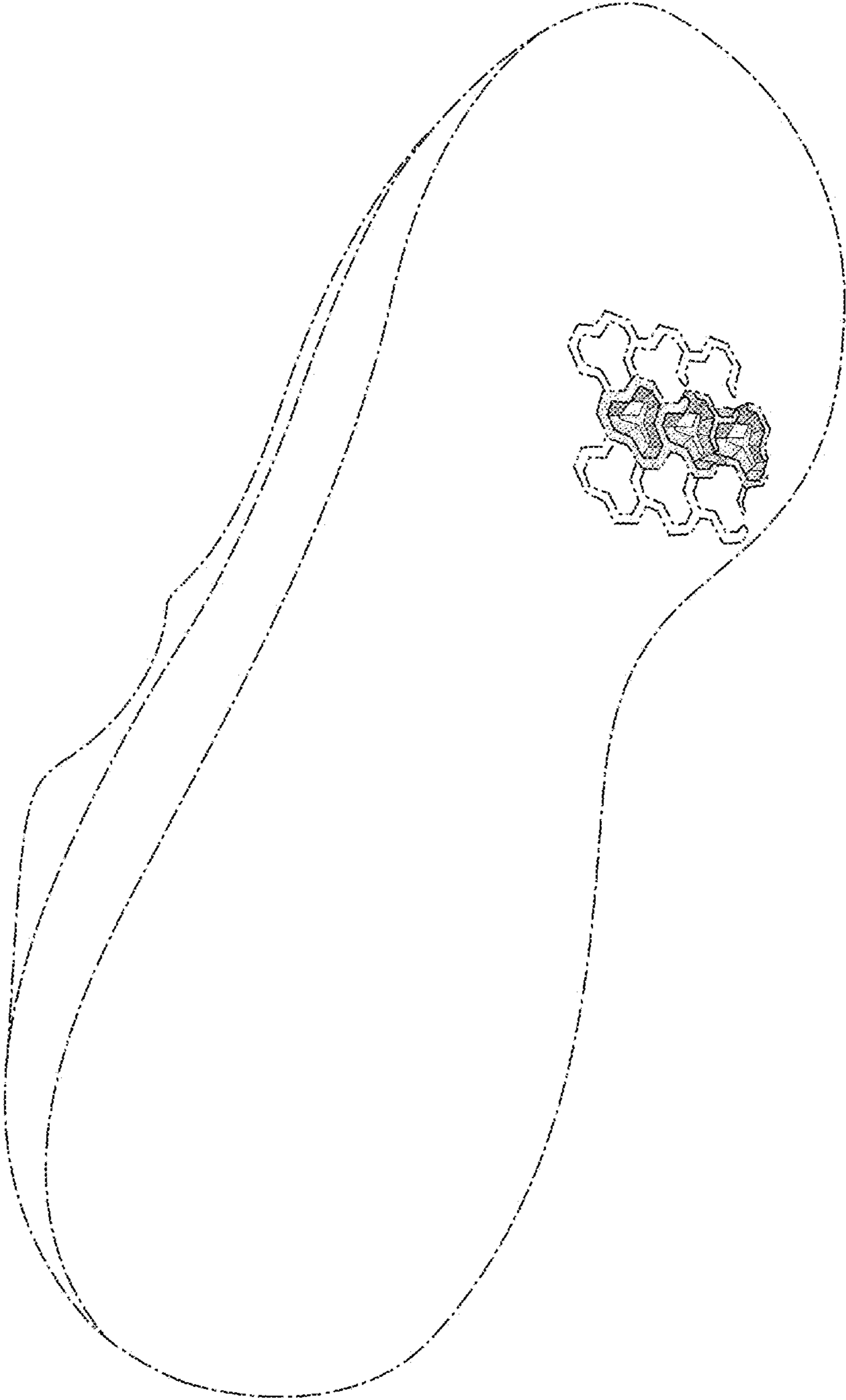

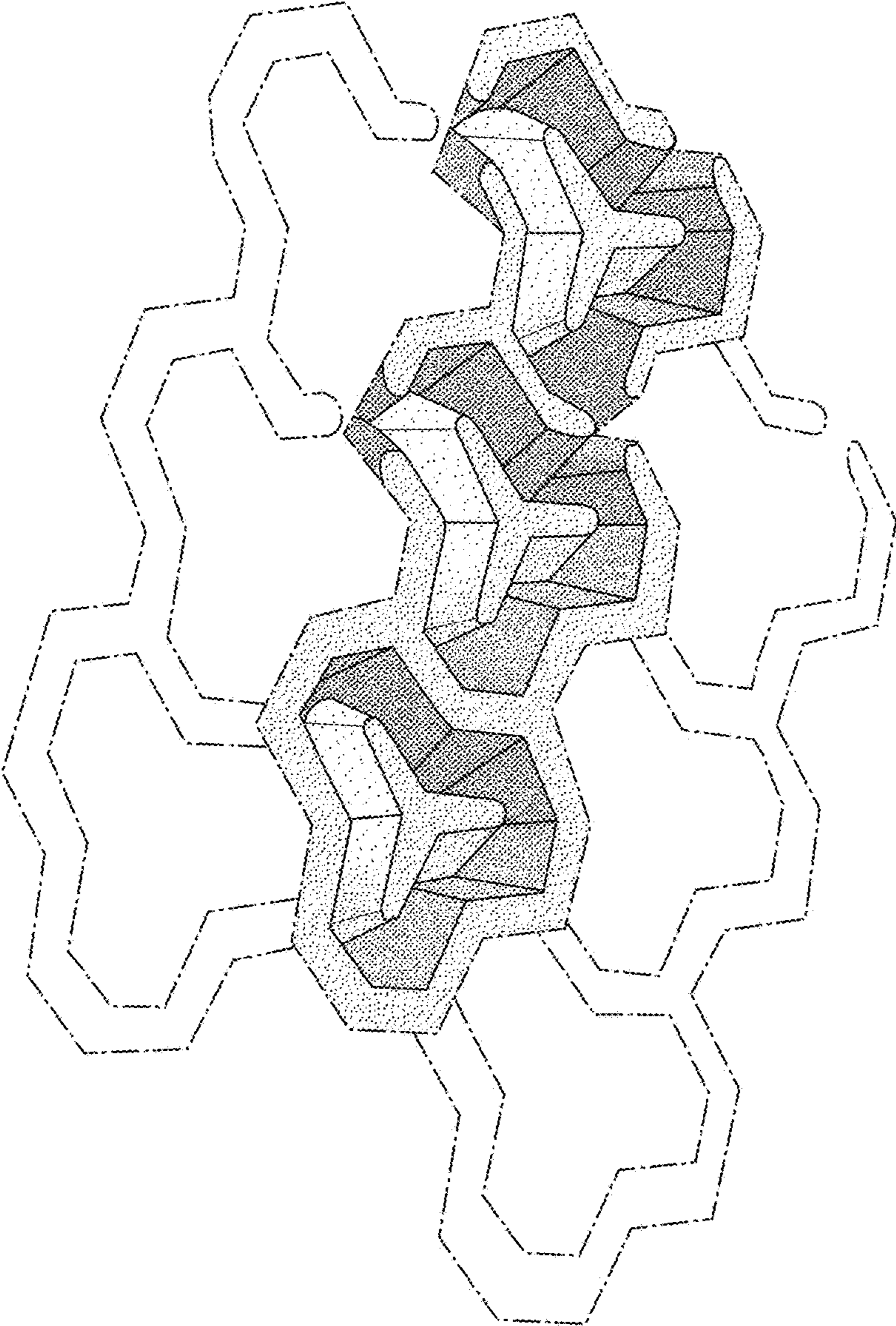

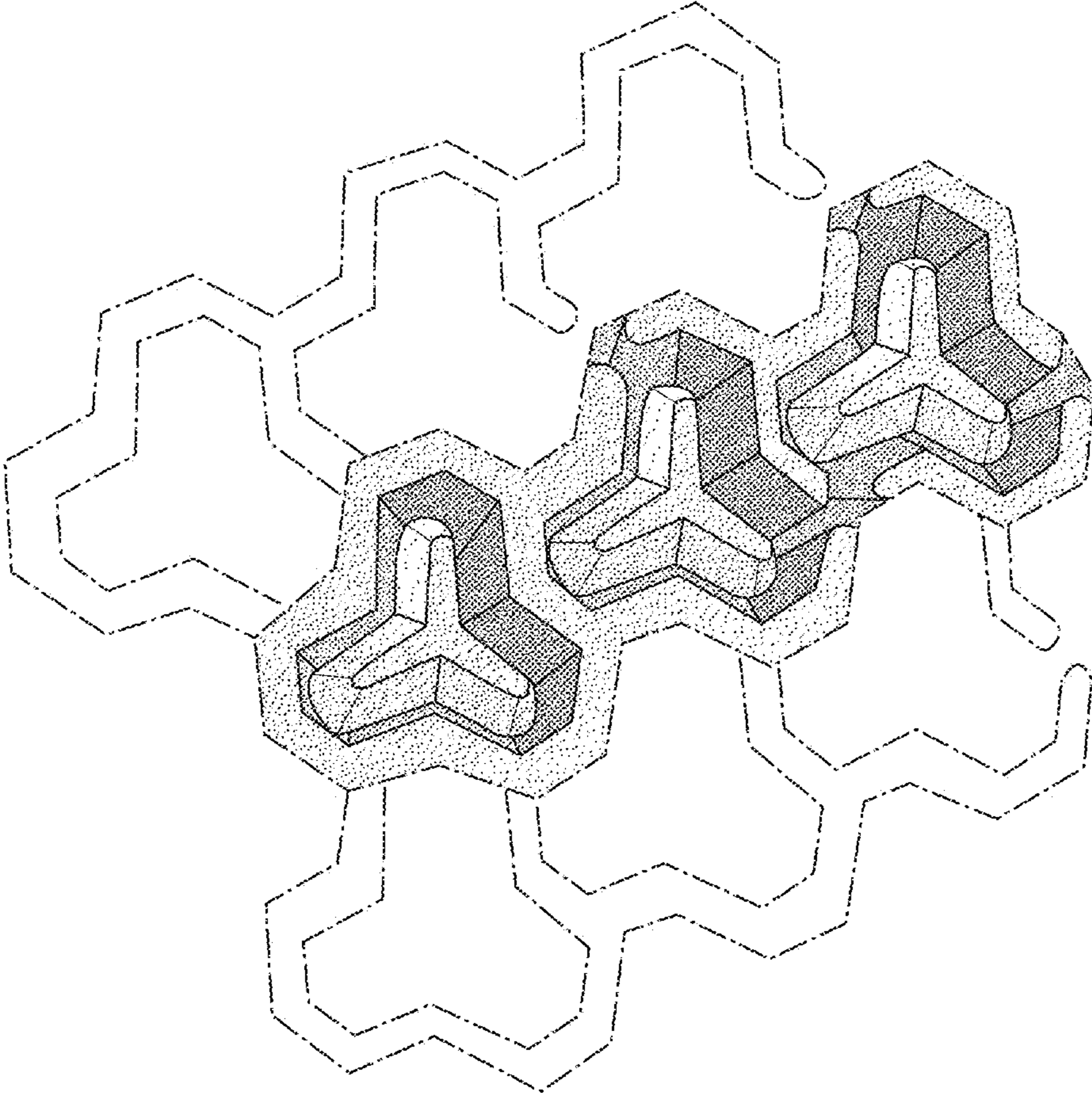

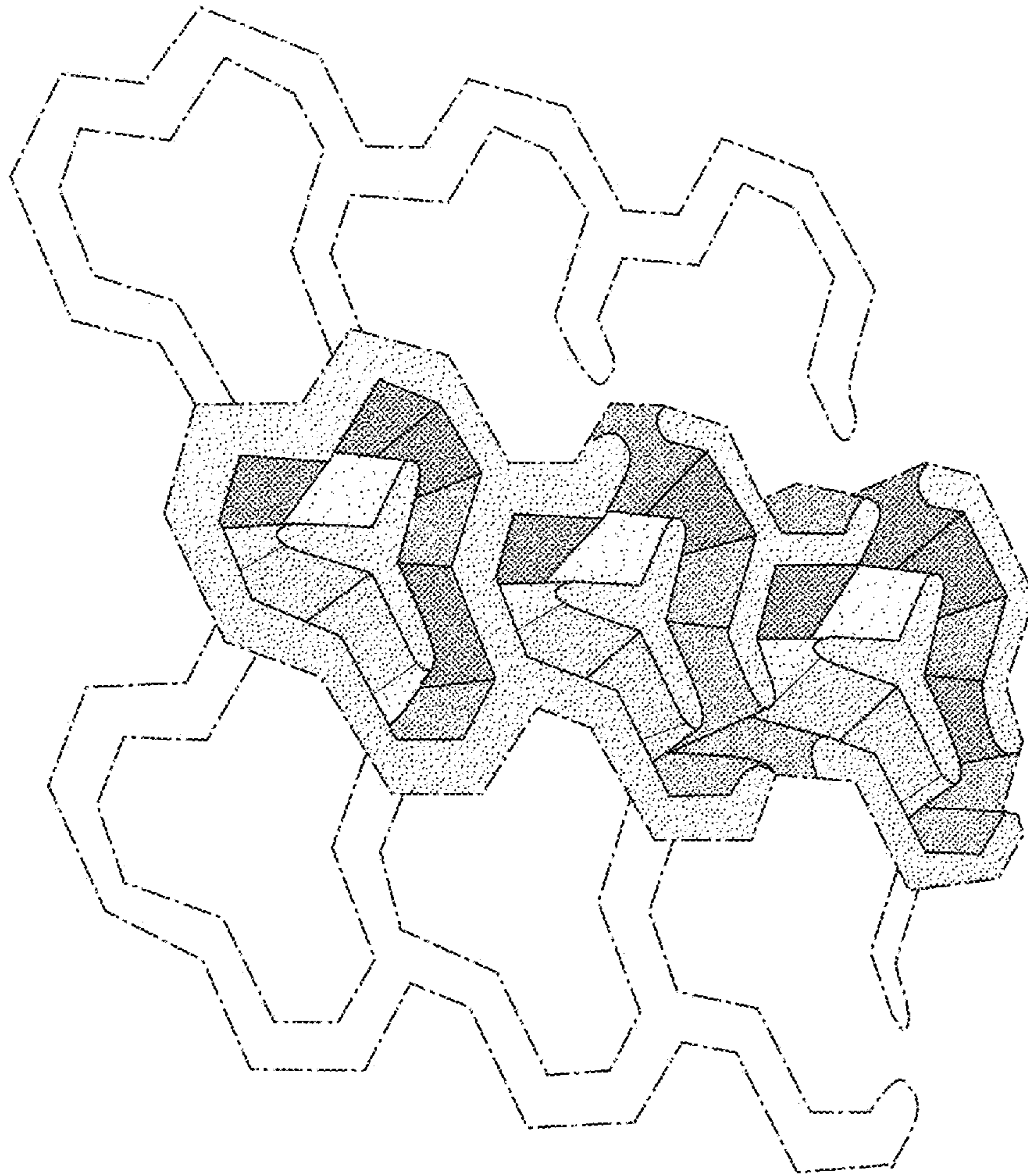
