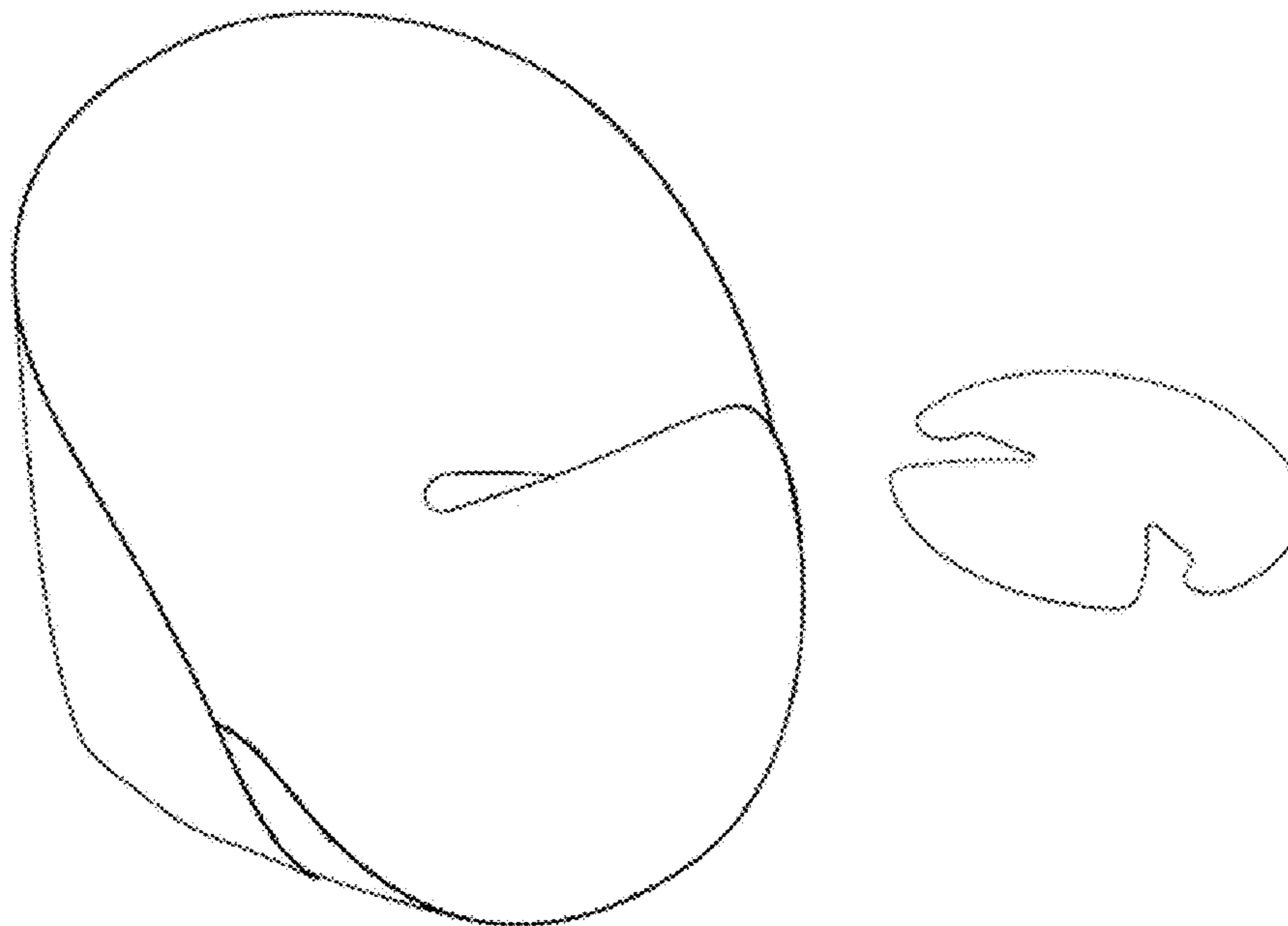
(57) **CLAIM**

The ornamental design for a foldable seat, as shown and described.

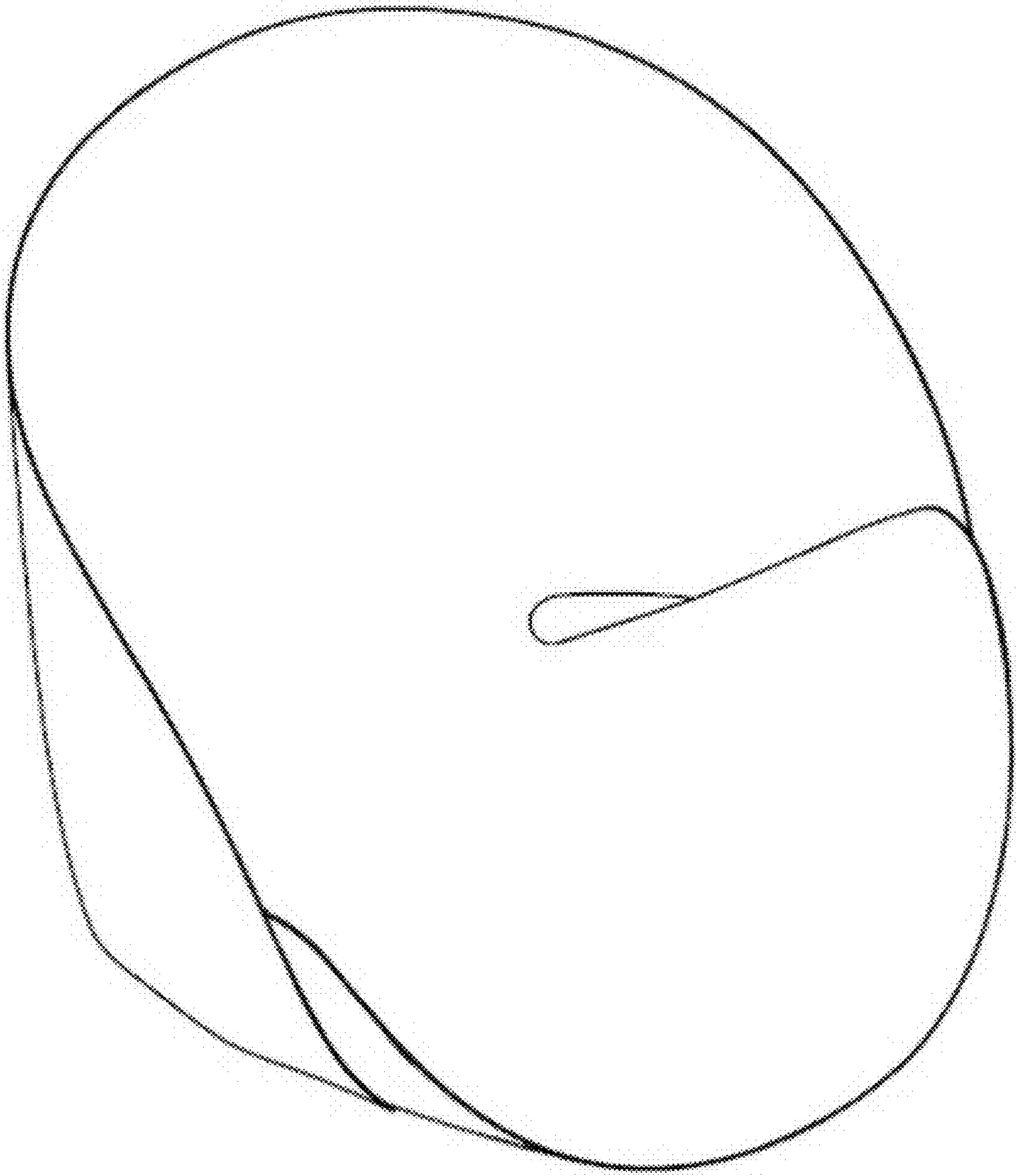
**DESCRIPTION**

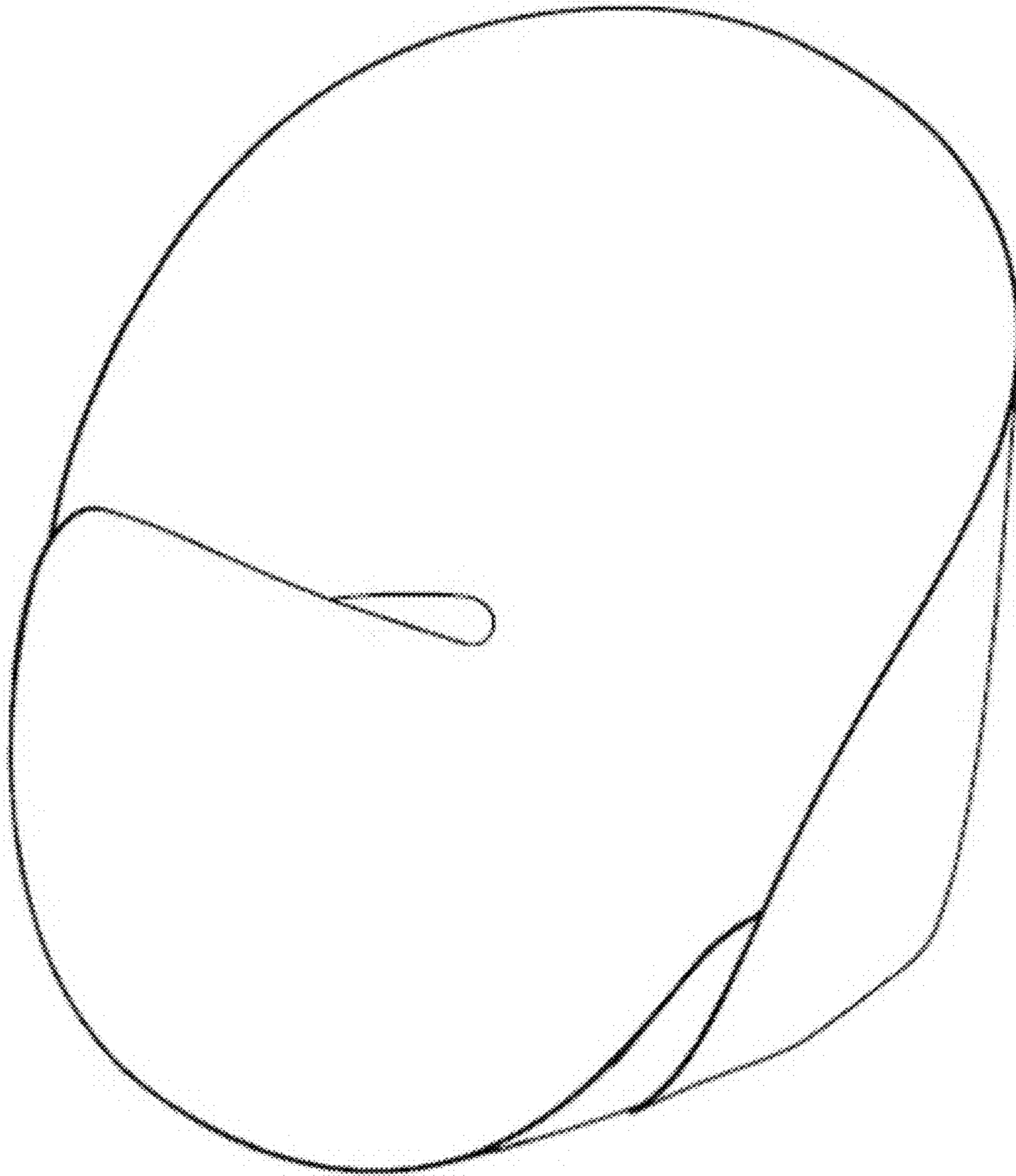

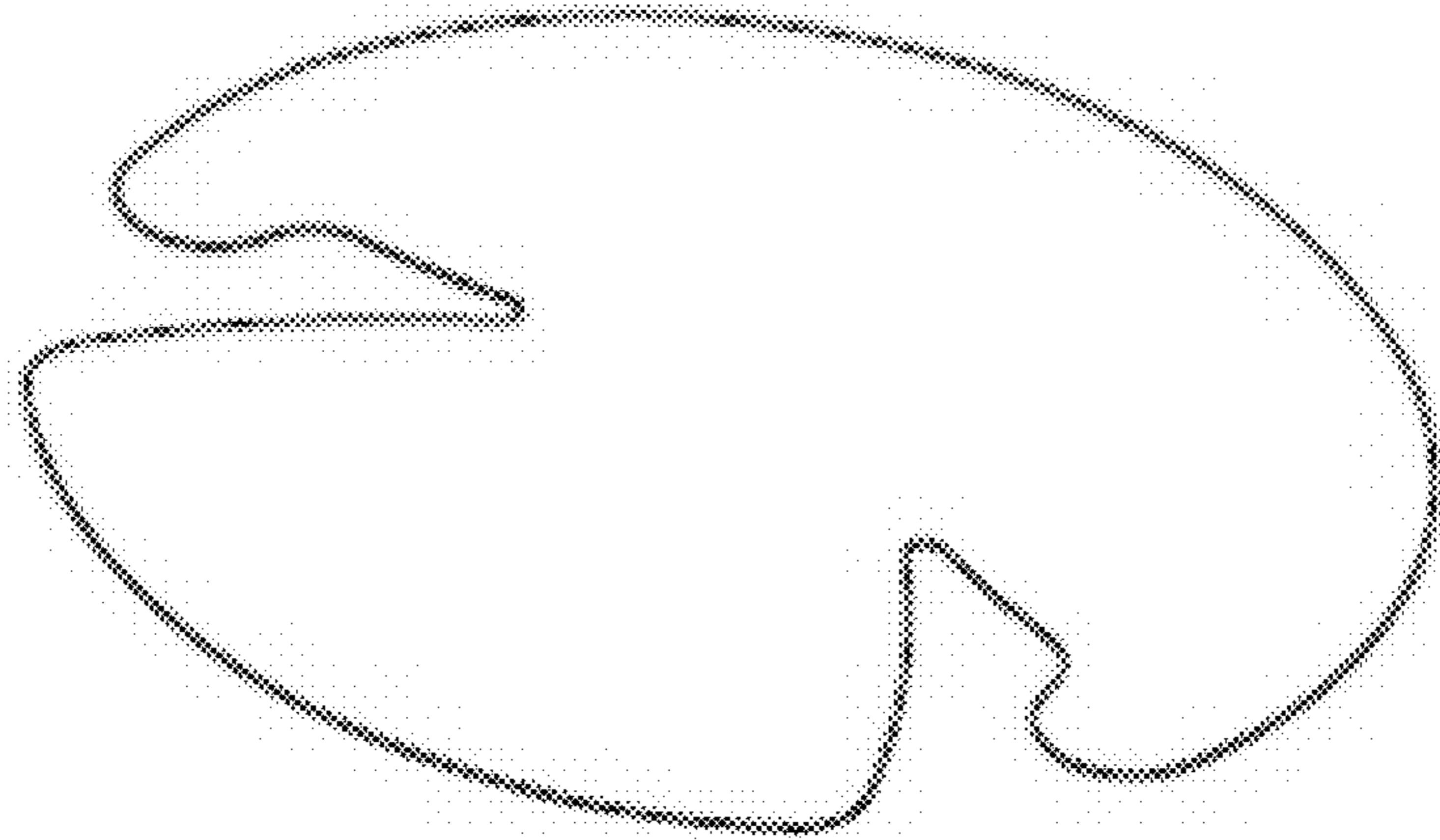
