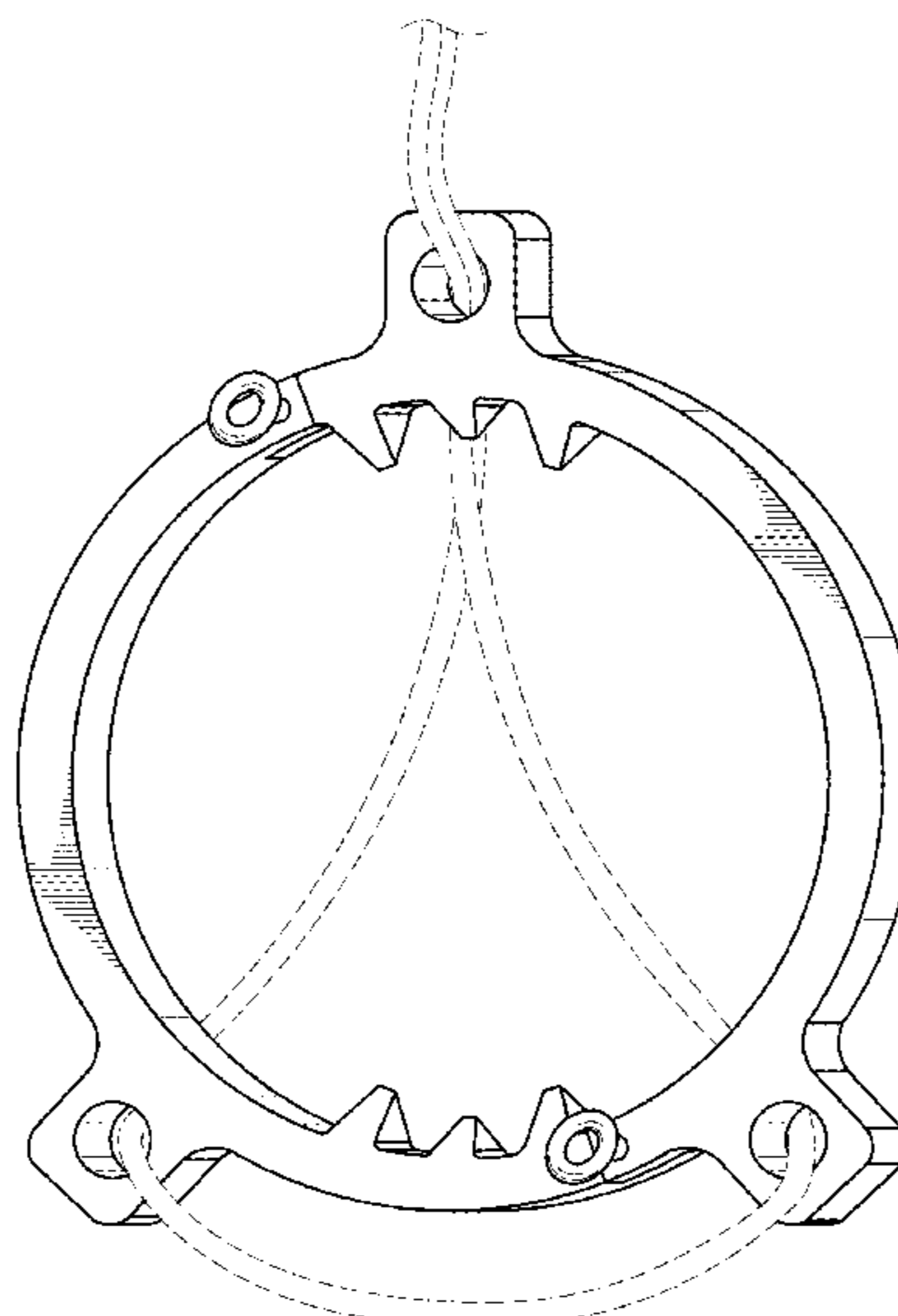
(57) **CLAIM**

The ornamental design for a pole gripper, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a pole gripper showing our new design;
FIG. 2 is a bottom plan view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a right side elevation view thereof;
FIG. 5 is a left side elevation view thereof;
FIG. 6 is a rear elevation view thereof;
FIG. 7 is a front elevation view thereof;
FIG. 8 is a perspective view thereof with environment;
FIG. 9 is a perspective view of a second embodiment of a pole gripper showing our new design;
FIG. 10 right side elevation view thereof;
FIG. 11 is a left side elevation view thereof;
FIG. 12 is a rear elevation view thereof;
FIG. 13 is a front elevation view thereof; and,
FIG. 14 is a bottom plan view thereof.

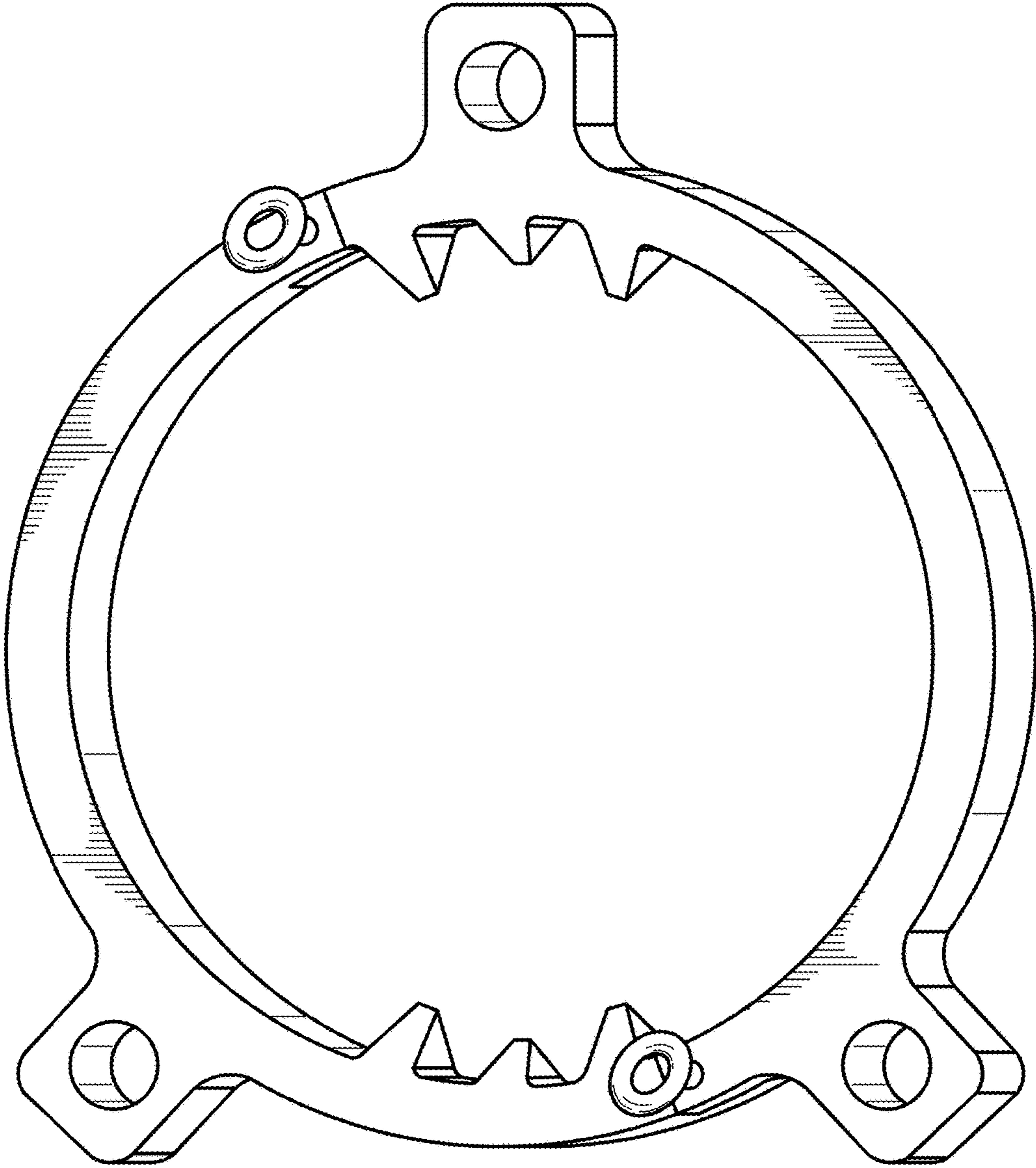

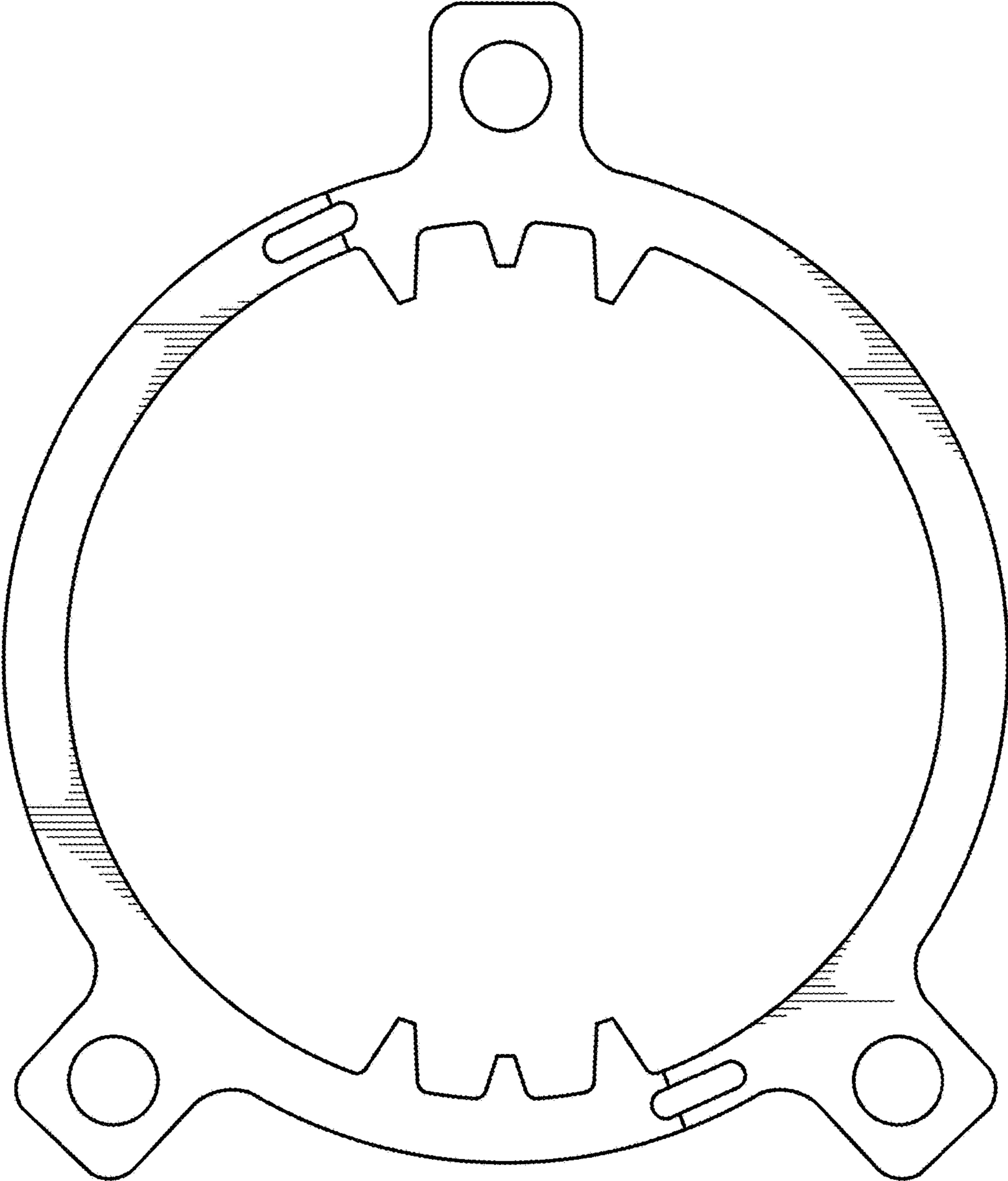

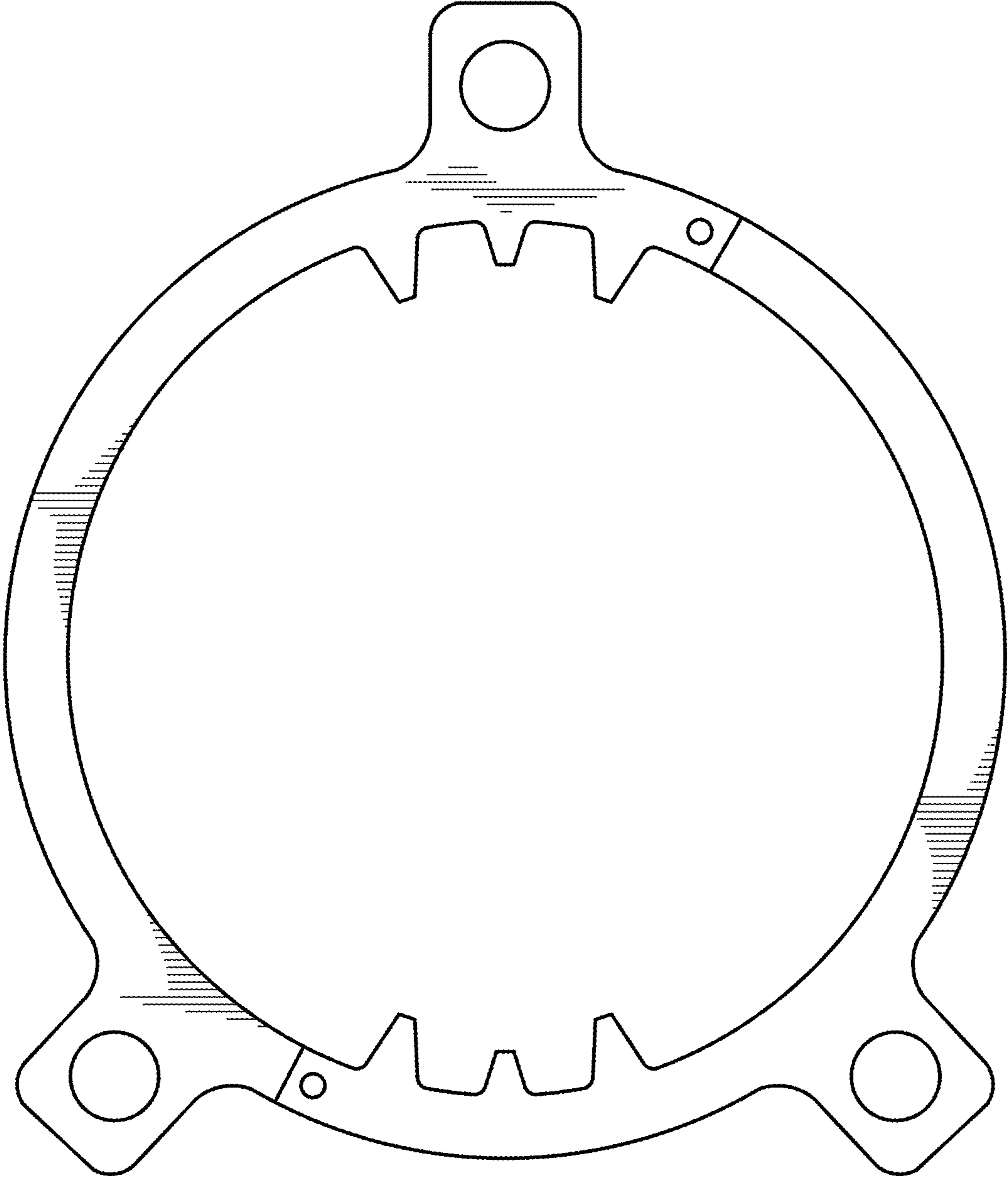

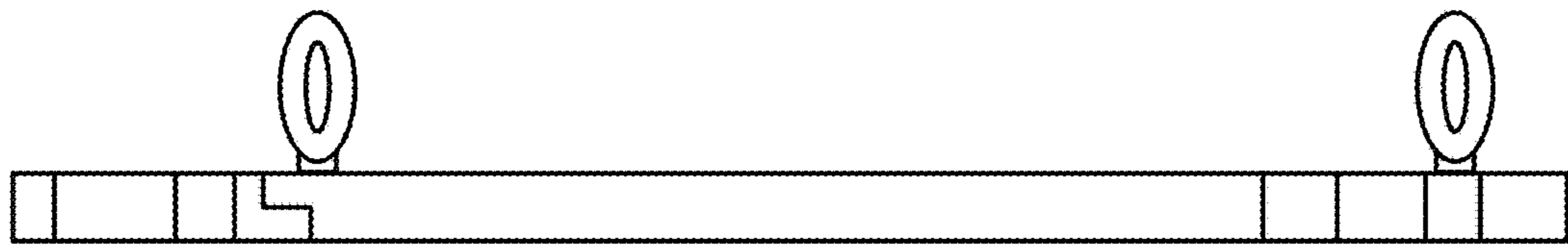

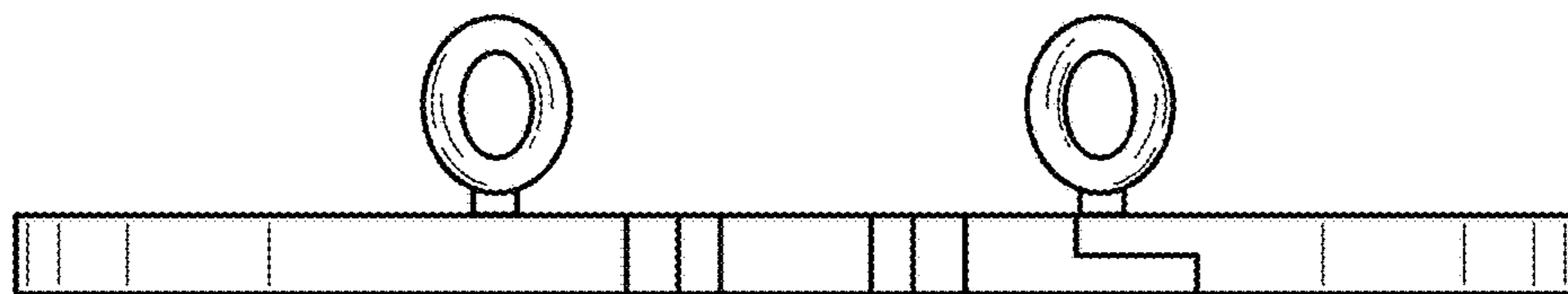

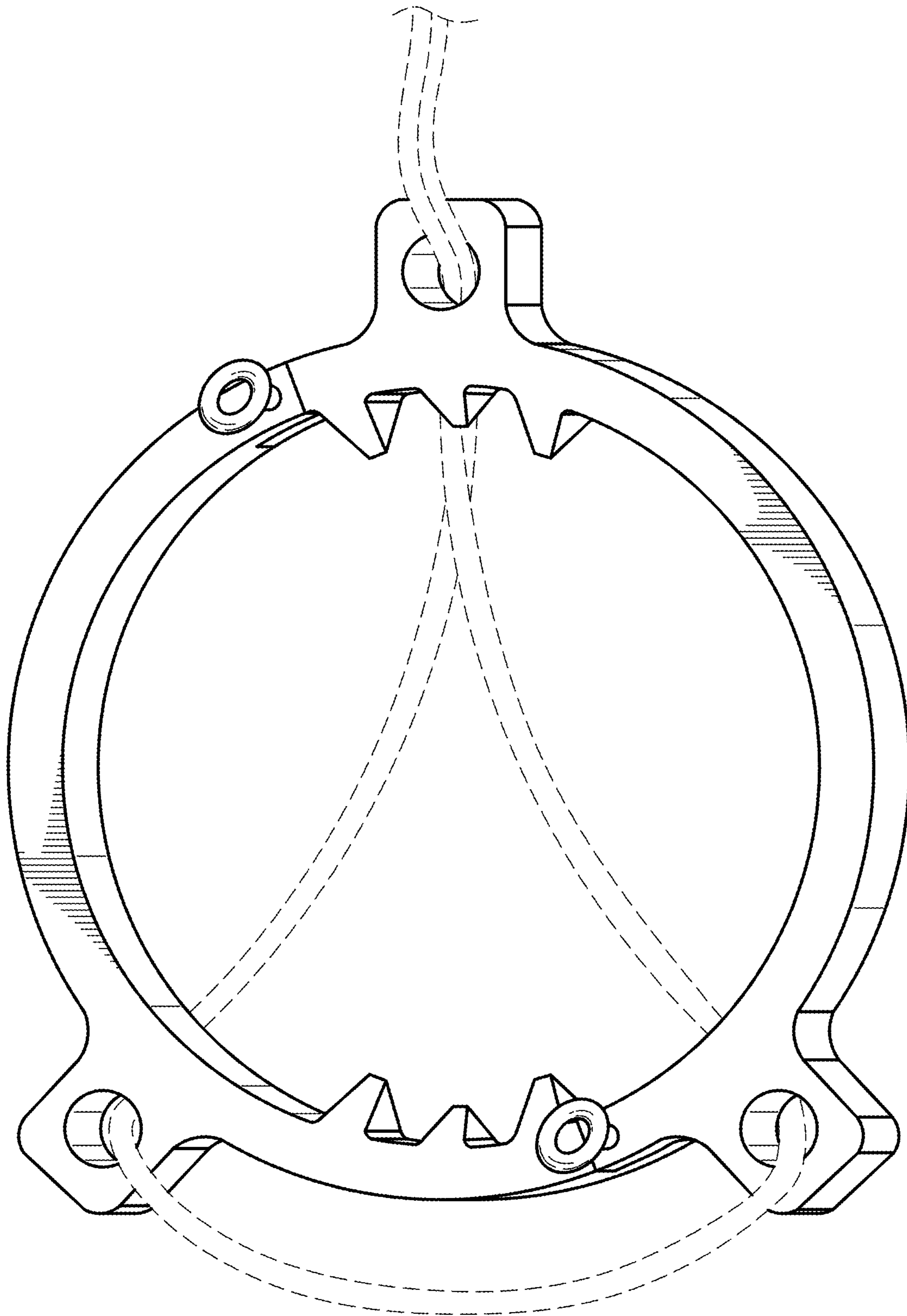

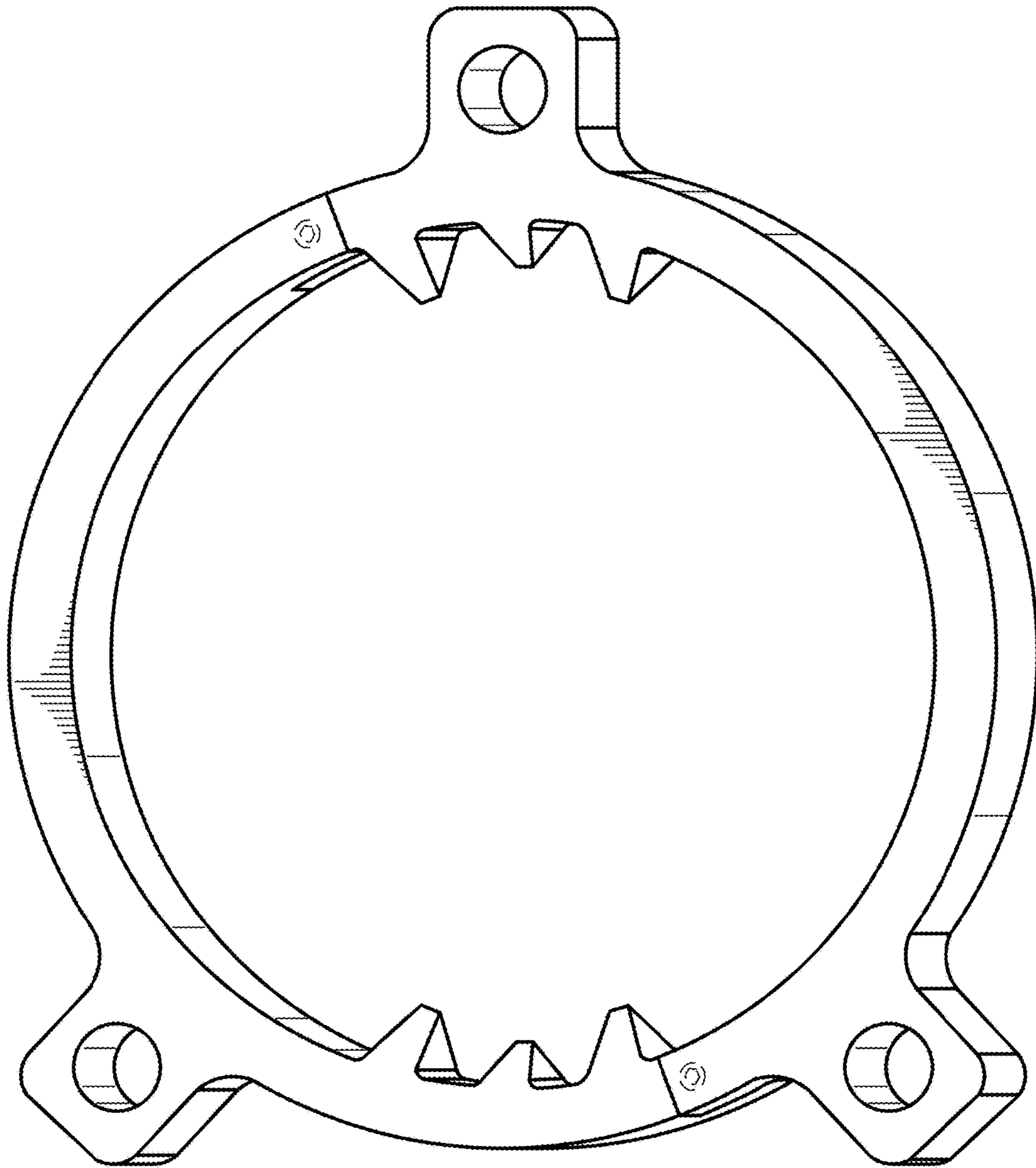

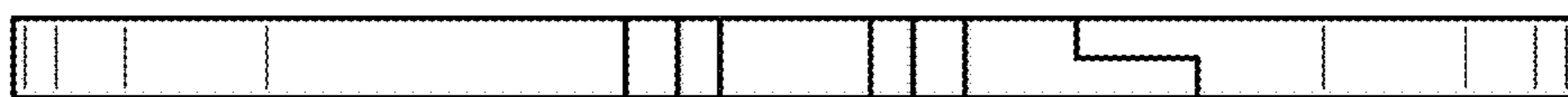

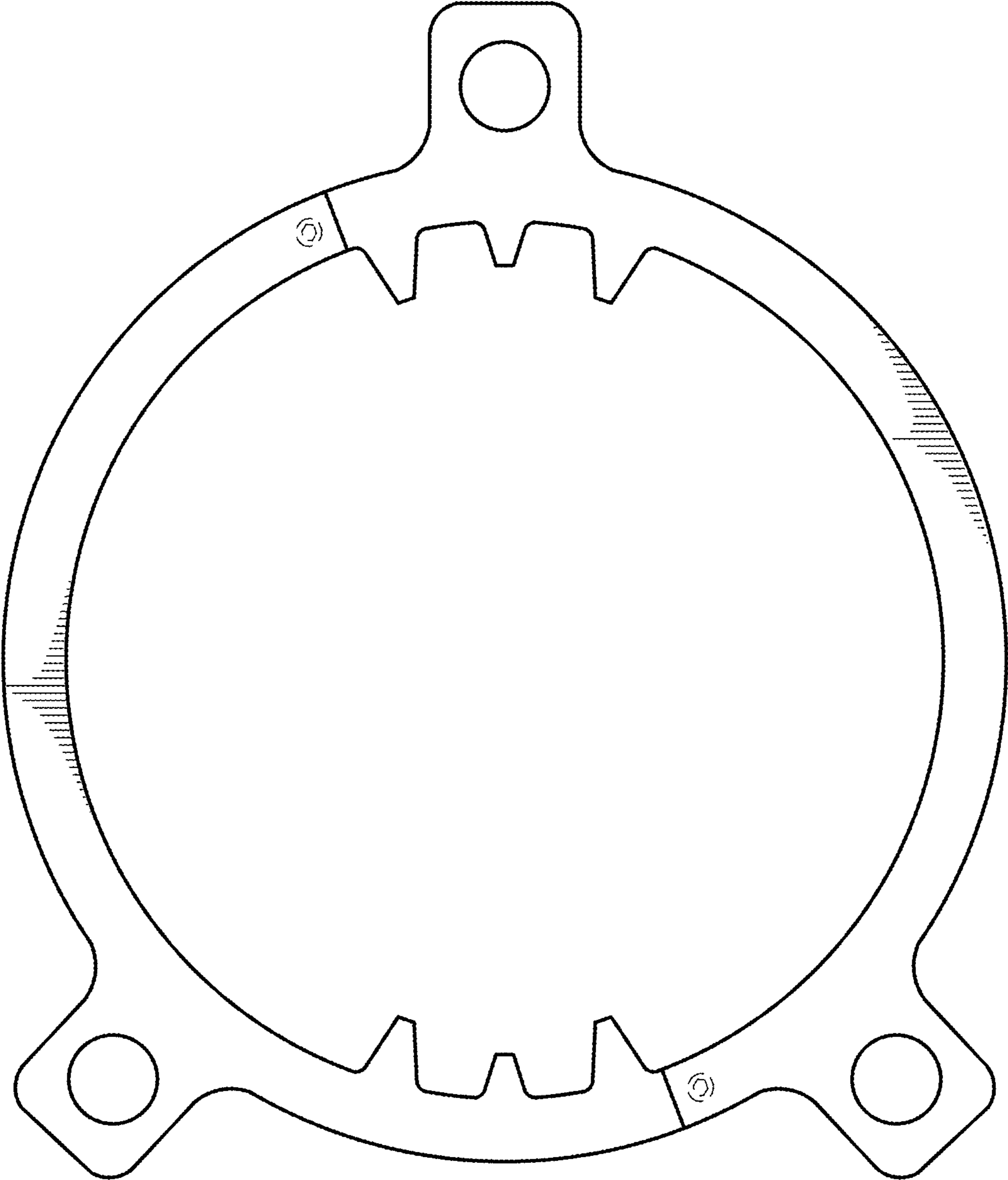
