The ornamental design for a front end of a vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a right, front perspective view of a front end of a vehicle showing our new design;
FIG. 2 is a left, rear perspective view thereof;
FIG. 3 is a front view thereof.
FIG. 4 is a left side view thereof.
FIG. 5 is a right side view thereof; and,
FIG. 6 is a top view thereof.

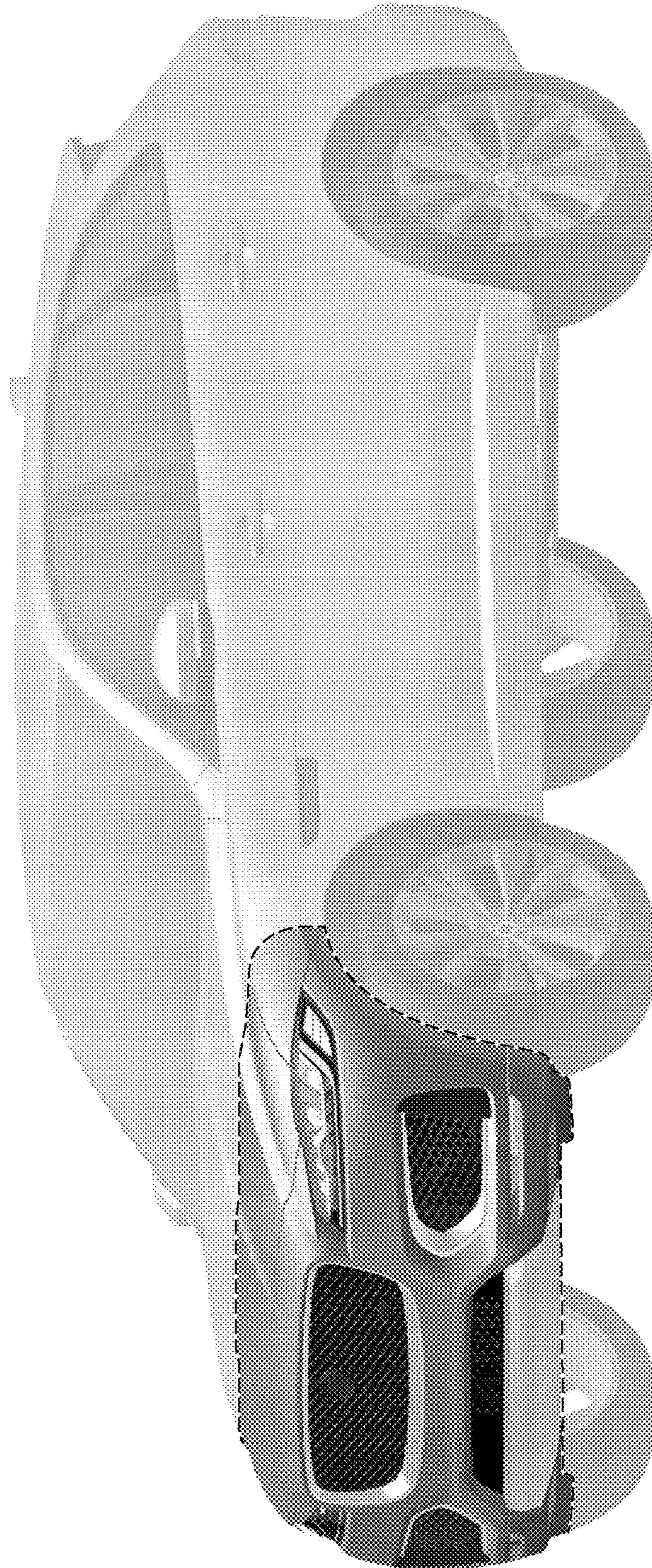

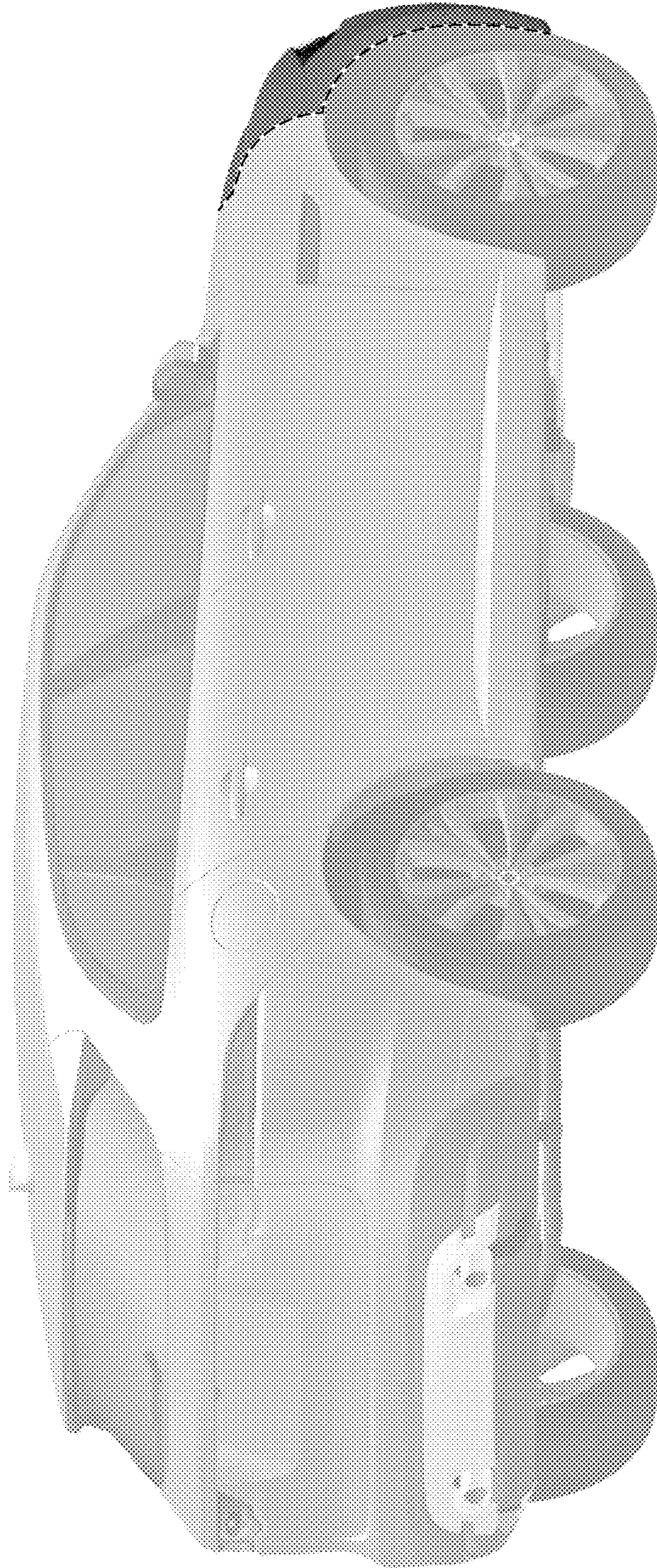

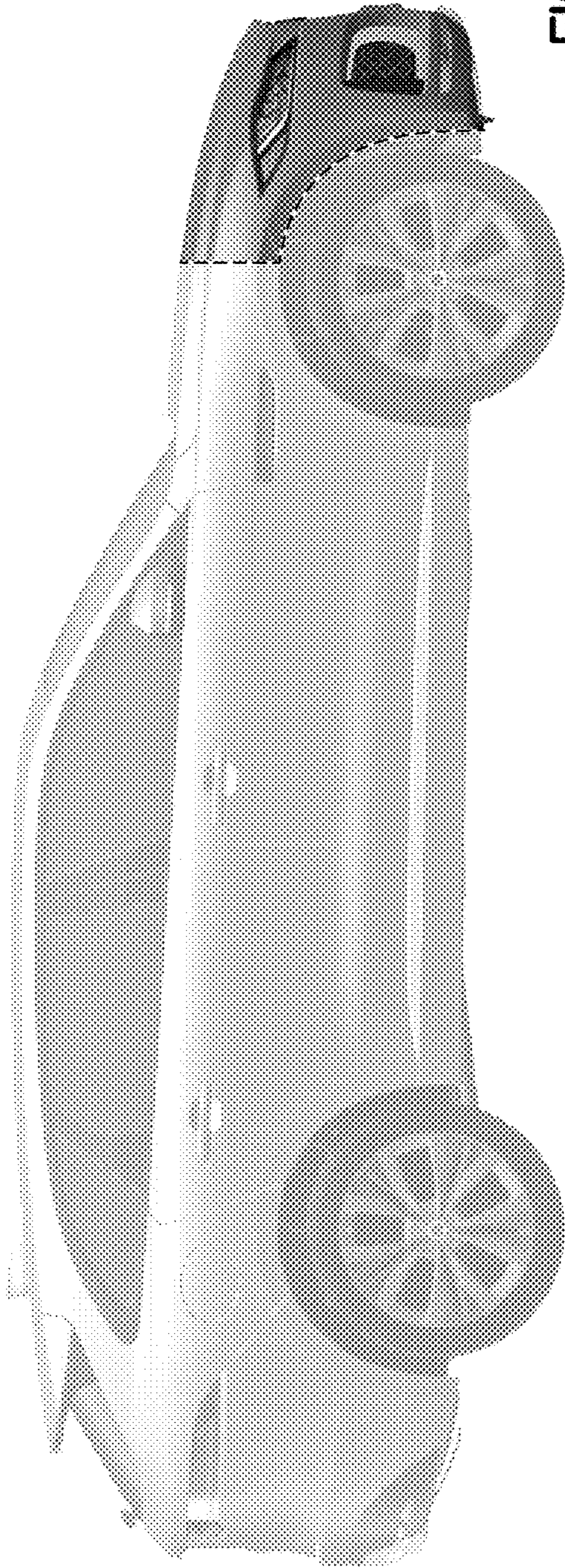

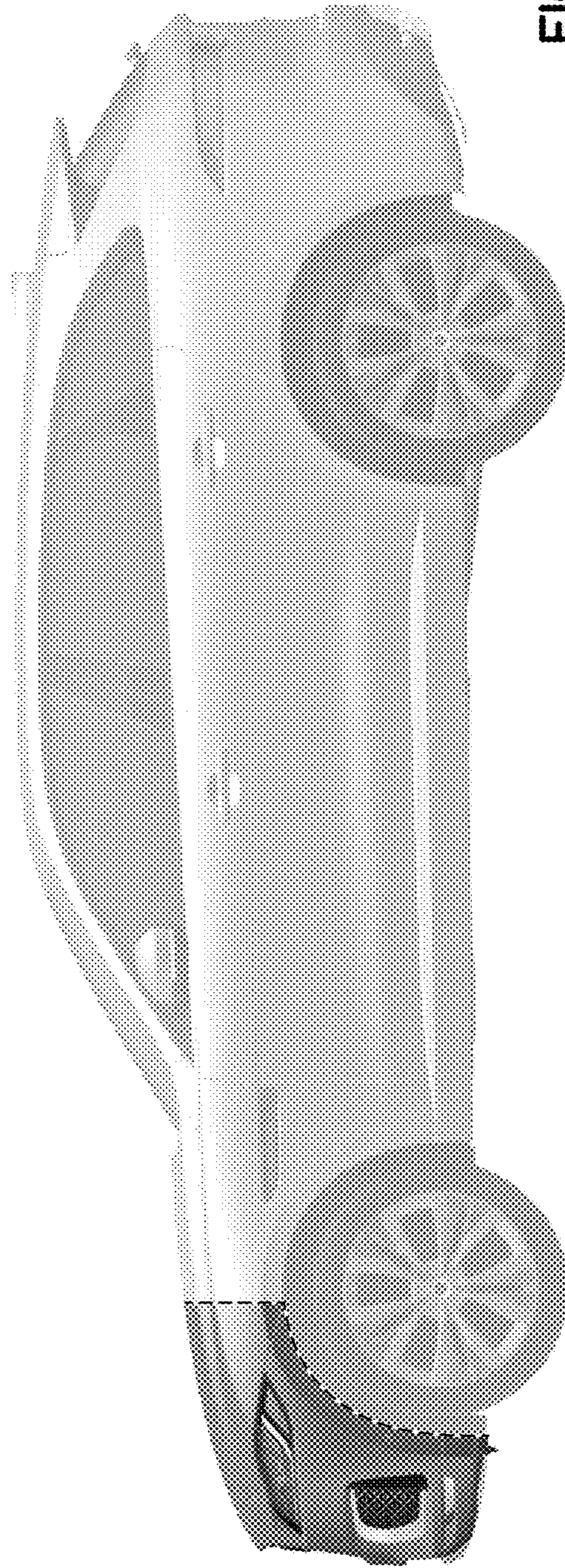

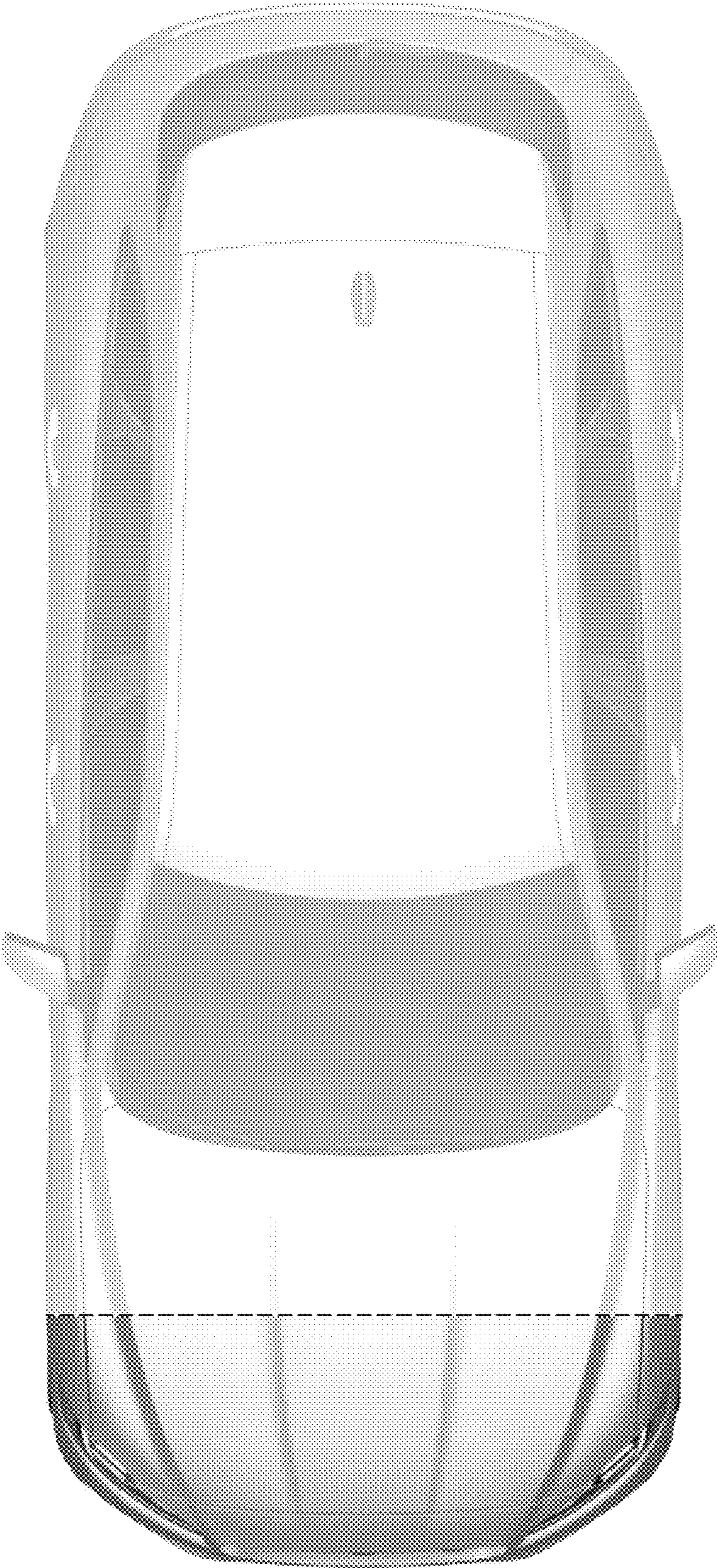
