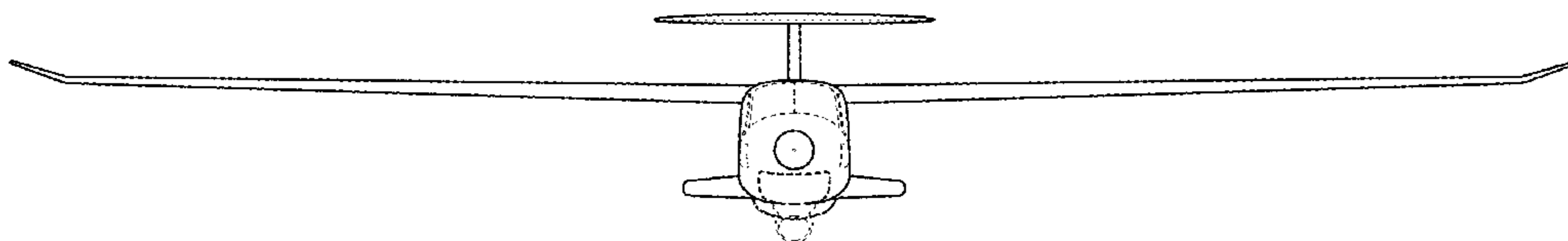
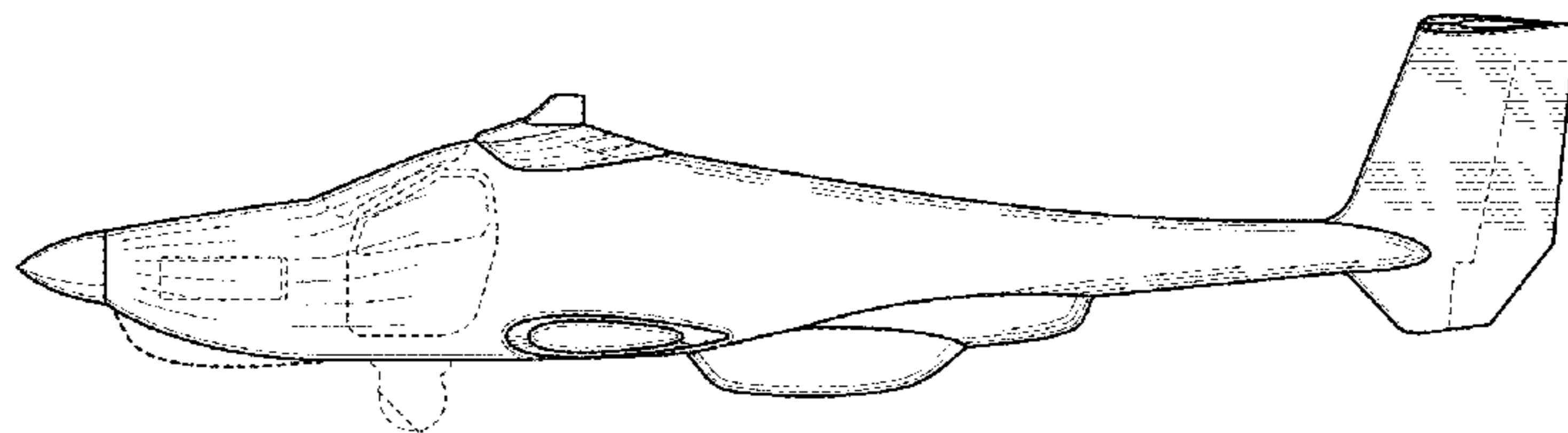
FIG. 1 is a side view for an aircraft, showing the new design,

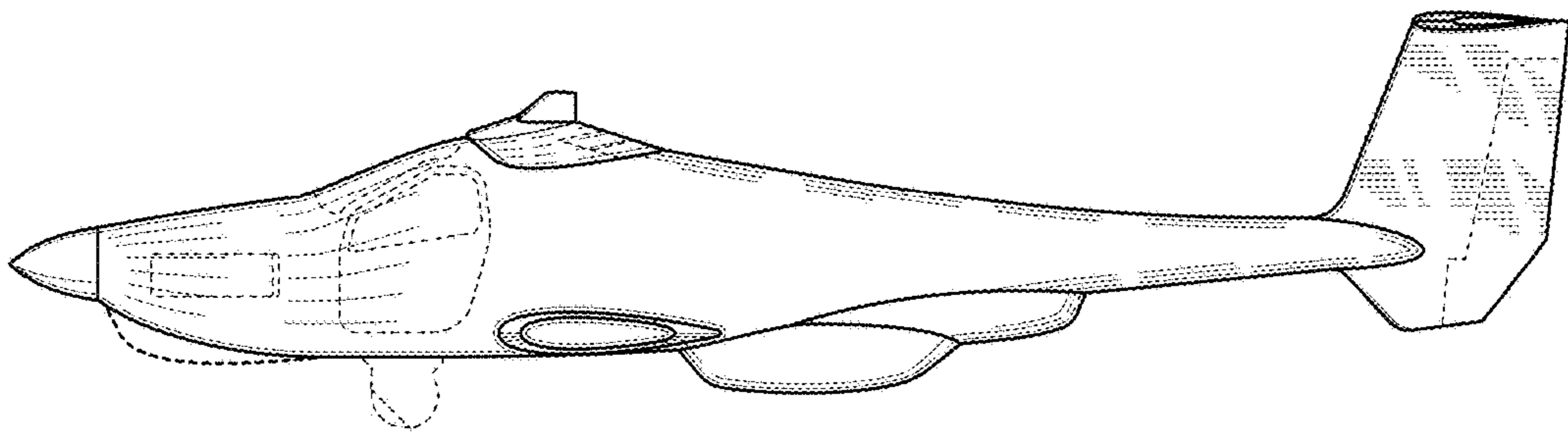

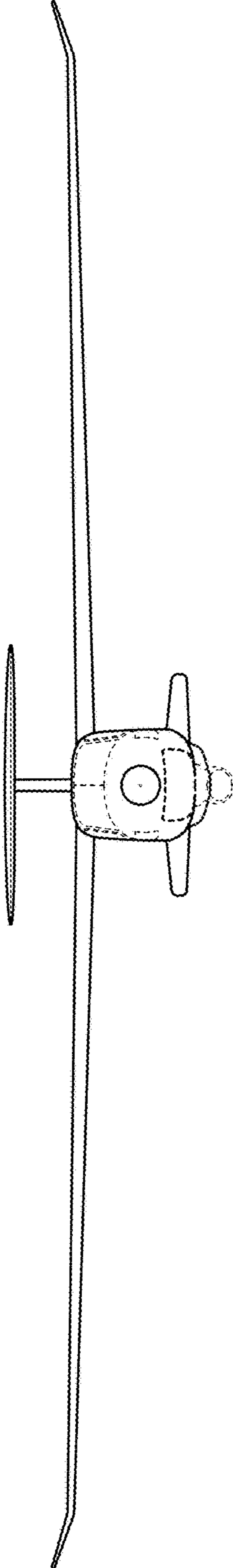

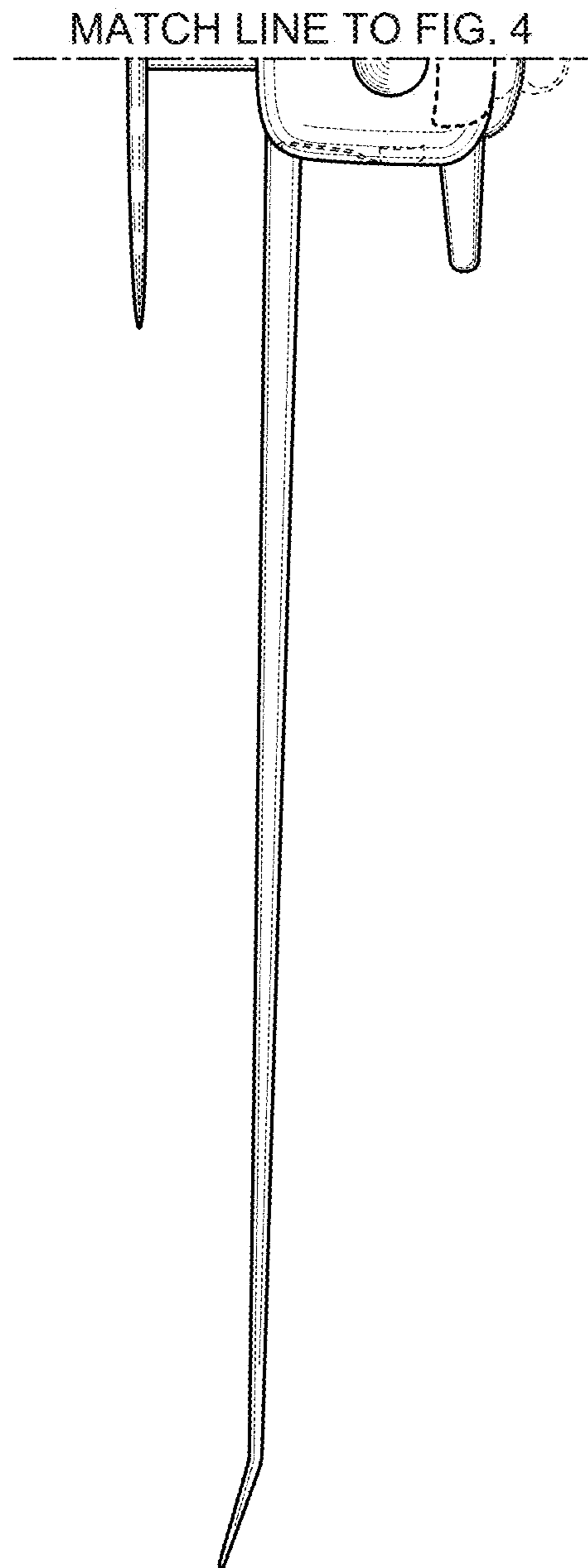

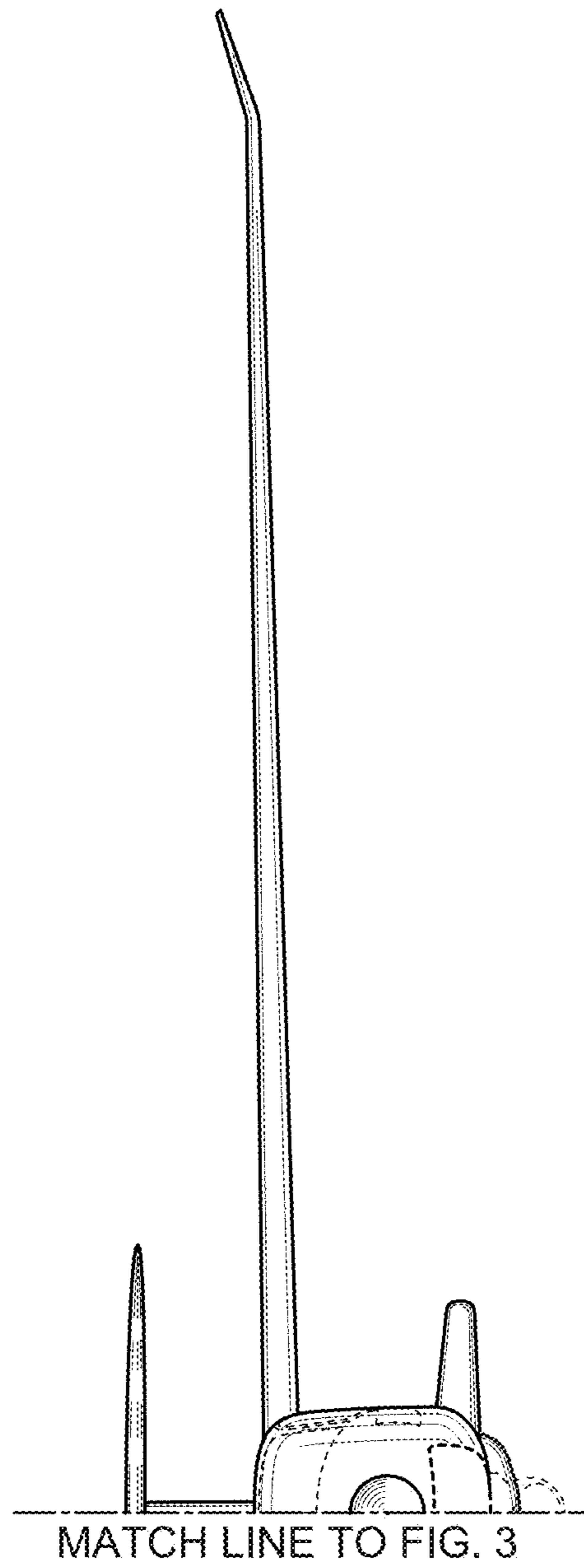

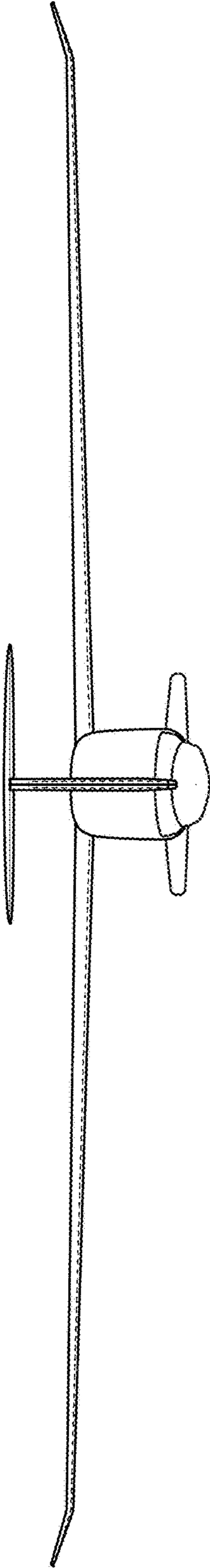

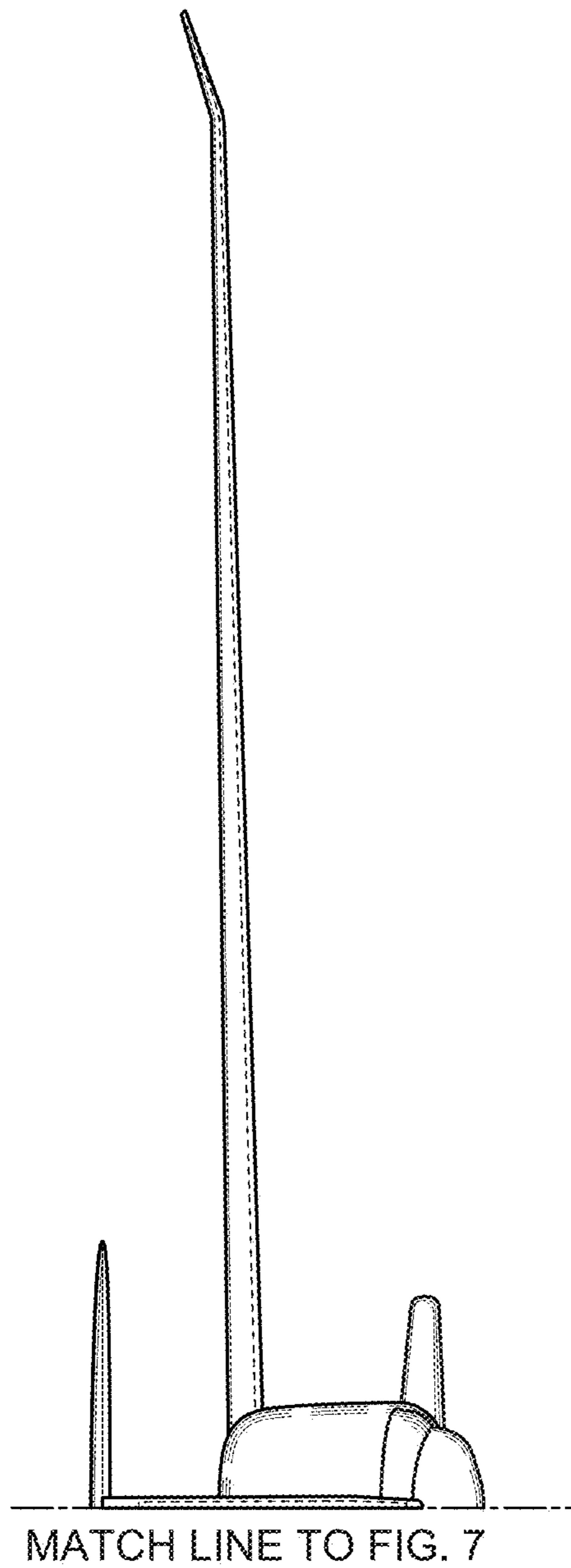
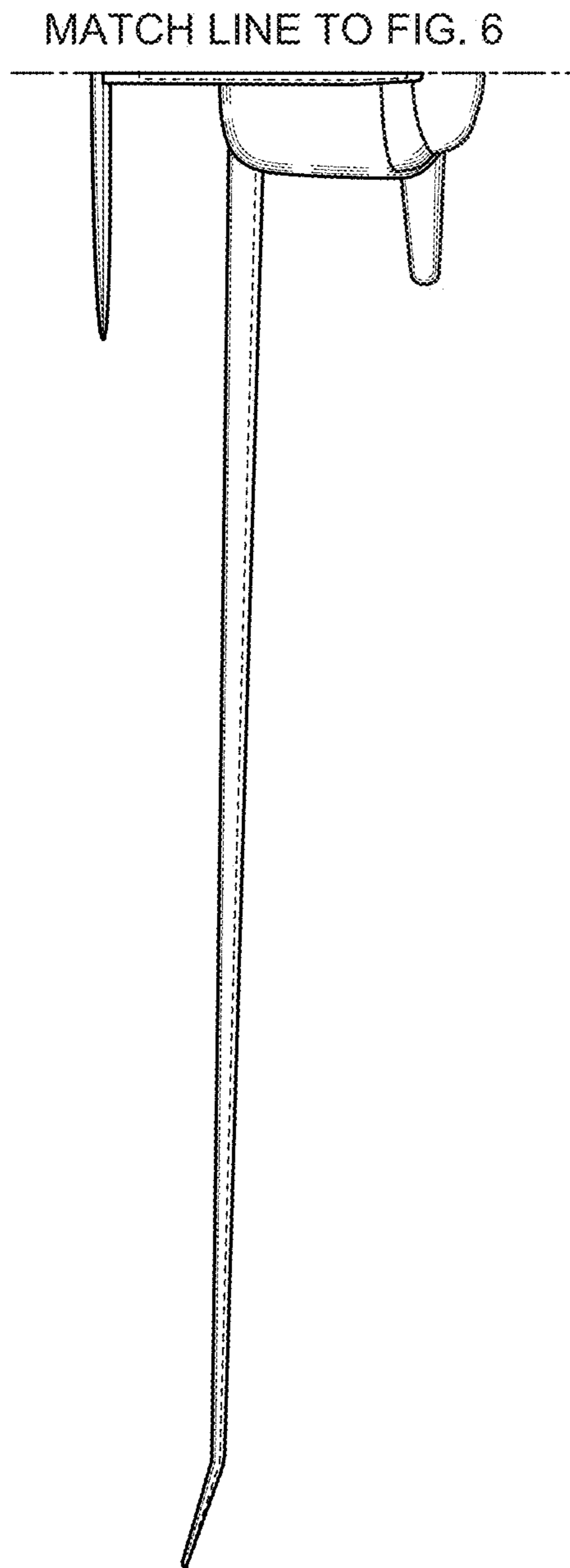

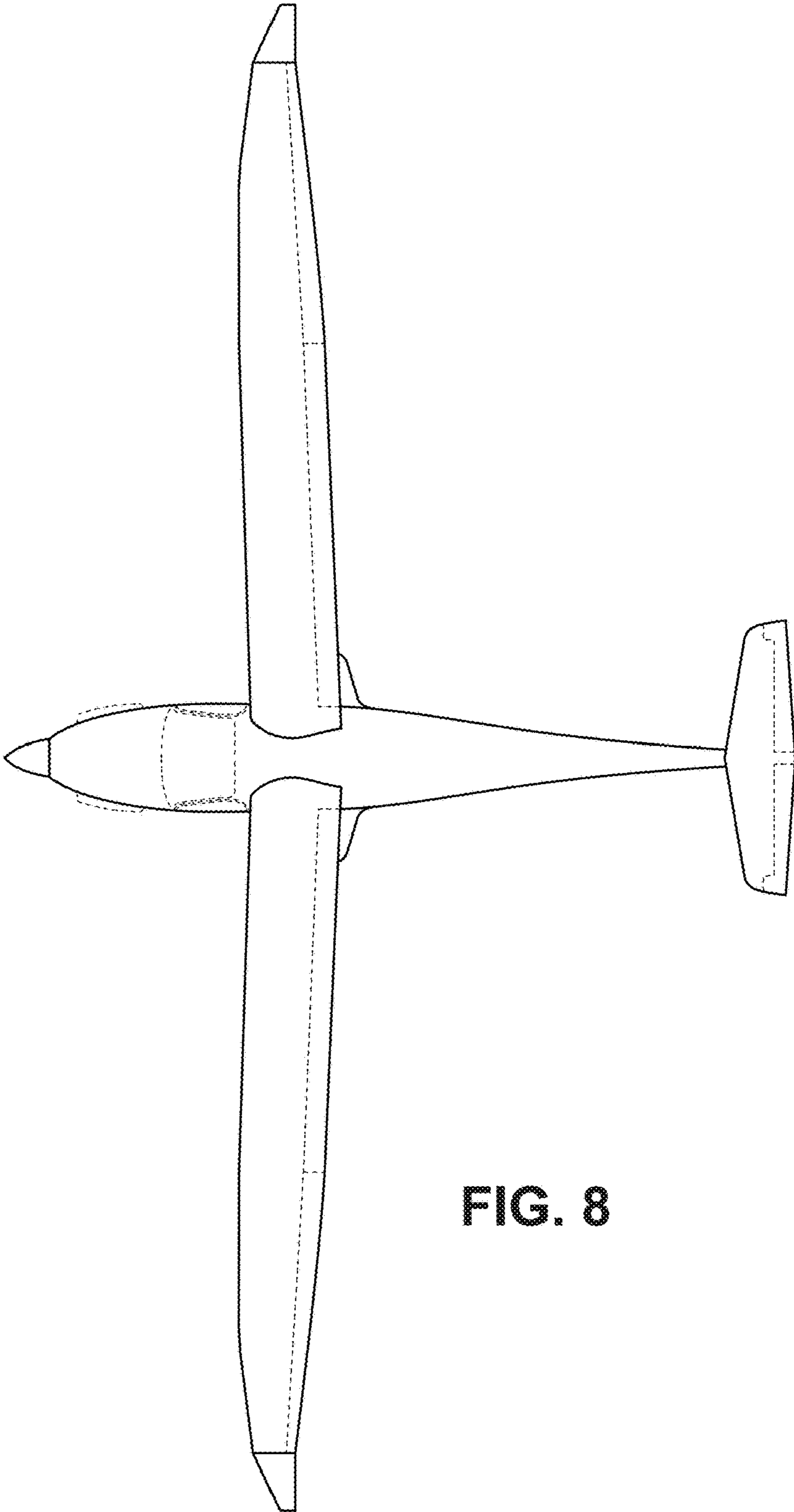
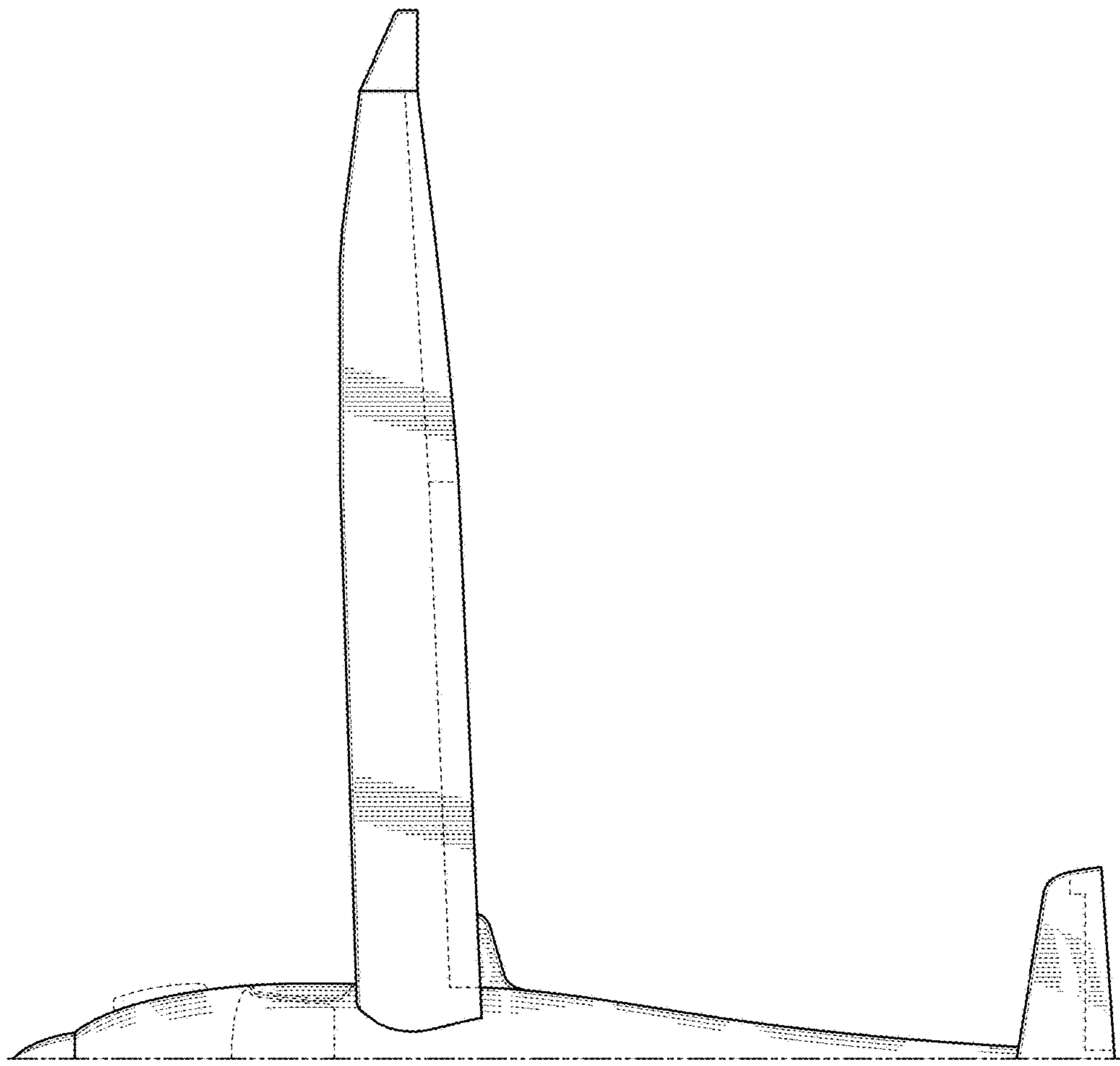
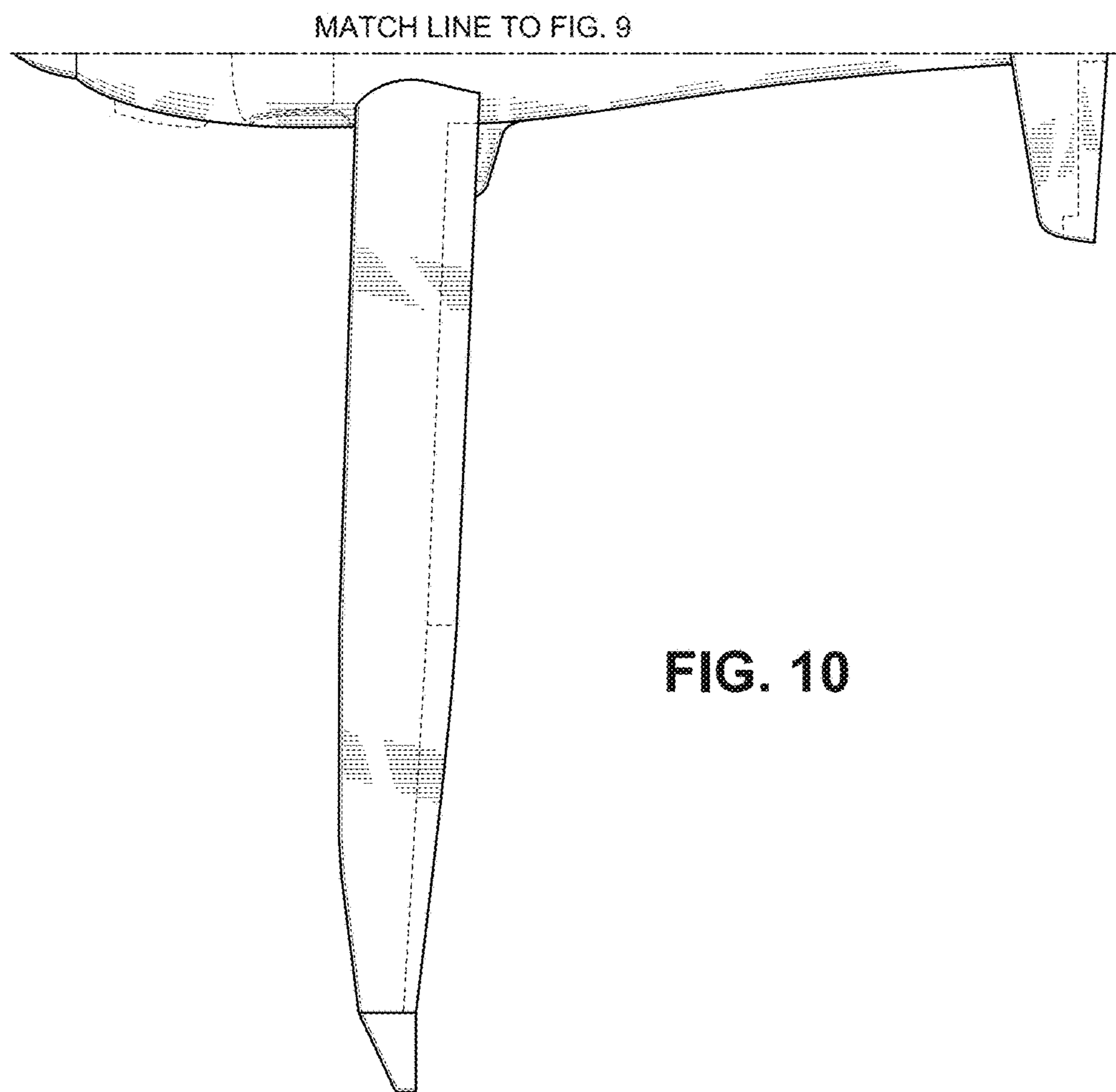

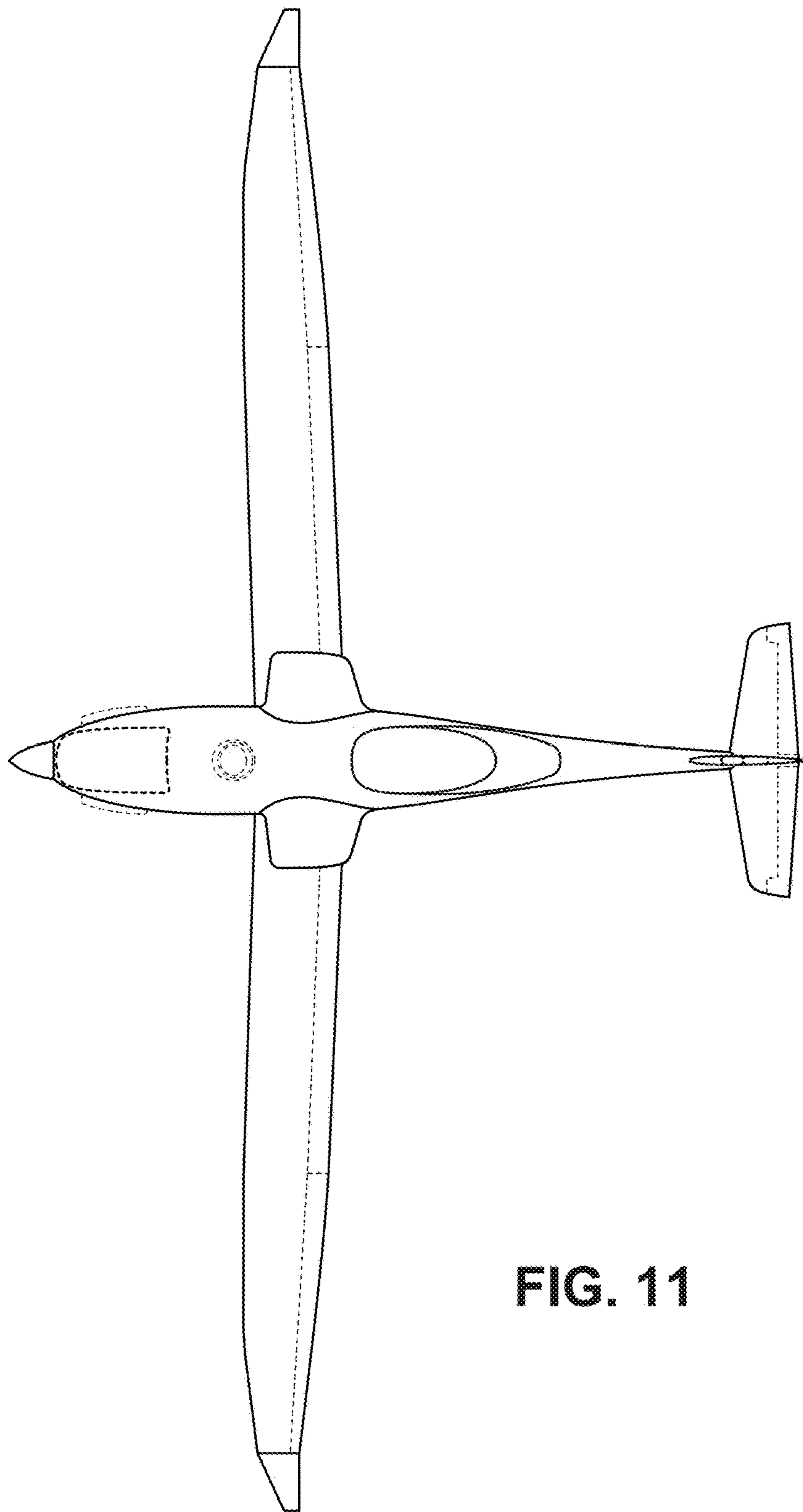
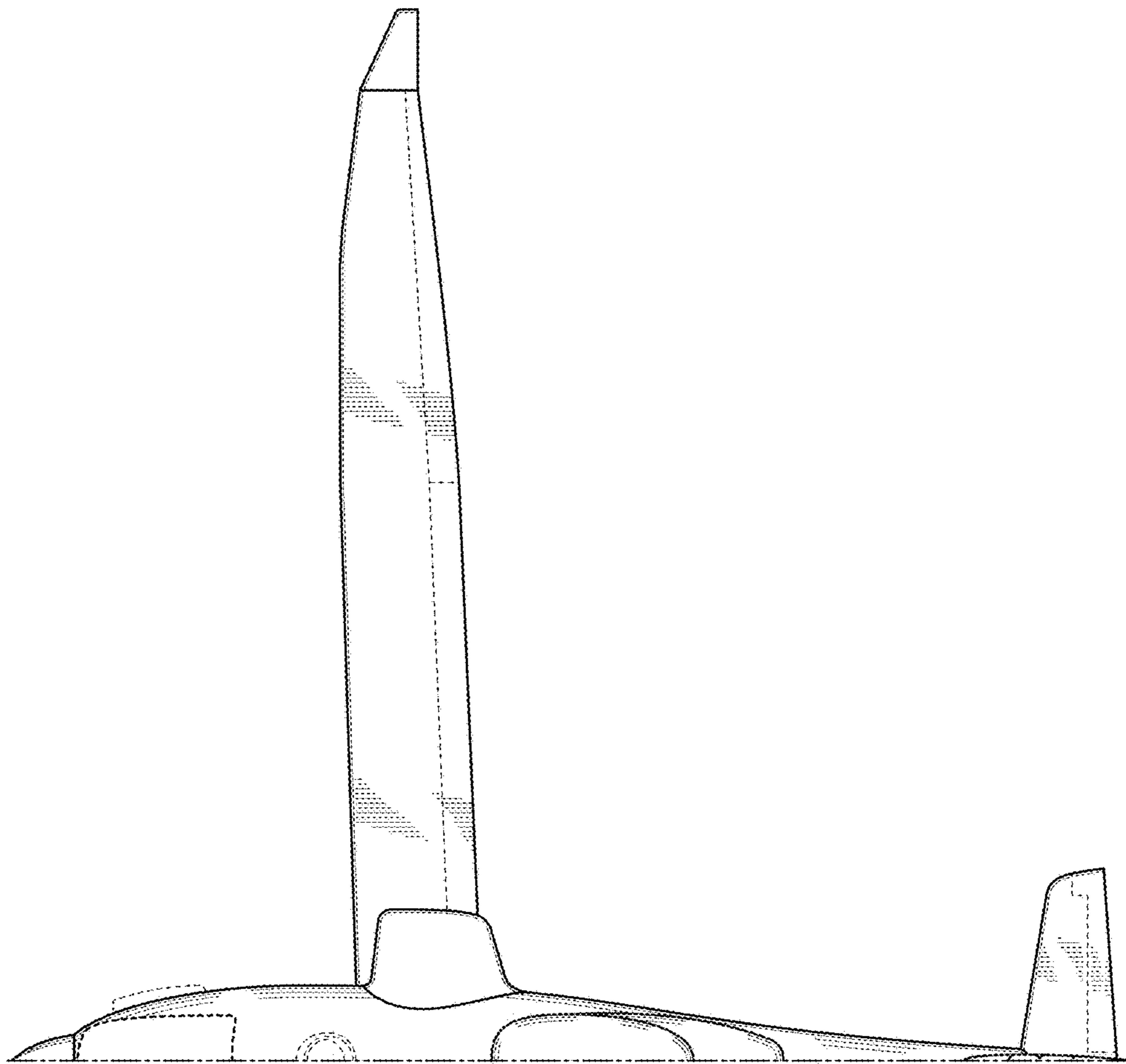
