(57) **CLAIM**

The ornamental design for a connector for a modular electronic building system, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom perspective view of a connector for a modular electronic building system, according to an embodiment;

FIG. 2 is a front view of the connector for a modular electronic building system illustrated in FIG. 1;

FIG. 3 is a rear view of the connector for a modular electronic building system illustrated in FIG. 1;

FIG. 4 is a left side view of the connector for a modular electronic building system illustrated in FIG. 1;

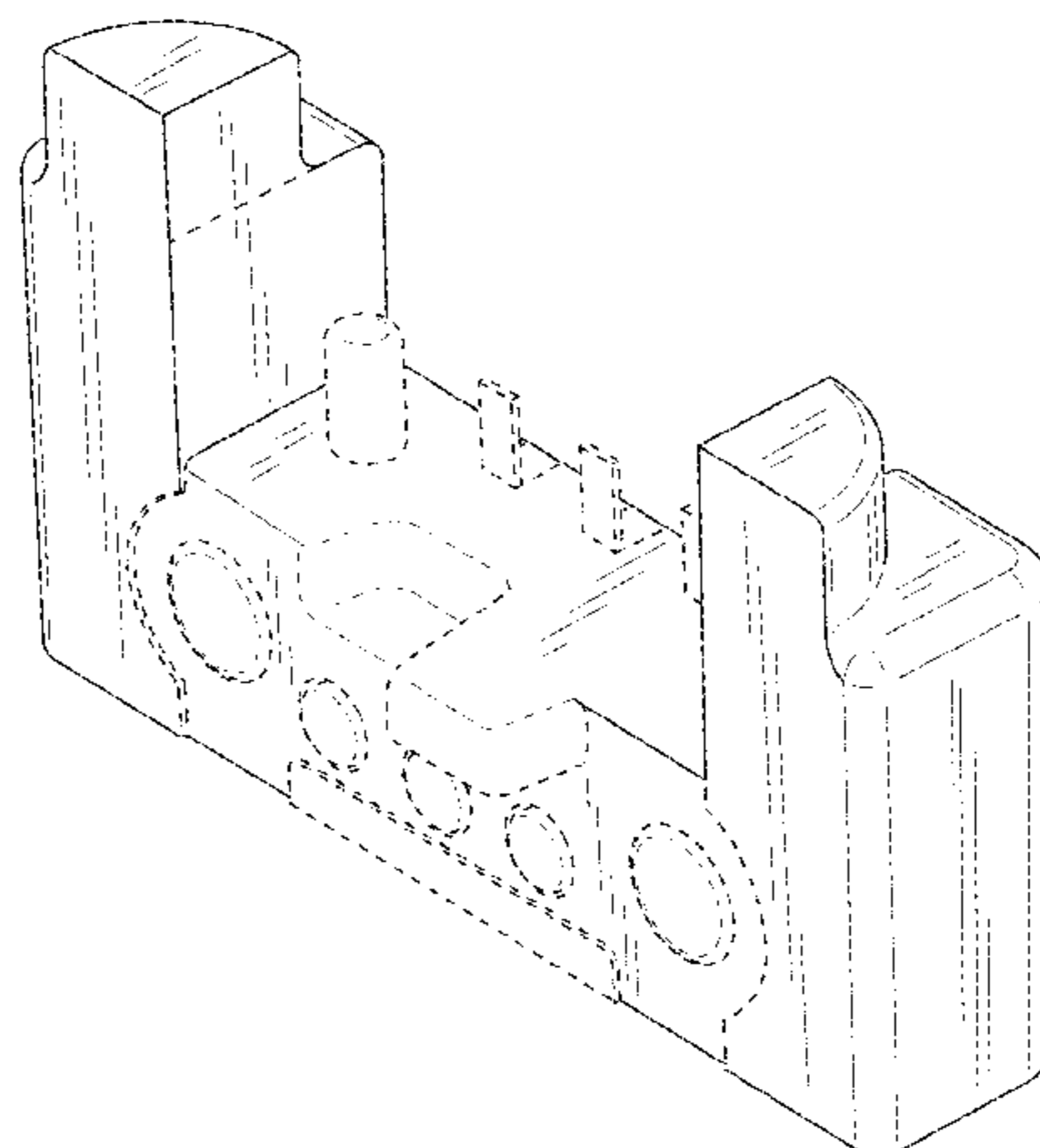
FIG. 5 is a right side view of the connector for a modular electronic building system illustrated in FIG. 1;

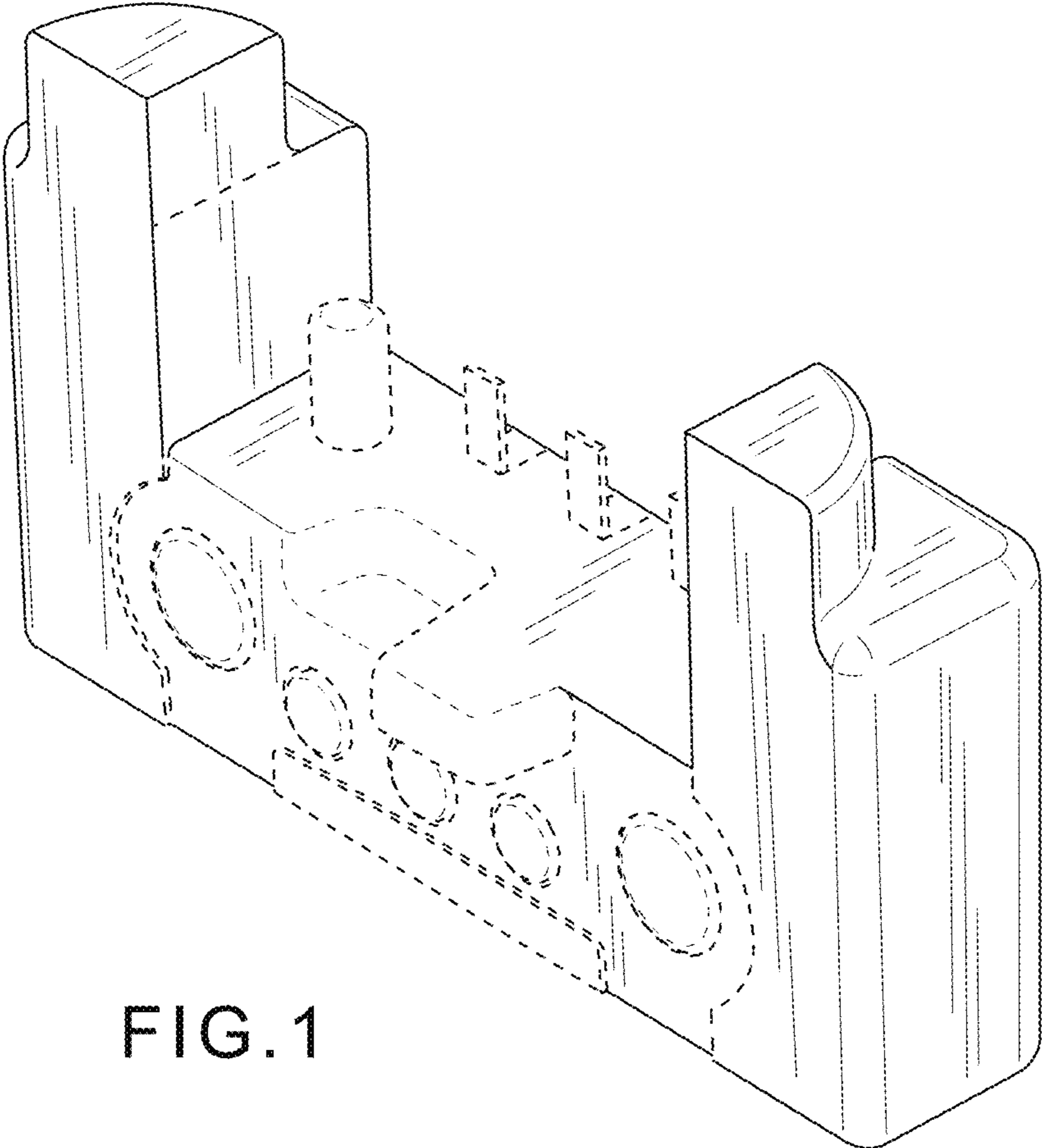

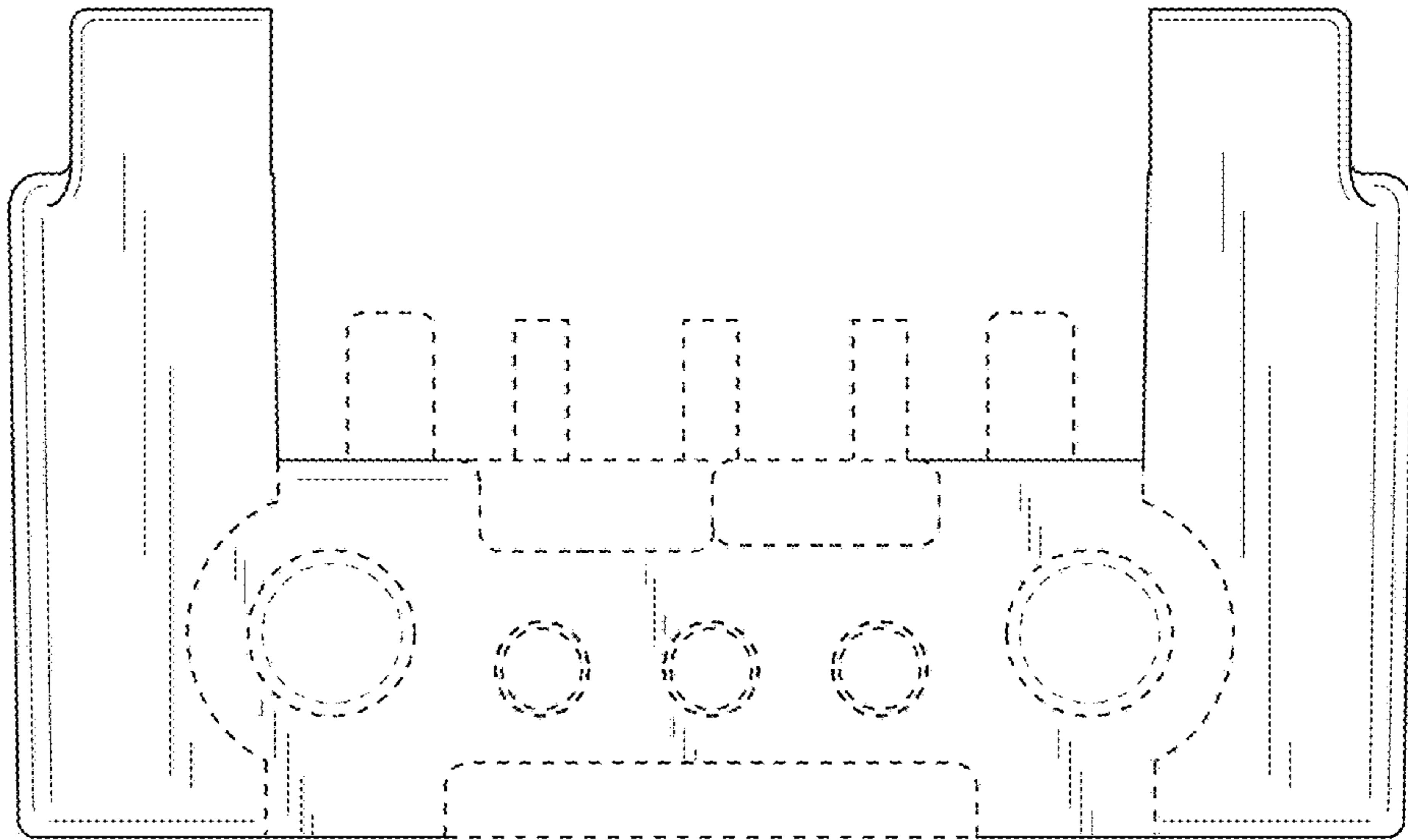

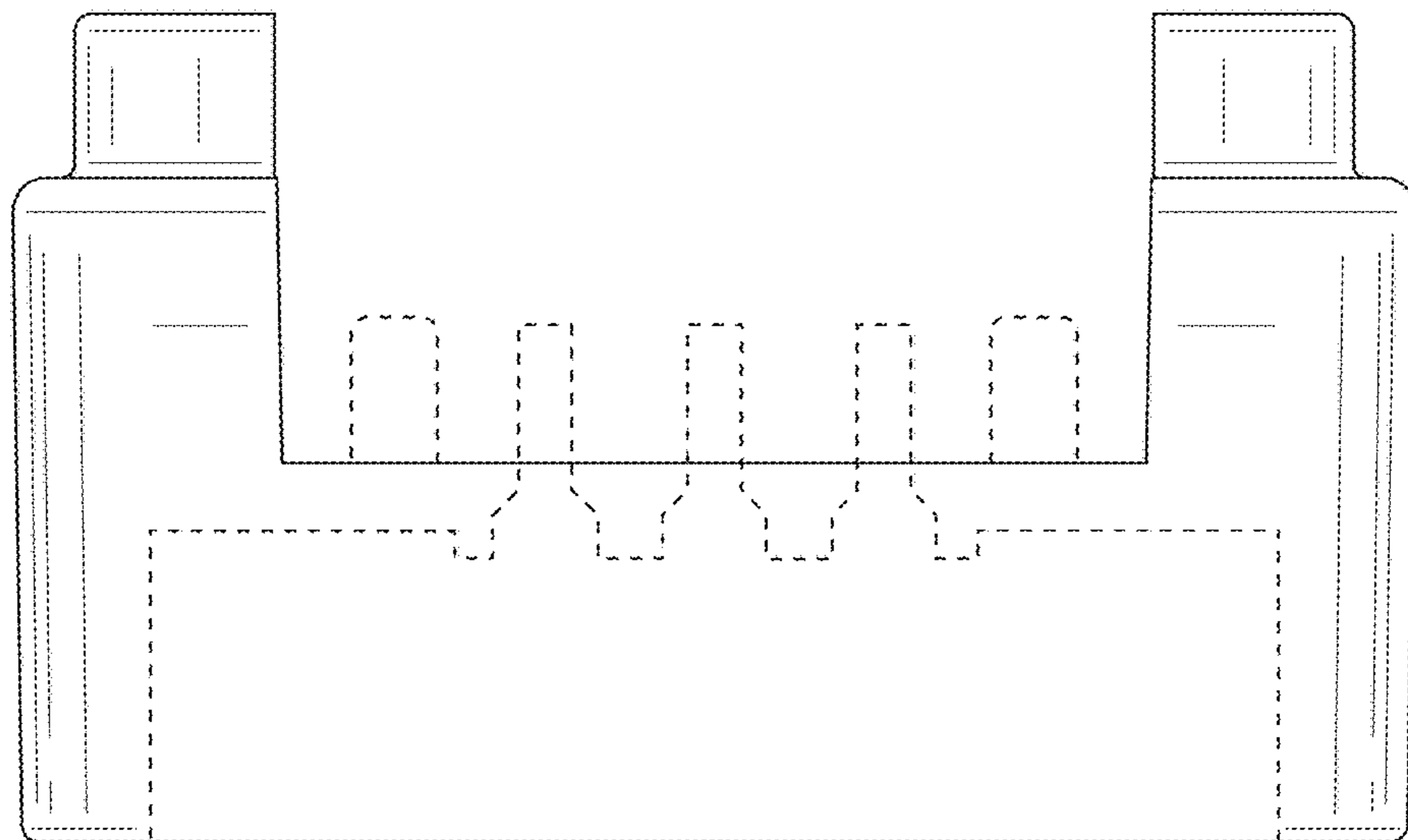

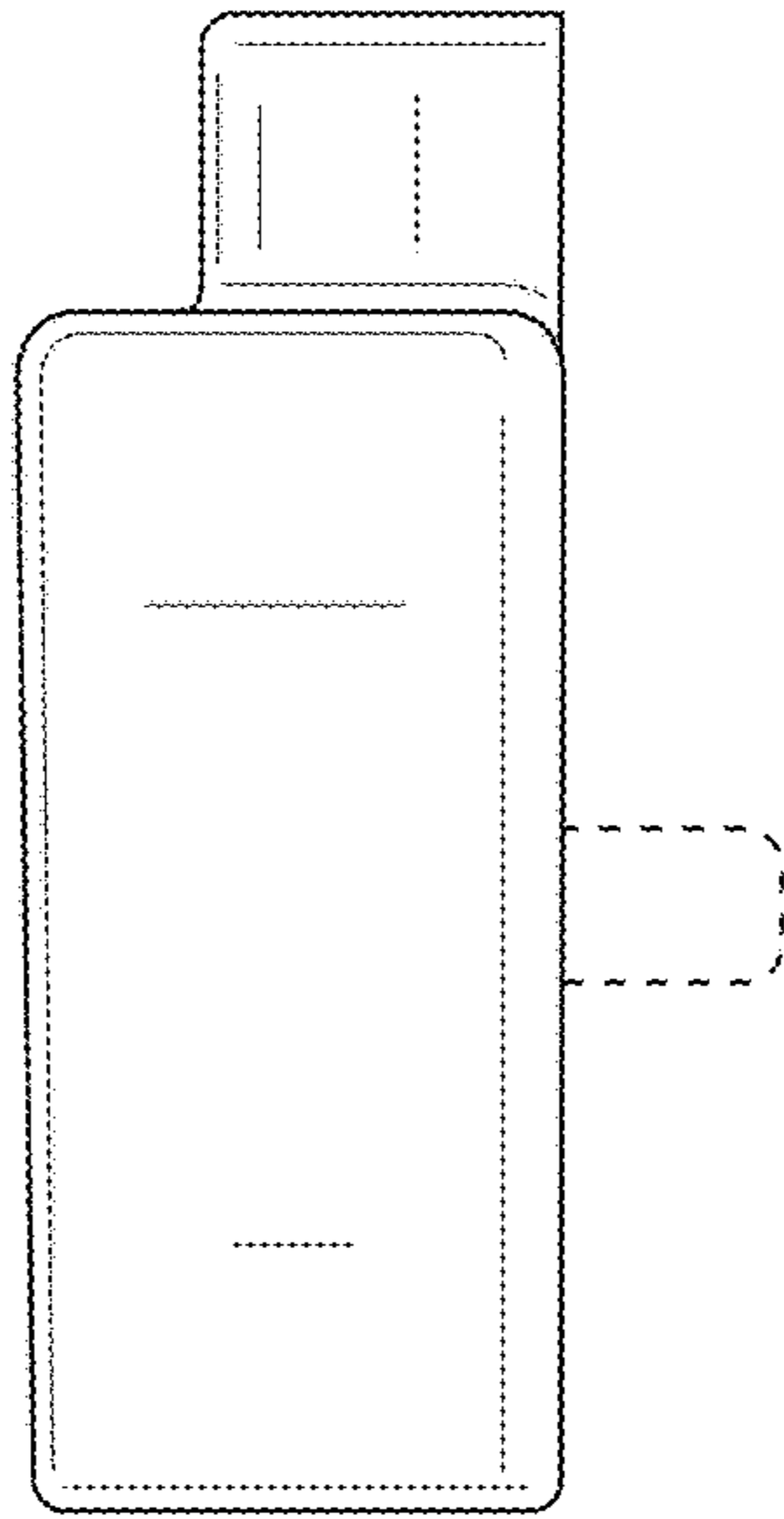

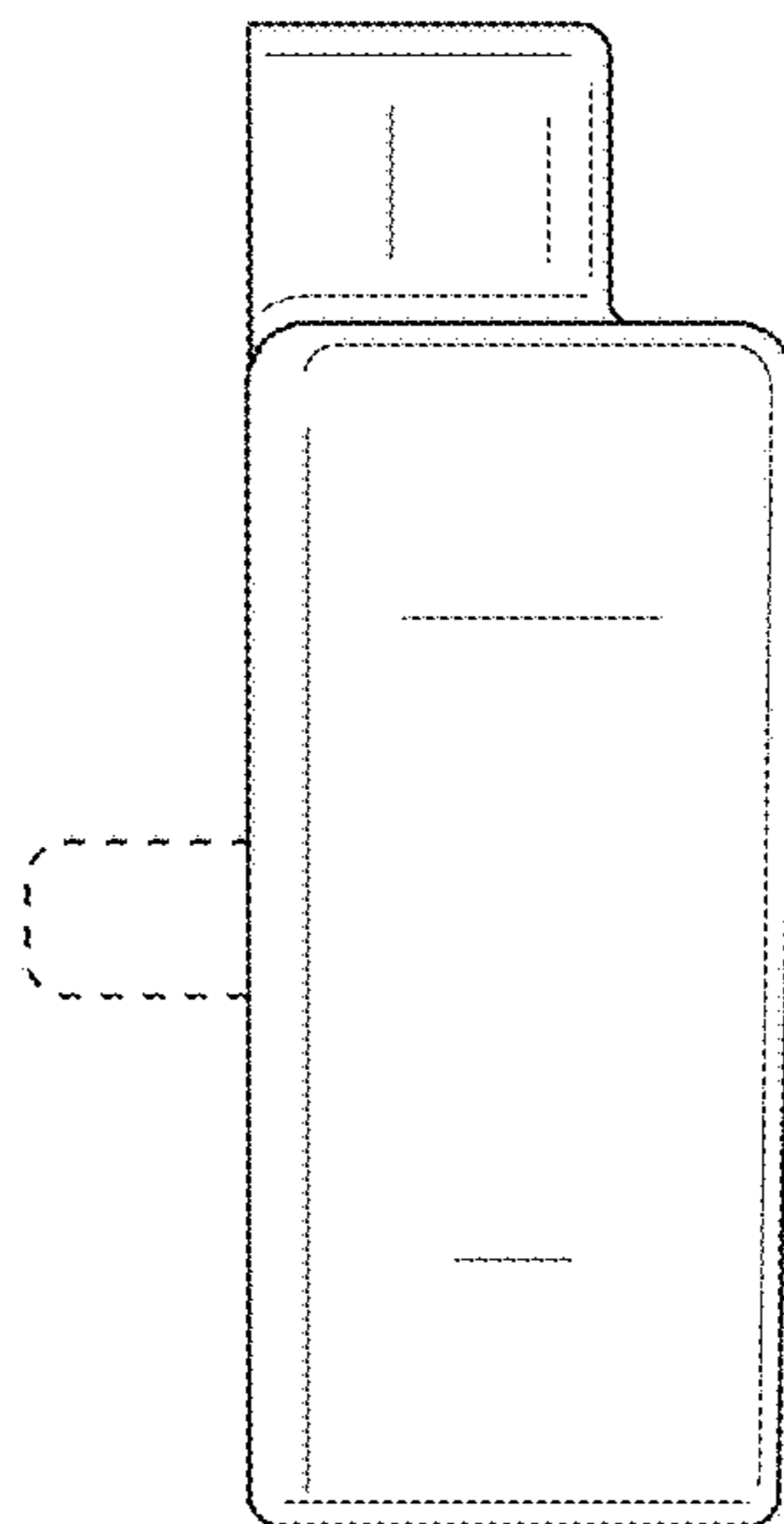

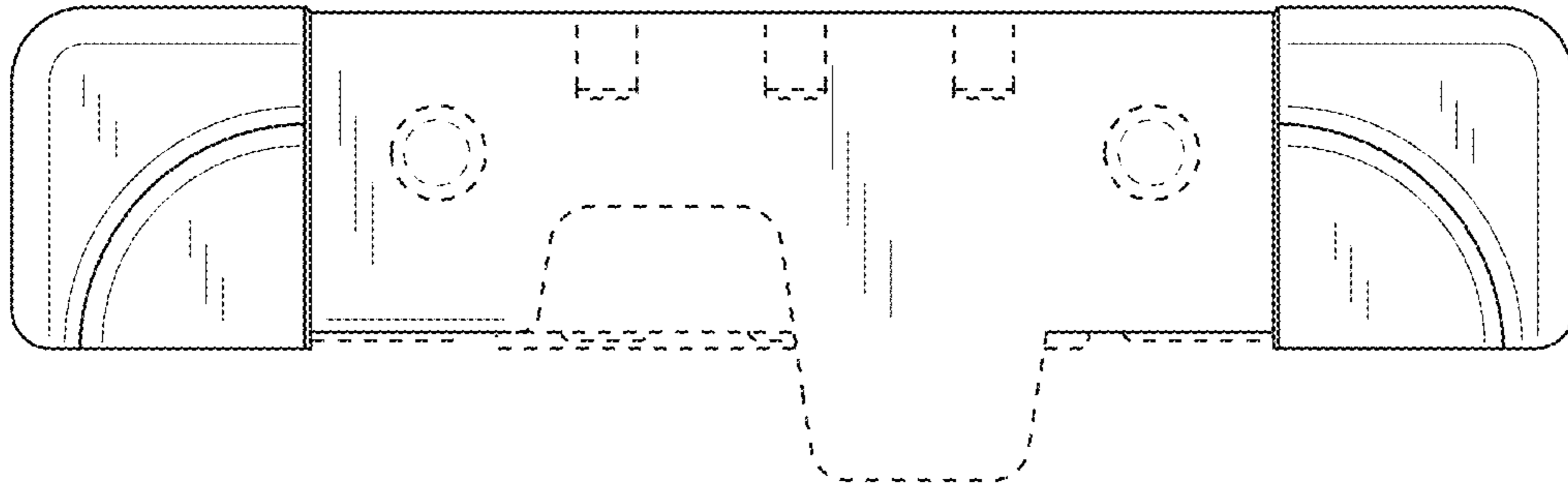

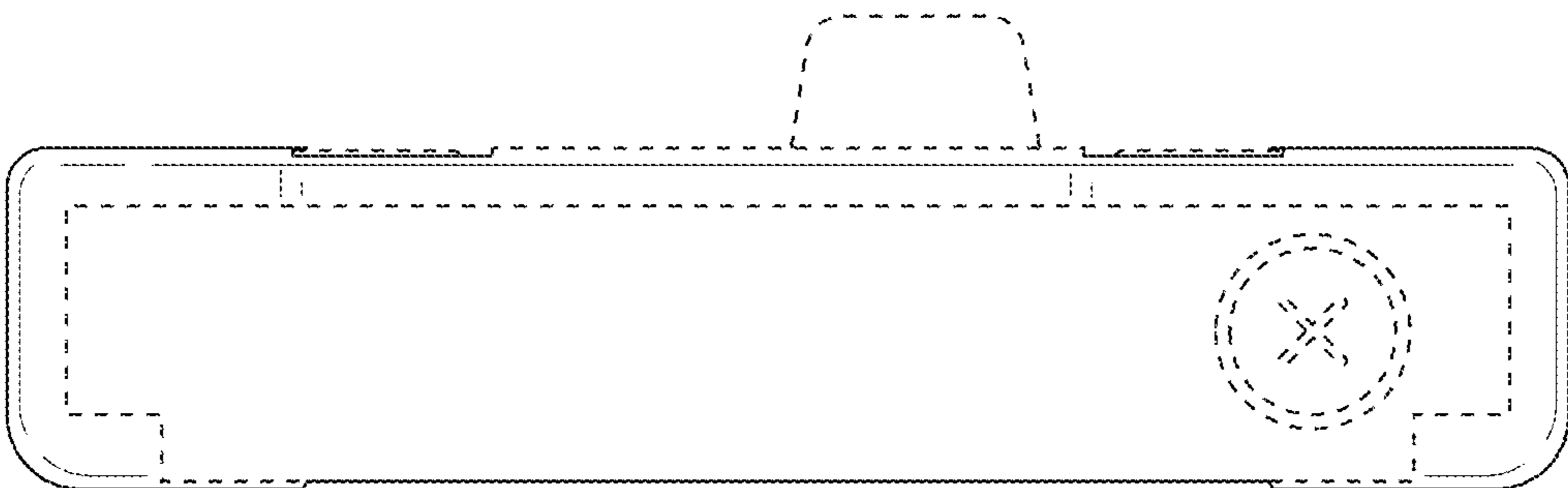
