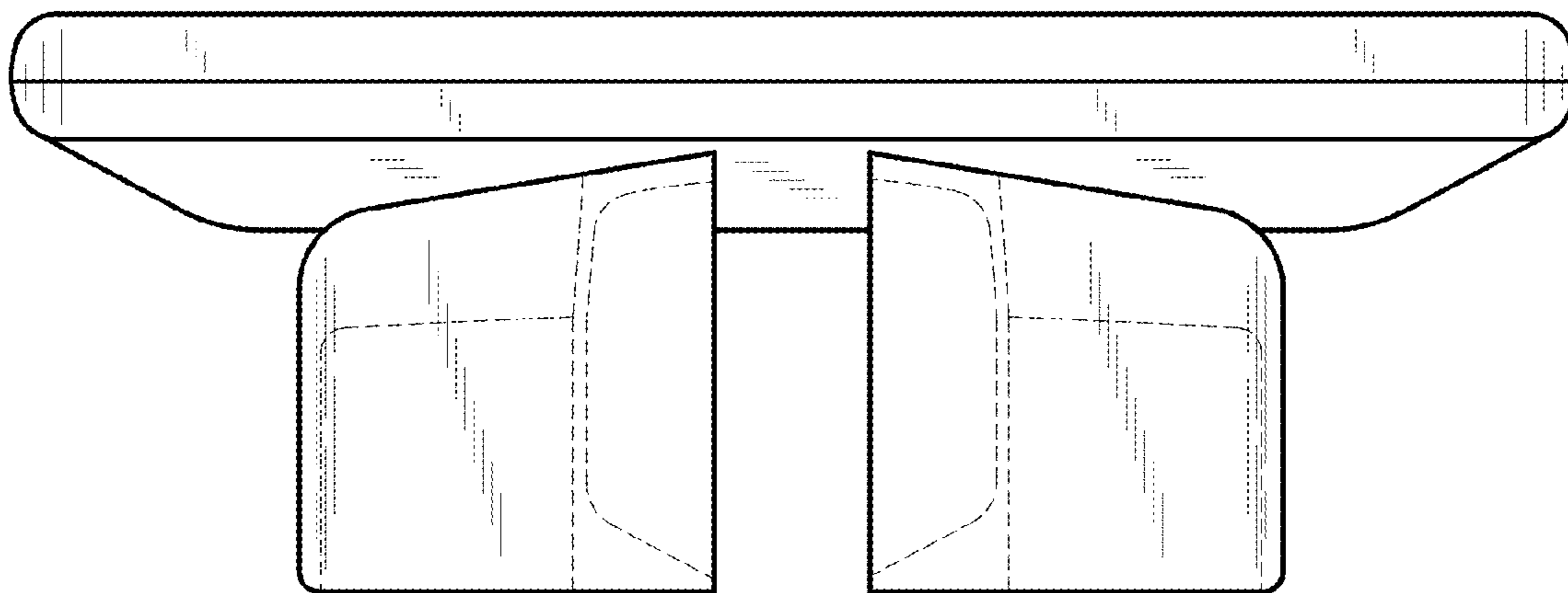
I claim the ornamental design for a set of components for a reel winding machine, as shown and described.

DESCRIPTION

FIG. 1 is a front top perspective view of a set of components for a reel winding machine embodying my design; FIG. 2 is a right side elevational view of FIG. 1; FIG. 3 is a left side elevational view of FIG. 1; FIG. 4 is a front elevational view of FIG. 1; FIG. 5 is a back elevational view of FIG. 1; FIG. 6 is a top plan view of FIG. 1; and, FIG. 7 is a bottom view of FIG. 1.

The broken lines and the unshaded areas in the drawings illustrate portions of a set of components for a reel winding machine that form no part of the claimed design.

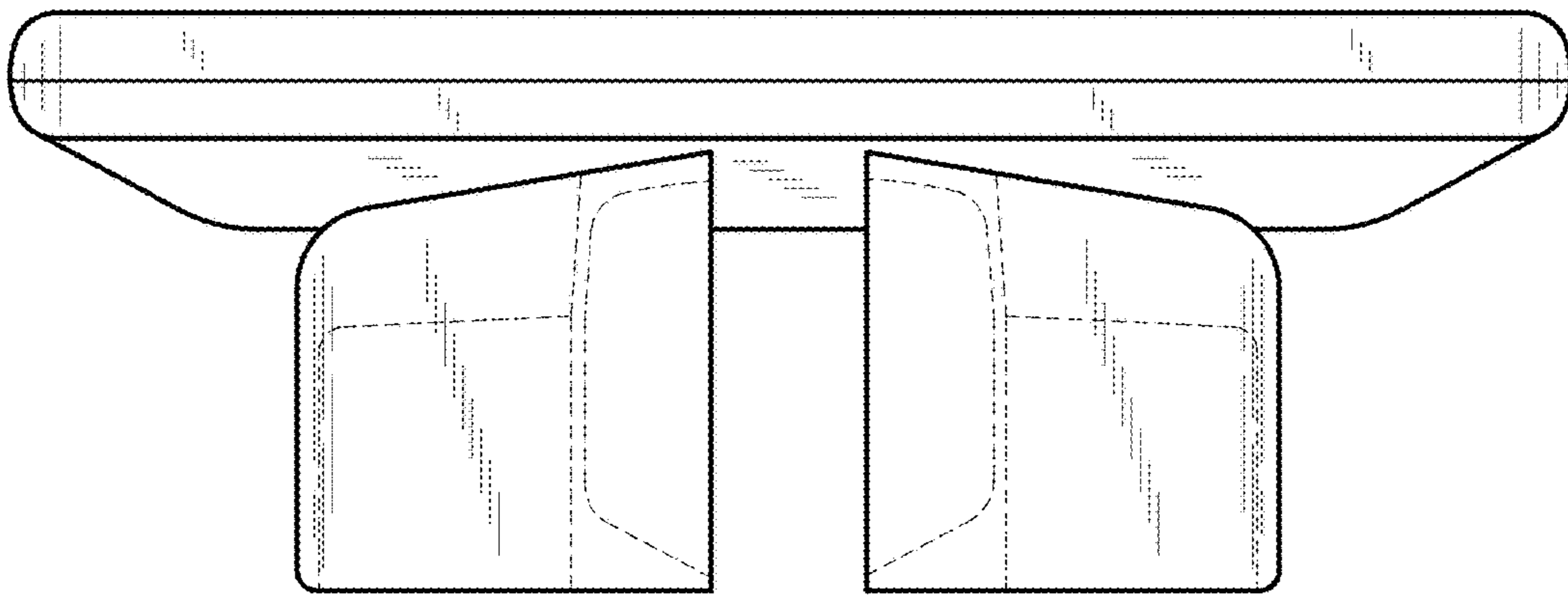

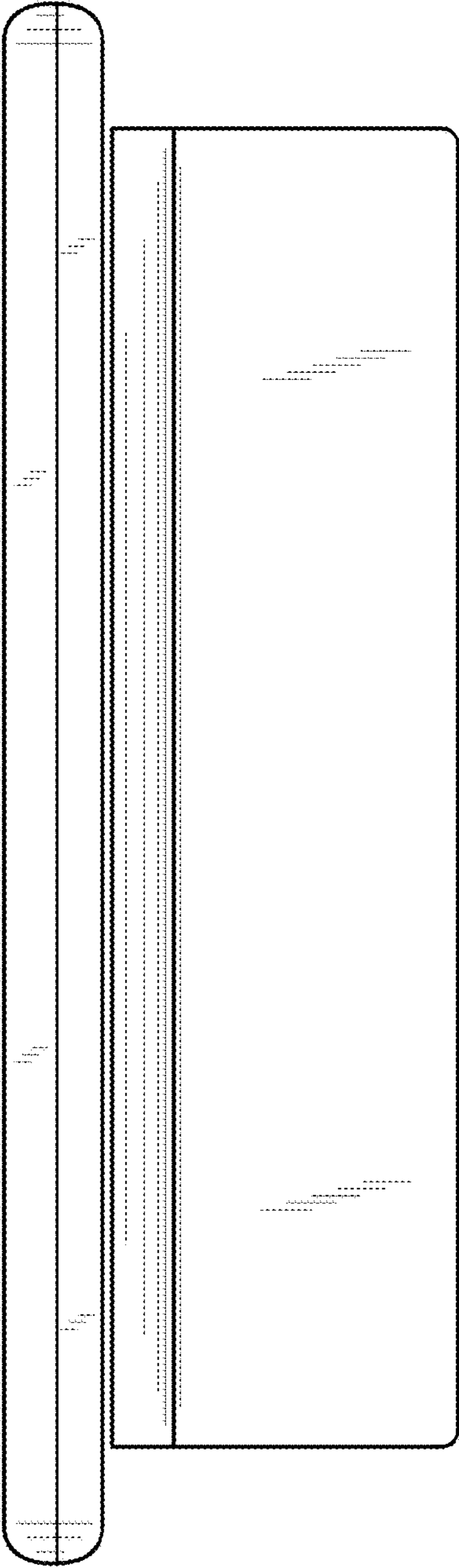

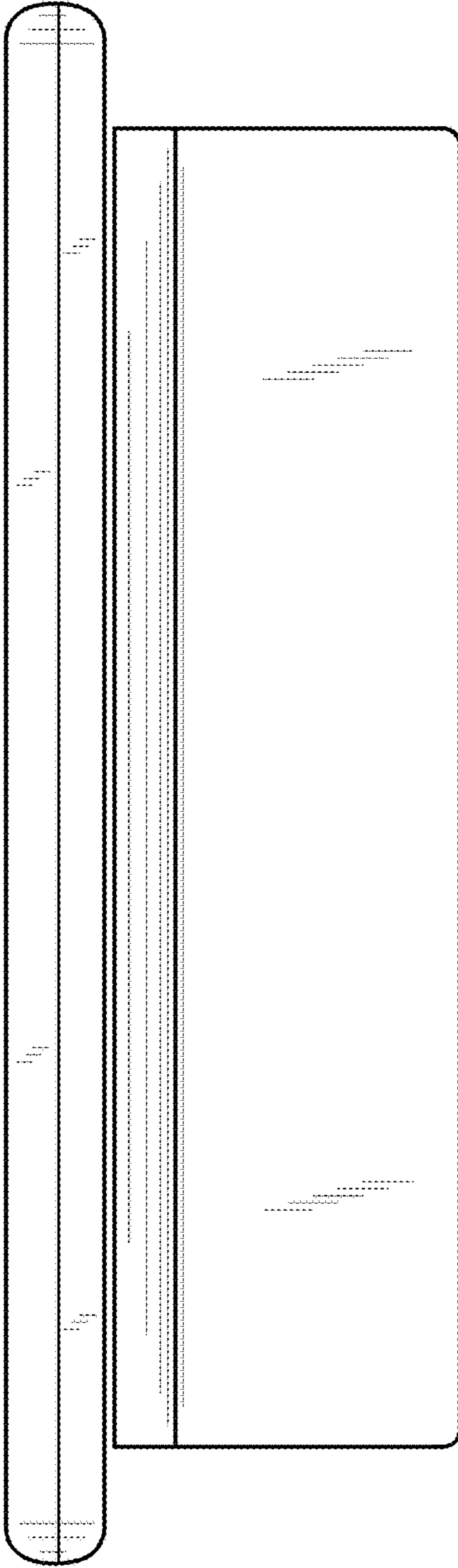

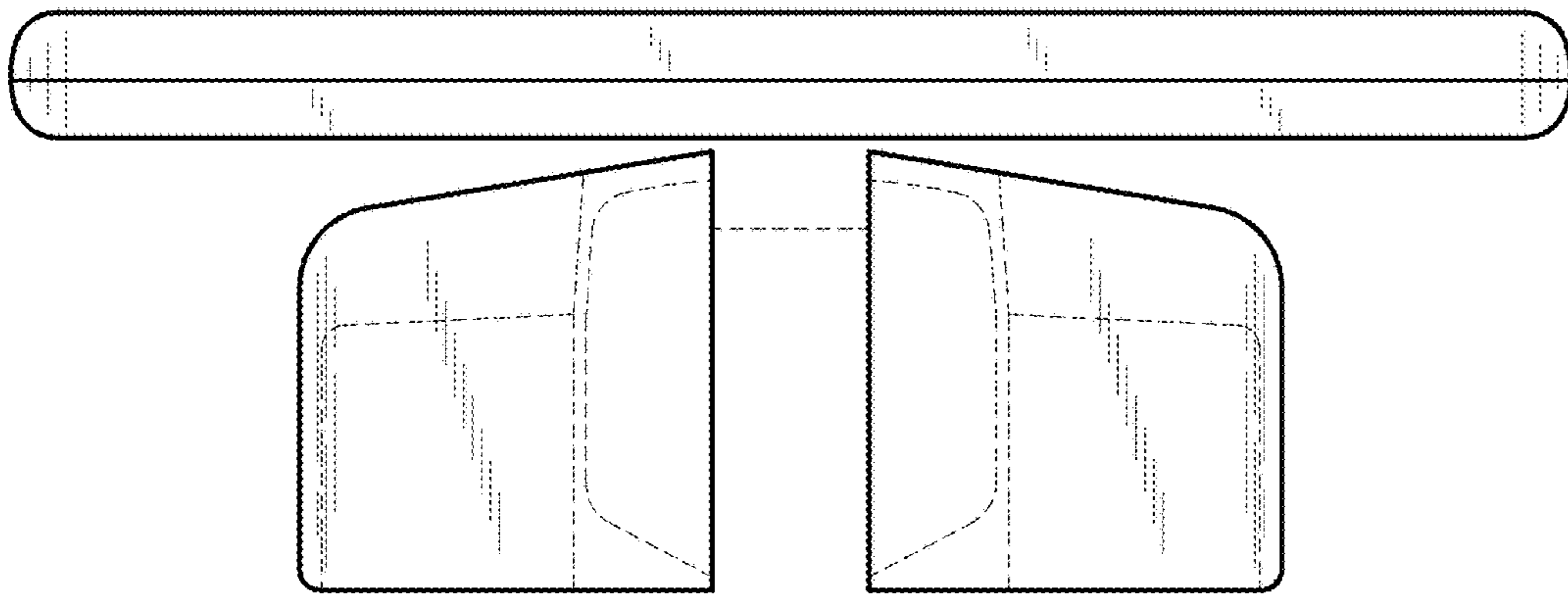

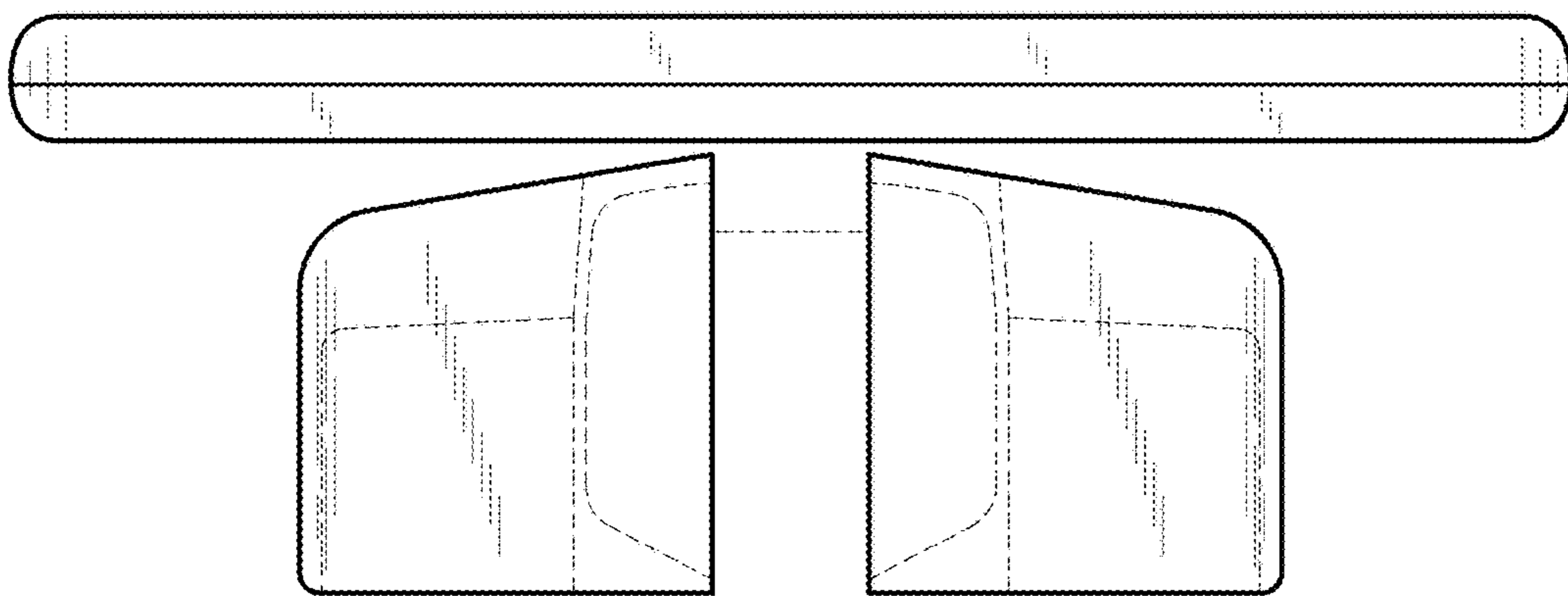

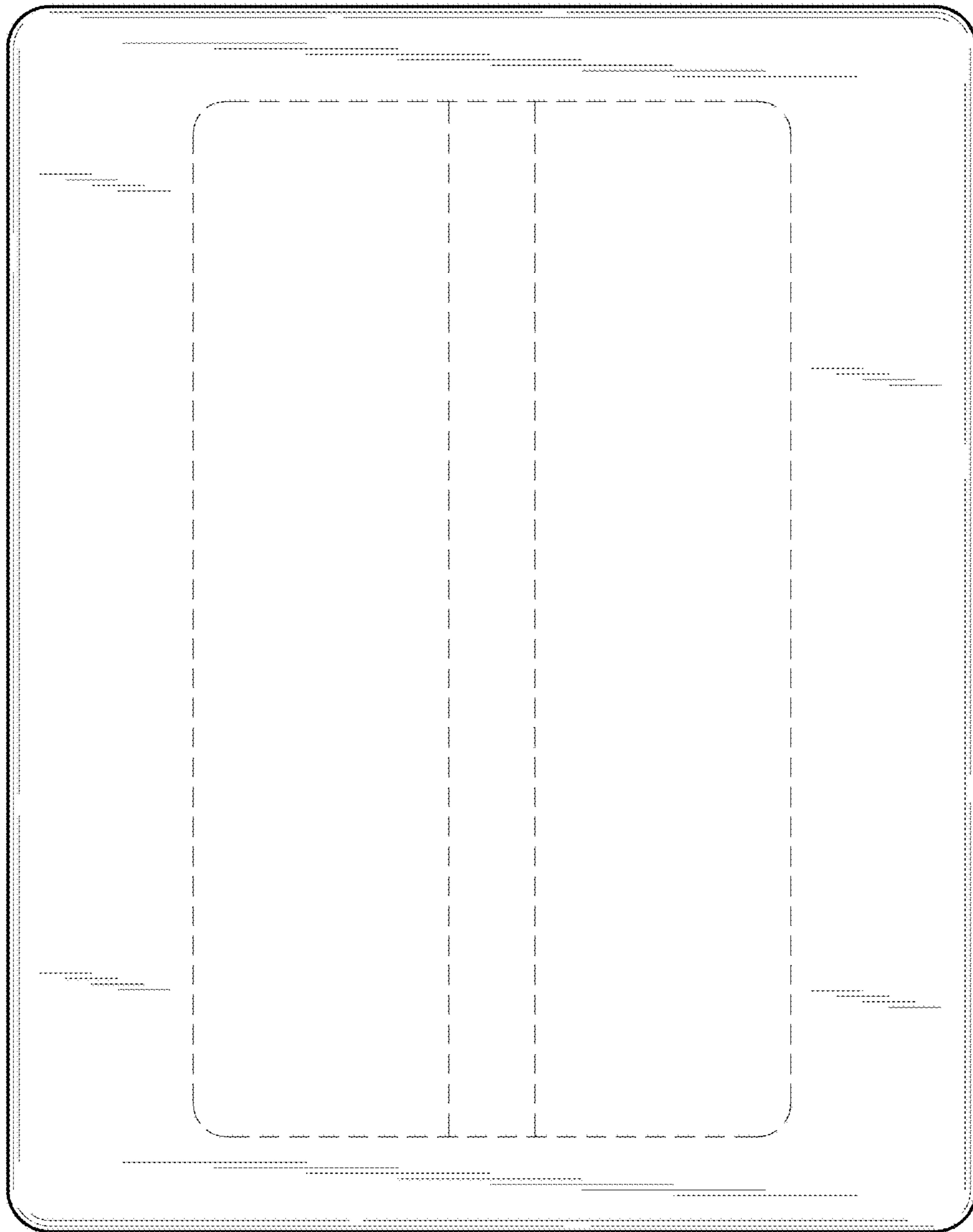

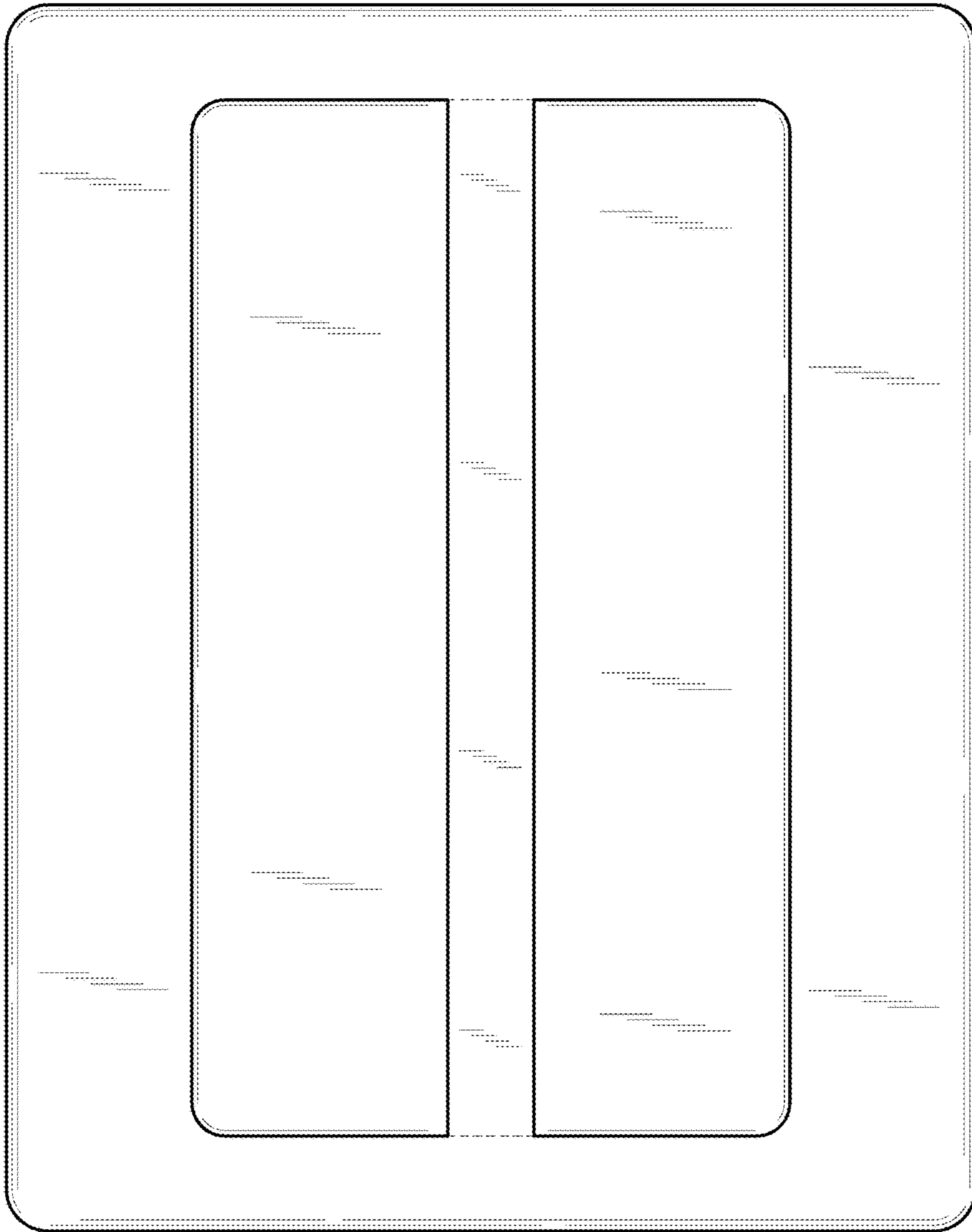
