(57) **CLAIM**

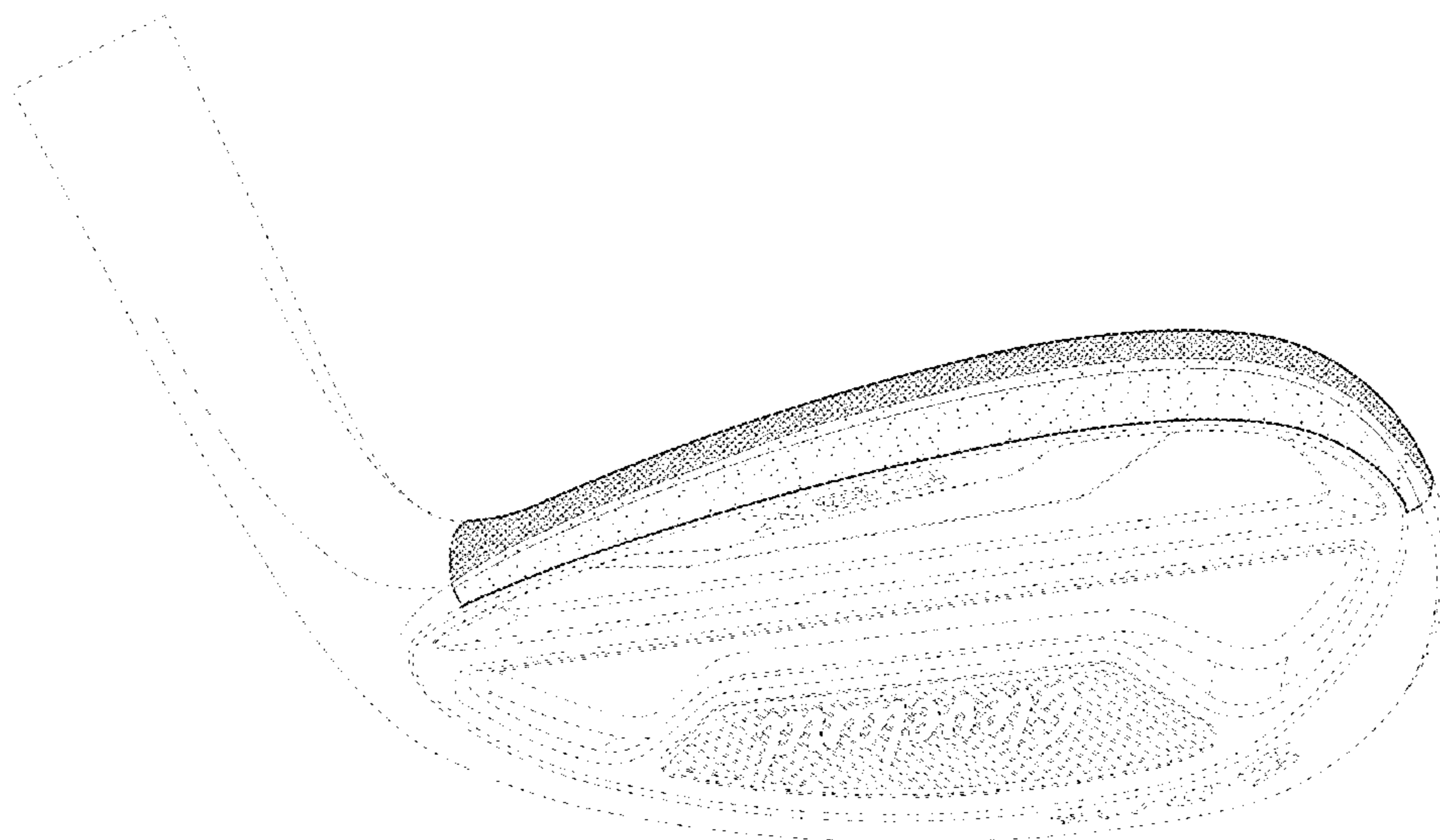
The ornamental design for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a rear, heel-side, bottom perspective view of the golf club head;
 FIG. 2 is a rear elevational view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a toe-side elevational view thereof;
 FIG. 5 is a heel-side elevational view thereof;
 FIG. 6 is a front elevational view thereof;
 FIG. 7 is a bottom plan view thereof; and,
 FIG. 8 is a rear, toe-side perspective view thereof.

The dot-dash chain lines depict boundaries of the claimed subject matter, and thus form no part of the claimed design. The broken lines depict parts of the golf club head that form no part of the claimed design. The two areas shown in stipple shading of different densities depict two areas that respectively contrast in appearance. The stippling does not represent any particular color, material, texture or finish.

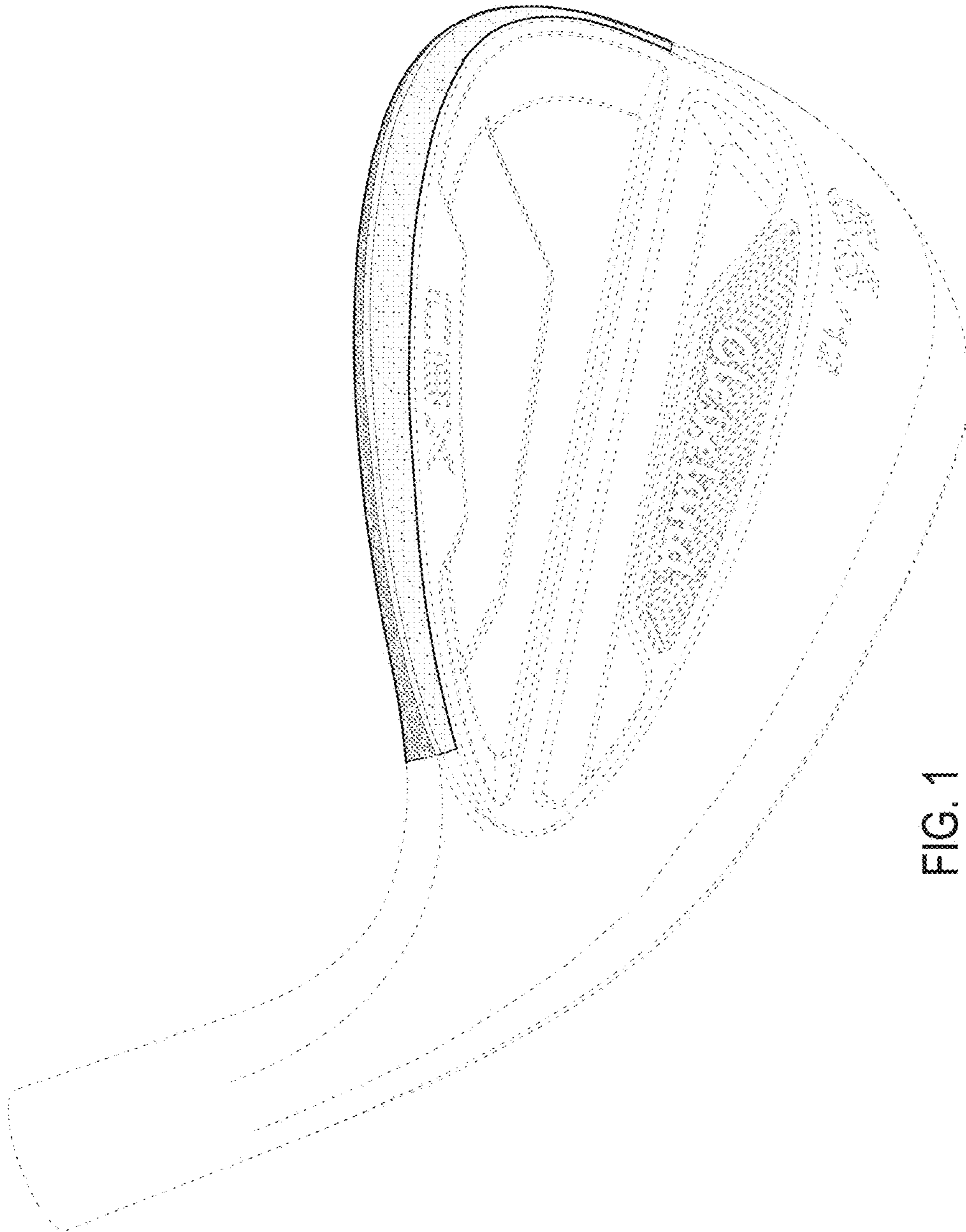

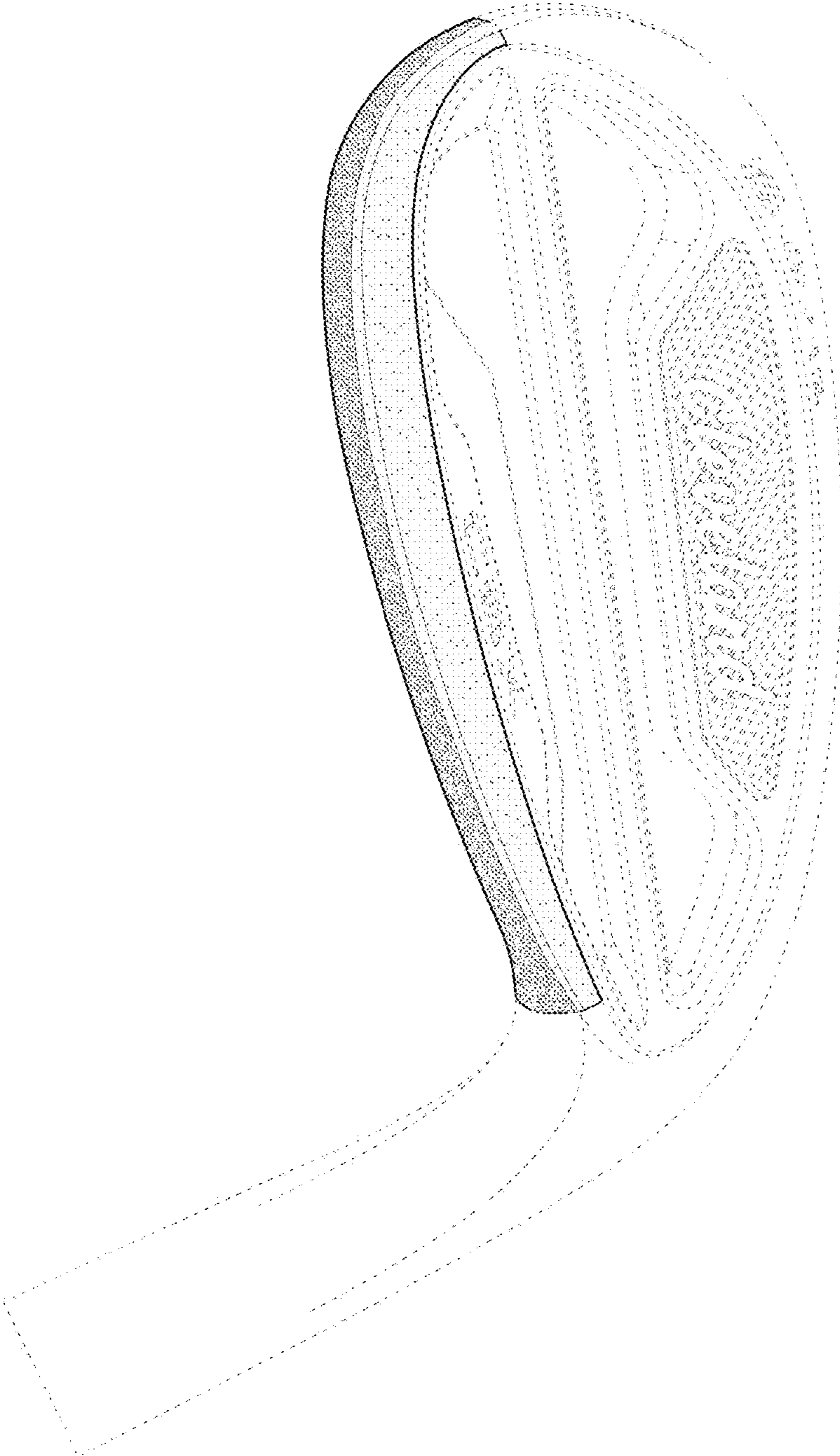

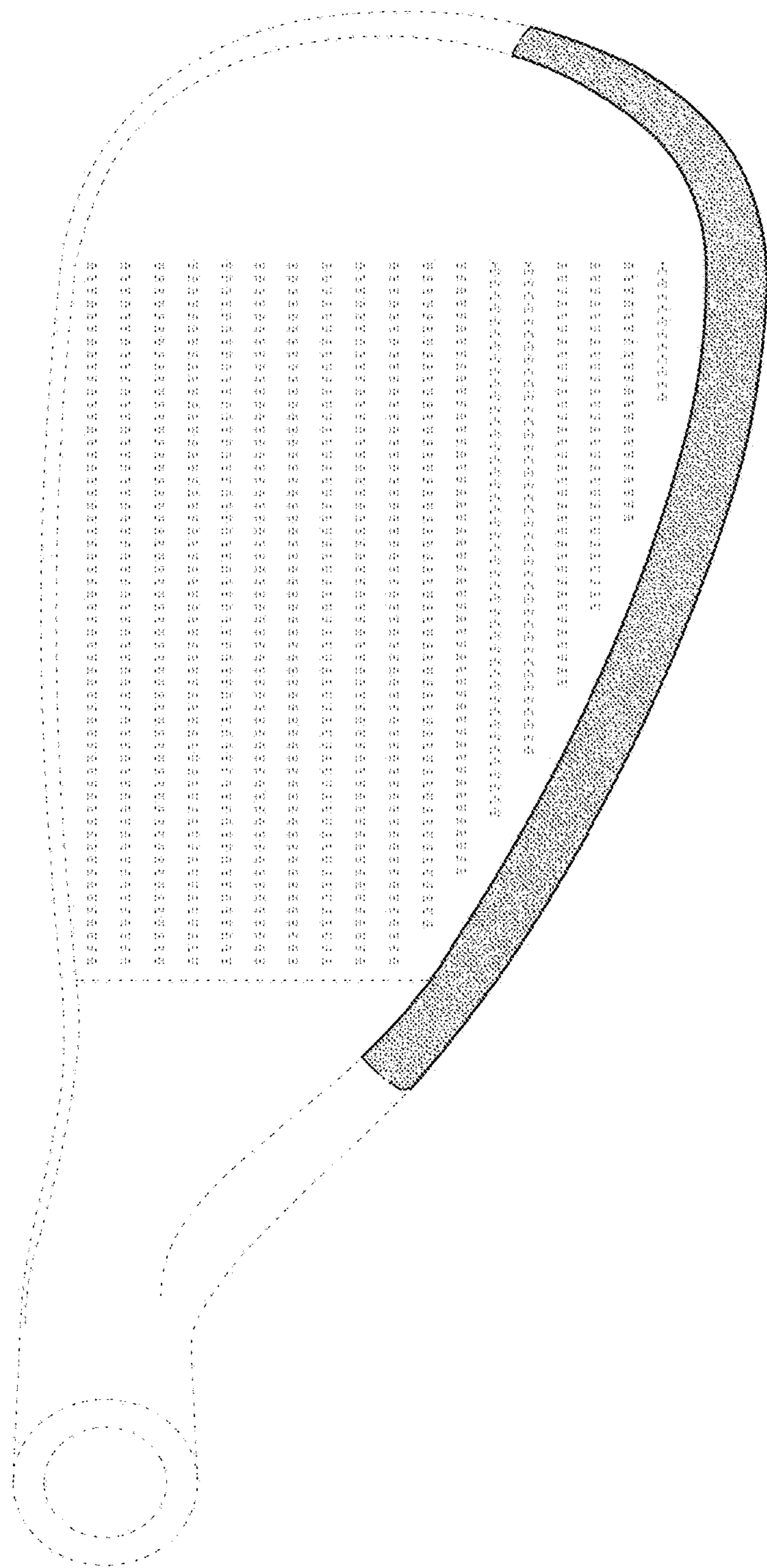

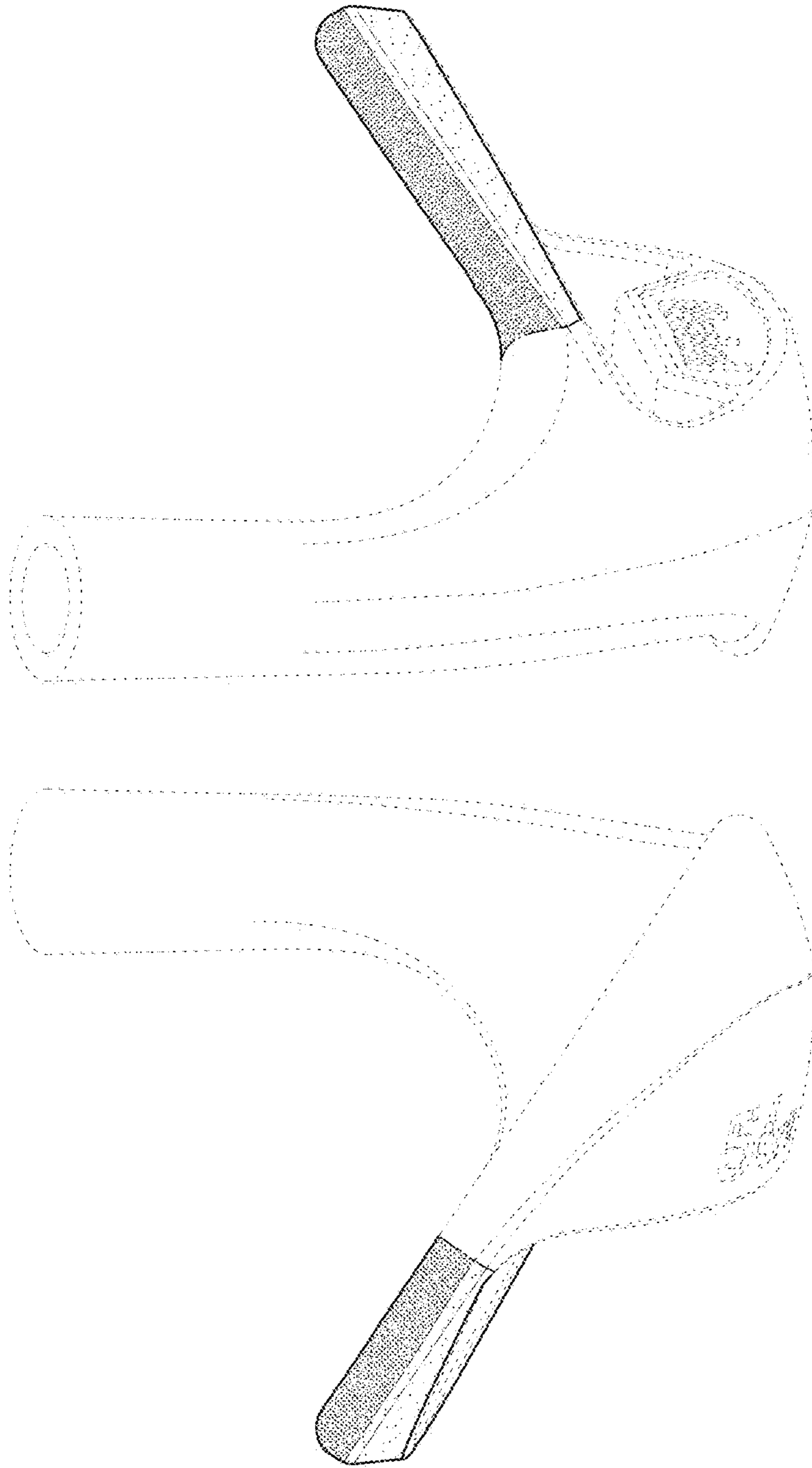

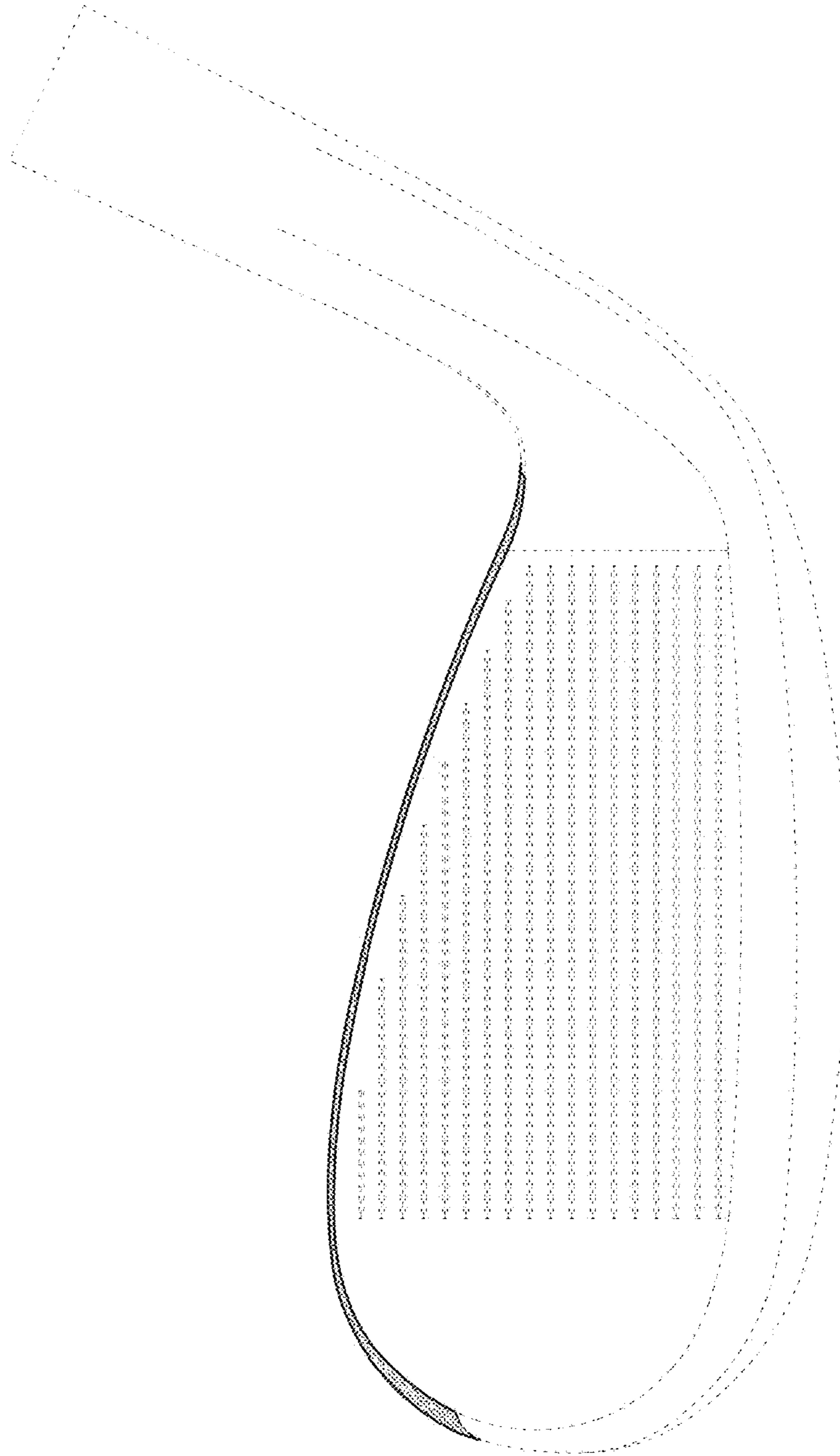

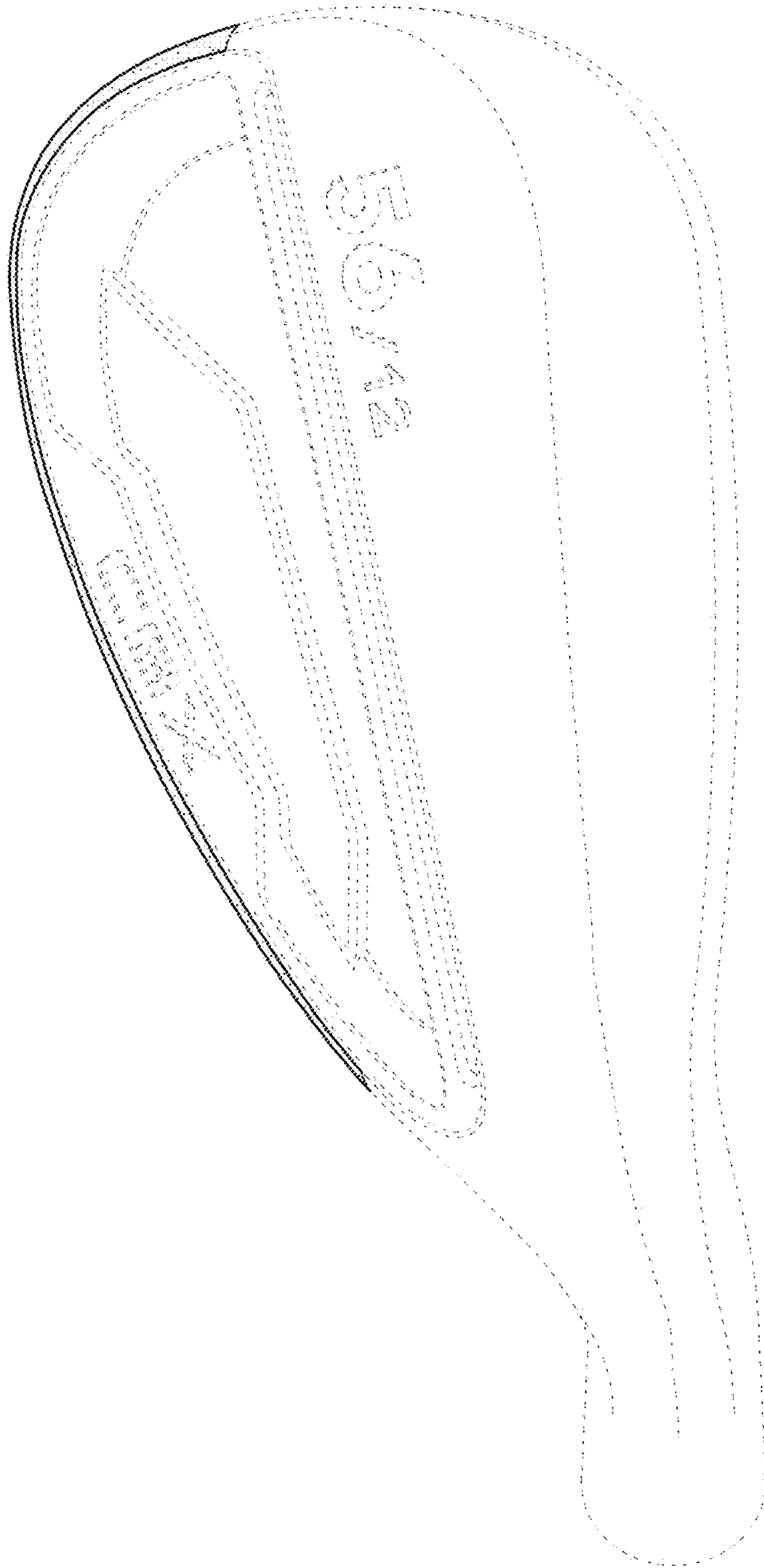

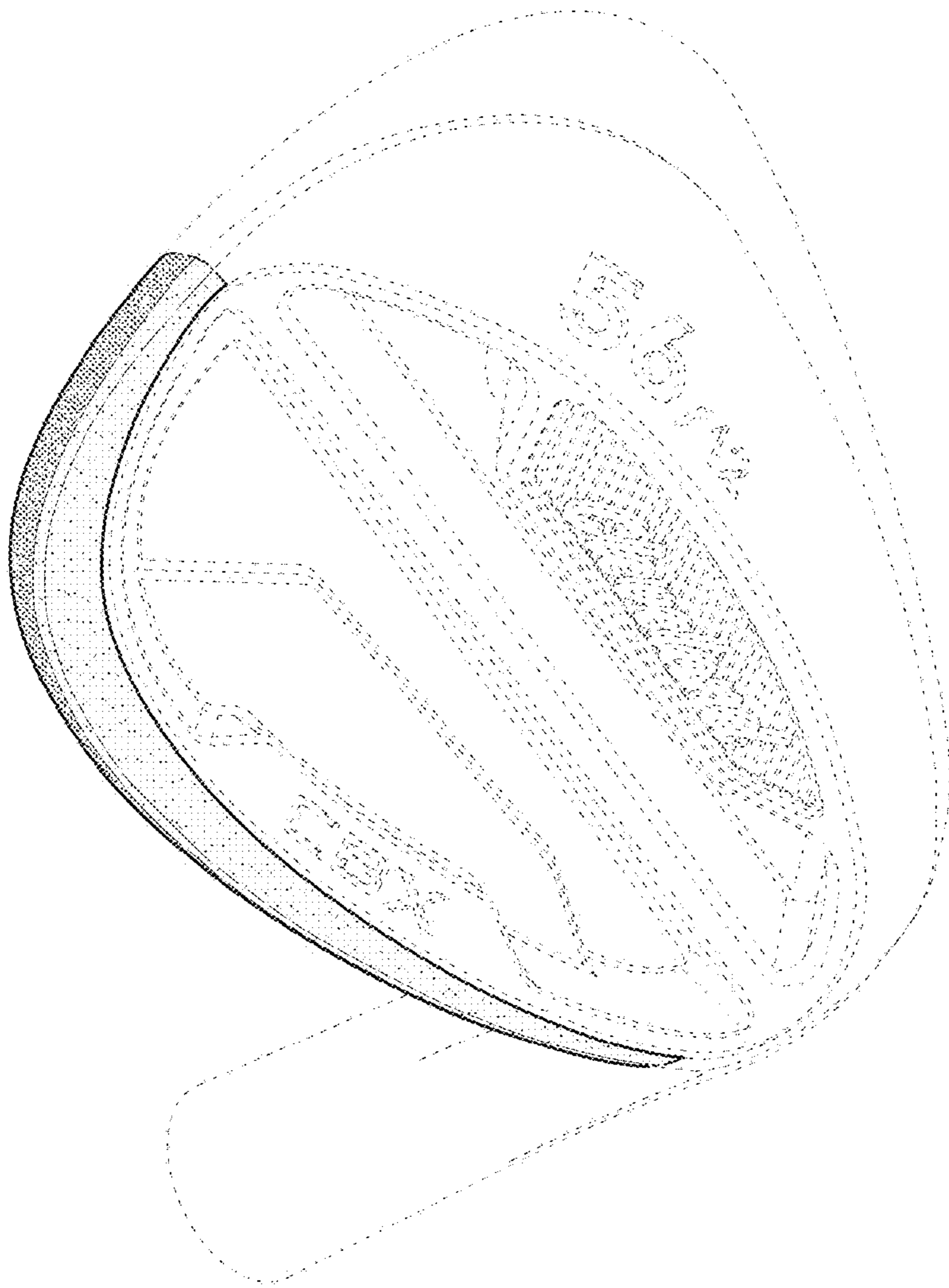
