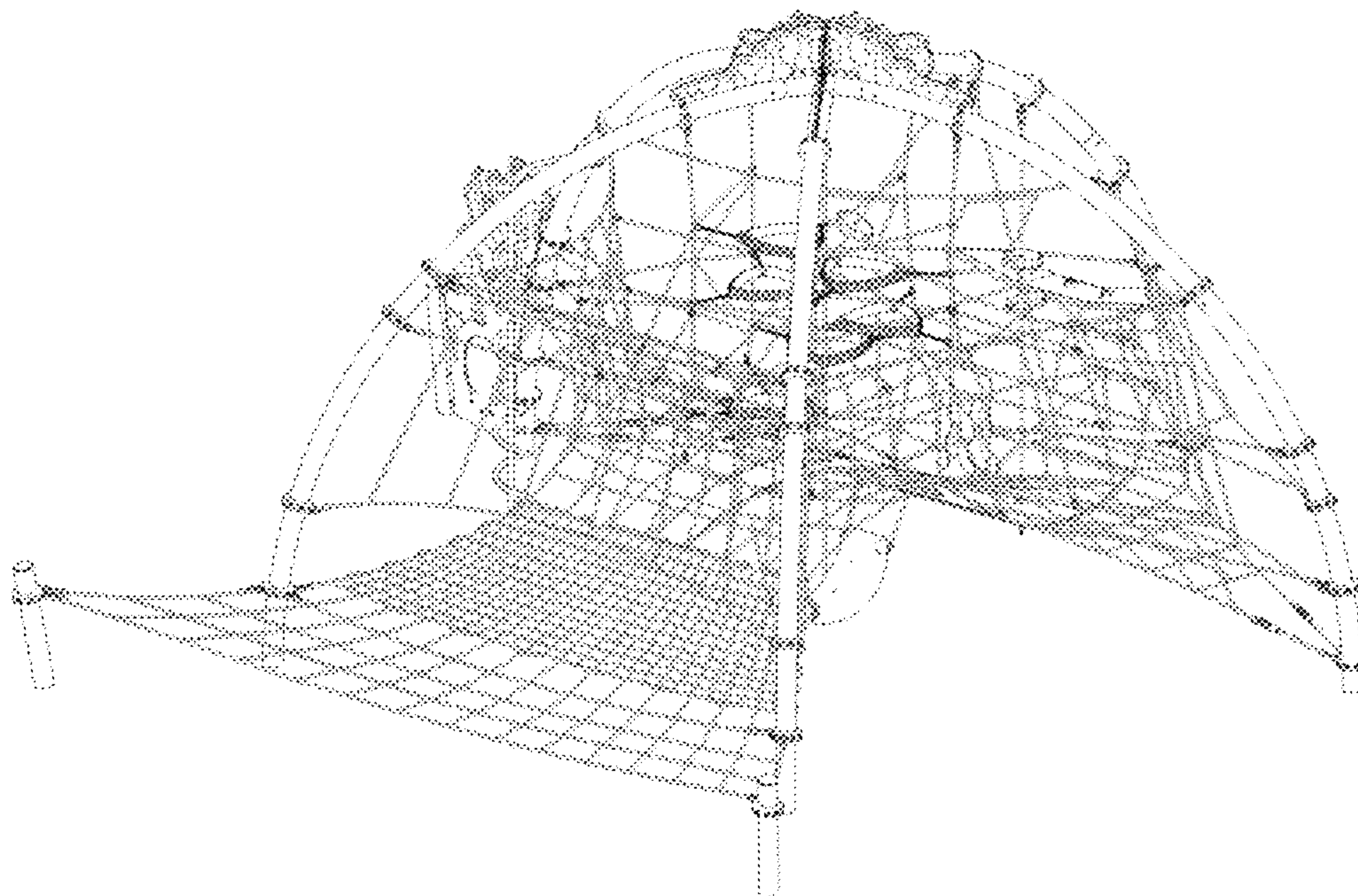

The ornamental design for a climbing frame, as shown and described.

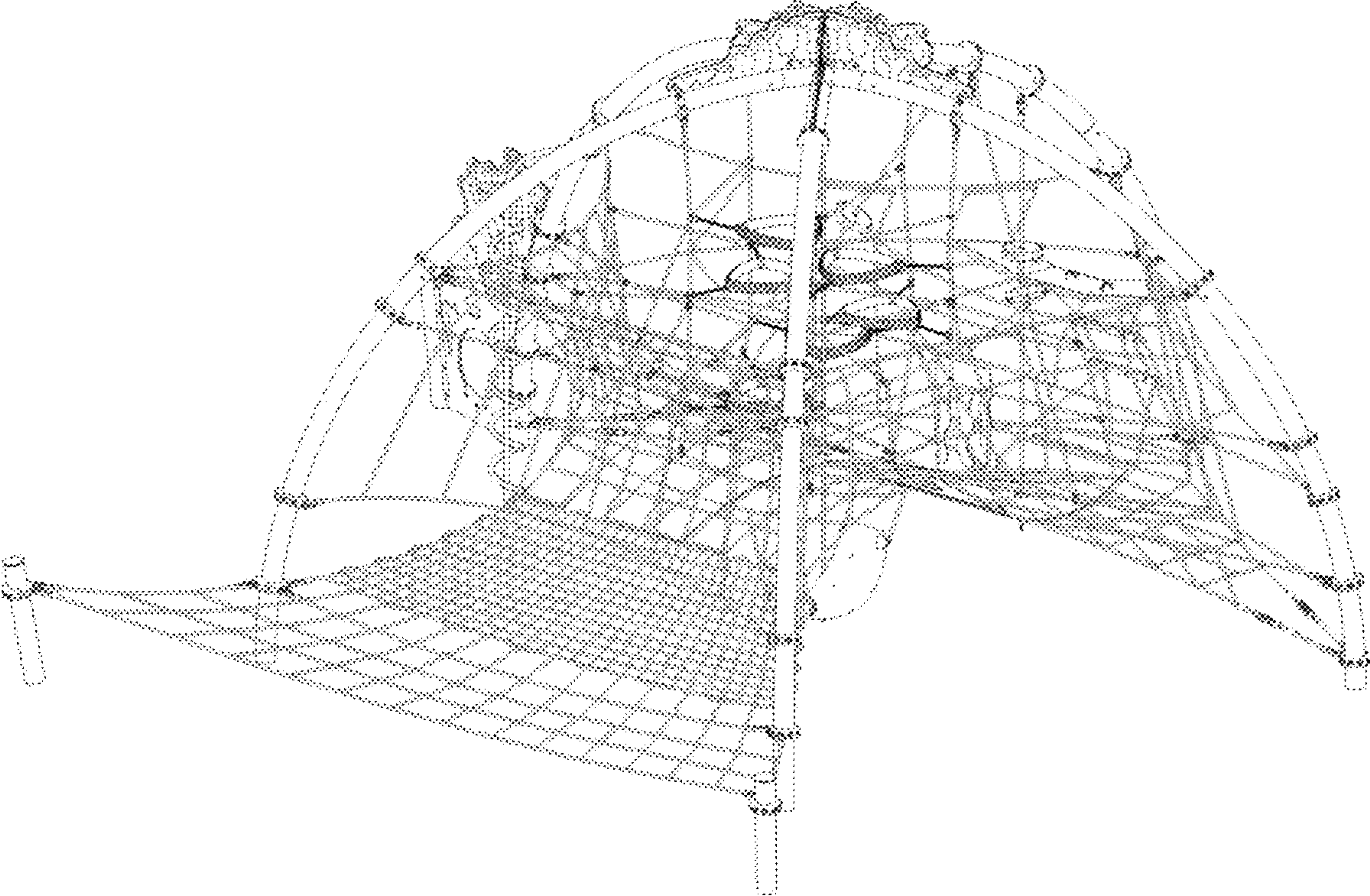
**DESCRIPTION**

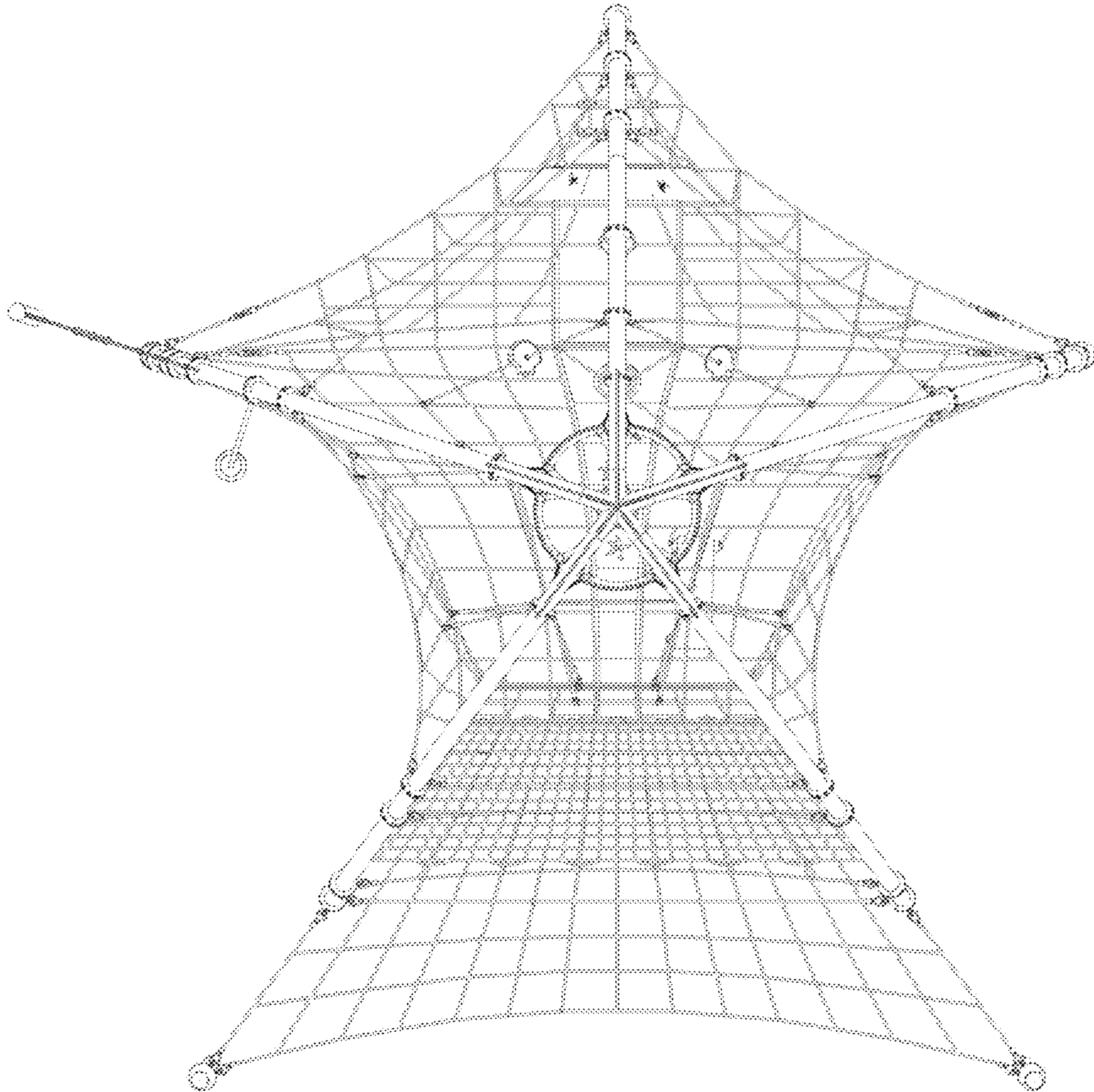

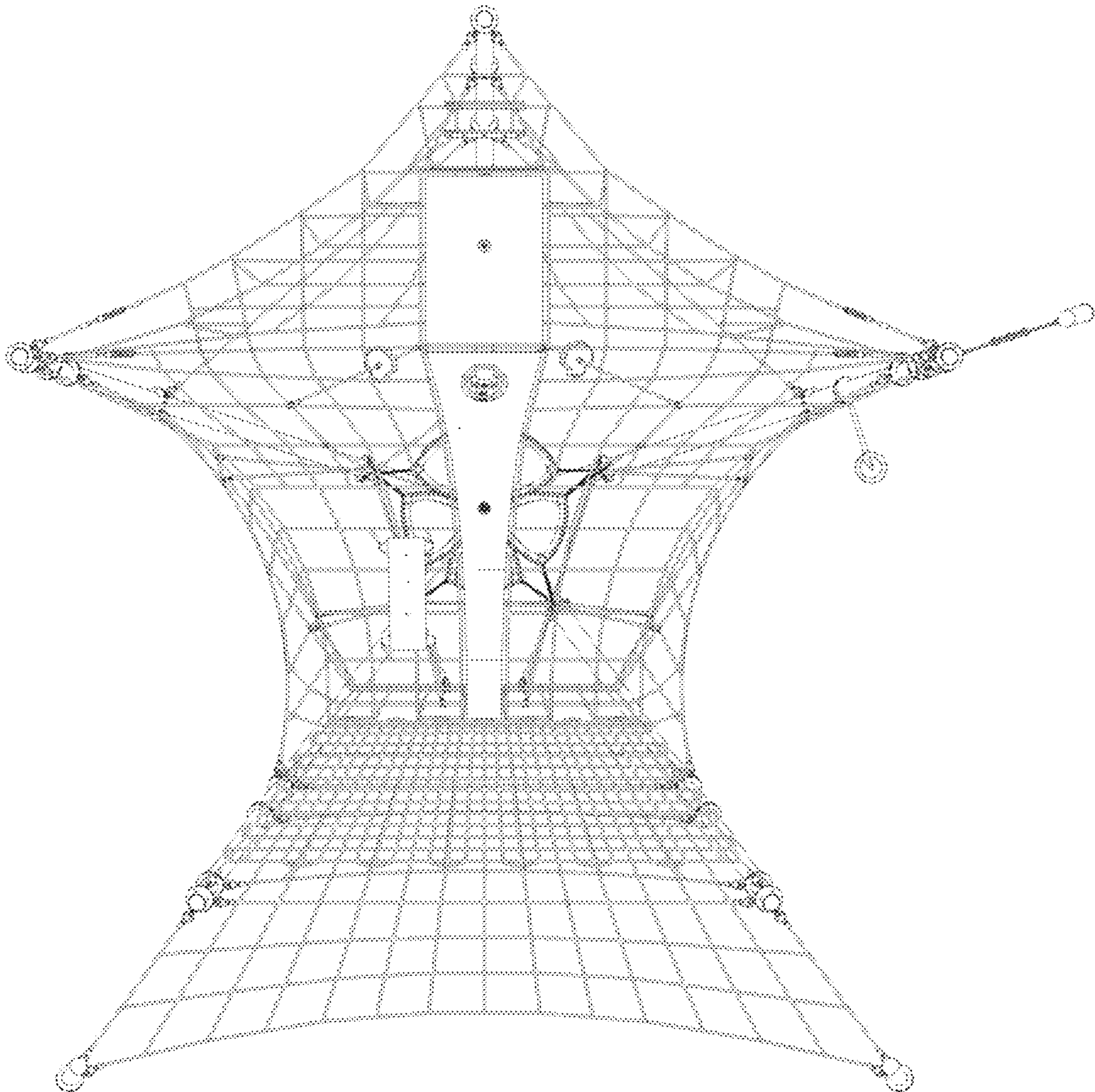

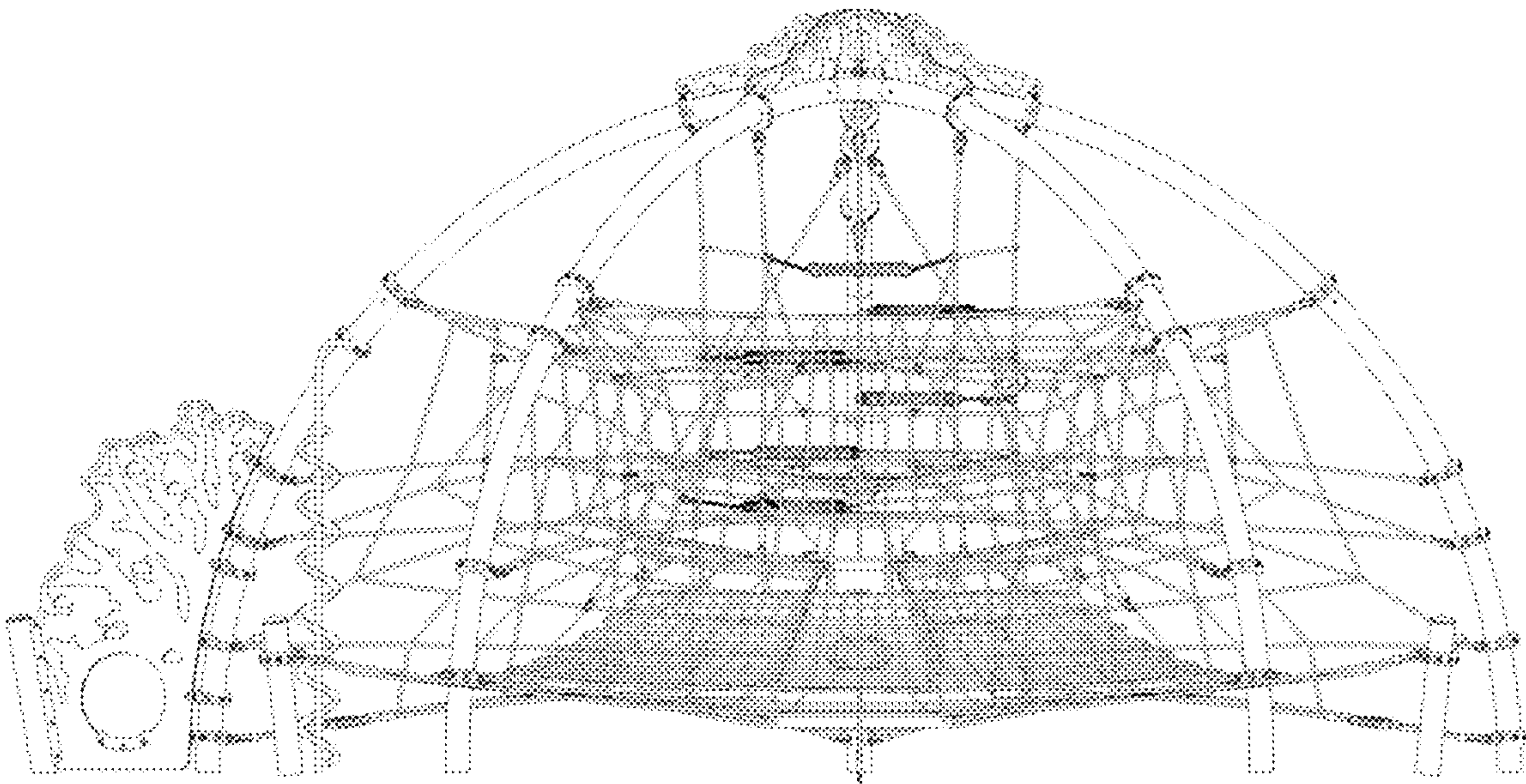

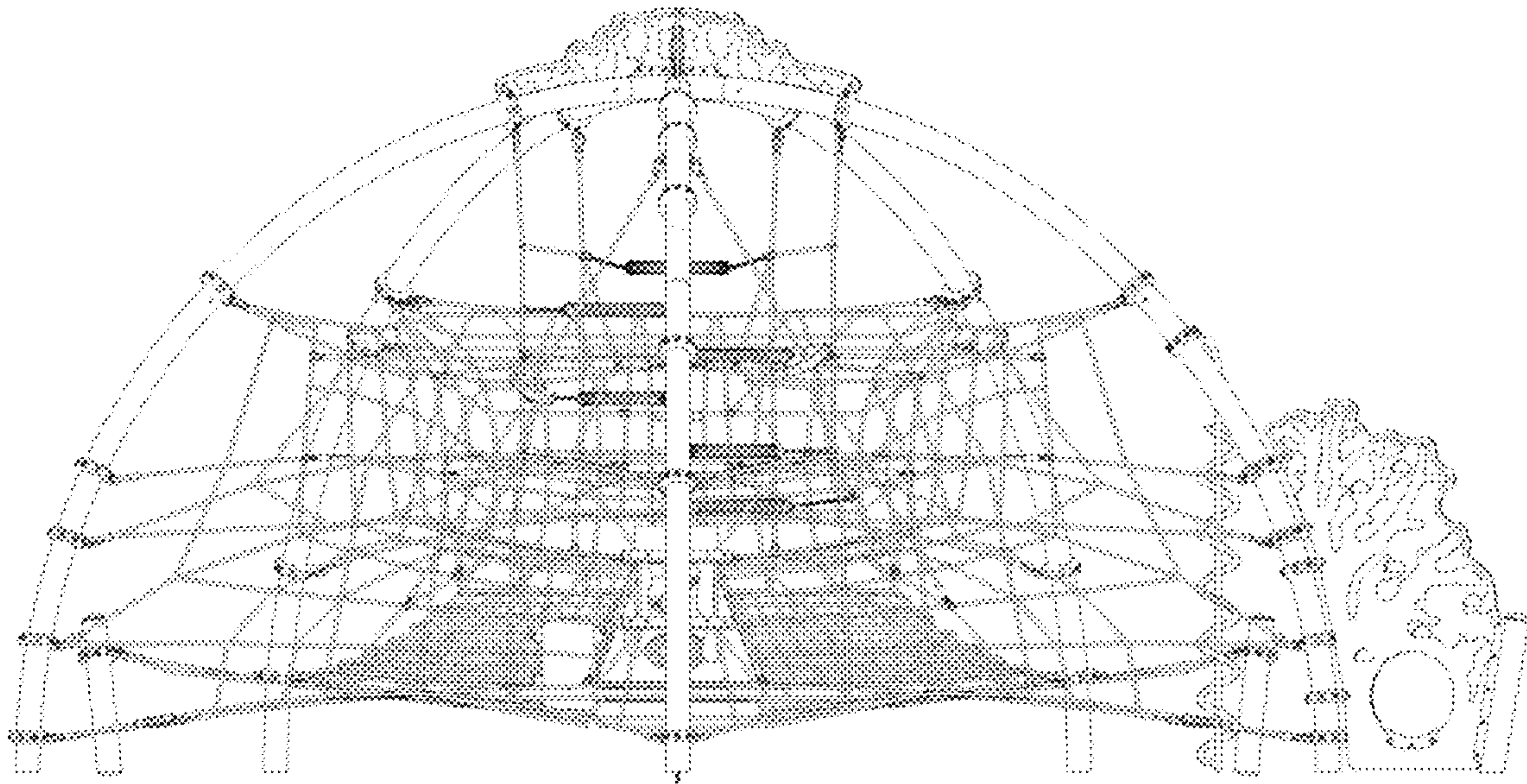




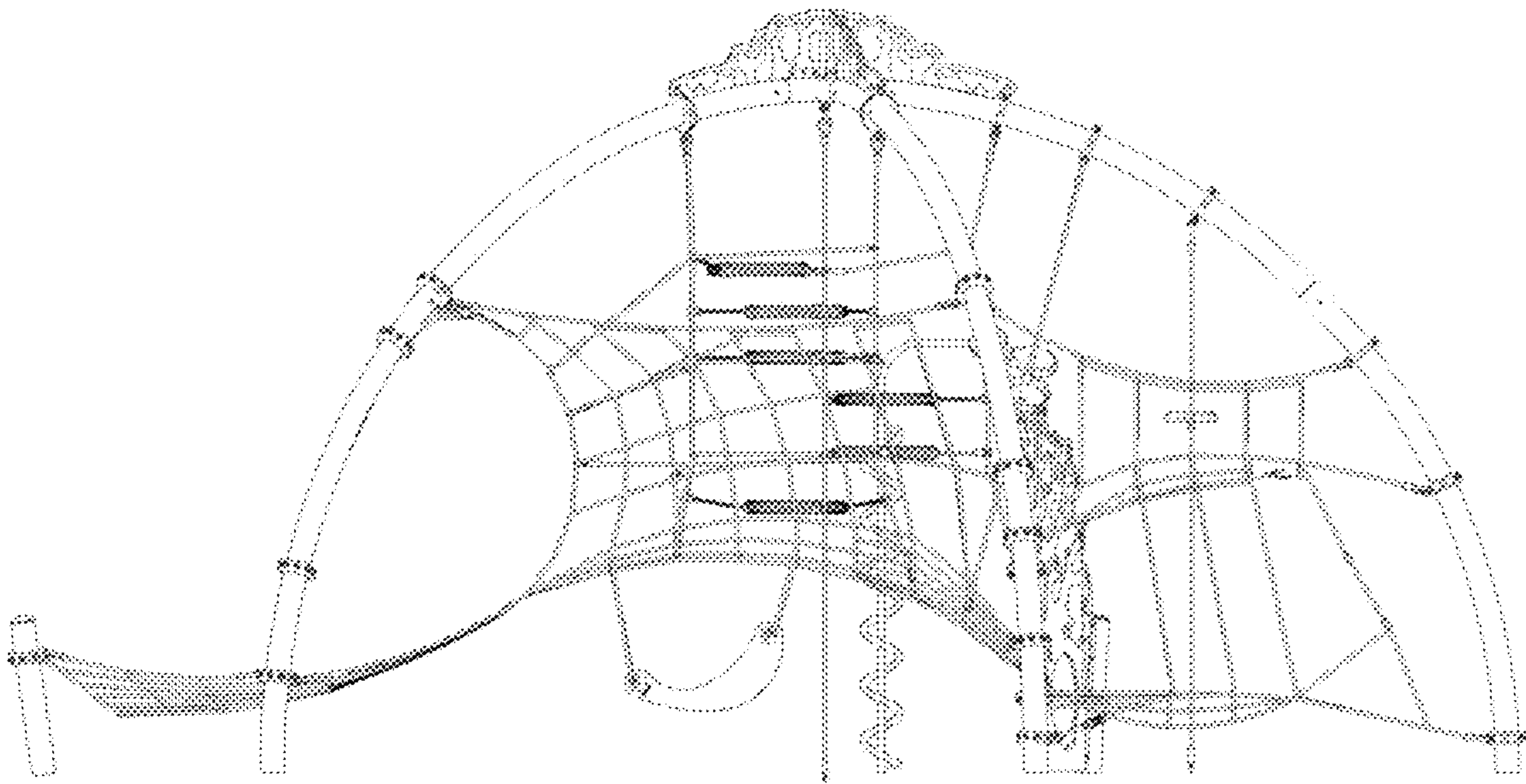
