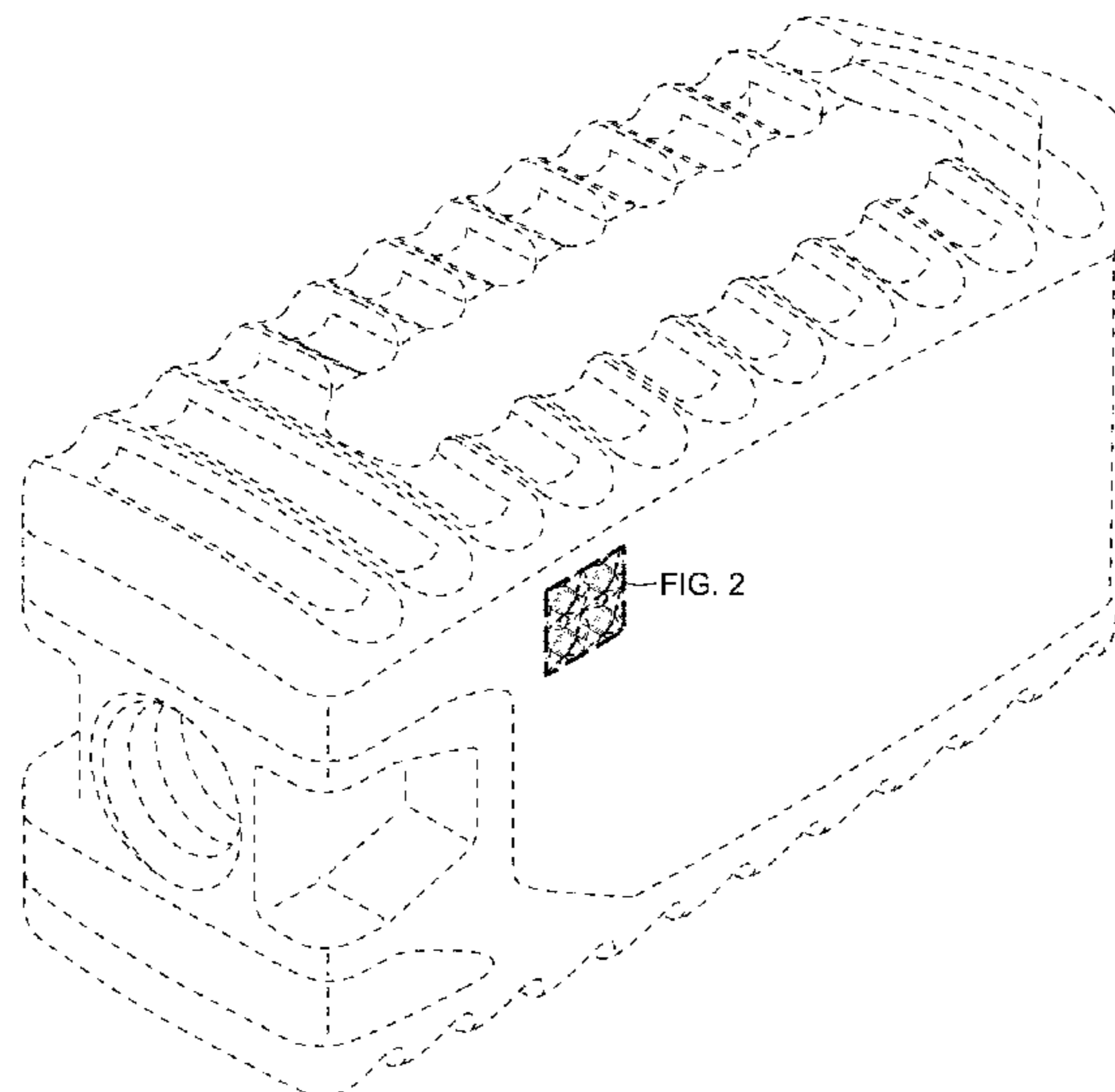
The ornamental design for an interbody fusion implant, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing the rear, top and right sides of the interbody fusion implant, showing my new design;

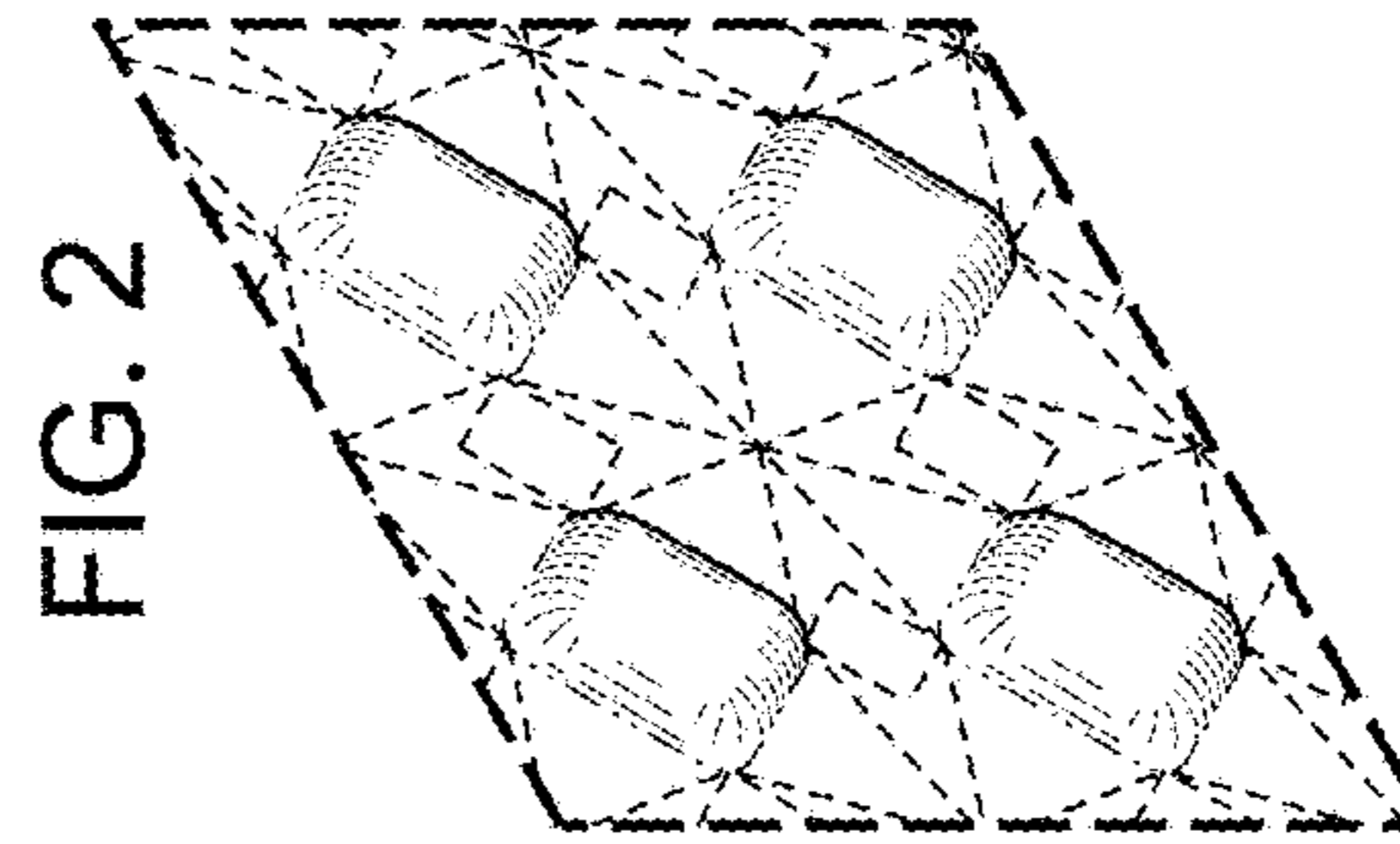
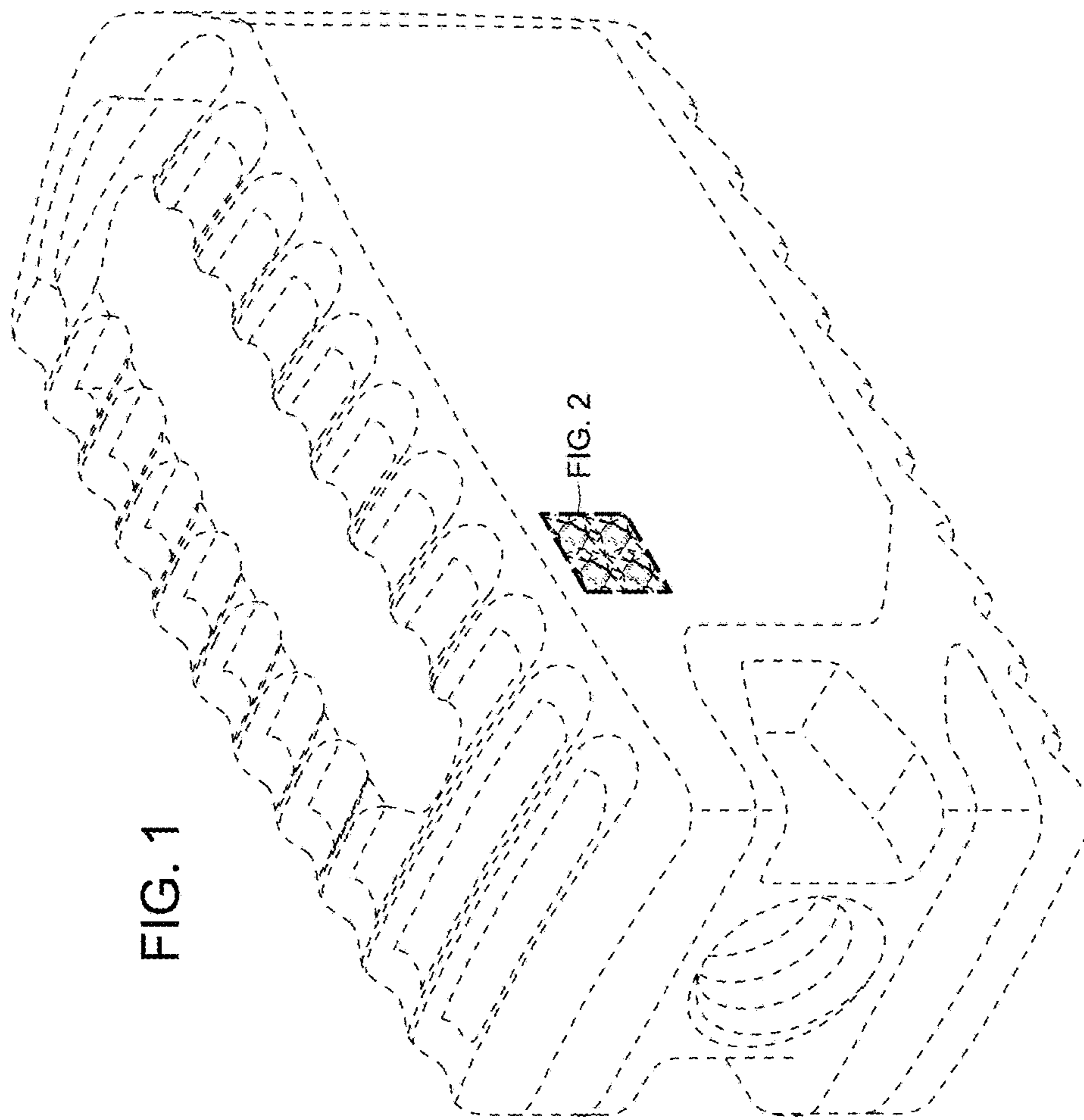

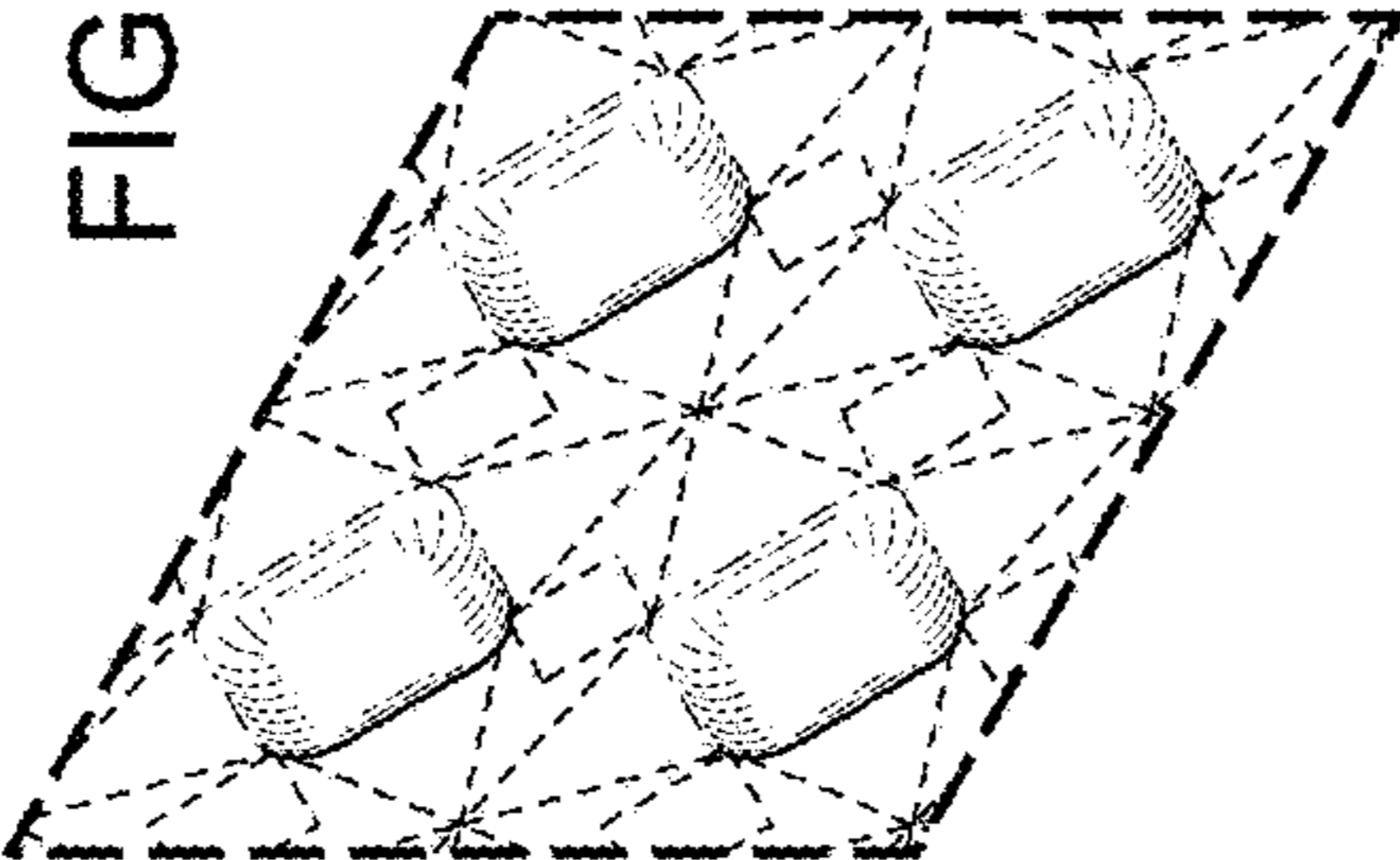
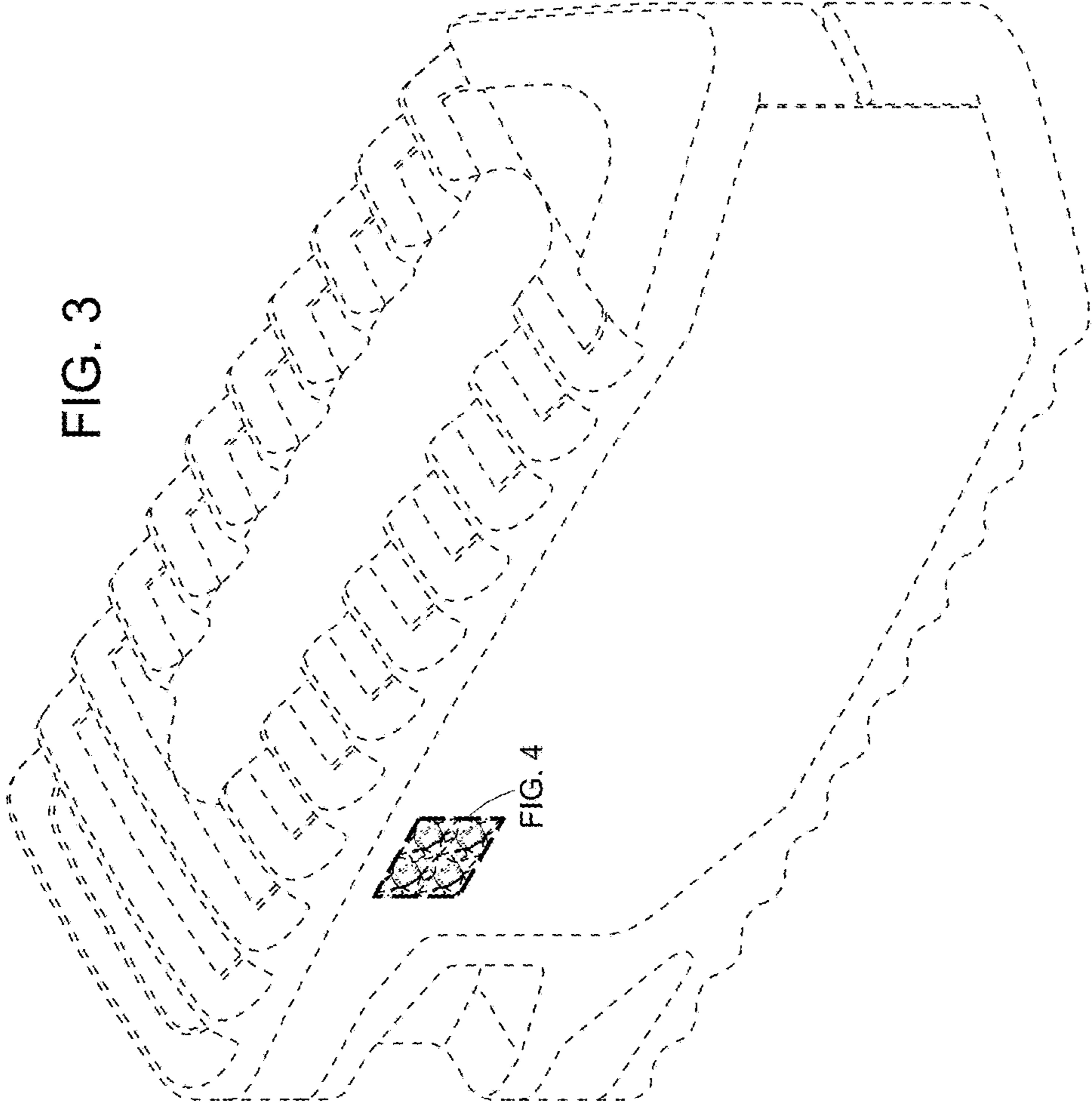

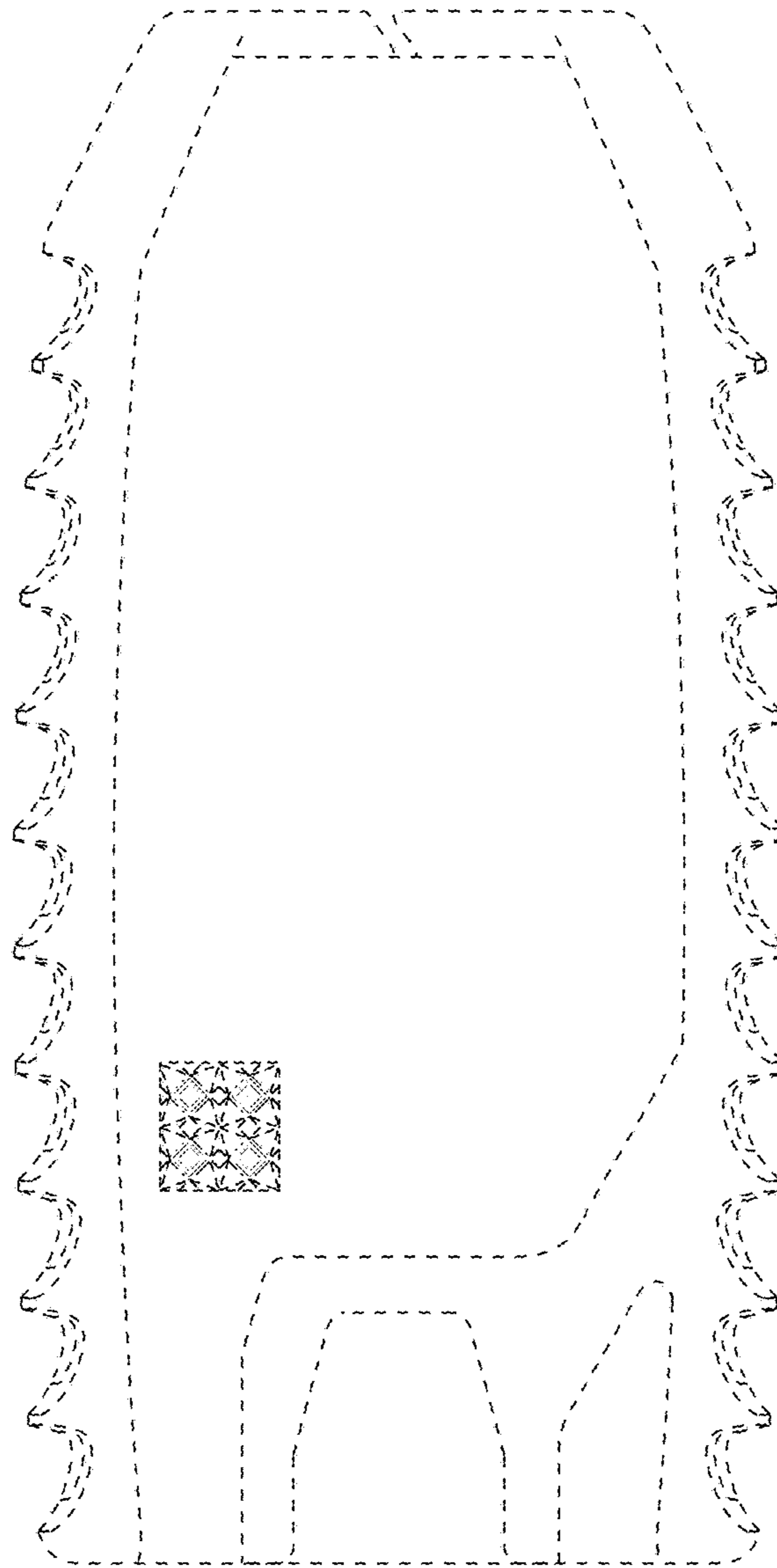

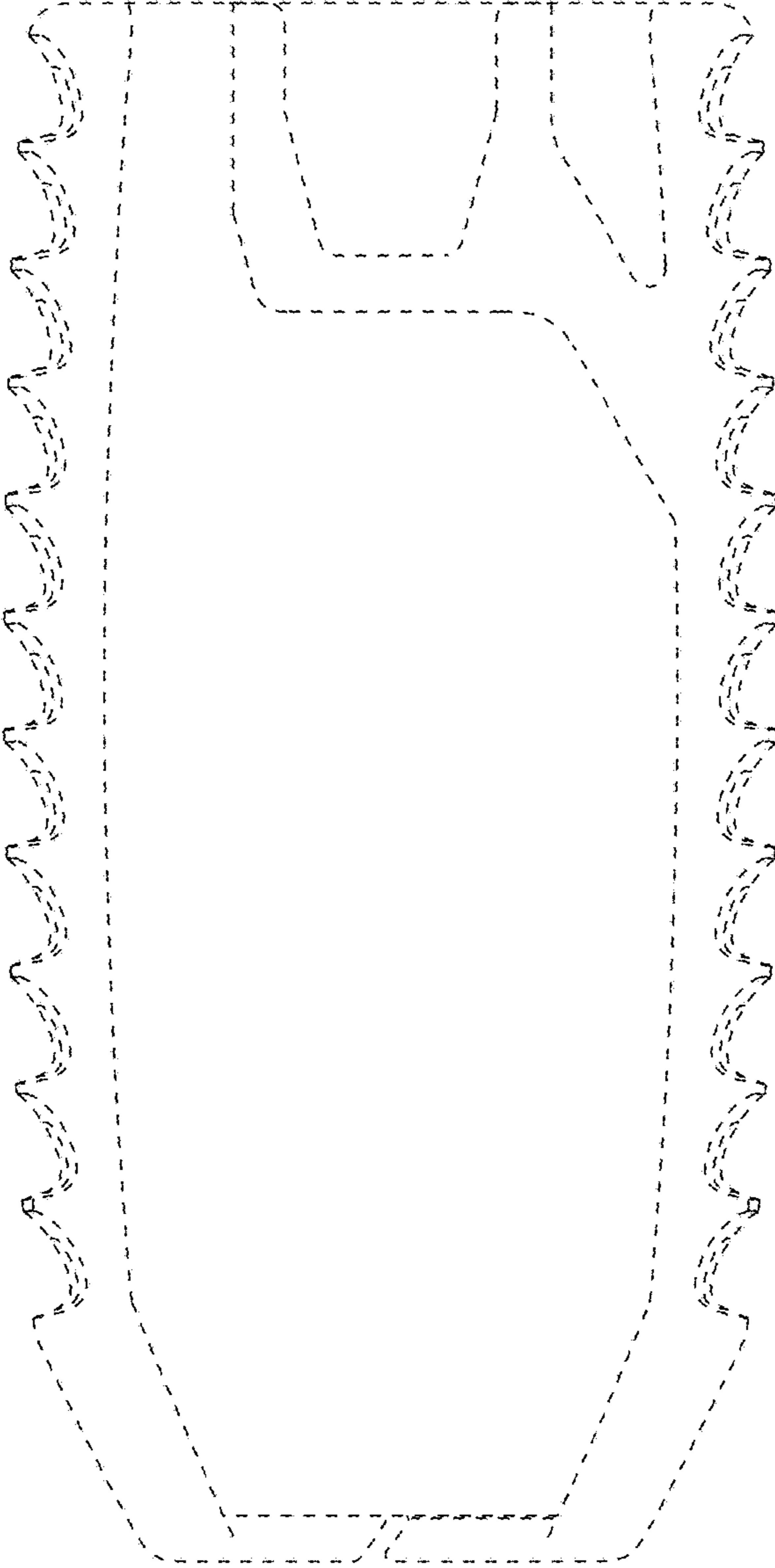

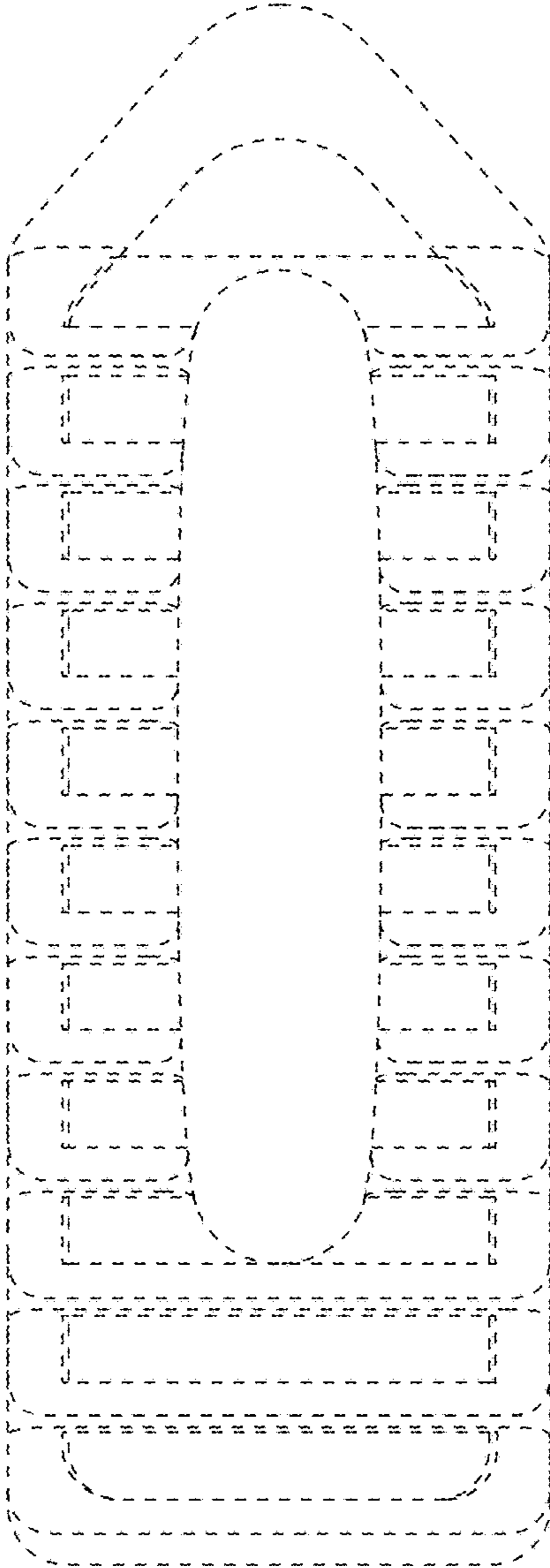

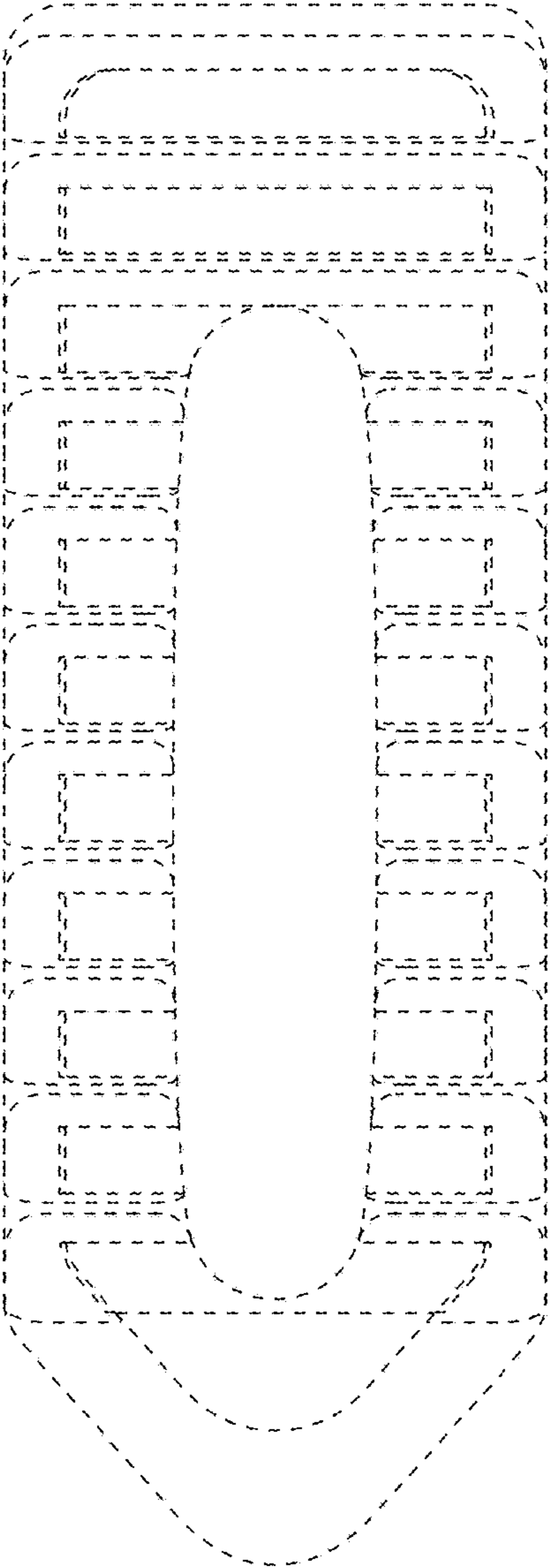

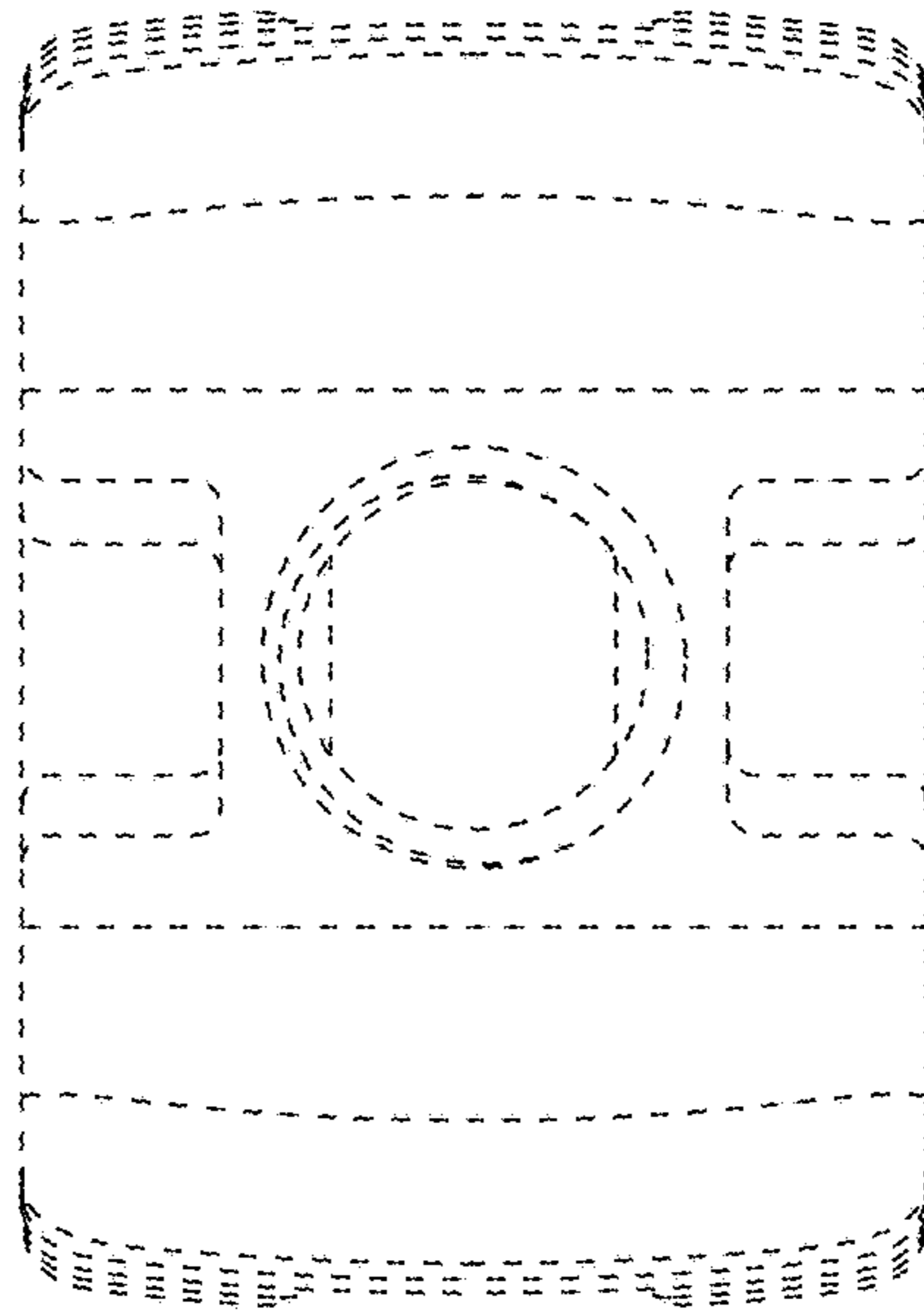

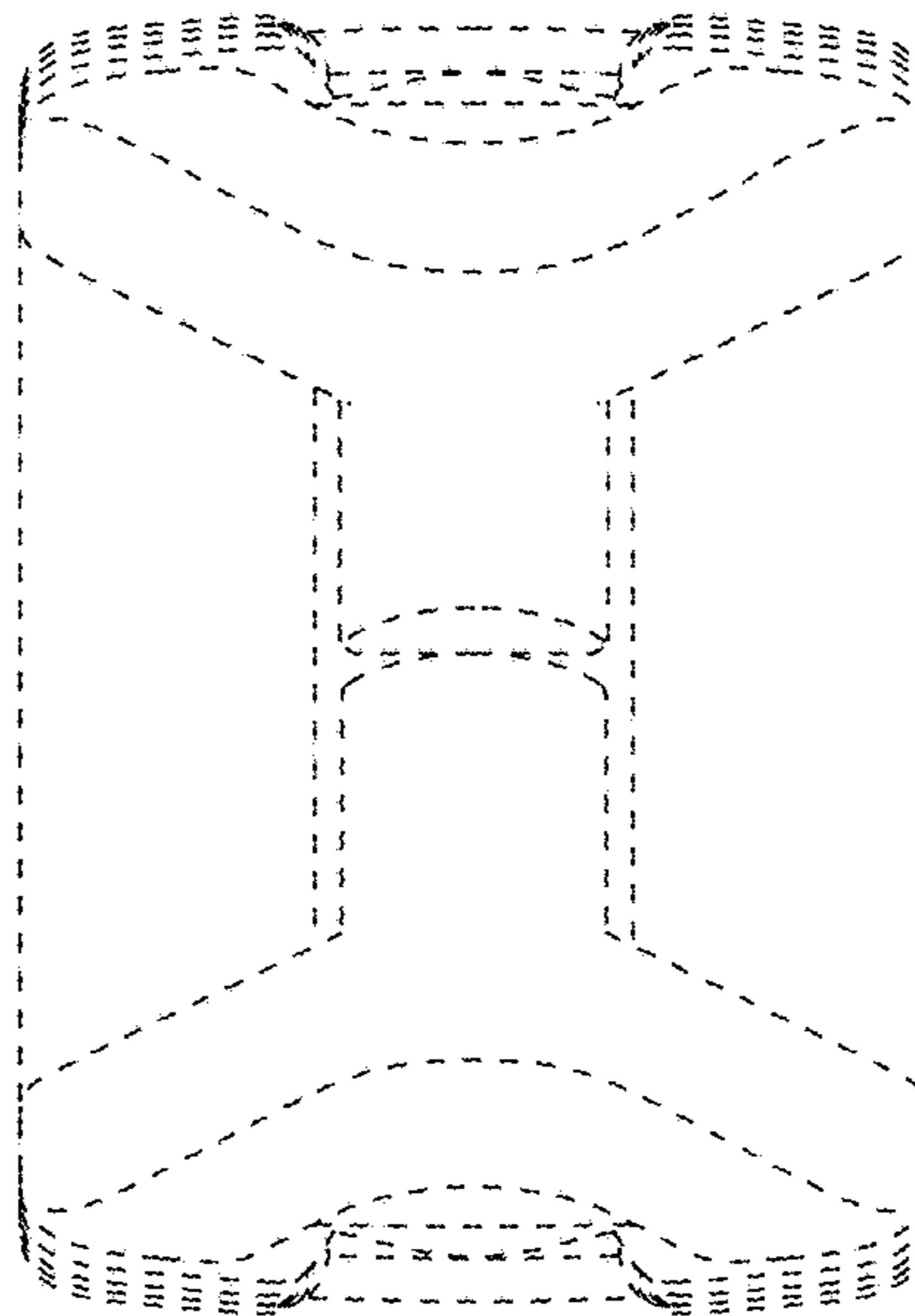
