(57) **CLAIM**

We claim ornamental design for a dental implant, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a dental implant according to the present invention;  
 FIG. 2 is a right-side elevational view of the dental implant of FIG. 1;  
 FIG. 3 is a left-side elevational view of the dental implant of FIG. 1;  
 FIG. 4 is a front elevational view of the dental implant of FIG. 1;  
 FIG. 5 is a rear elevational view of the dental implant of FIG. 1;  
 FIG. 6 is a top plan view of the dental implant of FIG. 1; and,  
 FIG. 7 is a bottom plan view of the dental implant of FIG. 1.

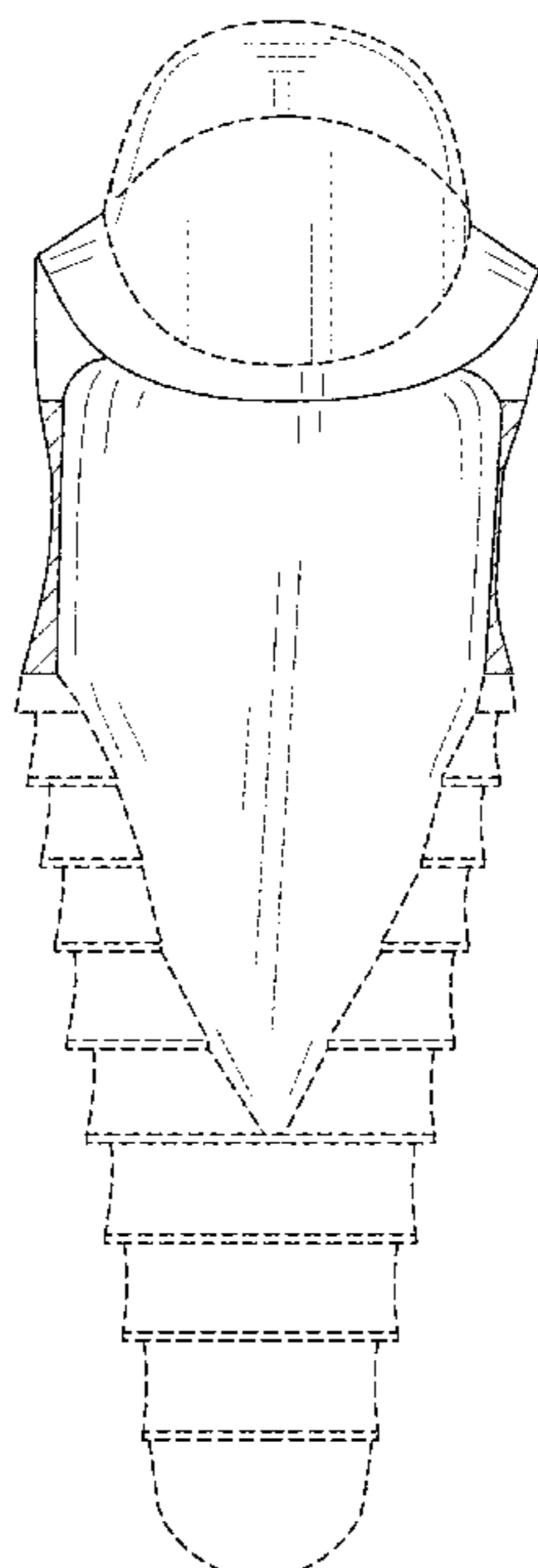
The broken line showing is included for the purpose of illustrating portions of the dental implant that form no part of the claimed design.

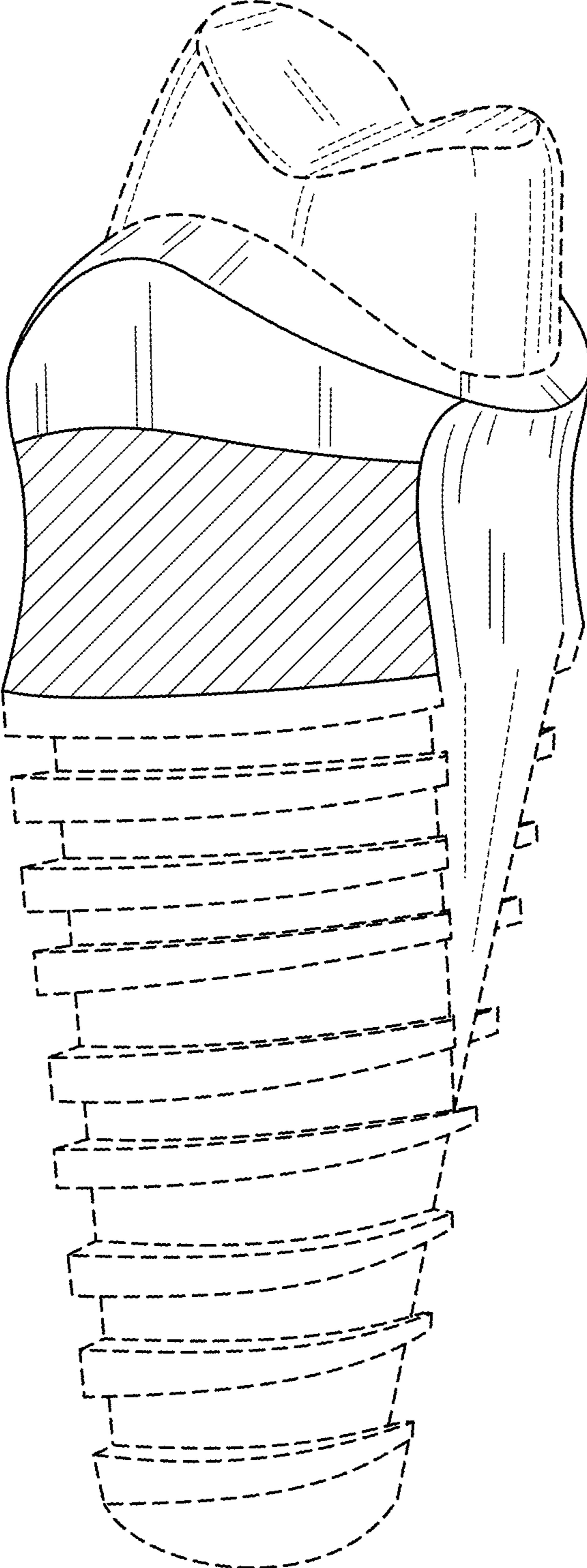

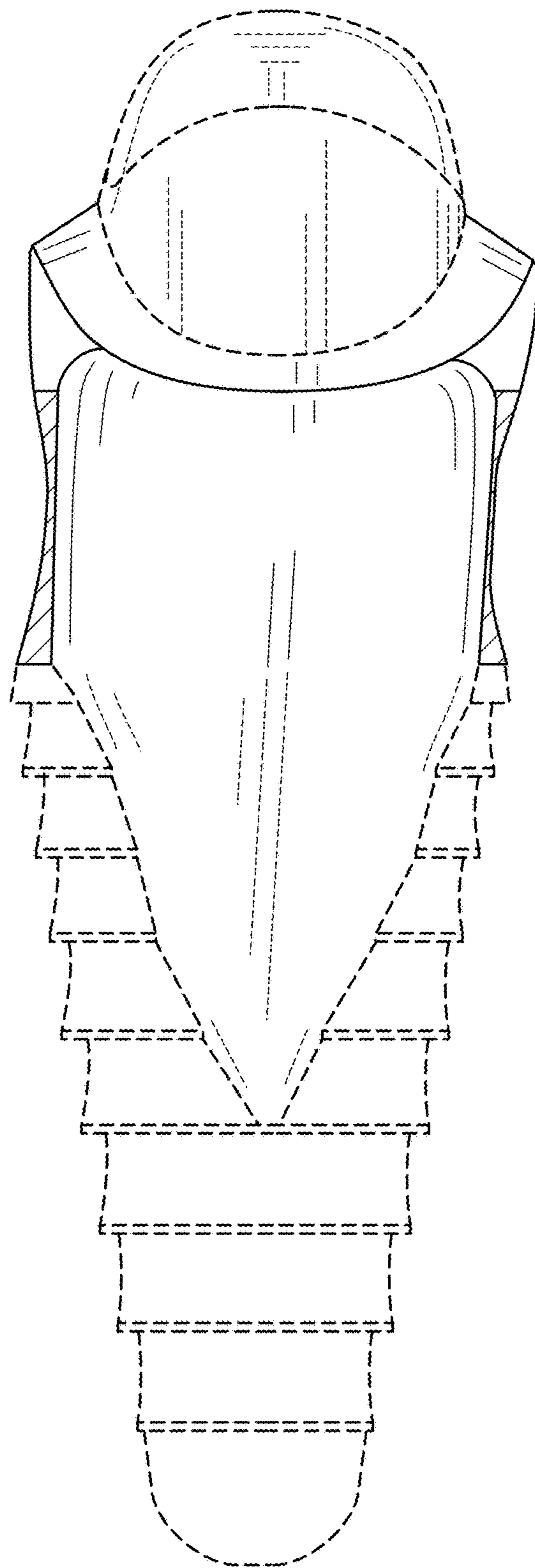

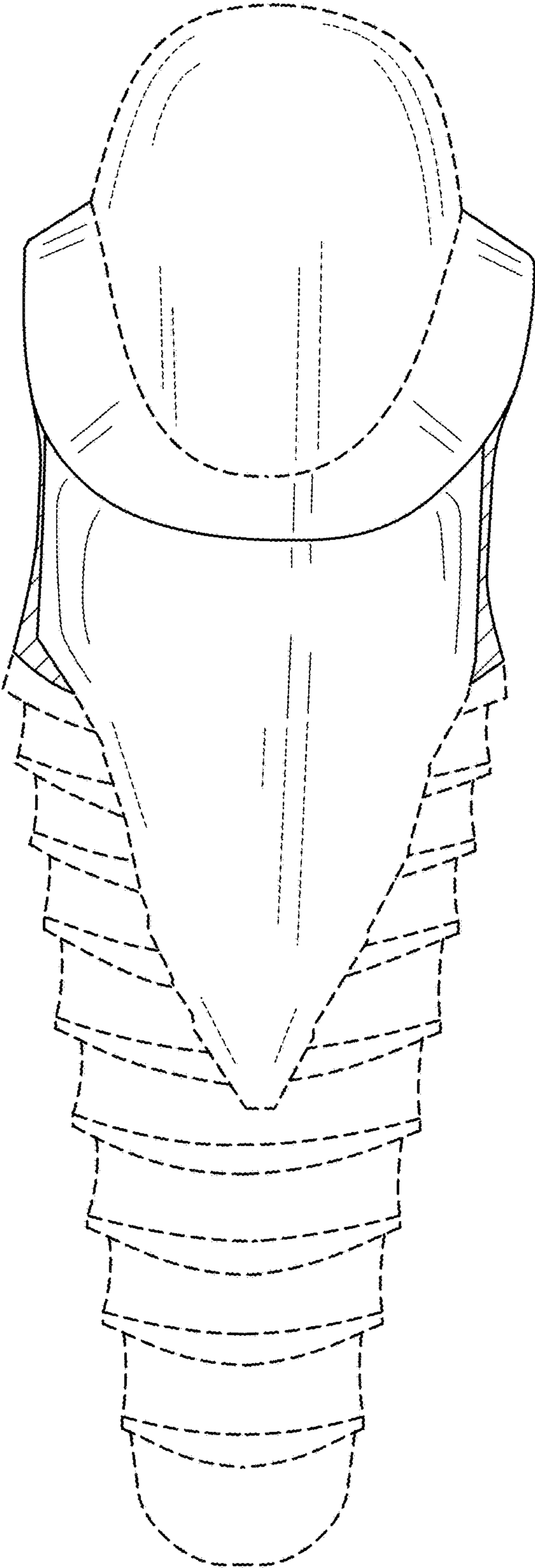

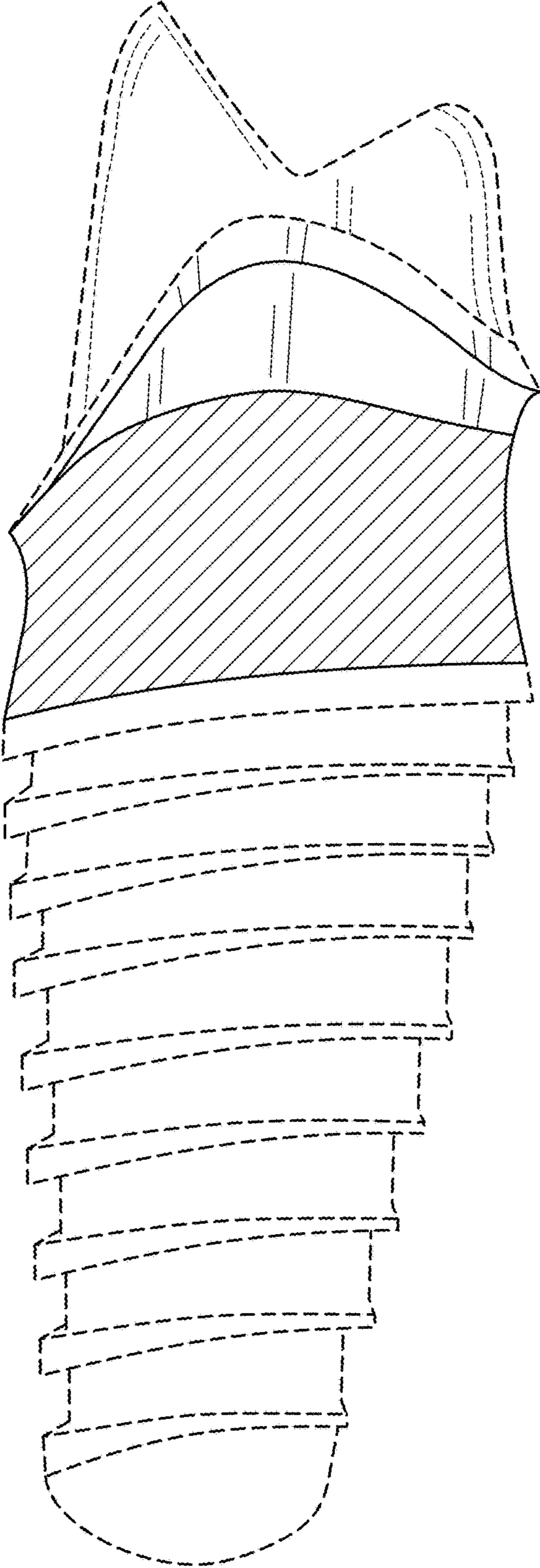

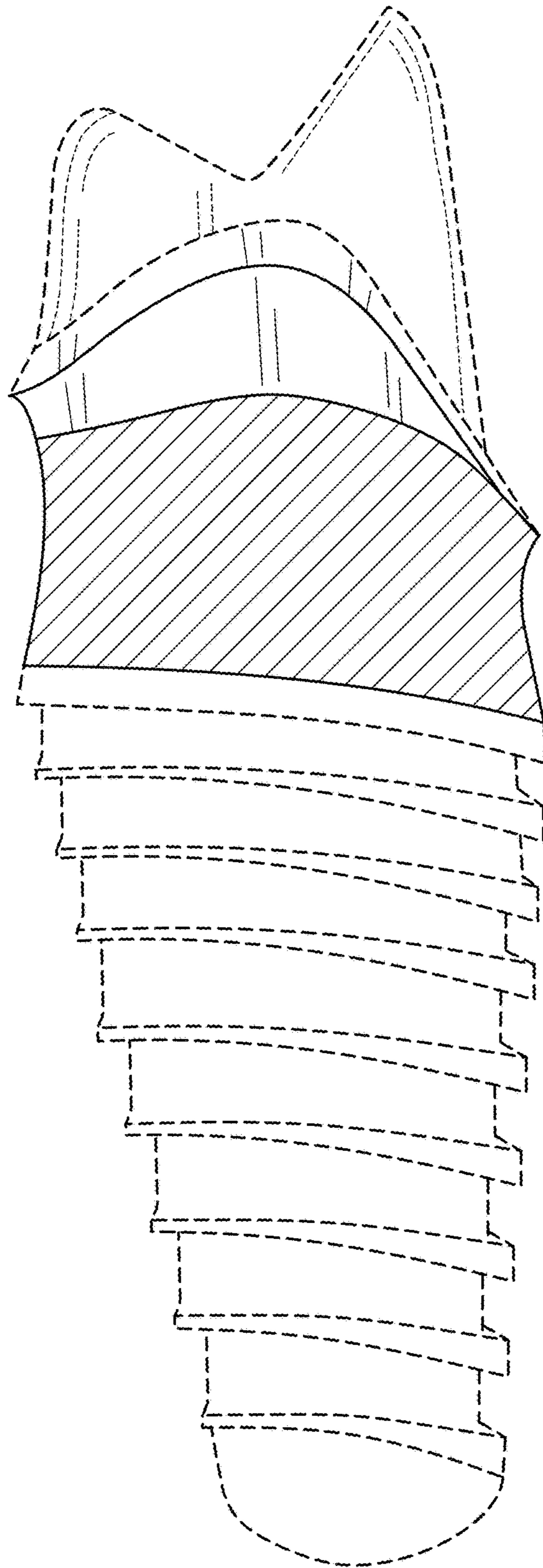

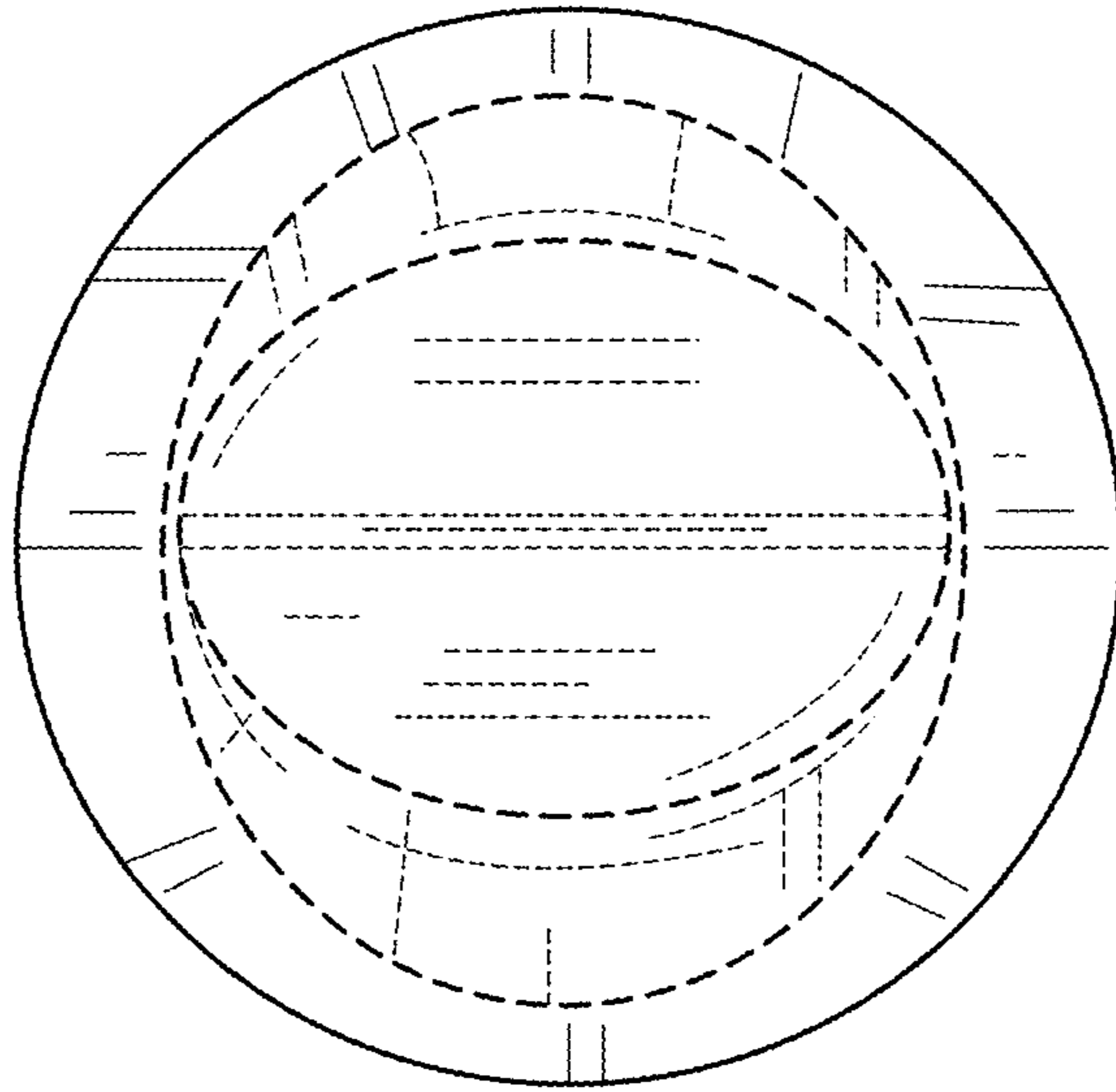

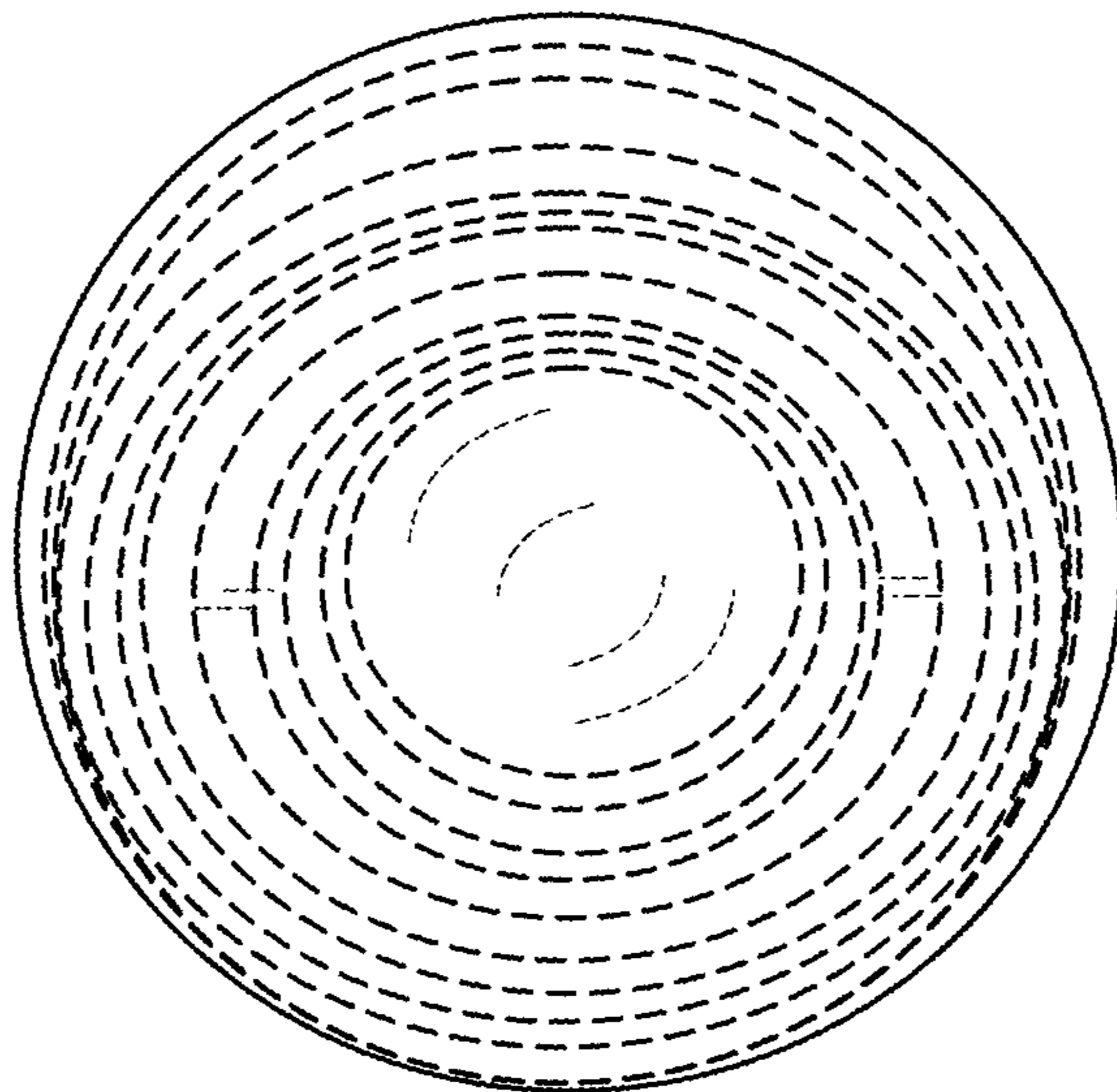
