The ornamental design for a cot fastener, as shown and described.

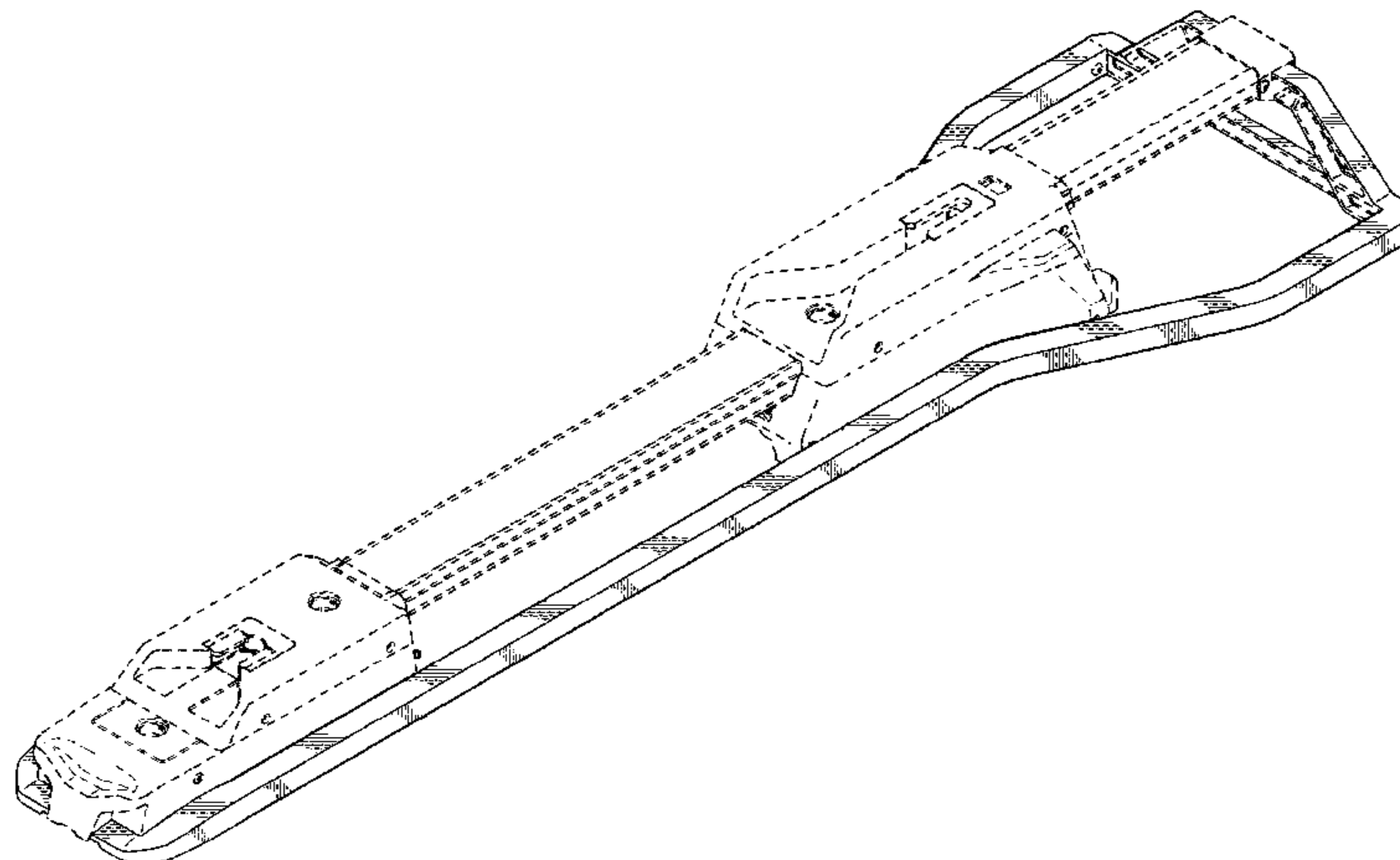
DESCRIPTION

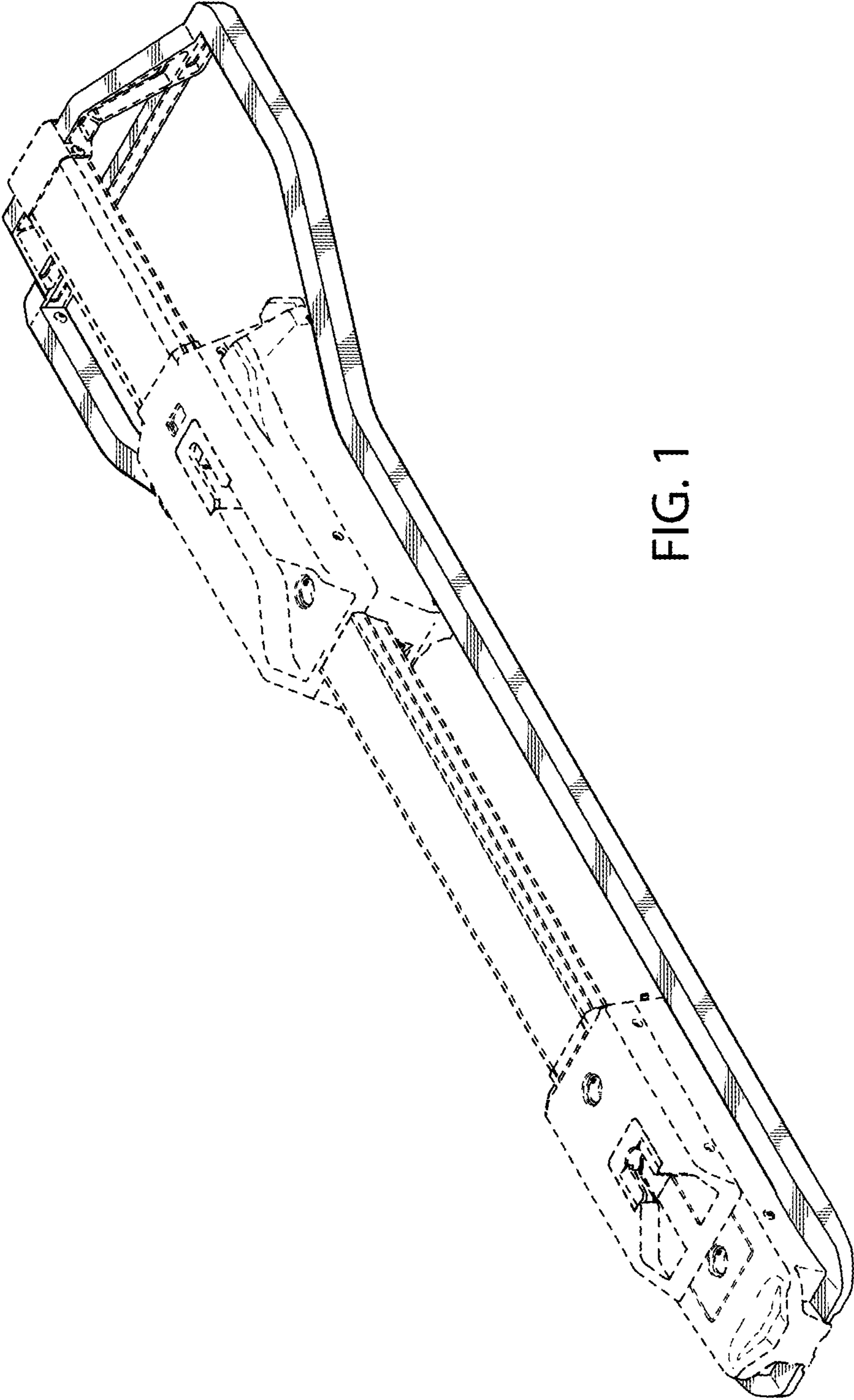

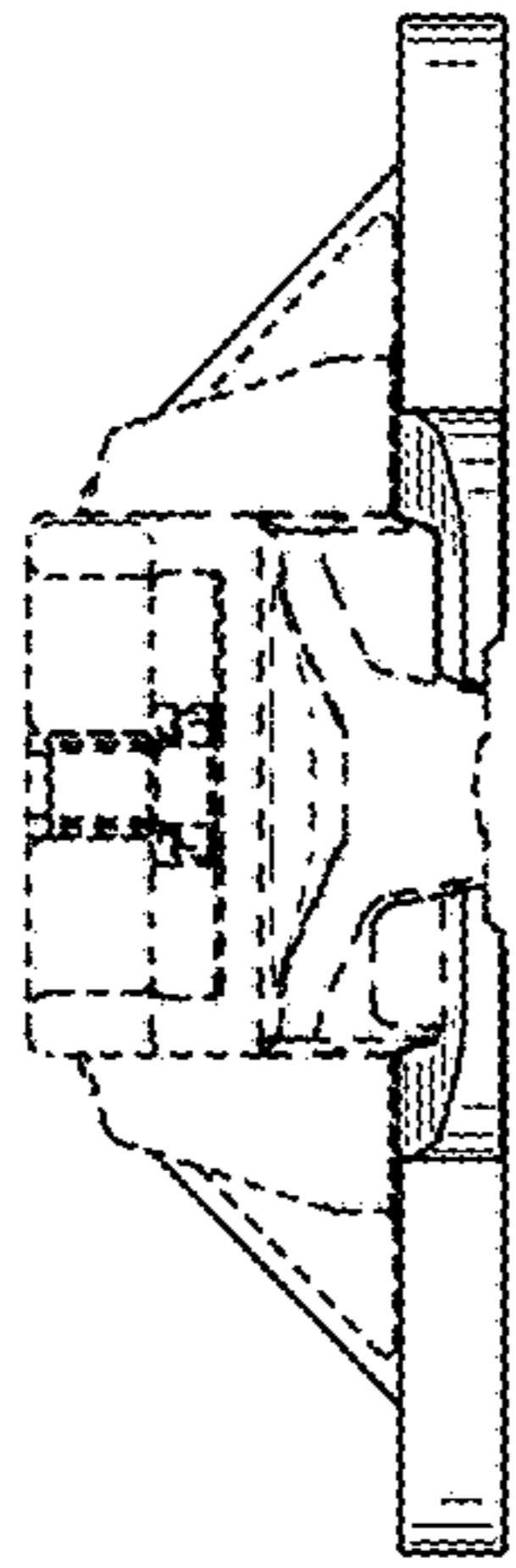

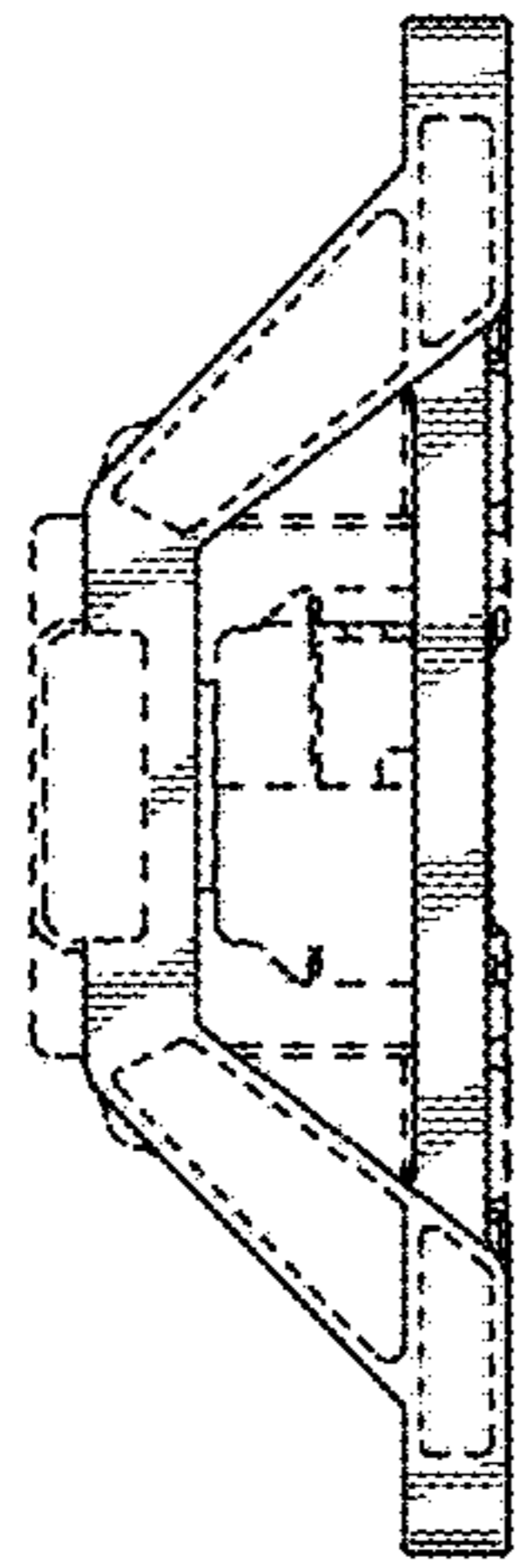

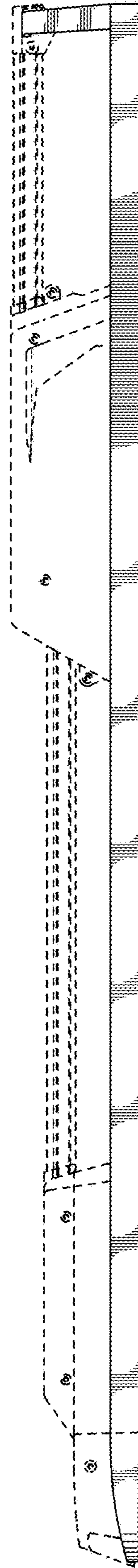

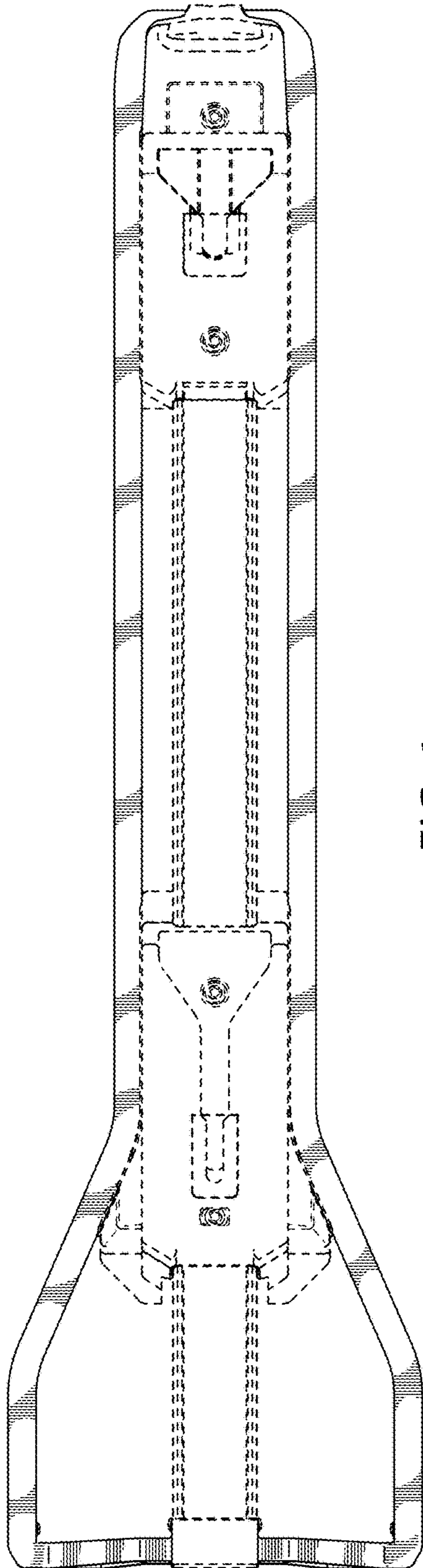

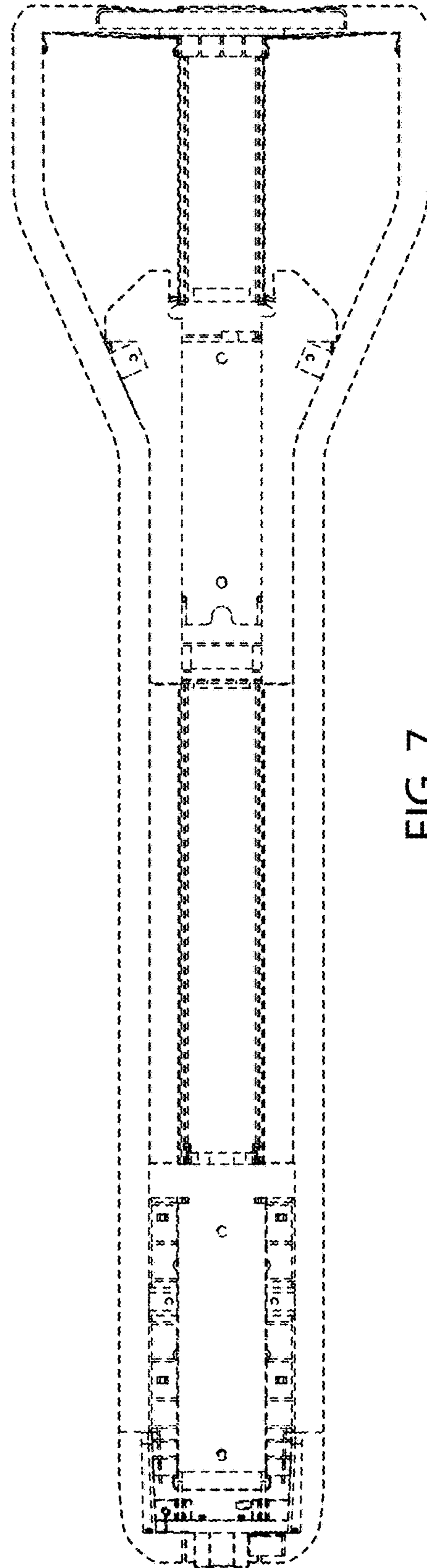
