FIG. 4 is a top plan view thereof;

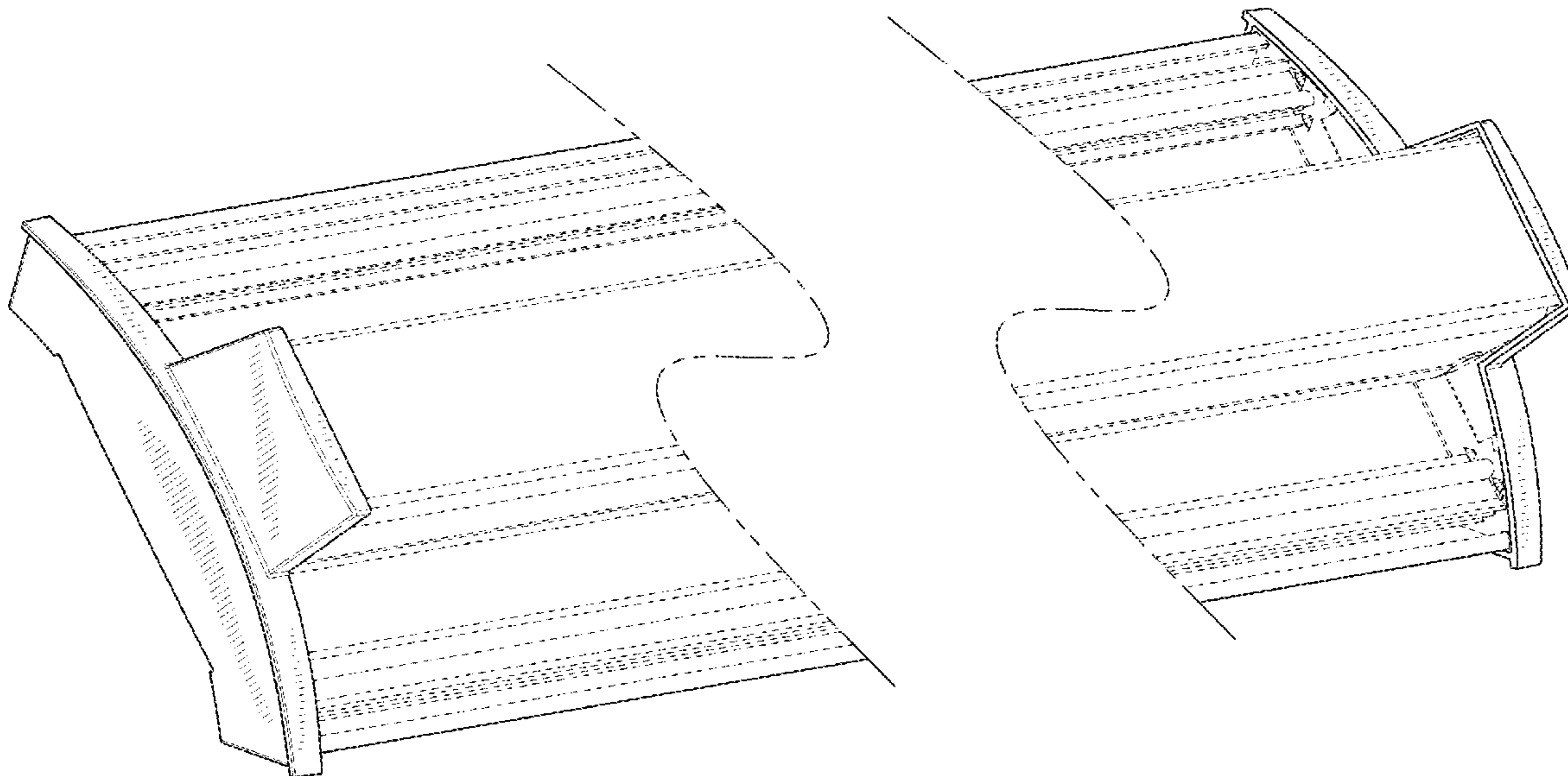
FIG. 5 is a left-side elevation view thereof, the right-side elevation view begin the same; and,

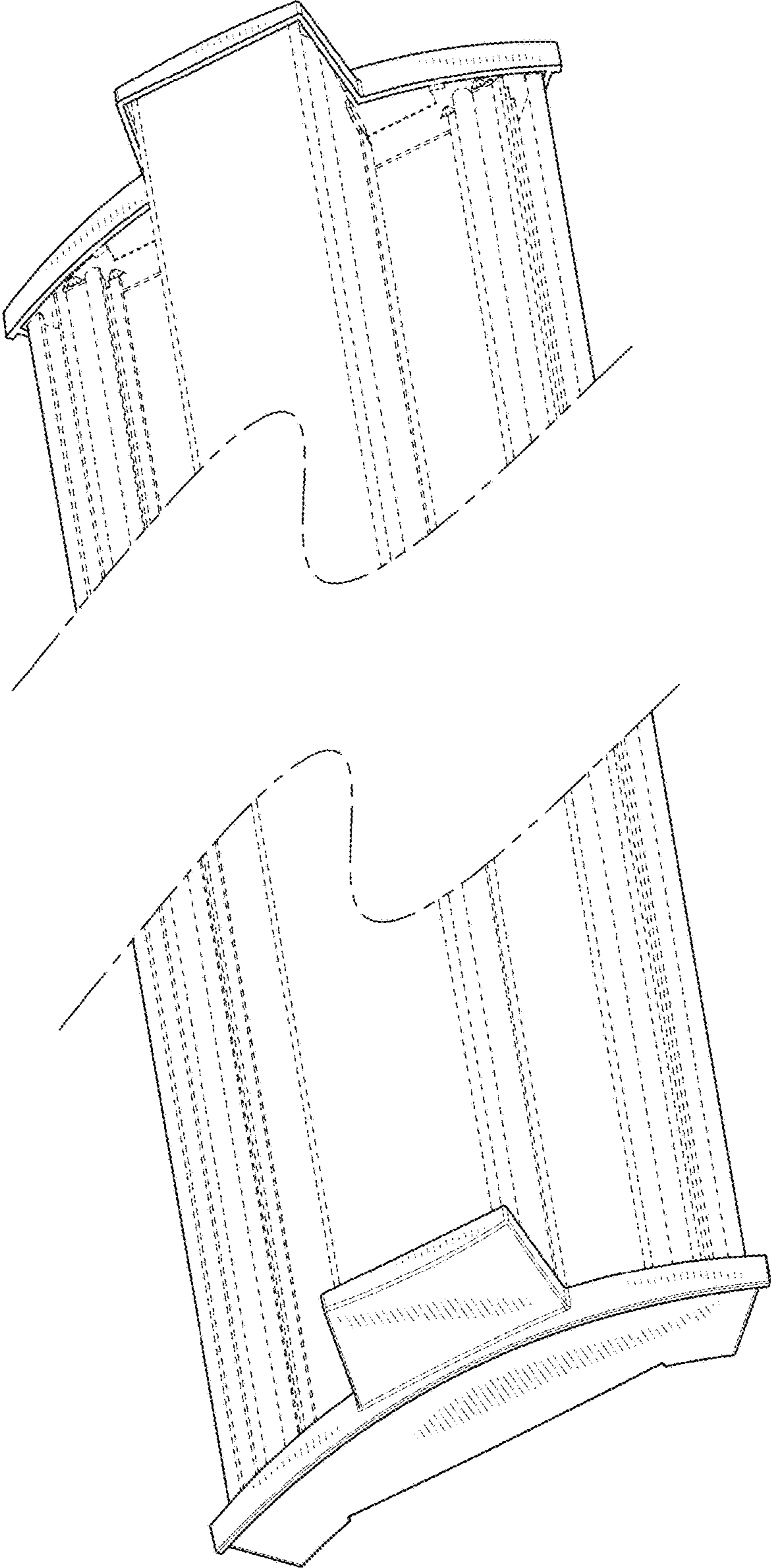

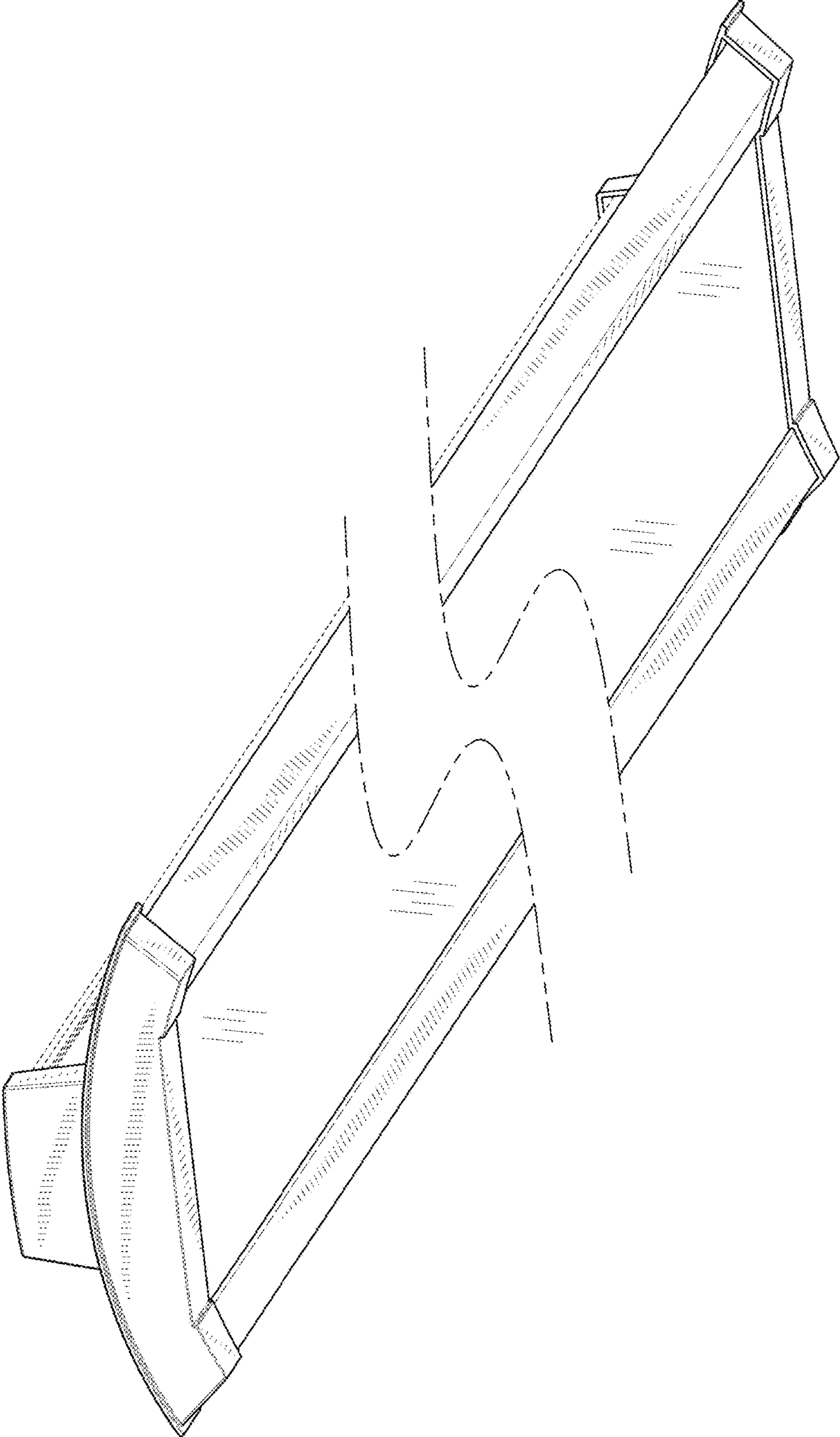
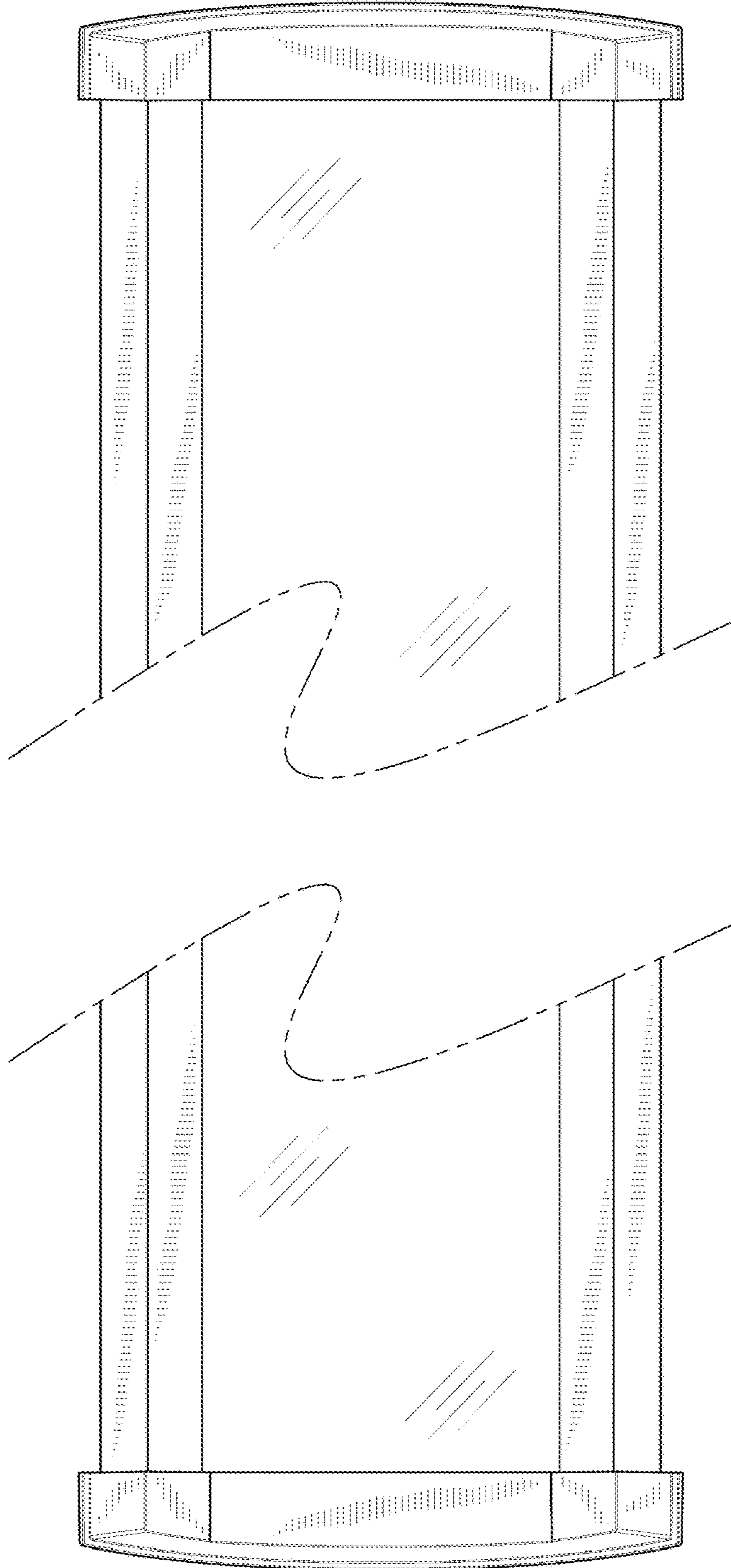

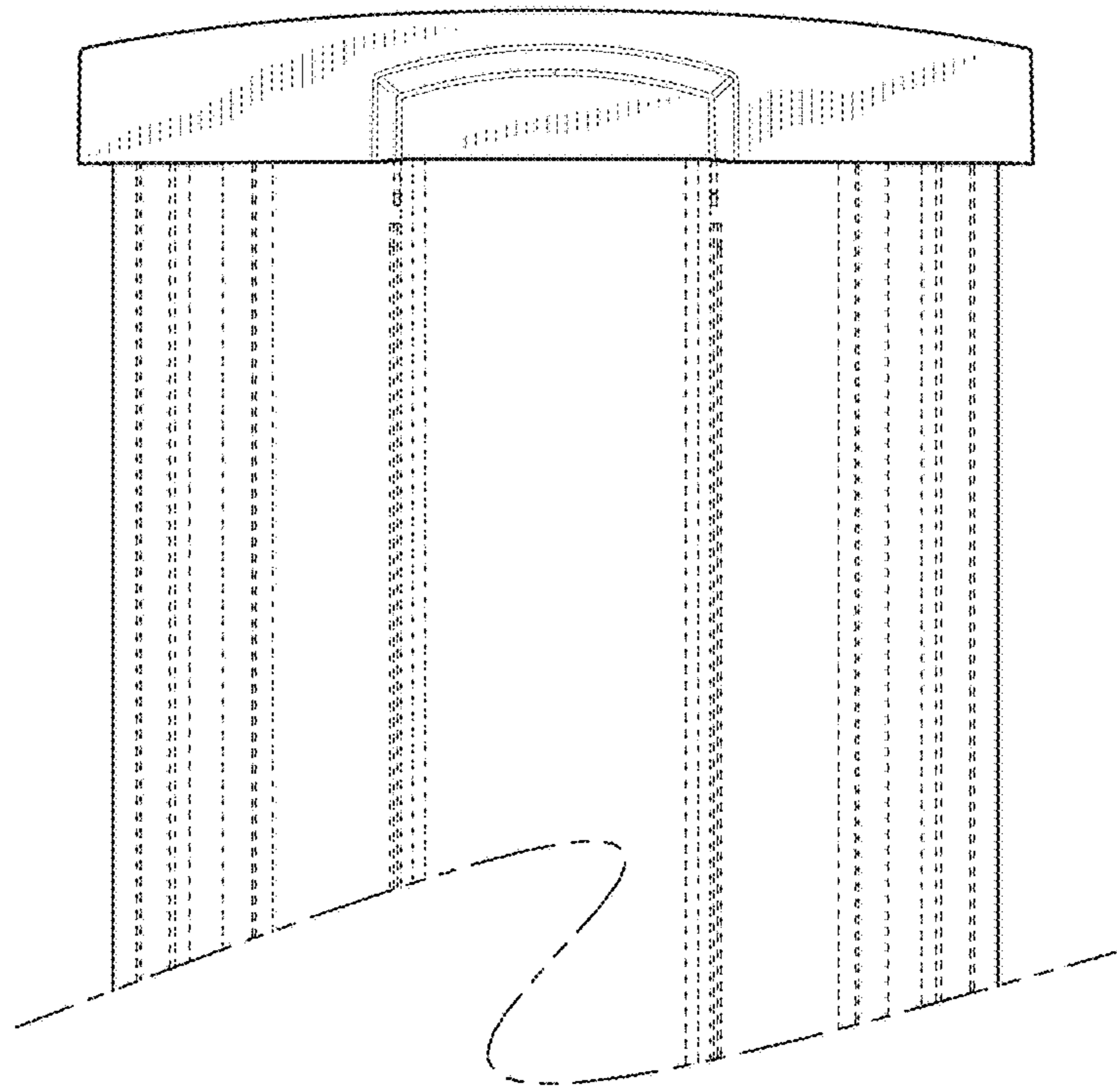

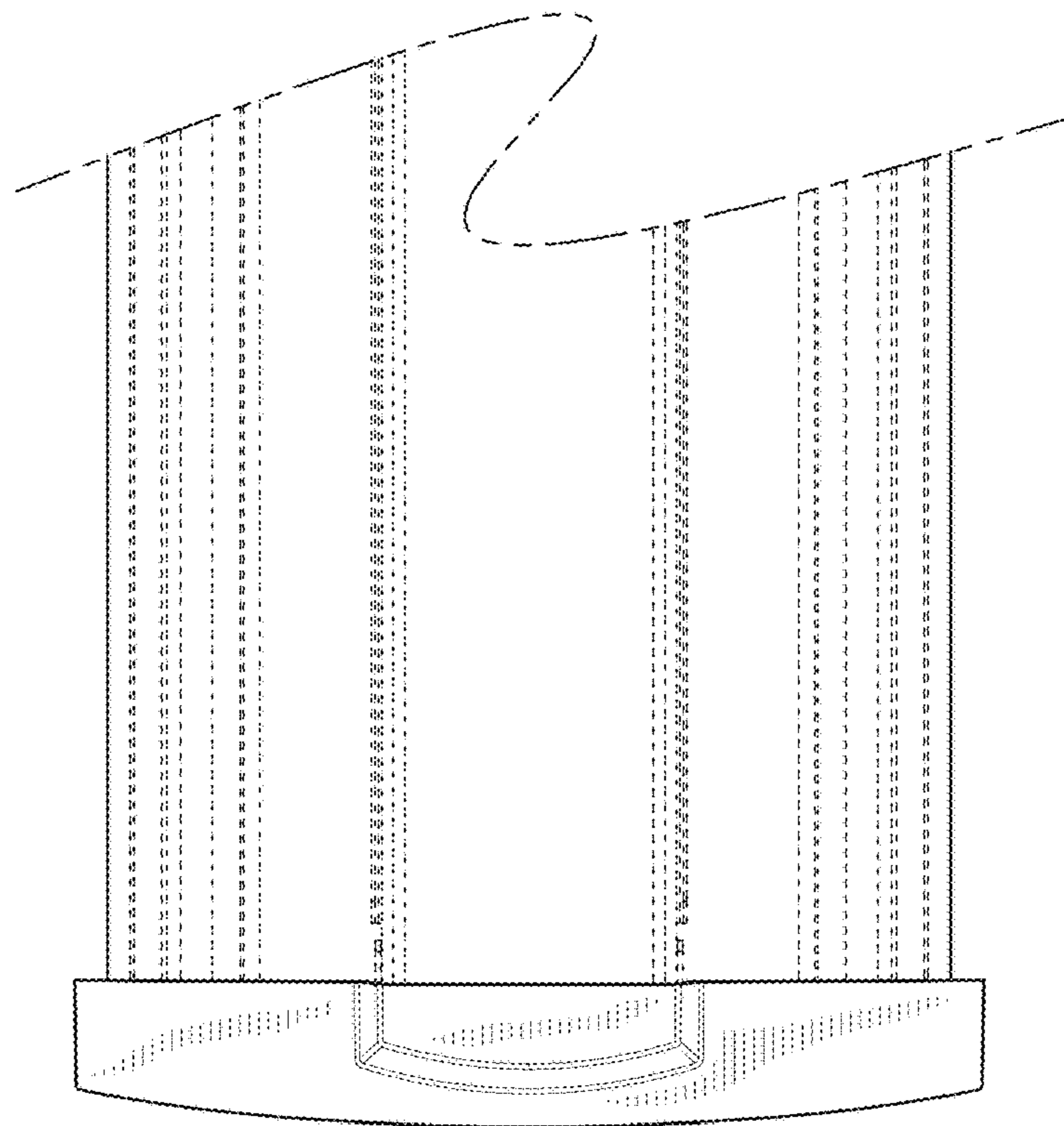

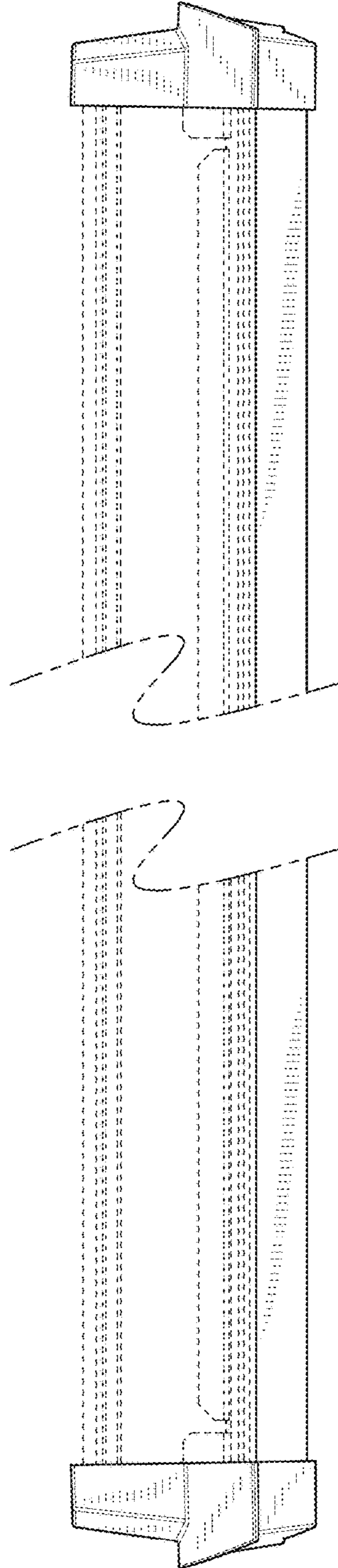
