The ornamental design for a garment management apparatus, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a garment management apparatus, showing my new design;

FIG. 2 is a front elevation view of FIG. 1 thereof;

FIG. 3 is a rear elevation view of FIG. 1 thereof;

FIG. 4 is a side elevation view of FIG. 1 thereof;

FIG. 5 is an opposite side elevation view of FIG. 1 thereof;

FIG. 6 is a top plan view of FIG. 1 thereof;

FIG. 7 is an elevation view of FIG. 1 thereof, showing the panels of the garment disassembled;

FIG. 8 is a perspective view of FIG. 7 thereof;

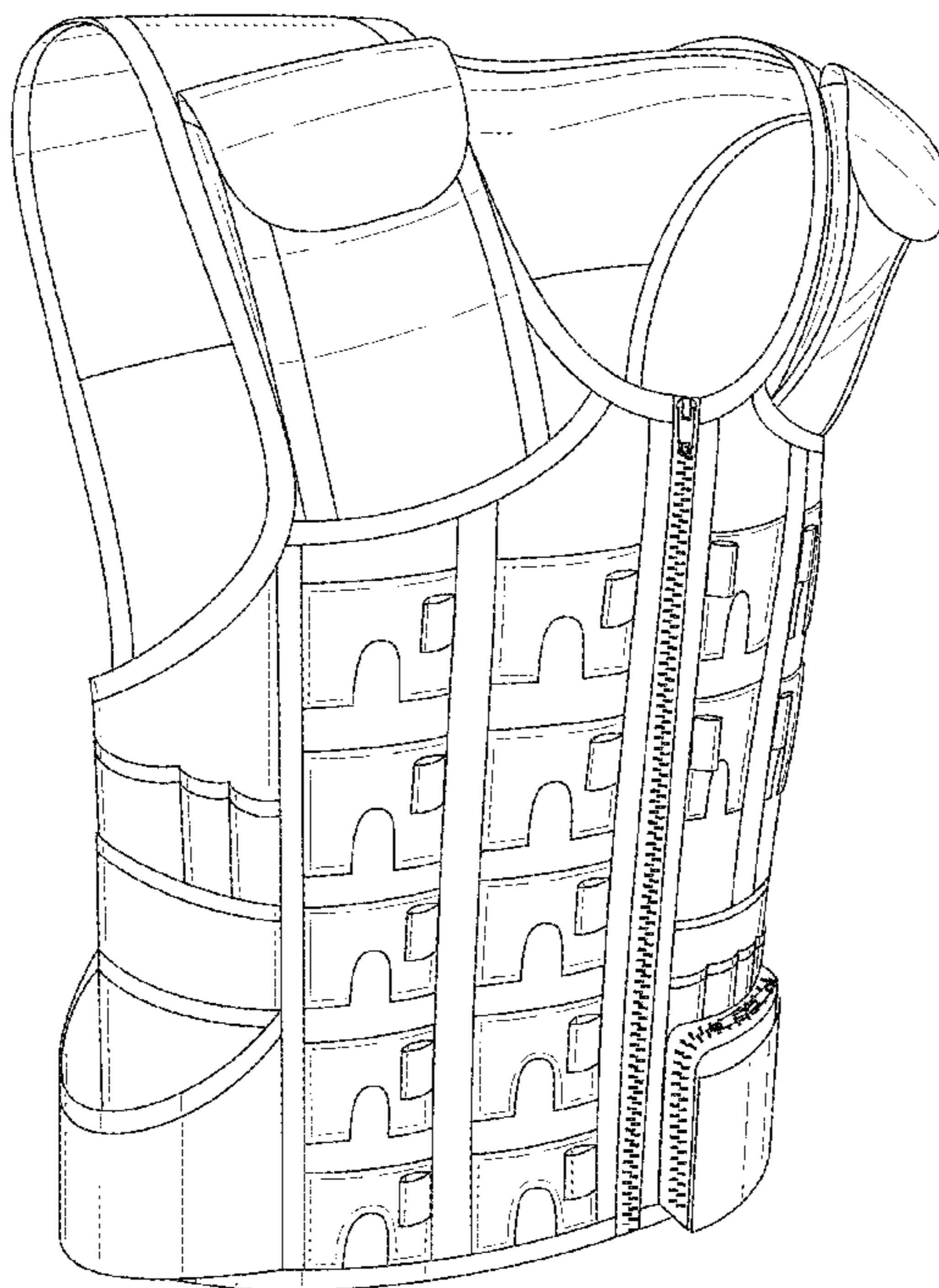
FIG. 9 is another perspective view of FIG. 7 thereof;

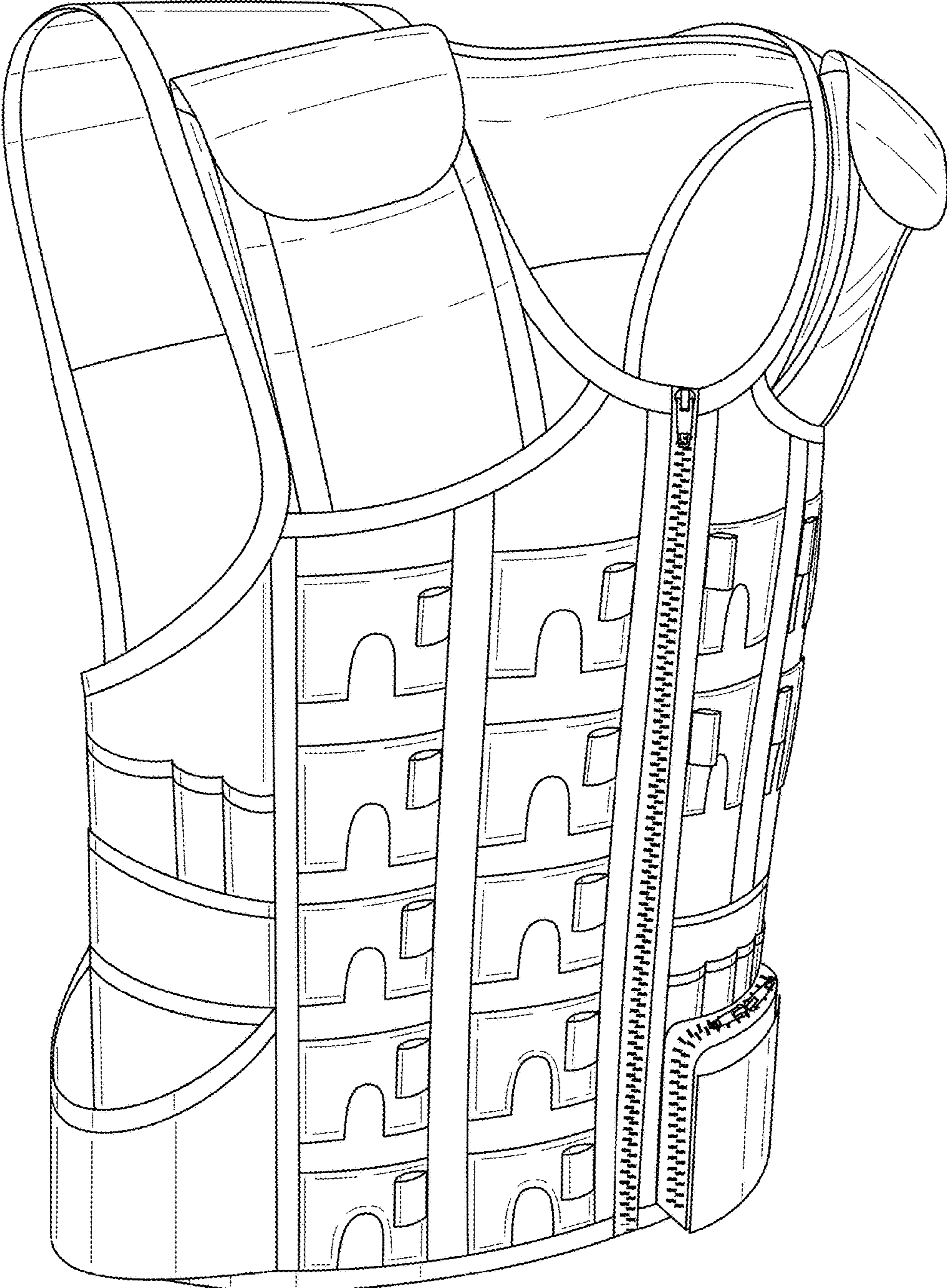

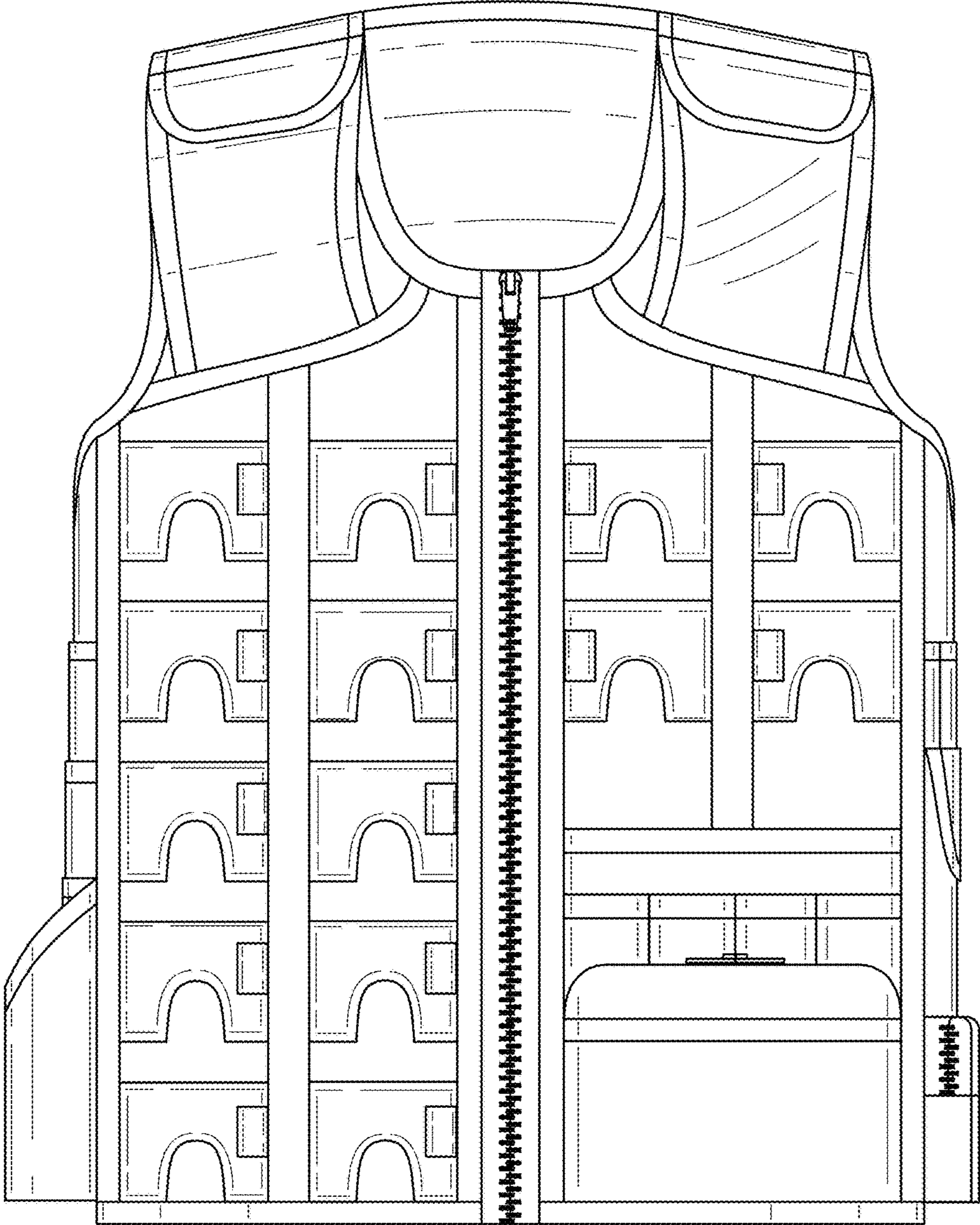

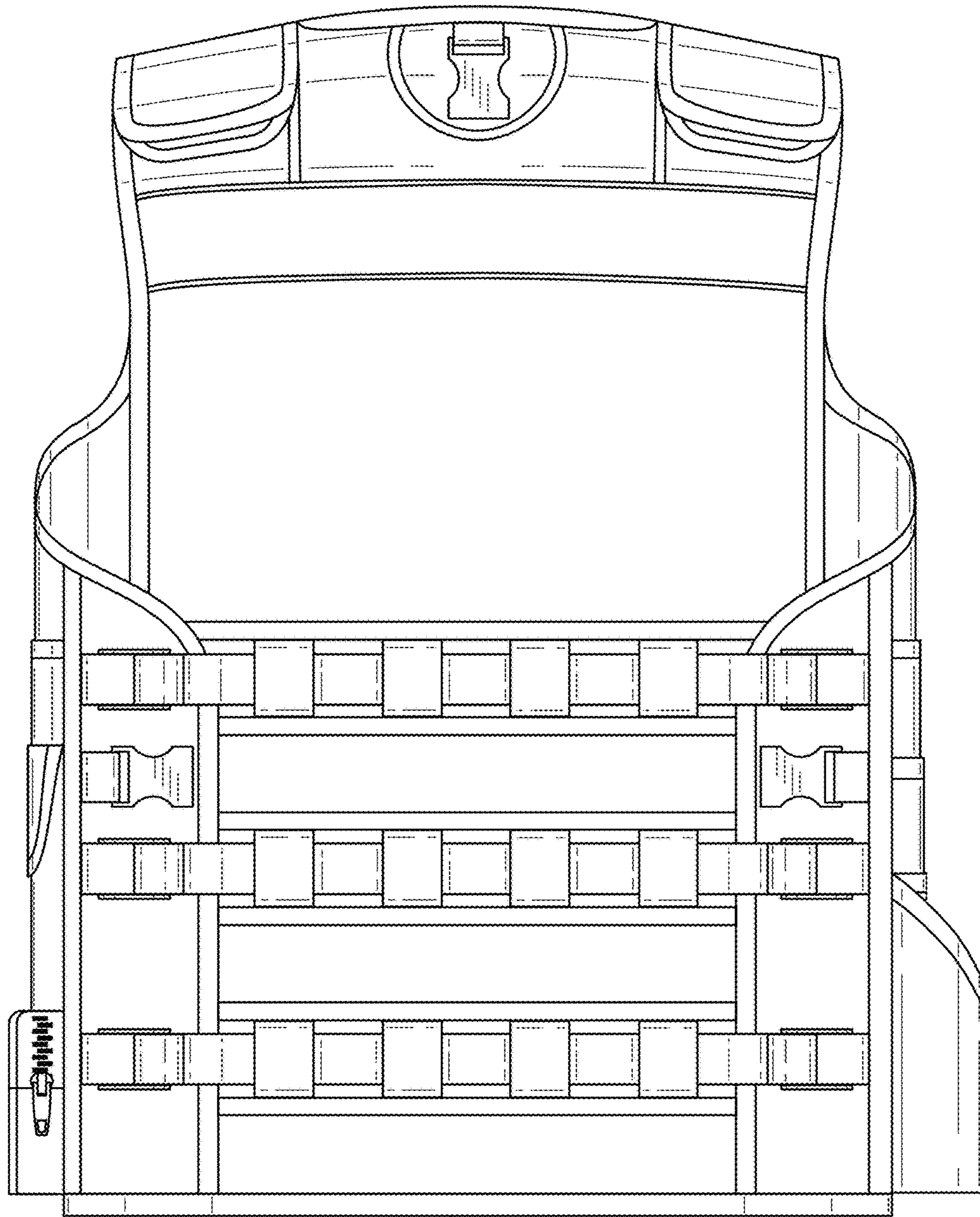

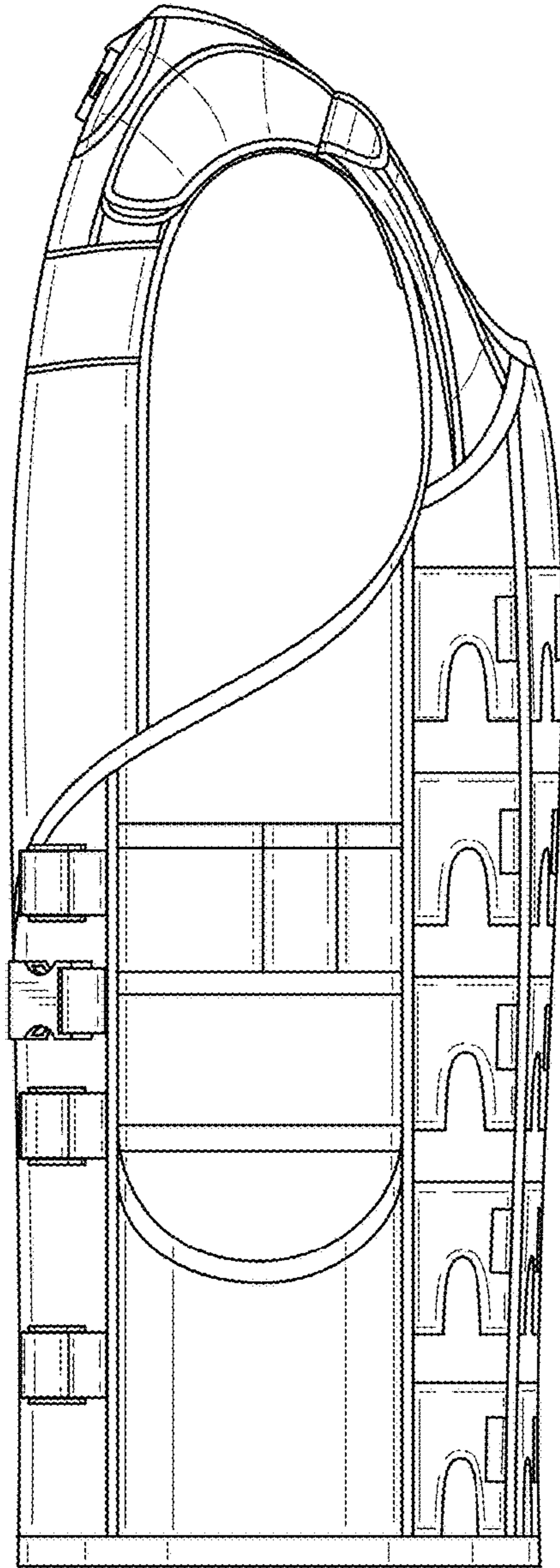

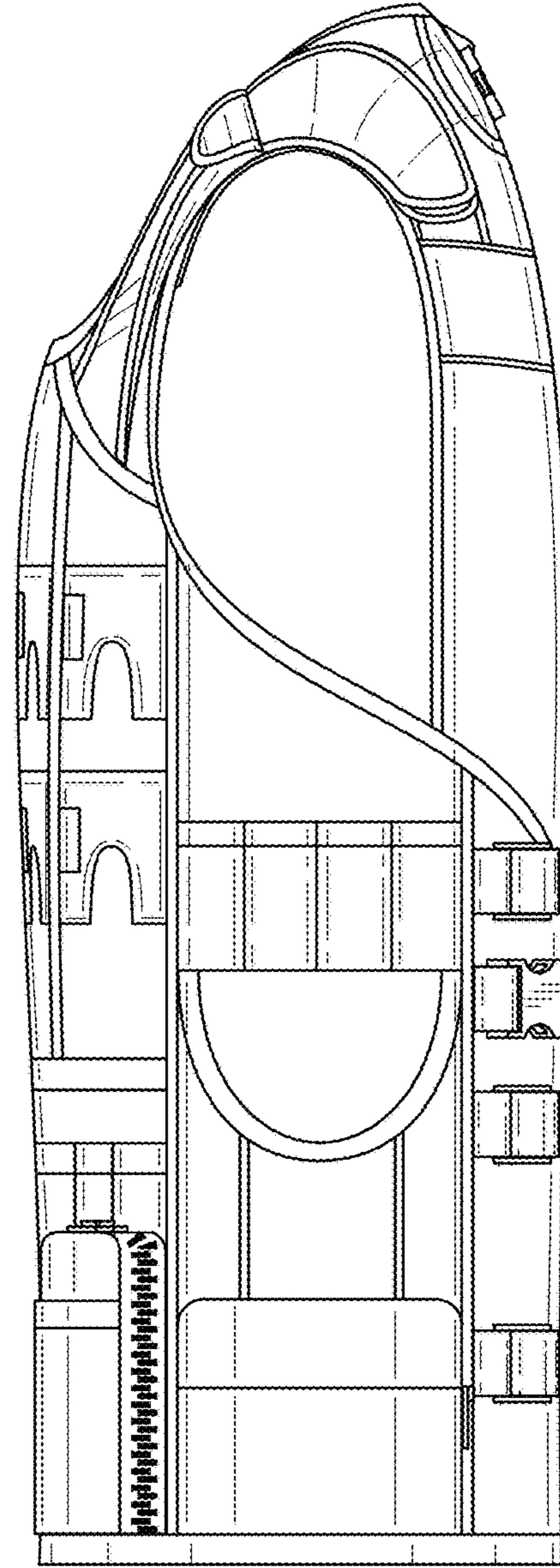

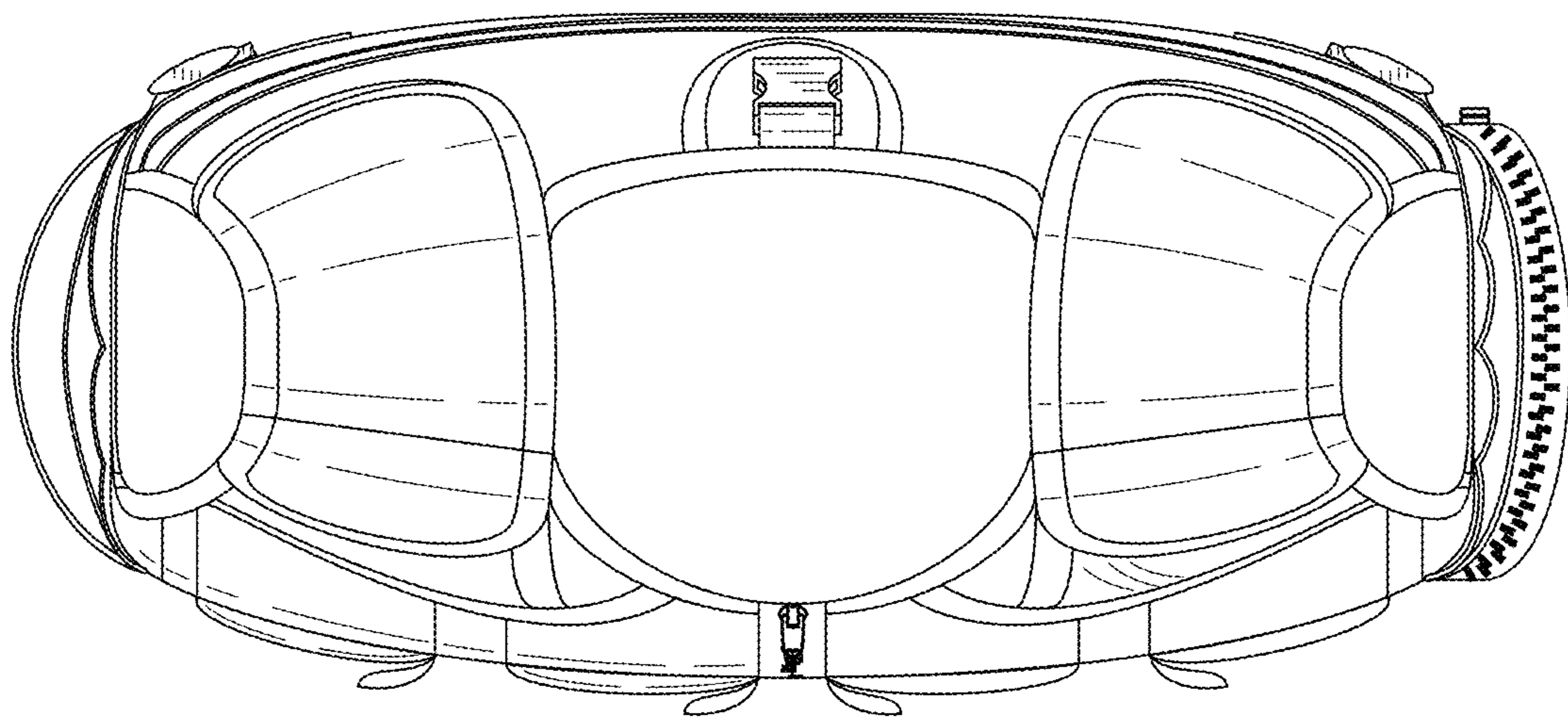

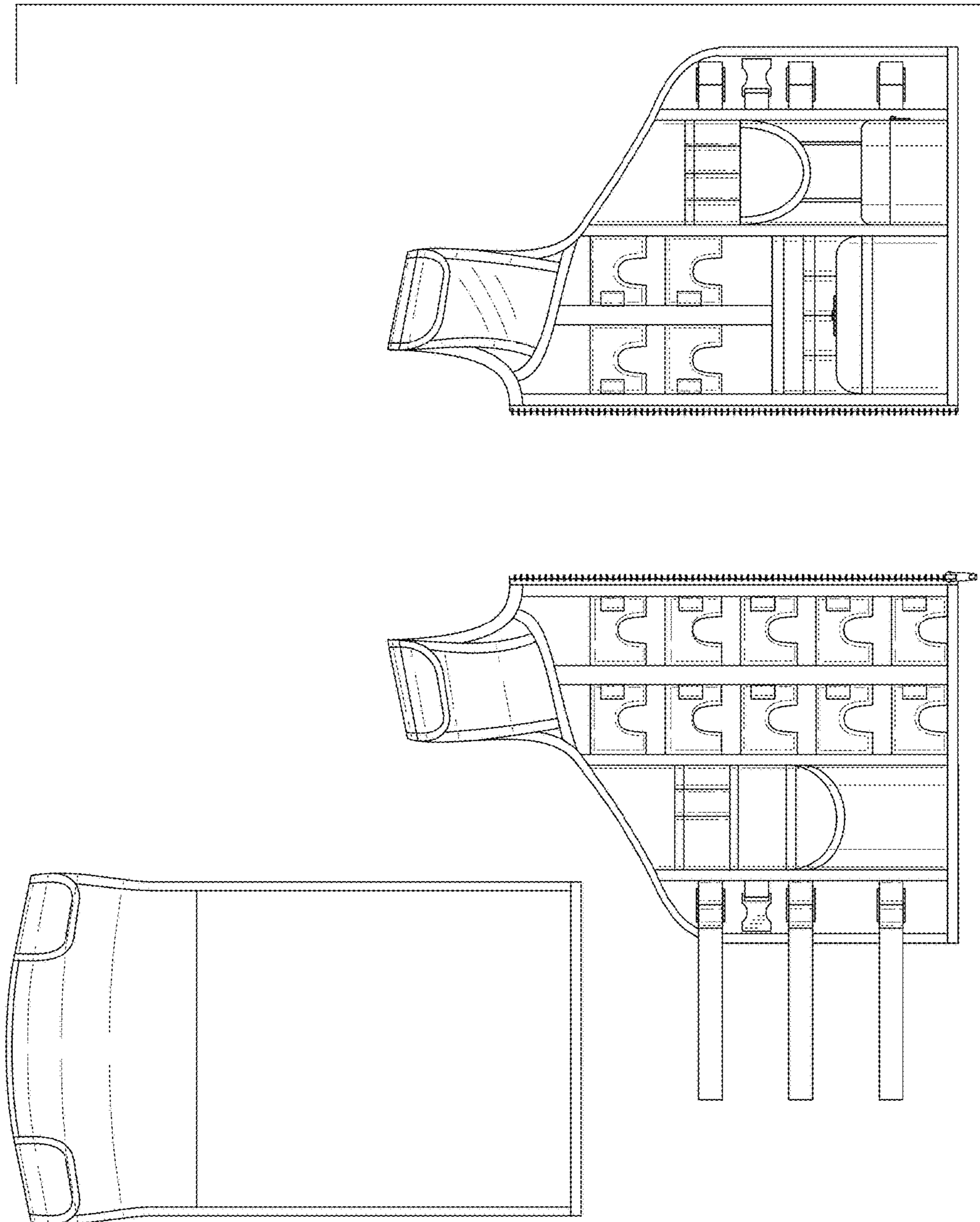

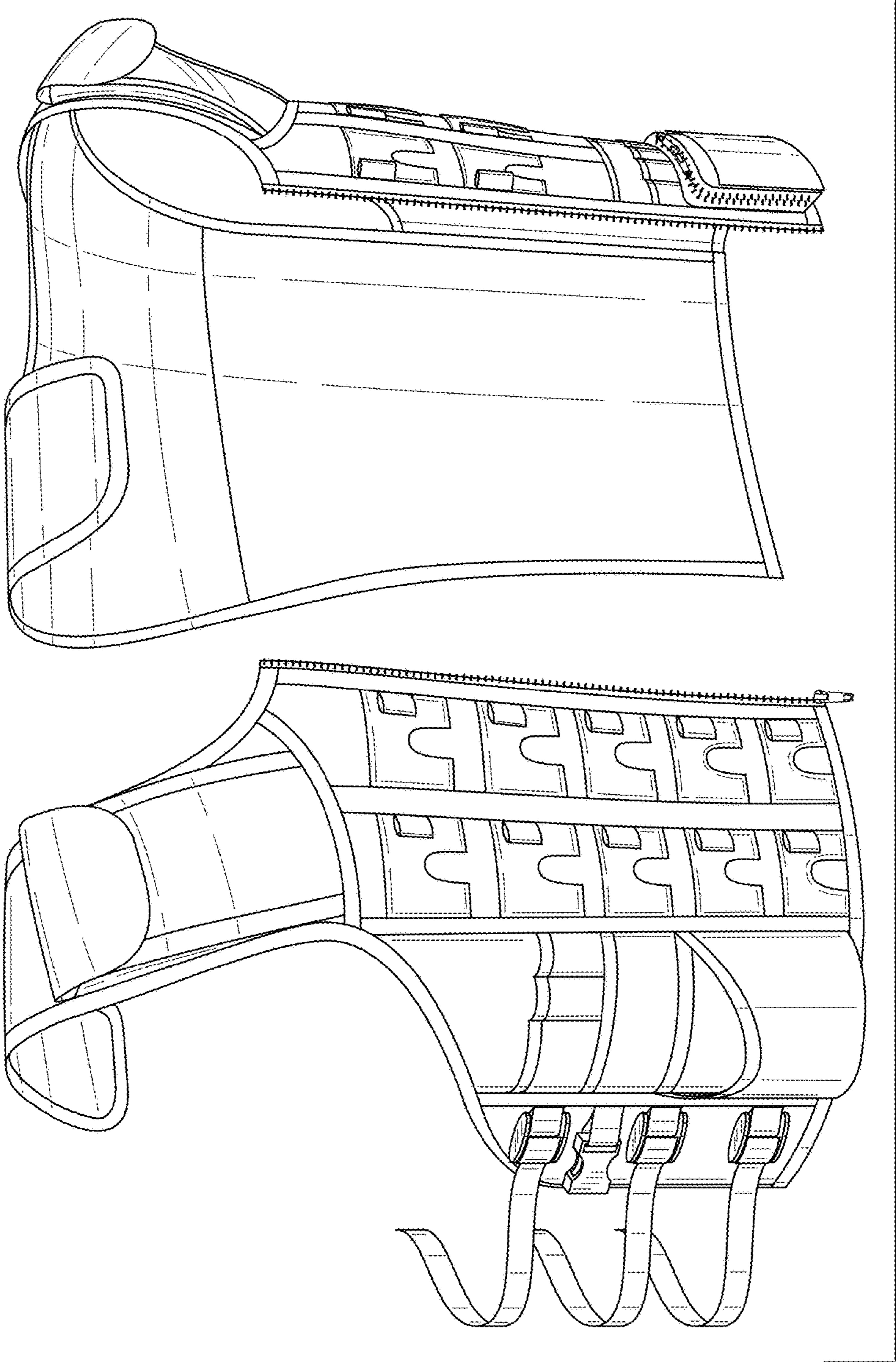

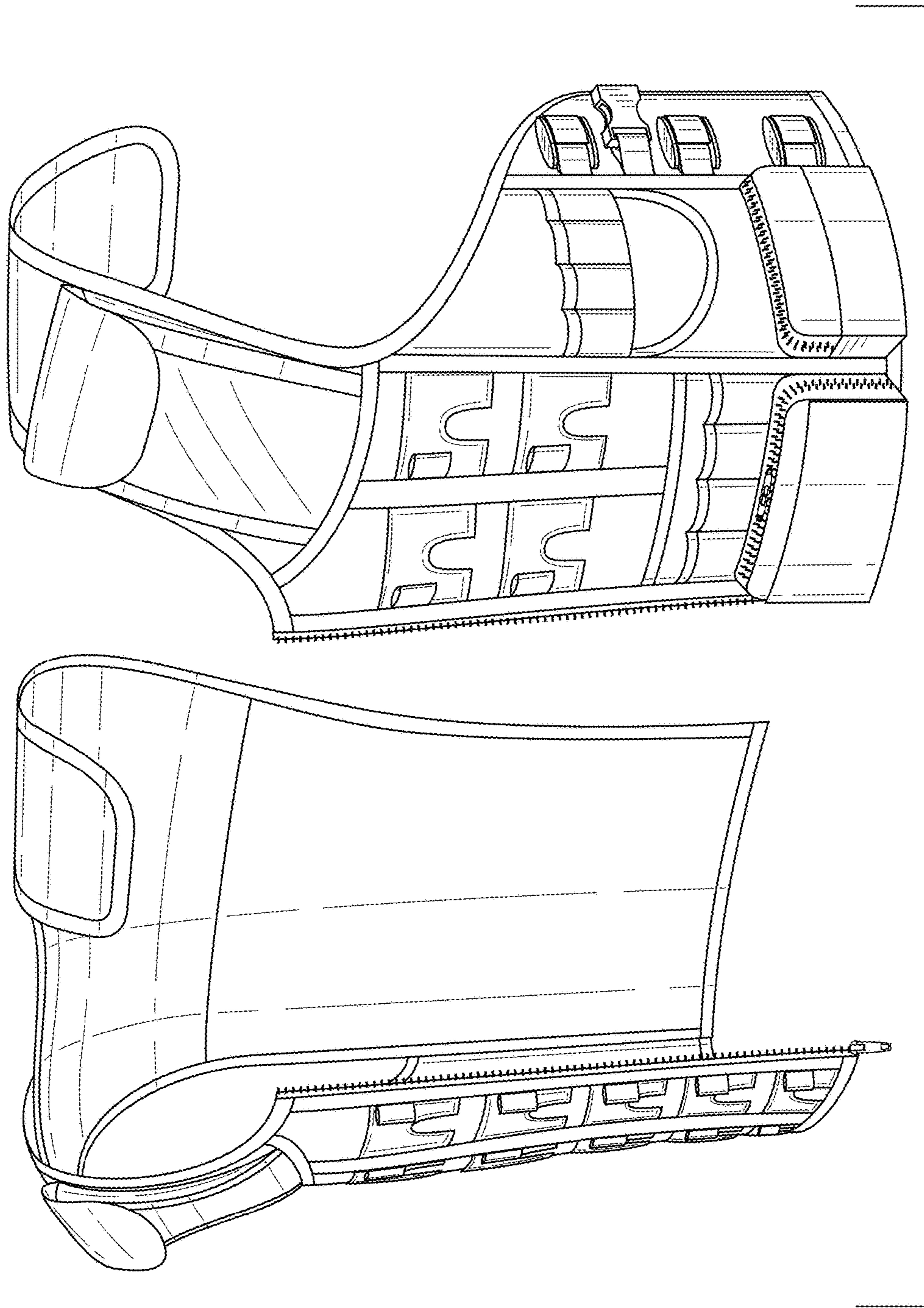

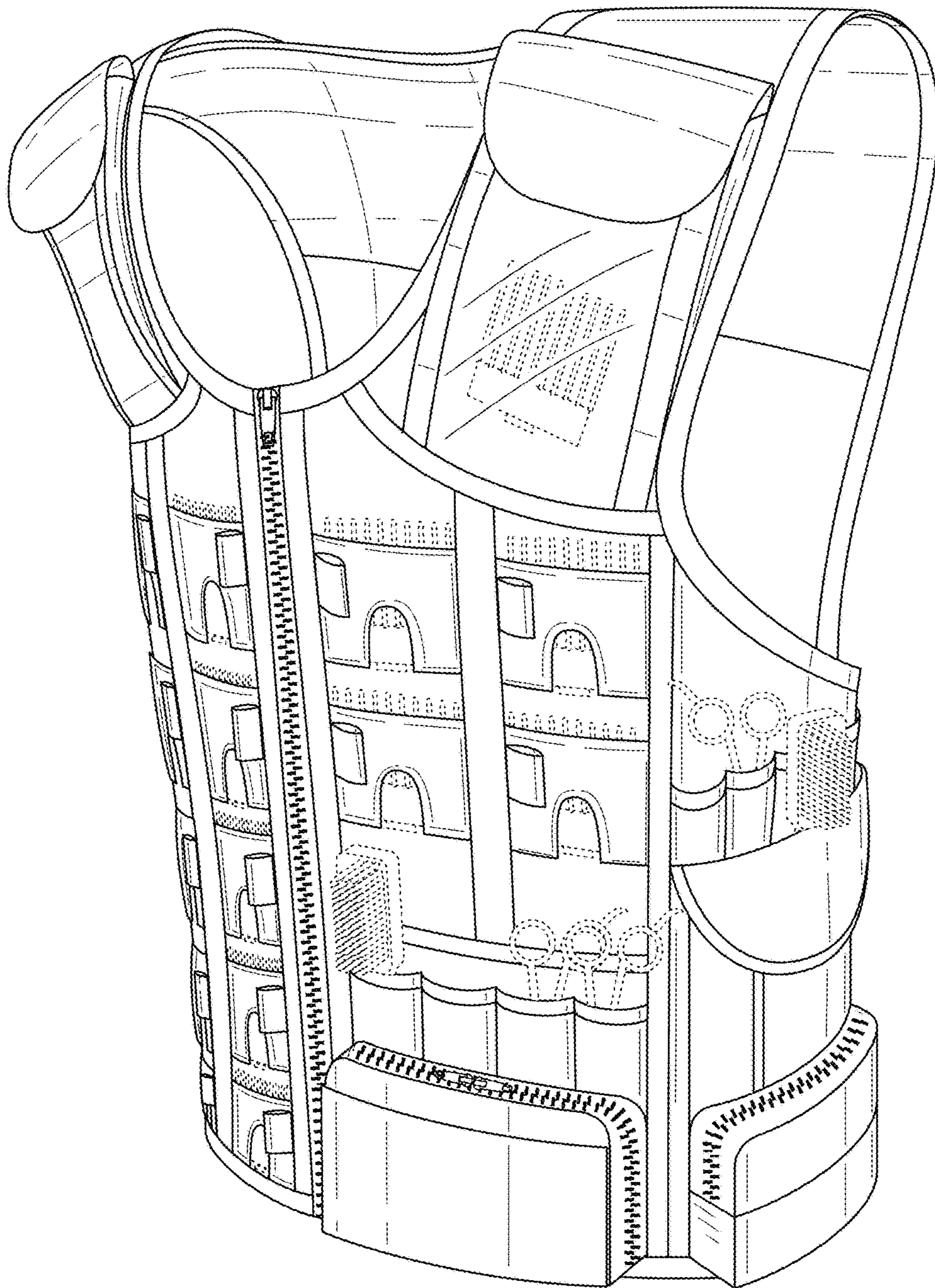

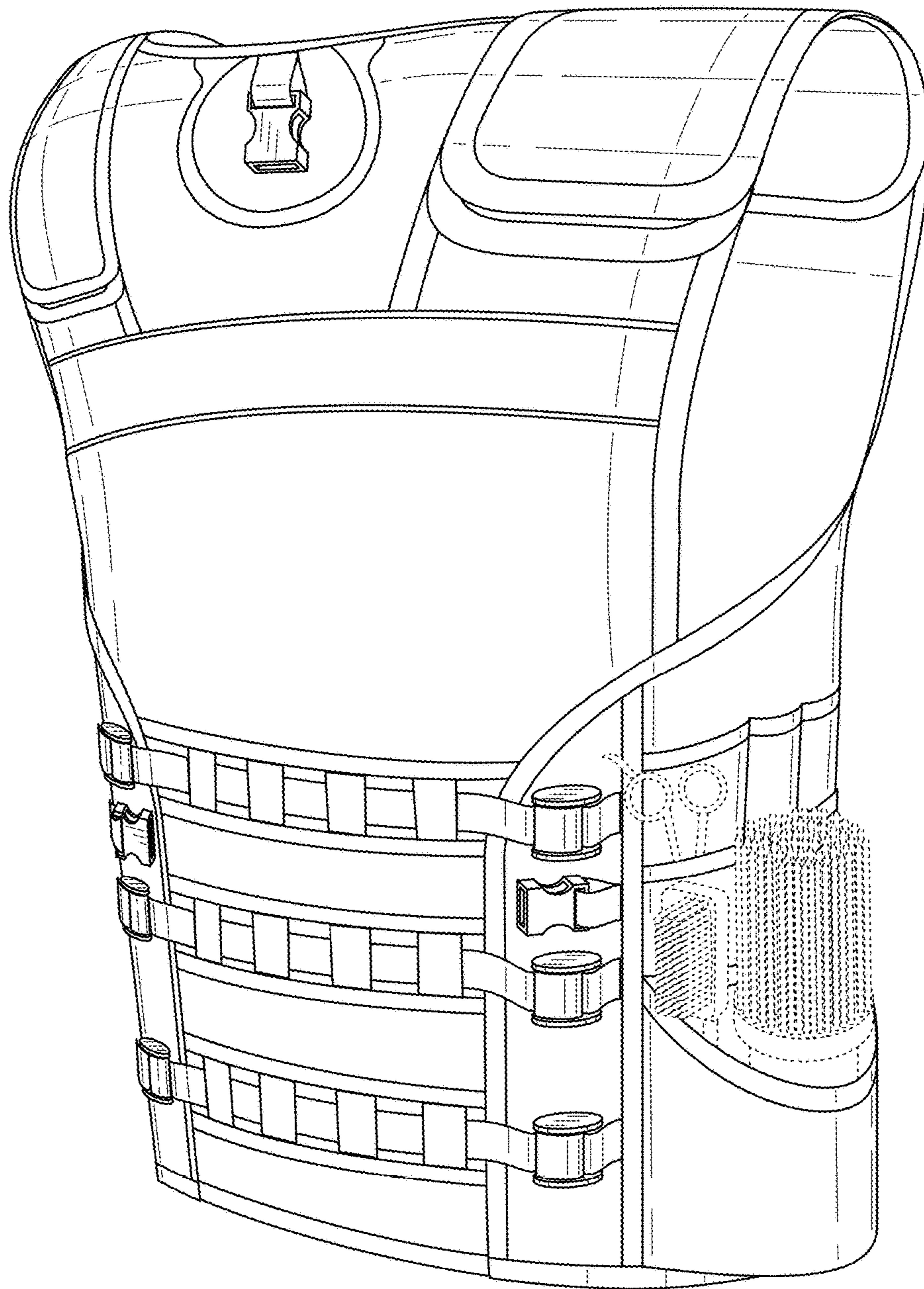
