The ornamental design for a sports shirt with label, as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view of a sports shirt with label showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a front right perspective view thereof; and,
FIG. 4 is an enlarged detailed view of the label shown in FIGS. 1-3.

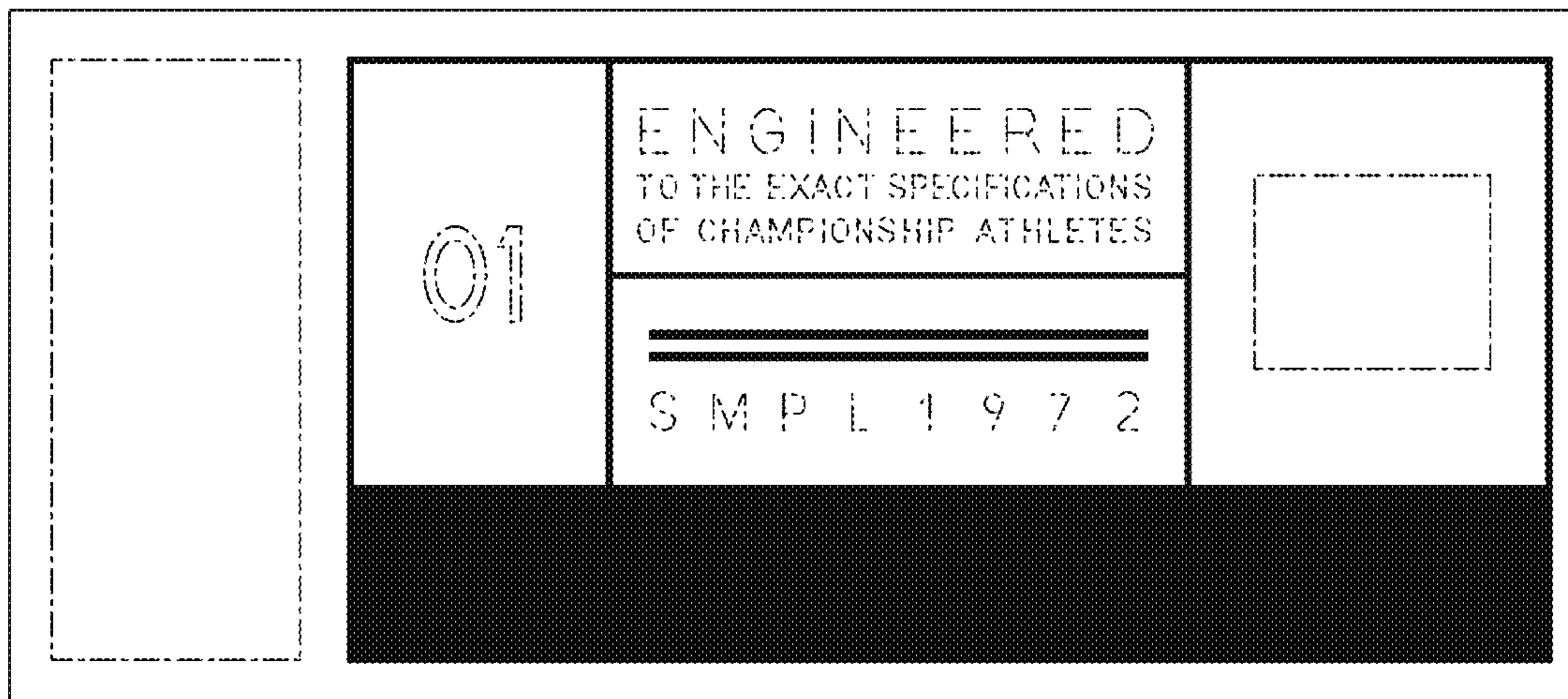

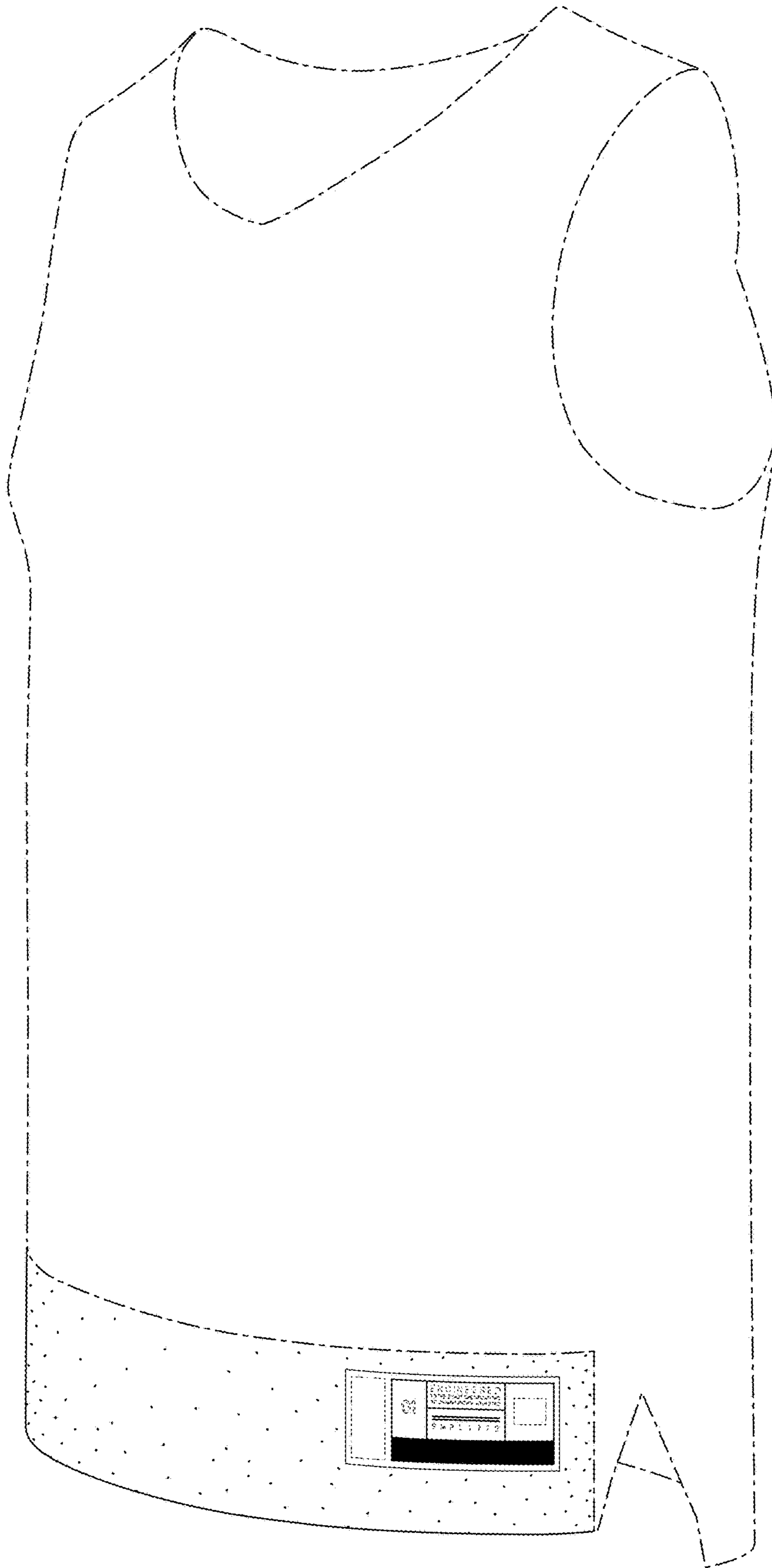

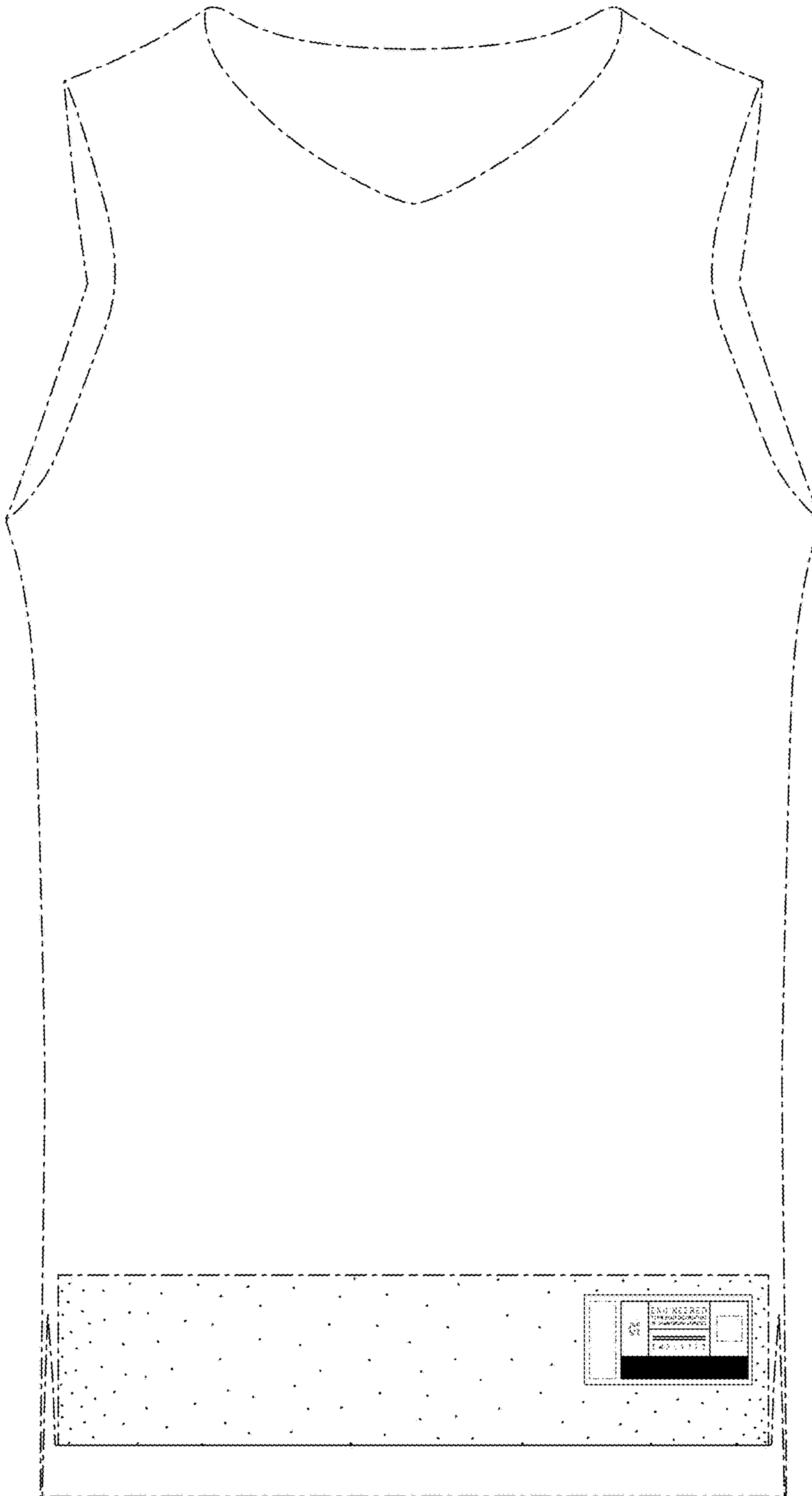

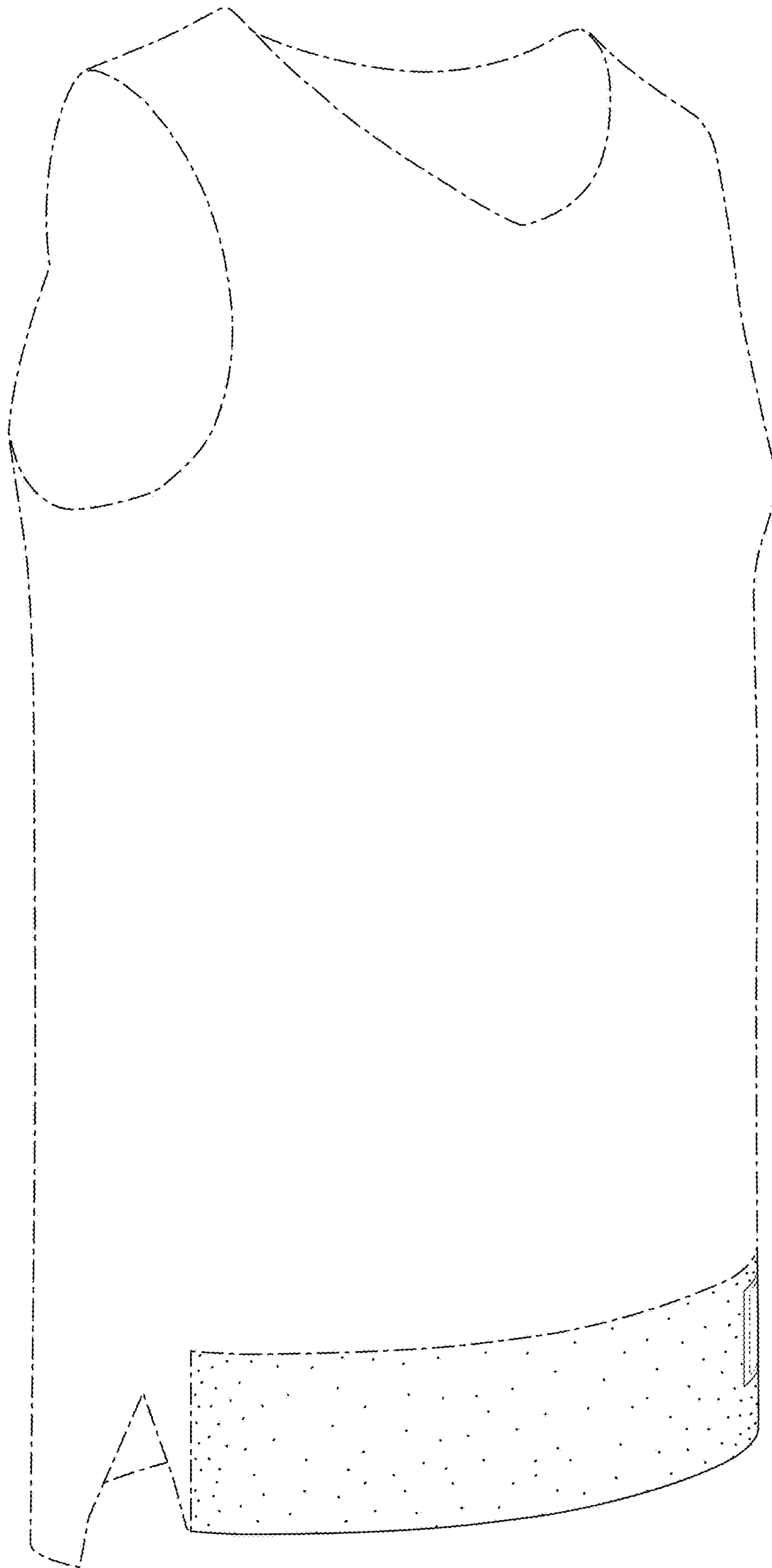

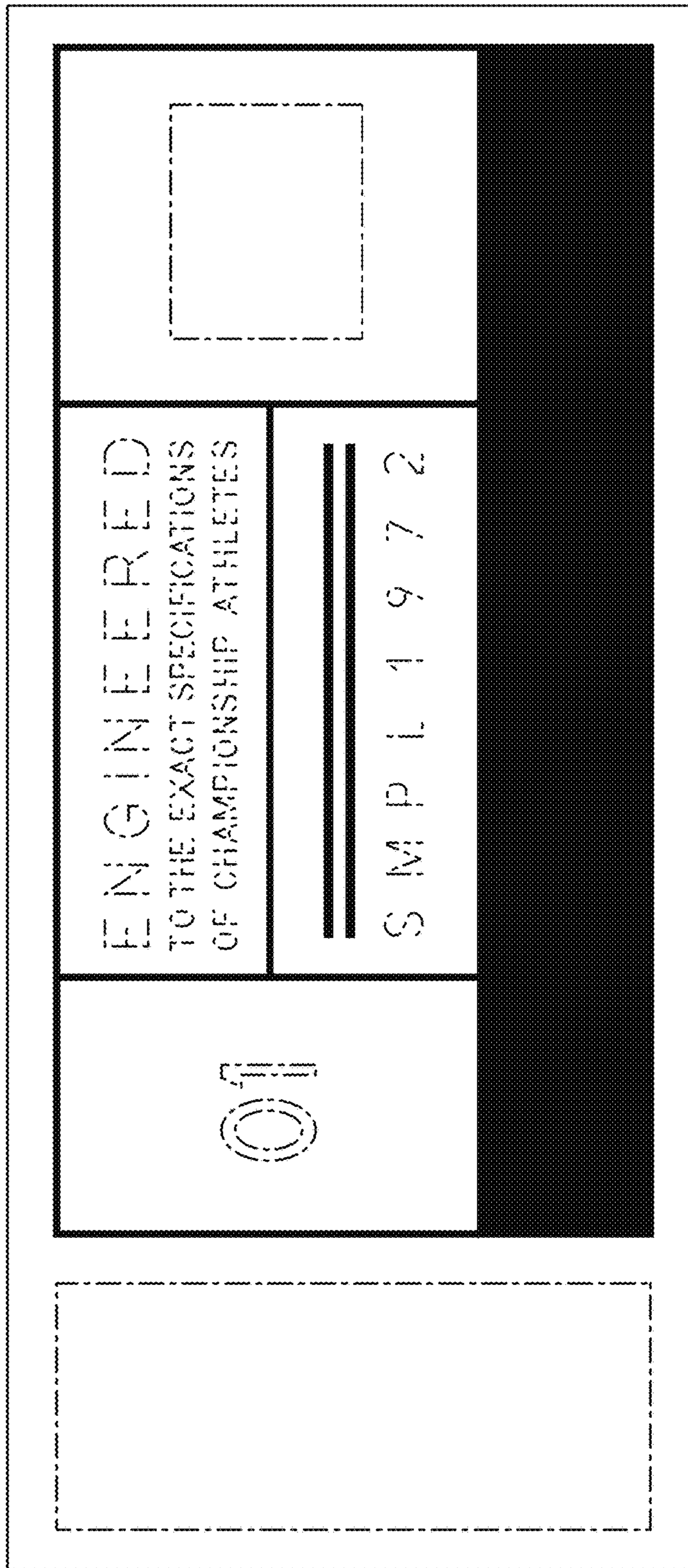
