DESCRIPTION

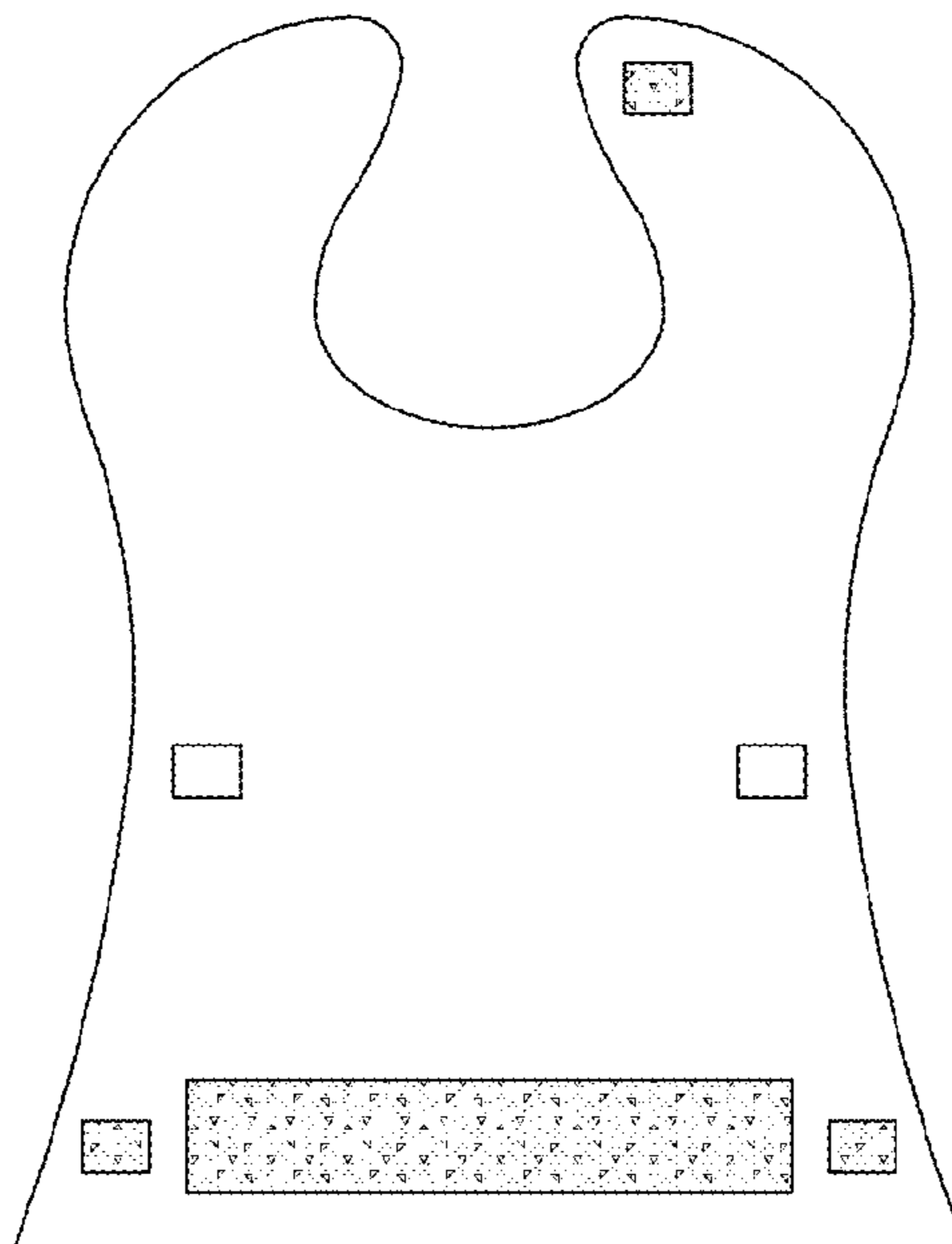
FIG. 1 is a front view of a bib including protective liners over adhesive material;

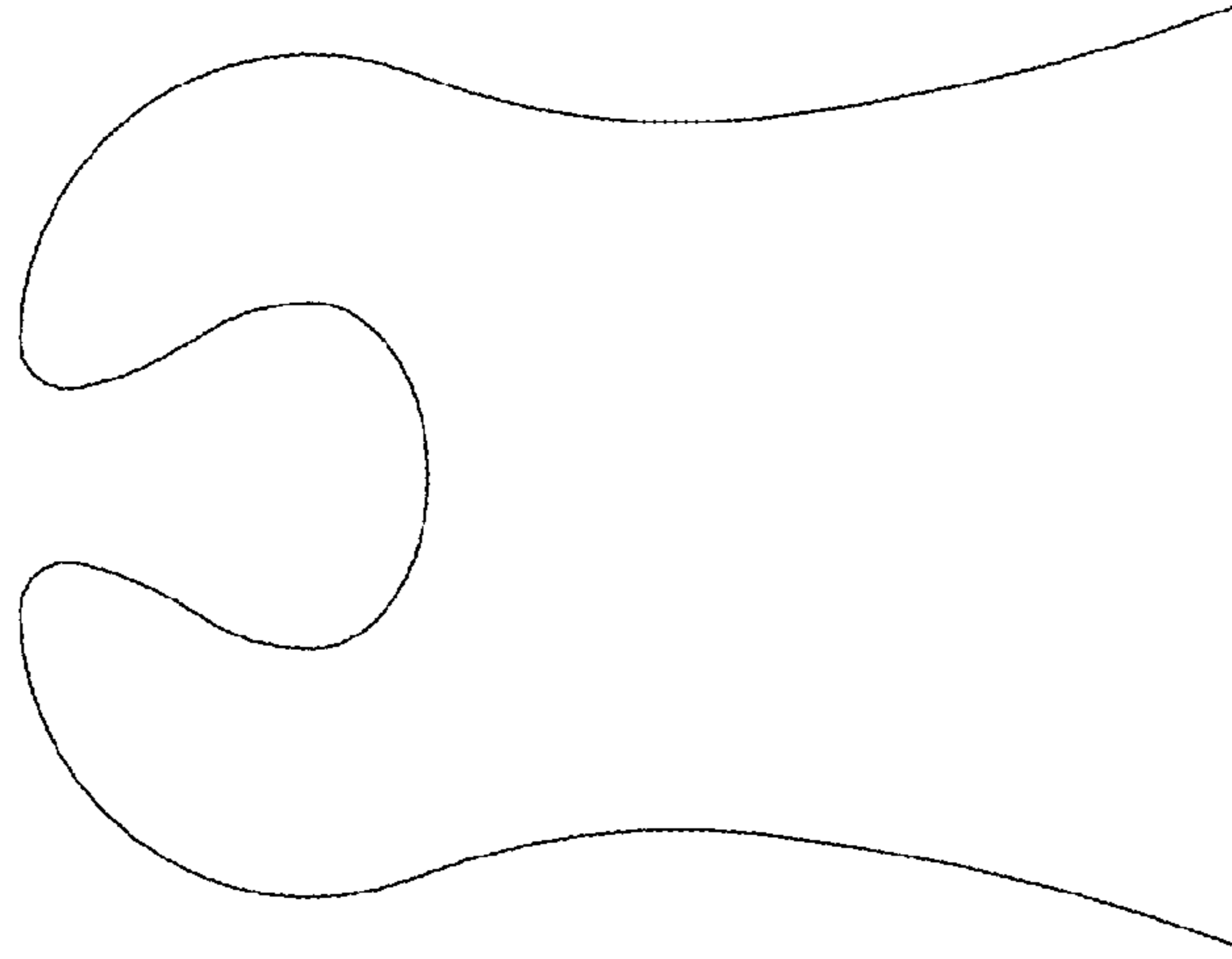

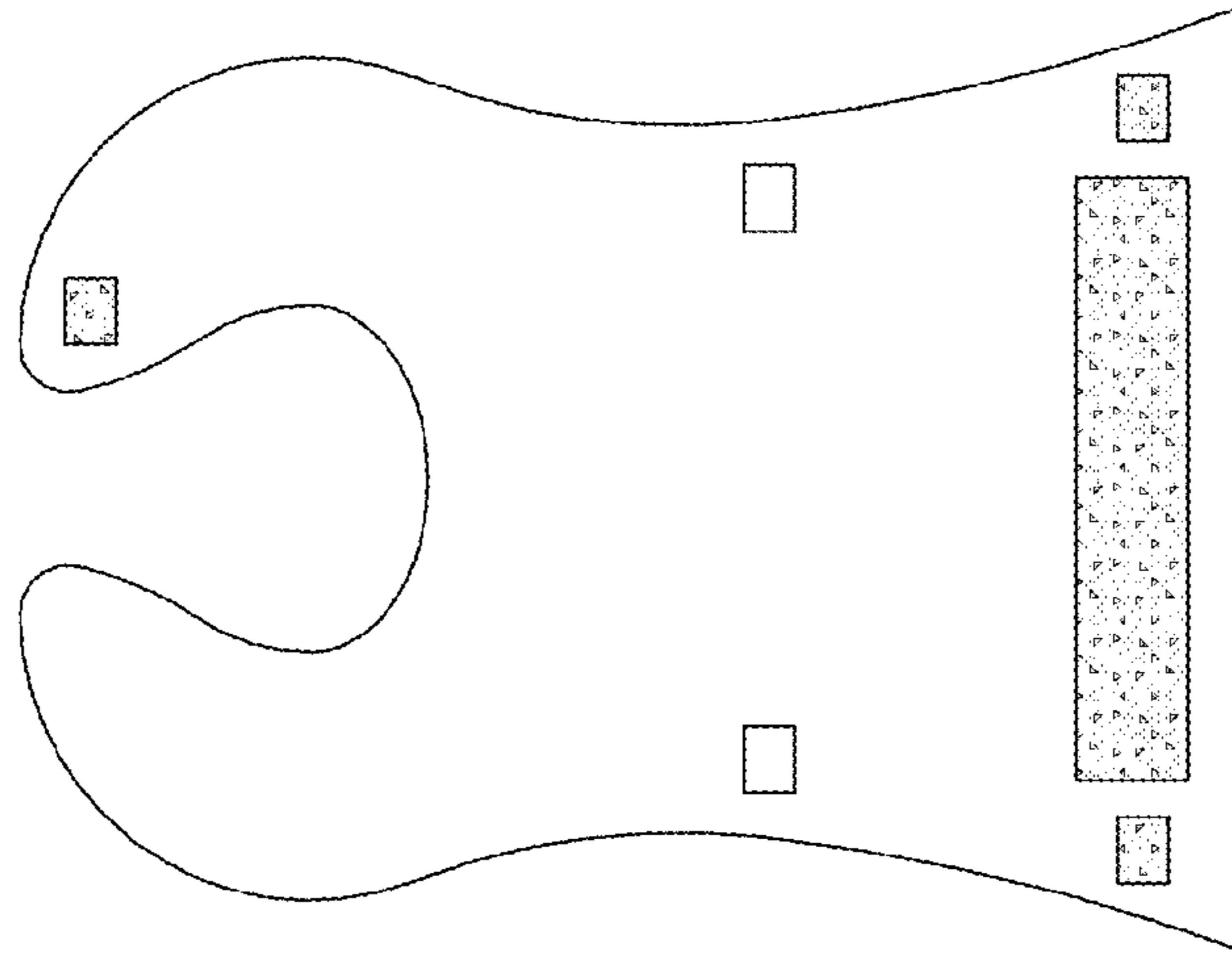

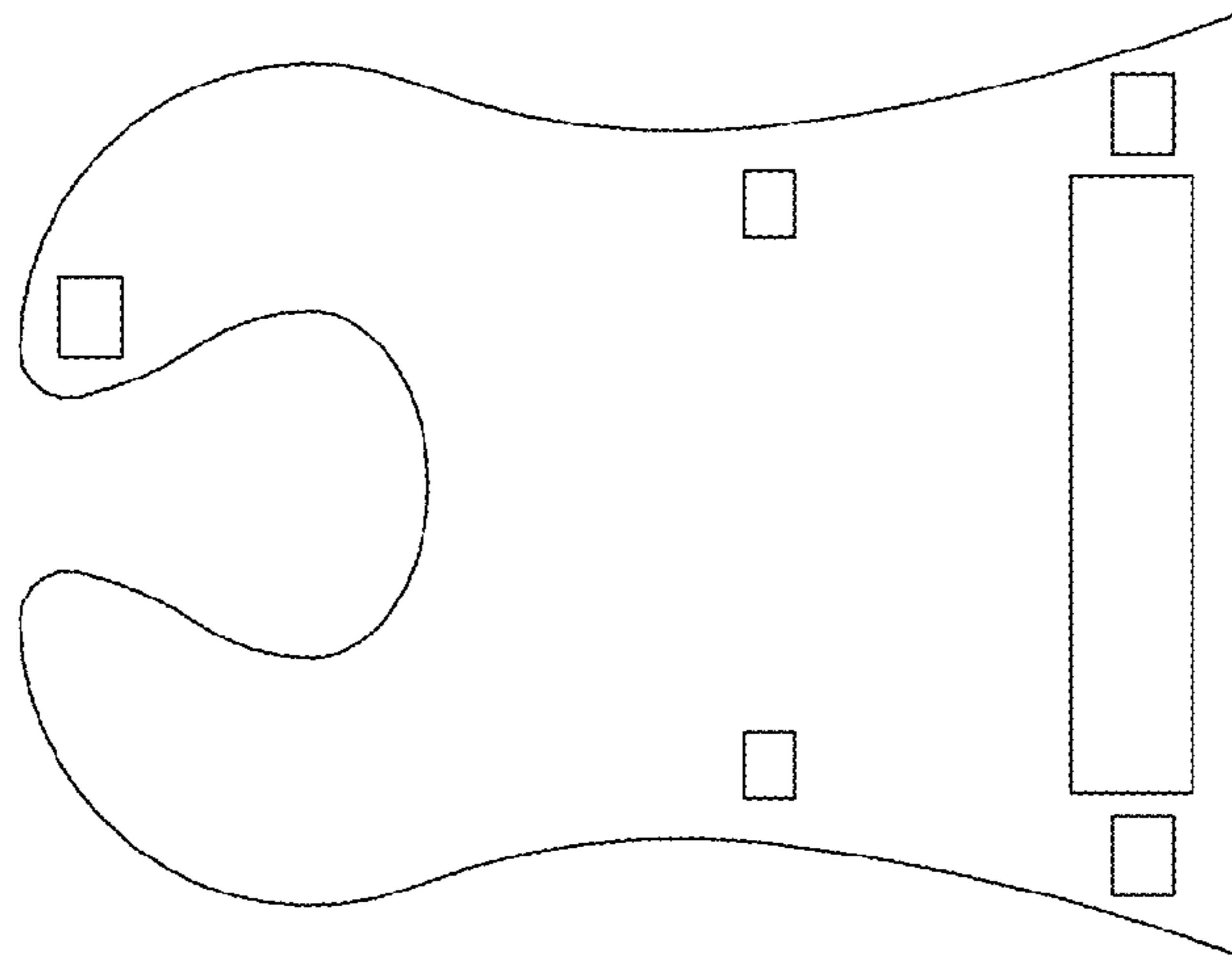
