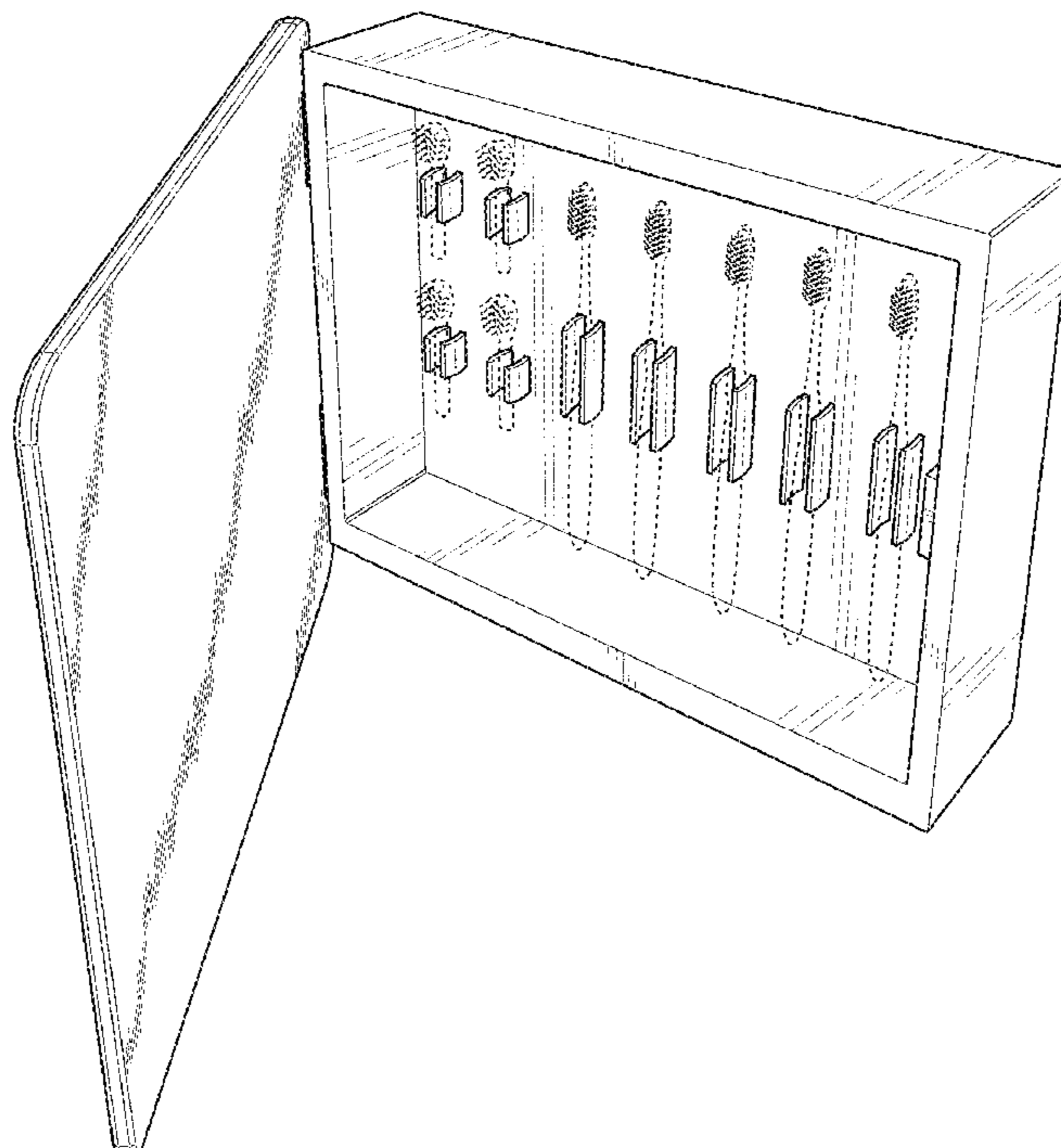

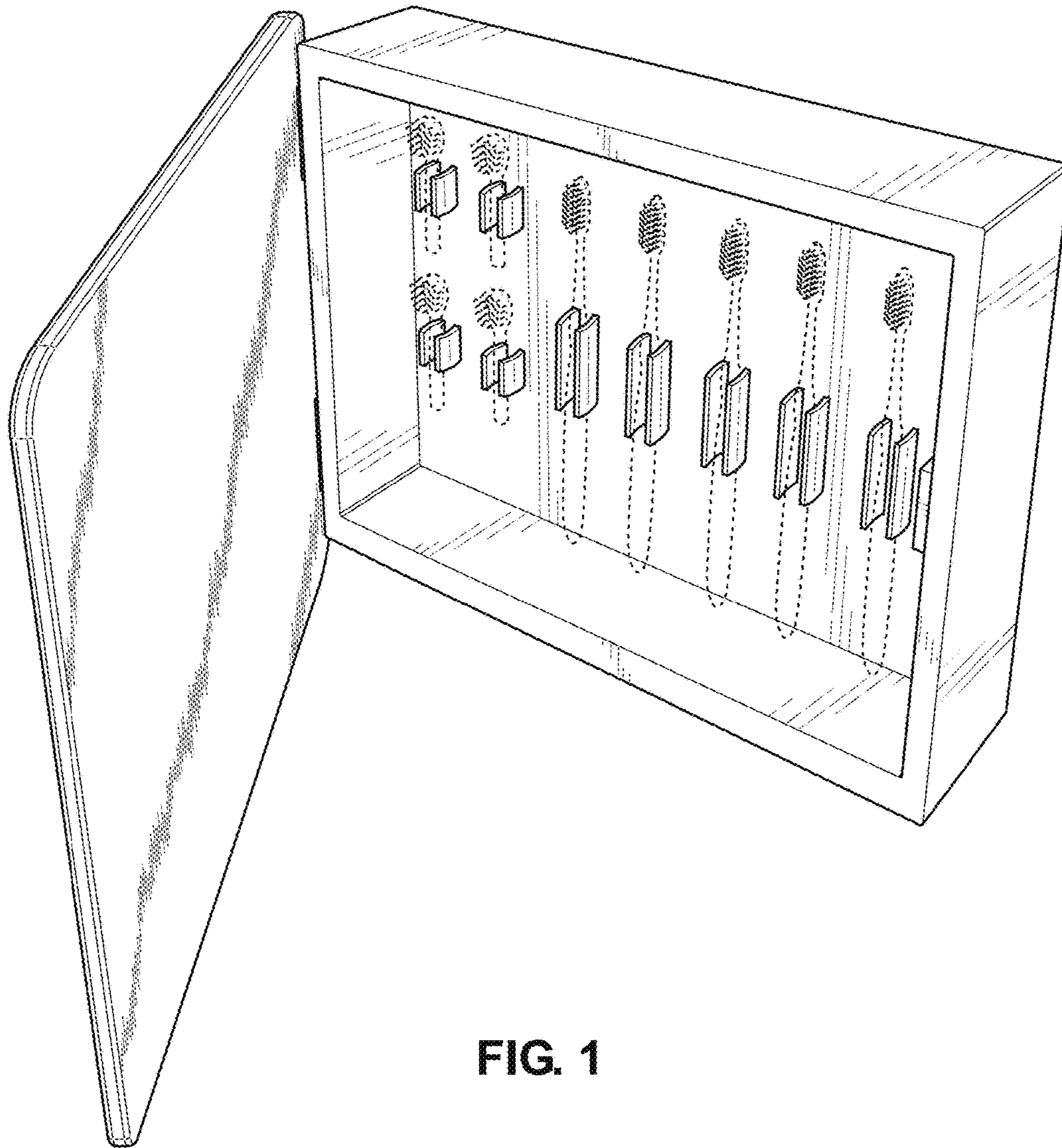
The ornamental design for a sanitizing toothbrush cabinet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the sanitizing toothbrush cabinet showing my new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a right elevation view thereof; FIG. 7 is a left elevation view thereof; FIG. 8 is a perspective view thereof, with the hinged closure in an alternate position; and, FIG. 9 is a perspective view thereof, with the hinged closure in an alternate position and showing the ultra violet light. 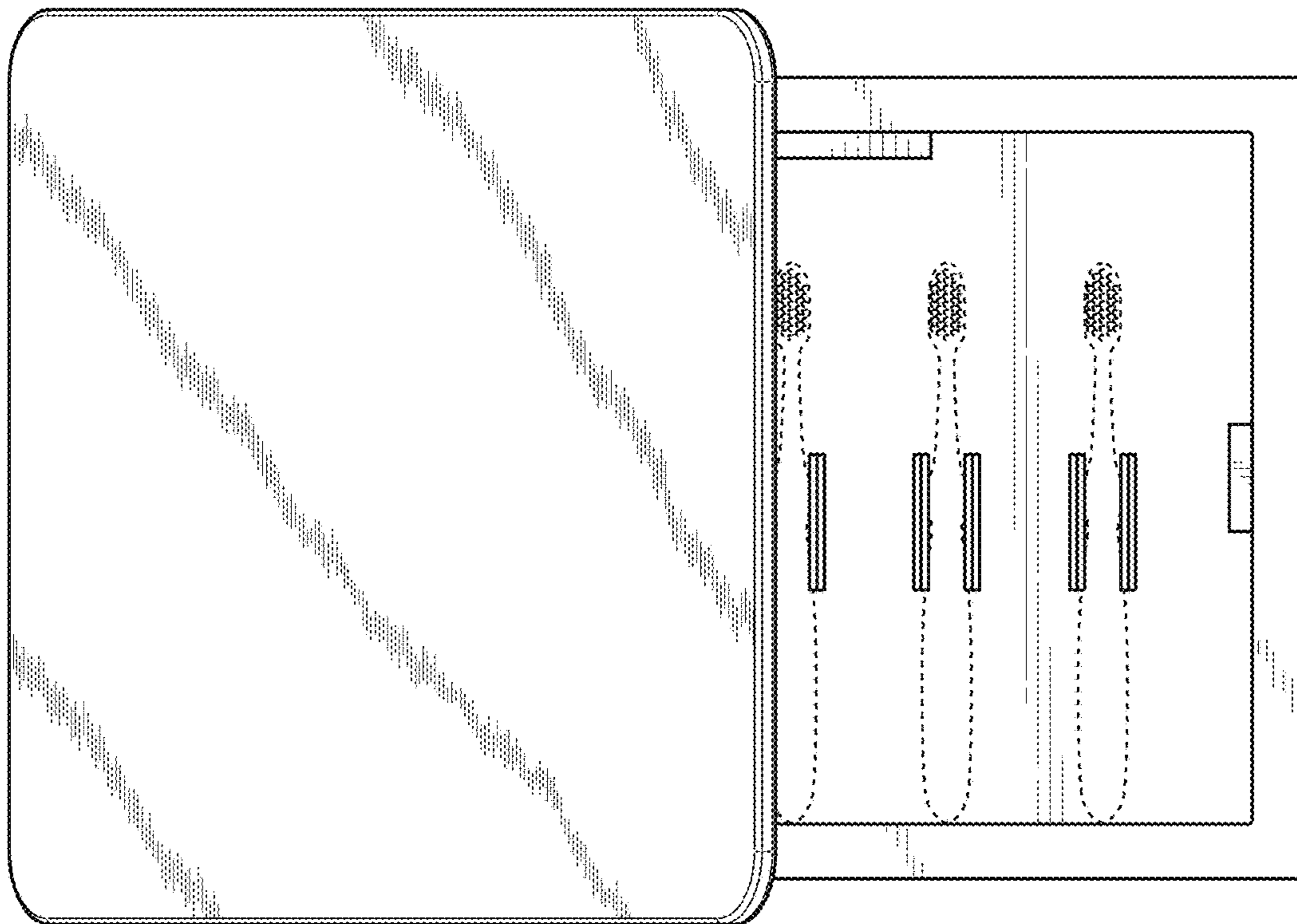

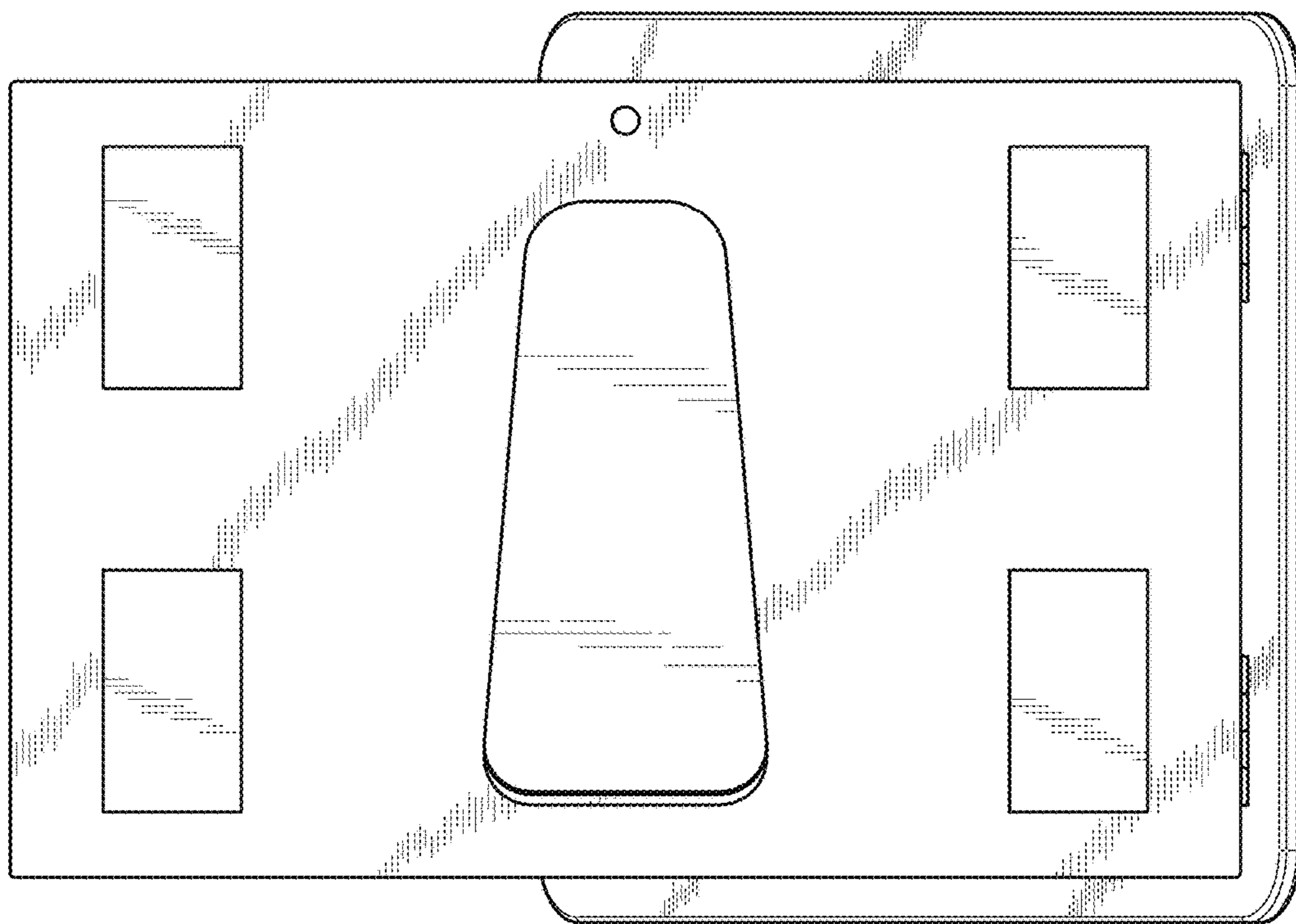

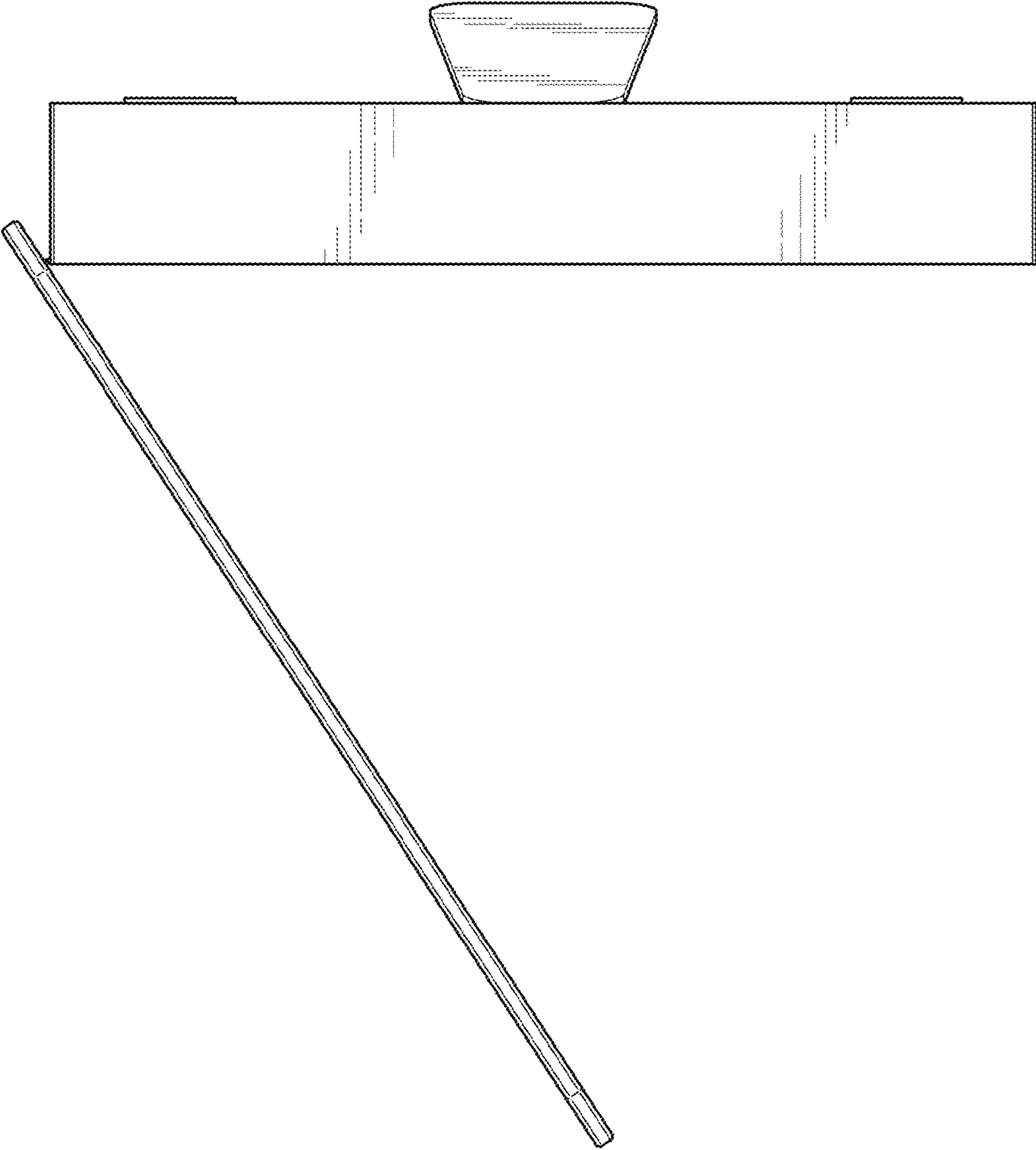

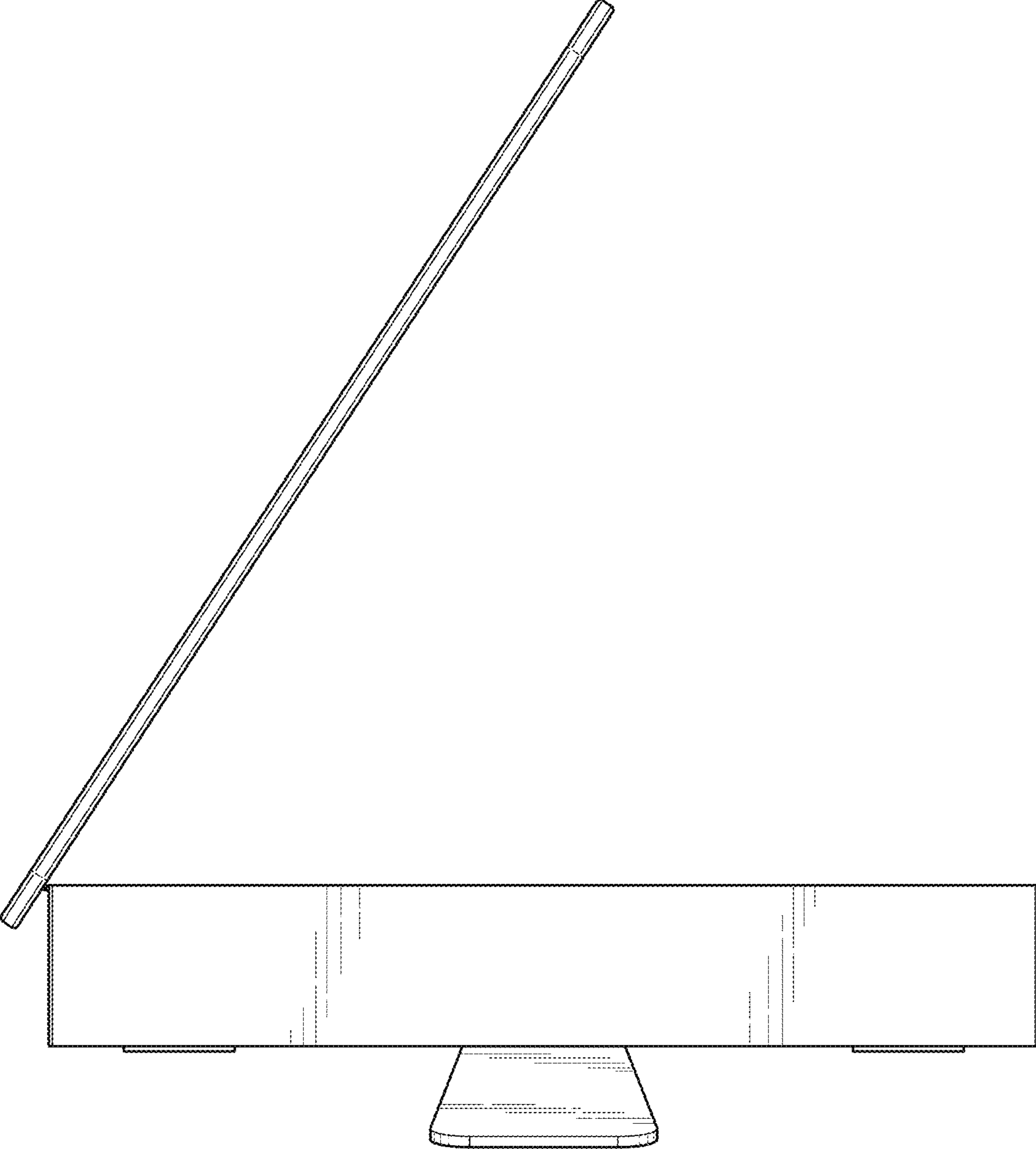

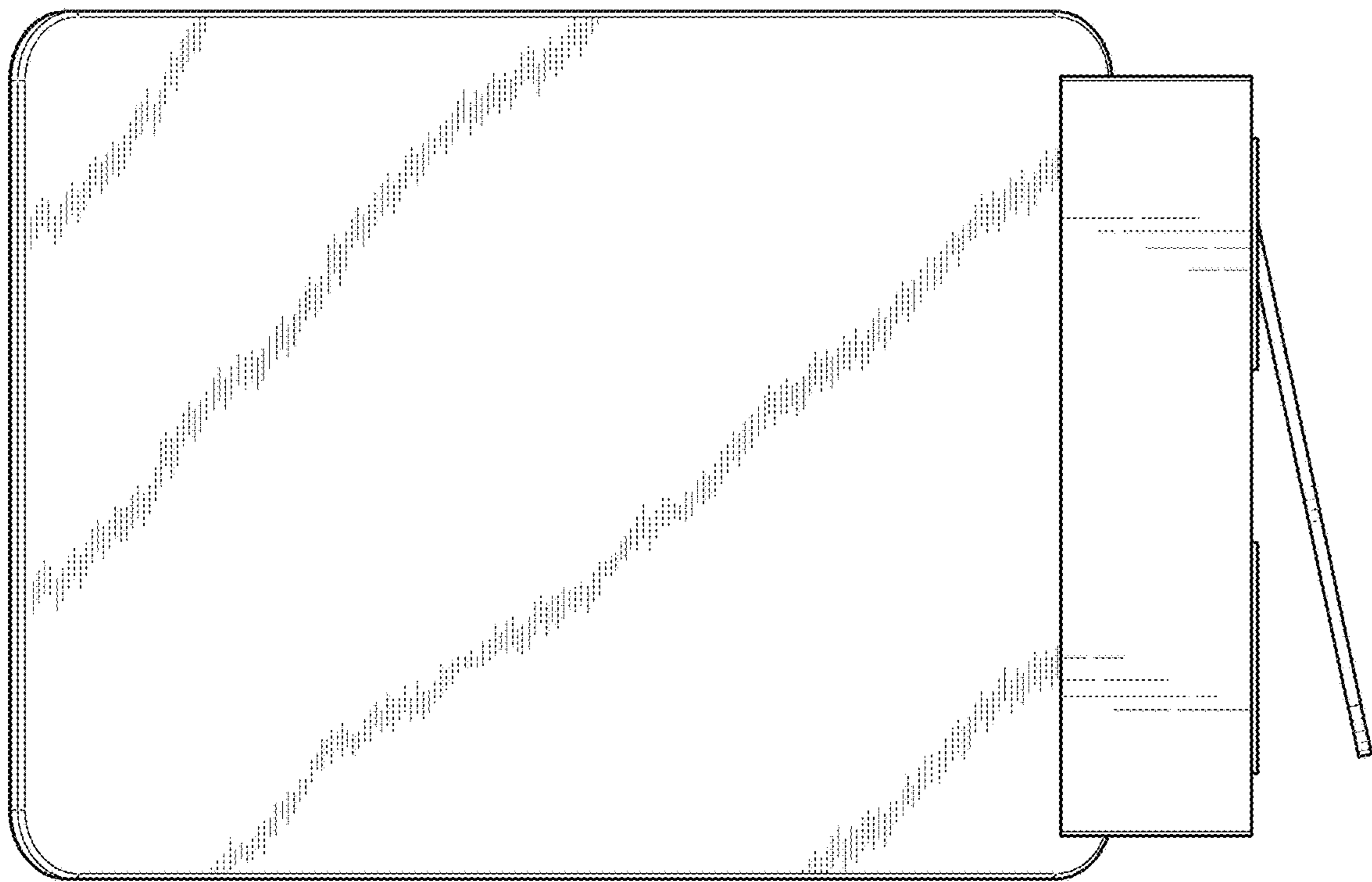

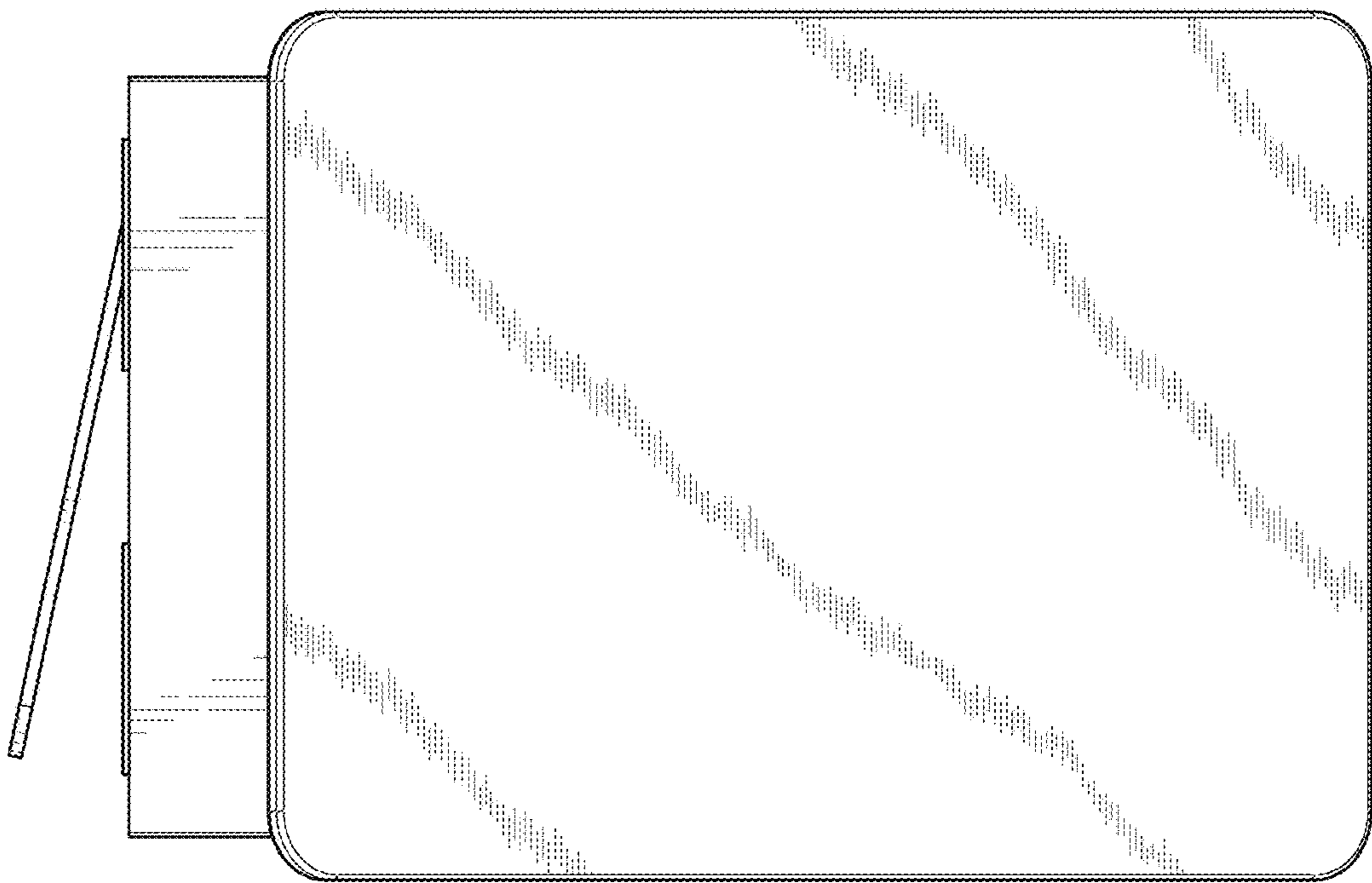

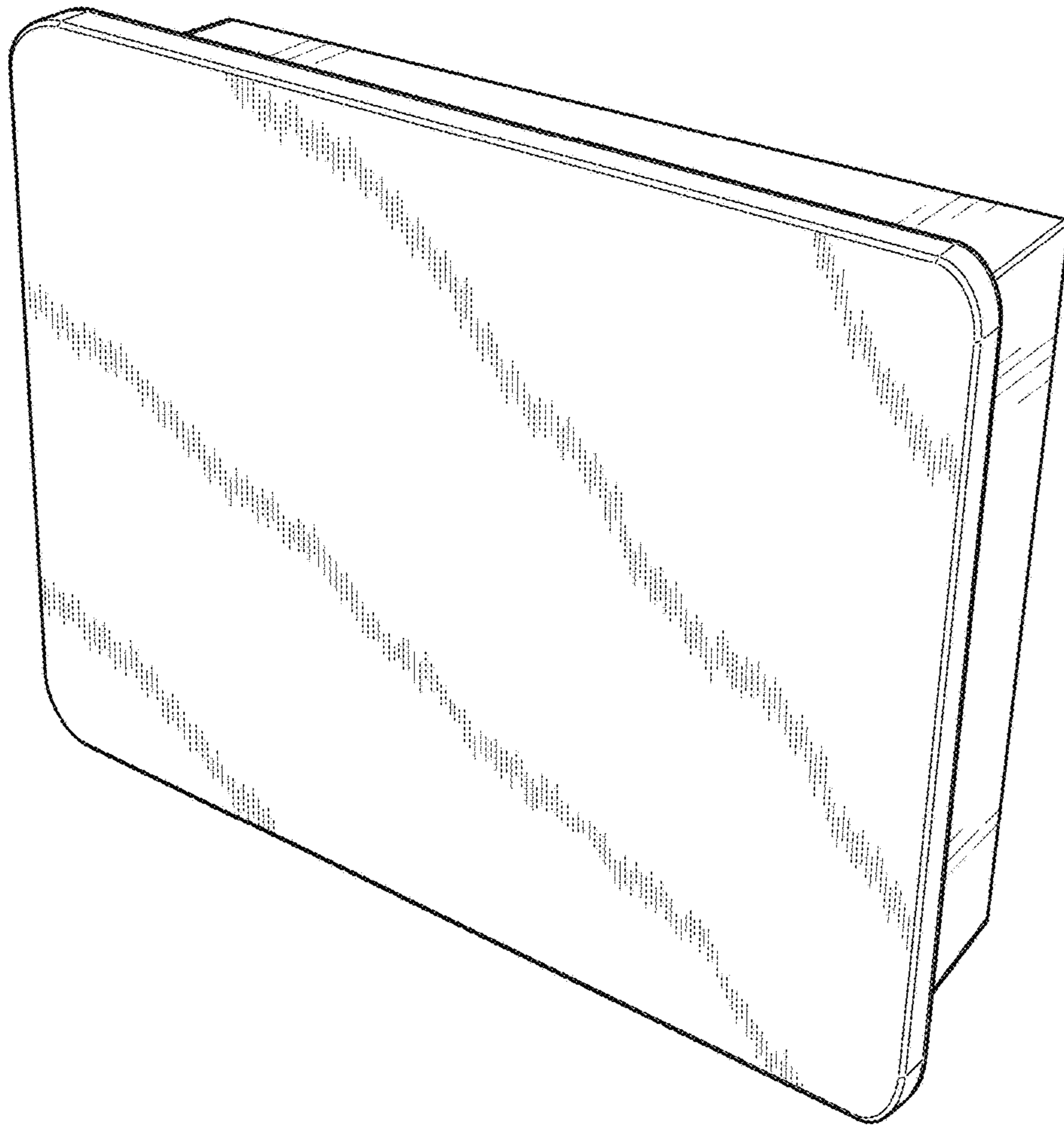

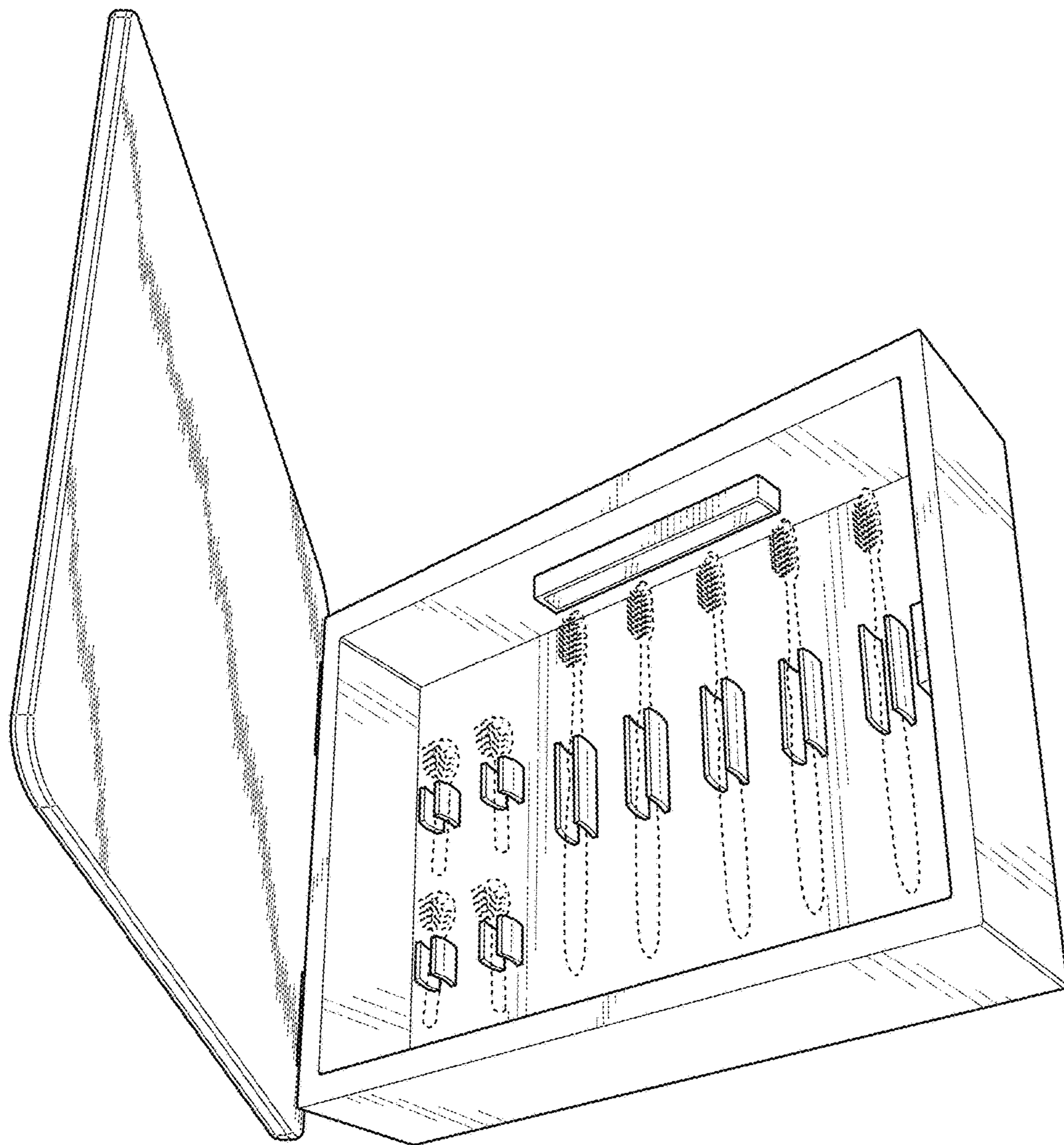
