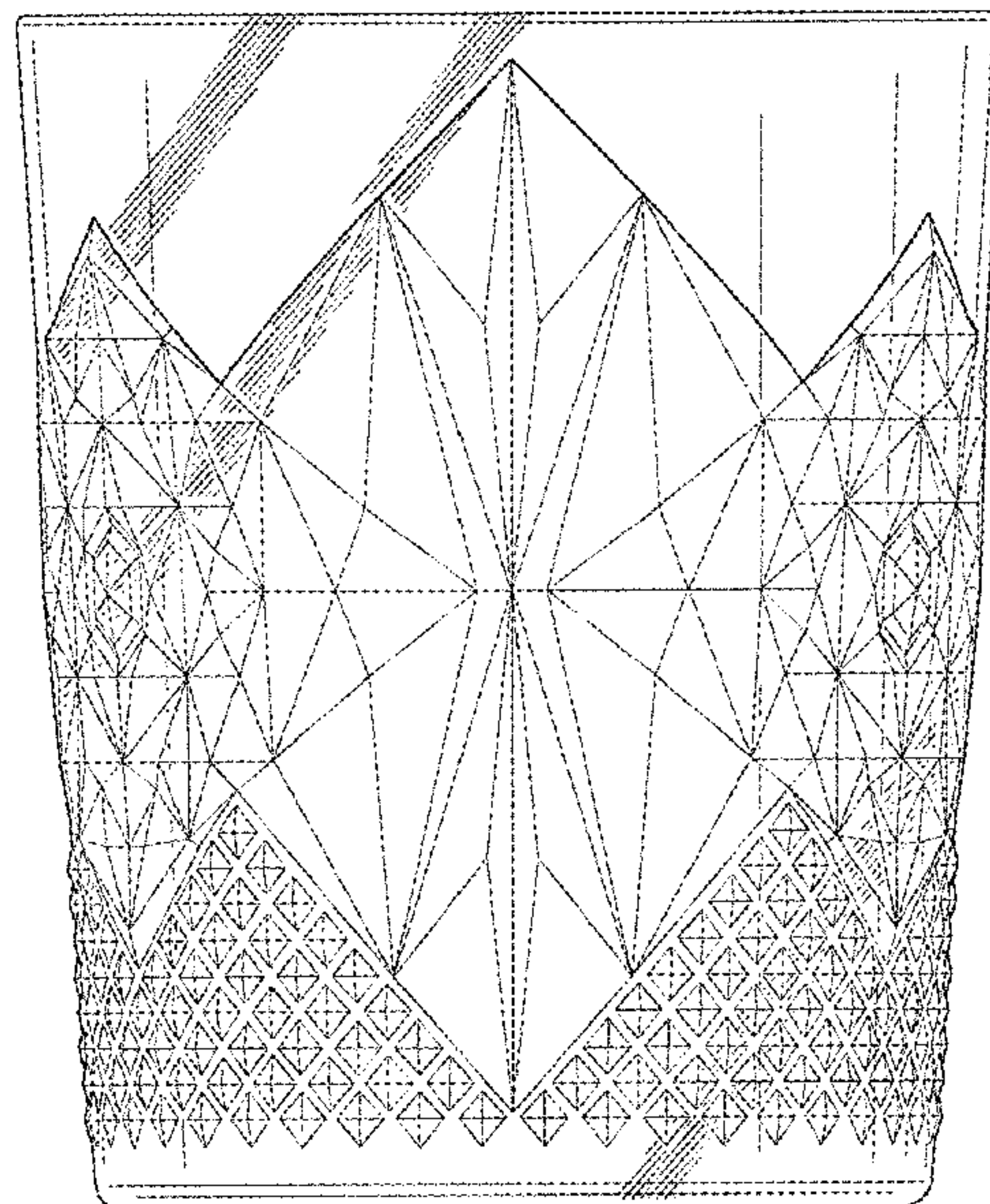
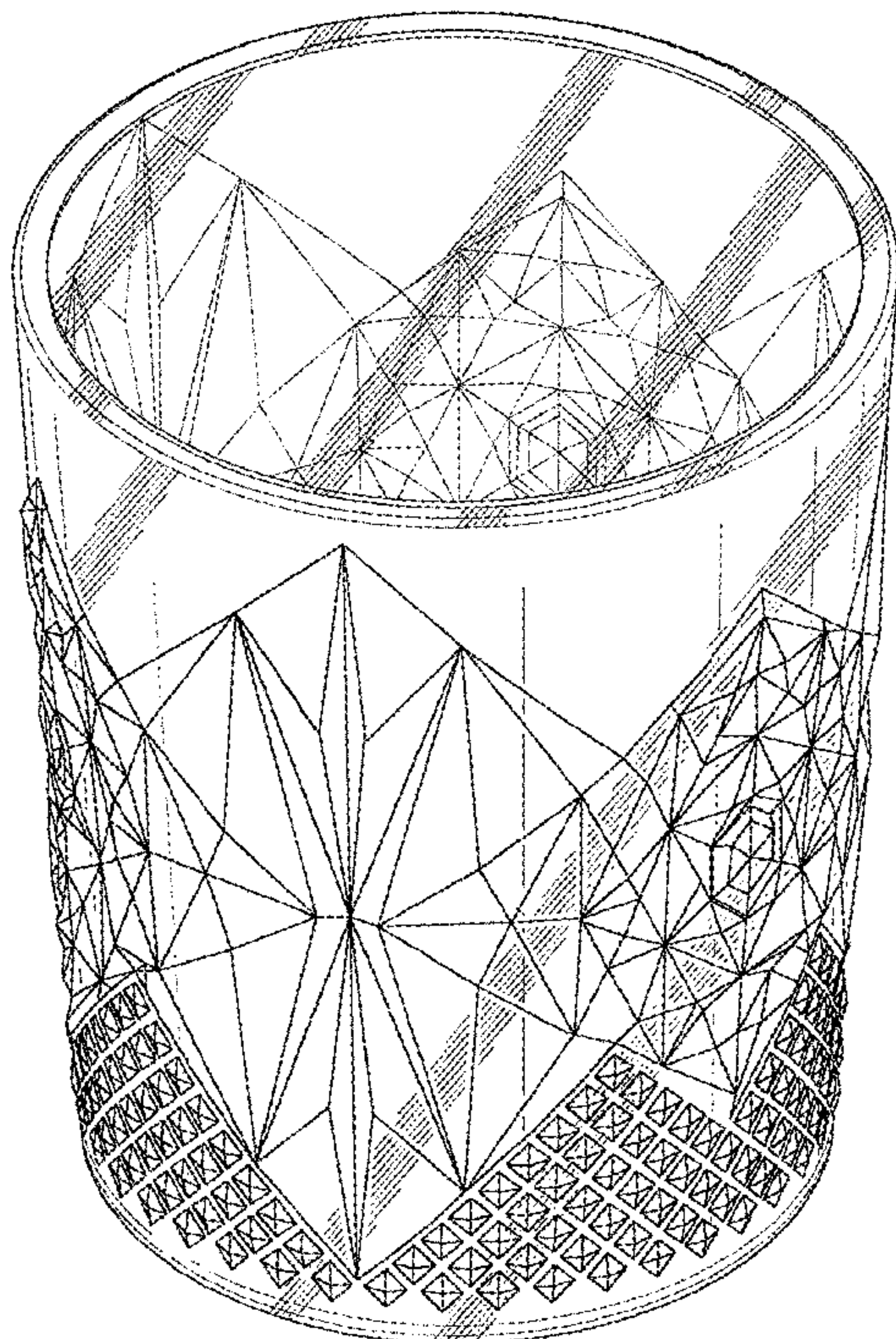
(57) **CLAIM**

I claim the ornamental design for a pyramid surface-externally textured glass, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a pyramid surface-externally textured glass showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom view thereof.

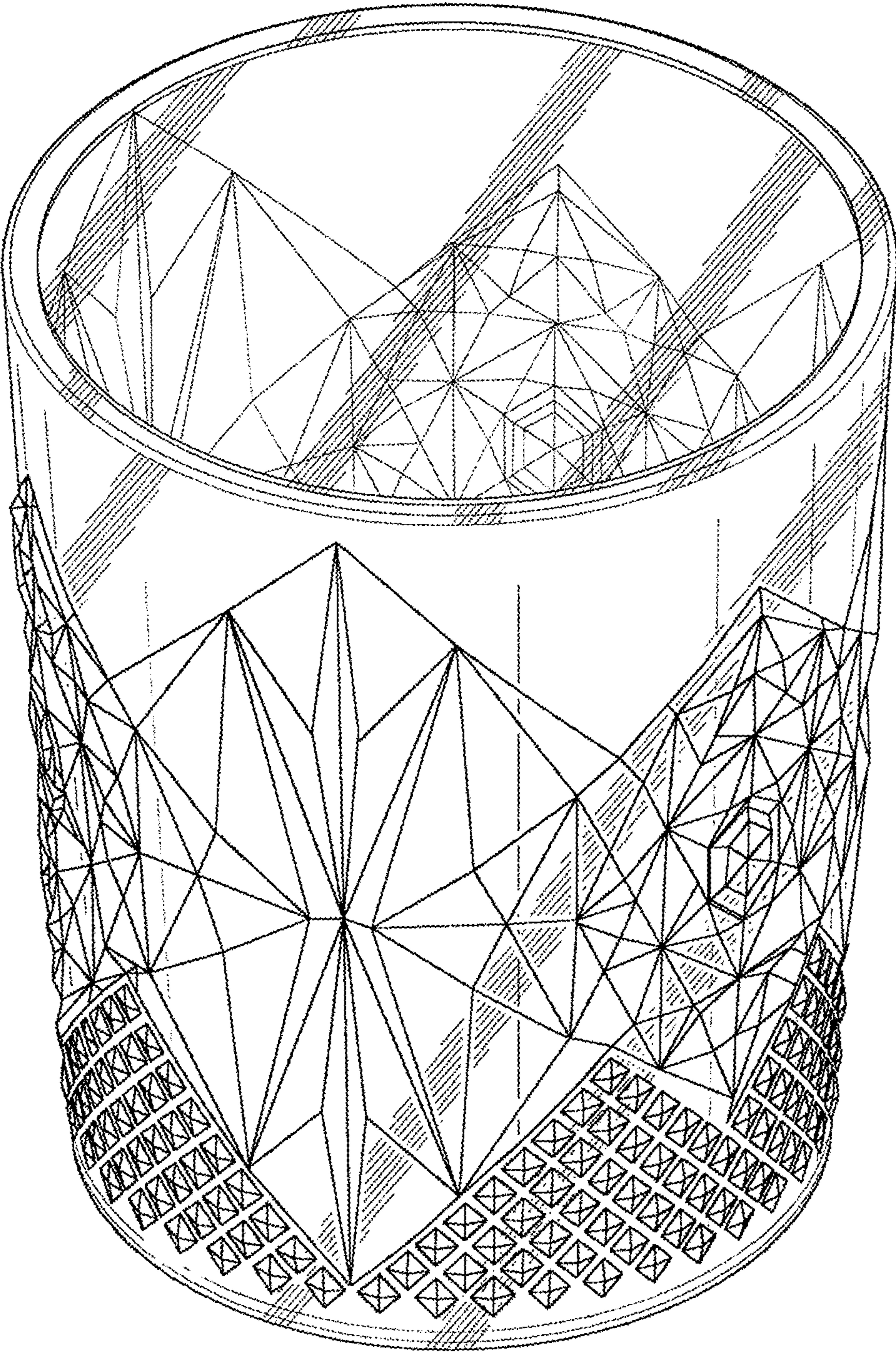

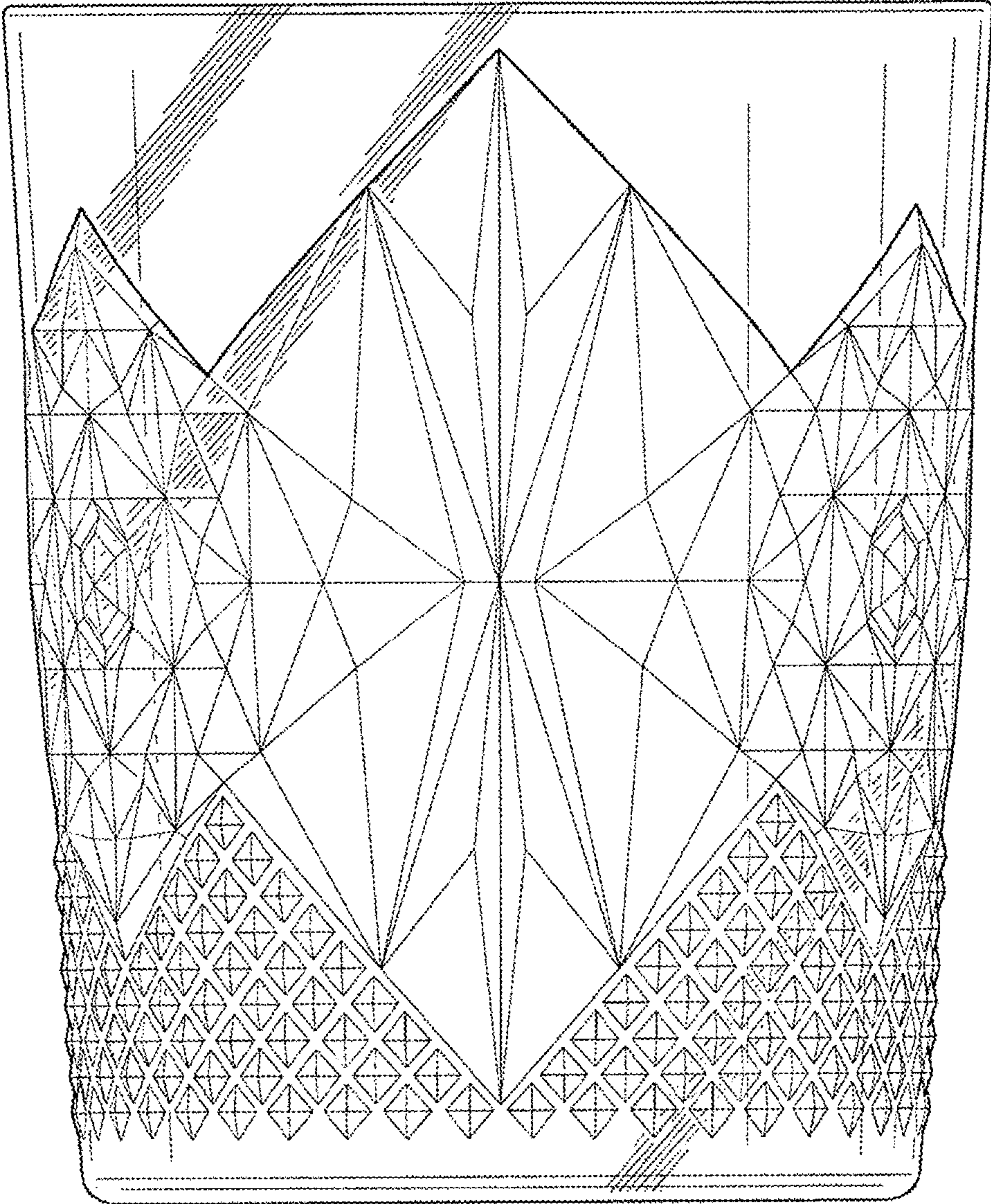

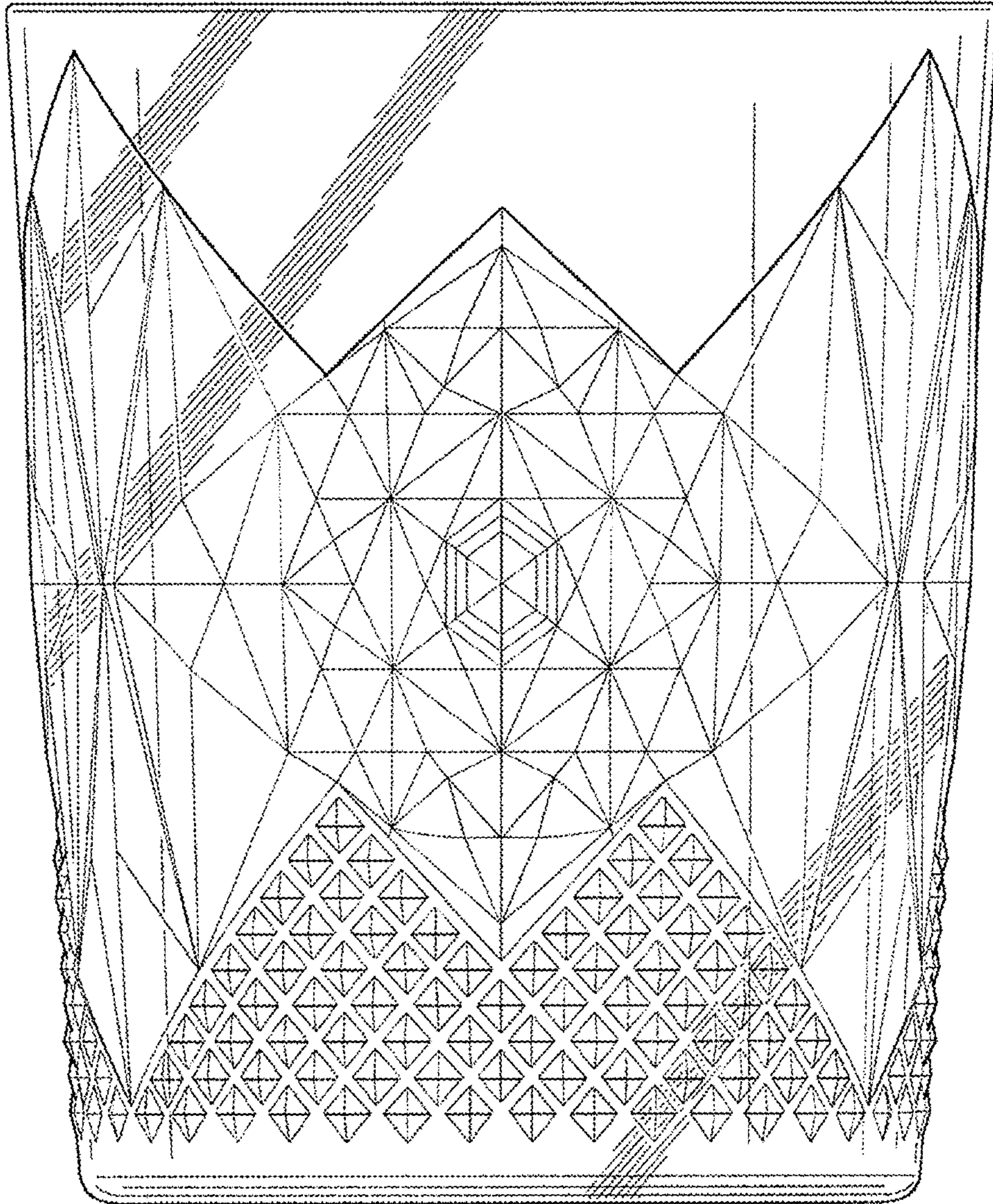

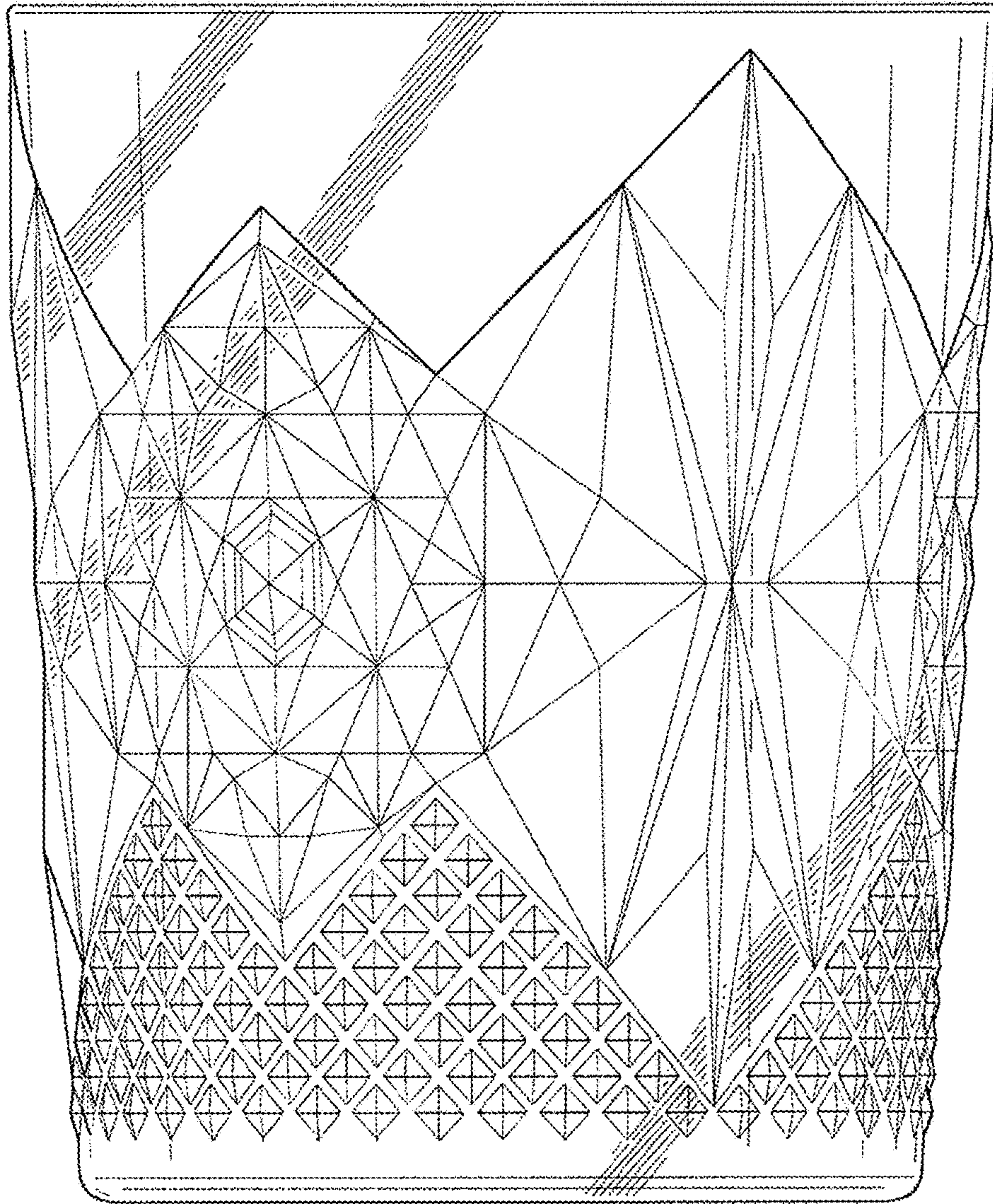

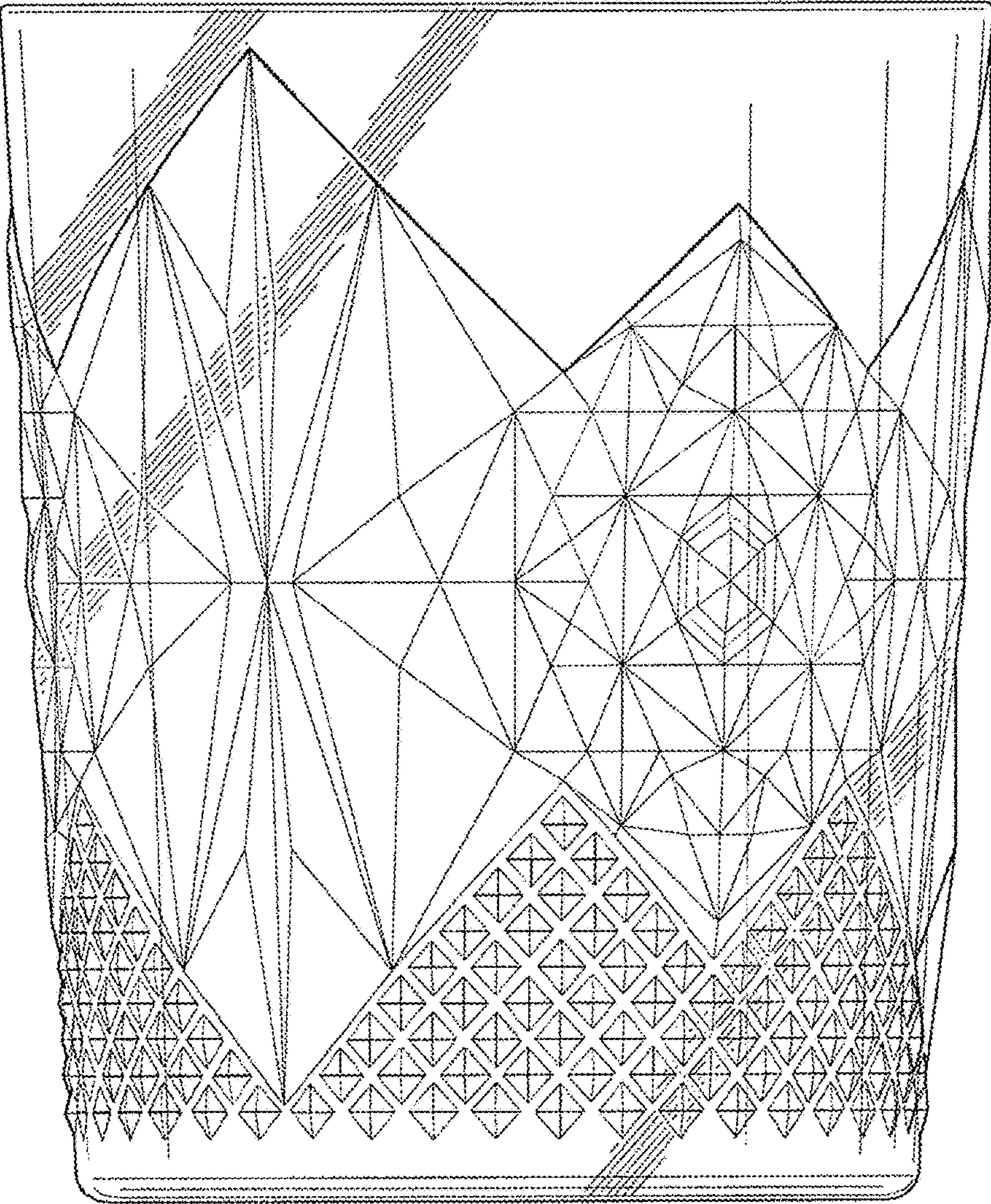

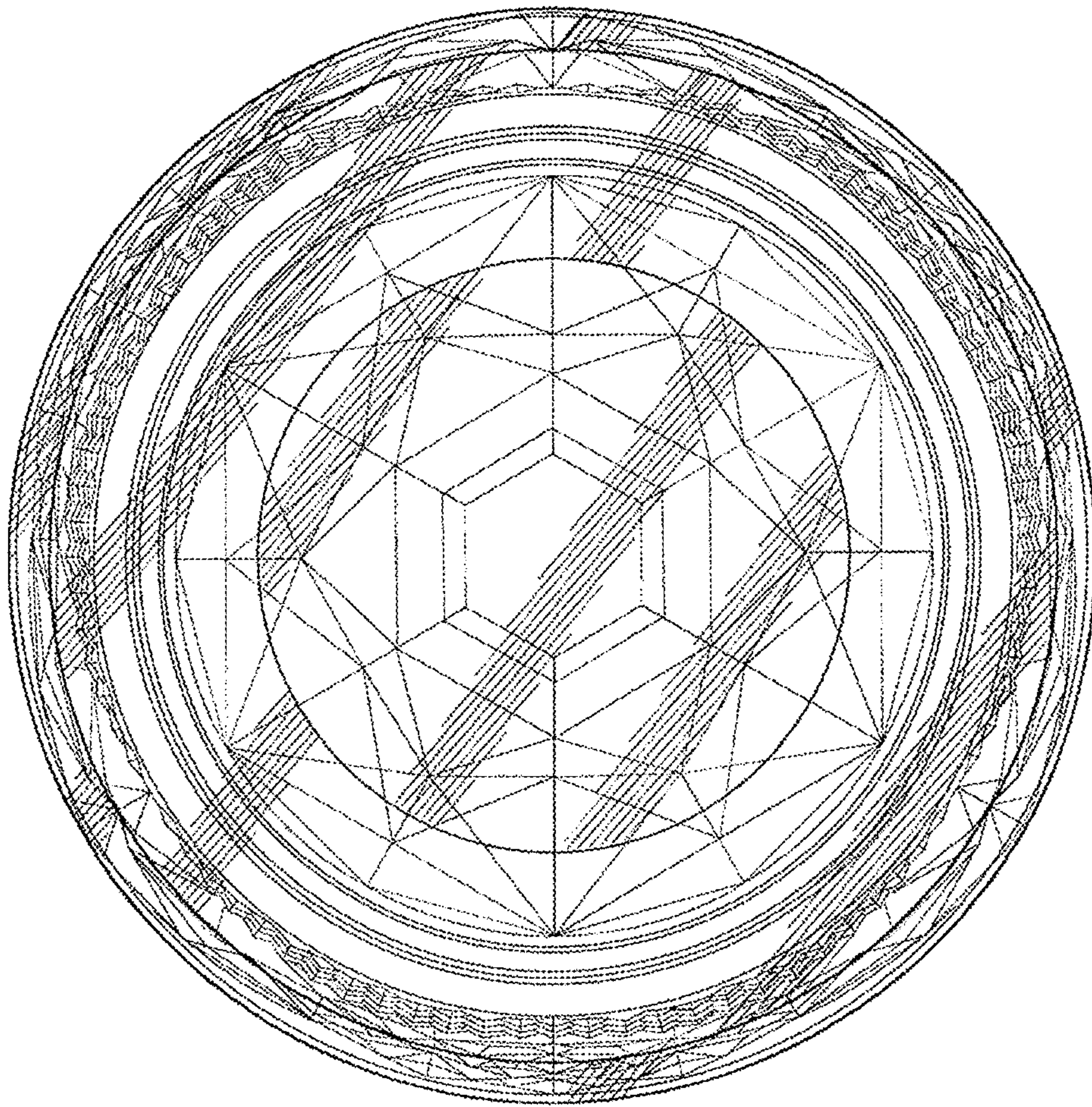

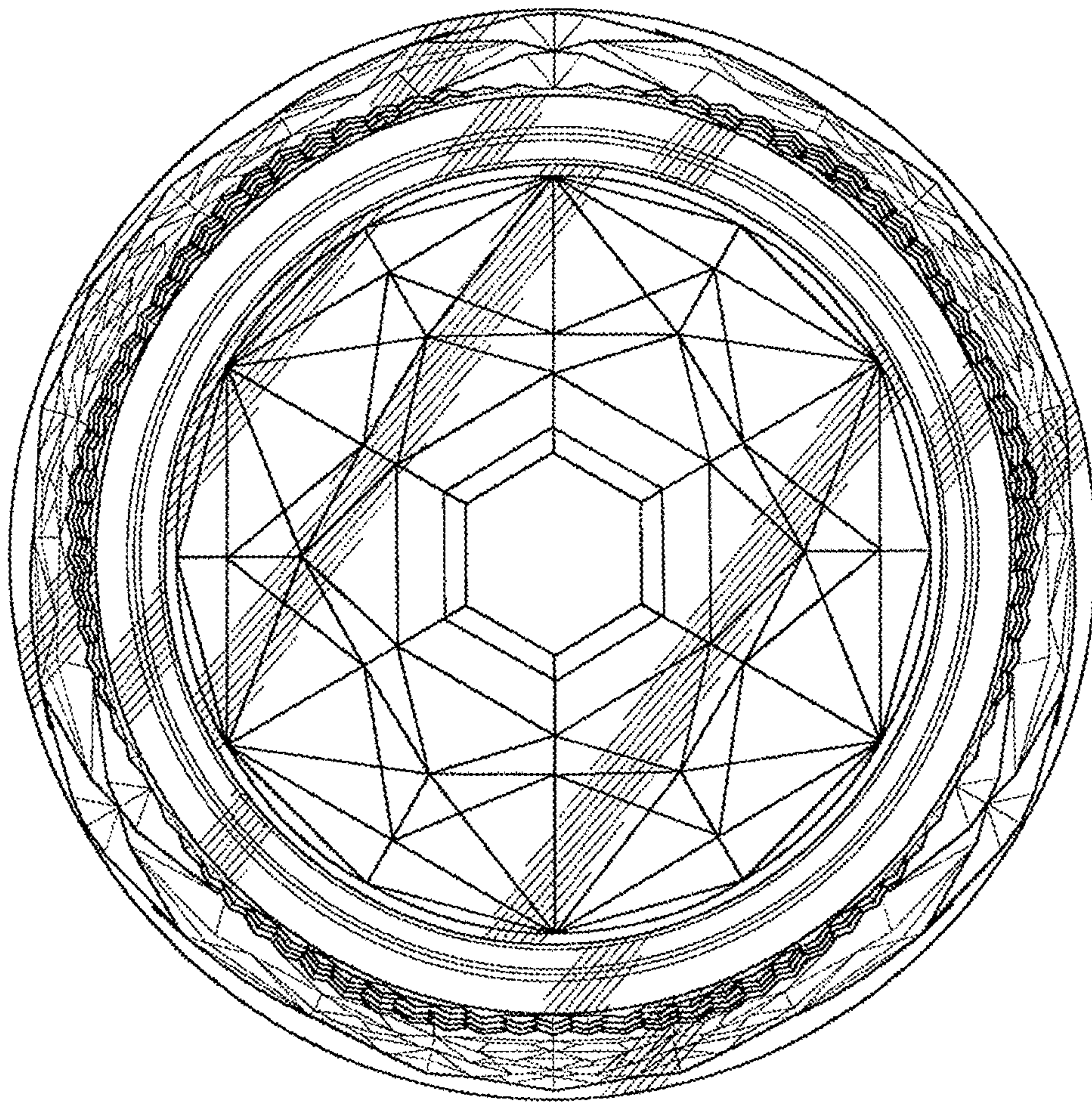
