The ornamental design for a container for medical products, cosmetic products and nutritional supplements, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right perspective view of a container for medical products, cosmetic products and nutritional supplements showing our new design.

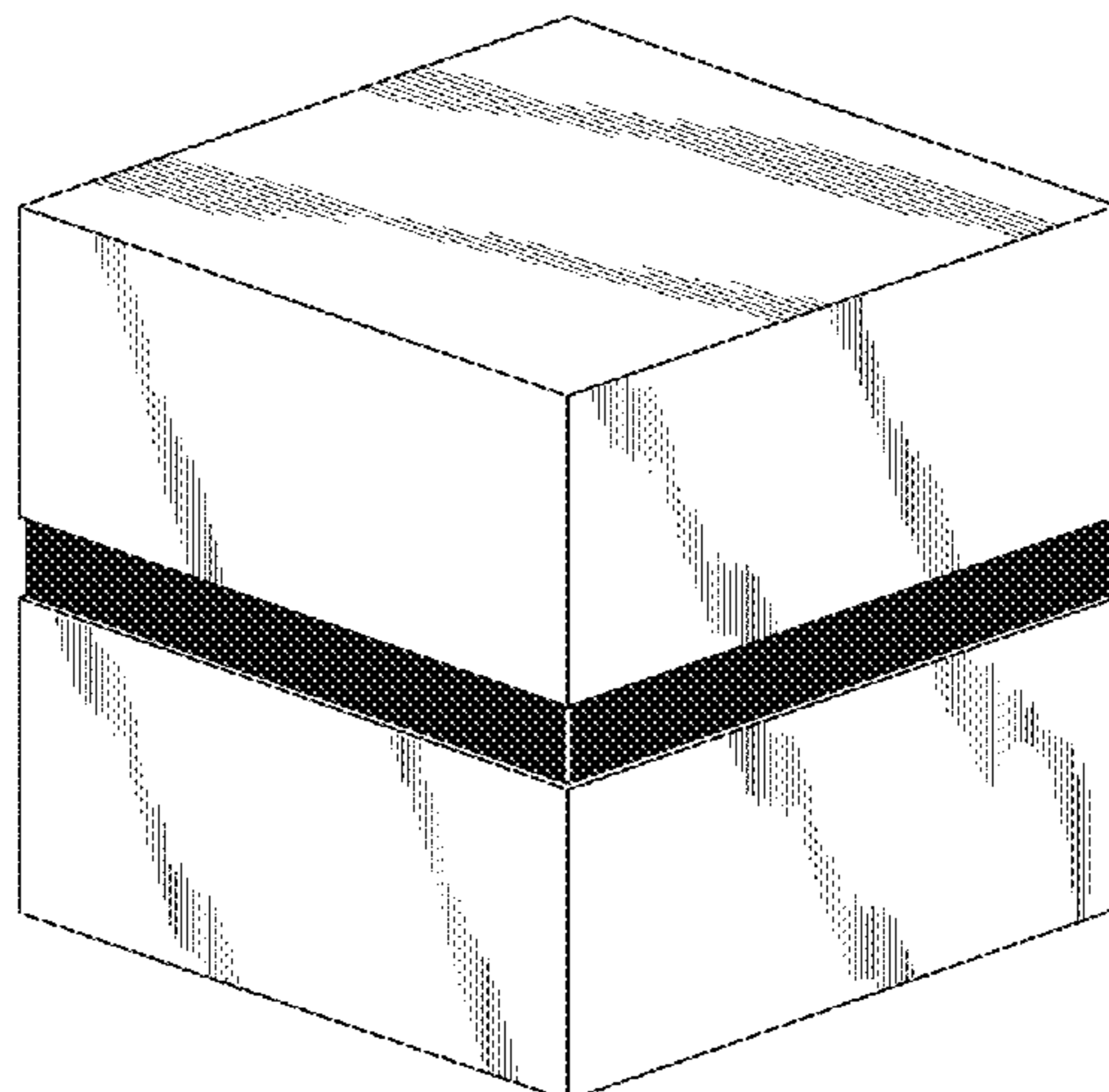
FIG. 2 is a front, bottom and right perspective view thereof.

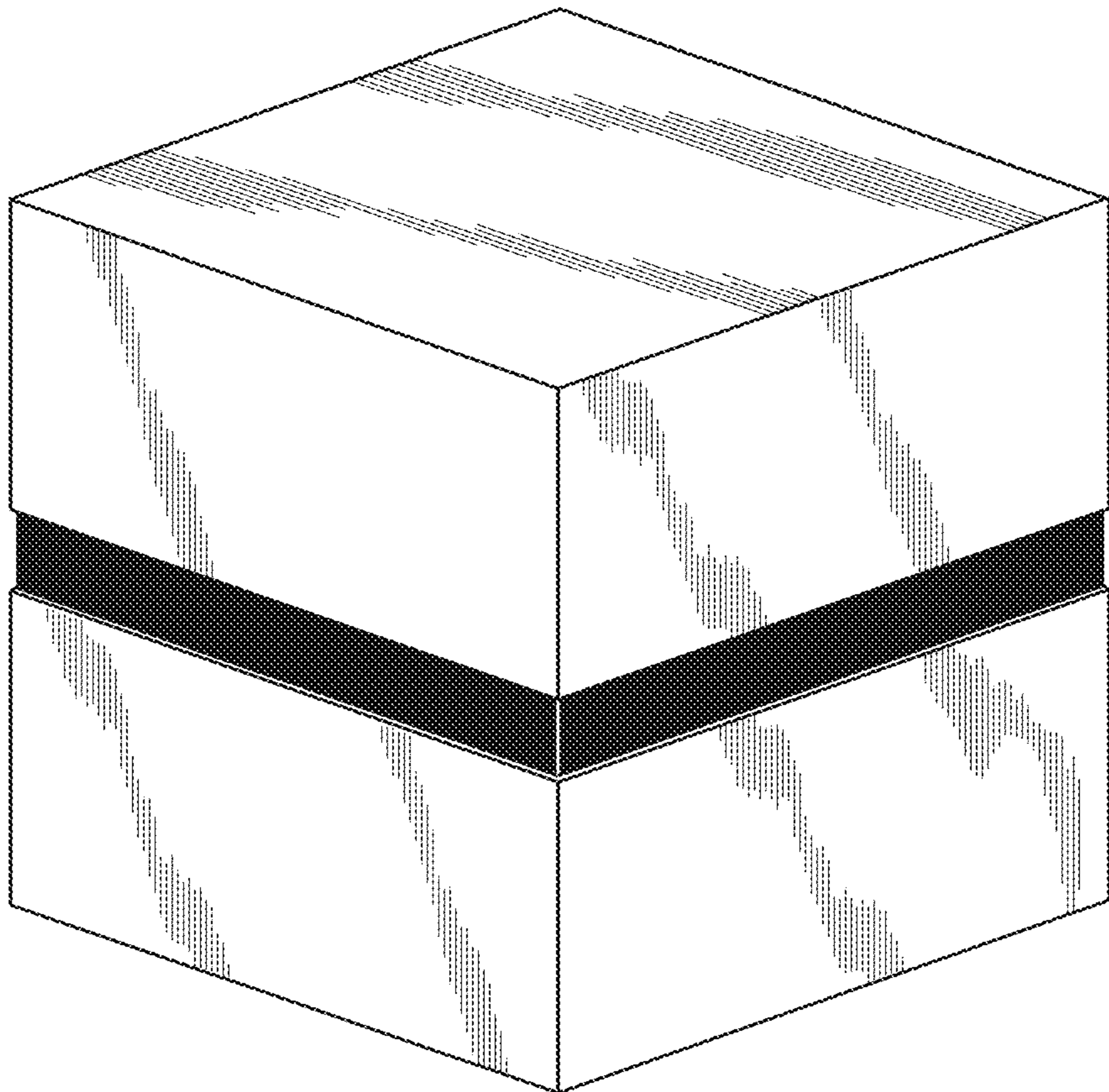

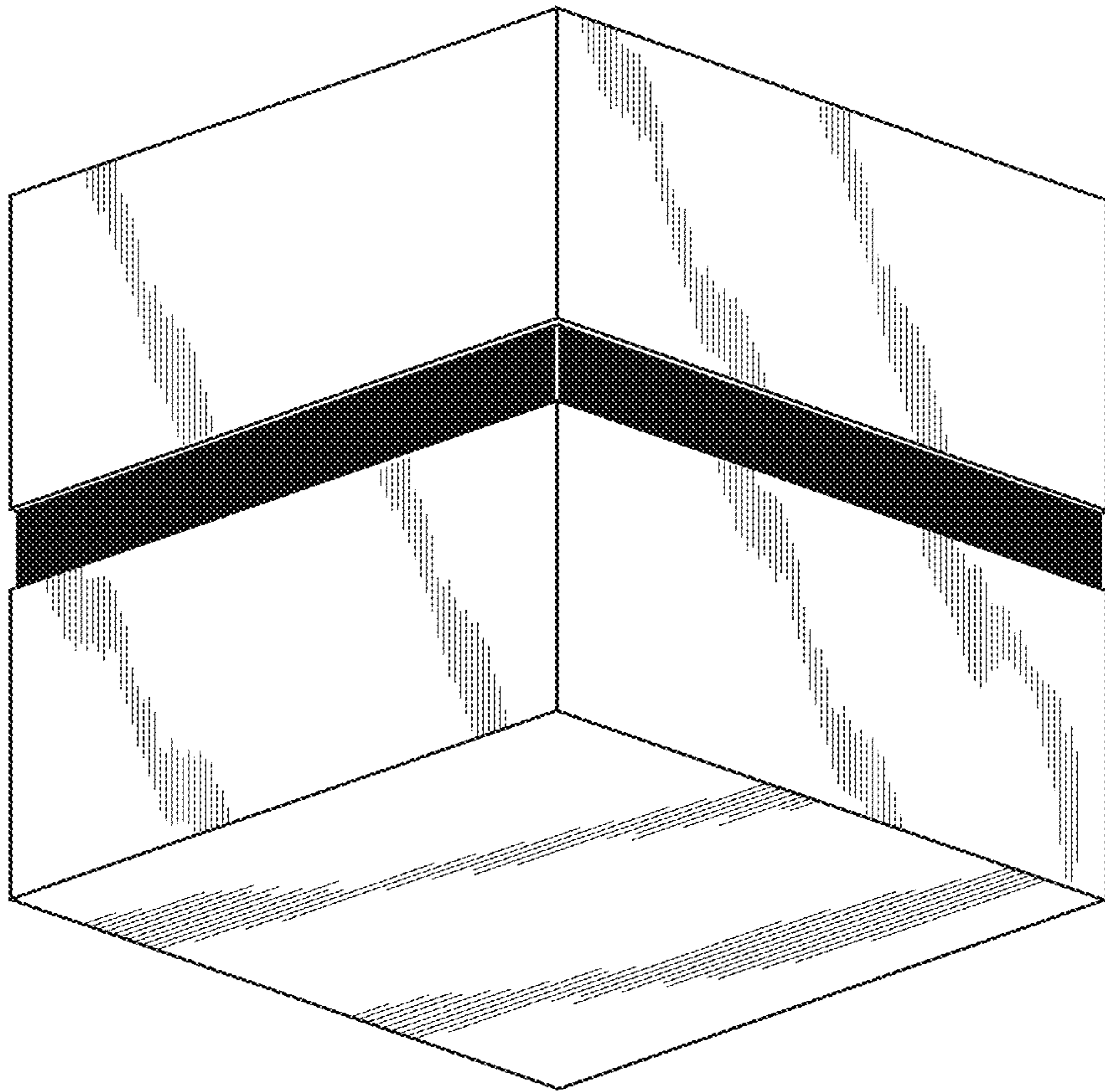

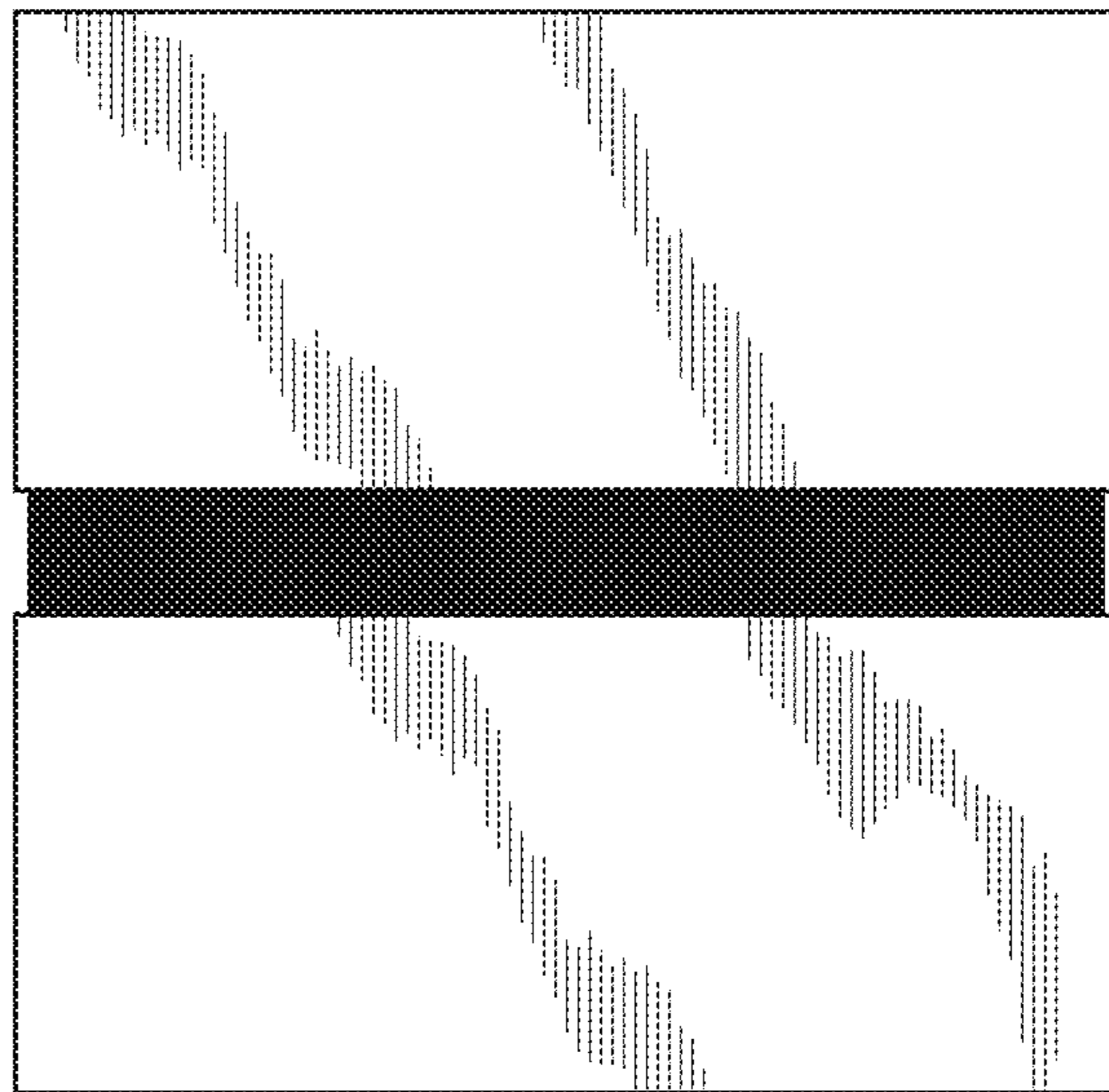

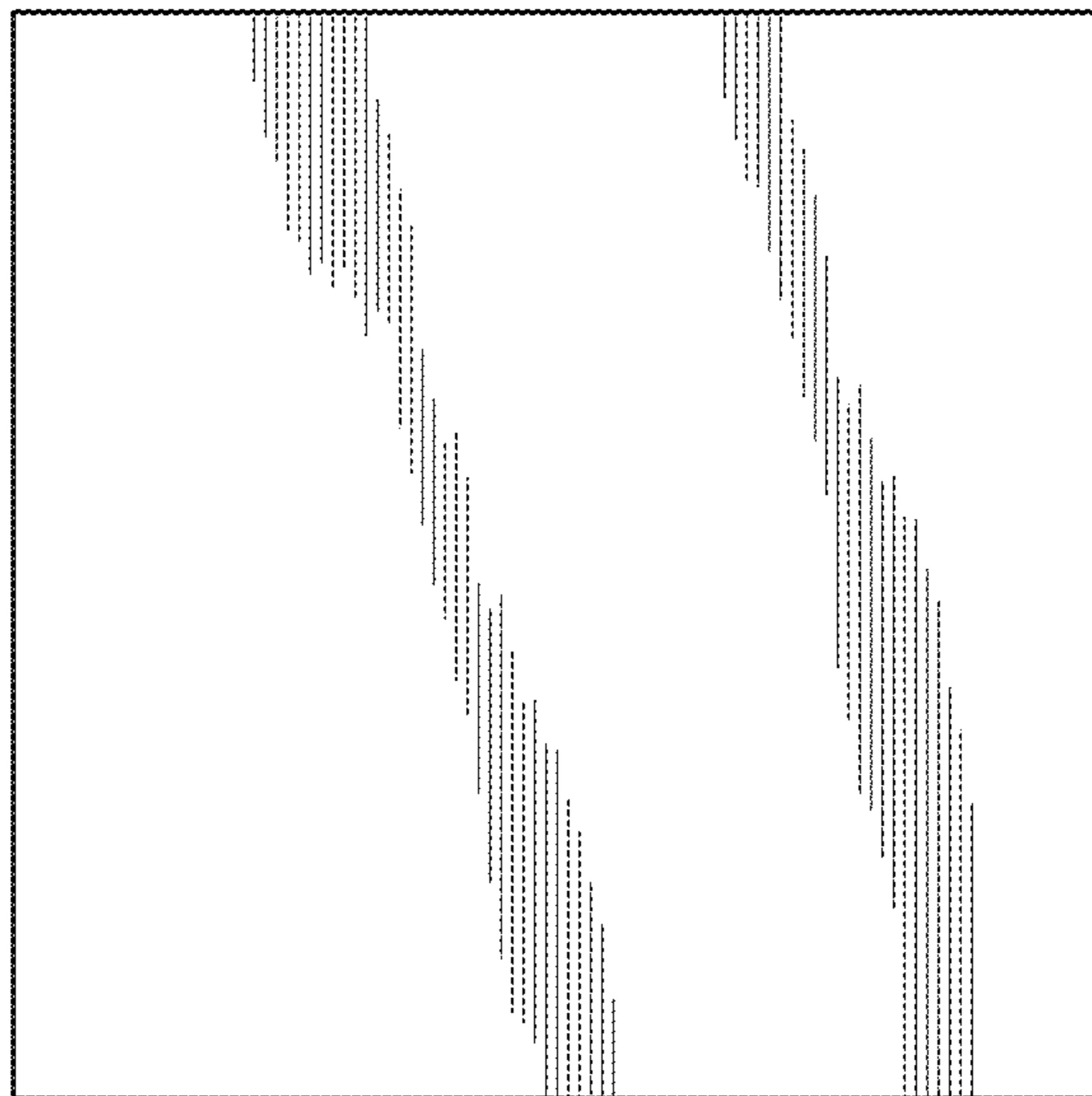
