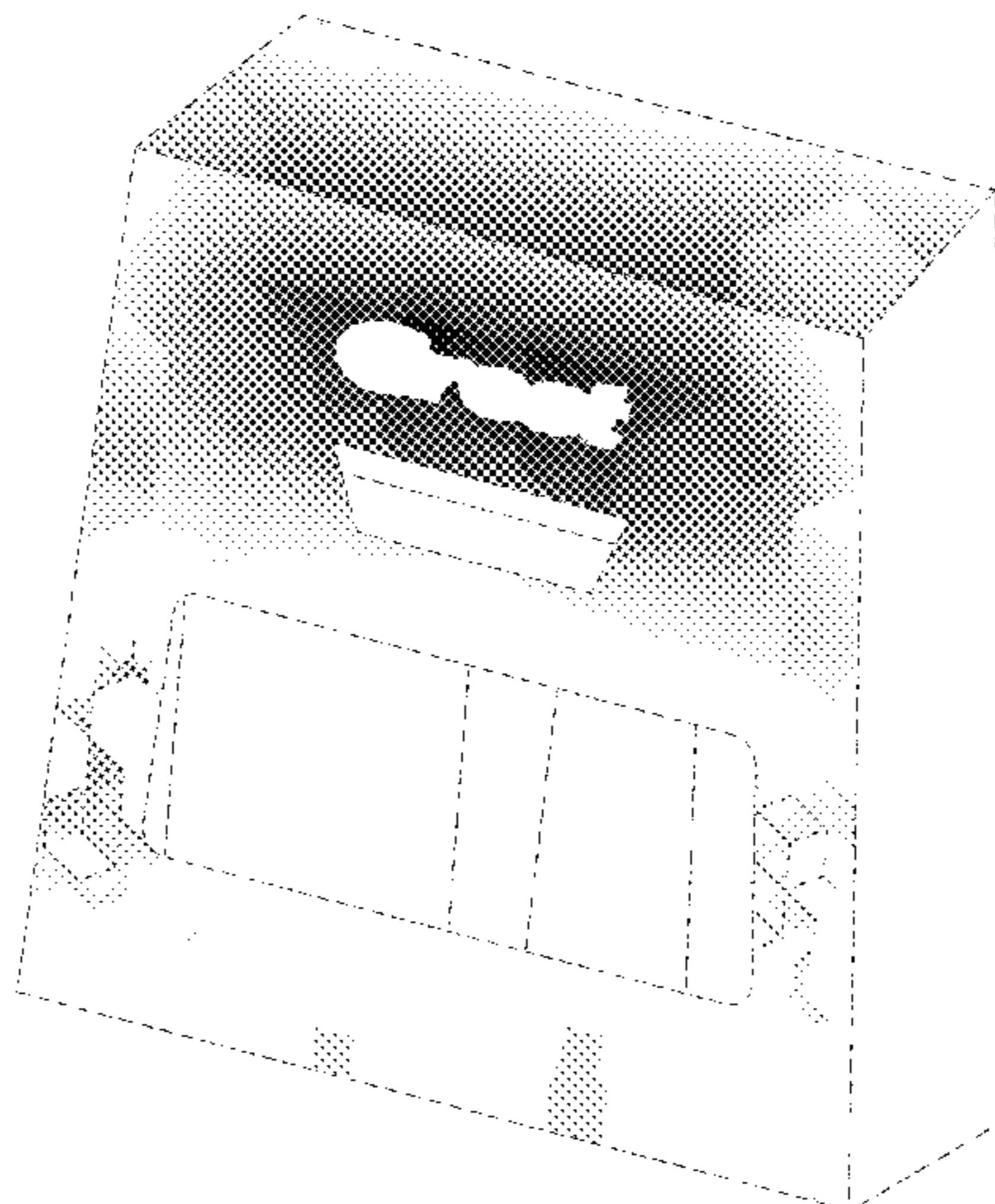
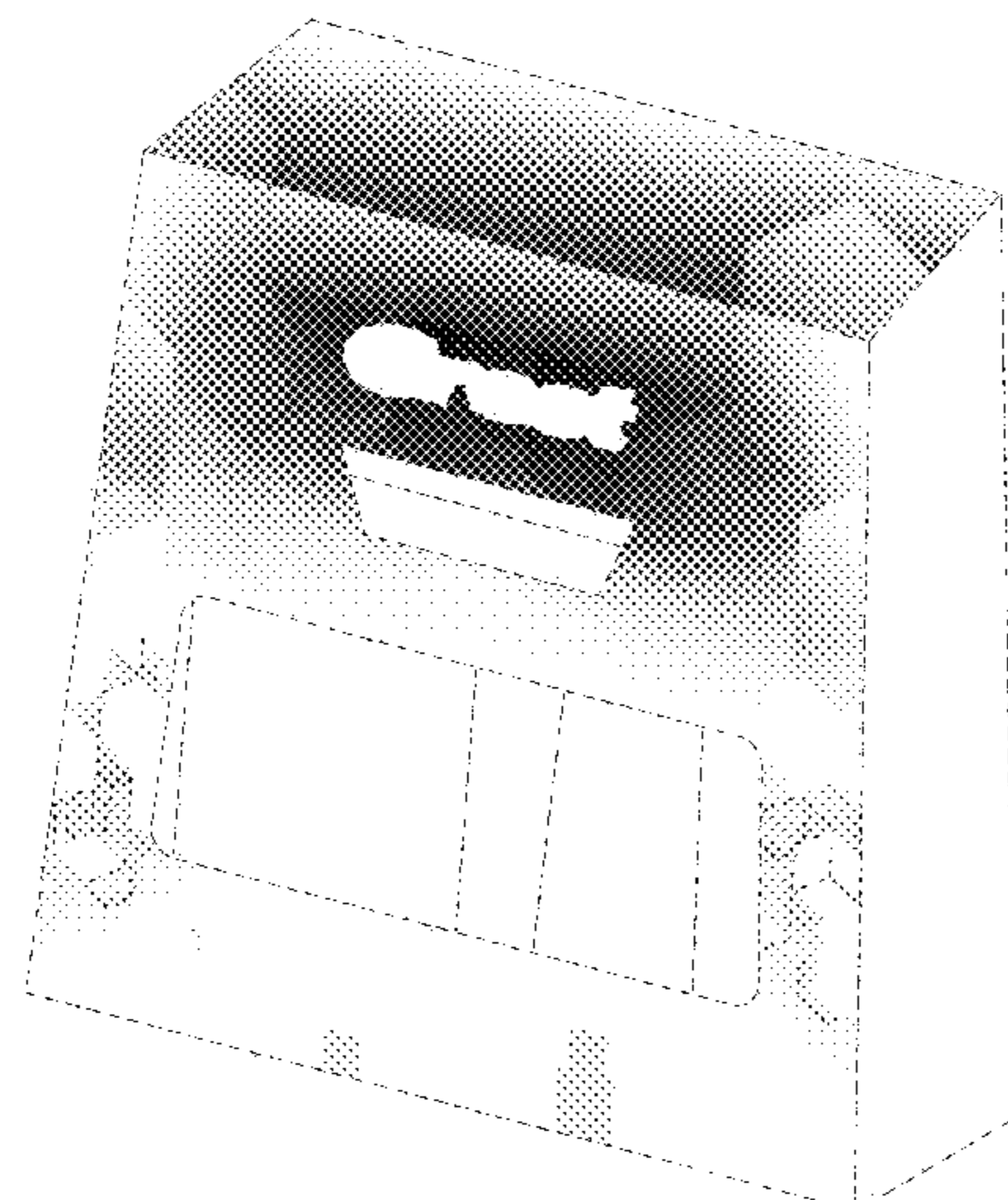
FIG. 13 is a top plan view thereof; and,

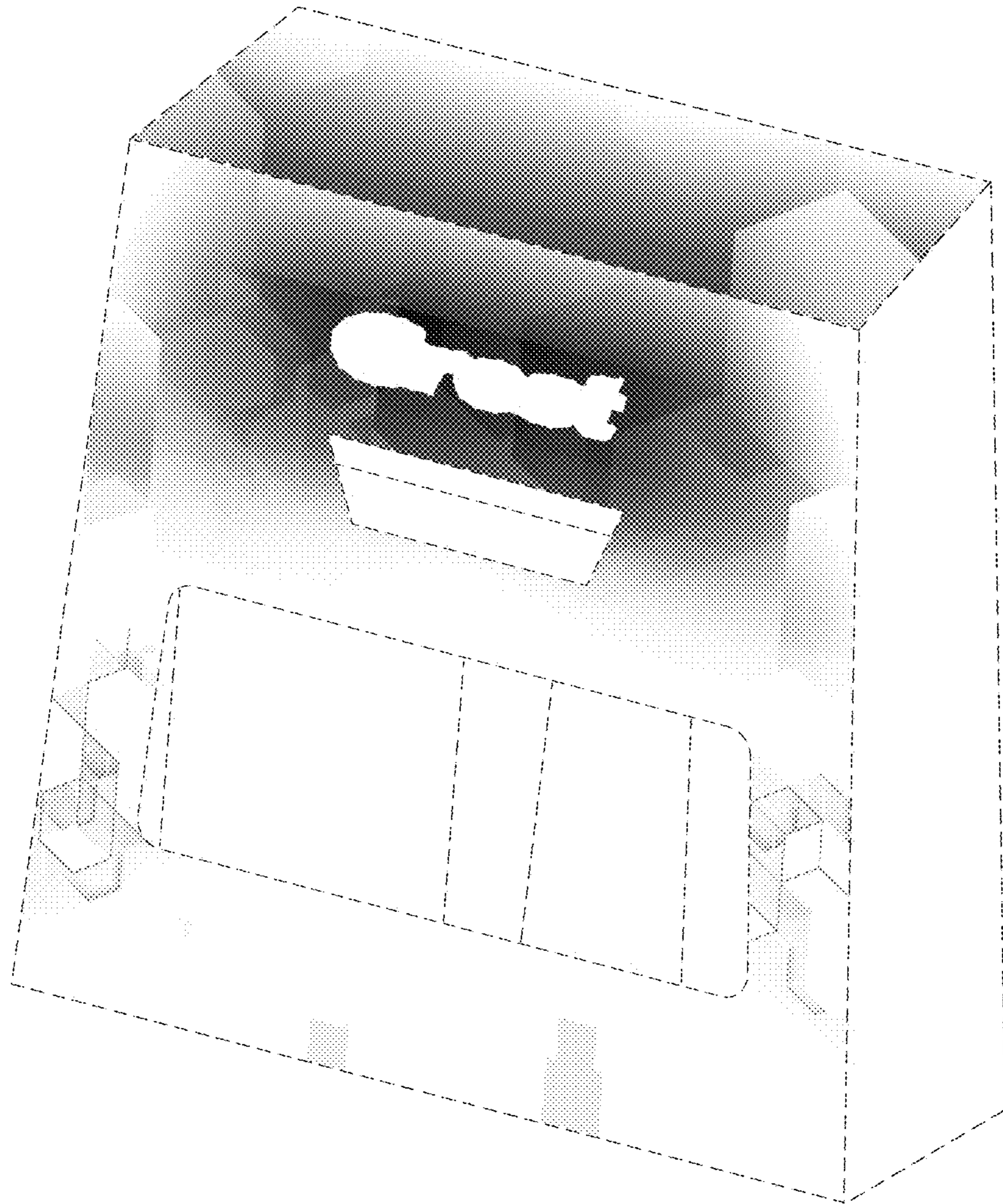

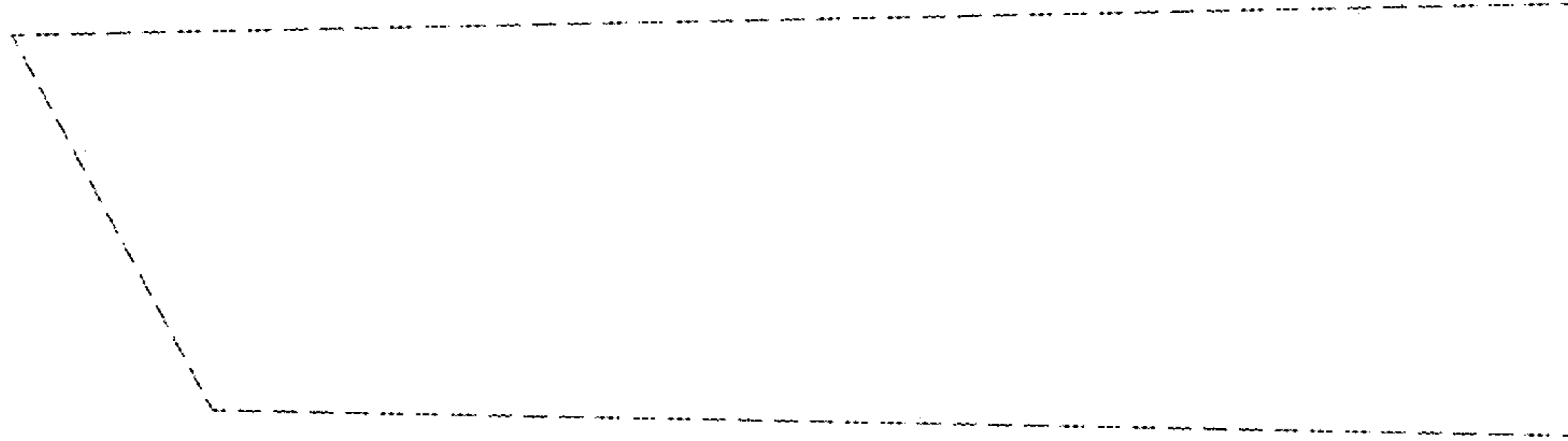

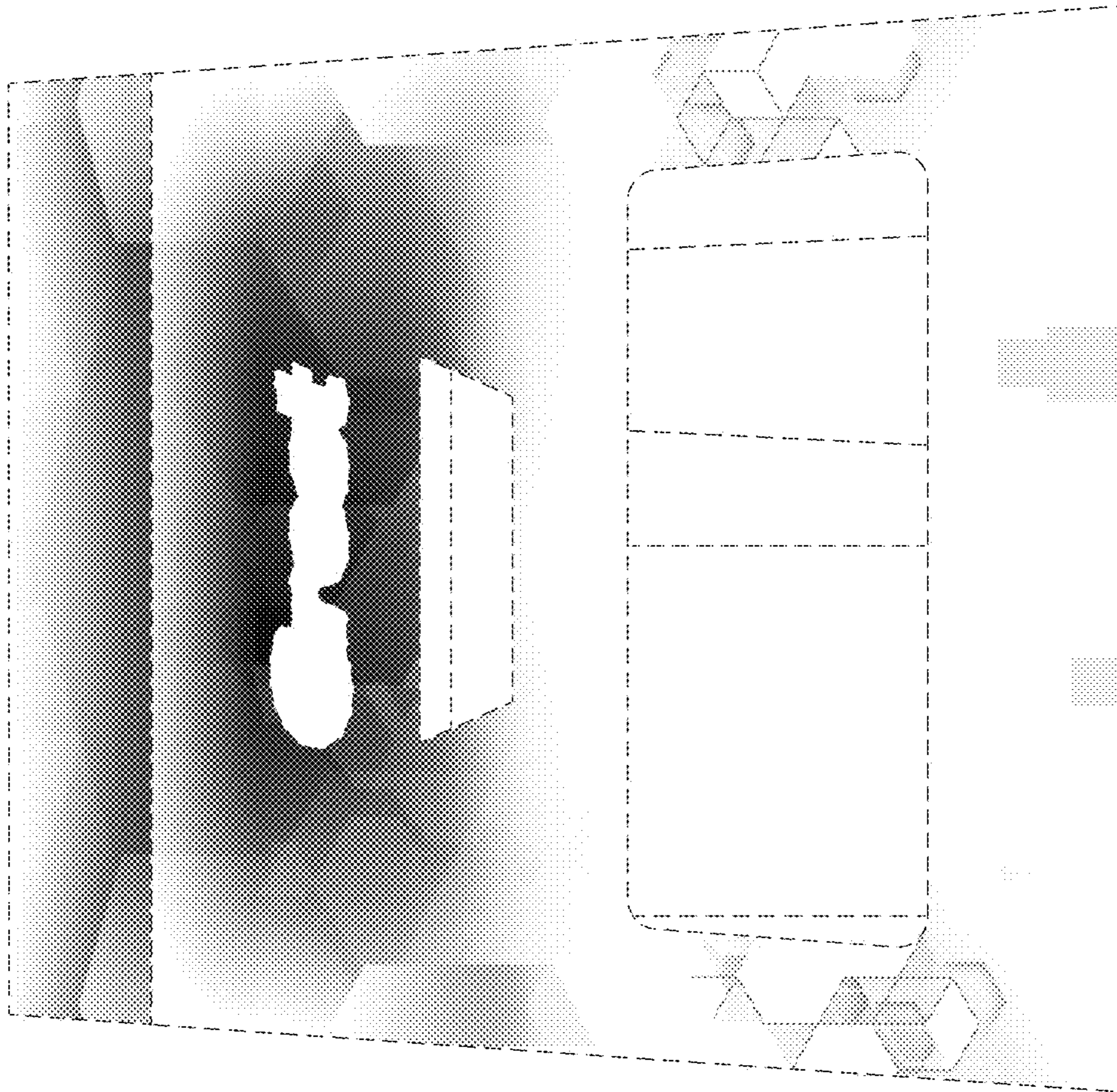

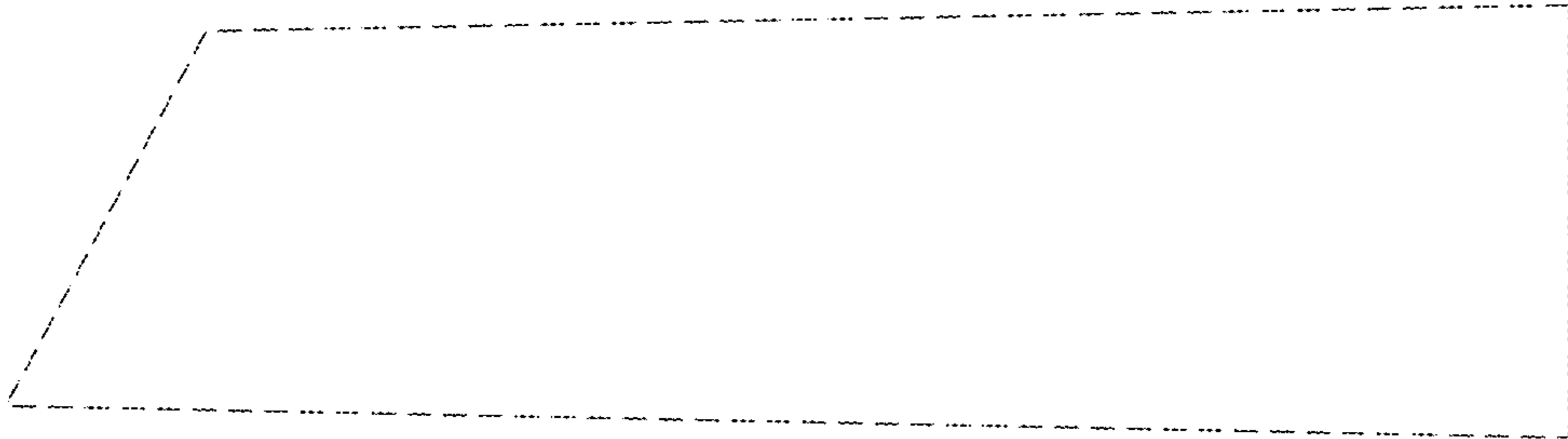

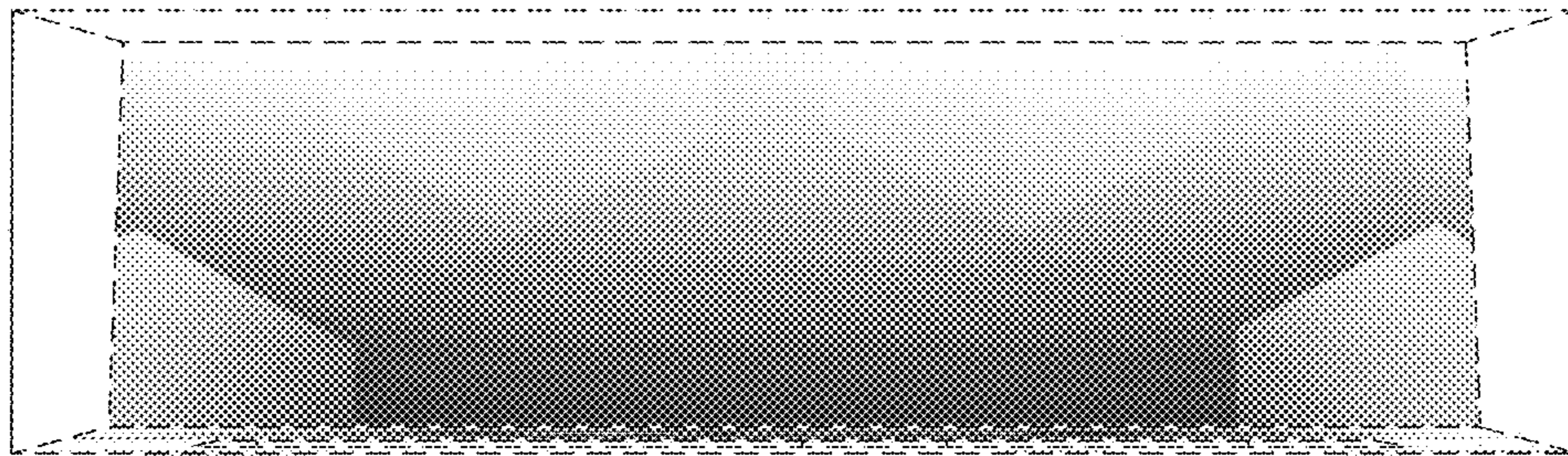

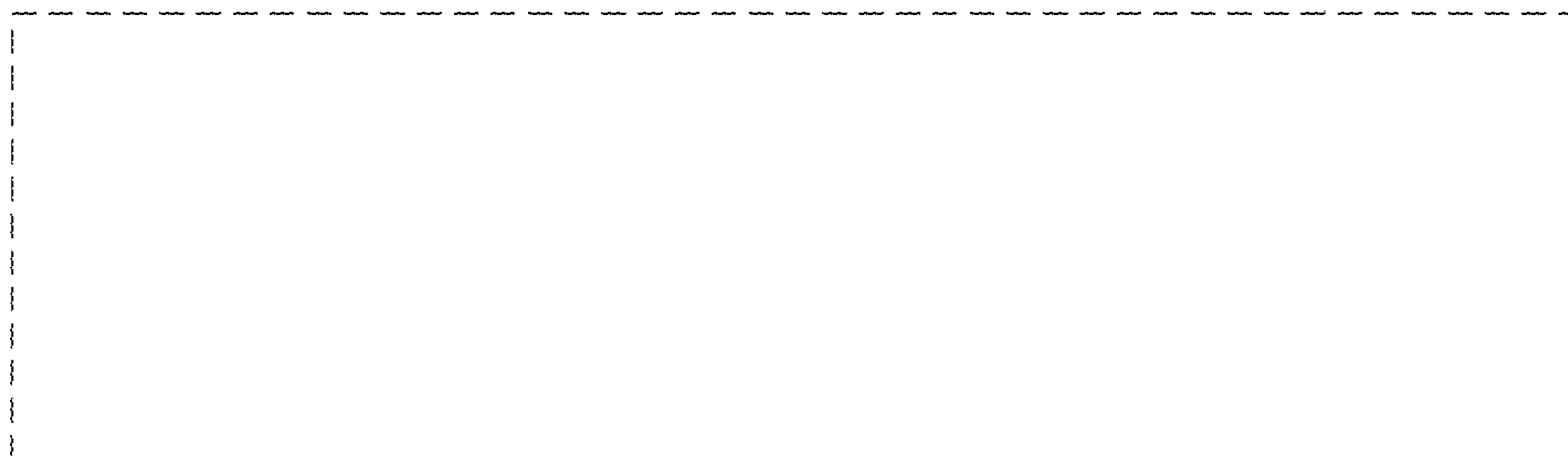

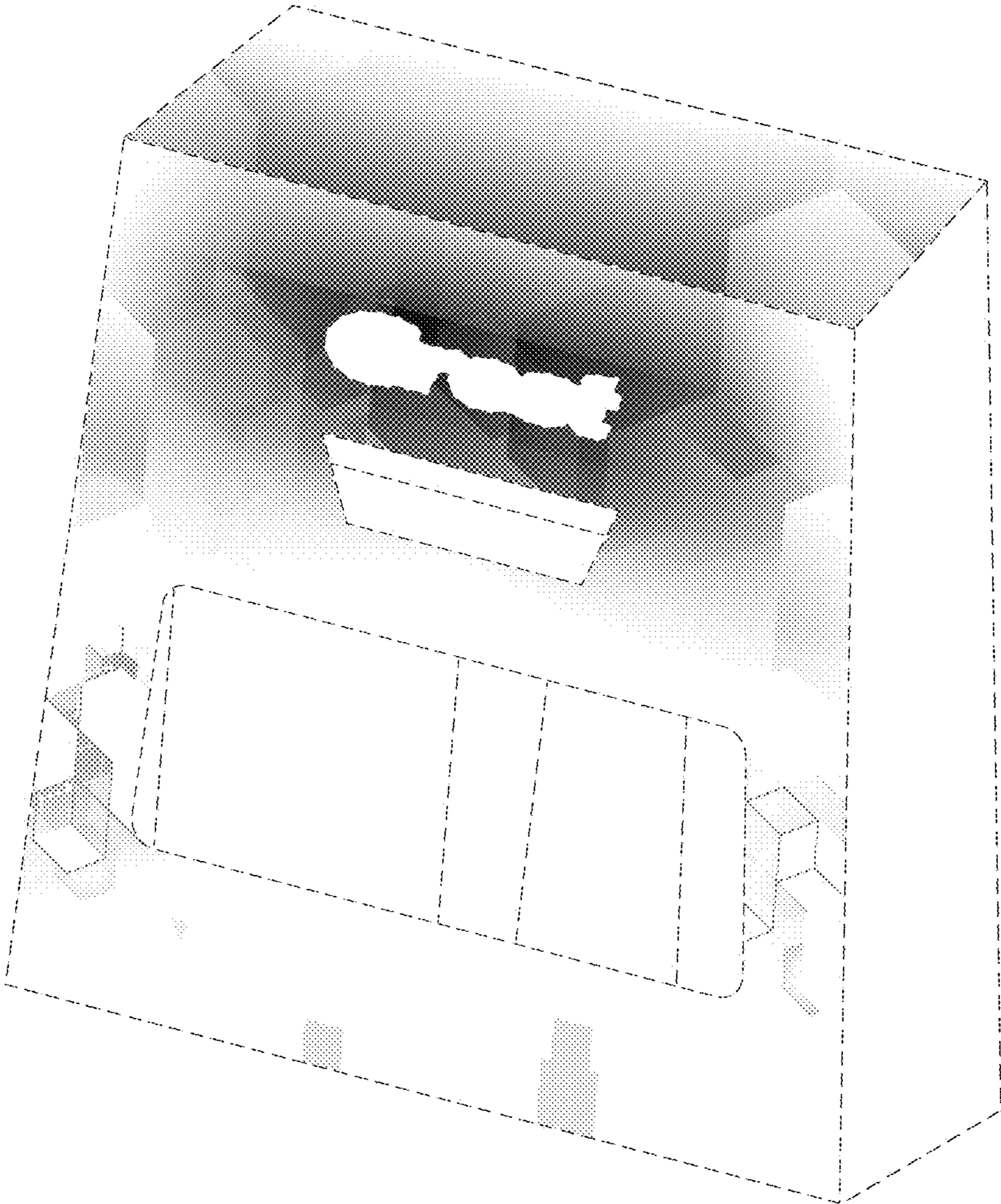

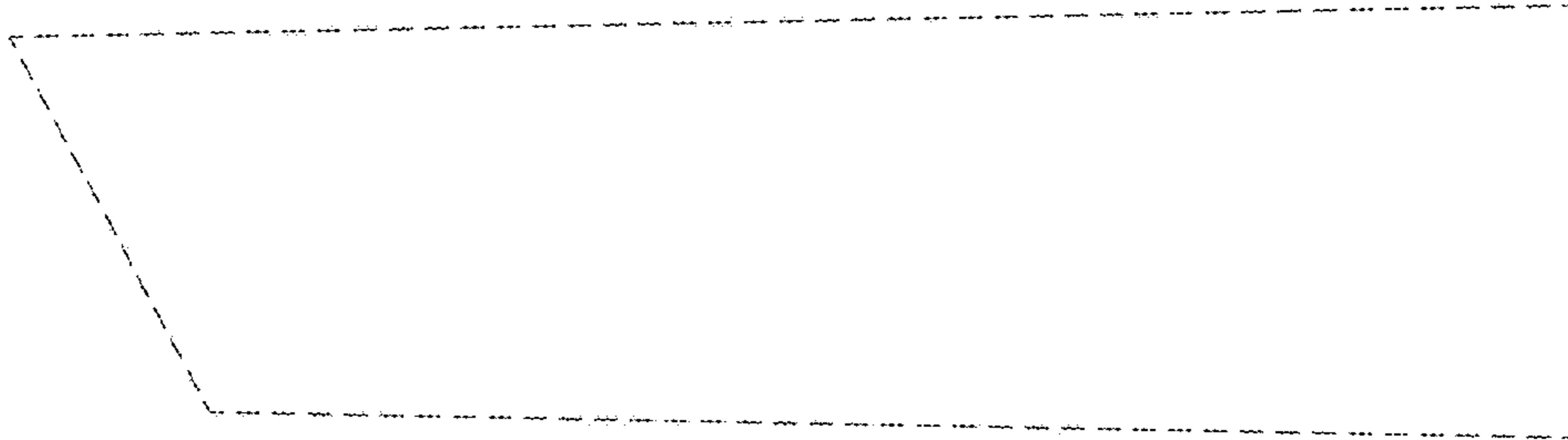

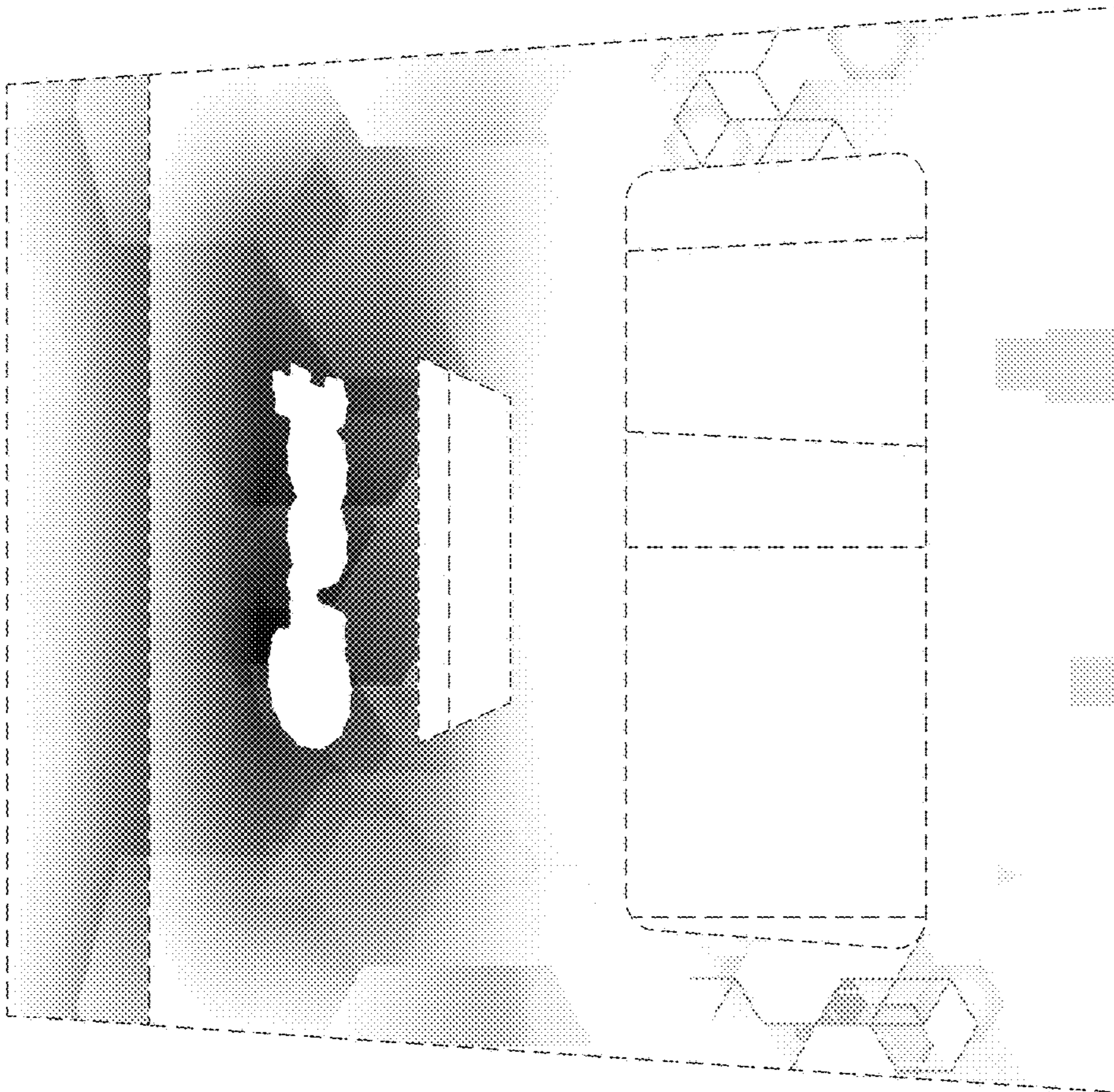

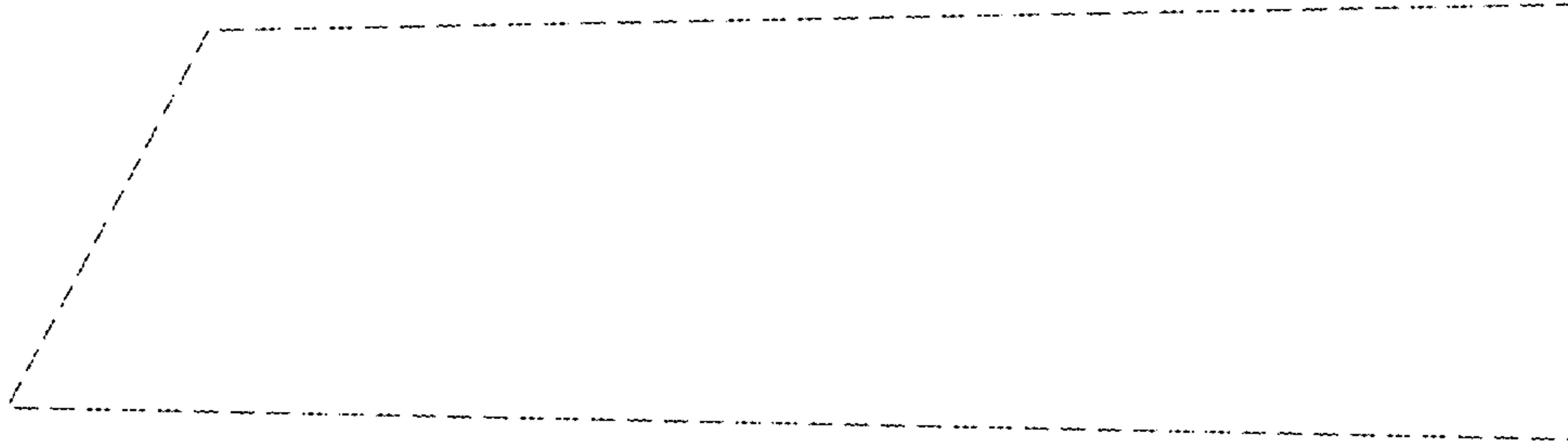

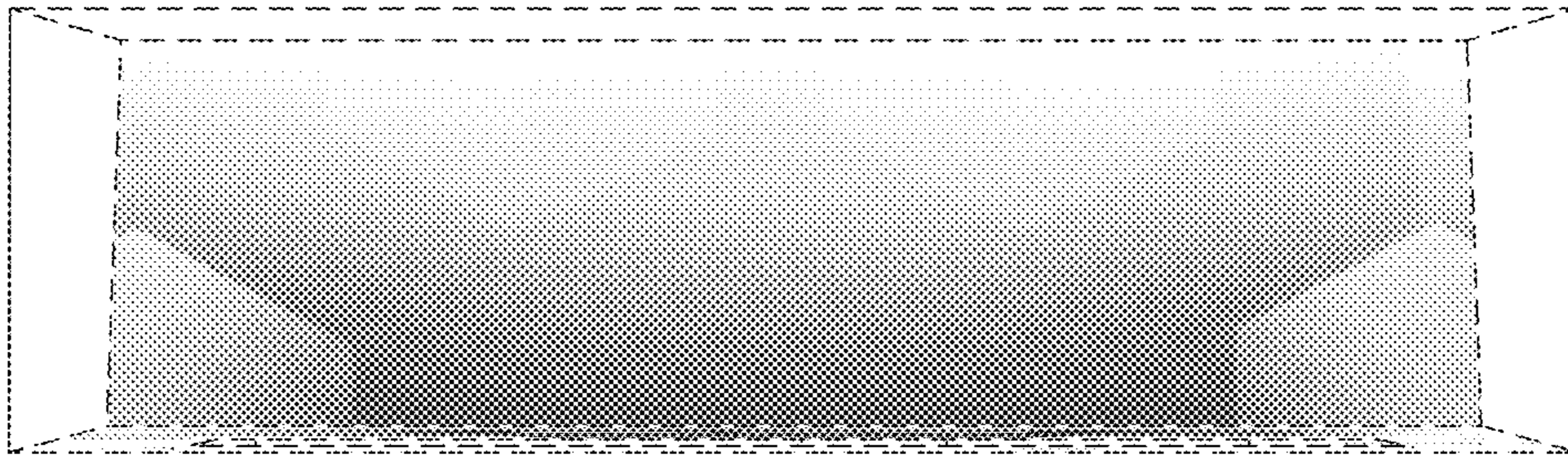

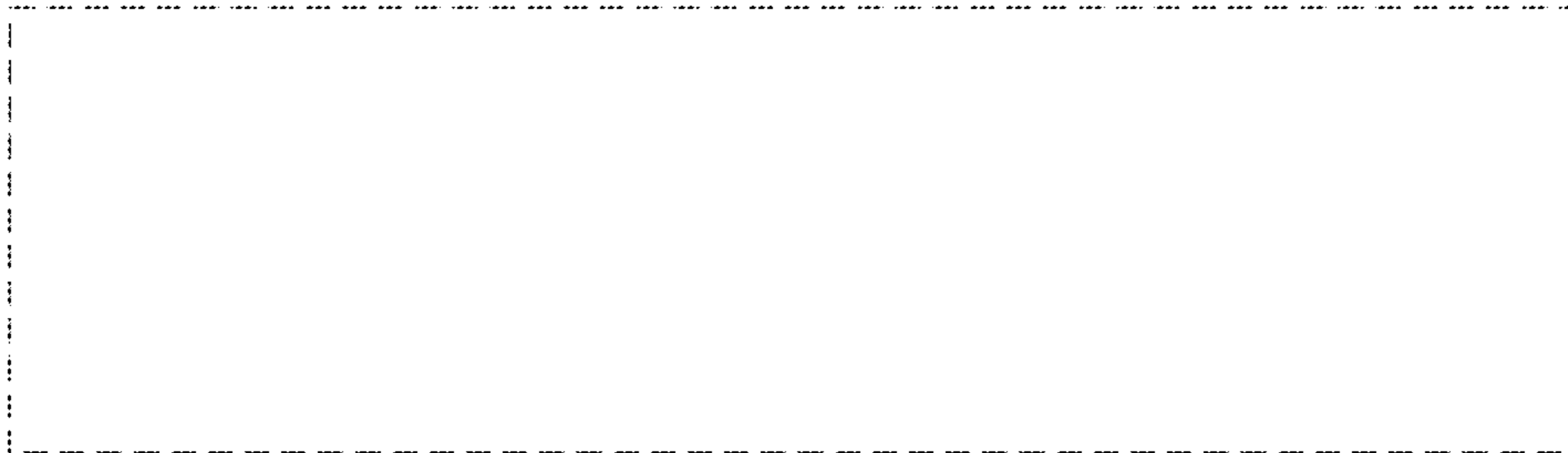
