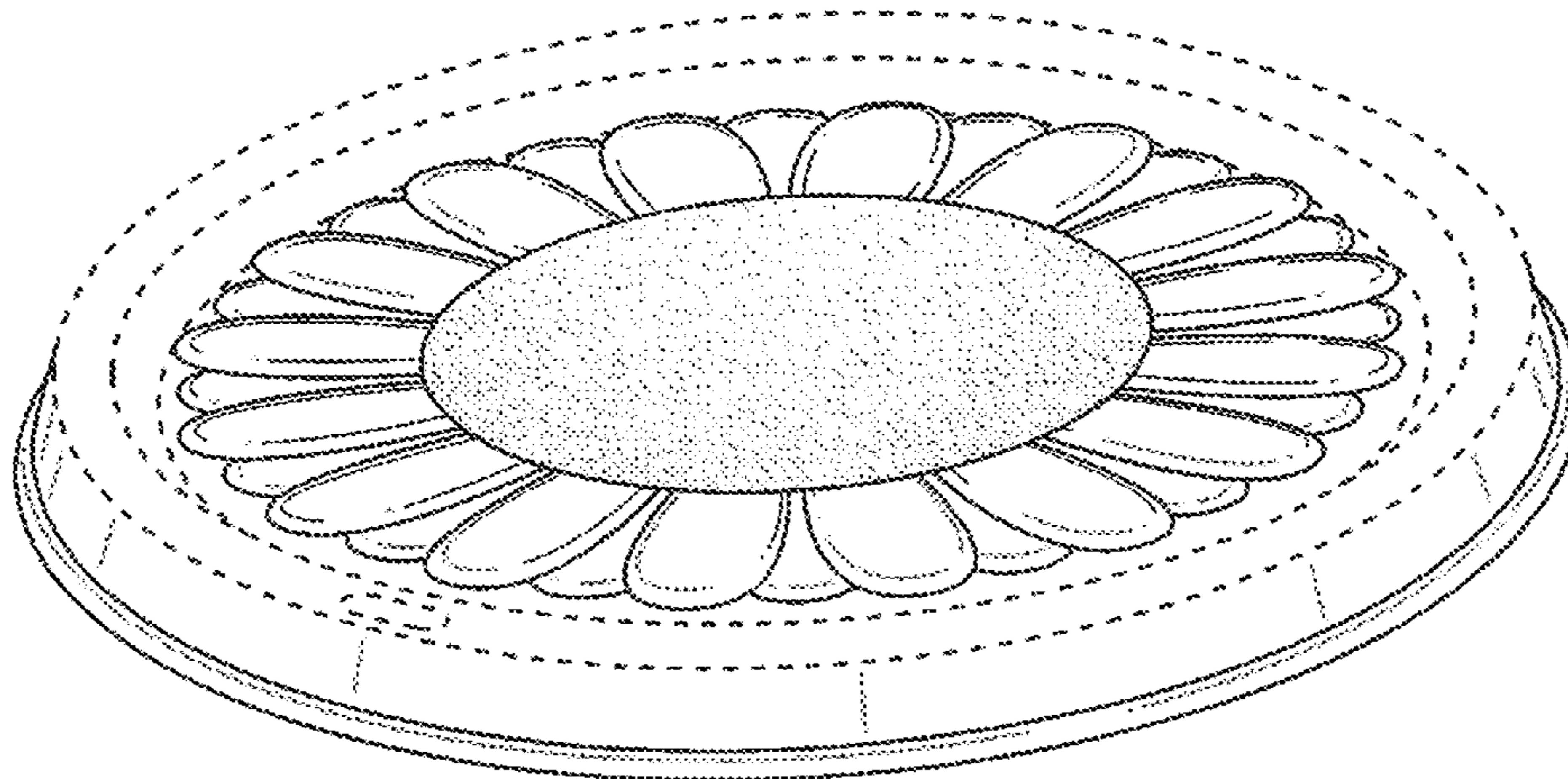

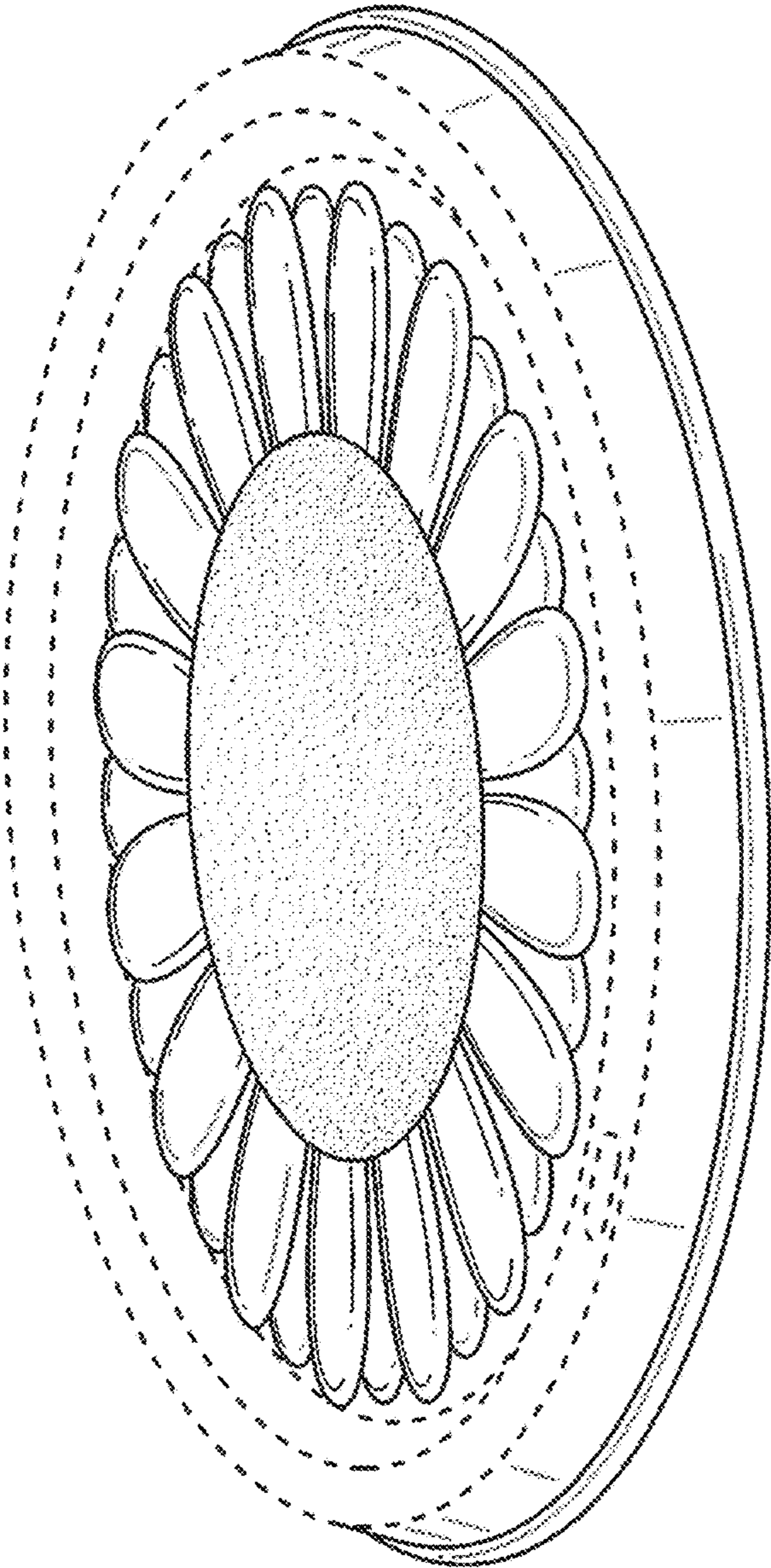
The ornamental design for a sunflower-style container lid, as shown and described.

**DESCRIPTION**

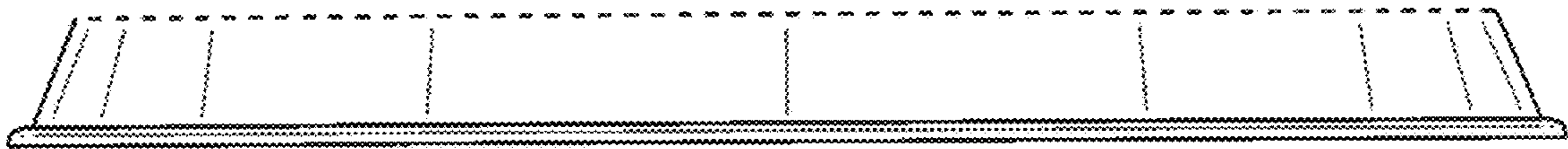

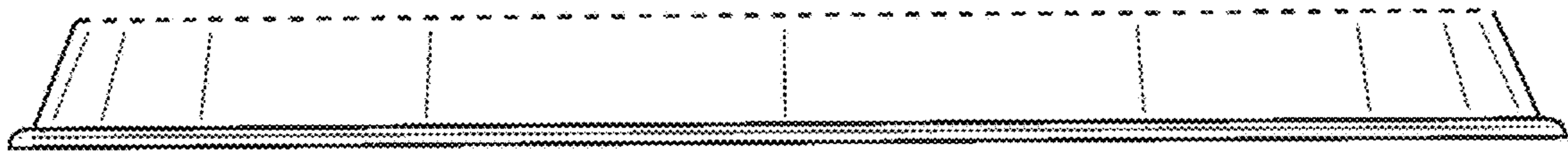




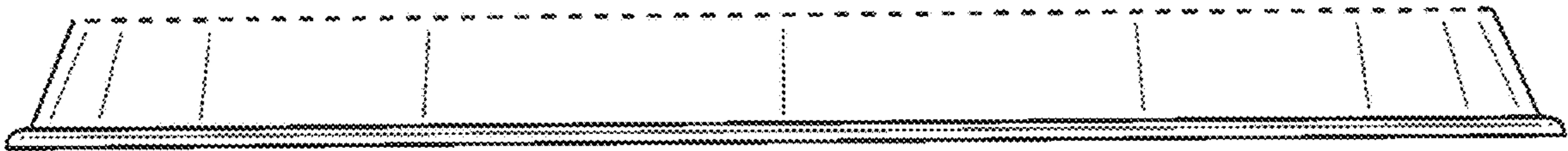

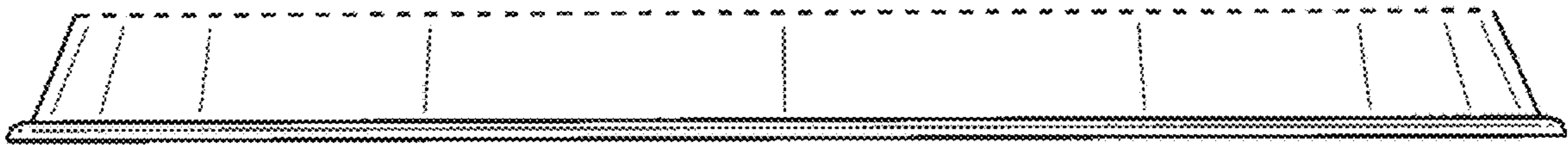

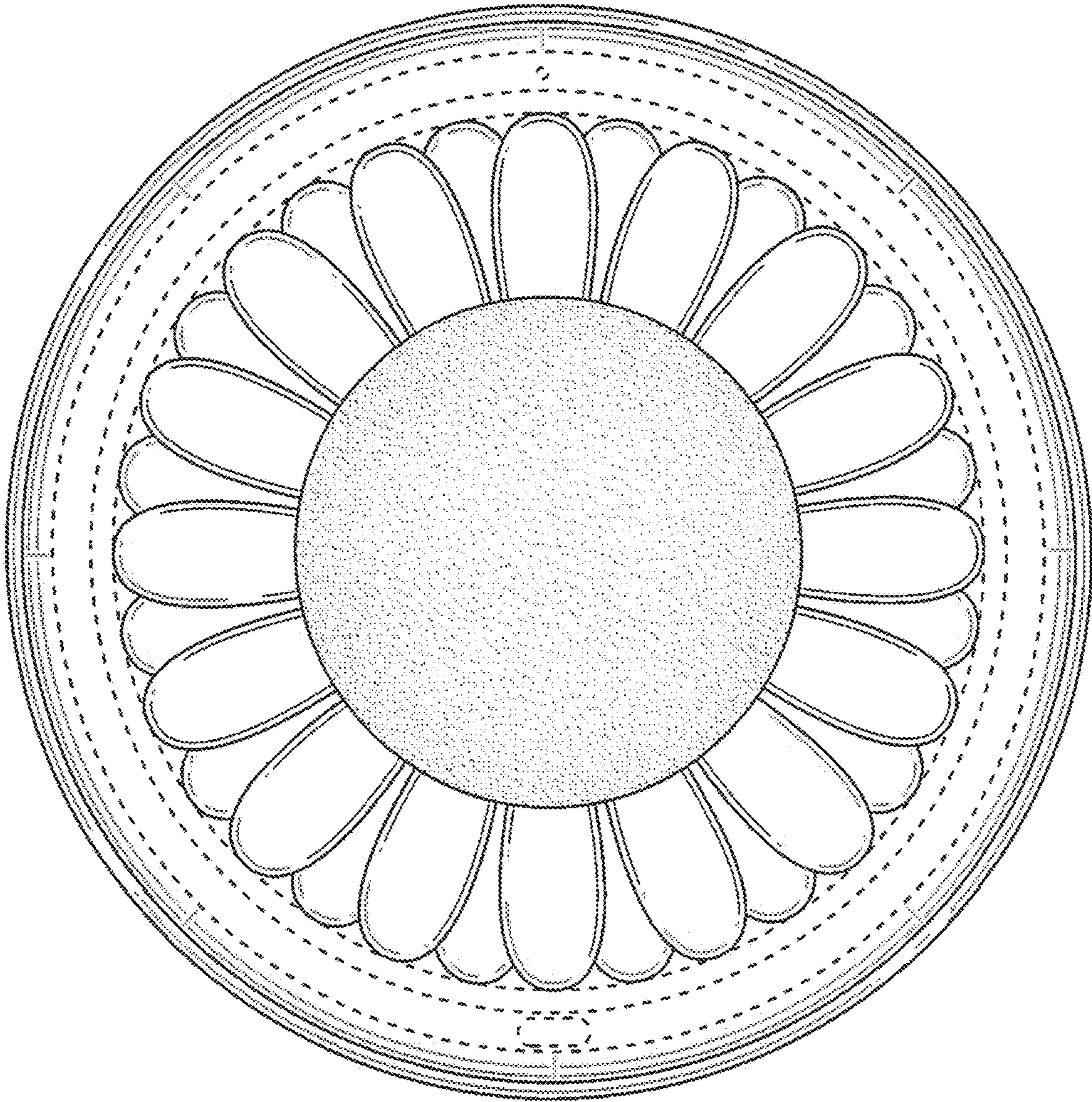

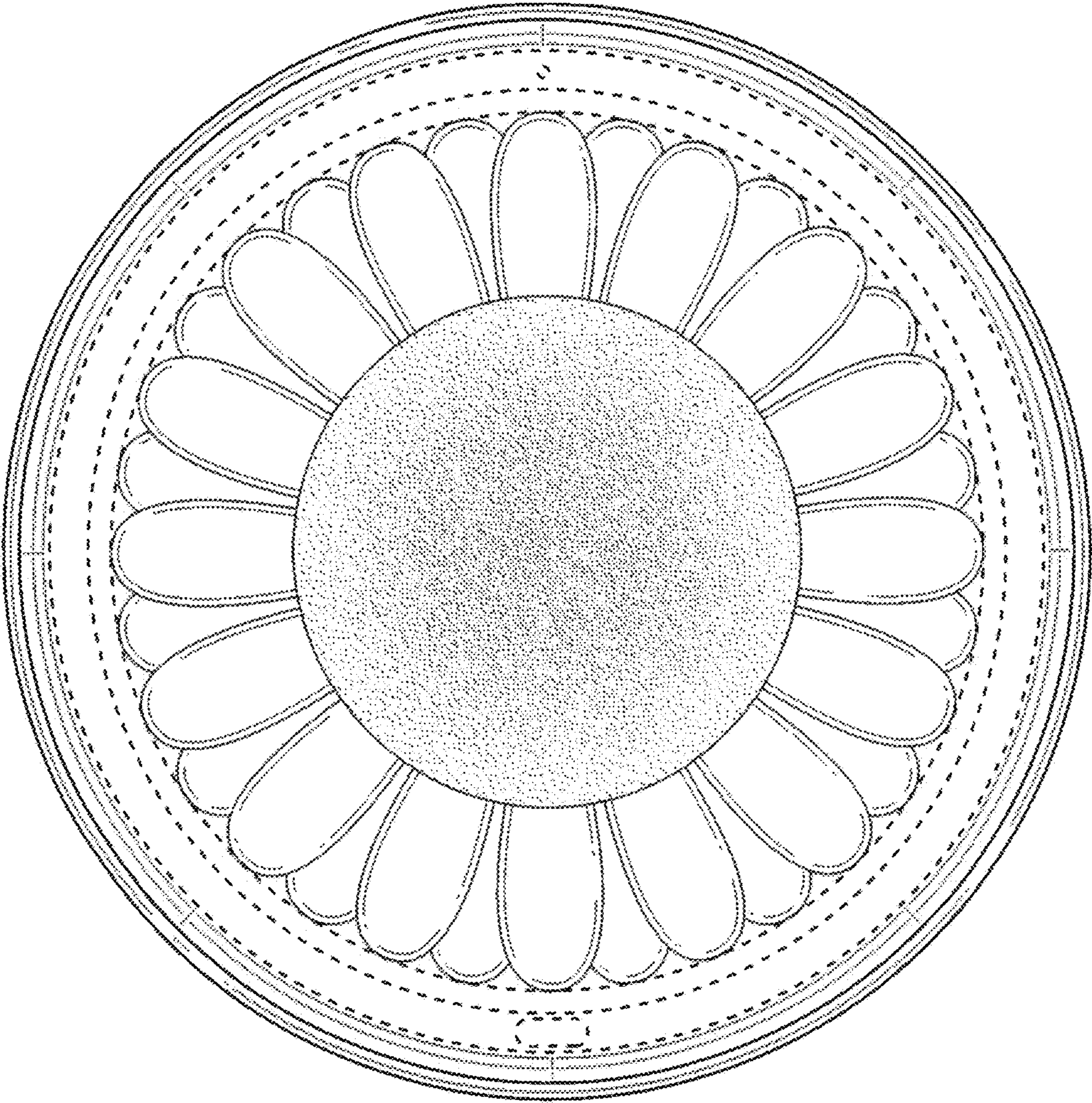
