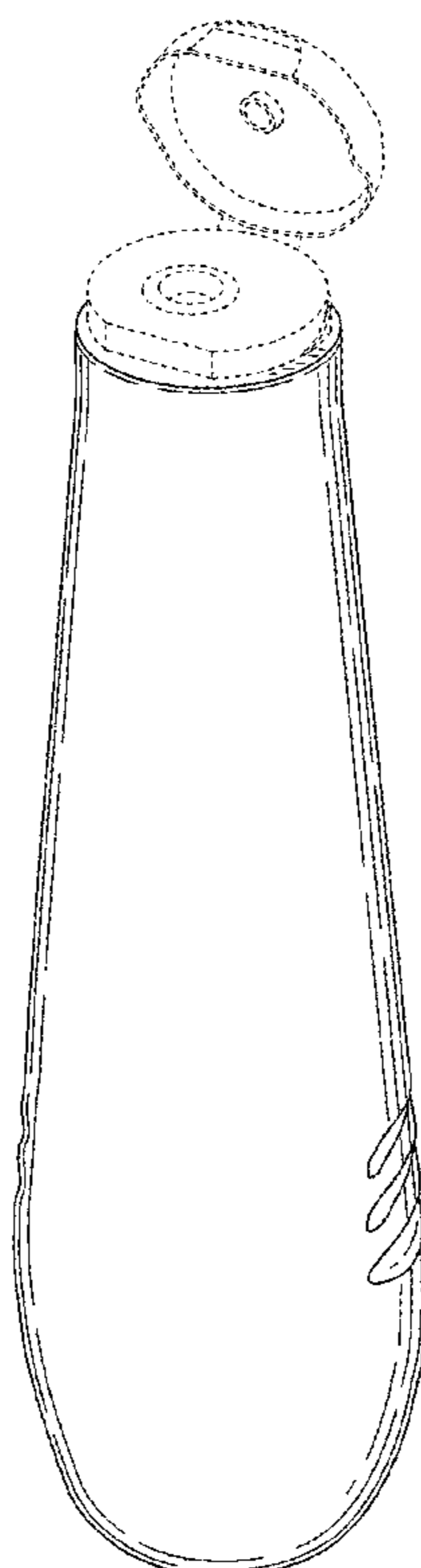

DESCRIPTION
FIG. 1 is a front perspective view of a bottle, showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;

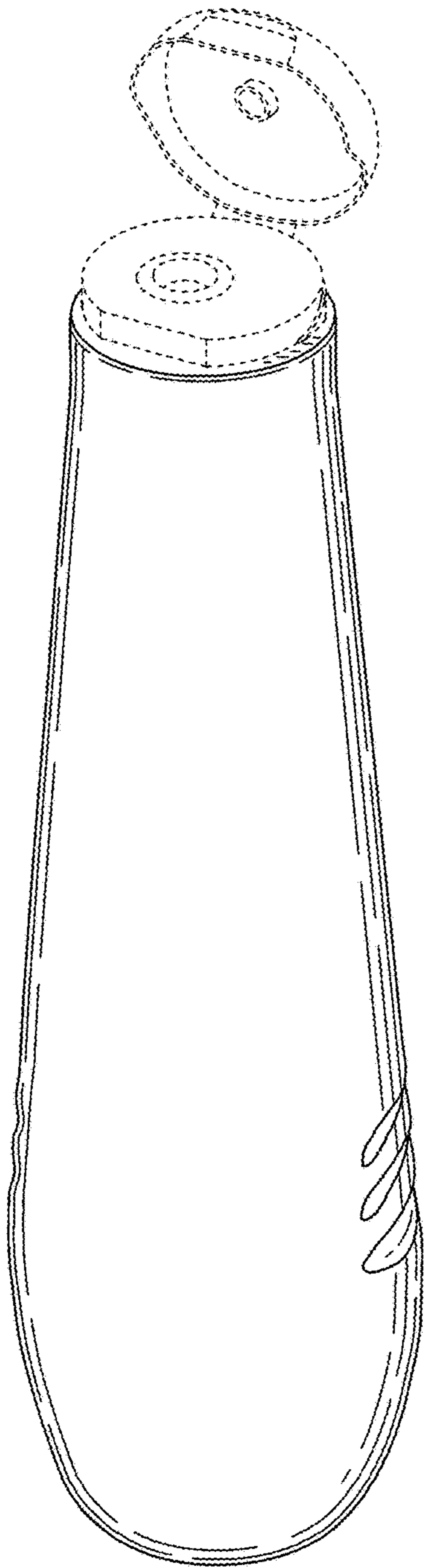

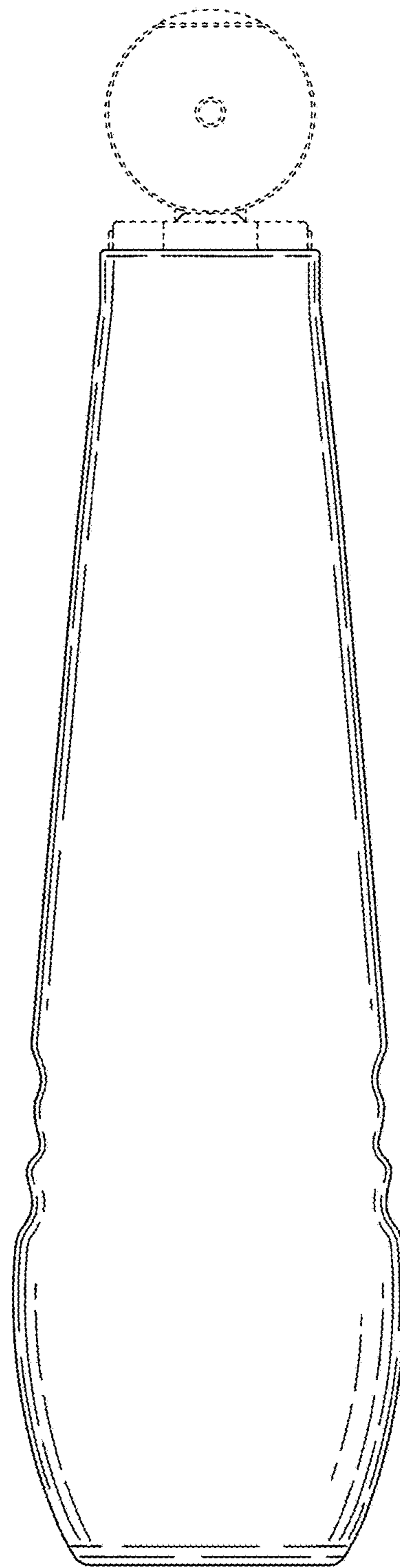

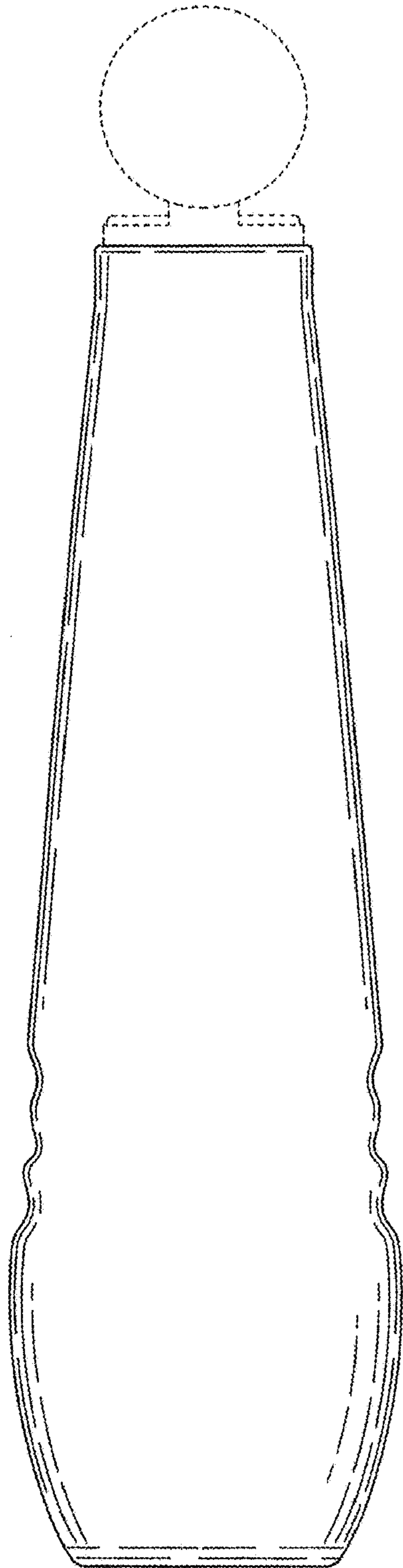

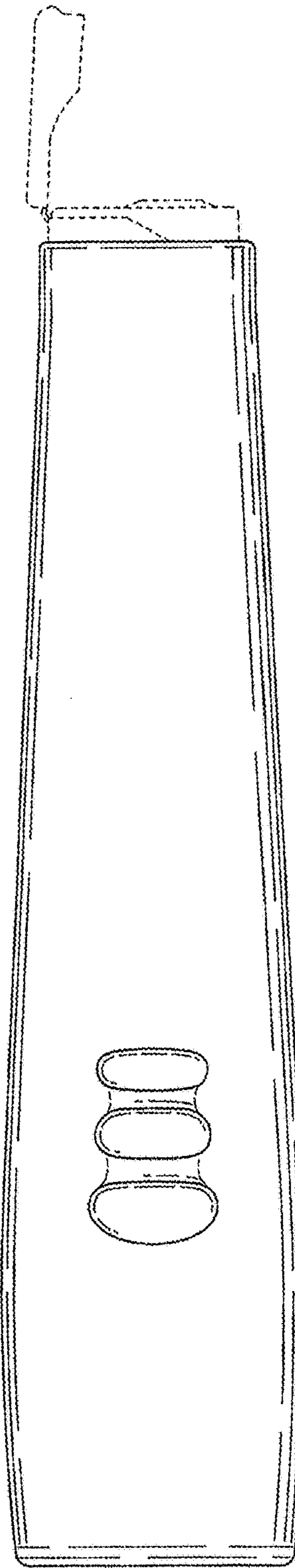

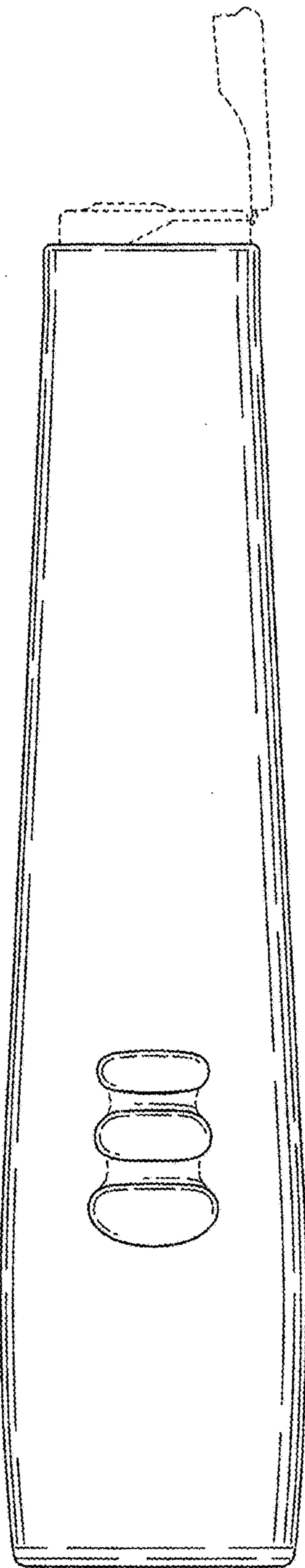

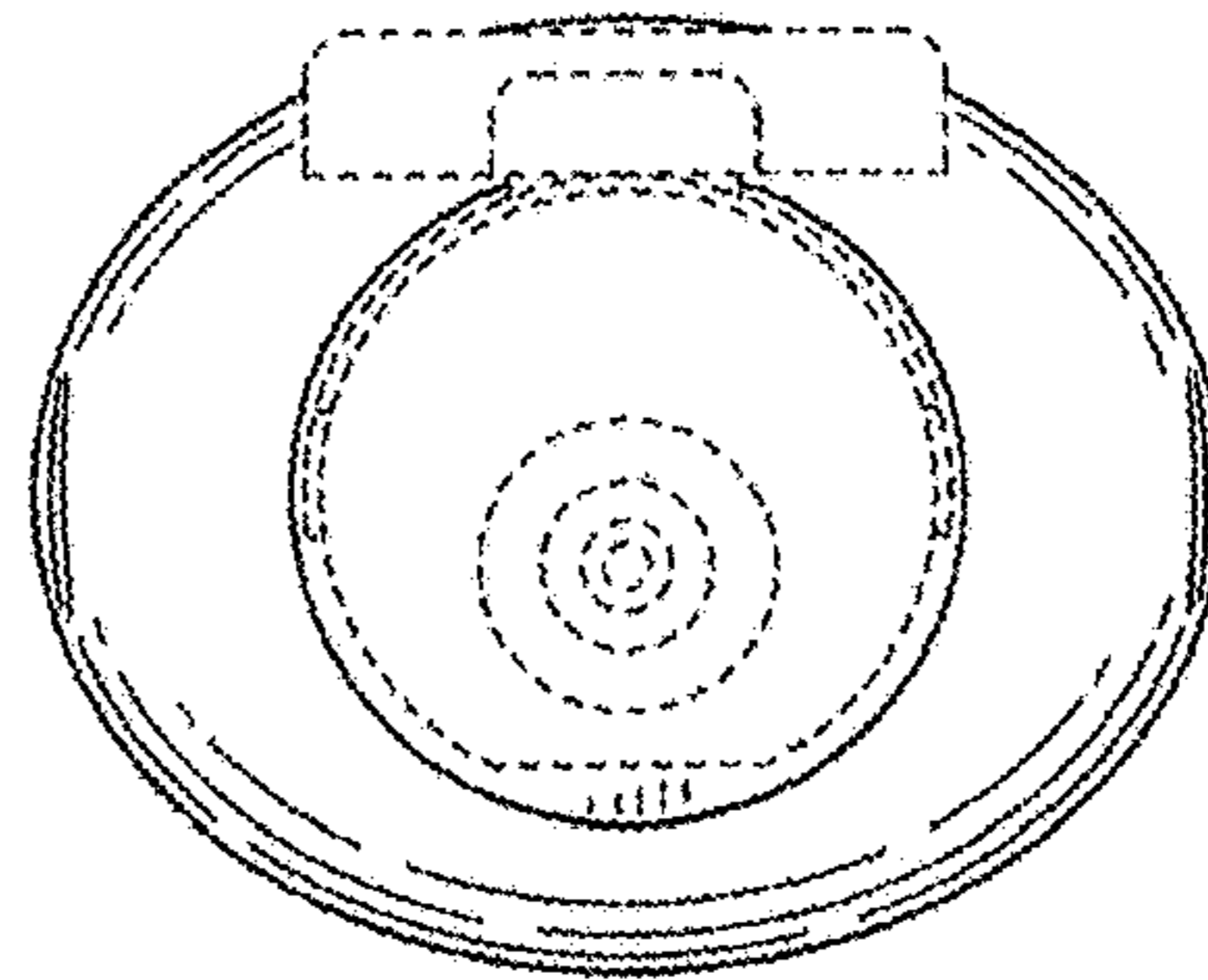

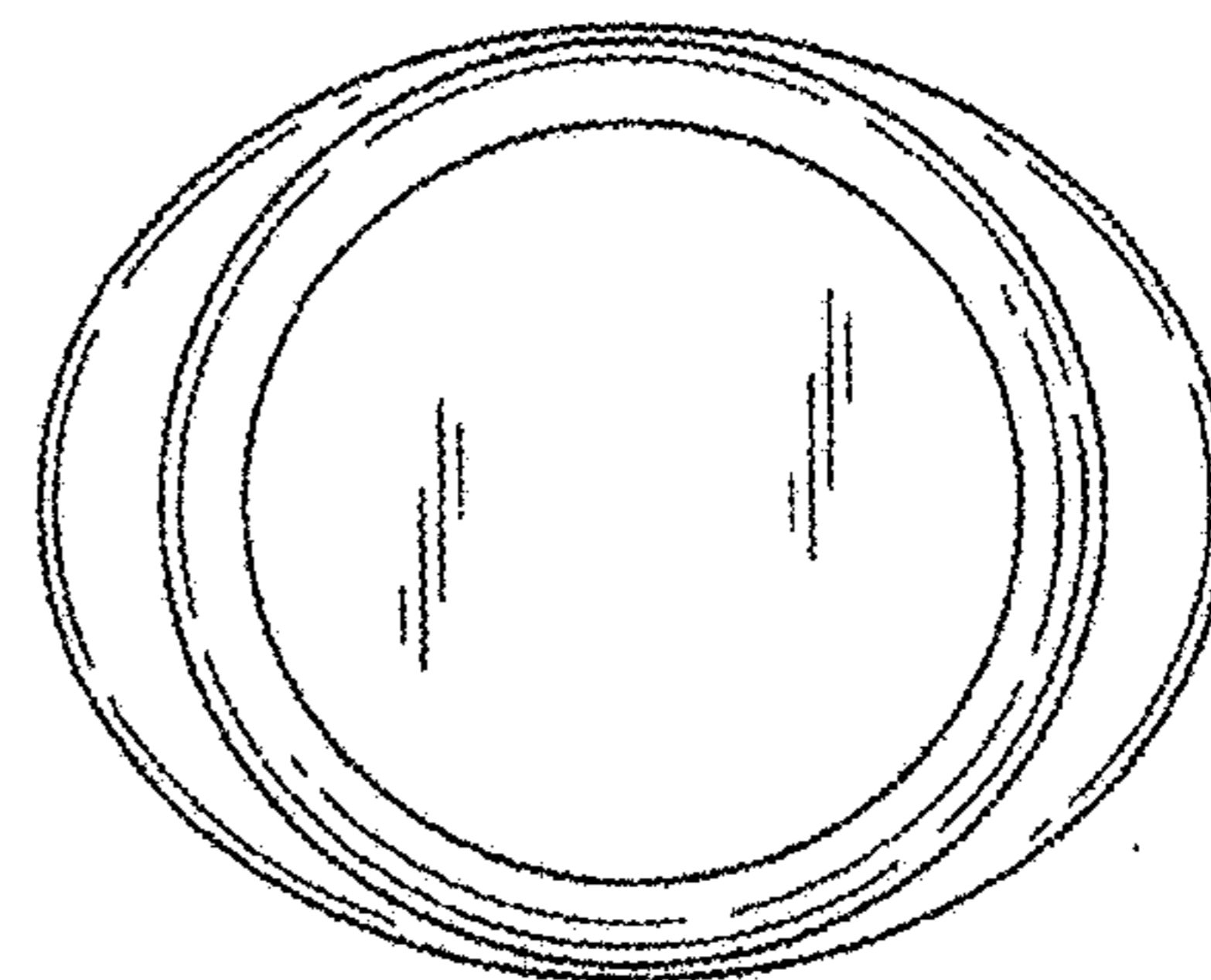
