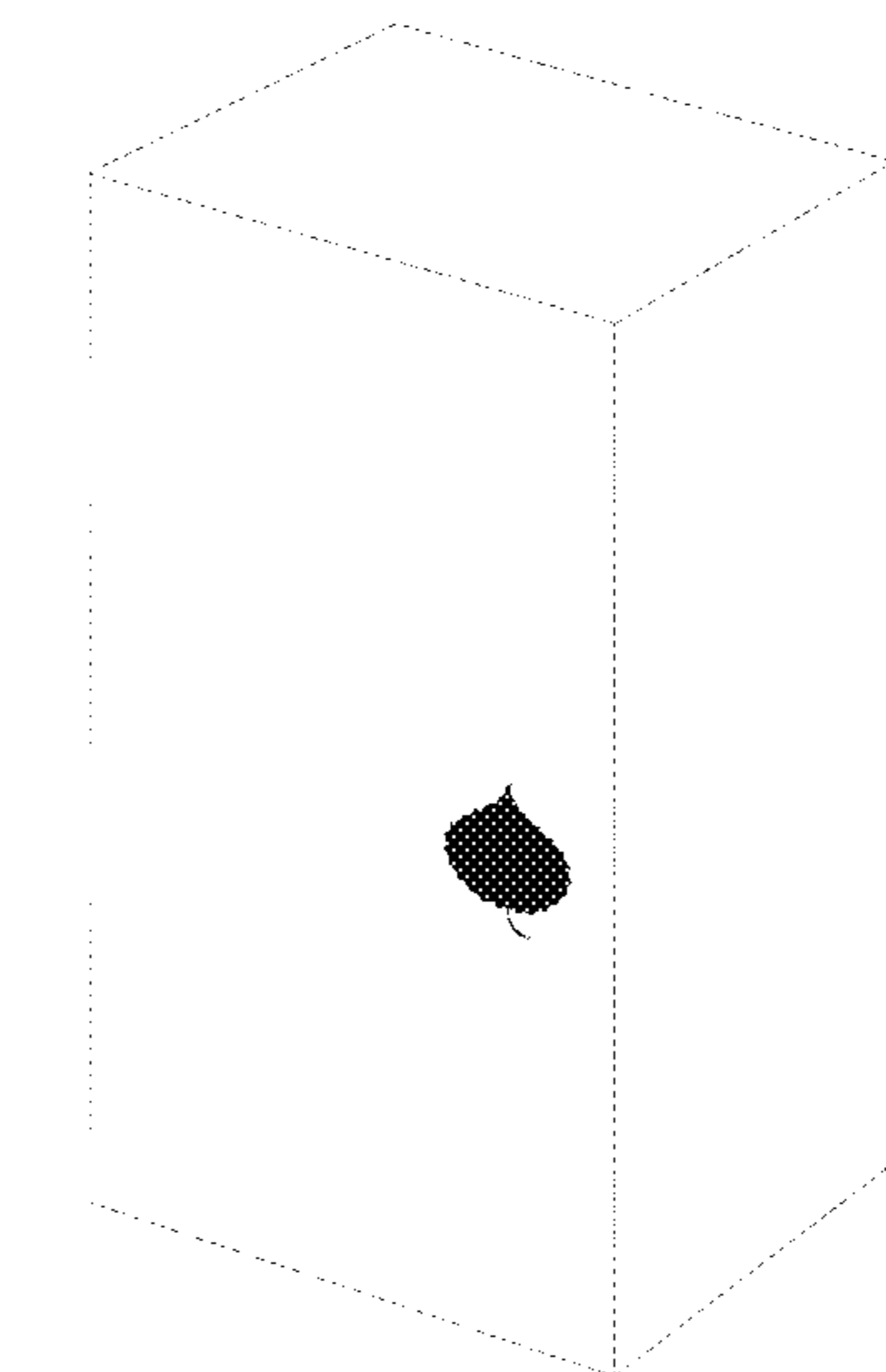
(57) **CLAIM**

The ornamental design for a dietary supplement package with surface ornamentation, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a dietary supplement package with surface ornamentation showing a new design; FIG. 2 is a front view of the new design; FIG. 3 is a right side view of the new design; FIG. 4 is a rear view of the new design; FIG. 5 is a left side view of the new design; FIG. 6 is a top view of the new design; and, FIG. 7 is a bottom view of the new design. 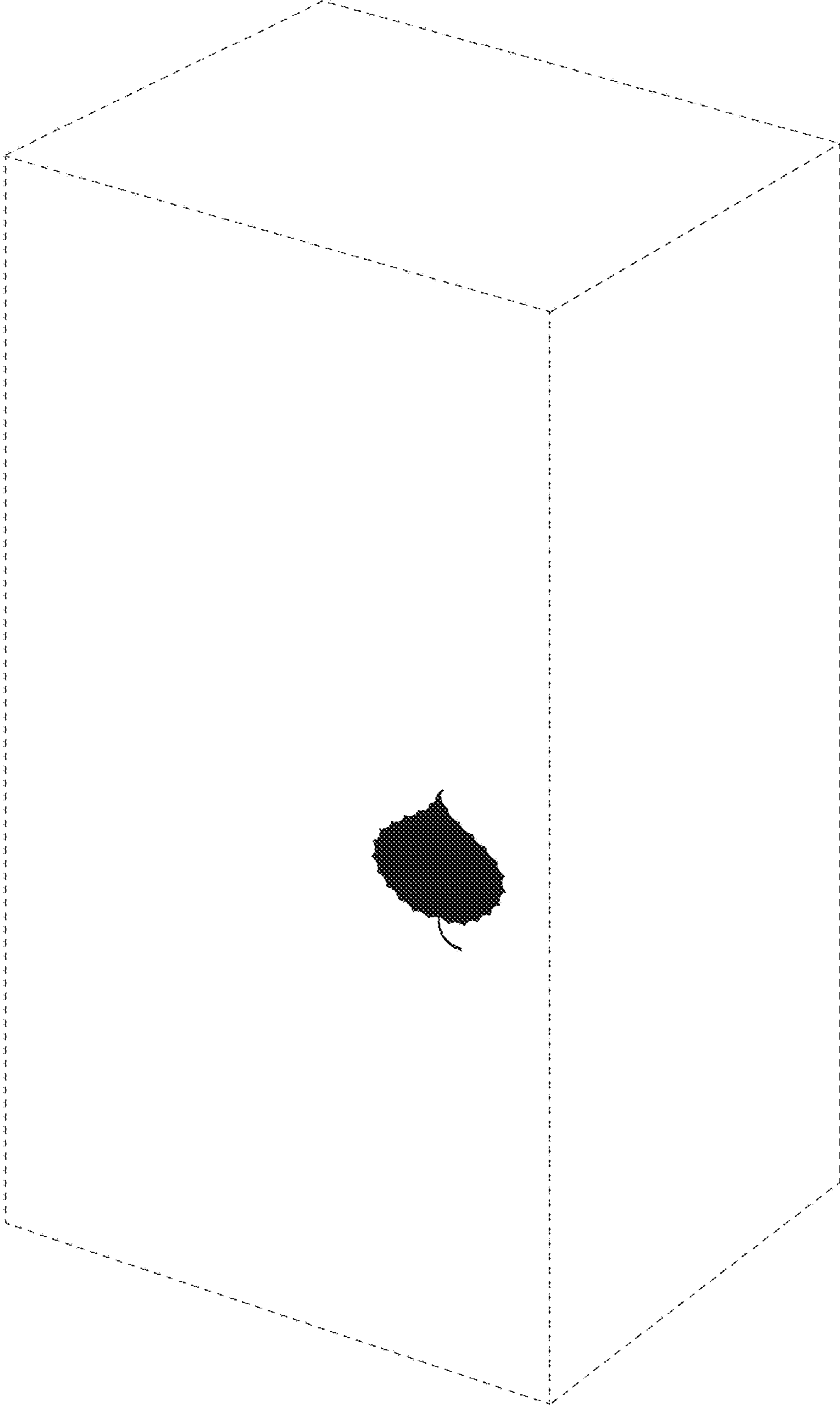

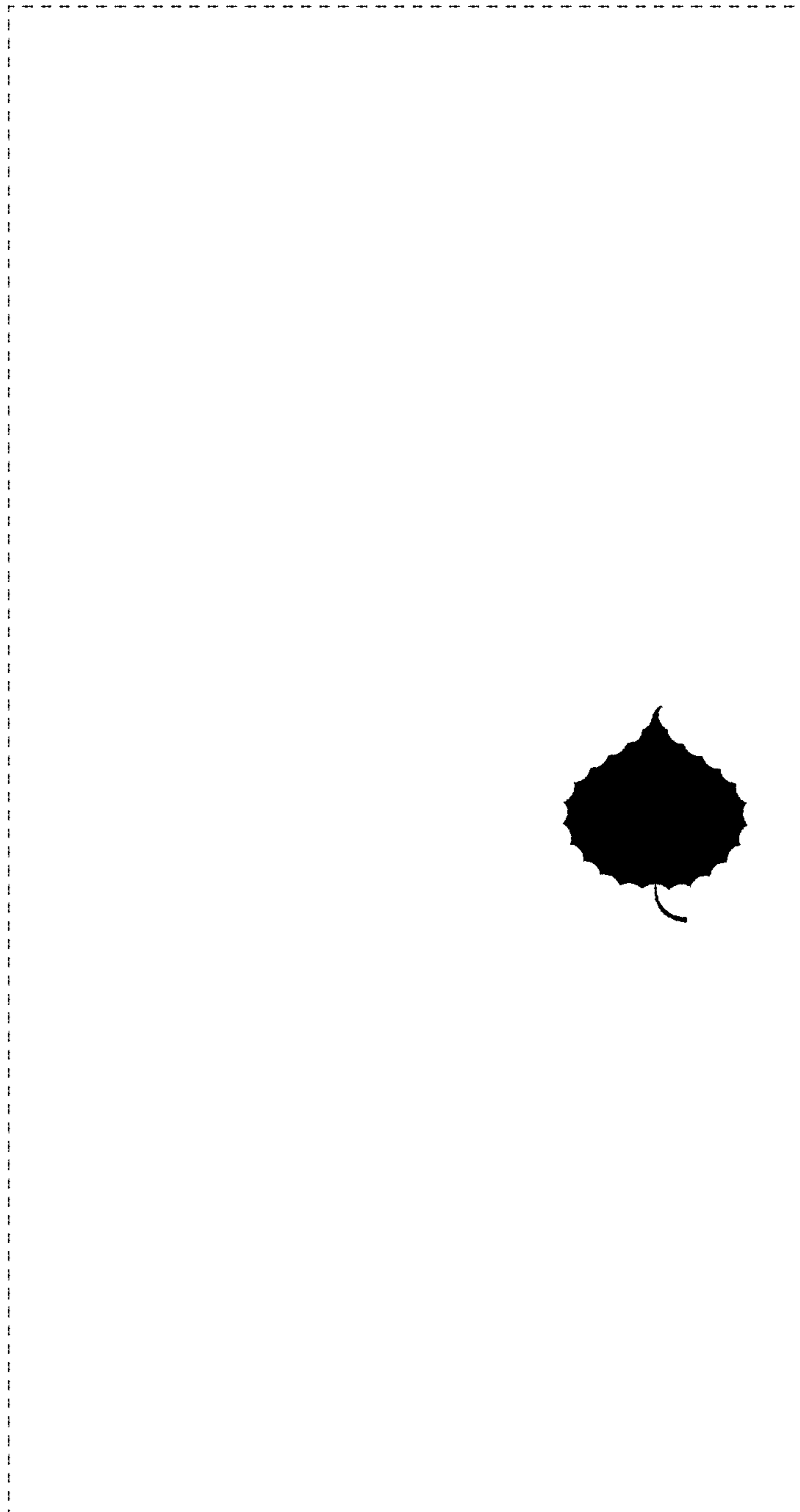

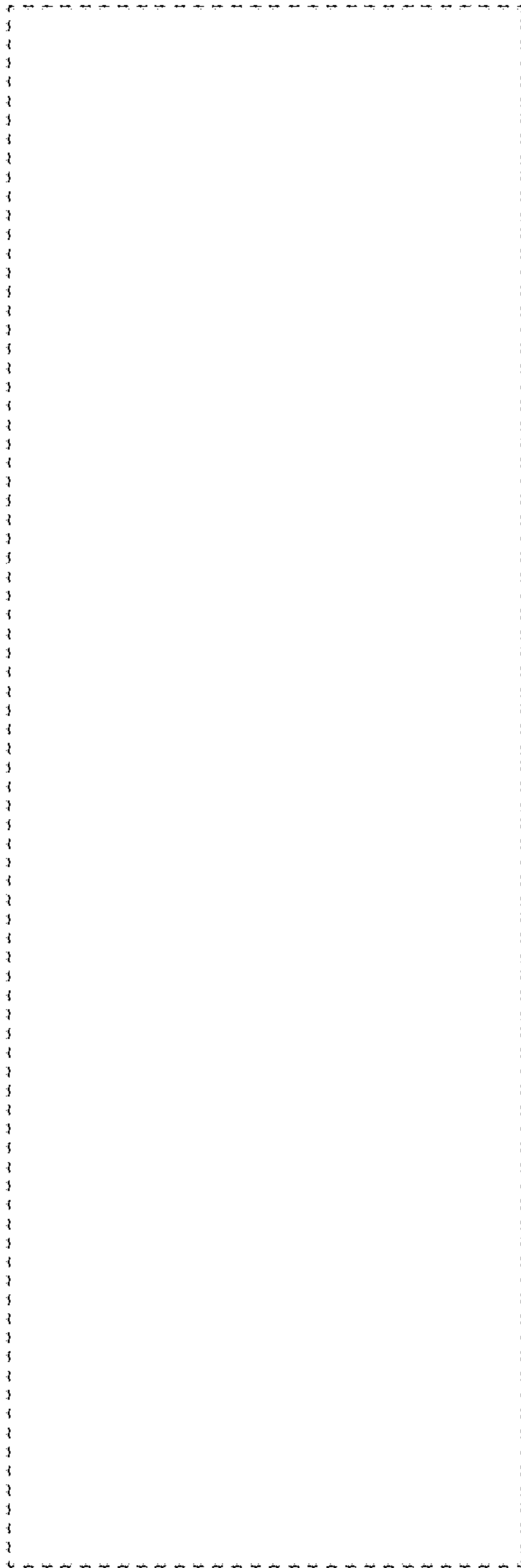

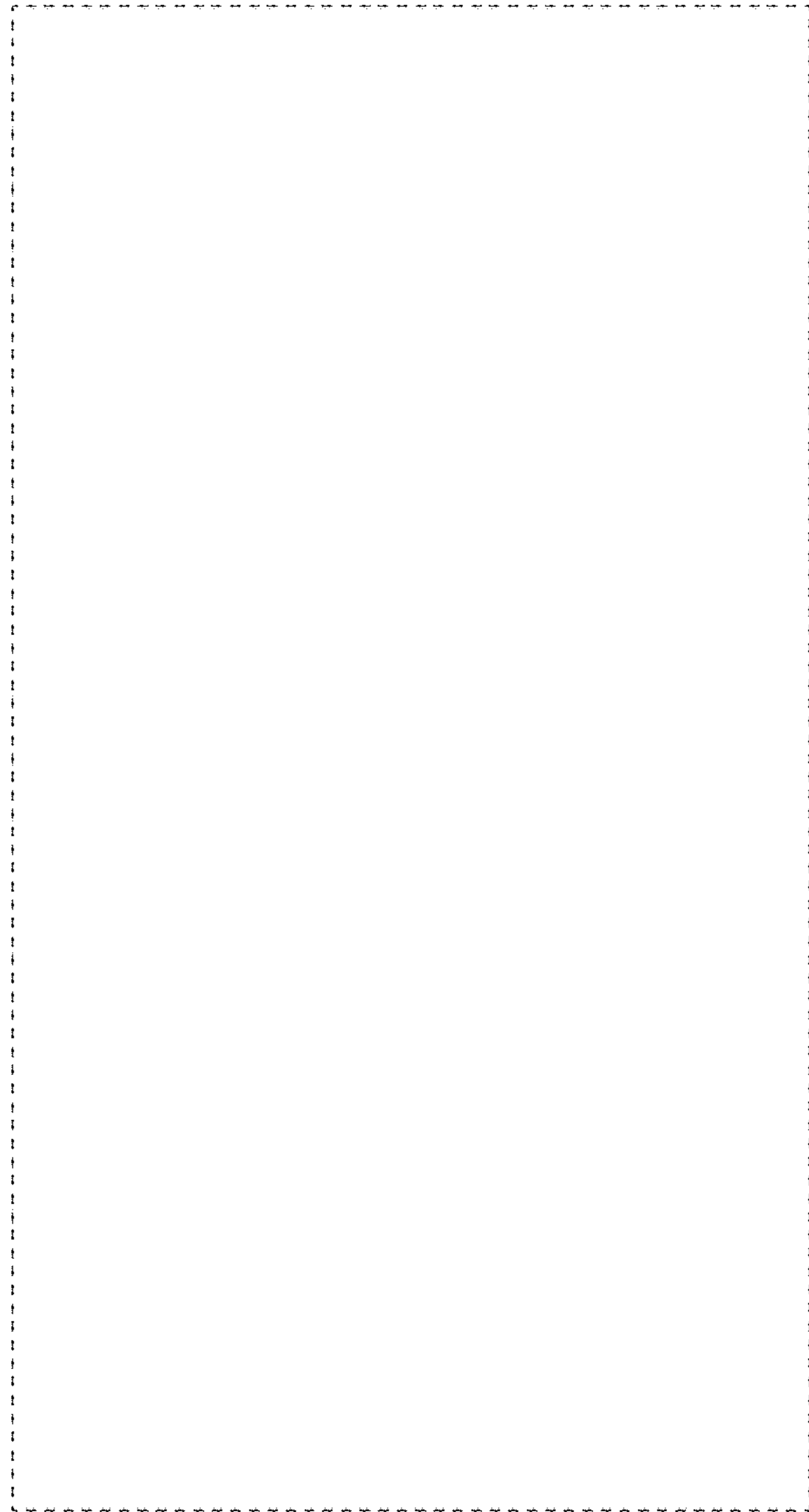

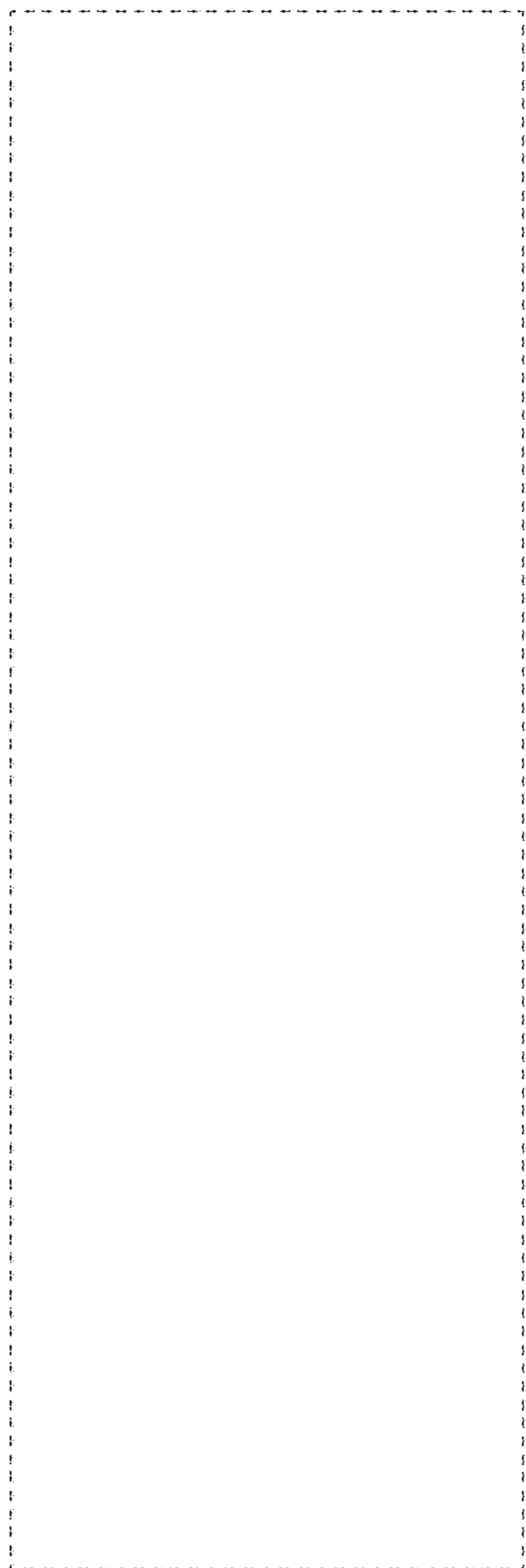
