The phantom lines shown in FIG. 2 illustrate portions of the clock that are seen through a transparent, window portion of the clock housing and form no part of the claimed design.

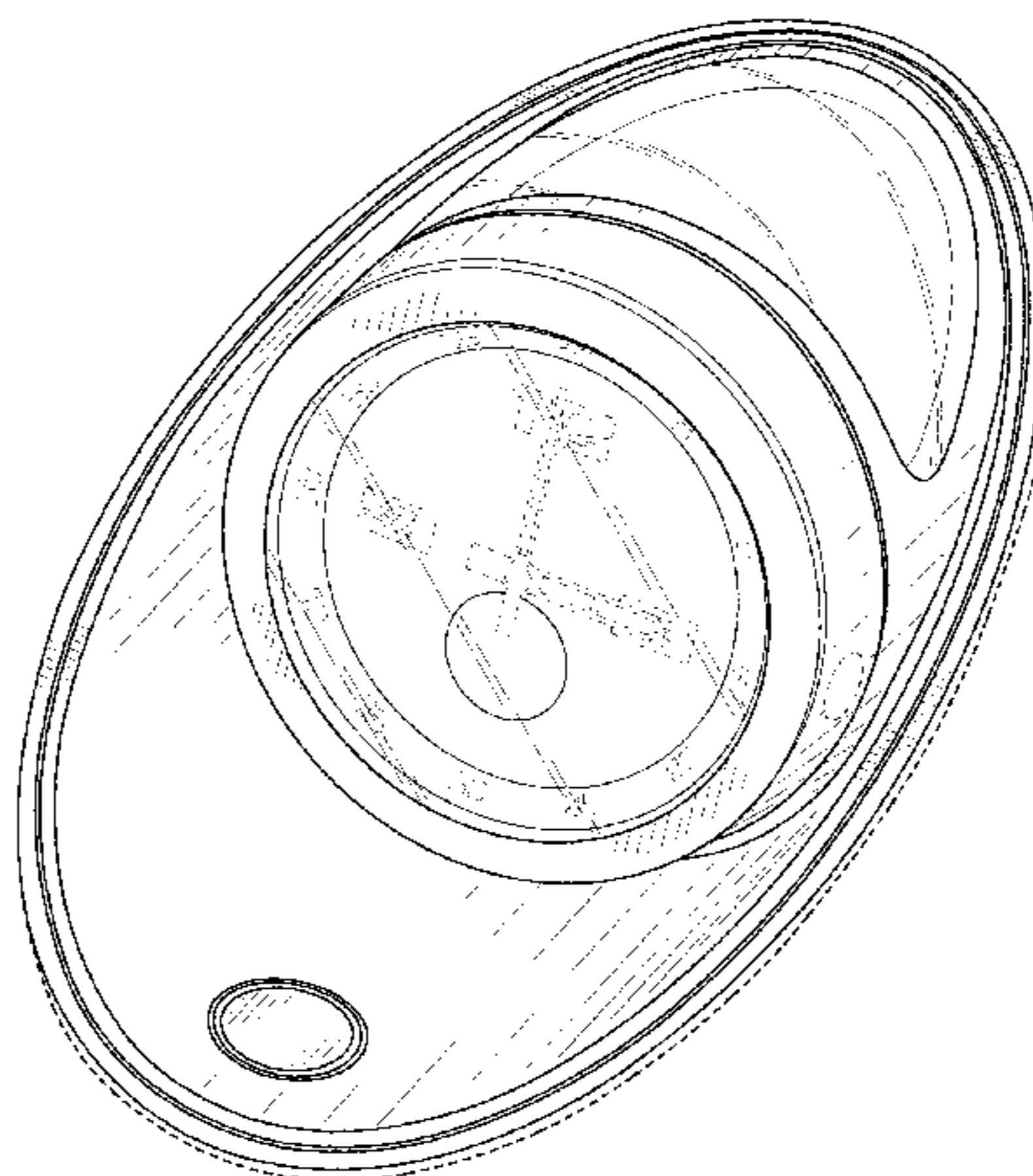

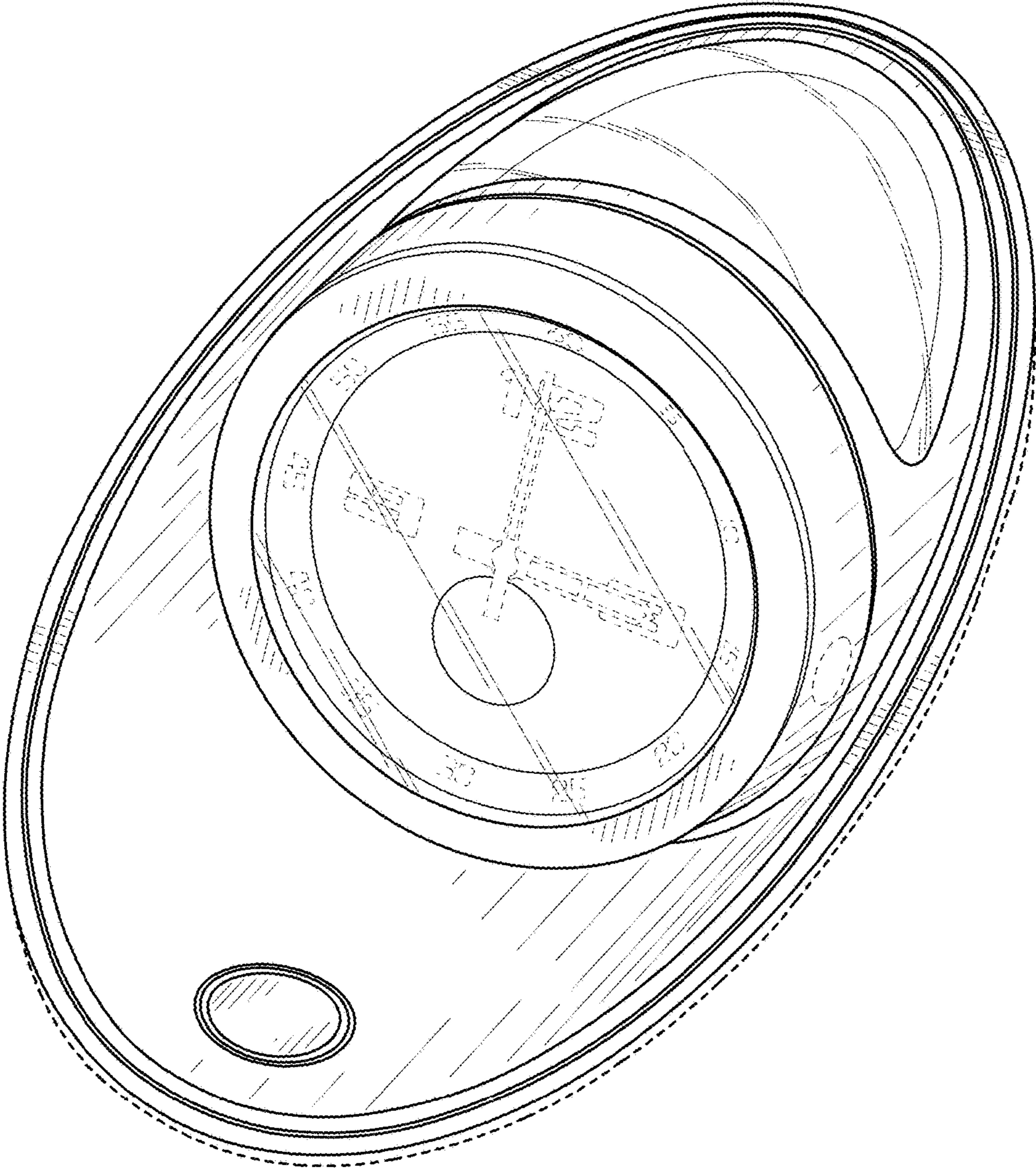

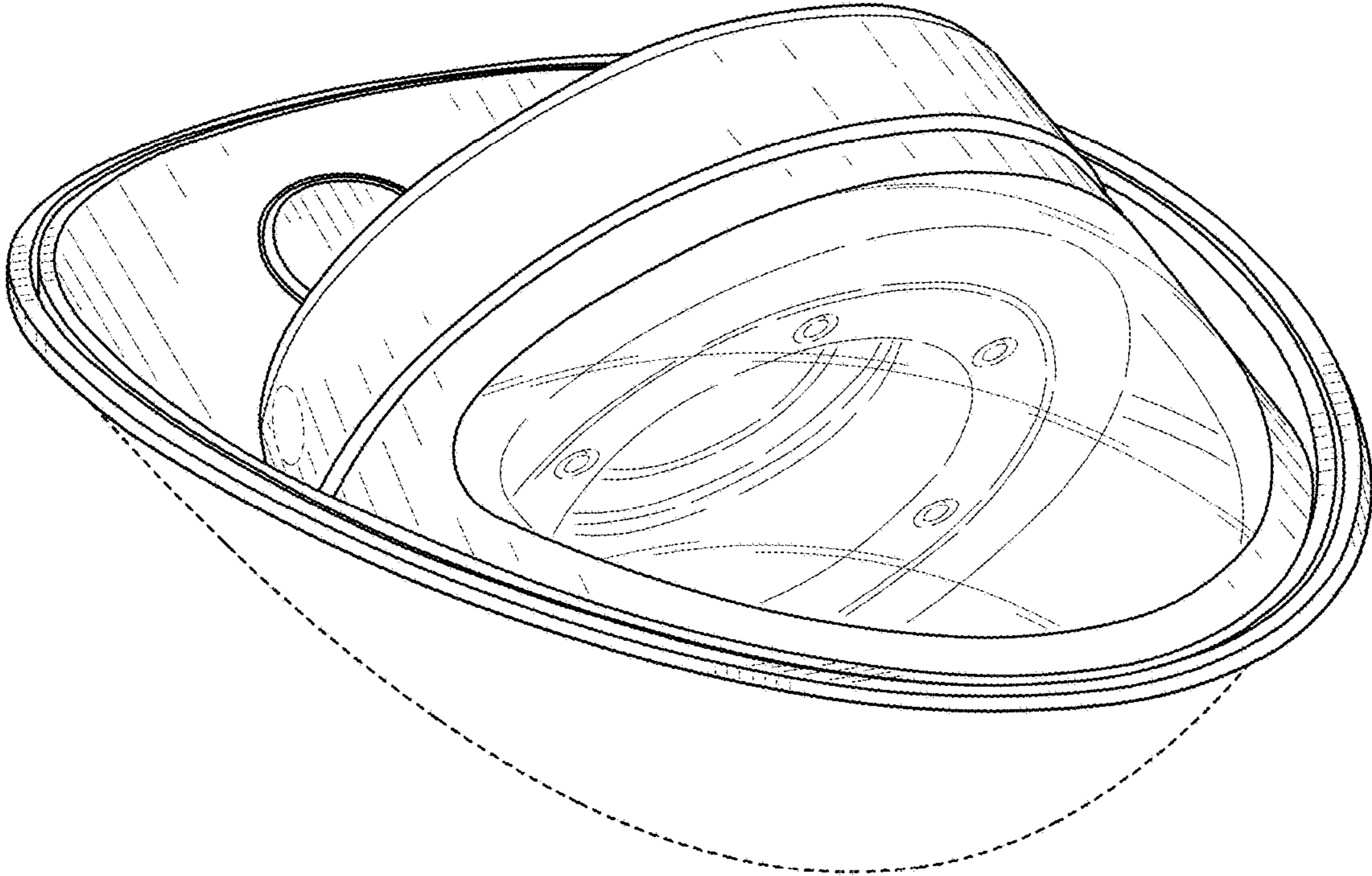

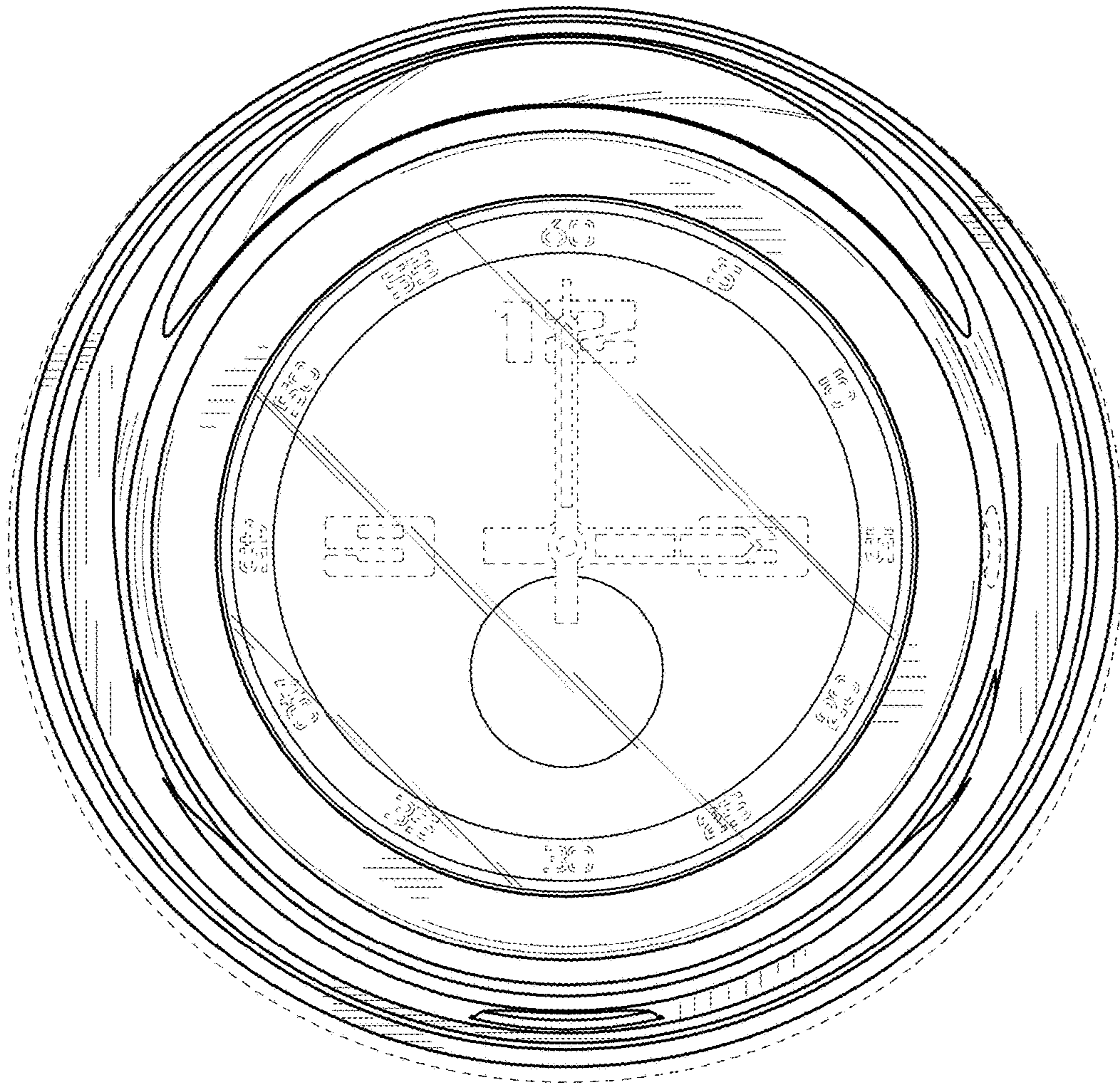

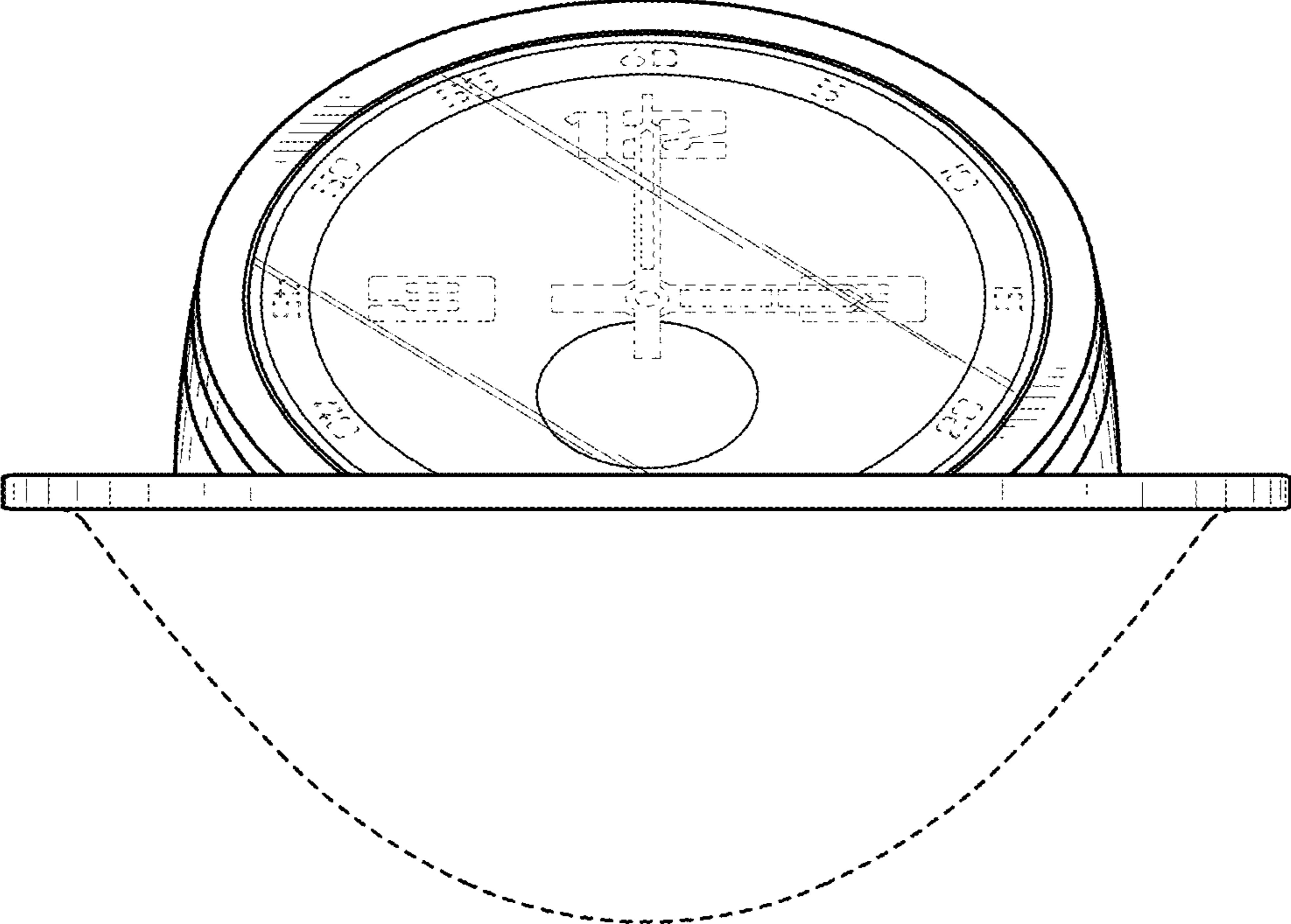

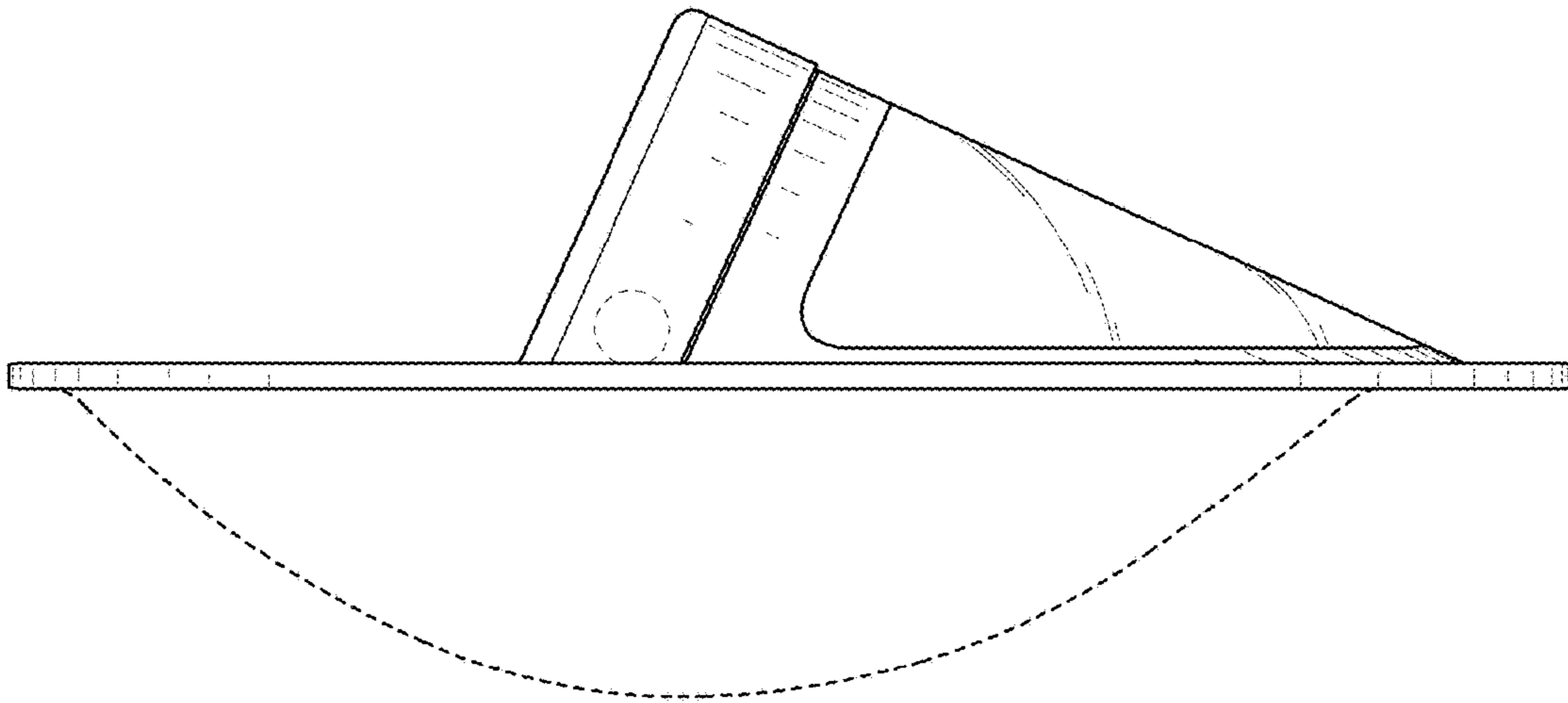

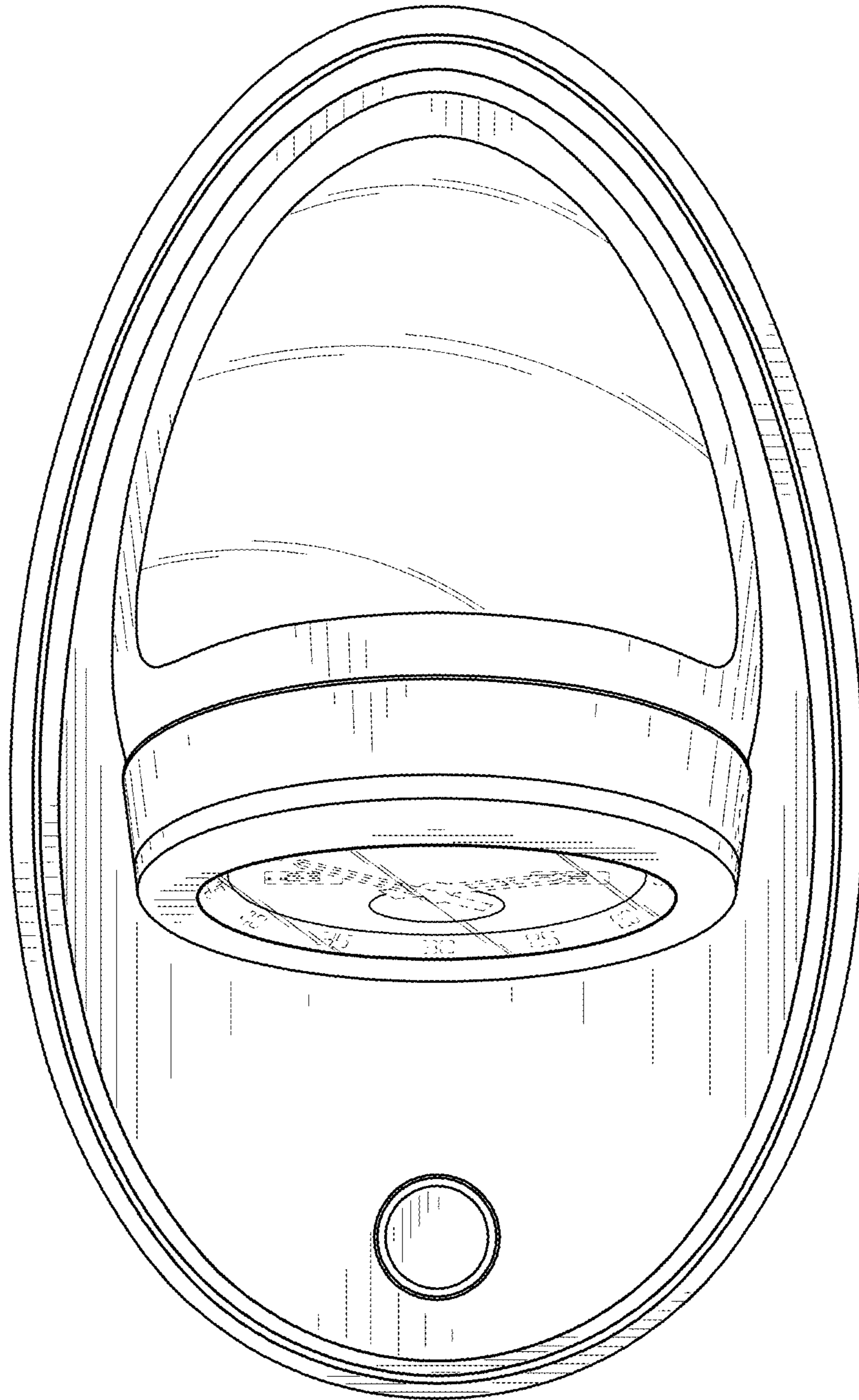
