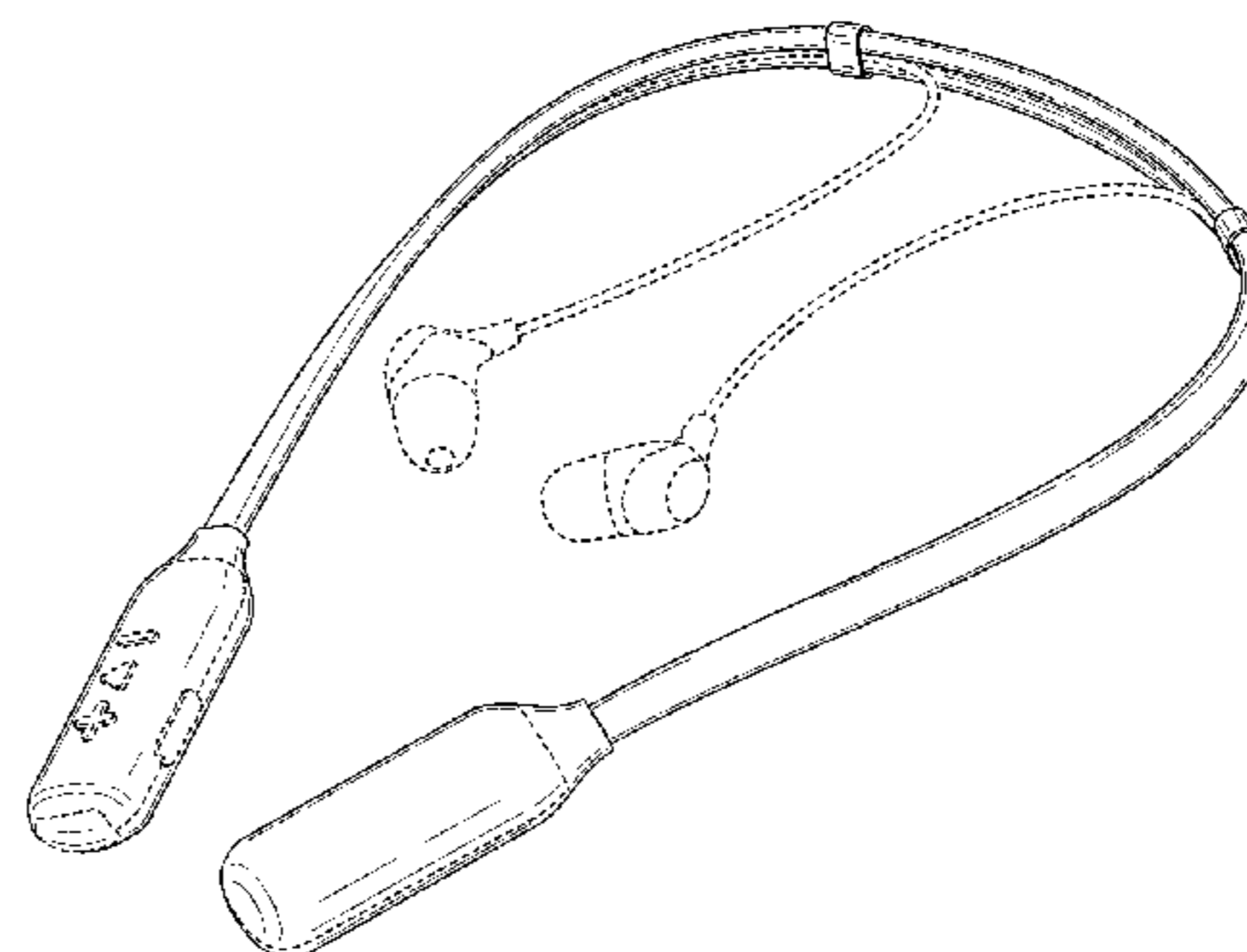
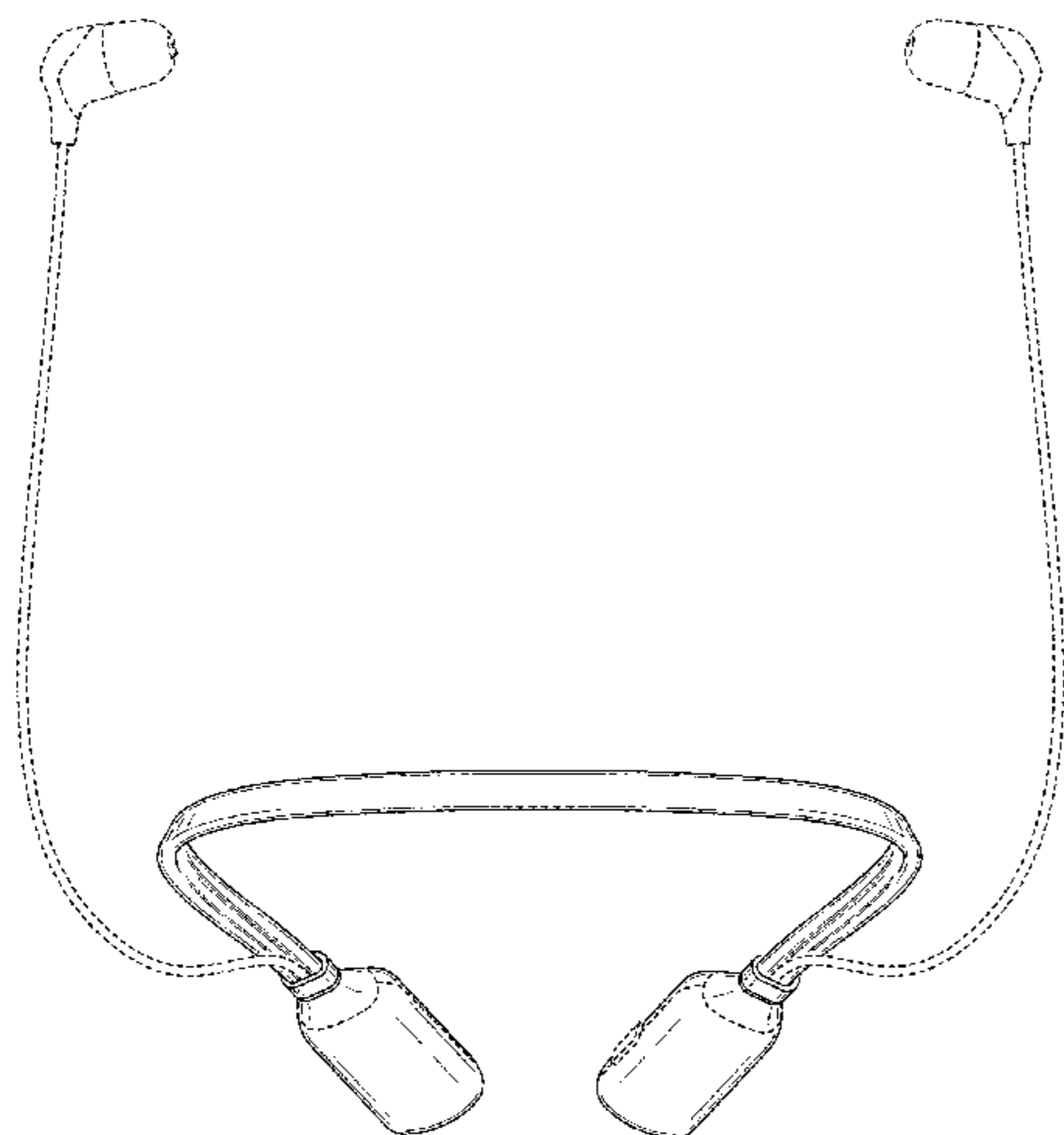
(57) **CLAIM**

The ornamental design for an earphone, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of an earphone showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a Rear elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a left side elevational view thereof; and, FIG. 8 is another perspective view showing a state that the earphone cord is stored in a slit of the neckband. The broken lines immediately adjacent the shaded areas represent a structure that is not part of the claimed design to show environment in which the design is associated, and all other broken lines are also directed to environment and are for illustrative purposes only; all the broken lines form no part of the claimed design.

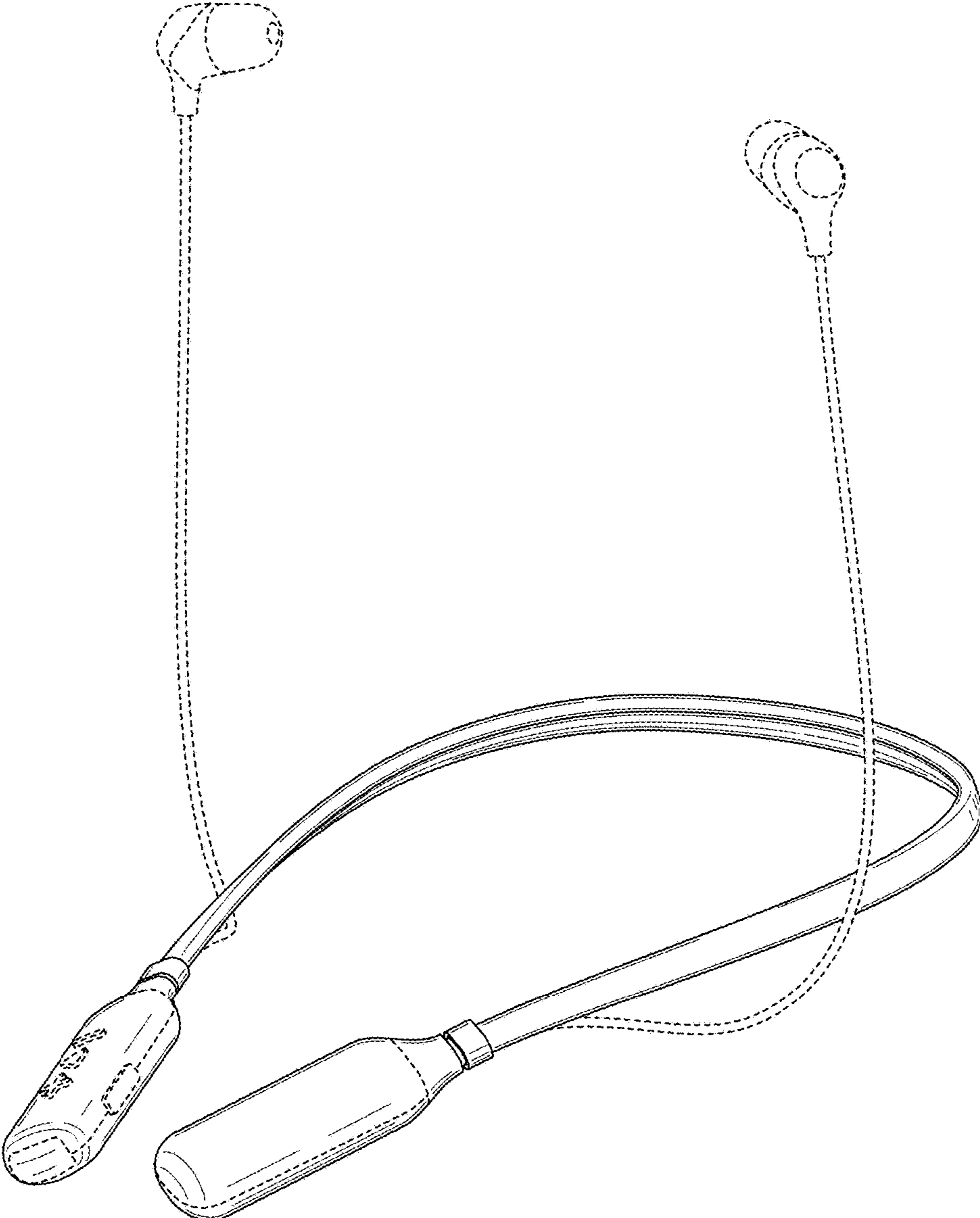

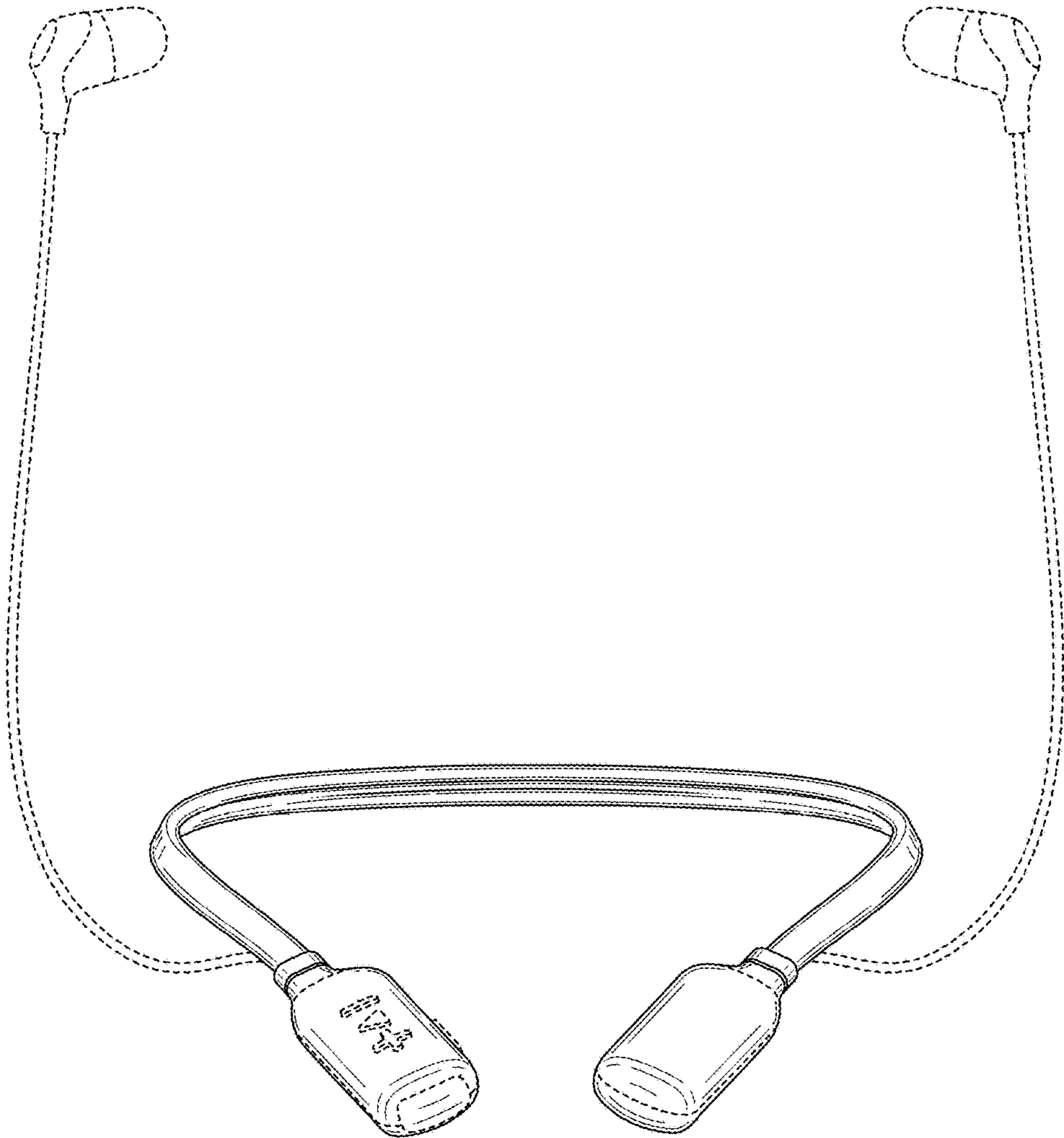

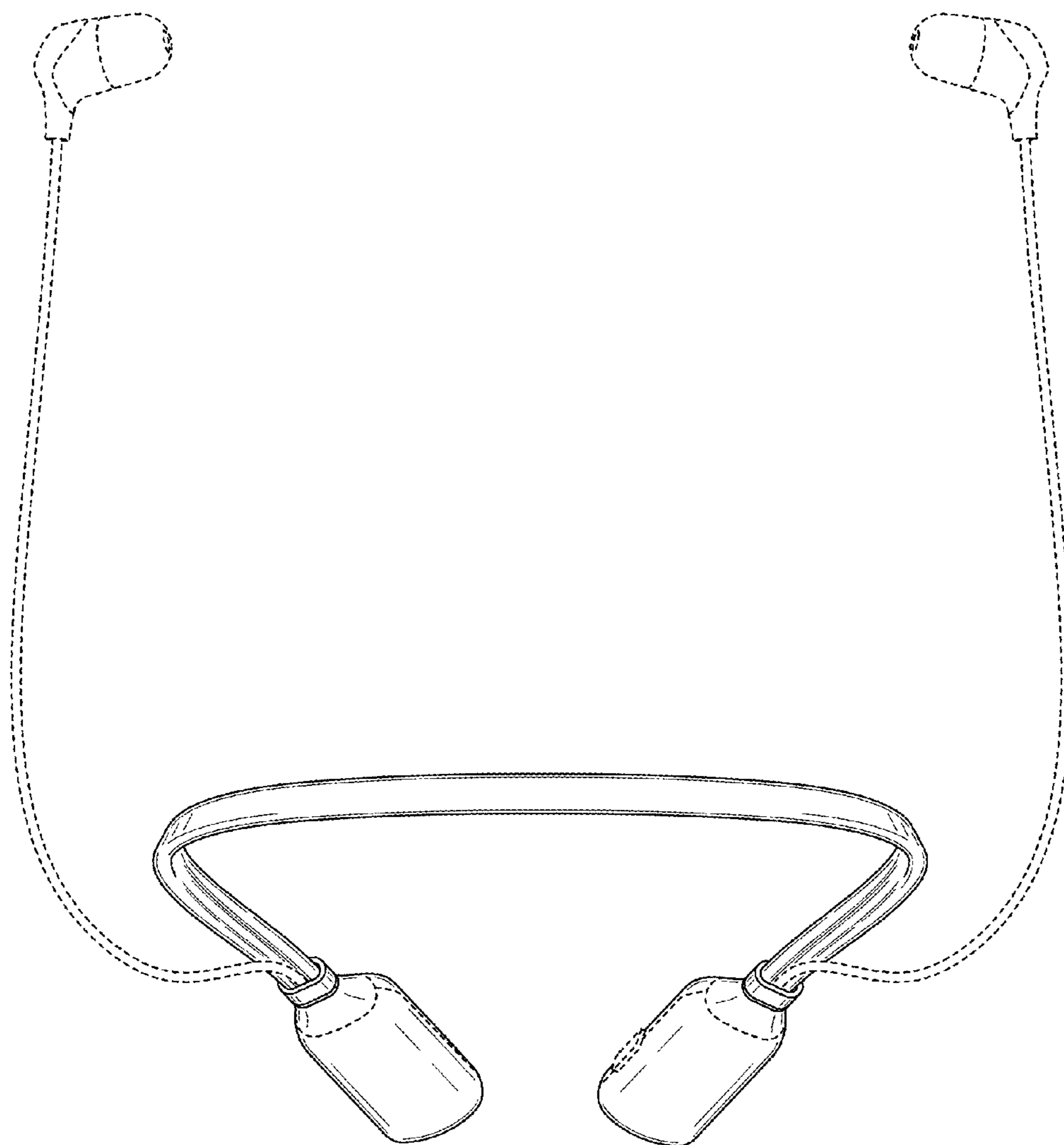

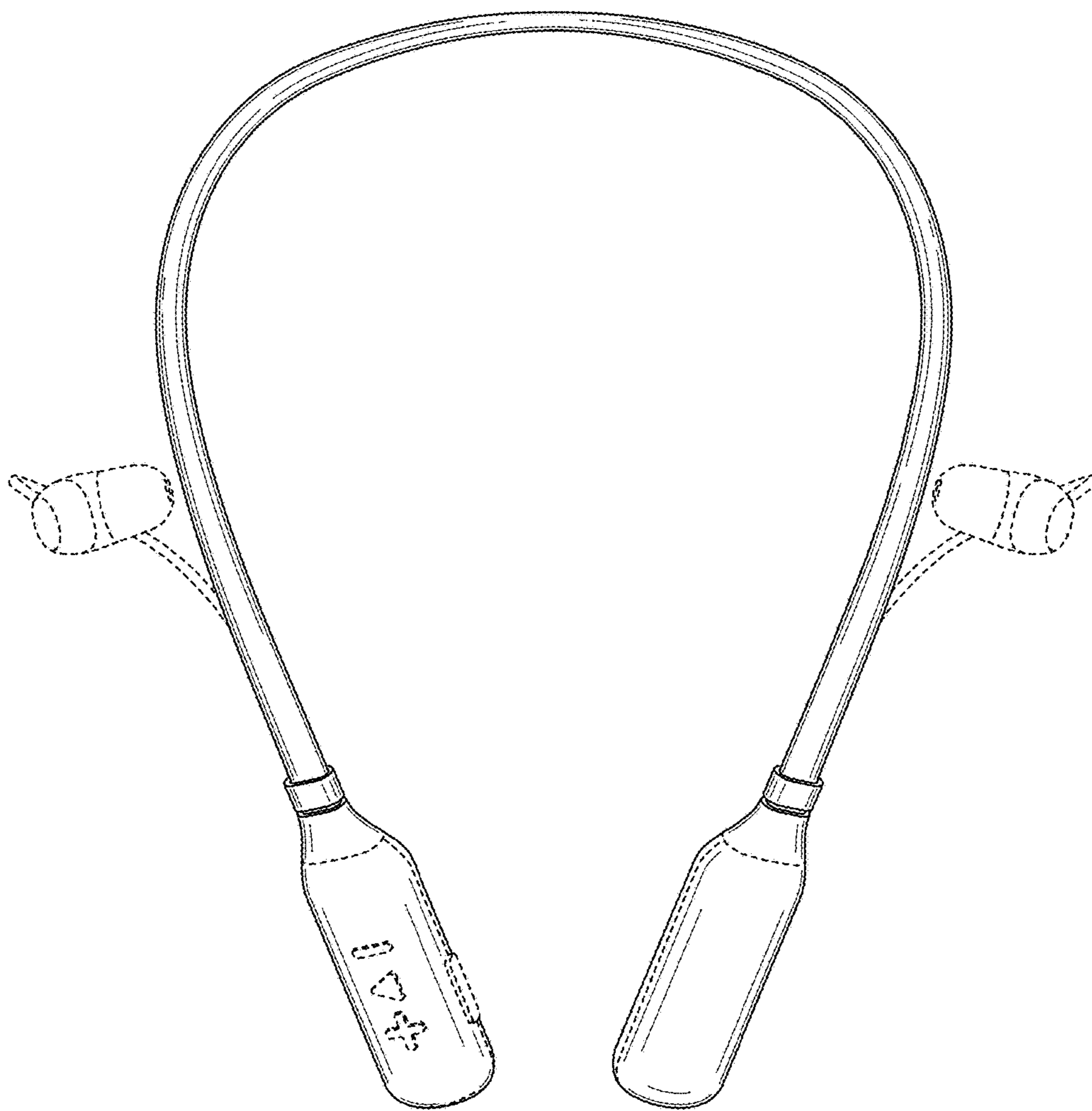

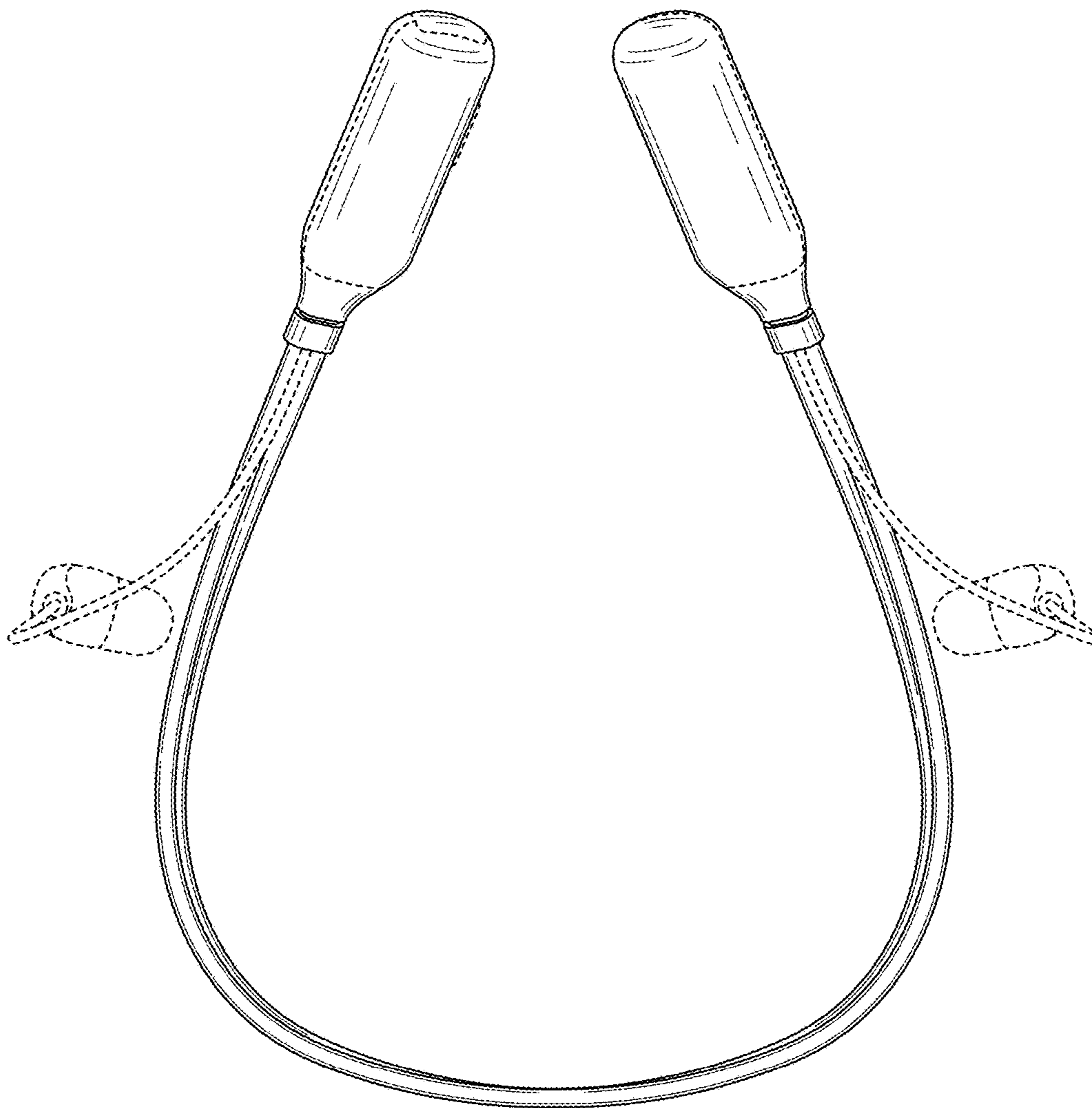

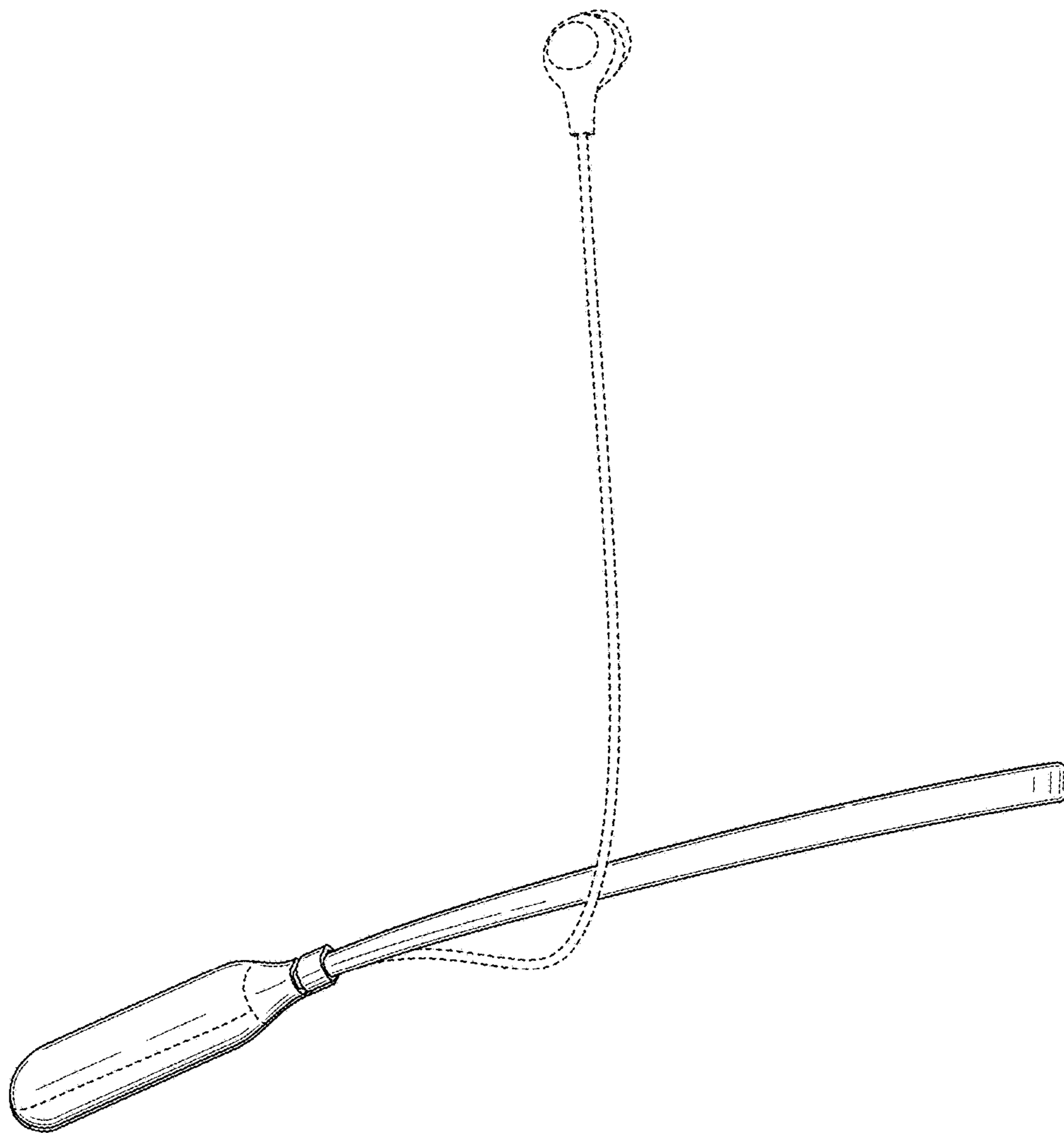

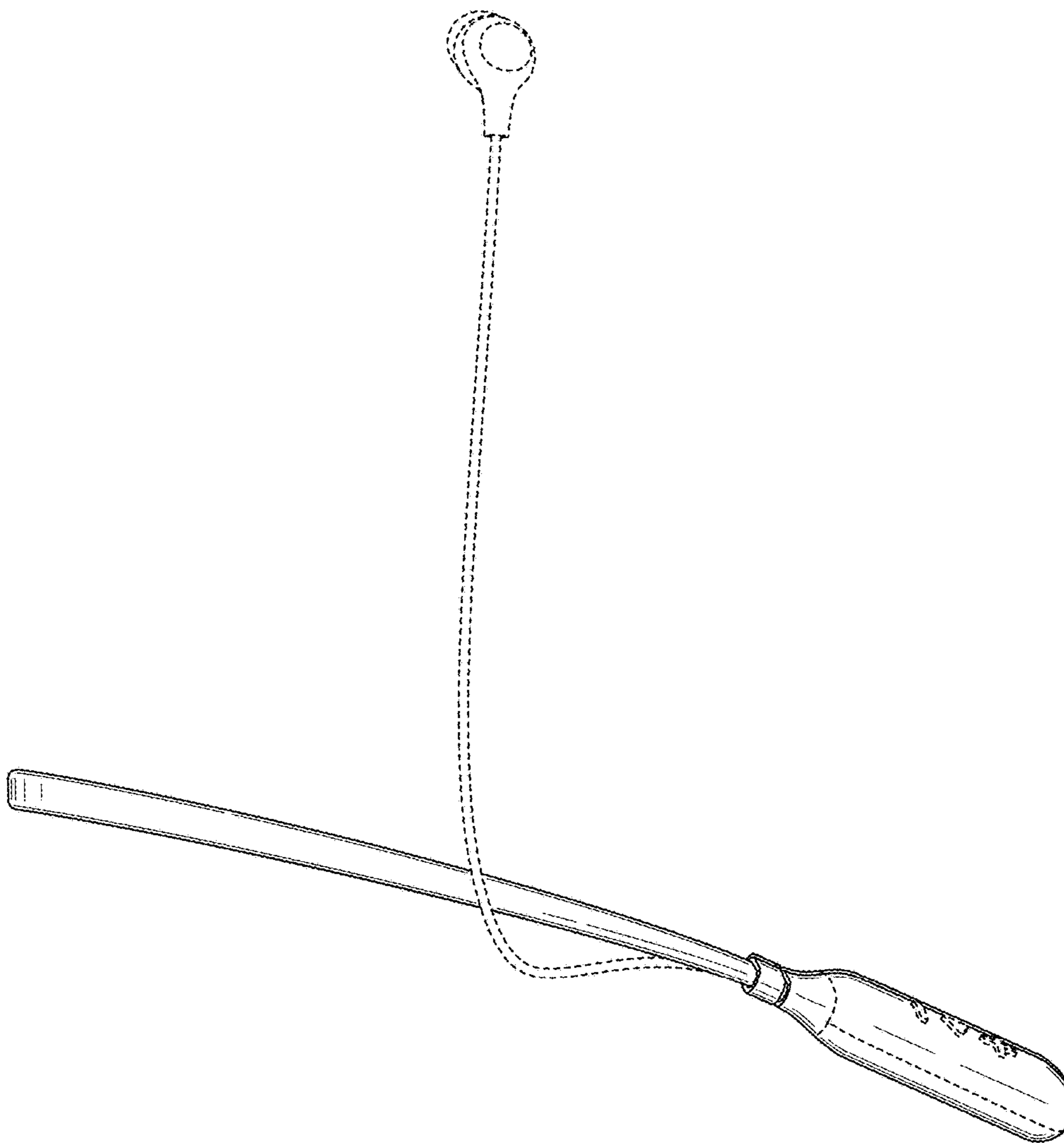
