The ornamental design for a display screen or portion thereof with a transitional icon, as shown and described.

**DESCRIPTION**

FIG. 16 is a front view of sixteenth image thereof;

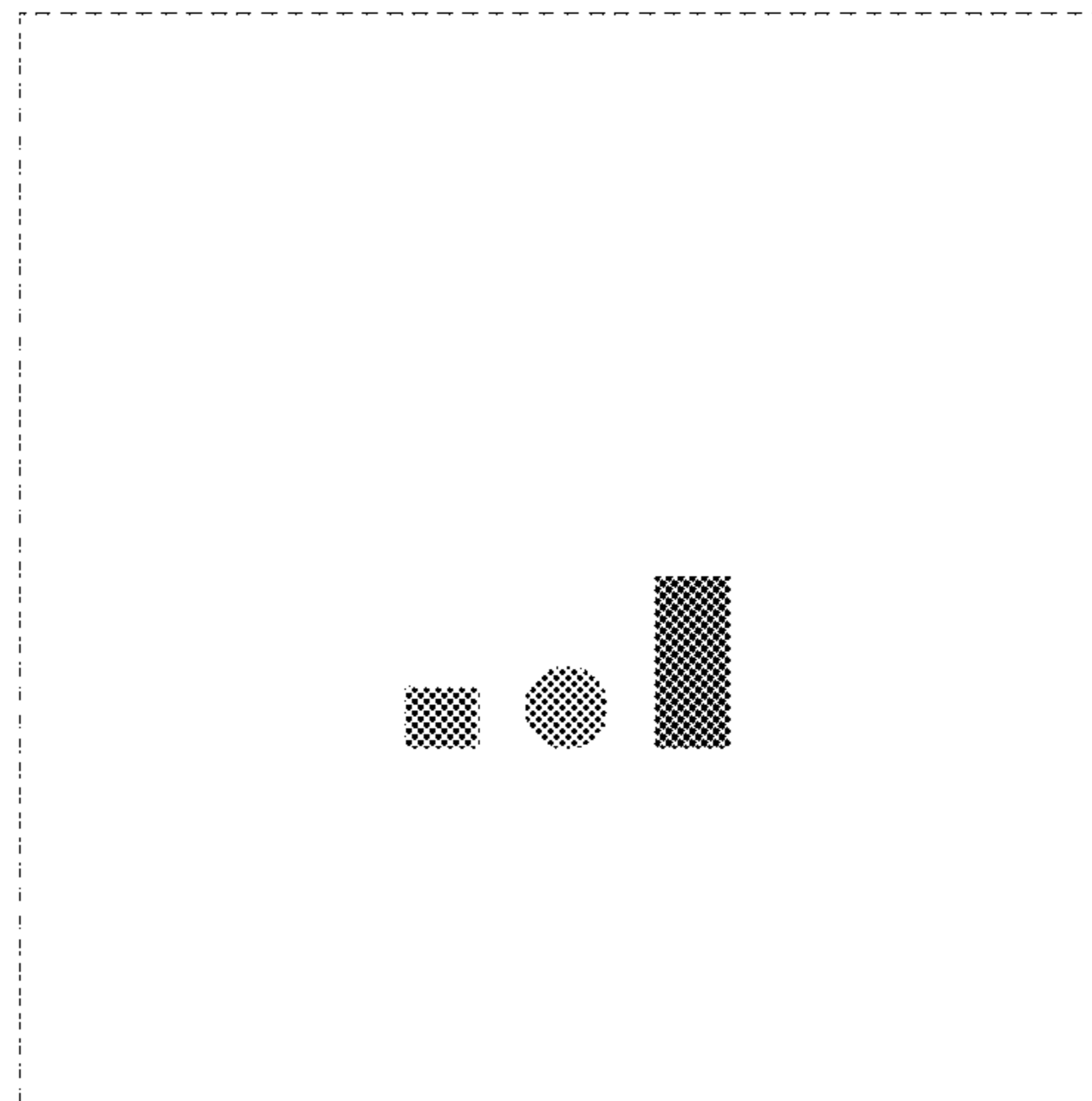
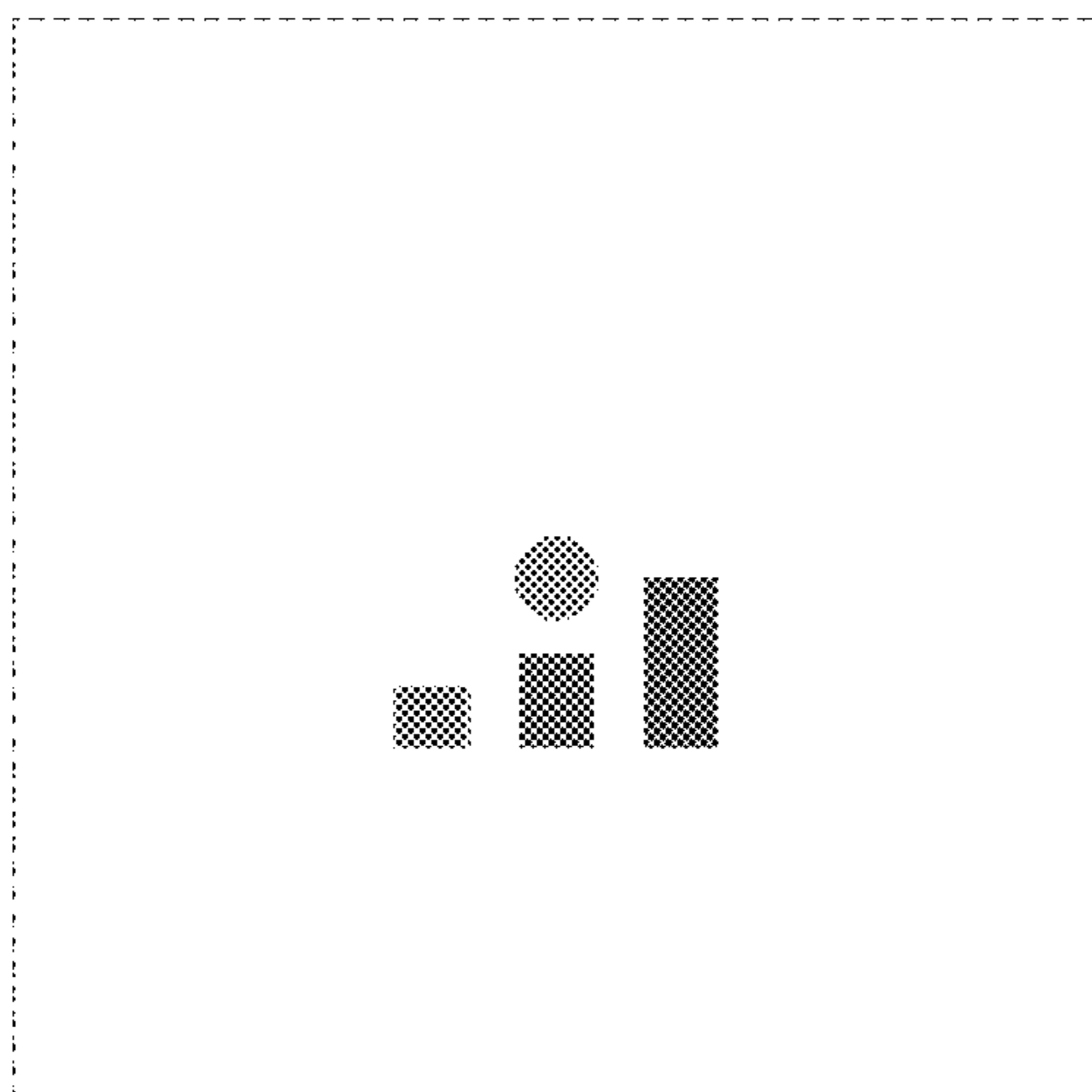
FIG. 17 is a front view of a seventeenth image thereof; and,

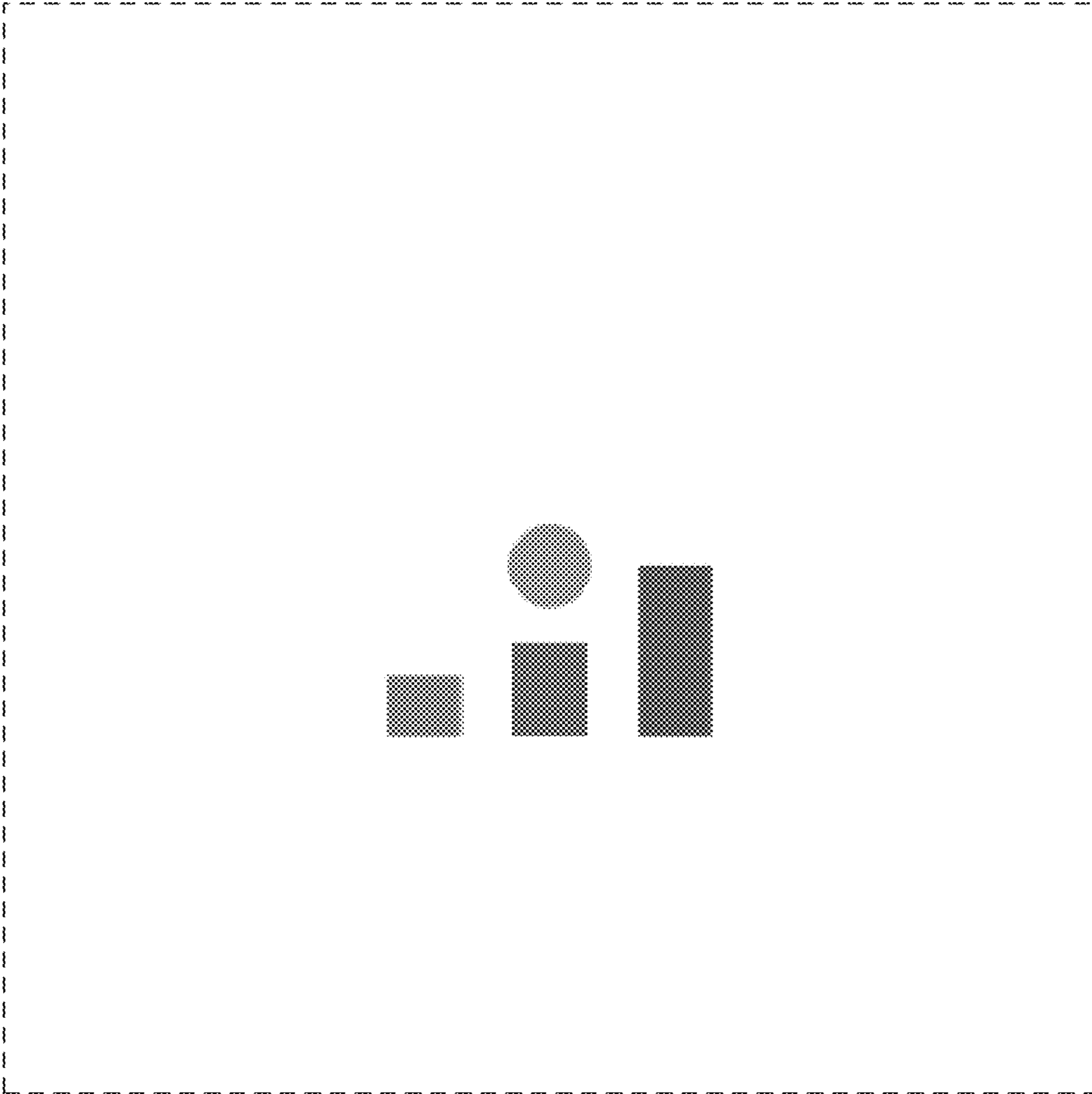

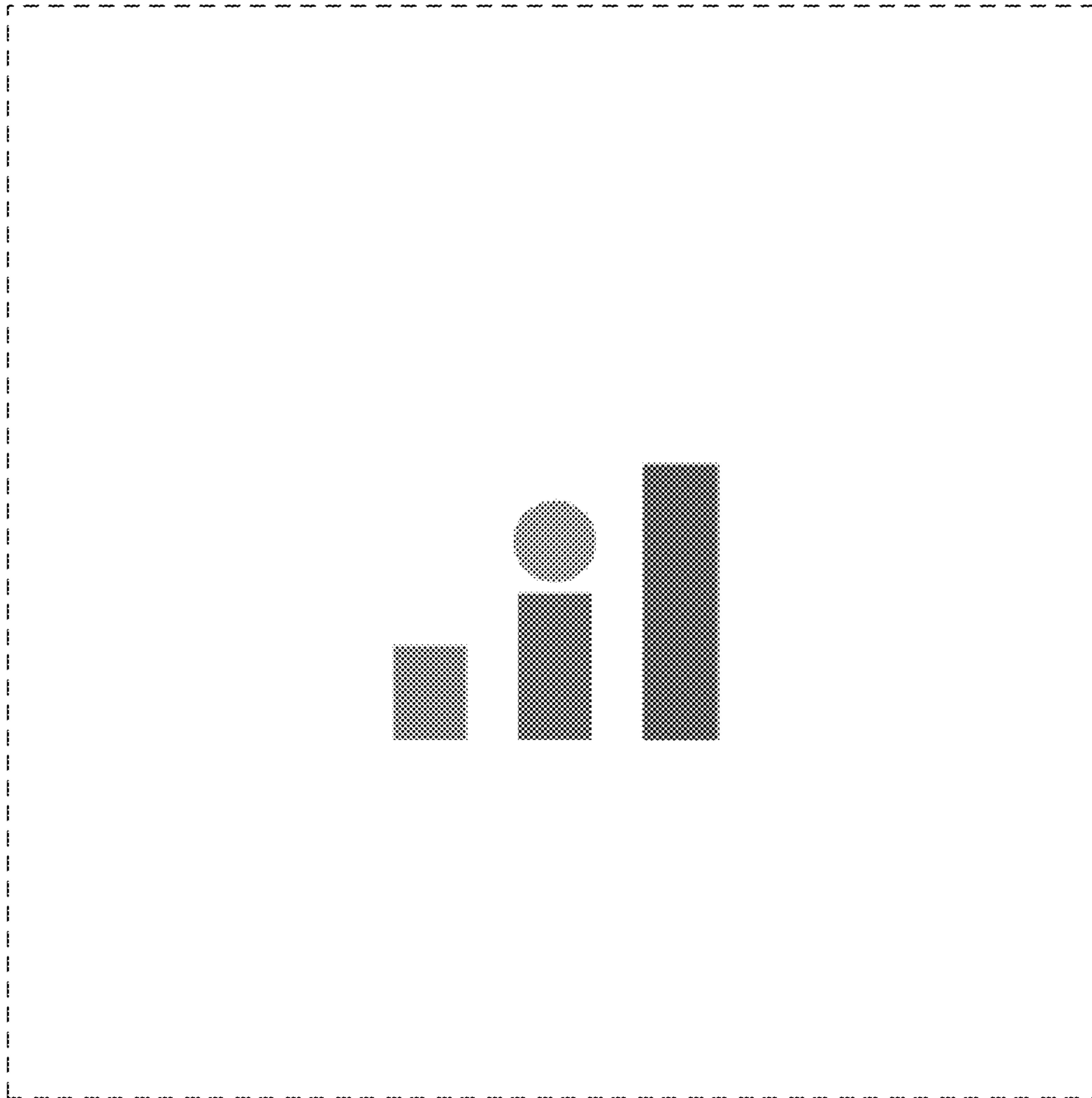

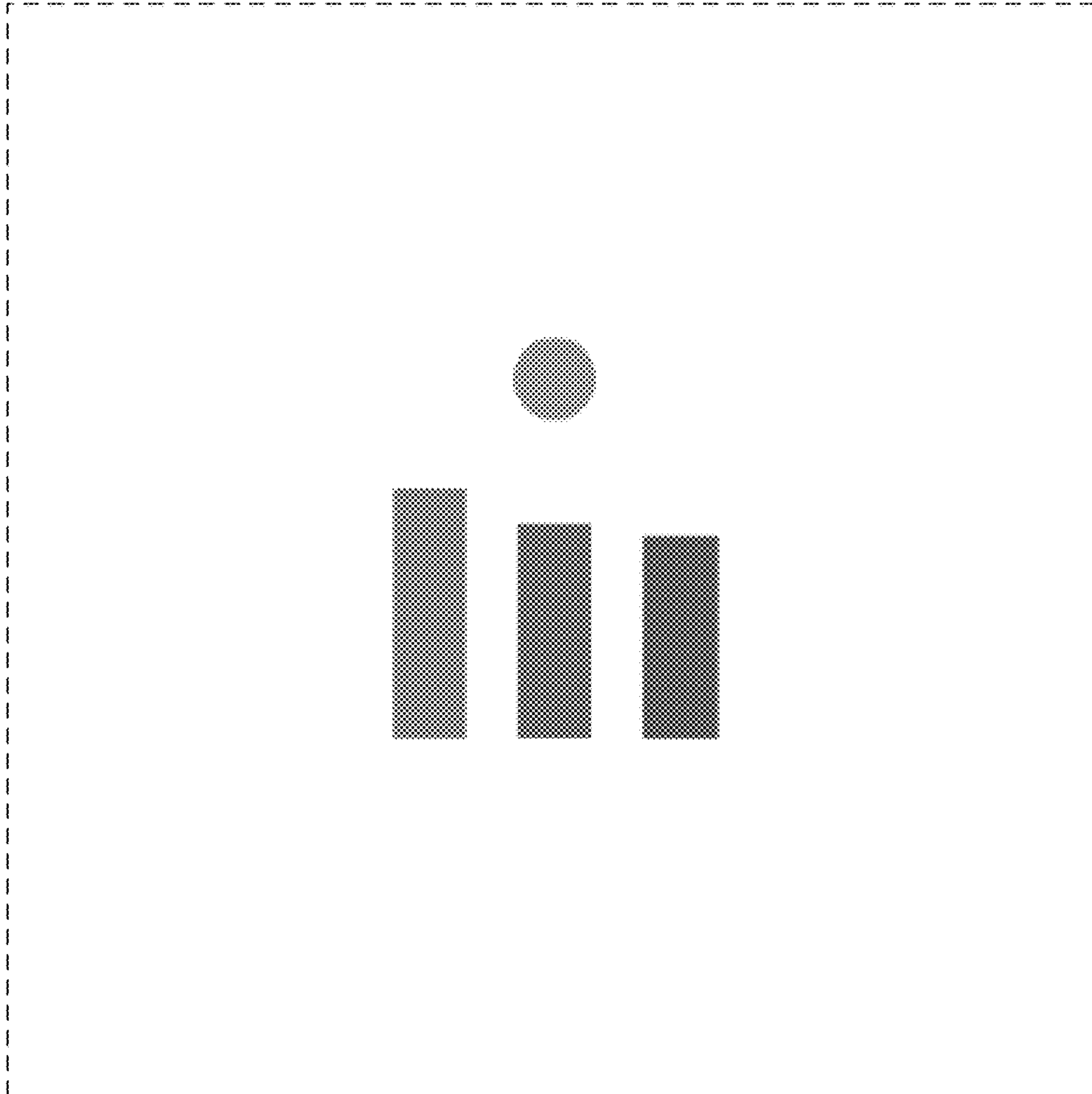

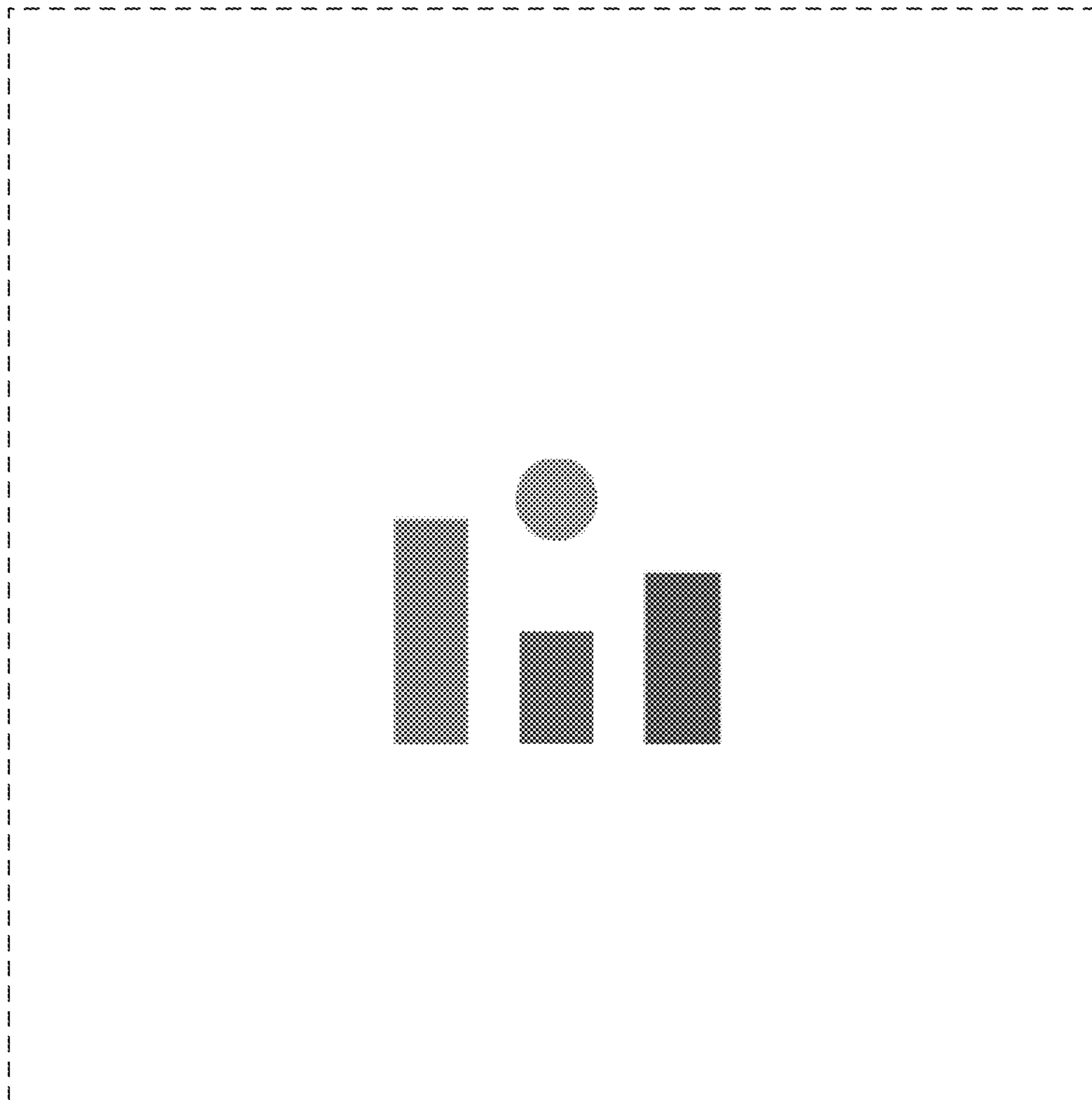

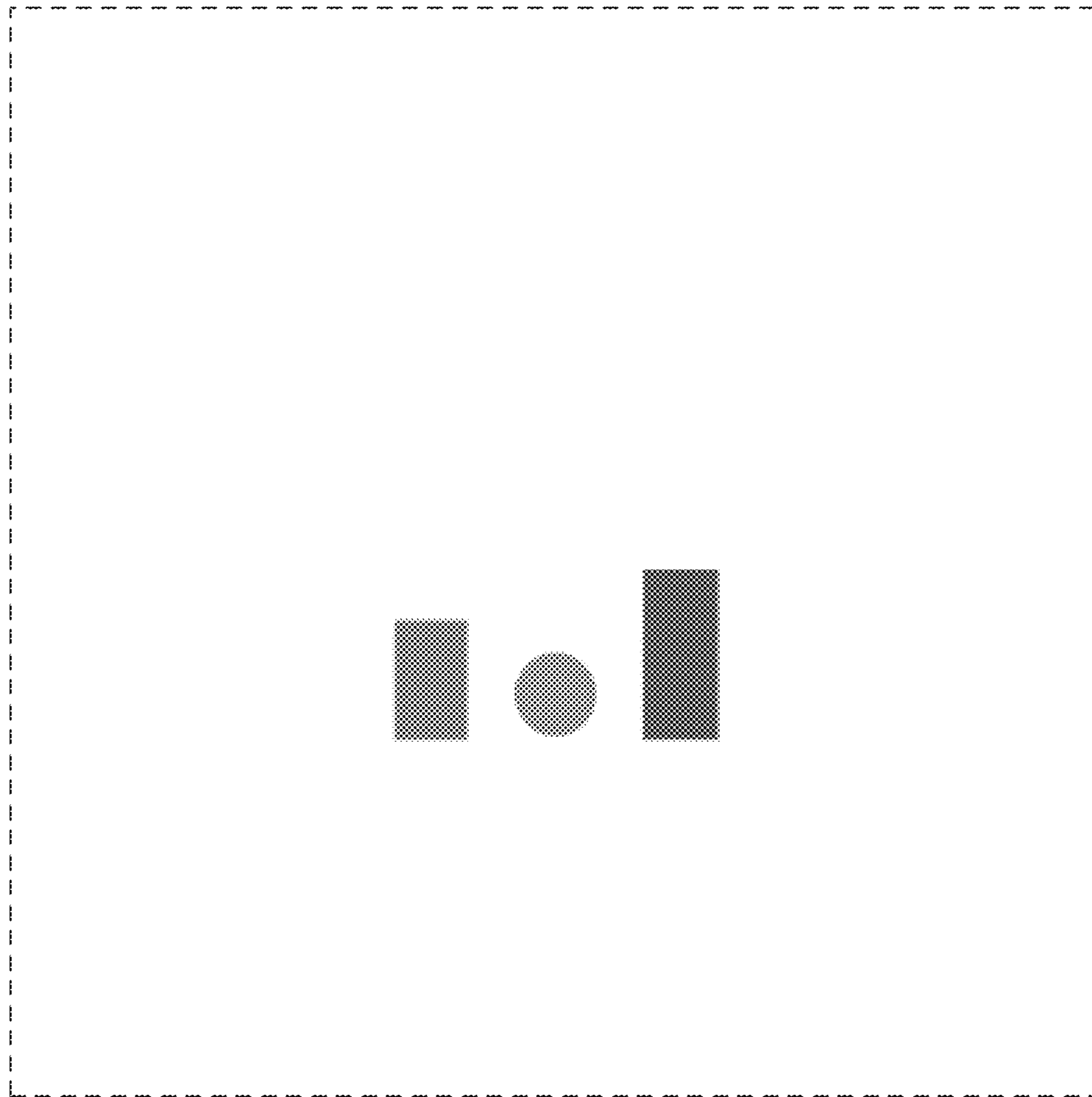

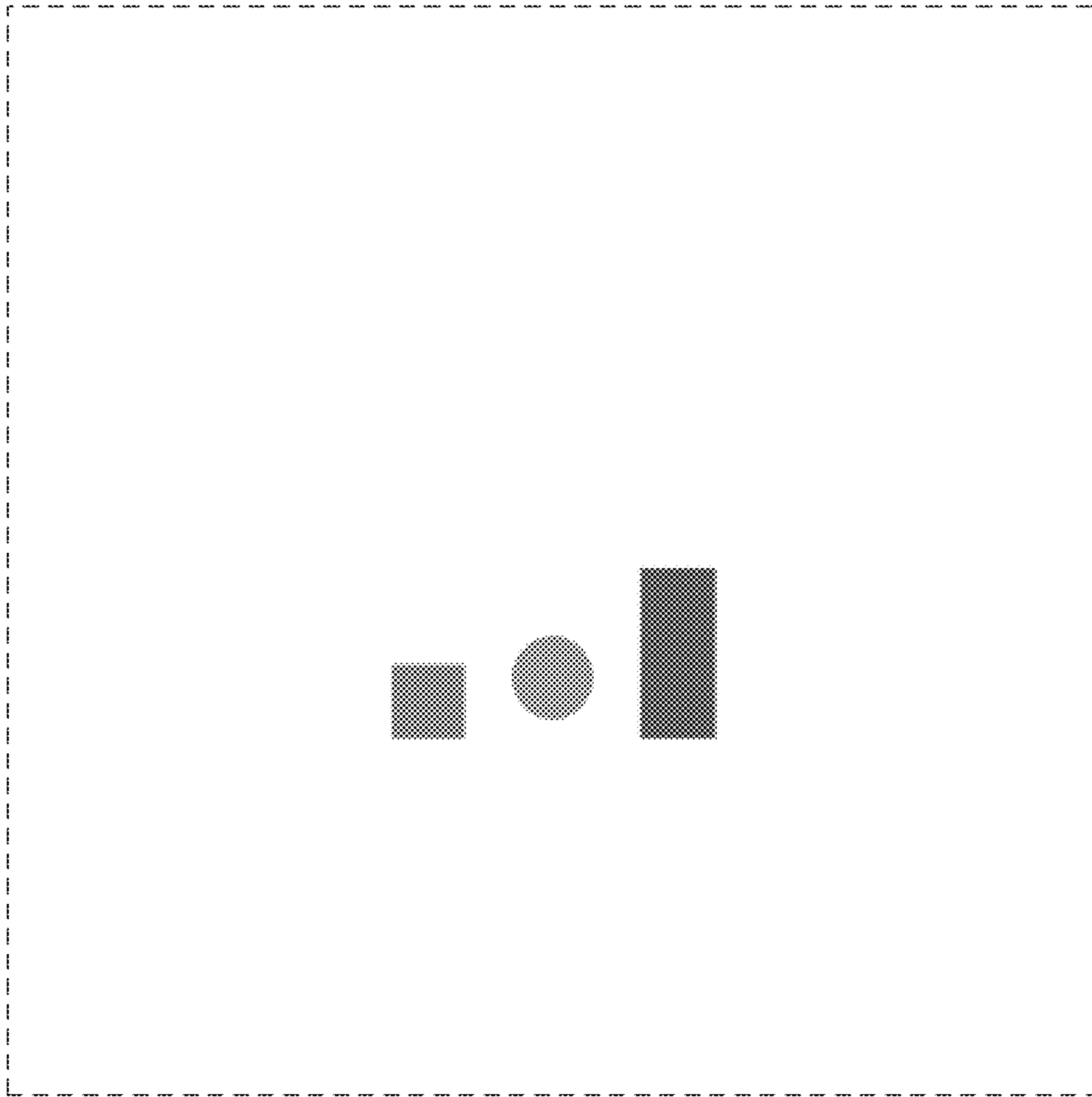

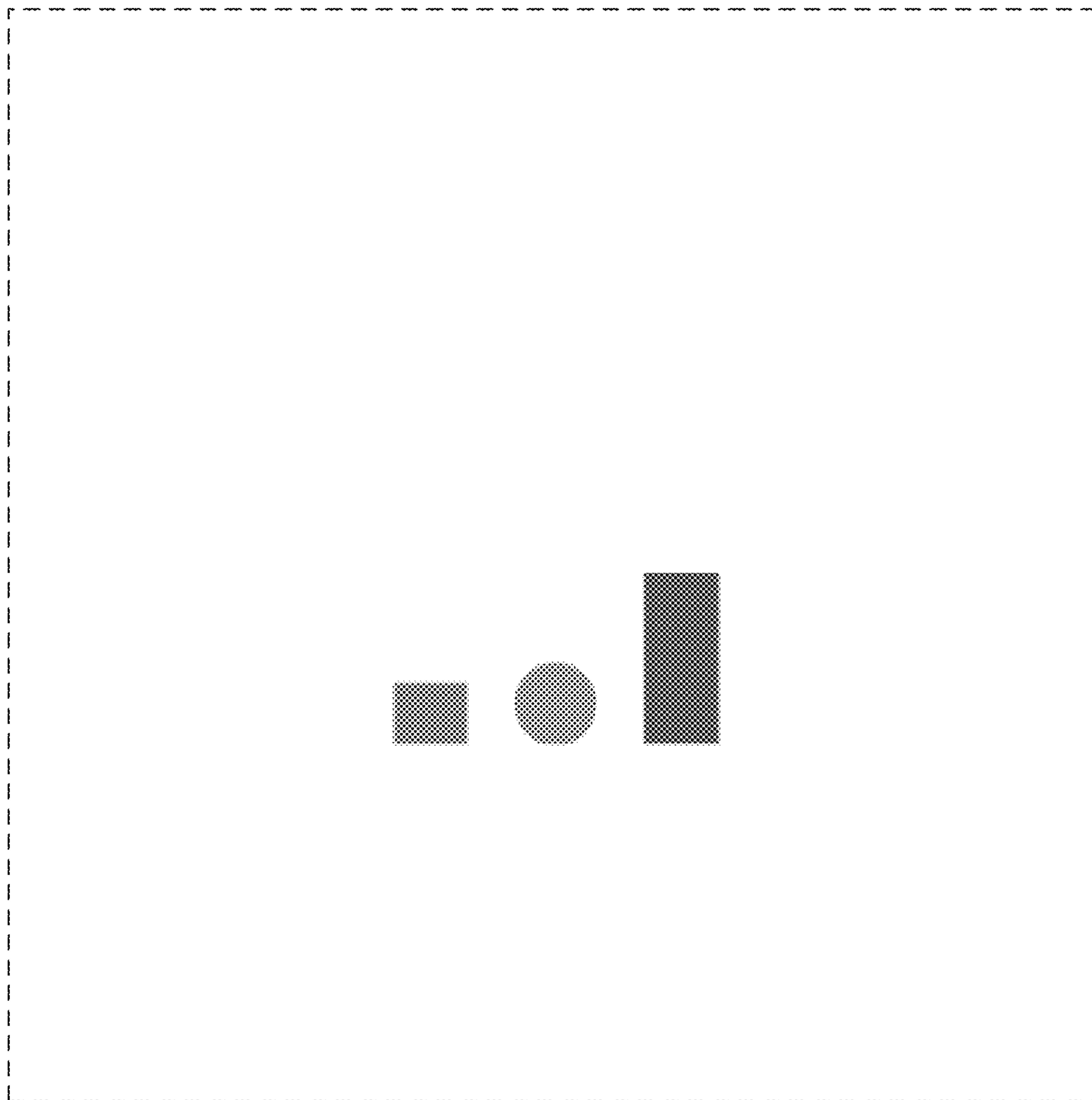

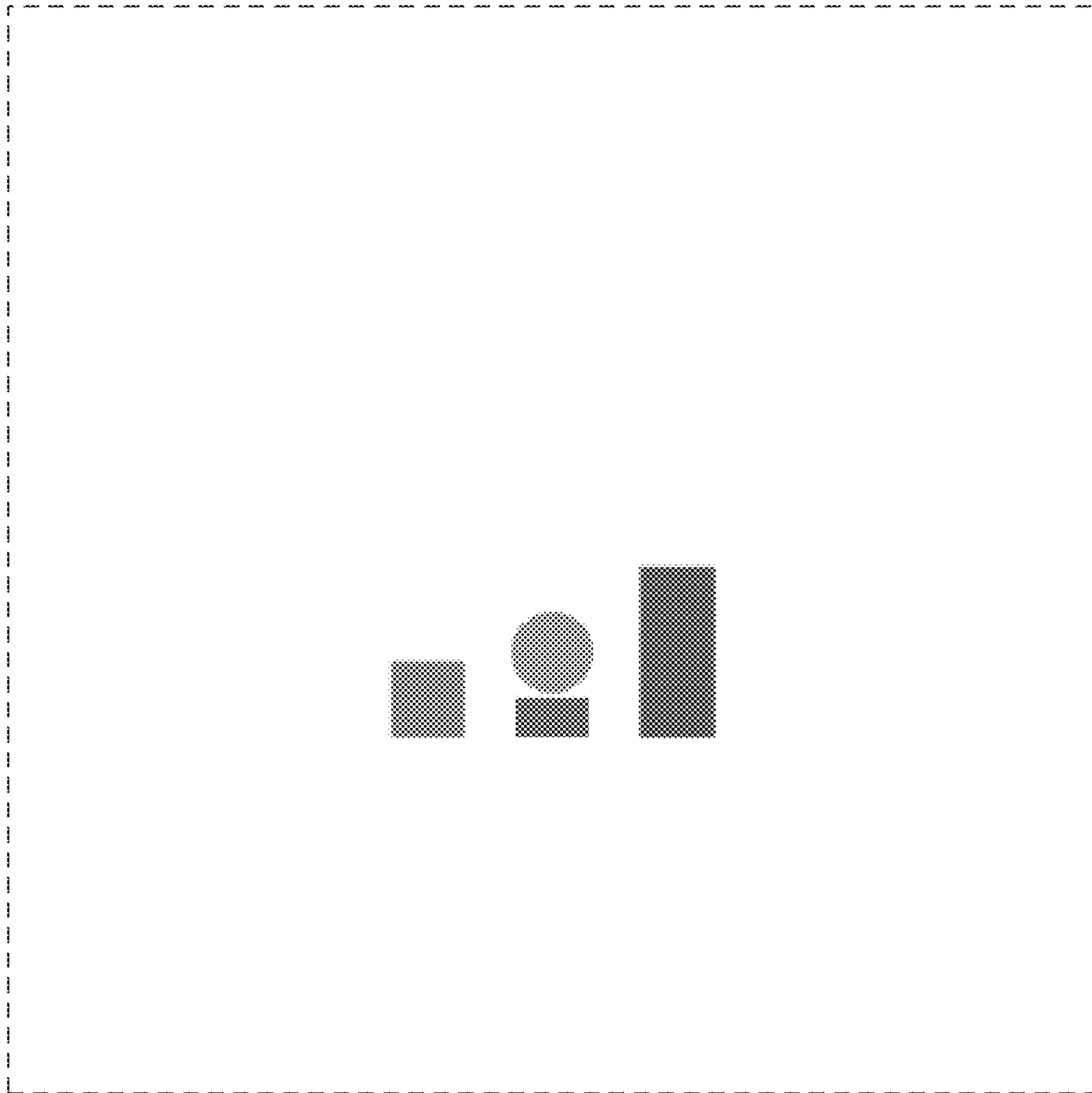

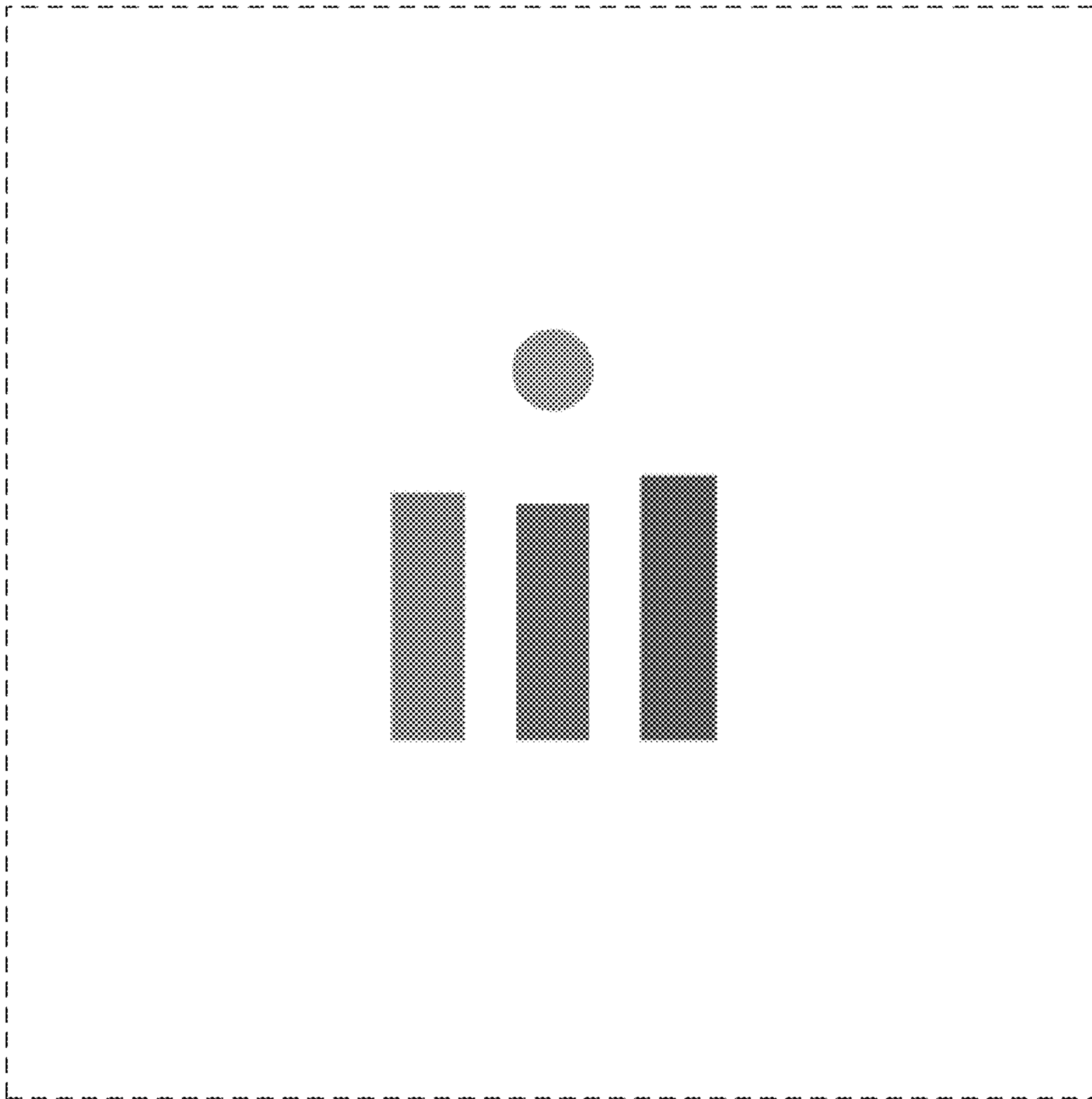

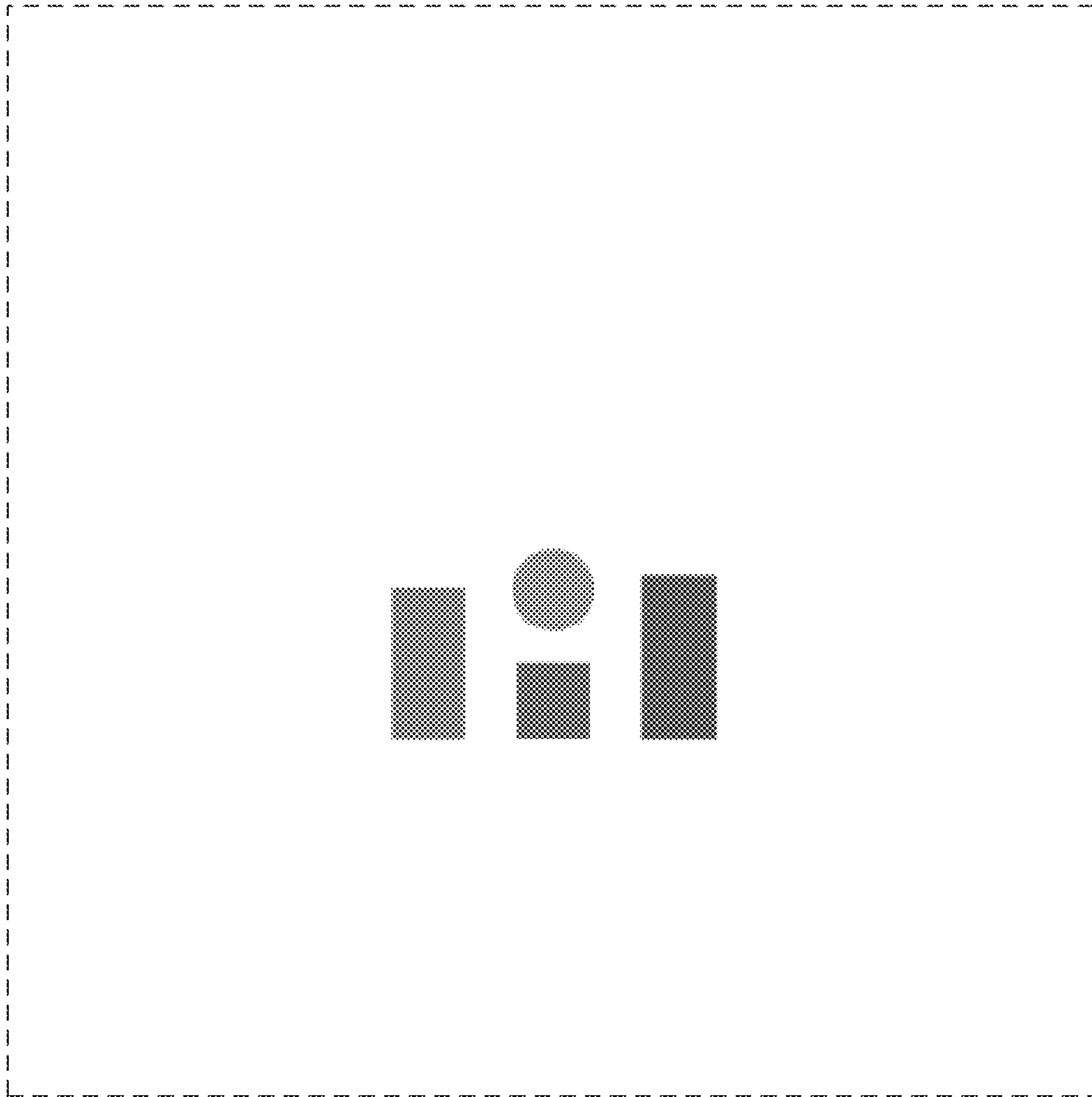

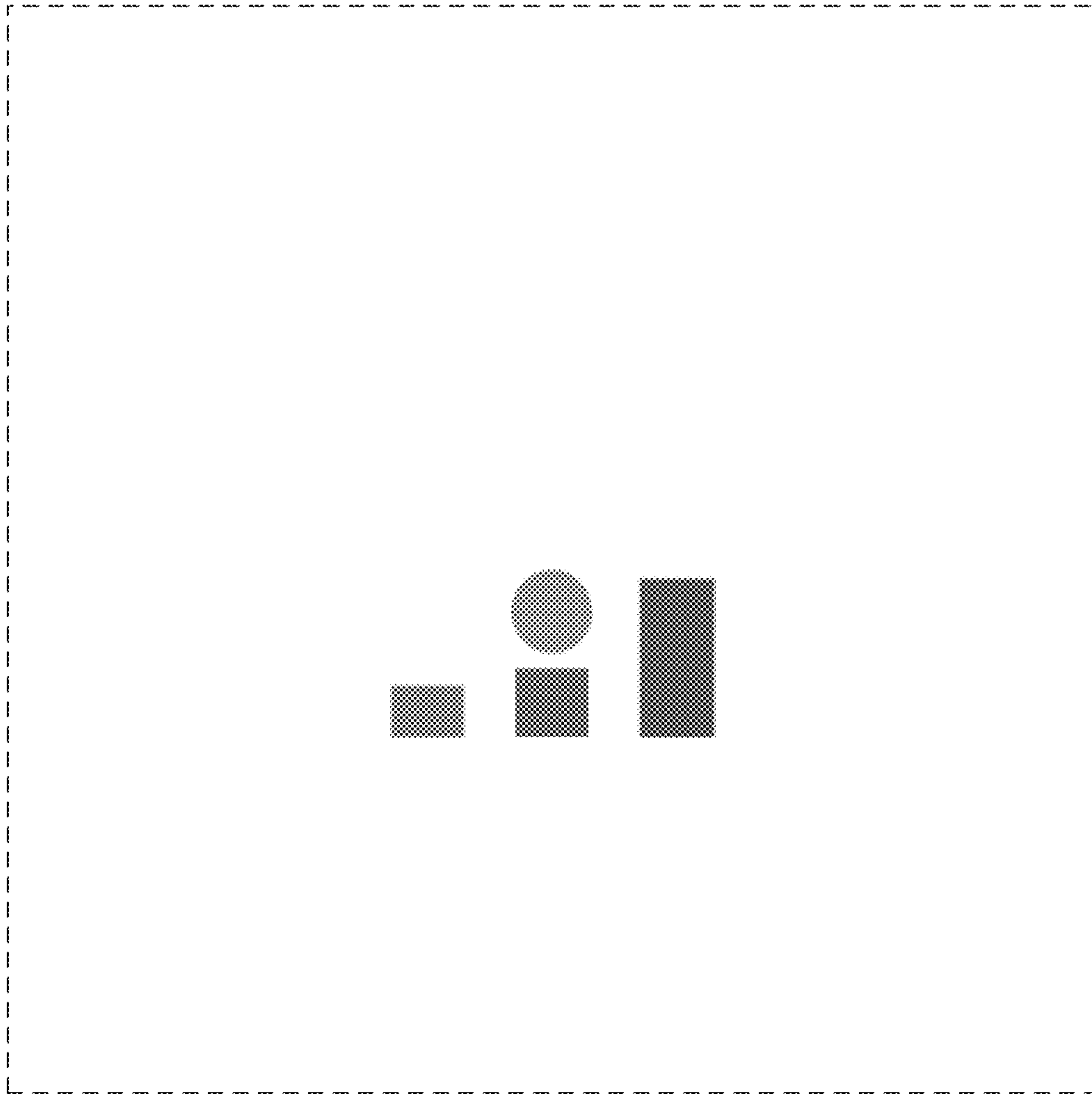

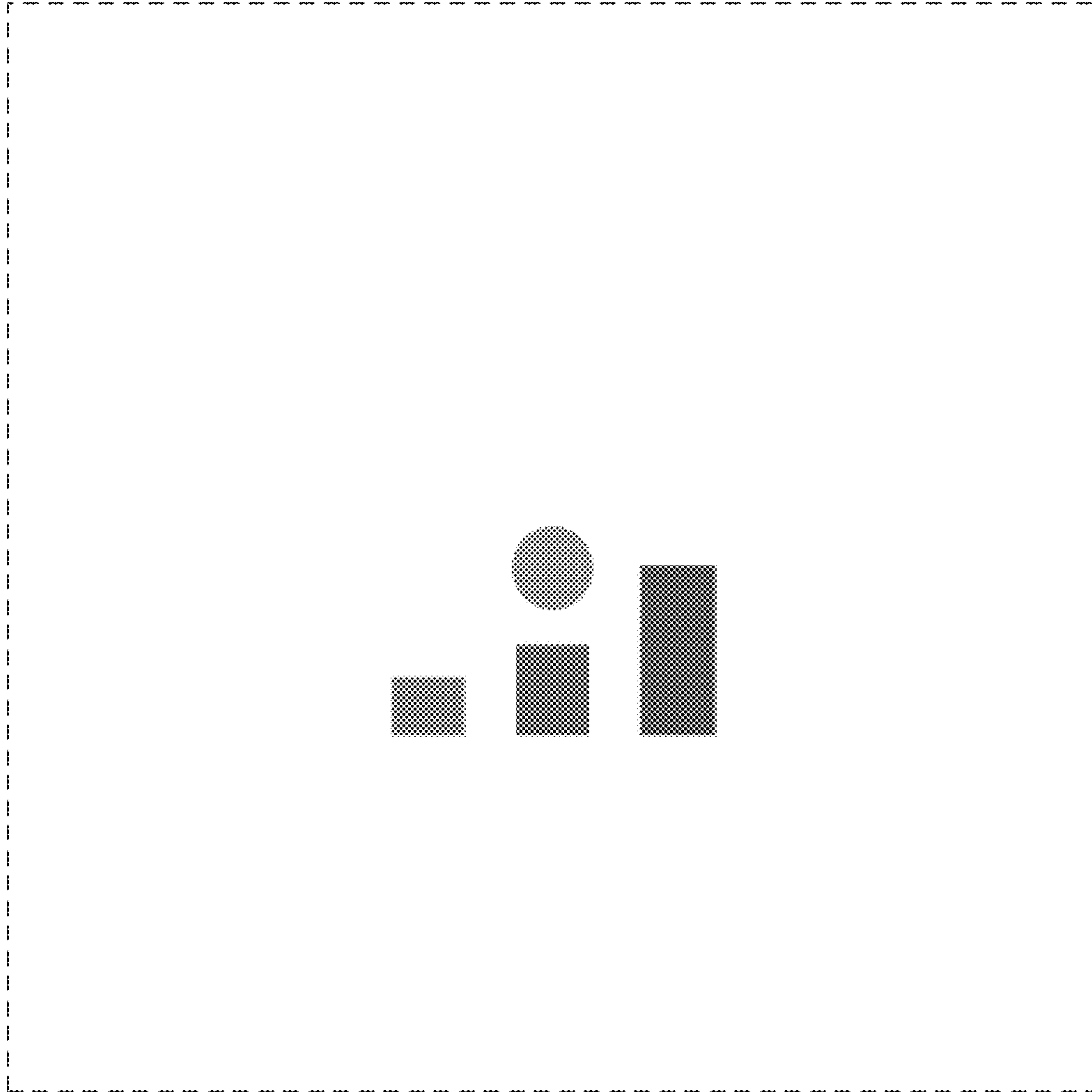
