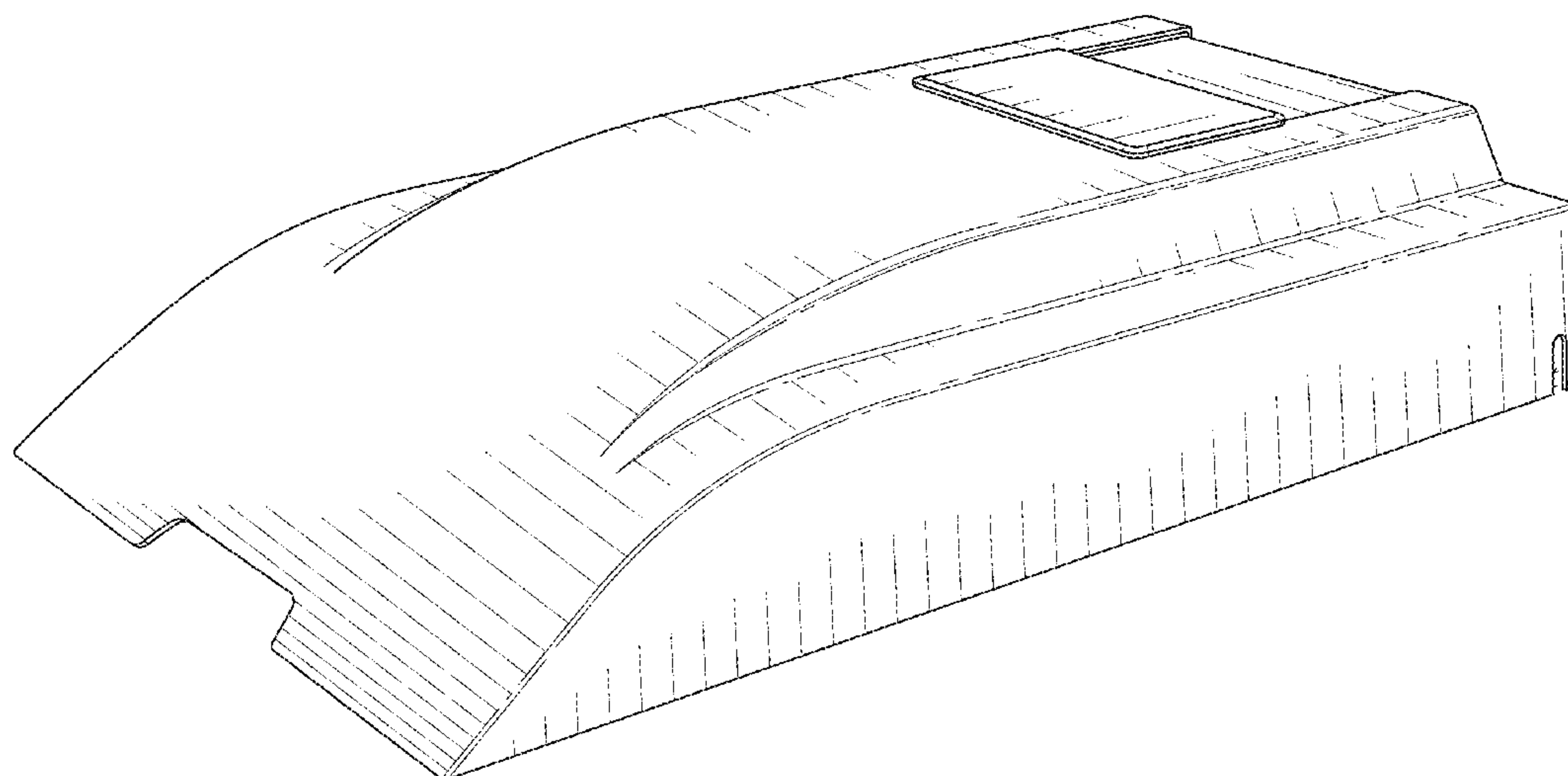
(57) **CLAIM**

We claim, the ornamental design for a vehicle loading platform, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a vehicle loading platform, showing our new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a side elevation view thereof, the opposite side being a mirror image thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.

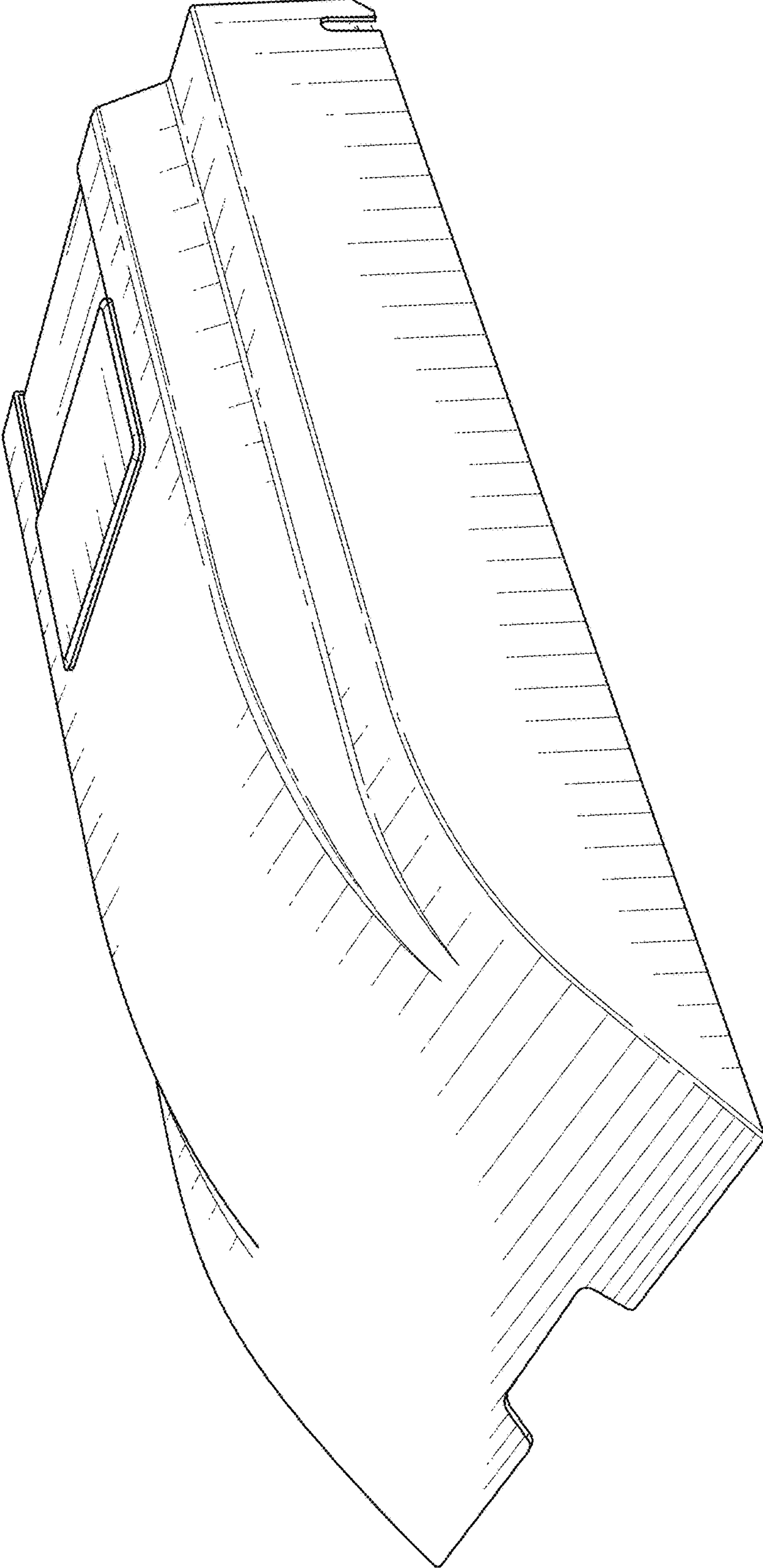

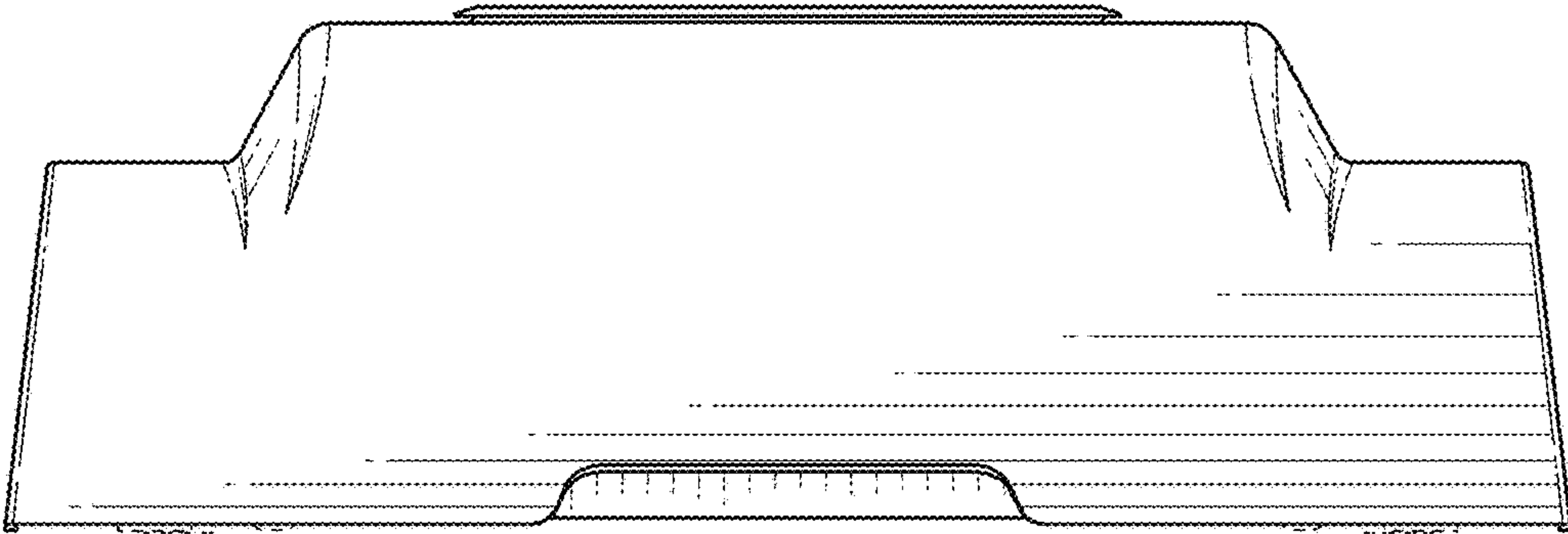

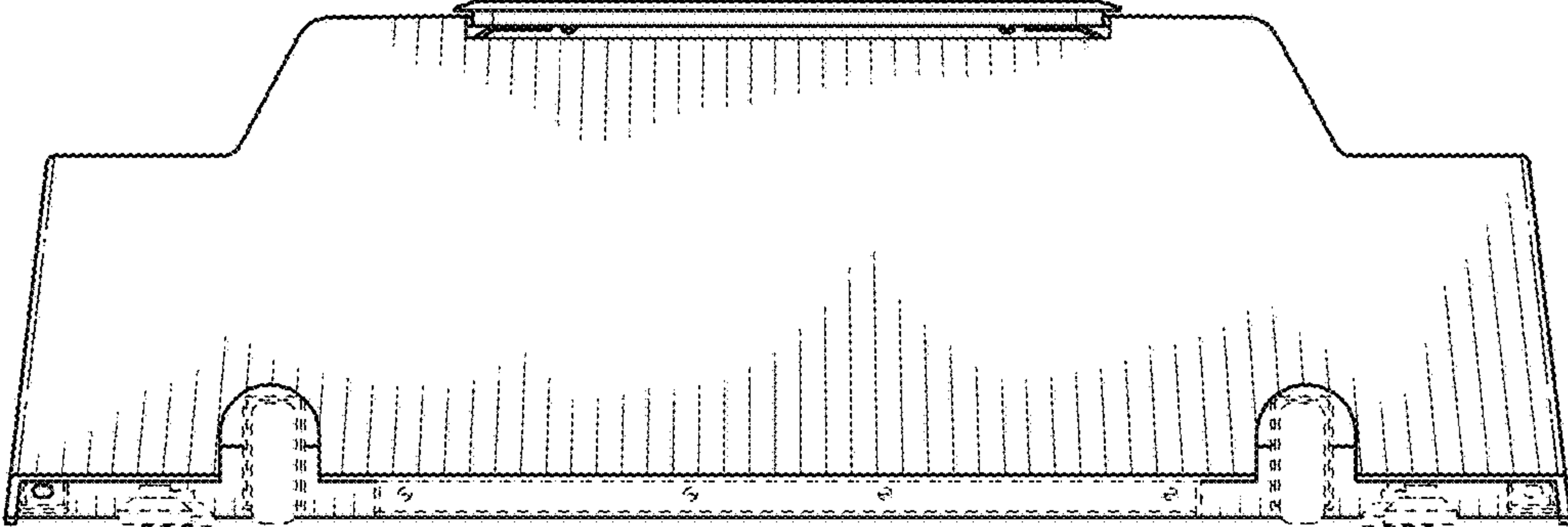

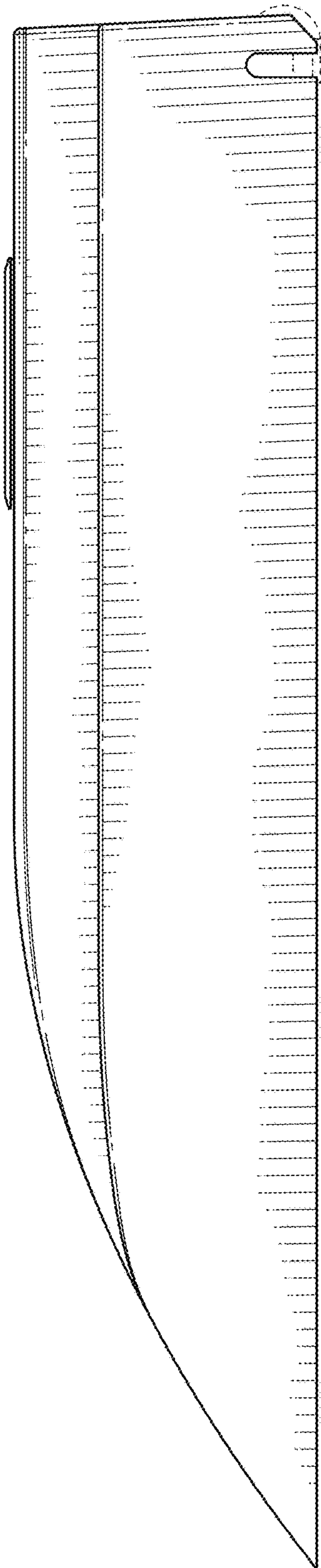

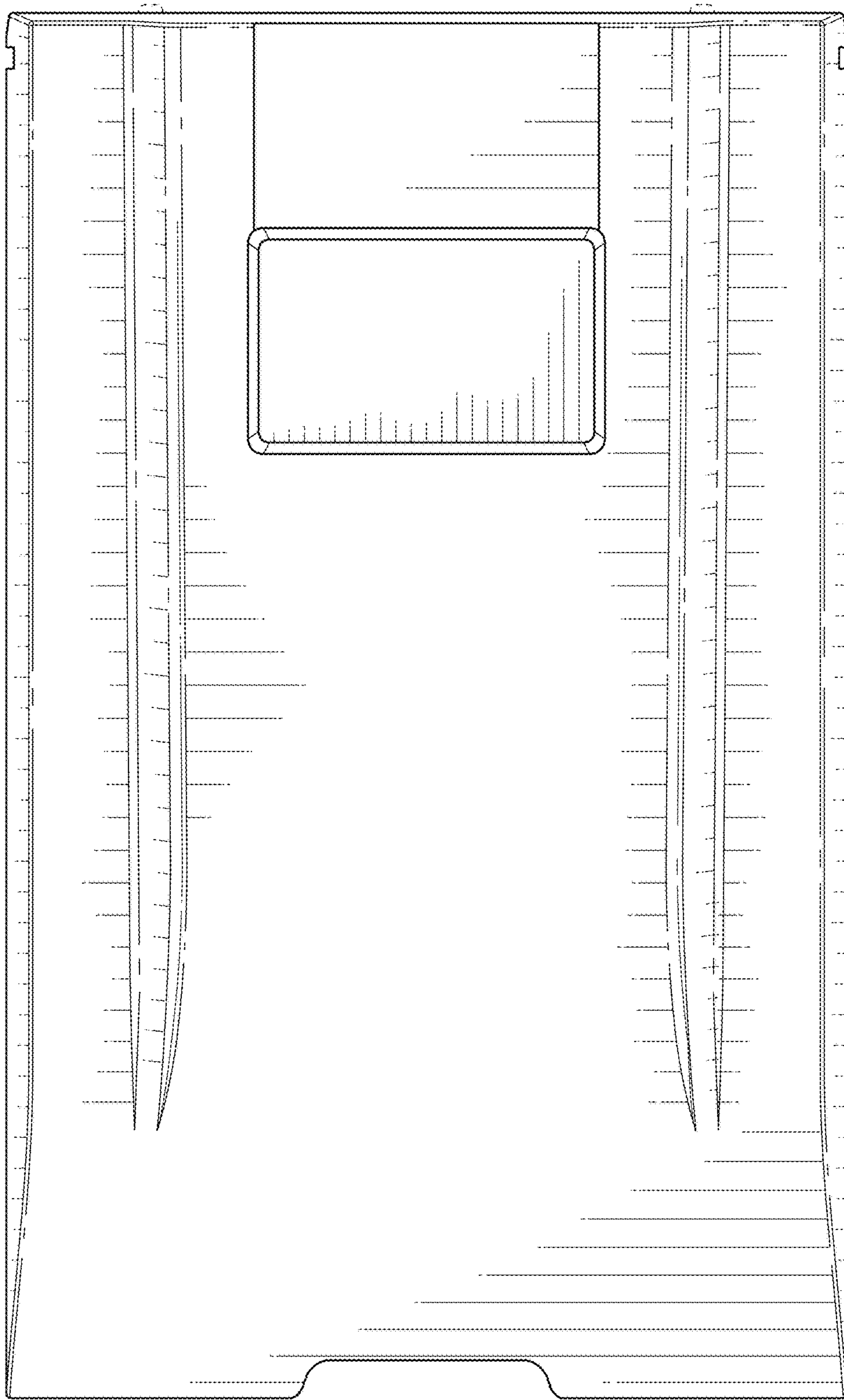

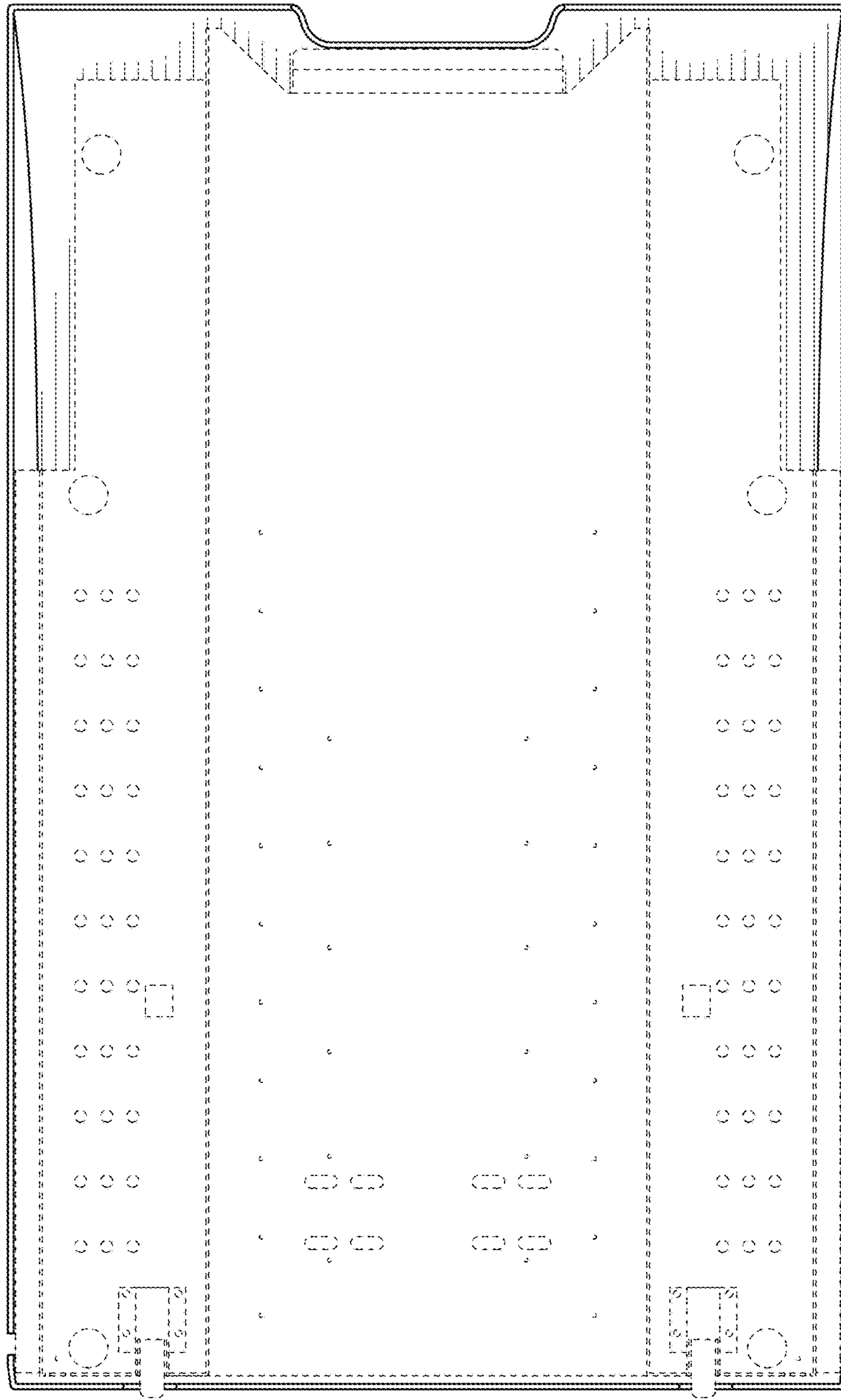
