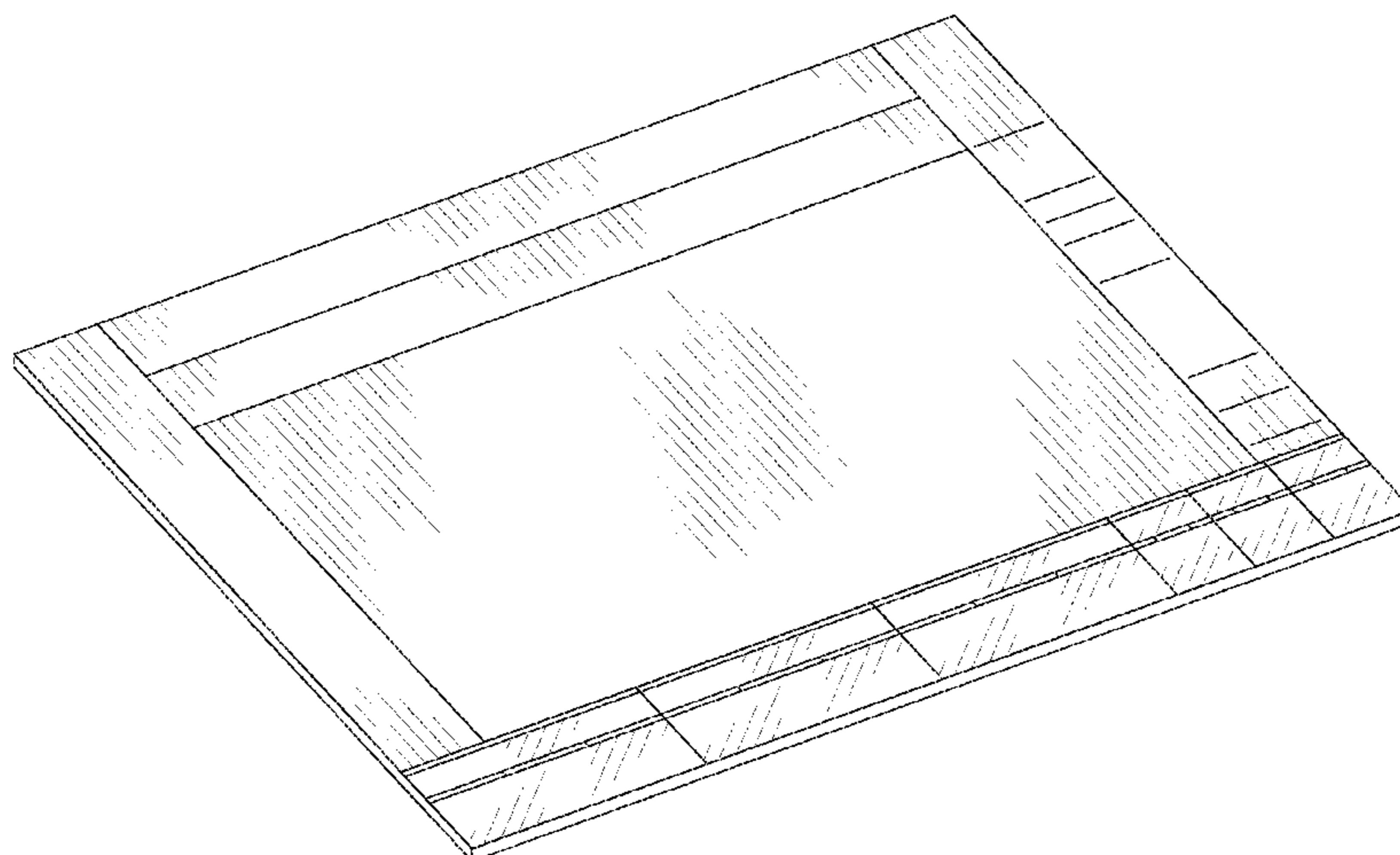
CLAIM

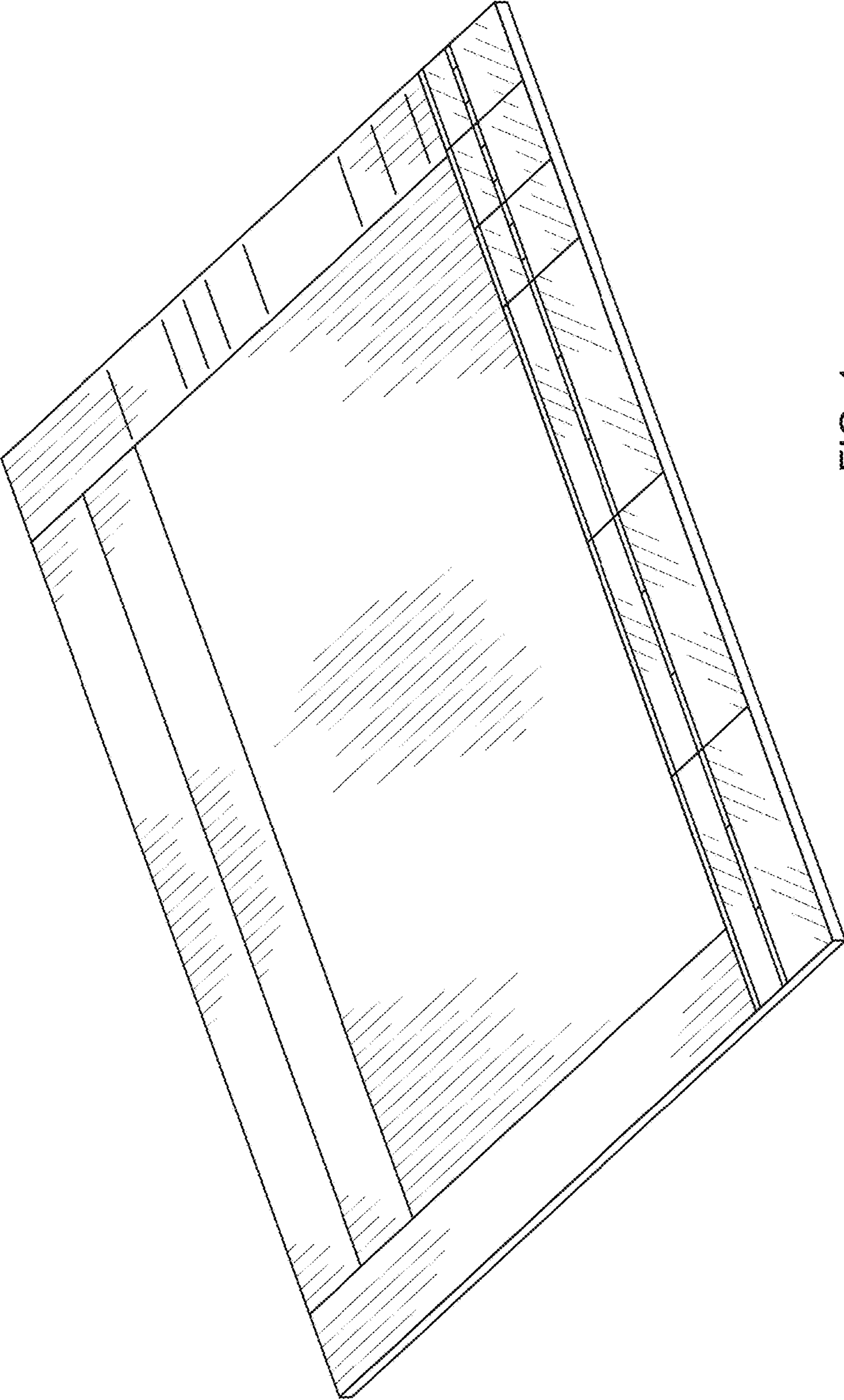

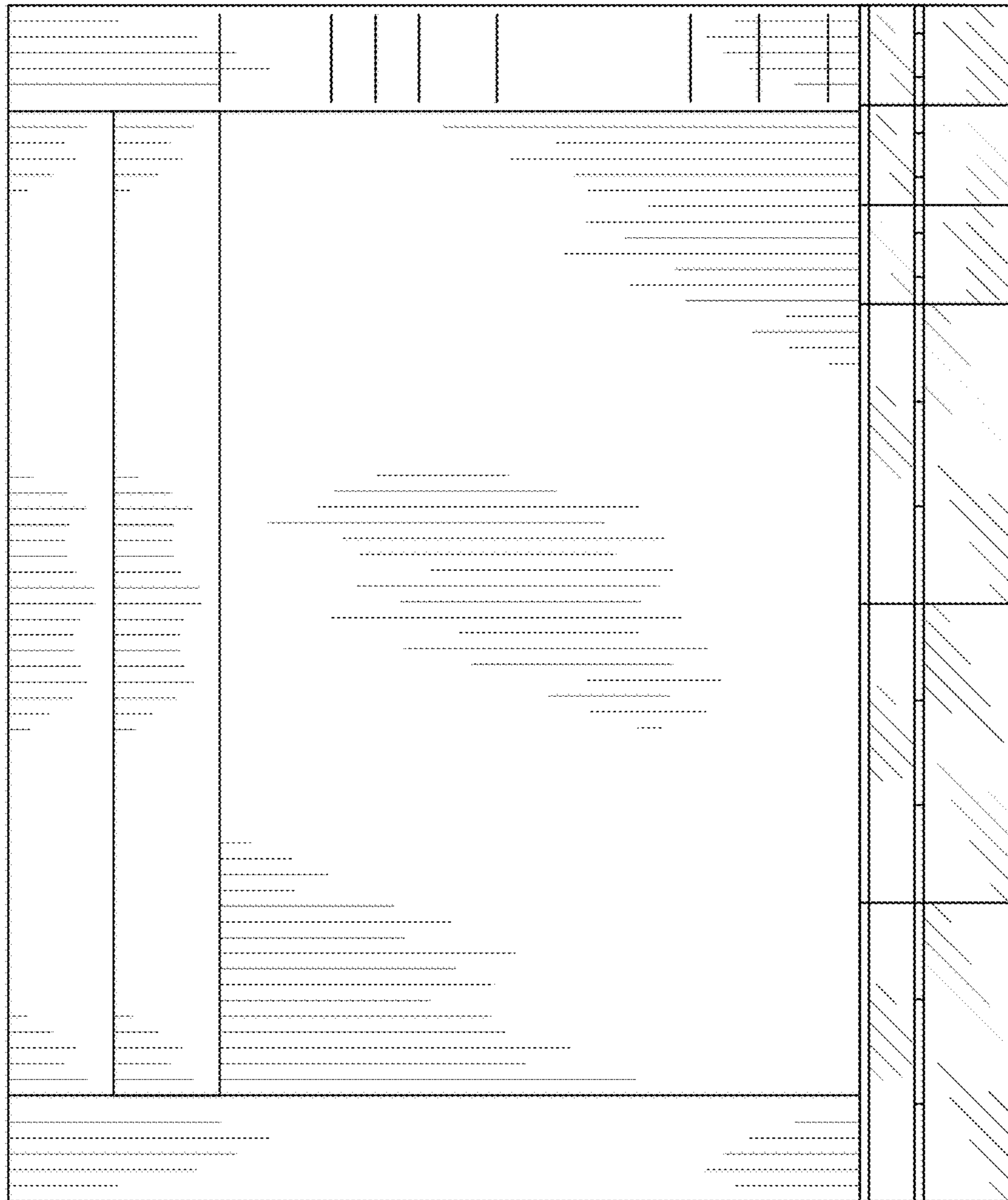

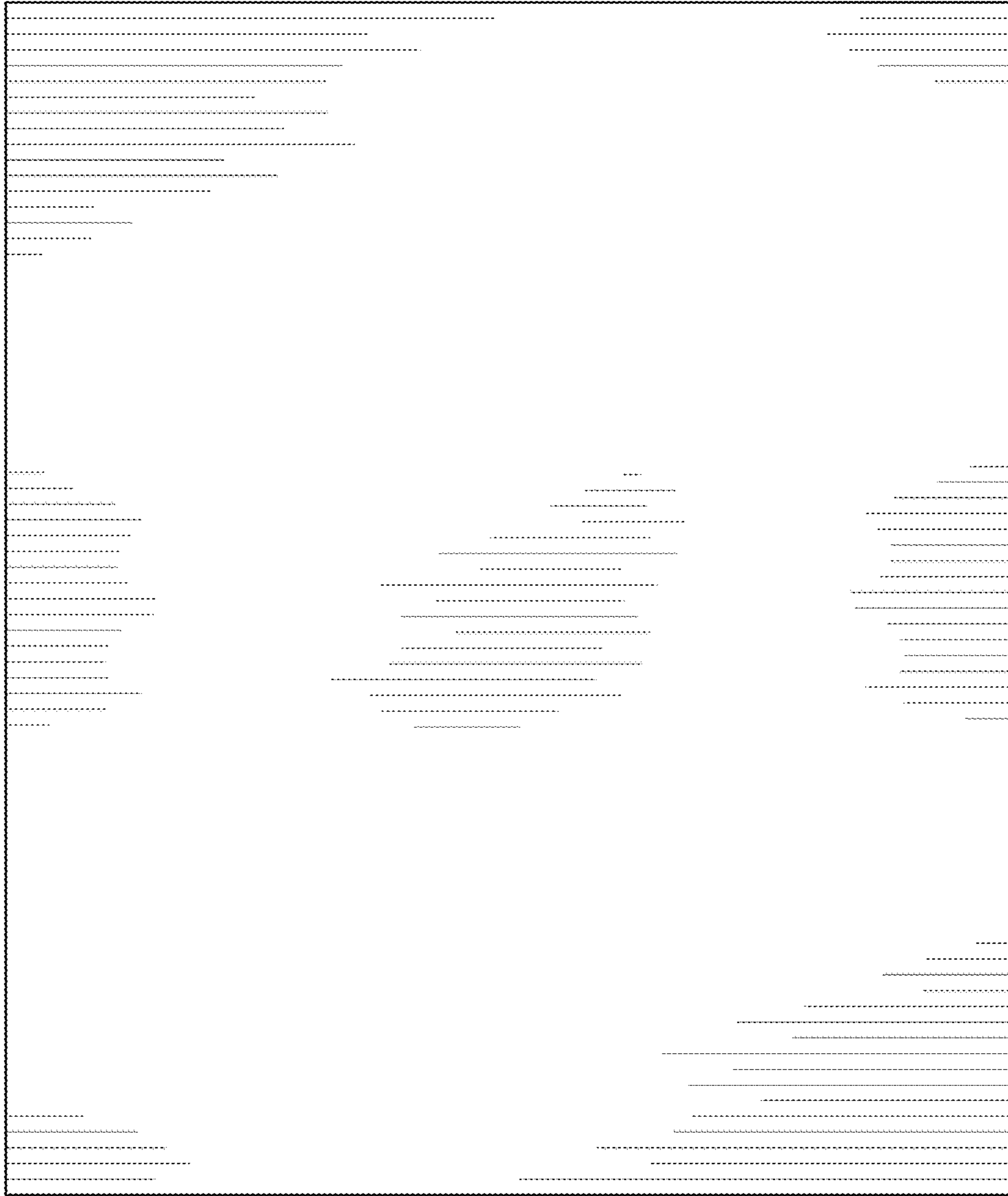

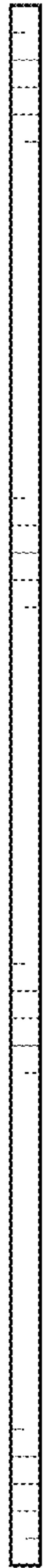

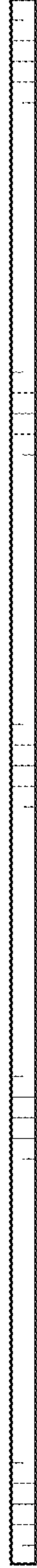
