(57) **CLAIM**

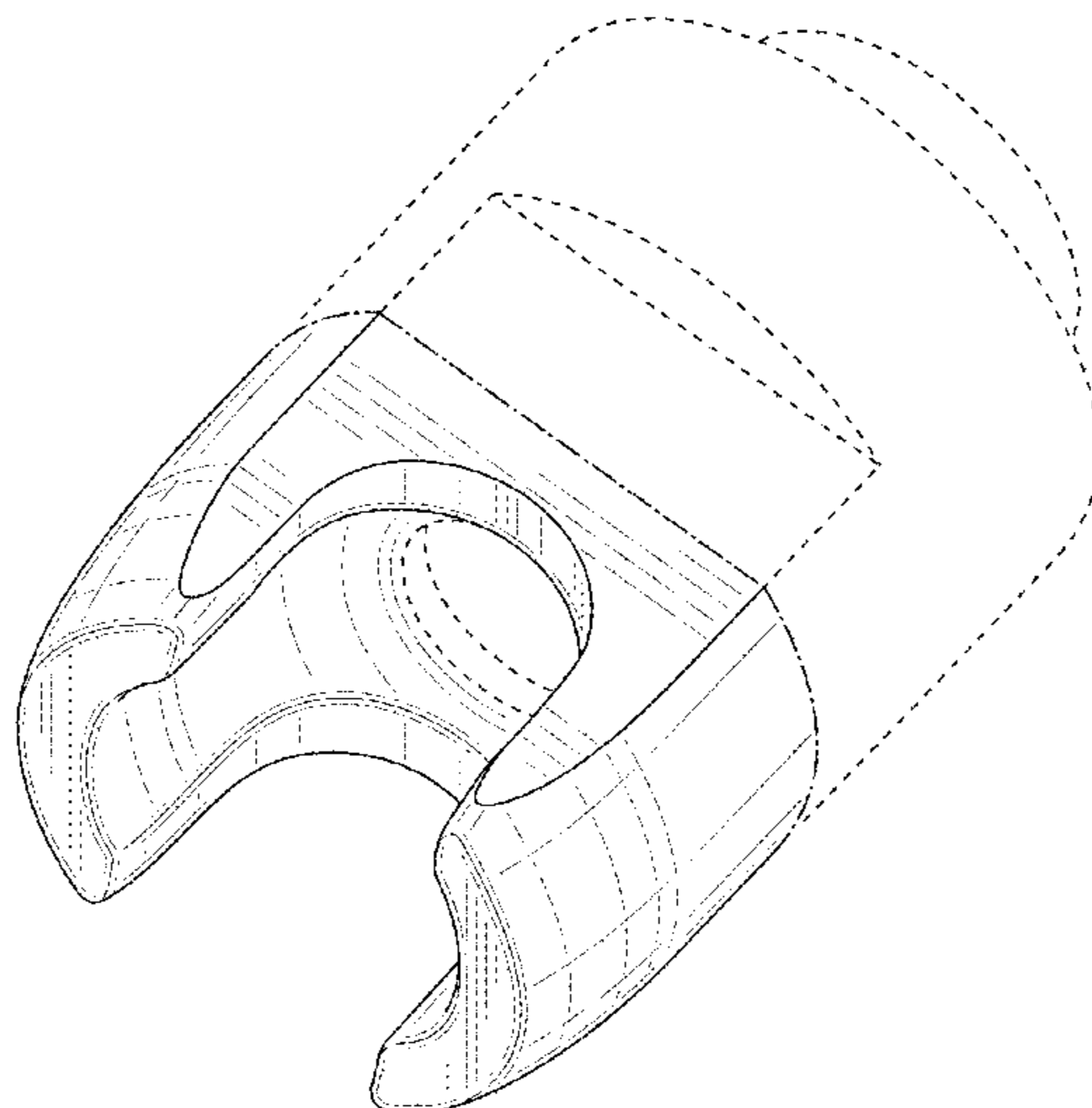
The ornamental design for a construction set element, as shown and described.

DESCRIPTION

FIG. 1 is a top isometric perspective view of a construction set element showing the new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a side elevational view of one side thereof;
FIG. 5 is a side elevational view of the opposite side thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

The evenly spaced broken lines and unshaded areas are included to illustrate parts of the article's appearance that form no part of the claimed design. The dash-dot broken lines define the boundaries of the claimed design and form no part thereof.

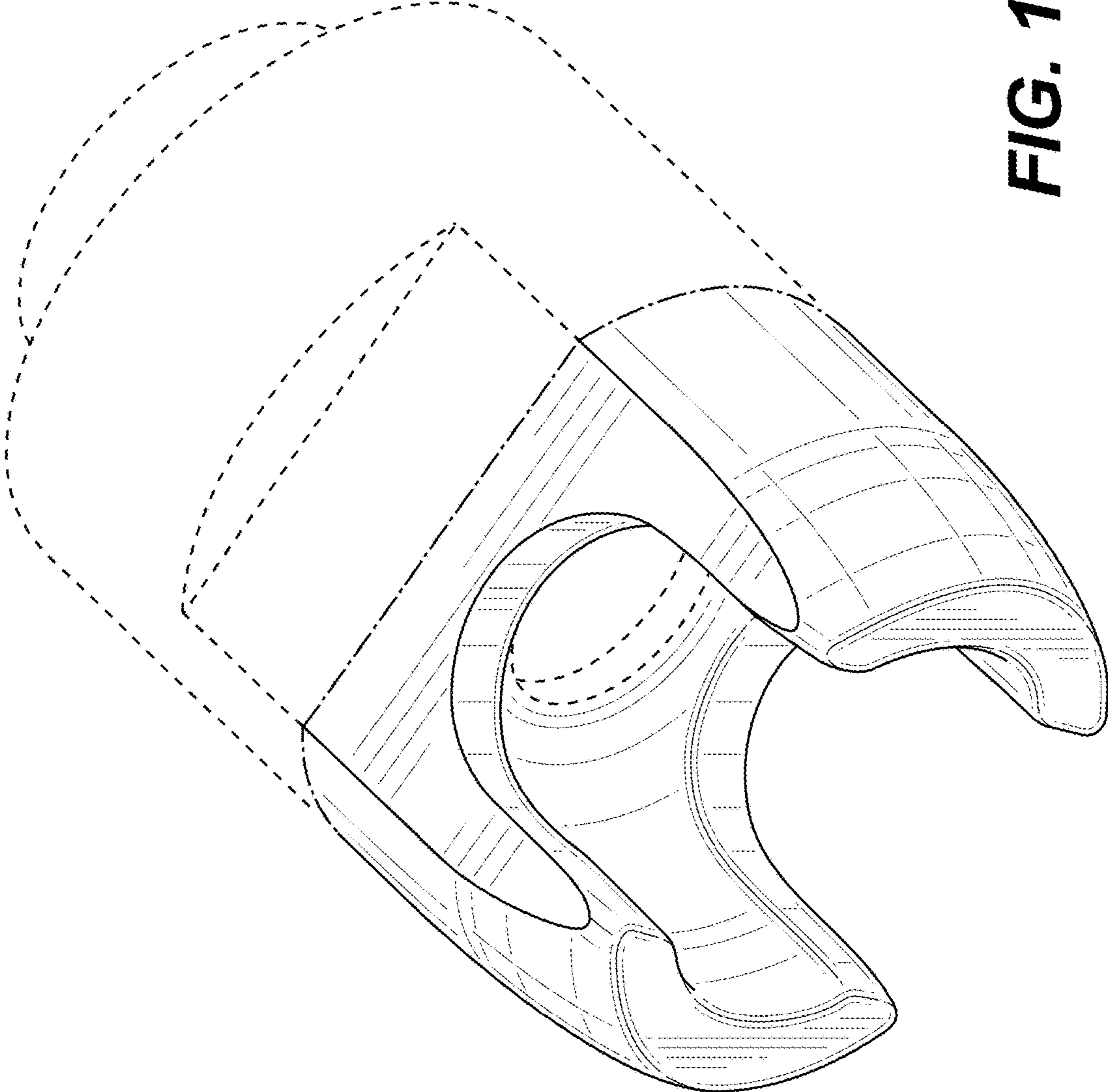

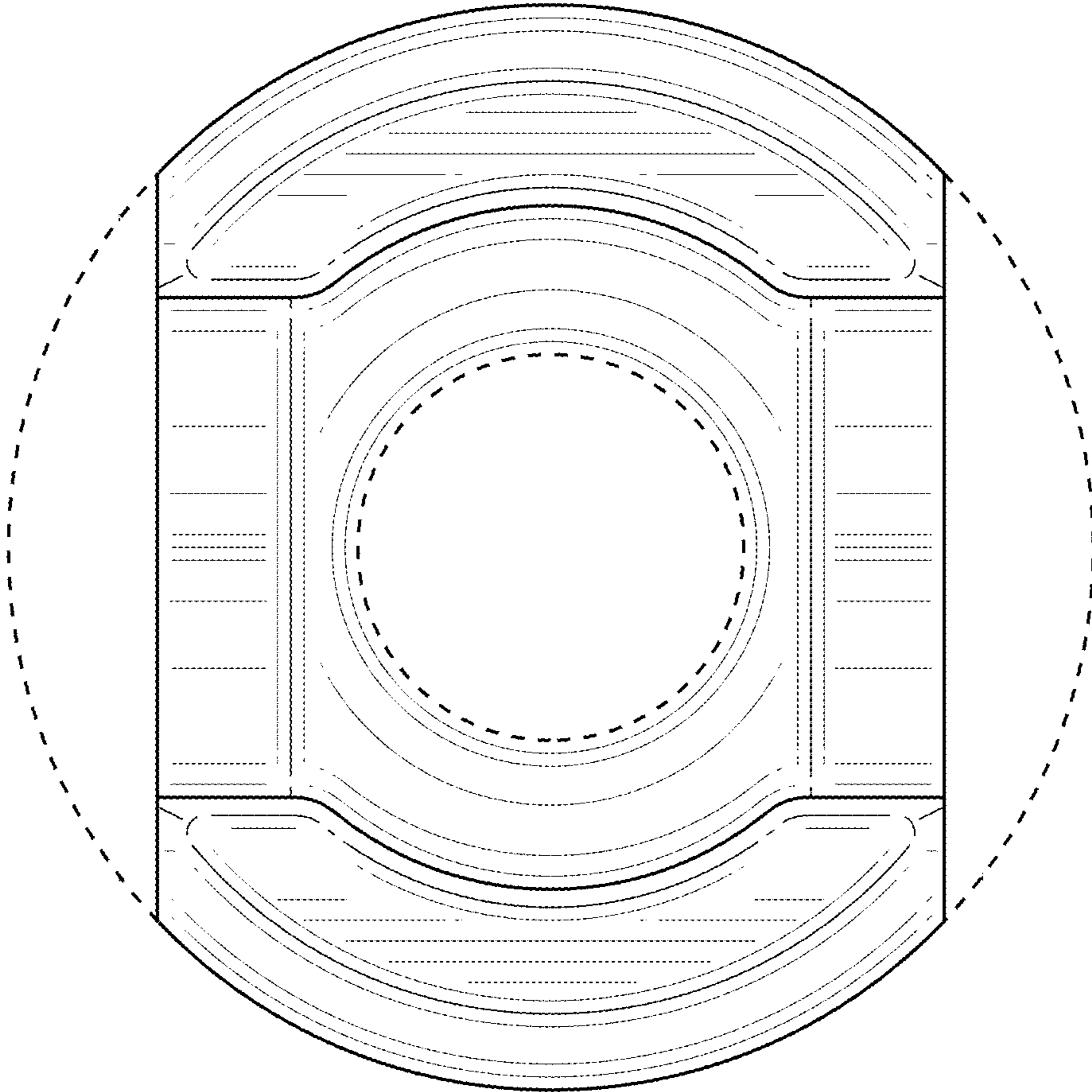

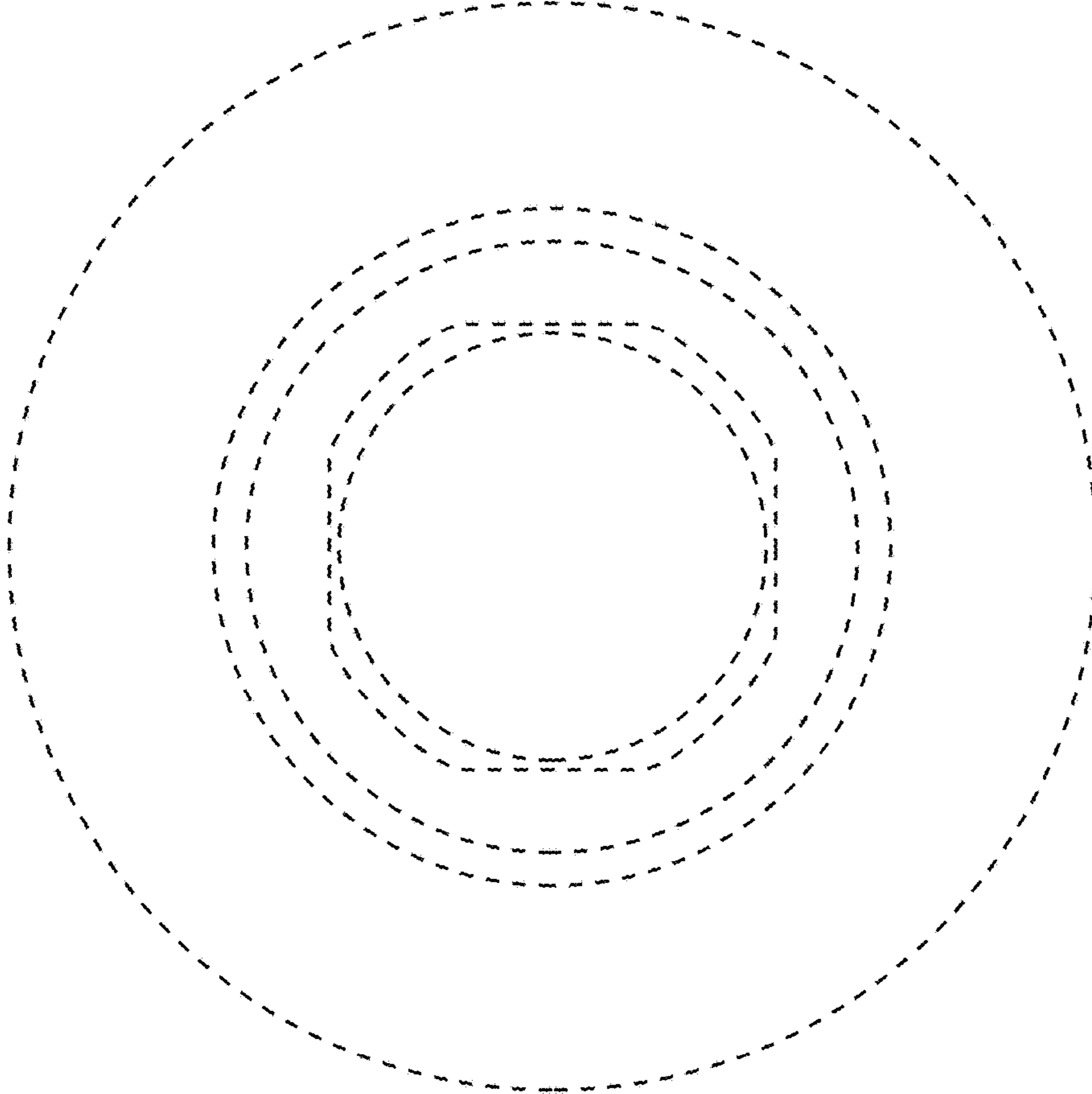

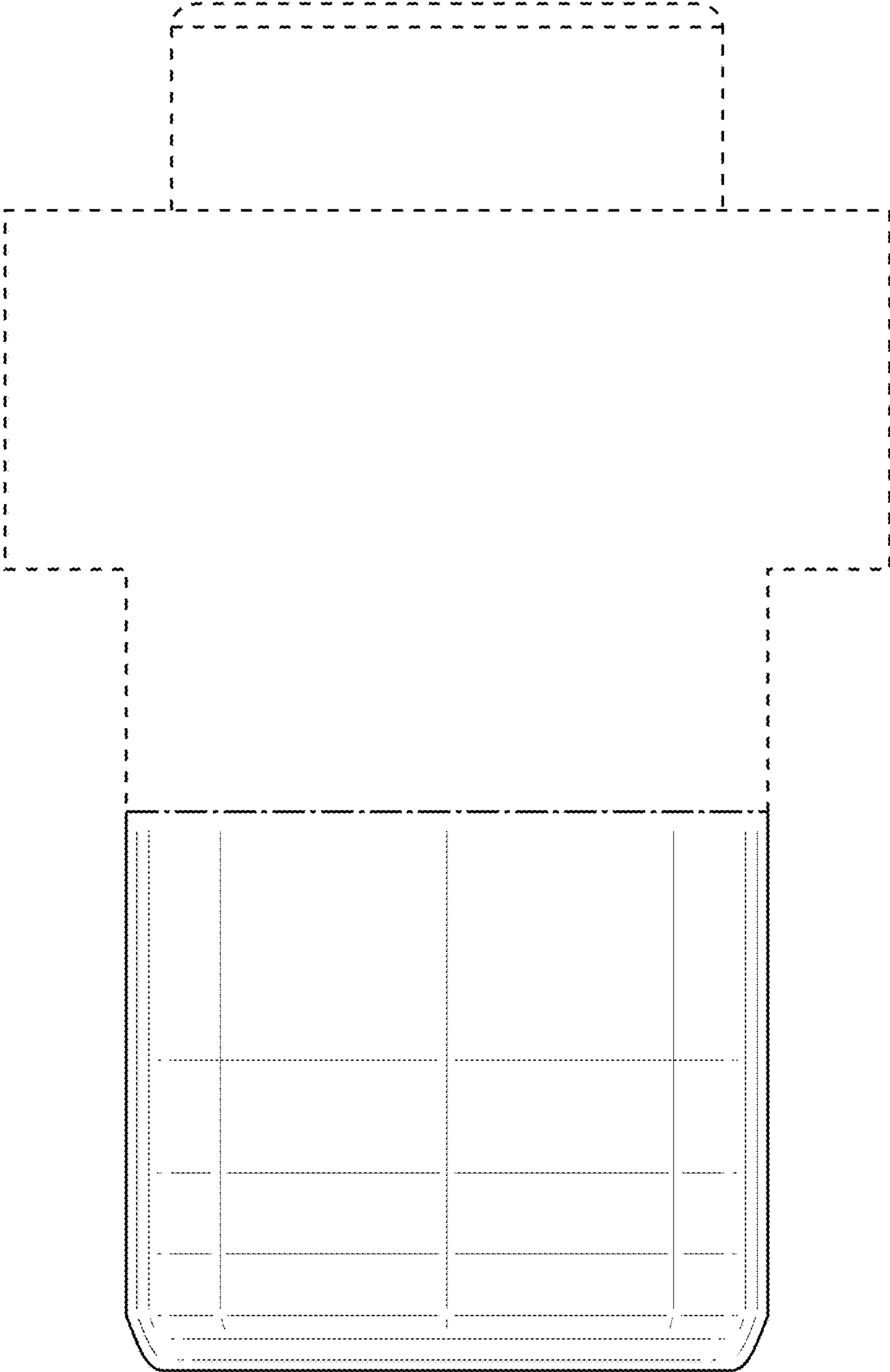

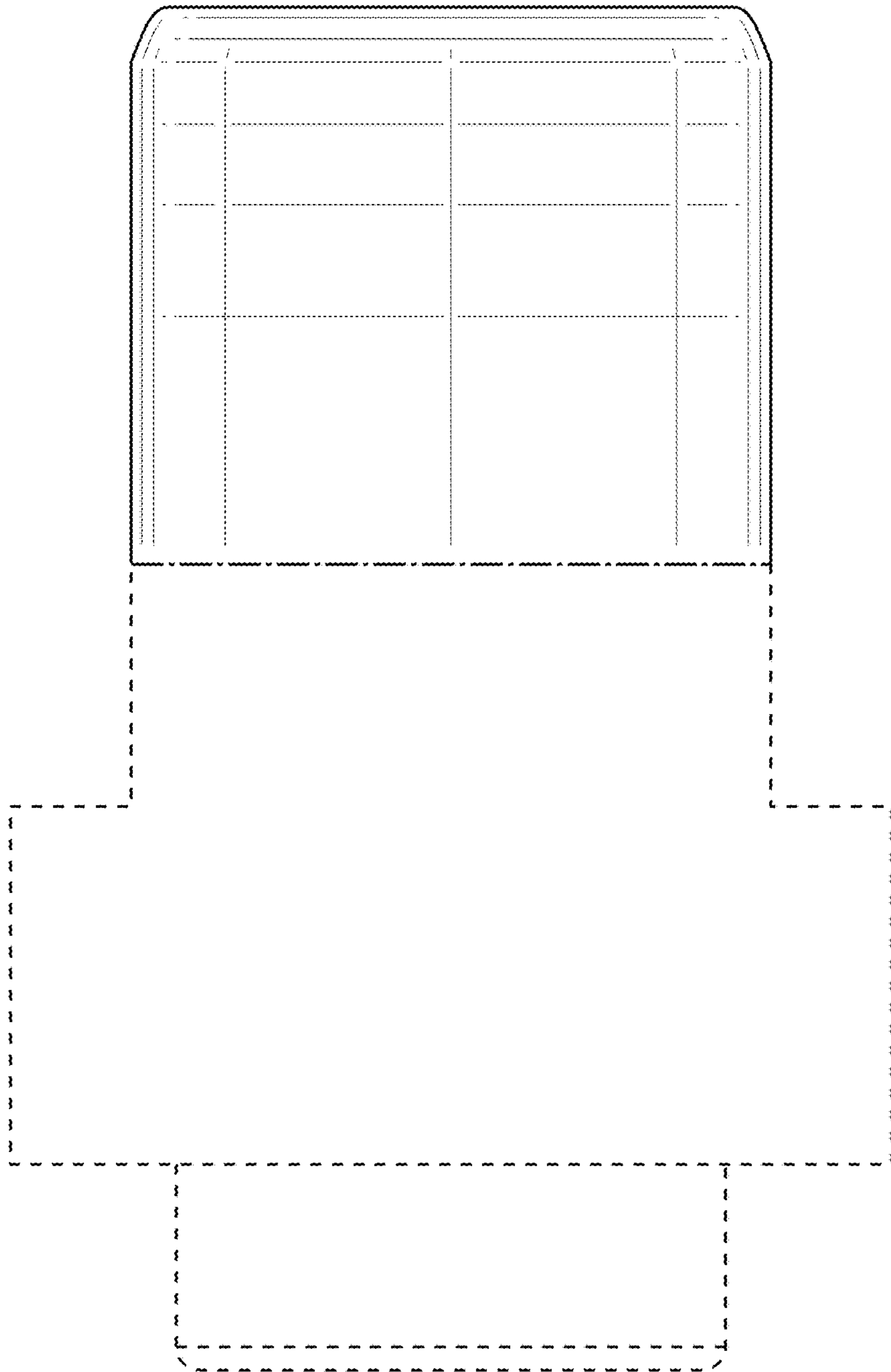

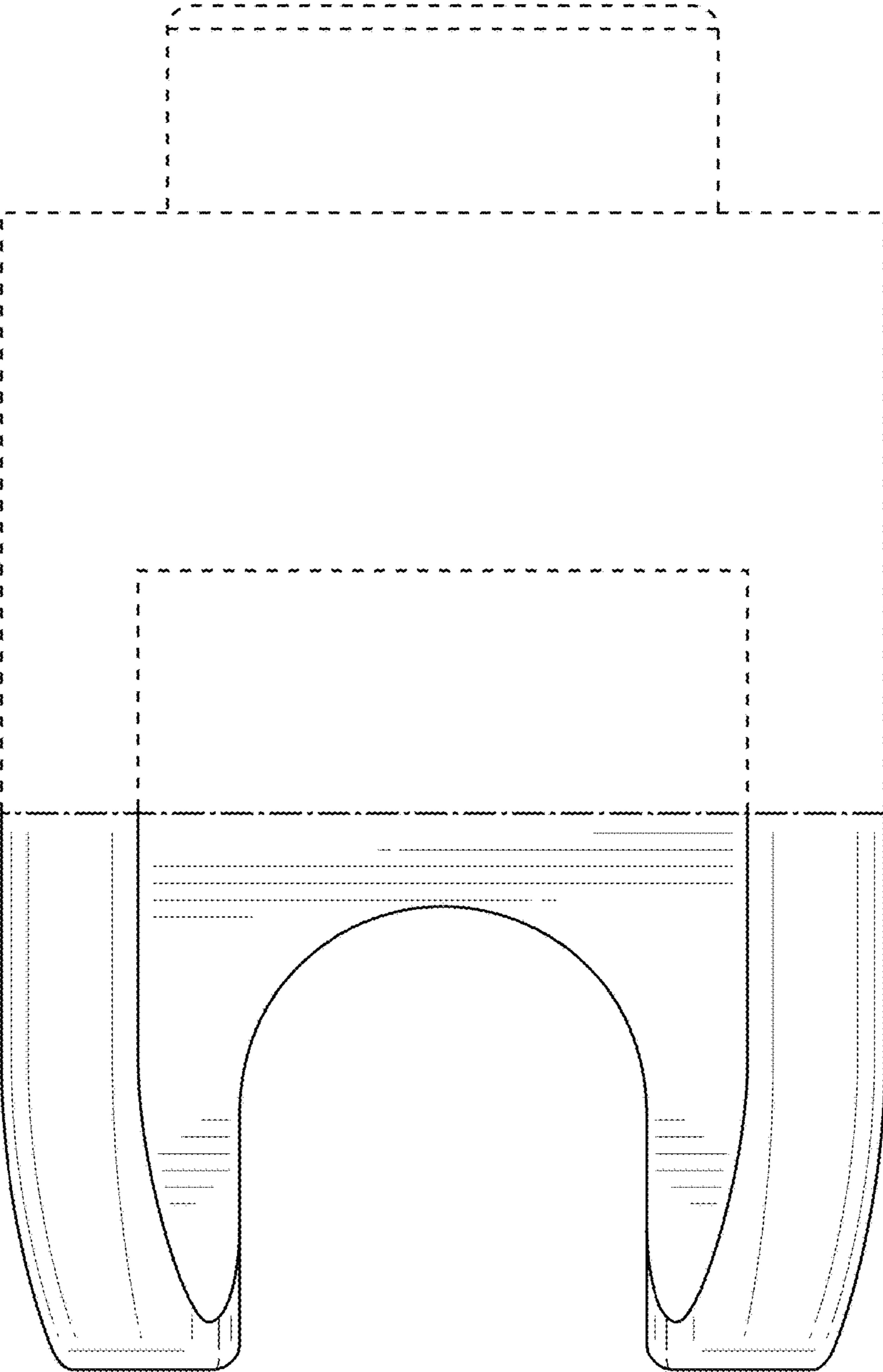

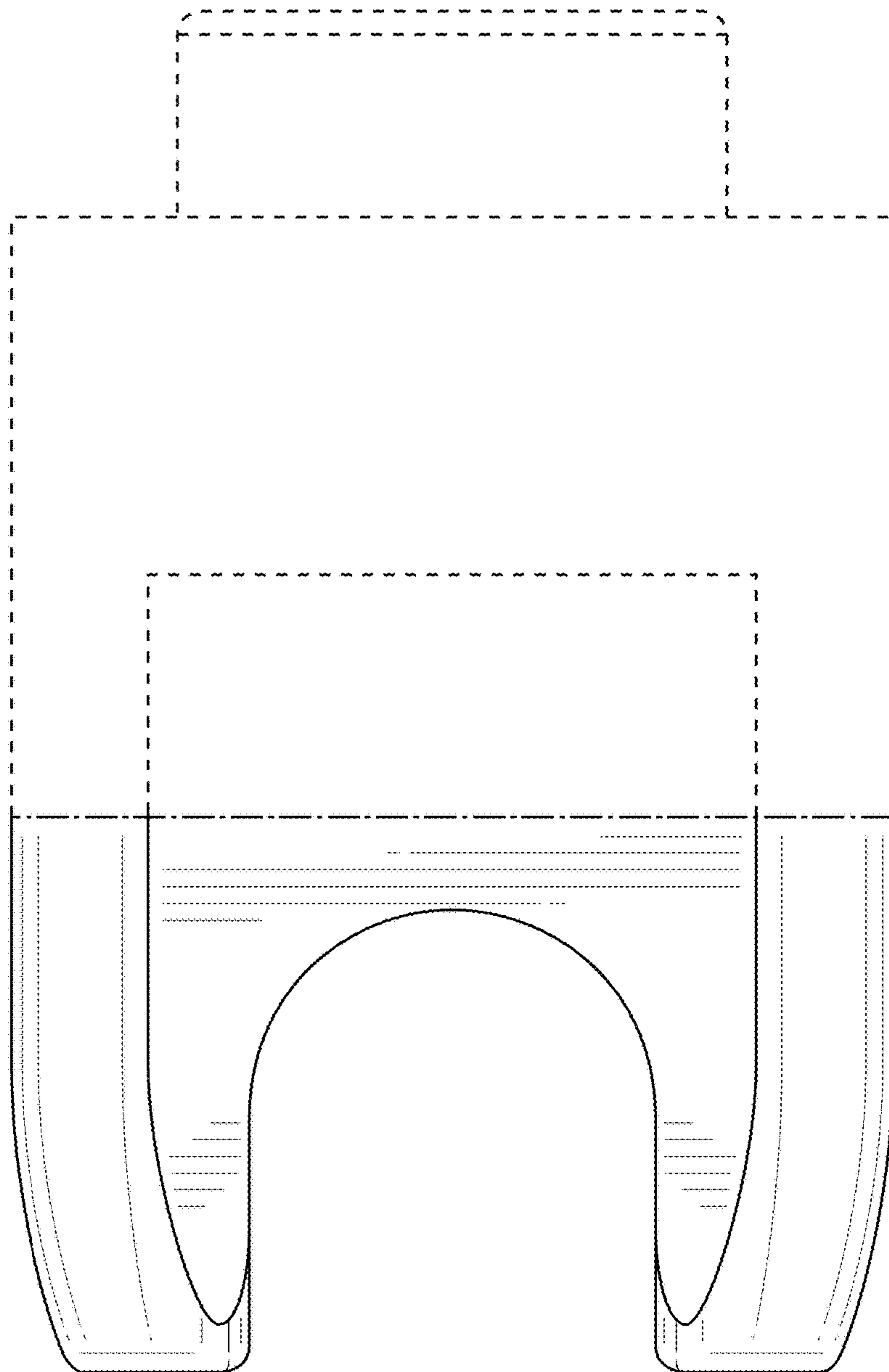
