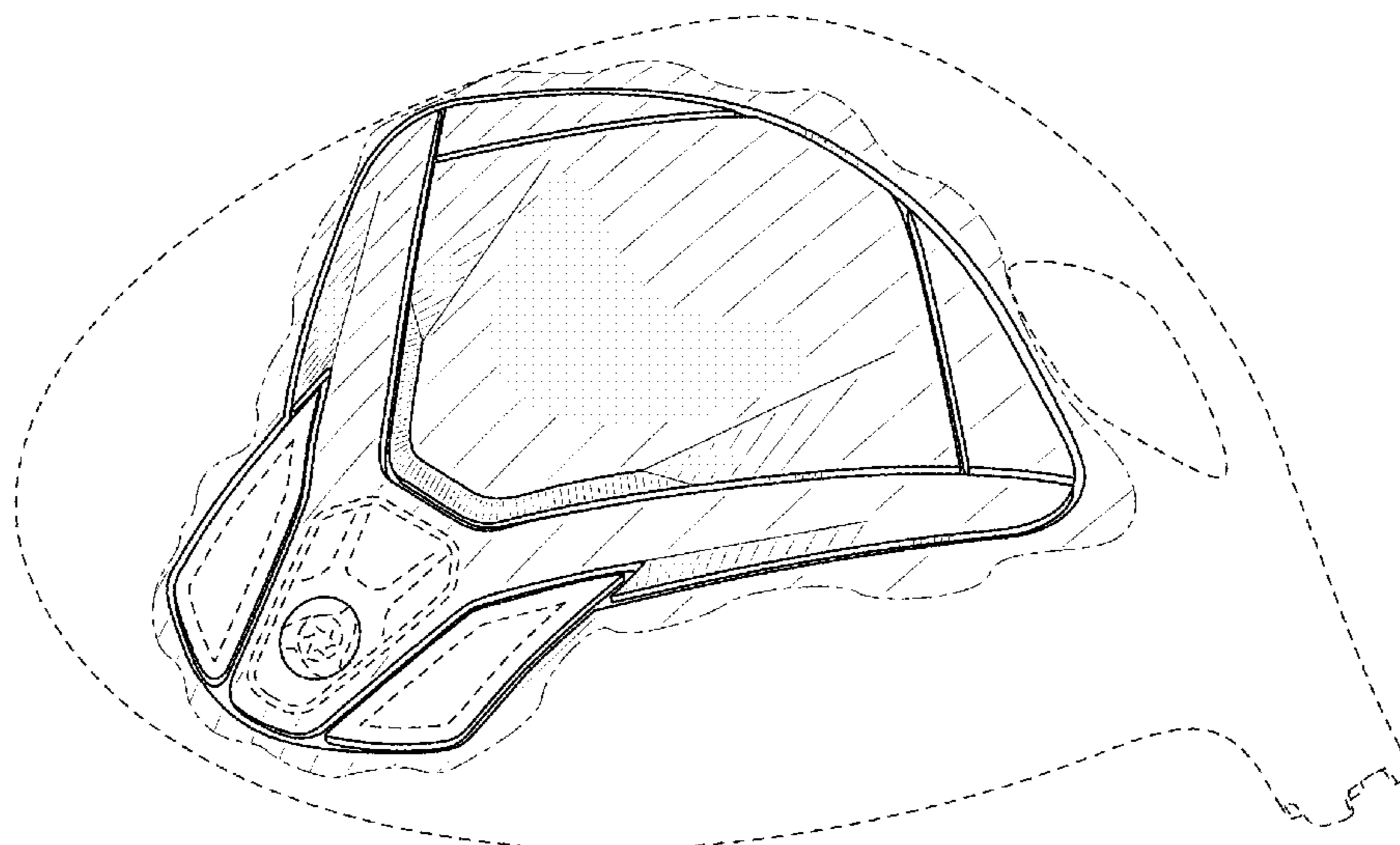
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective sole bottom view of my new design for a golf club head;
FIG. 2 is a front view thereof;
FIG. 3 is a sole view thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a back view thereof;
FIG. 6 is a toe view thereof; and,
FIG. 7 is a heel view thereof.

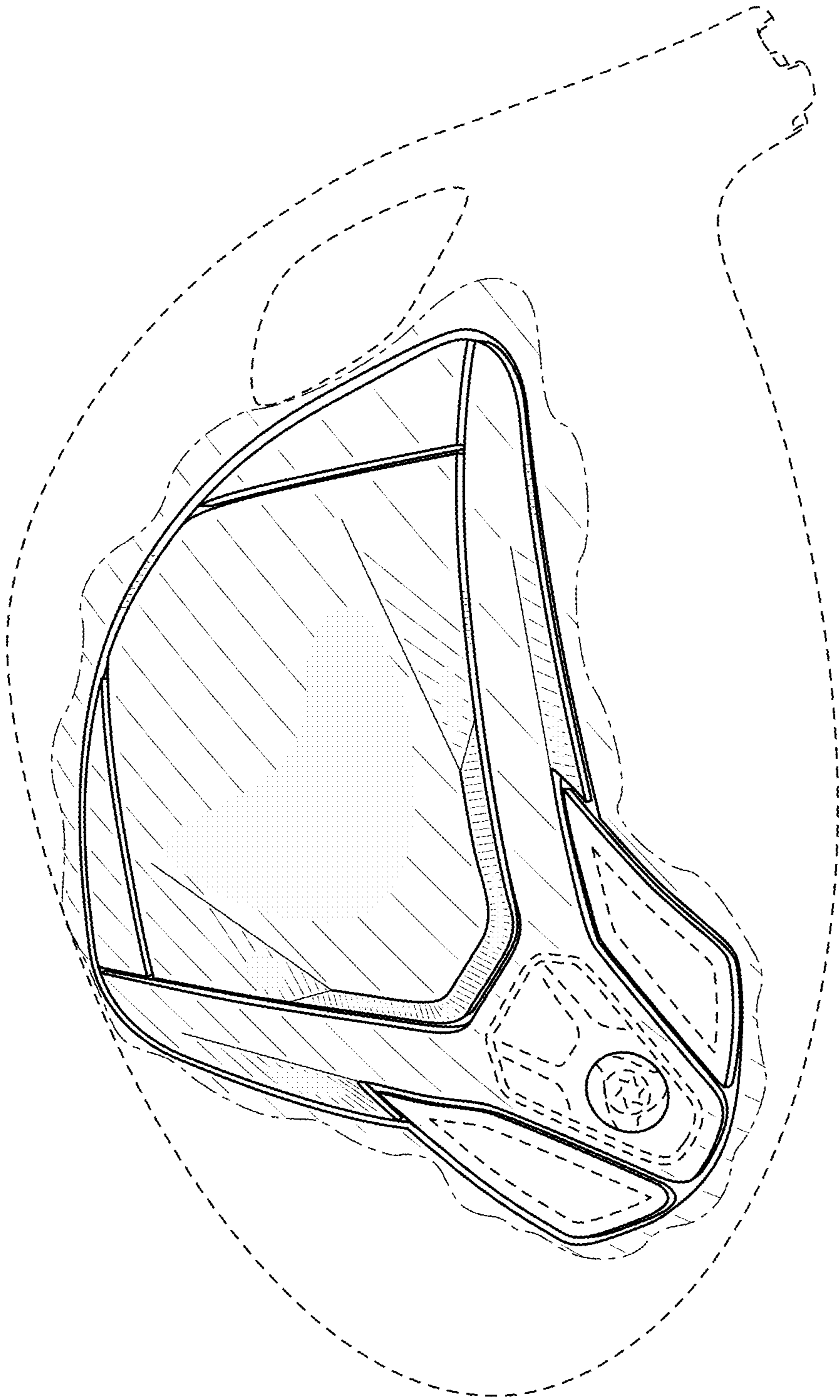

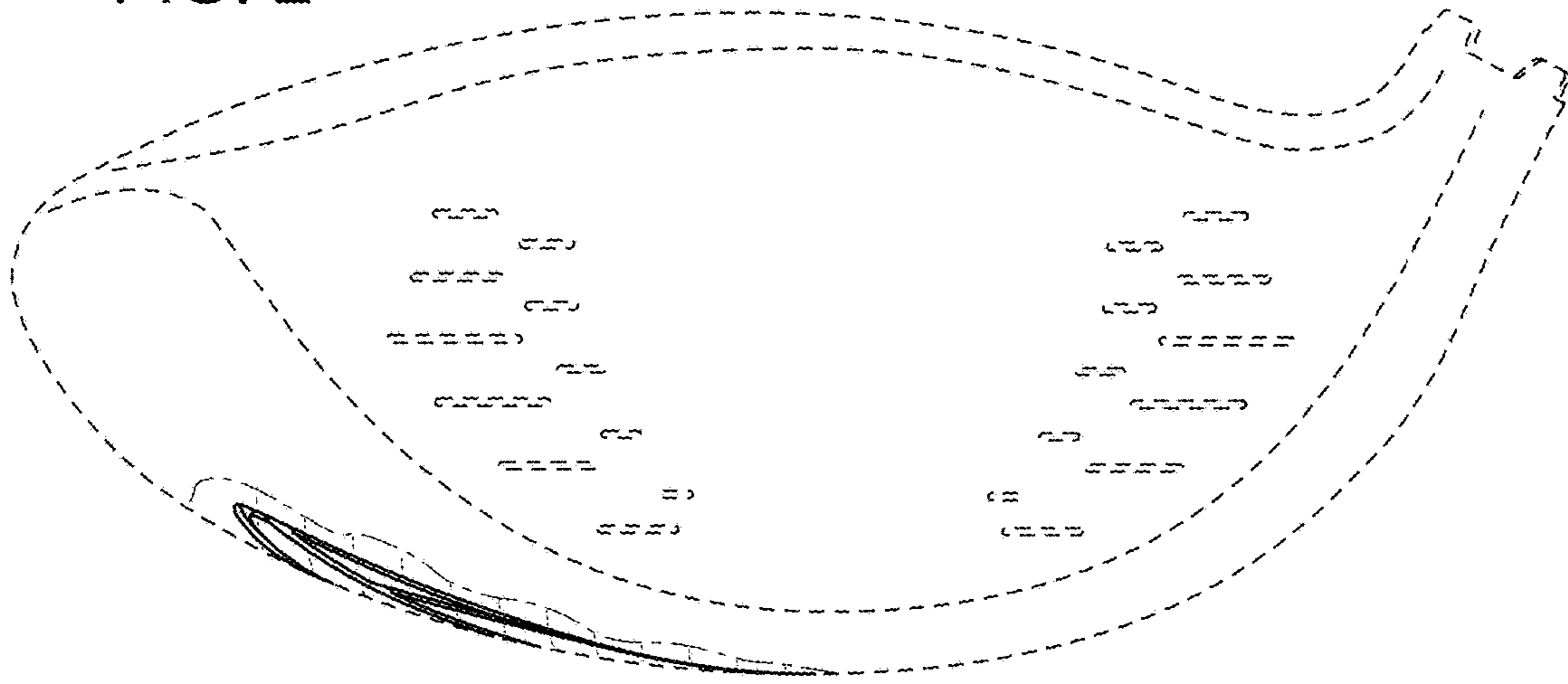

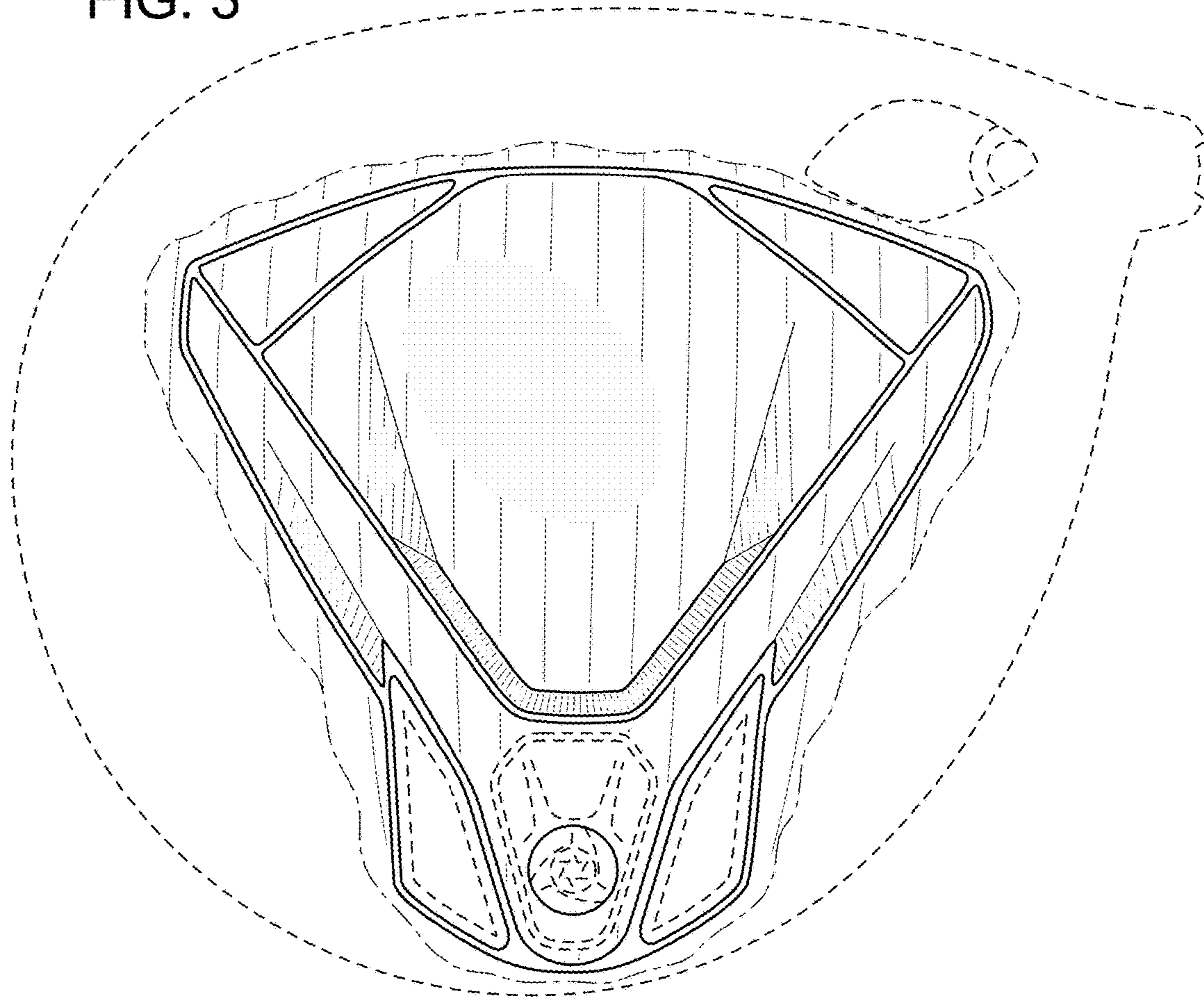

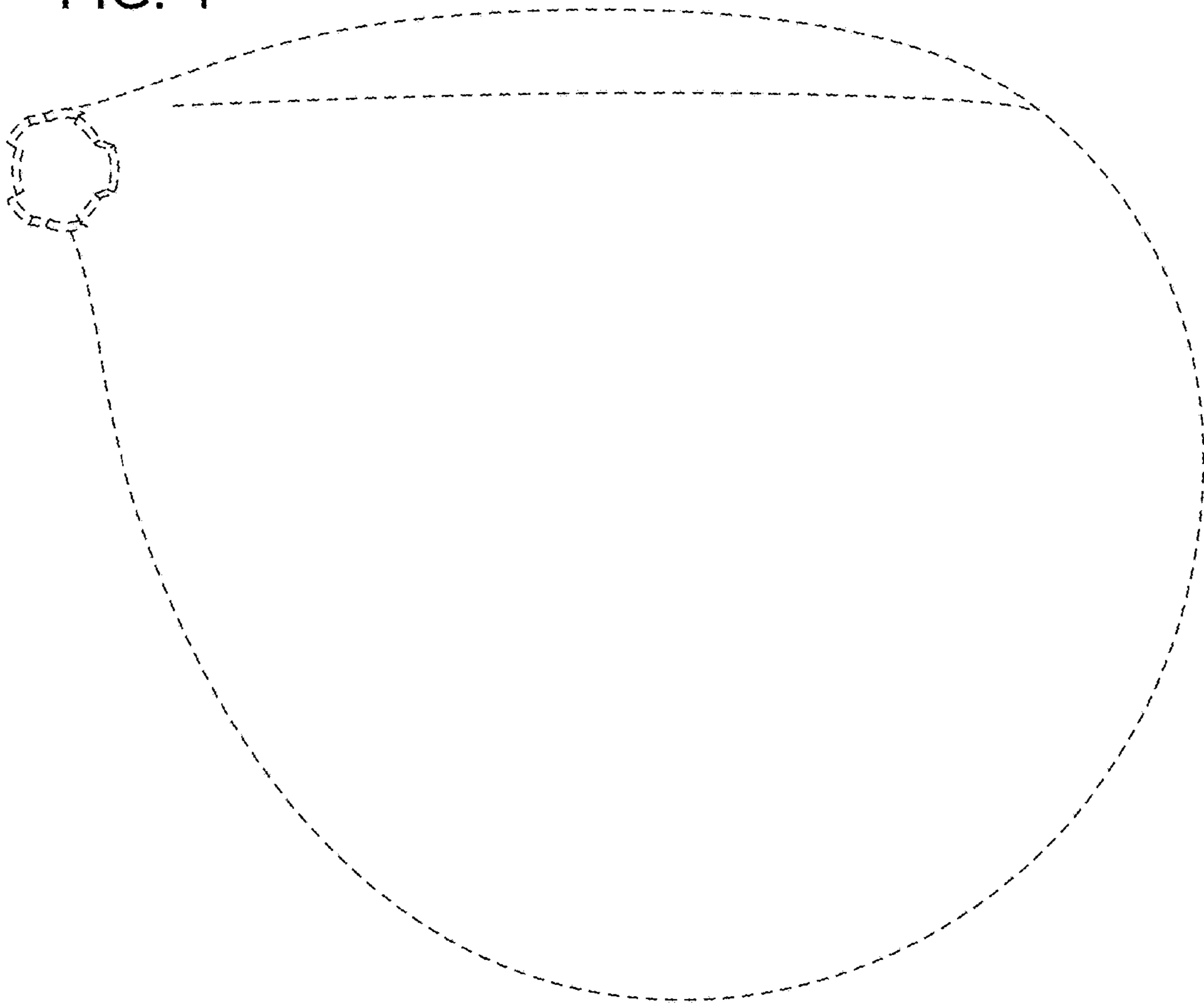

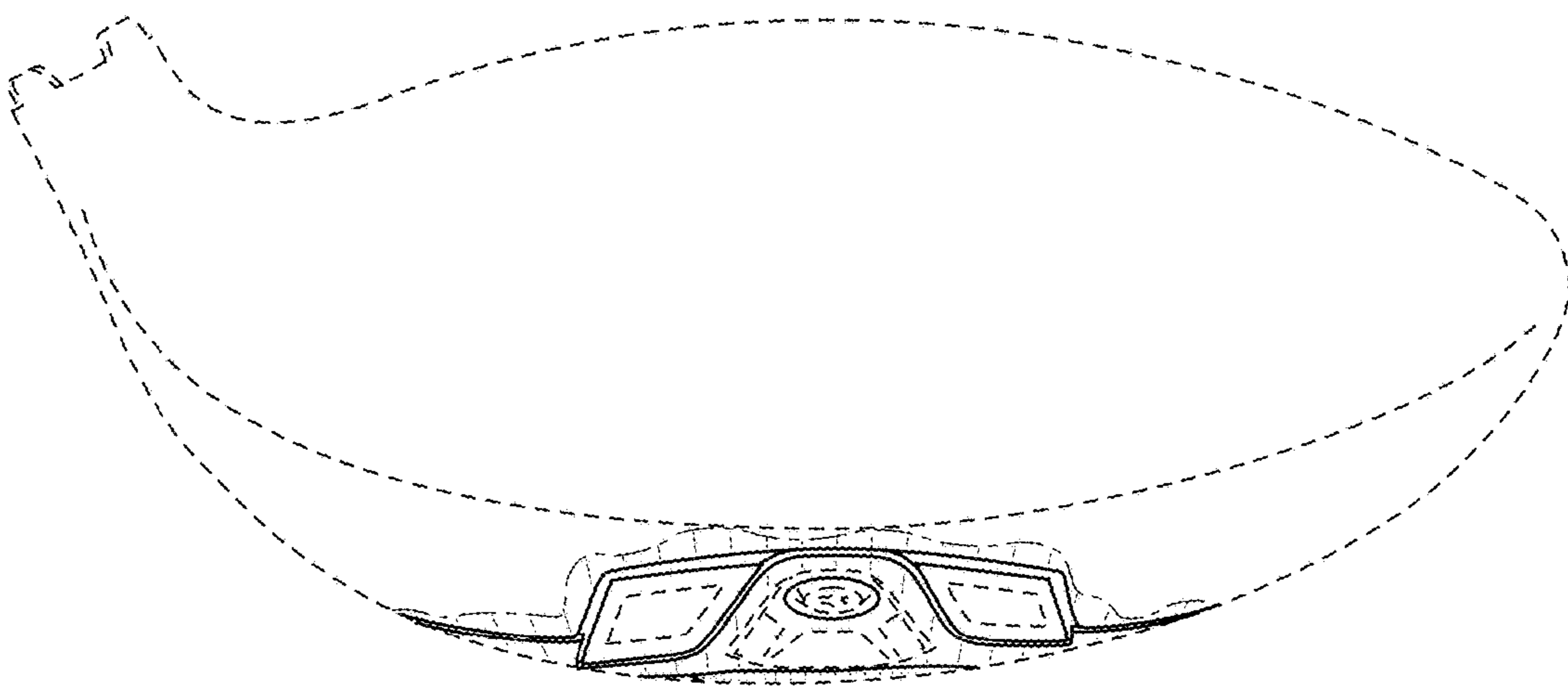

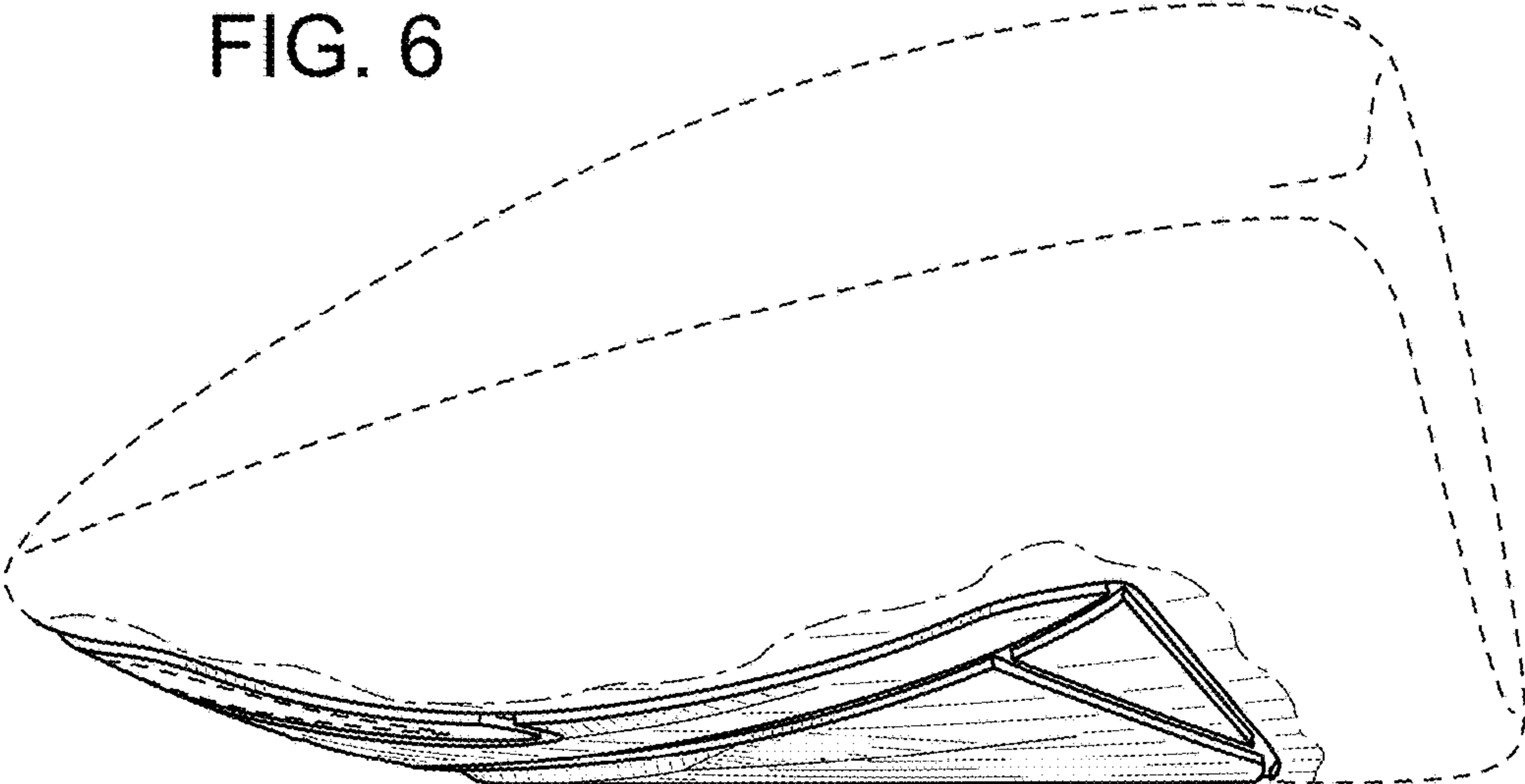
