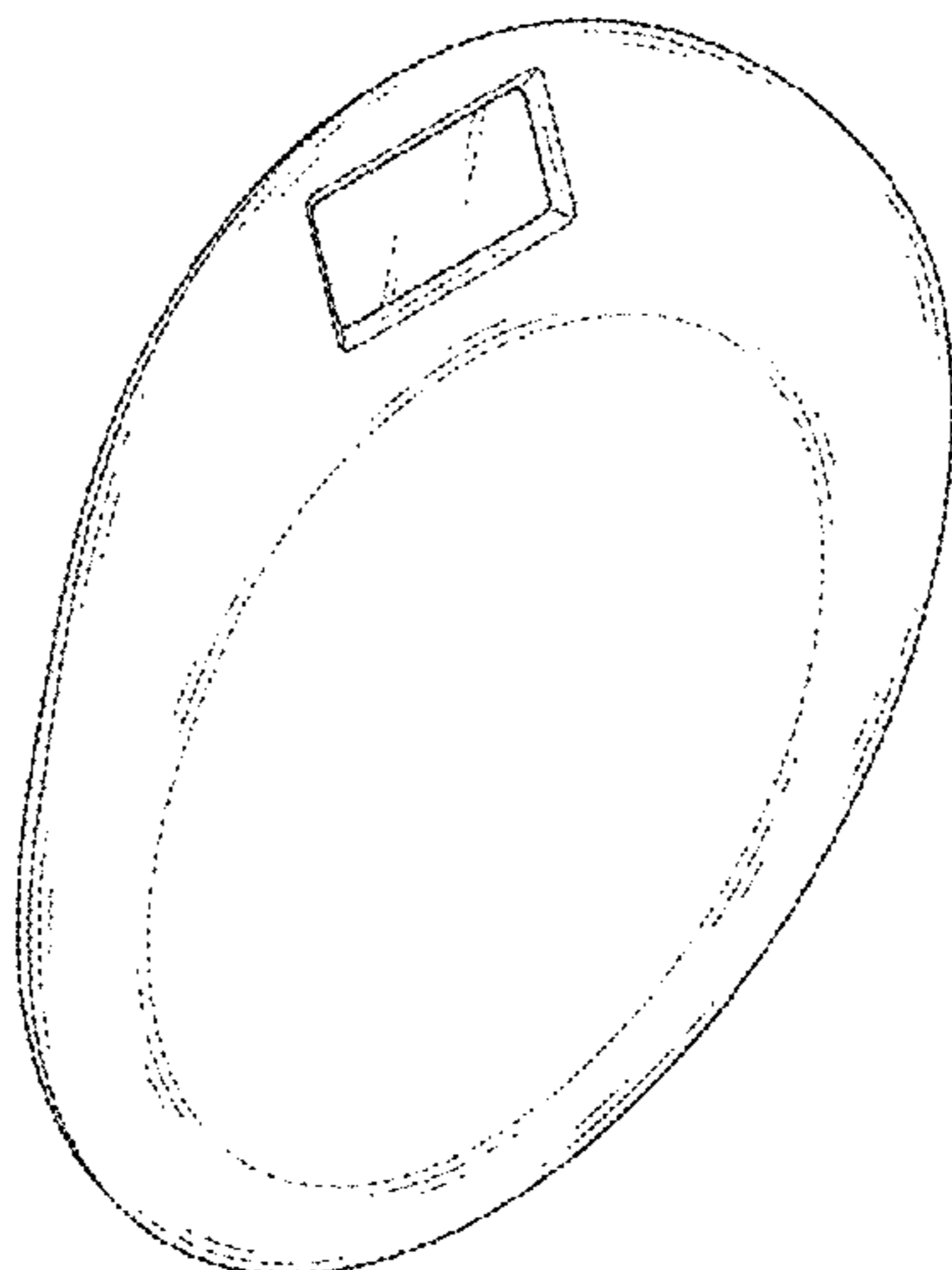
(57) **CLAIM**

The ornamental design for a door for washing machine, as shown and described.

**DESCRIPTION**

1. Door for washing machine  
1.1 is a top, front, and left side perspective view of a door for washing machine showing our new design;  
1.2 is a front elevation view thereof;  
1.3 is a rear elevation view thereof;  
1.4 is a left side elevation view thereof;  
1.5 is a right side elevation view thereof;  
1.6 is a top plan view thereof; and  
1.7 is a bottom plan view thereof.  
The broken lines in the reproductions illustrate portions of the door for washing machine that form no part of the claimed design.

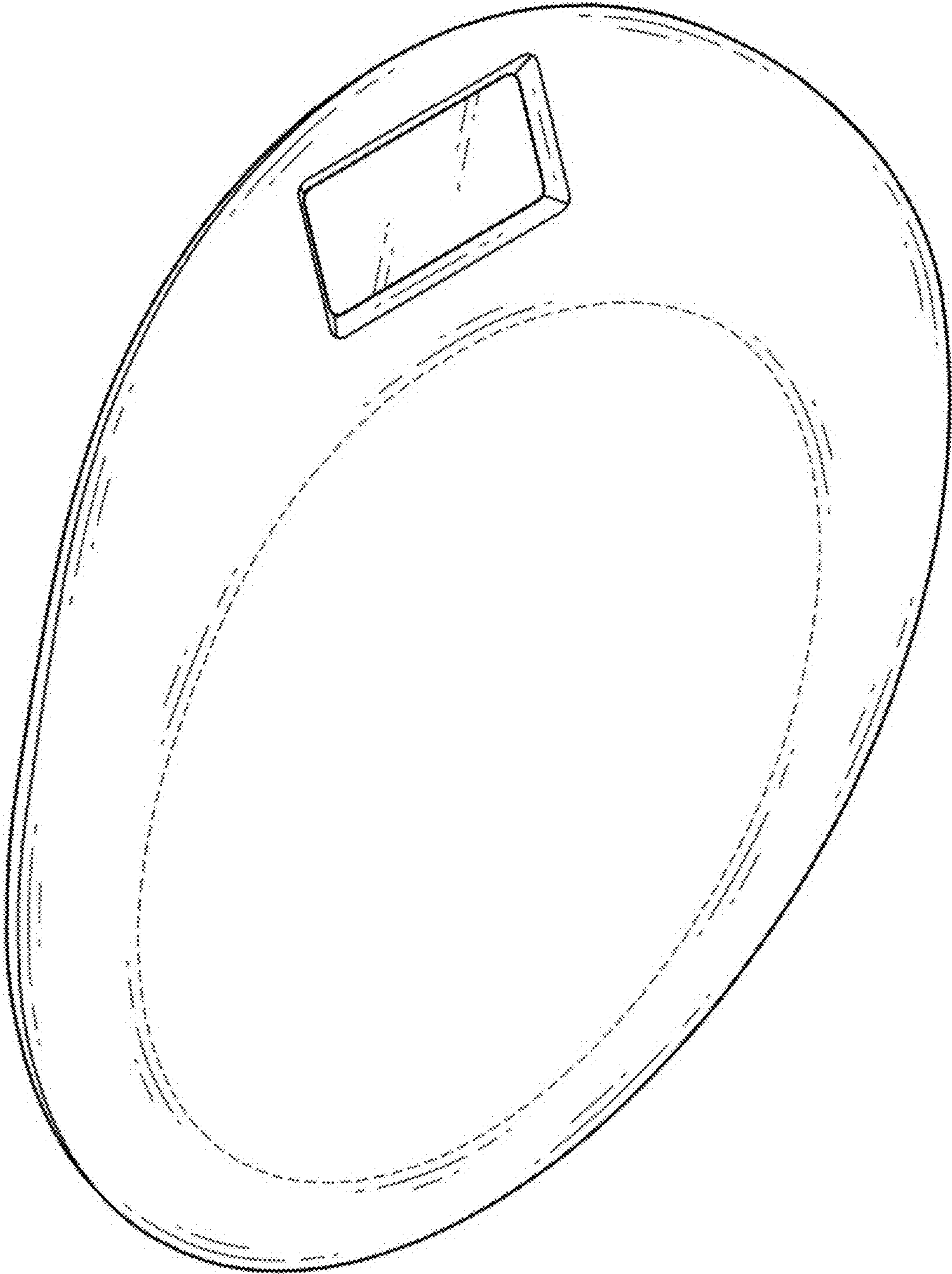

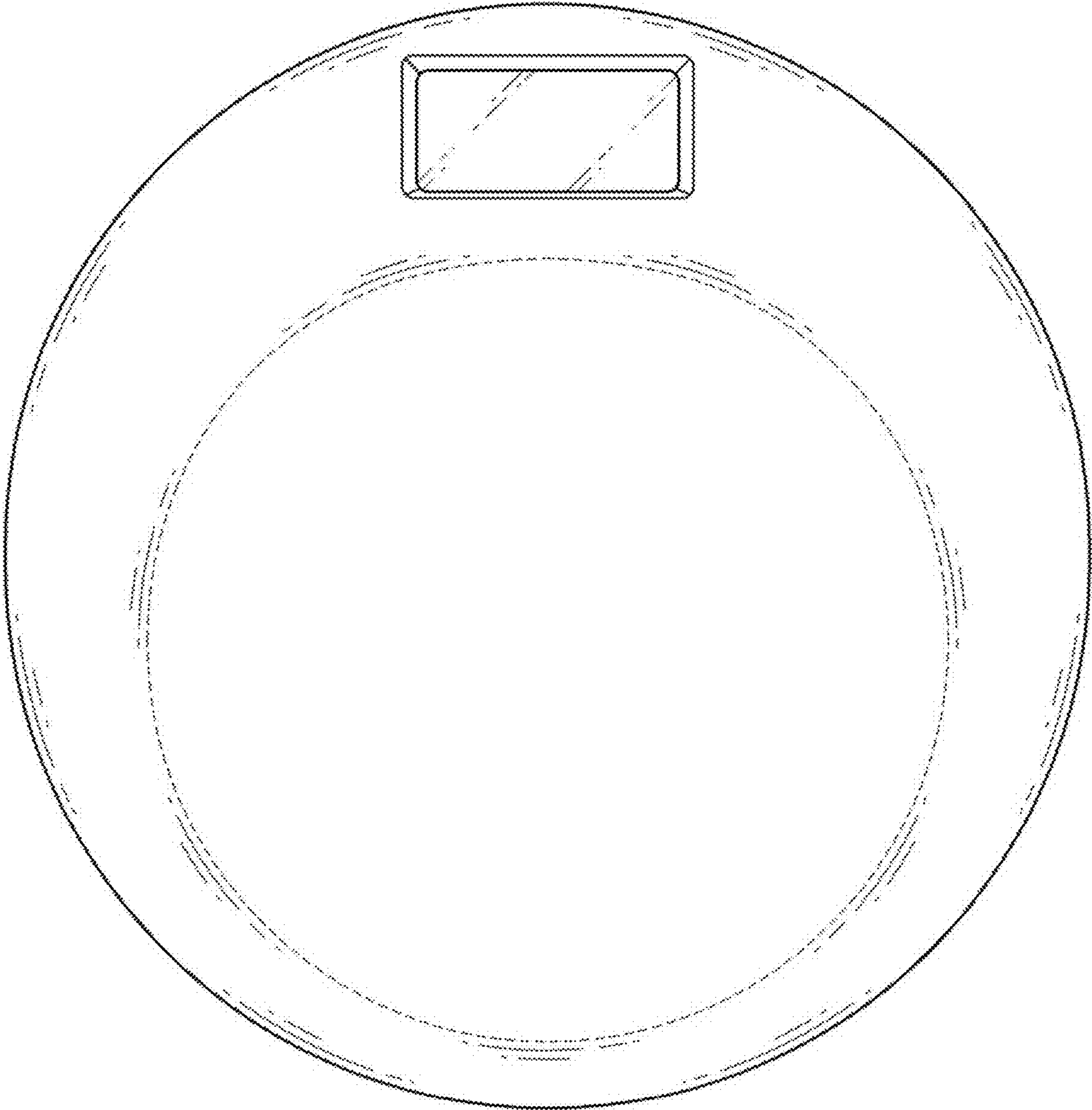

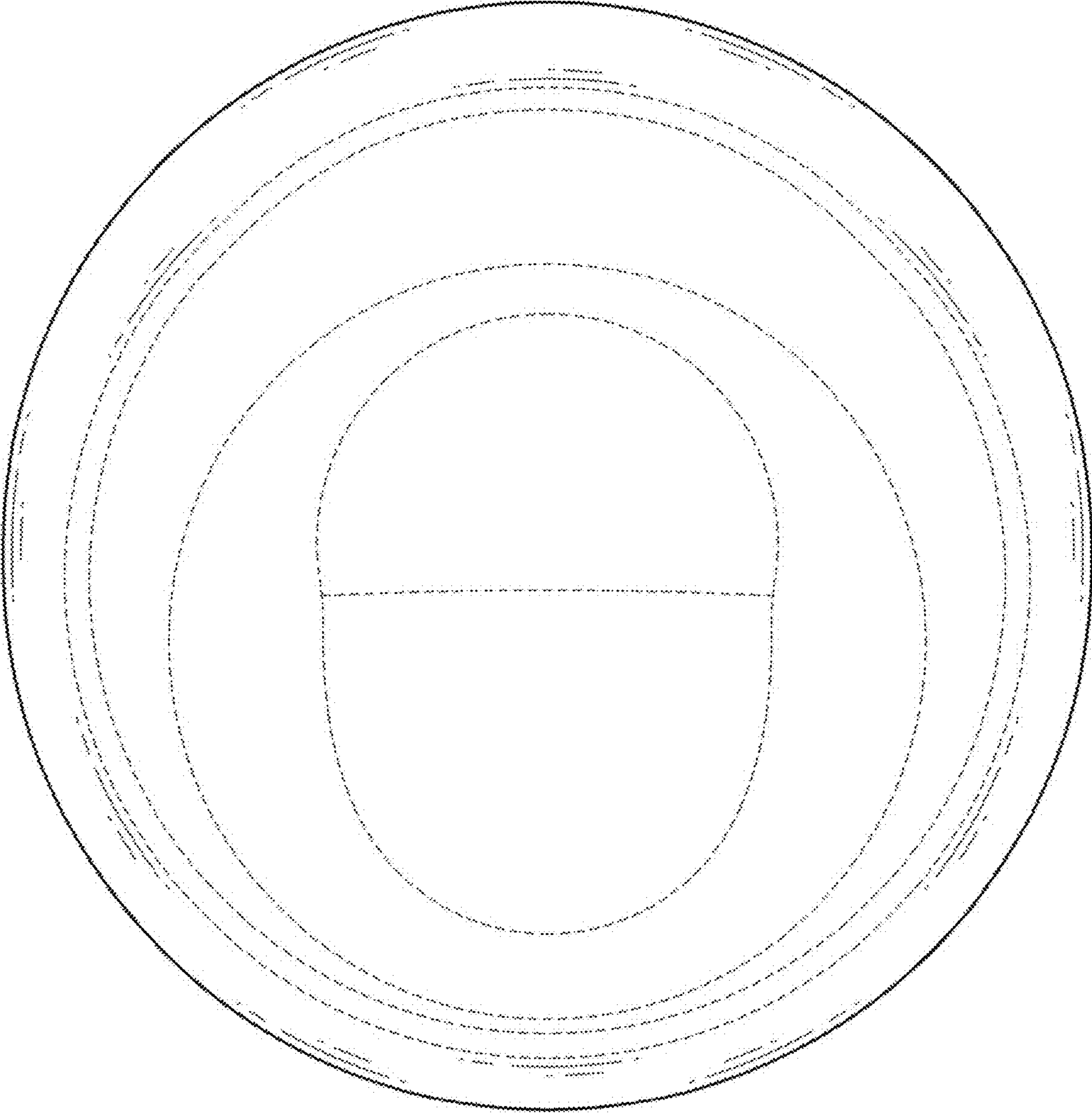

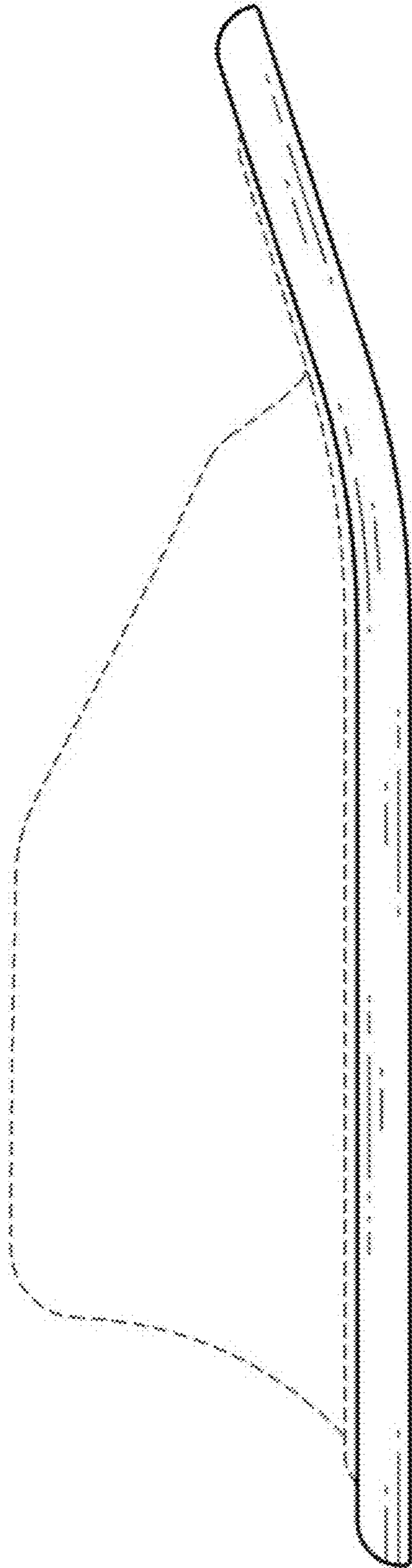

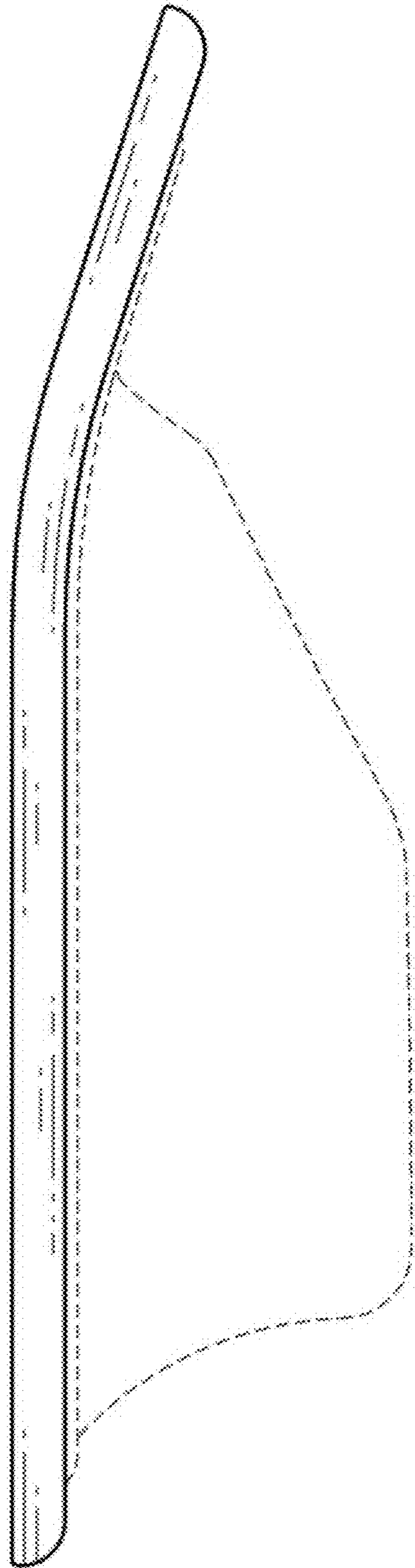

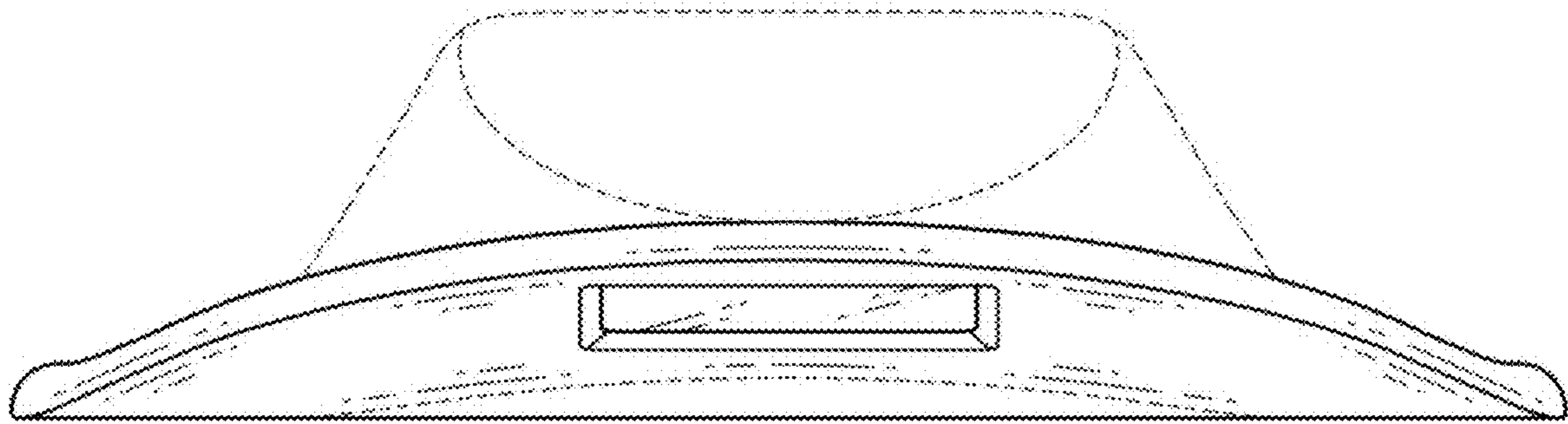
