(57) **CLAIM**

The ornamental design for pants, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a pair of pants showing my new design;

FIG. 2 is an enlarged front view of the waistband of the pants;

FIG. 3 is a front view of the pants with the pockets spread open;

FIG. 4 is a right view of the pants;

FIG. 5 is a right view of the pants with the upper leg zipper partially unzipped from the knee portion;

FIG. 6 is a front view of the pants with the knee zippers fully unzipped;

FIG. 7 is a right view of the pants with the lower leg zipper partially unzipped;

FIG. 8 is a front view of the pants with the right lower leg zipper fully unzipped;

FIG. 9 is a front view of the pants with the upper leg zippers unzipped from their respective knee portions to the waistband, the knee zippers fully unzipped, and the lower leg zippers fully unzipped;

FIG. 10 is a front view of the upper portion of the pants with the knee zippers fully unzipped, the lower leg portions removed, and the upper leg zippers unzipped from their respective knee portions to the waistband;

FIG. 11 is a front view of the pants with the knee zippers fully unzipped and the upper leg zippers partially unzipped from the waistband;

FIG. 12 is a front view of the pants with the knee zippers full unzipped and the upper leg zippers undone from the waistband and respective knee portions;

FIG. 13 is a rear view of the pants;

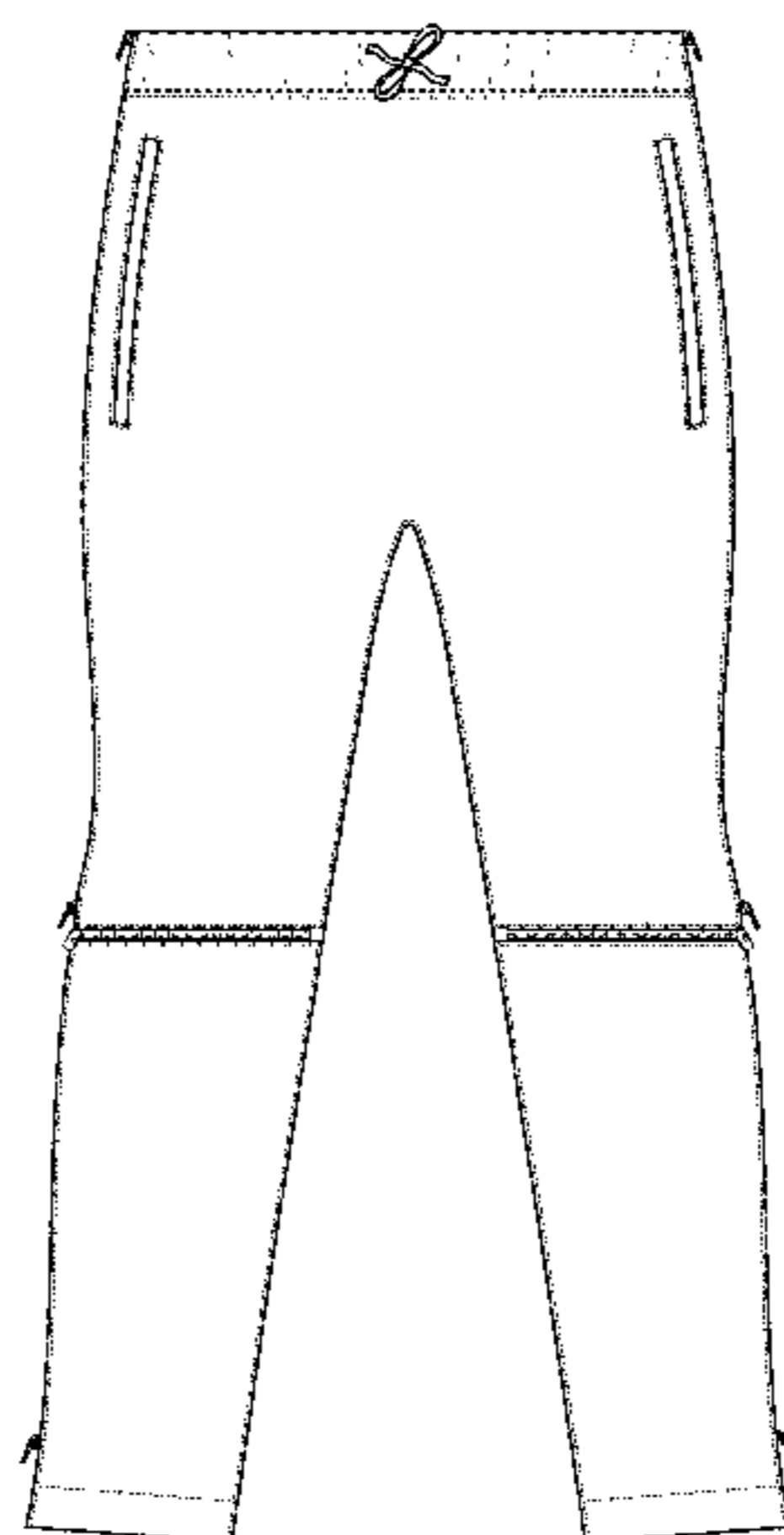
FIG. 14 is an enlarged front view of the left pocket on the front of the pants;

FIG. 15 is a top view of the pants; and,

FIG. 16 is a bottom view of the pants.

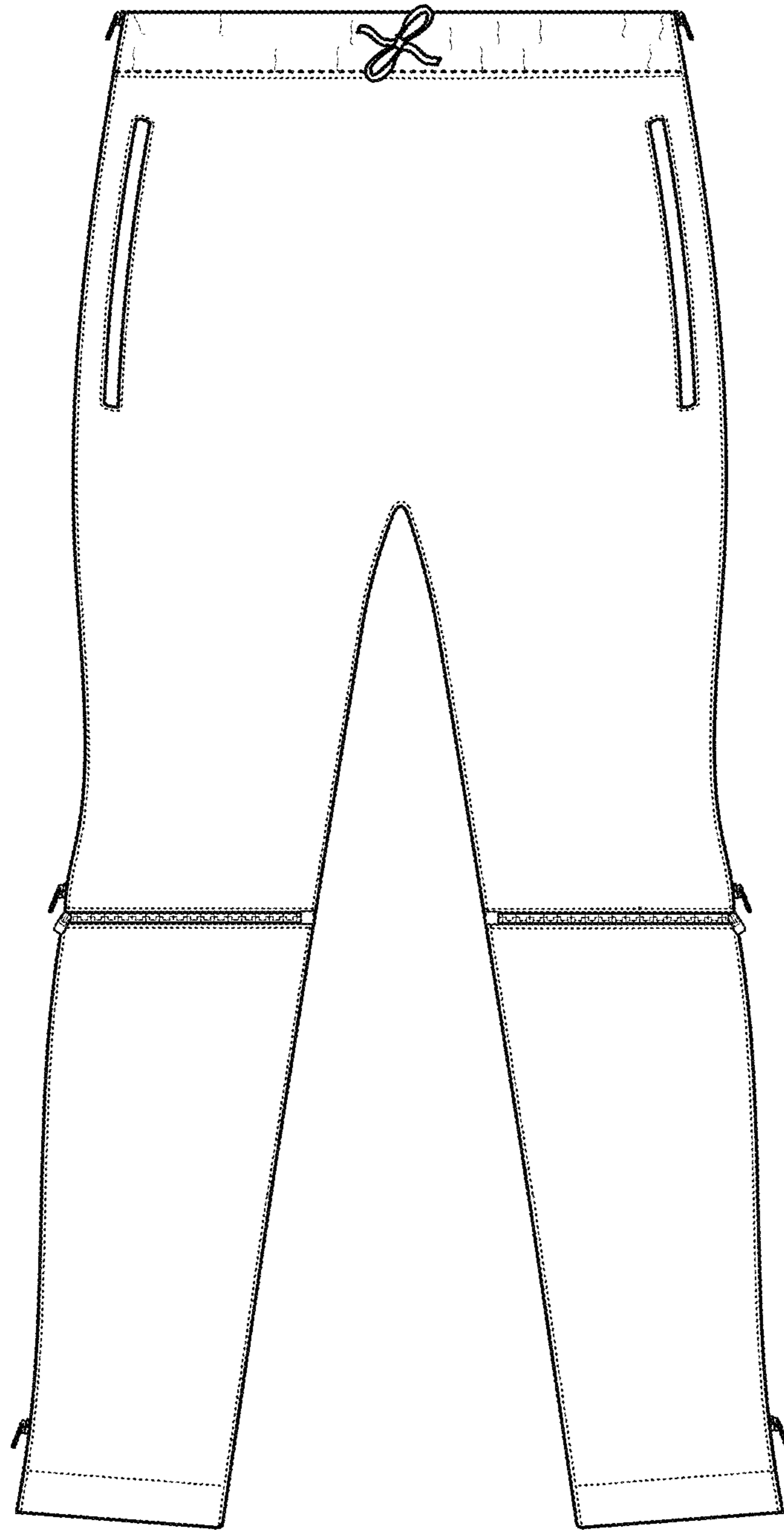

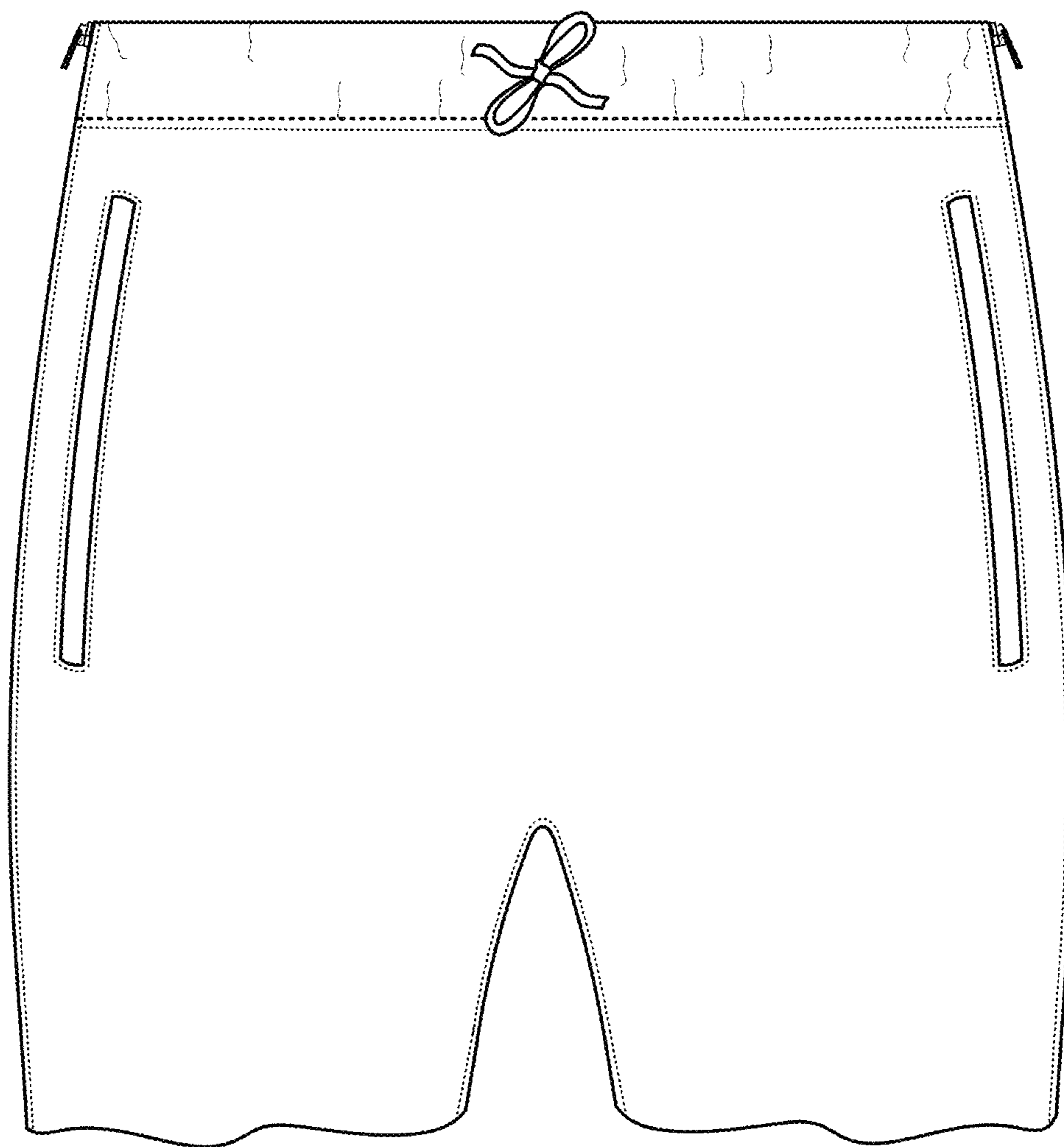

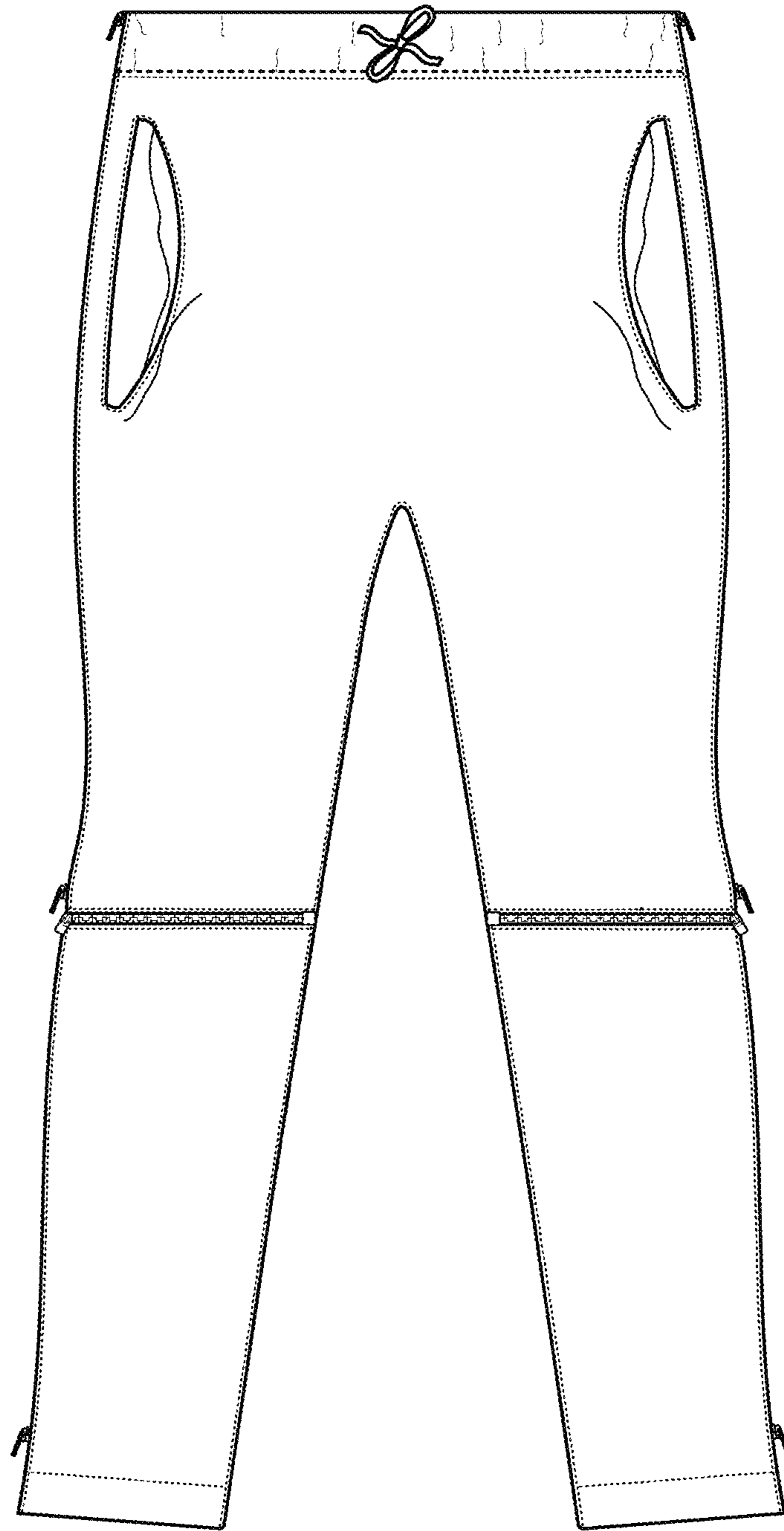

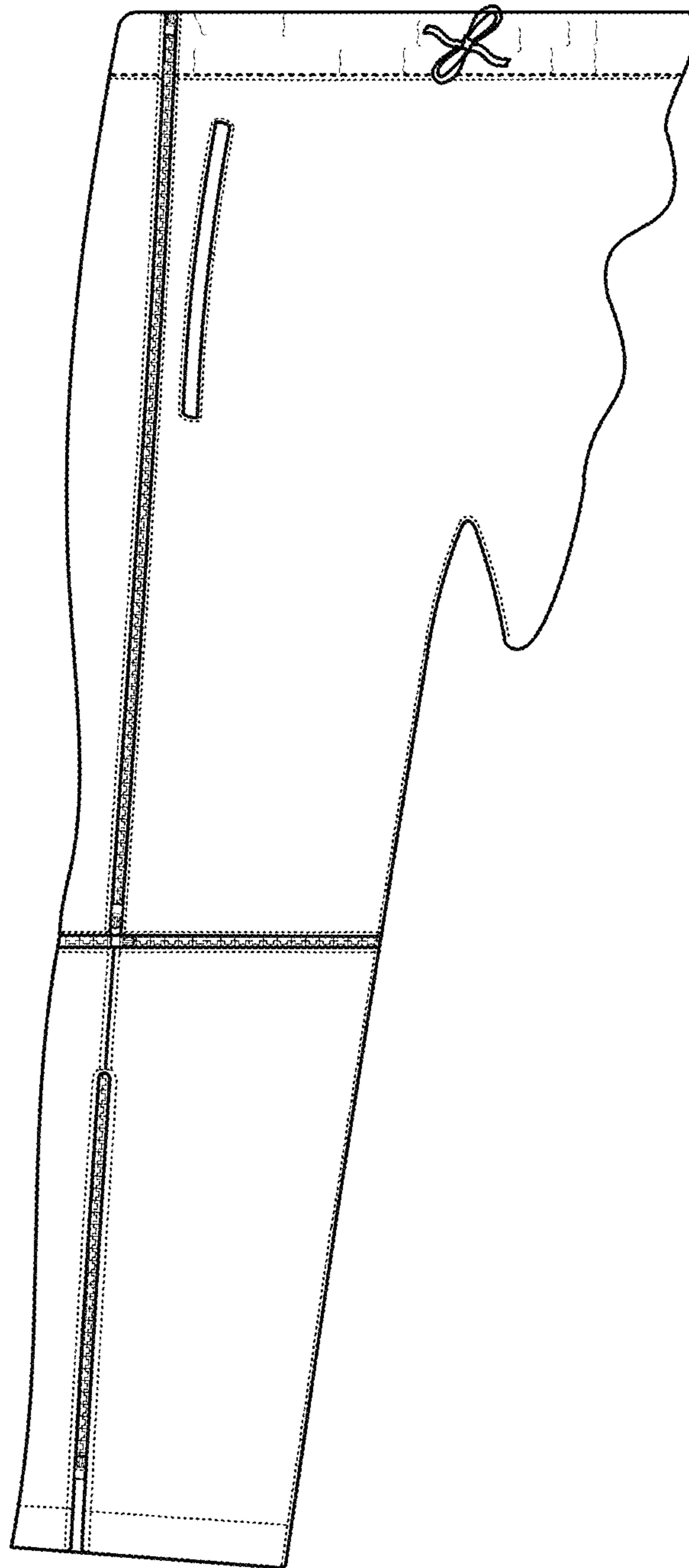

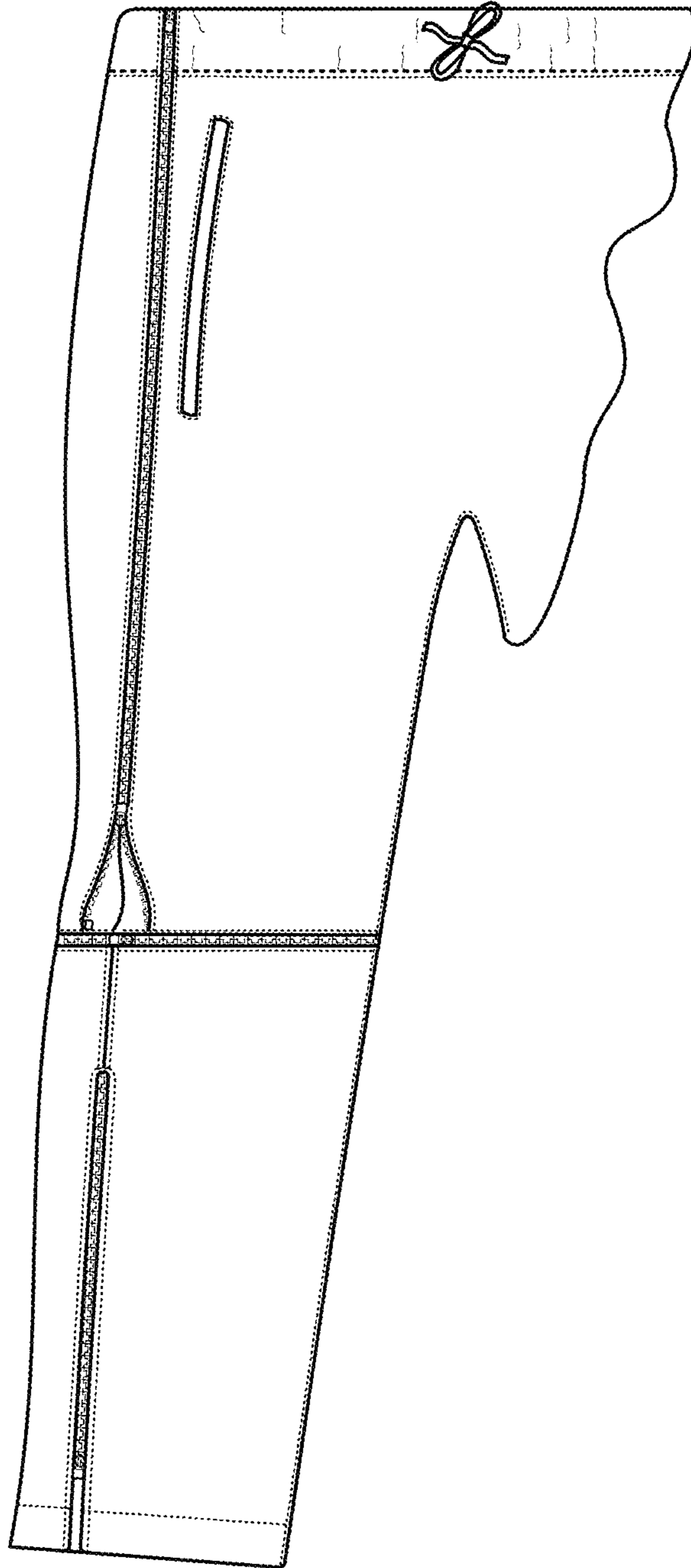

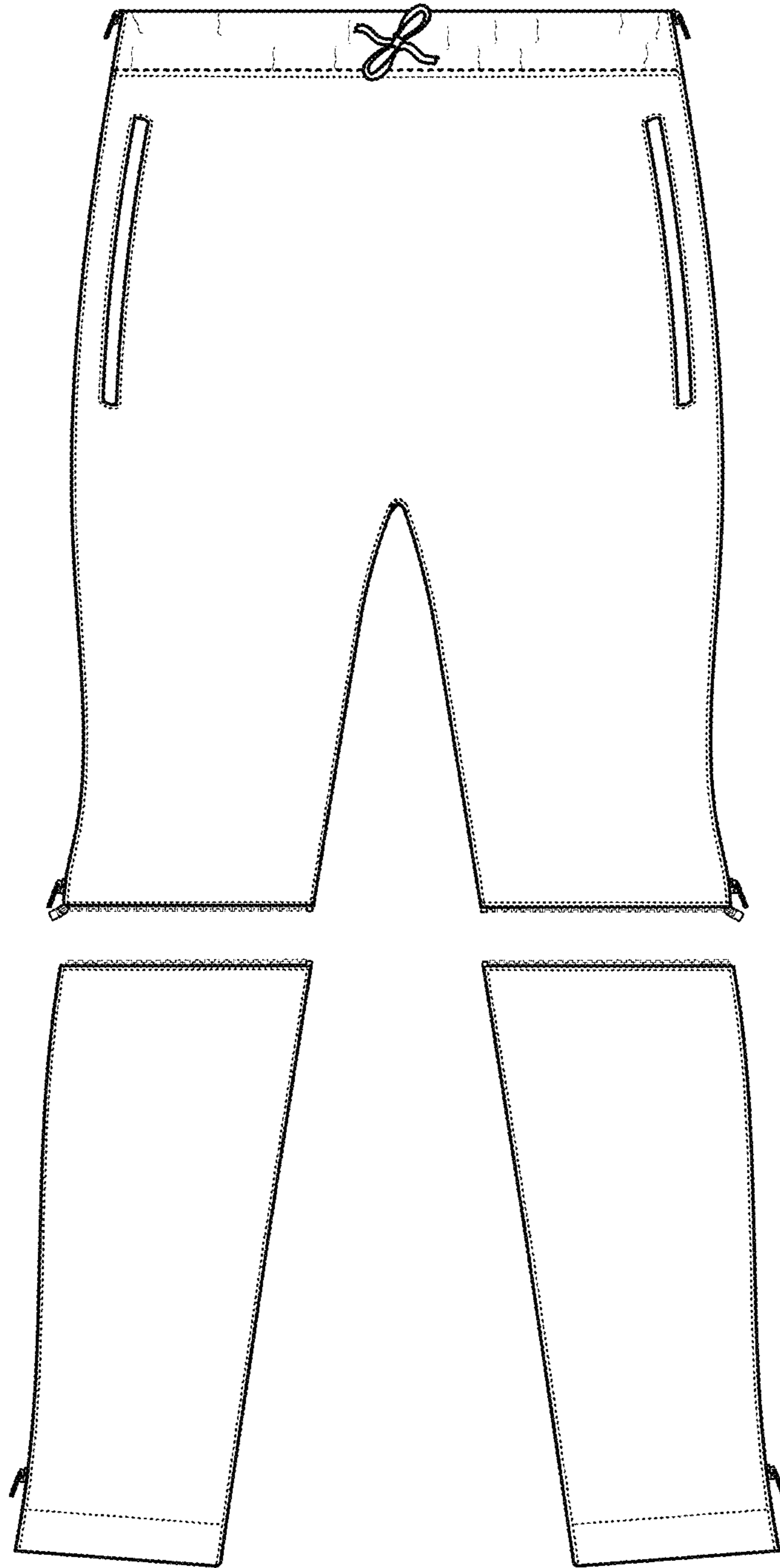

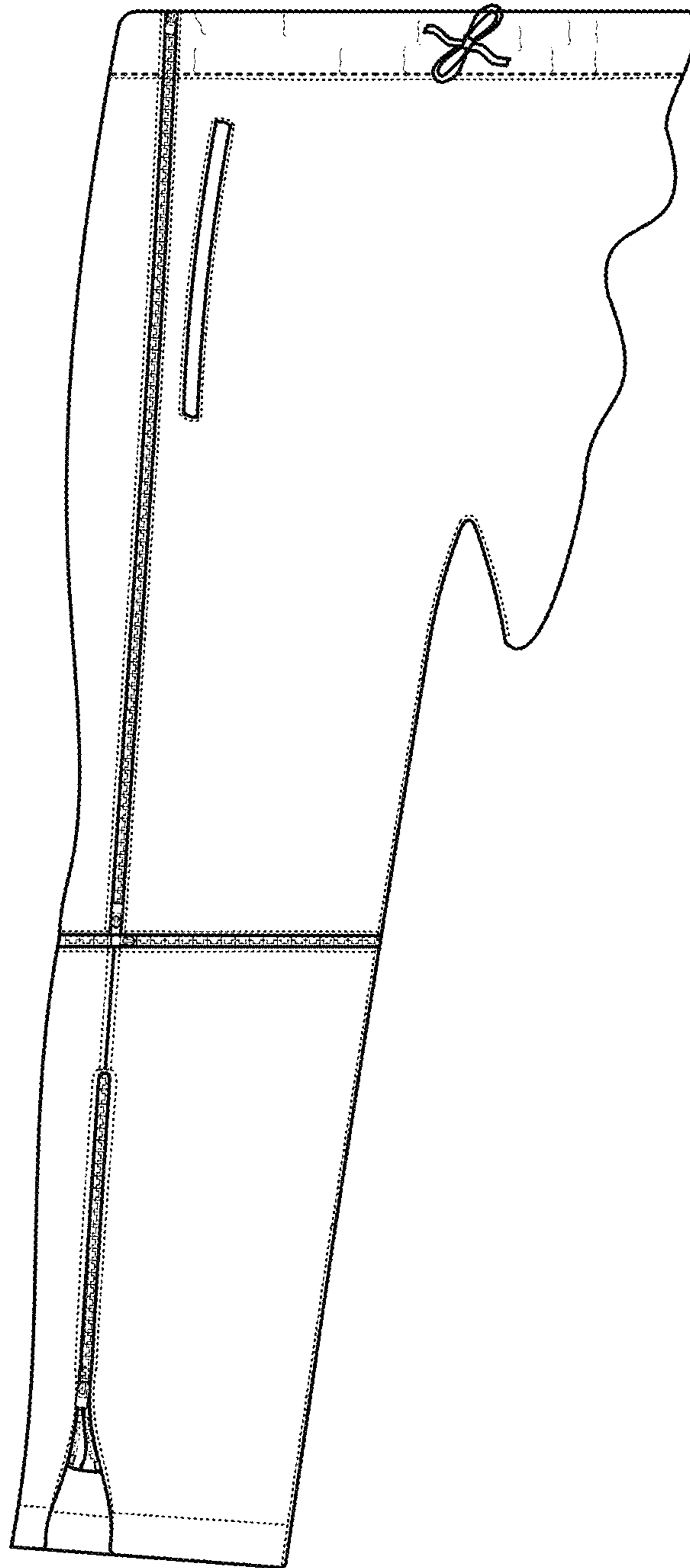

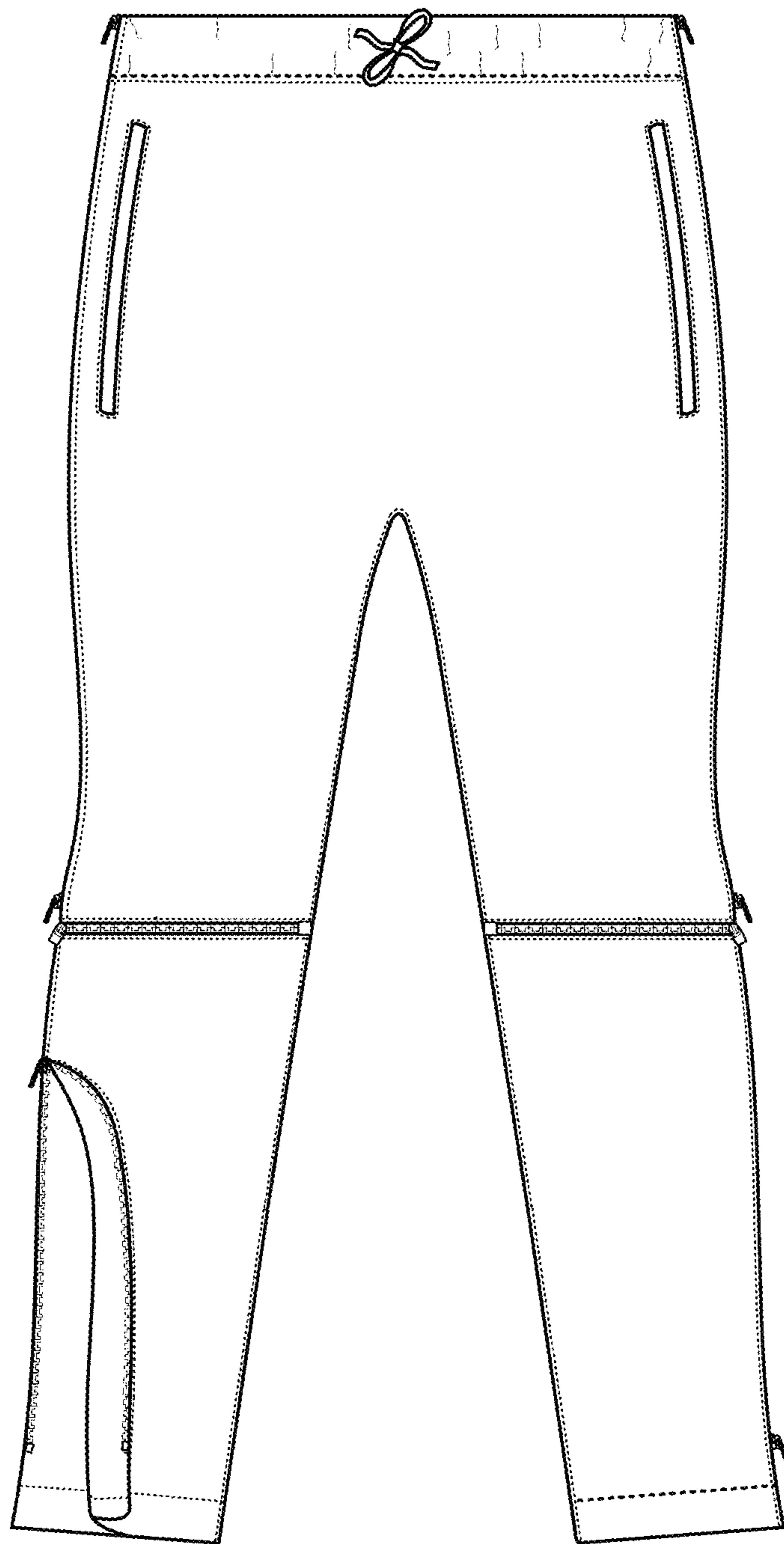

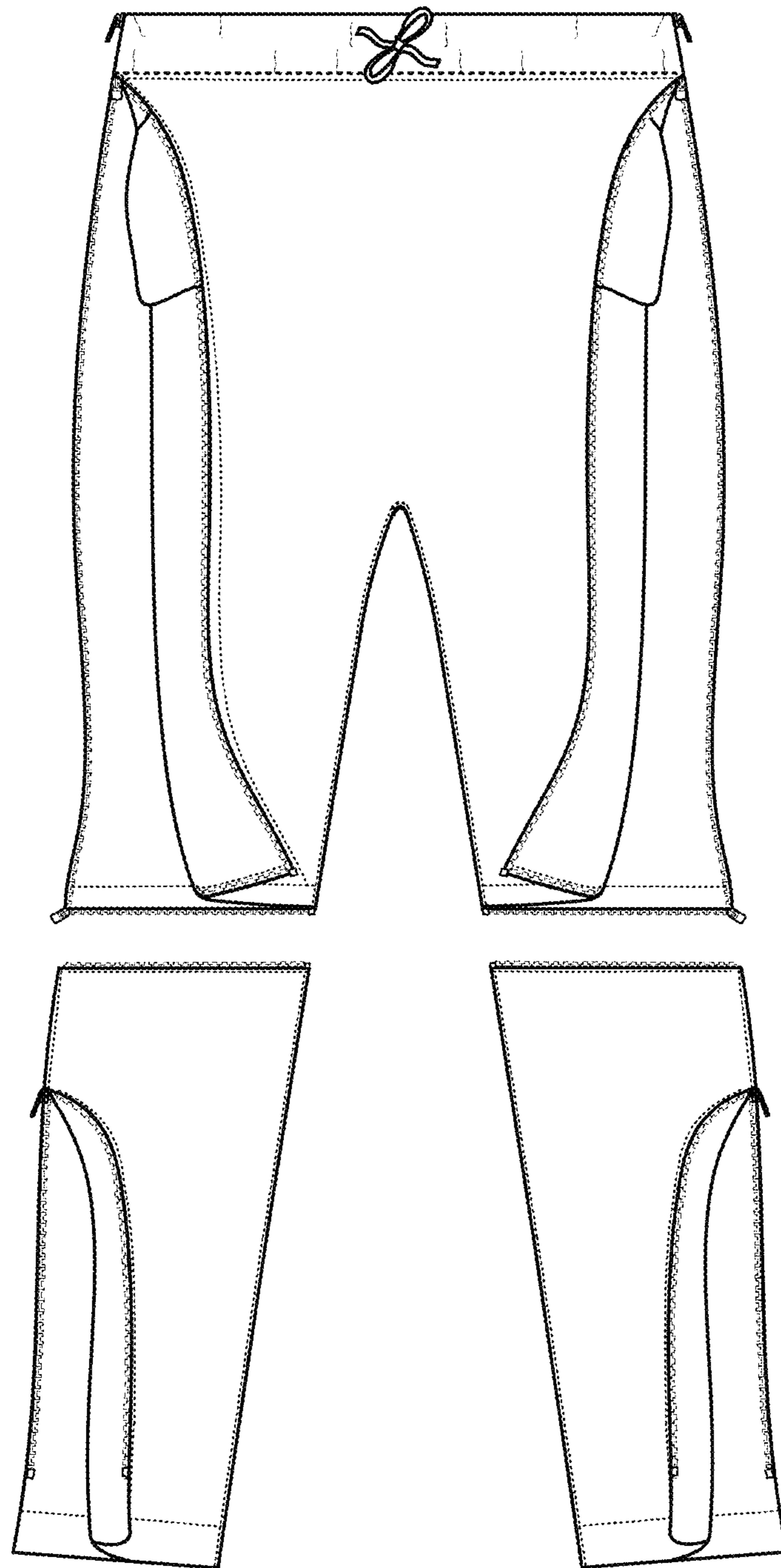

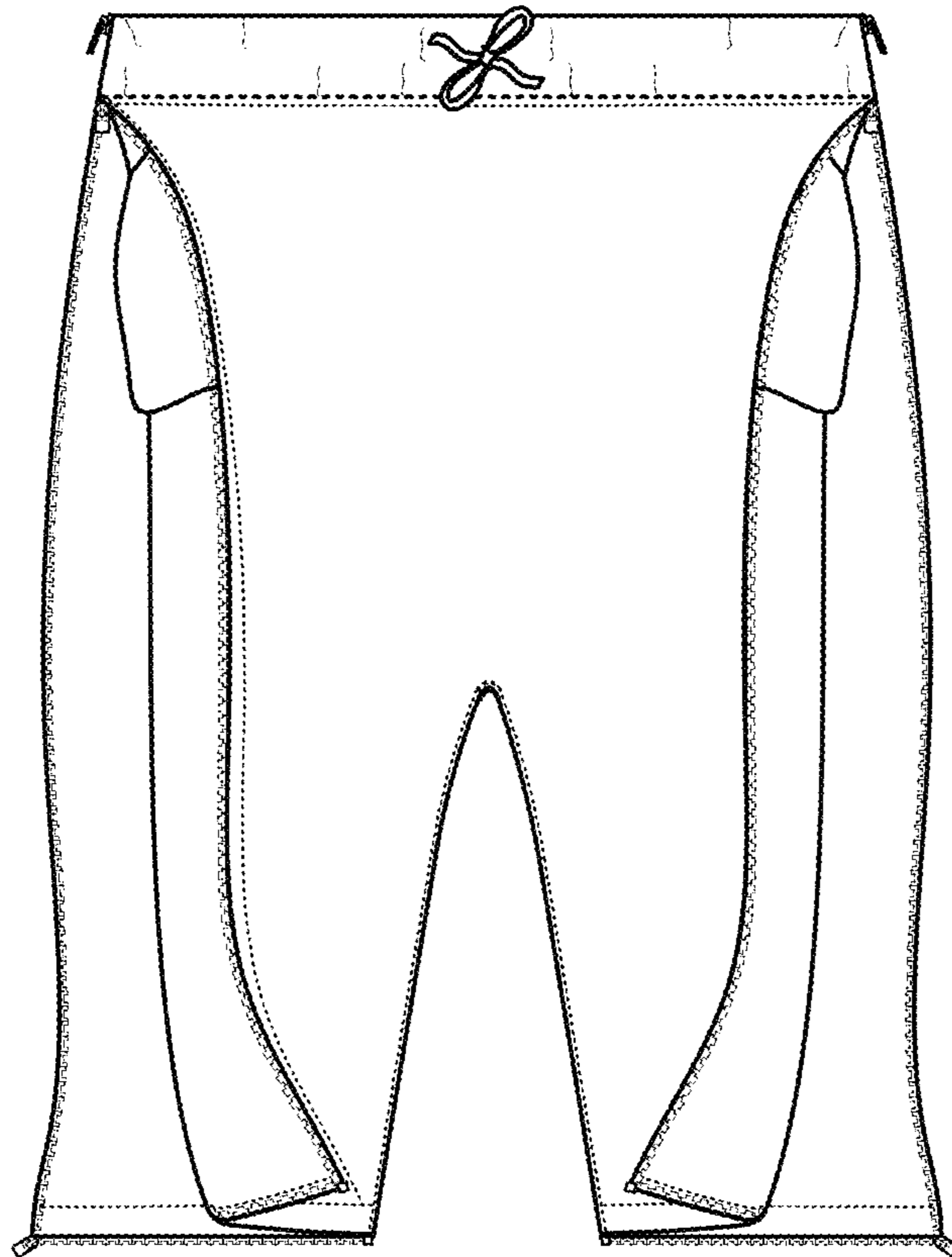

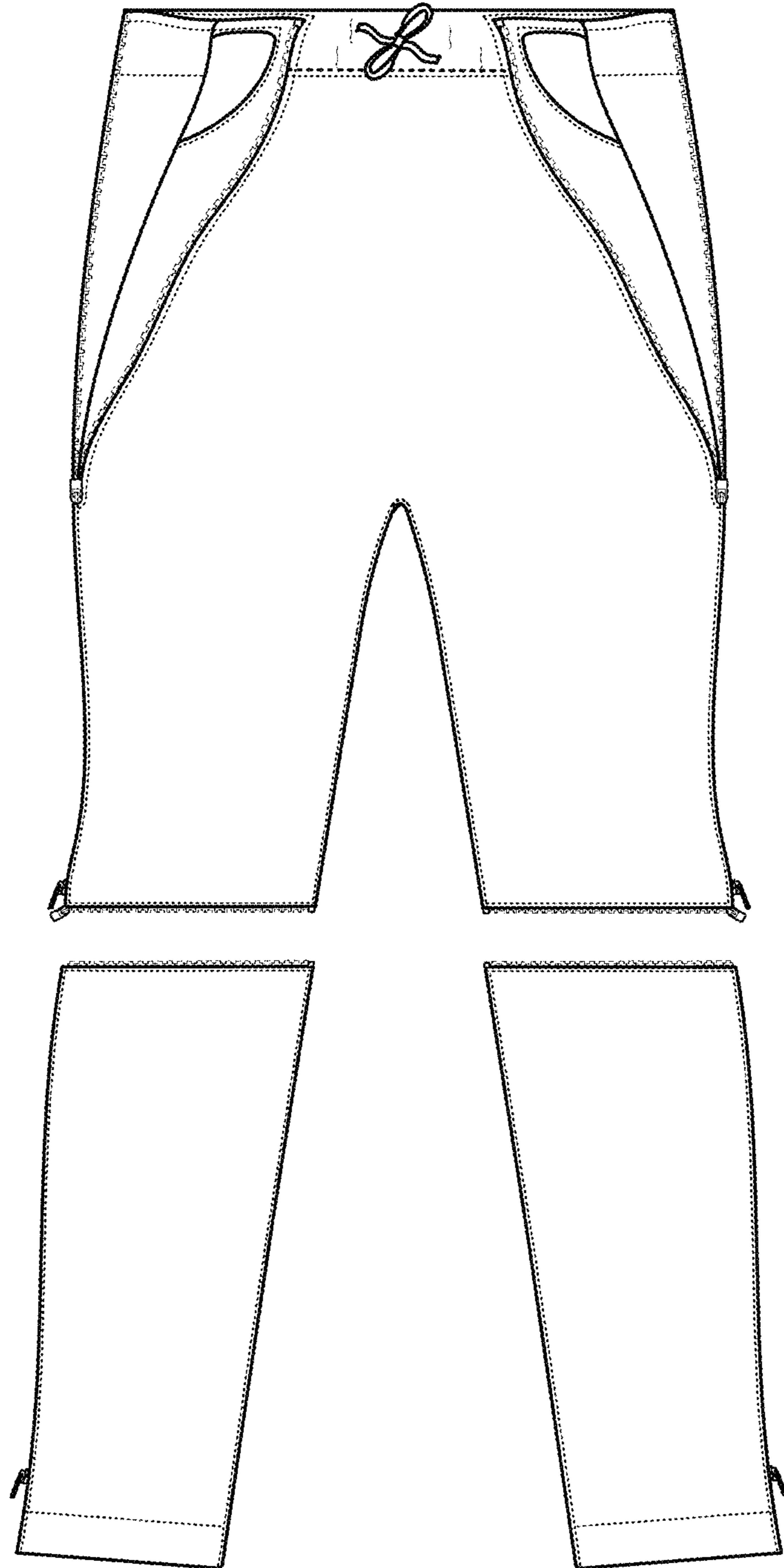

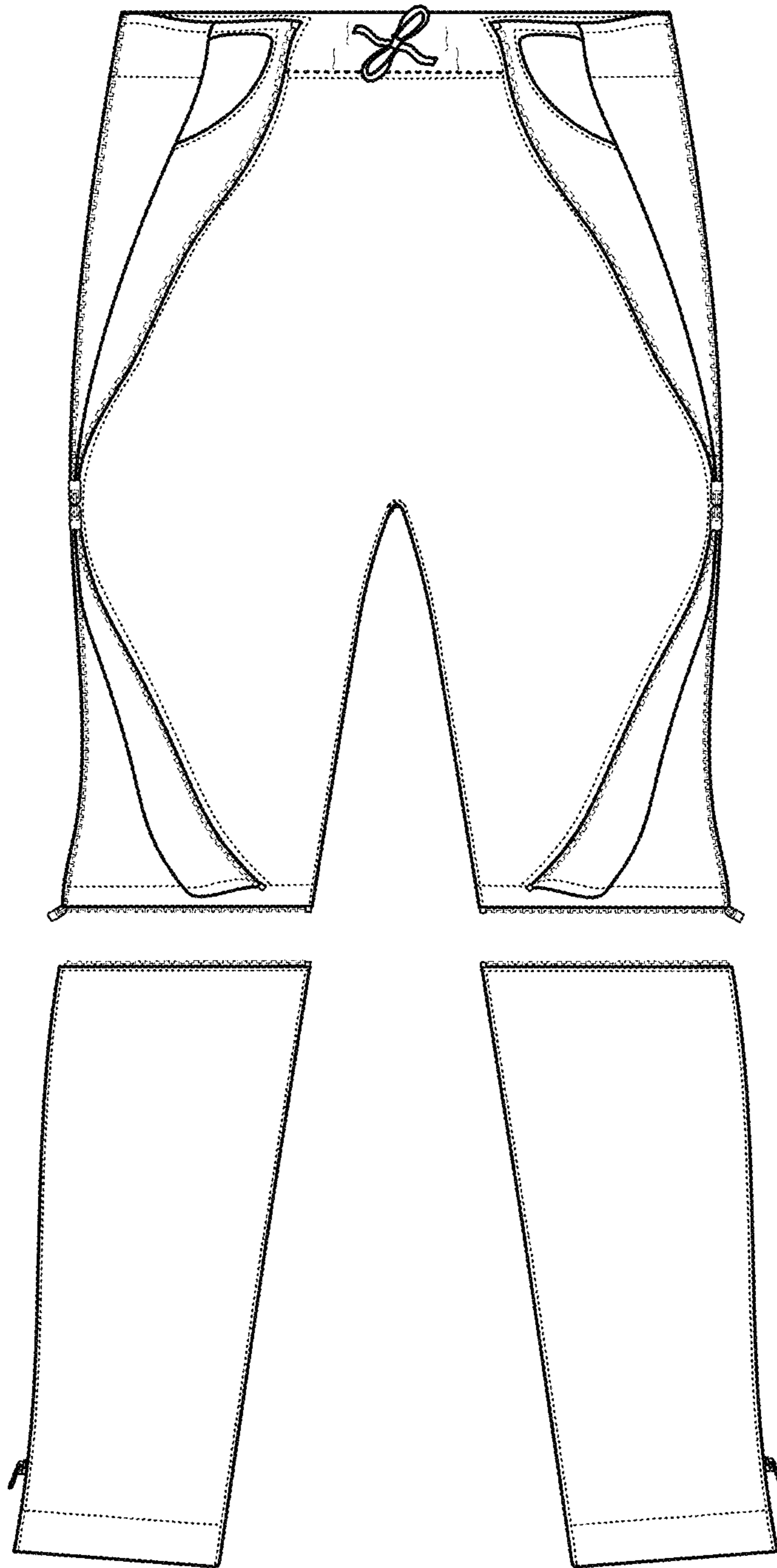

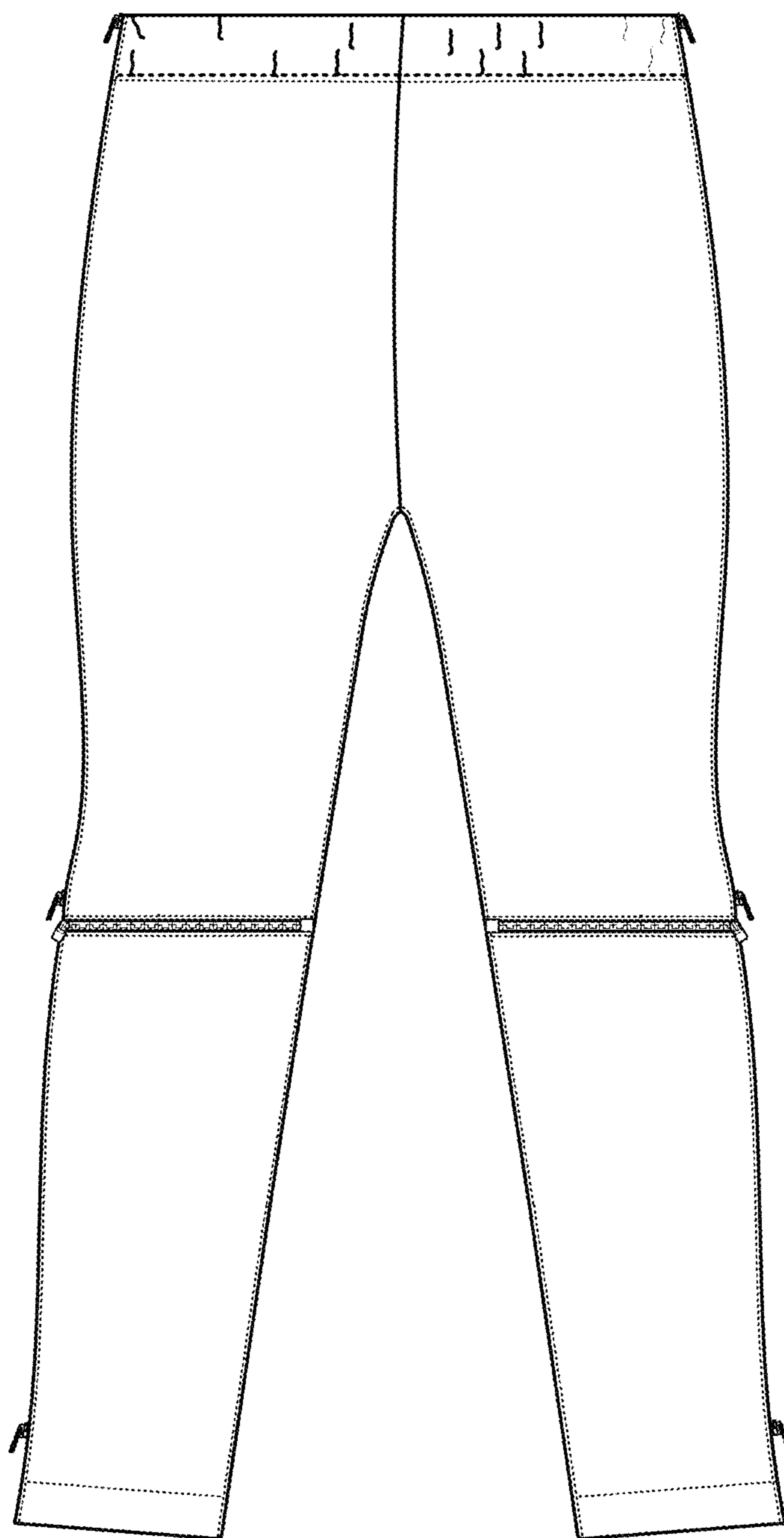

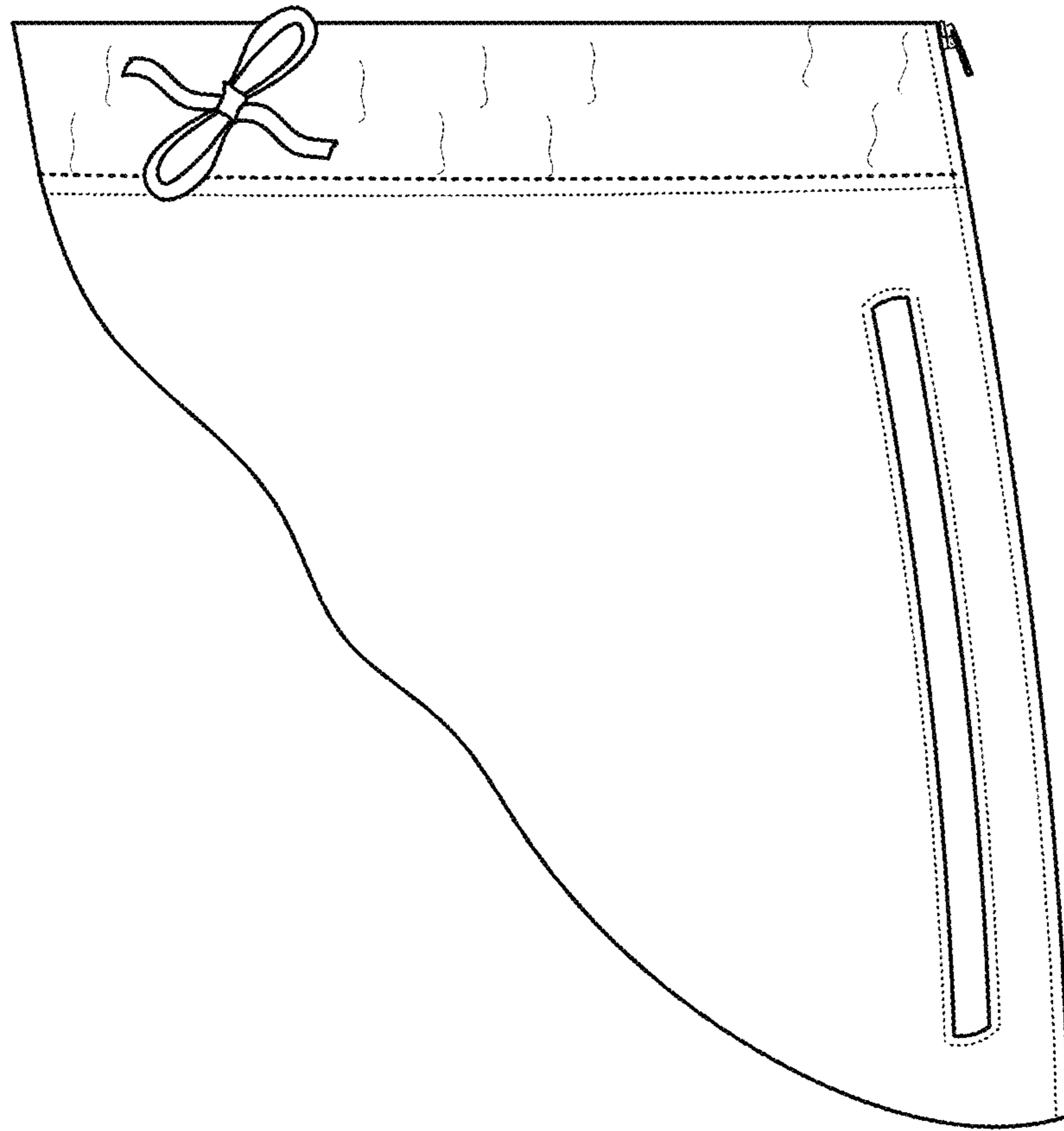

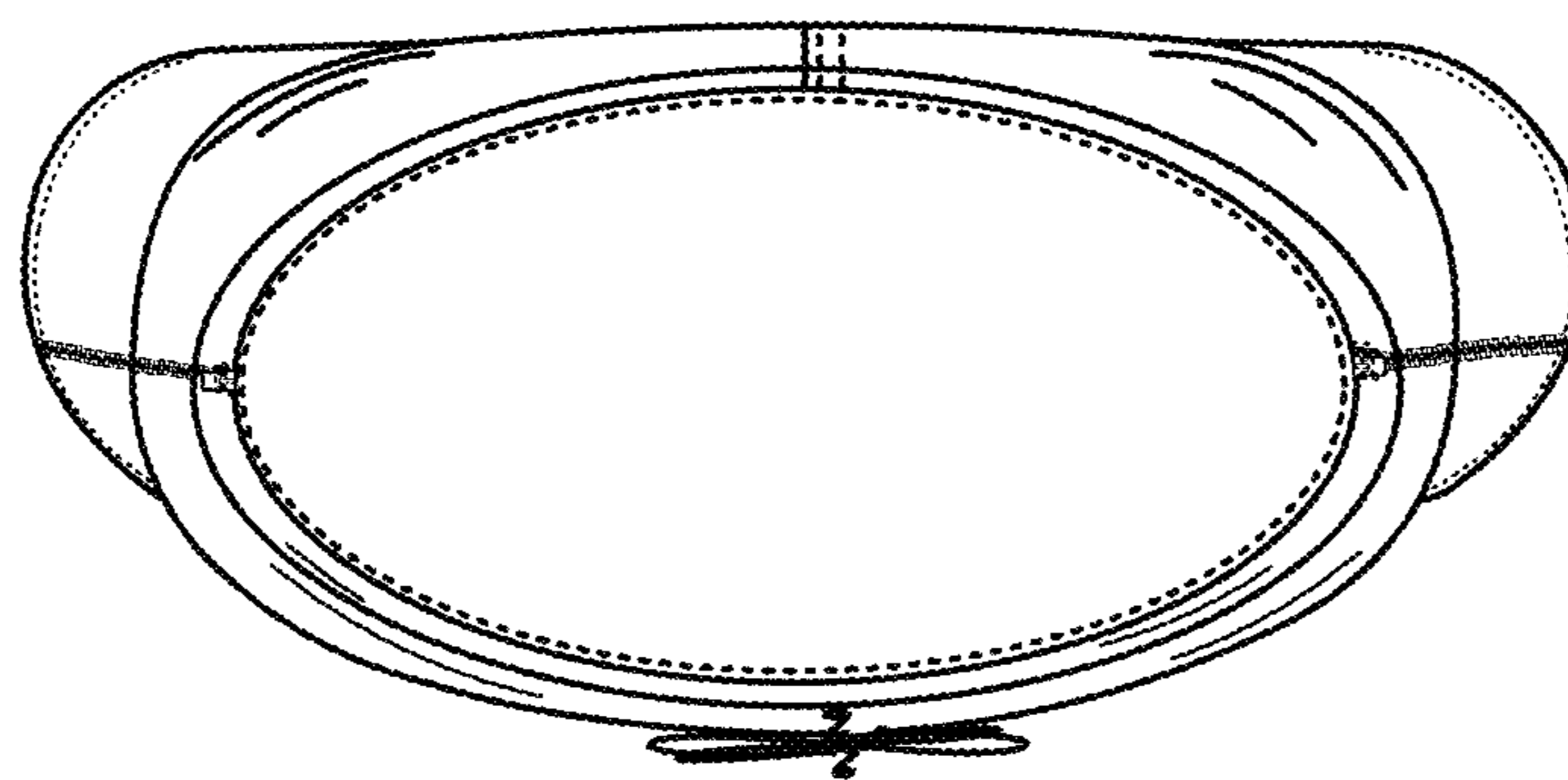

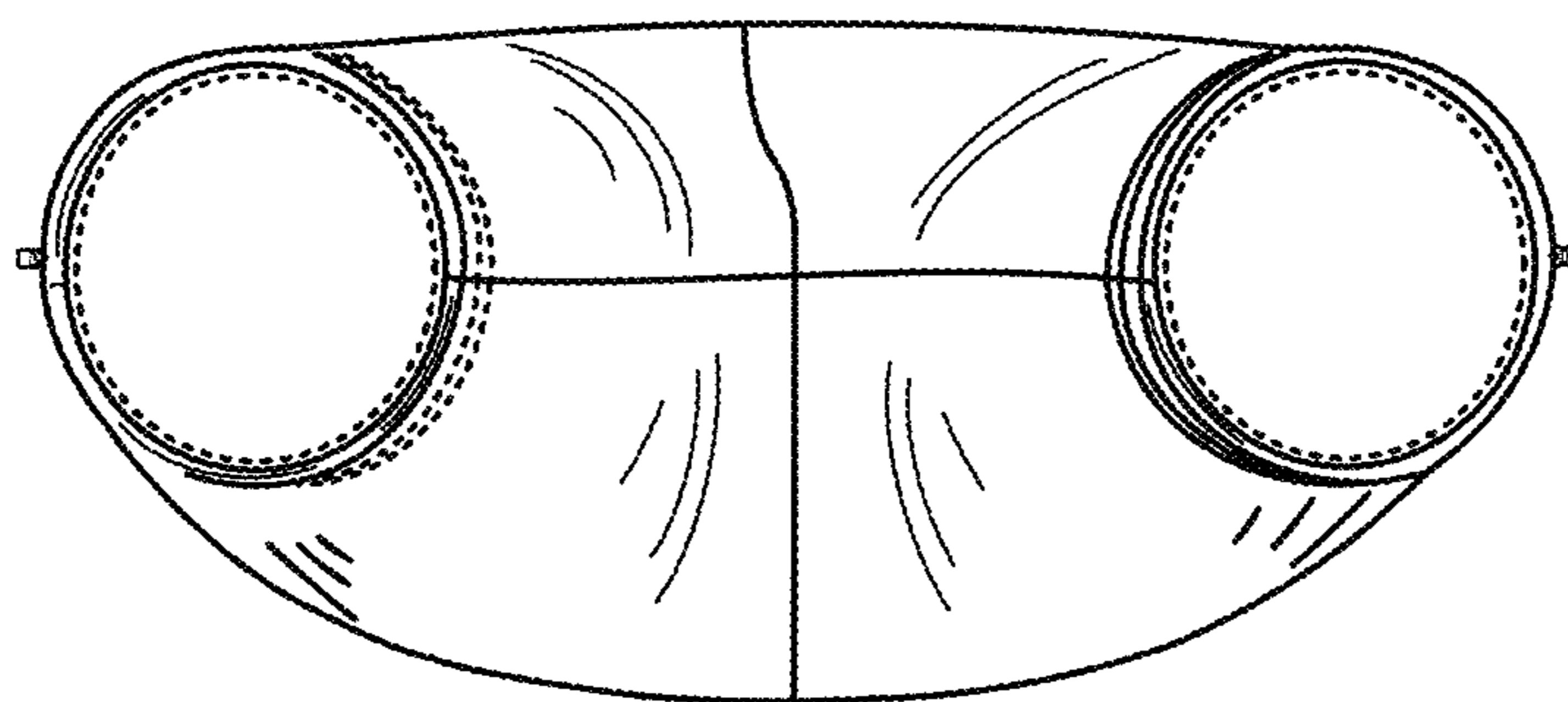
