(57) **CLAIM**

We claim the ornamental design for a padded stool with storage, as shown and described.

DESCRIPTION

FIG. 1 is an upper front perspective view of a padded stool with storage of our design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is an upper view thereof;
 FIG. 5 is a bottom view thereof;
 FIG. 6 is an end view thereof, showing the padded end;
 FIG. 7 is an end view thereof, showing the unpadded end opposite to the padded end;
 FIG. 8 is a second upper front perspective view thereof, showing an orientation for one possible use, supporting a user in a perching position;
 FIG. 9 is a third upper front perspective view thereof, showing an orientation for a second possible use, supporting a user in a sitting position; and,
 FIG. 10 is a rear perspective view thereof, showing an orientation for a third possible use, holding luggage in a storage area.

The broken lines in the drawings illustrate portions of the padded stool with storage that form no part of the claimed design.

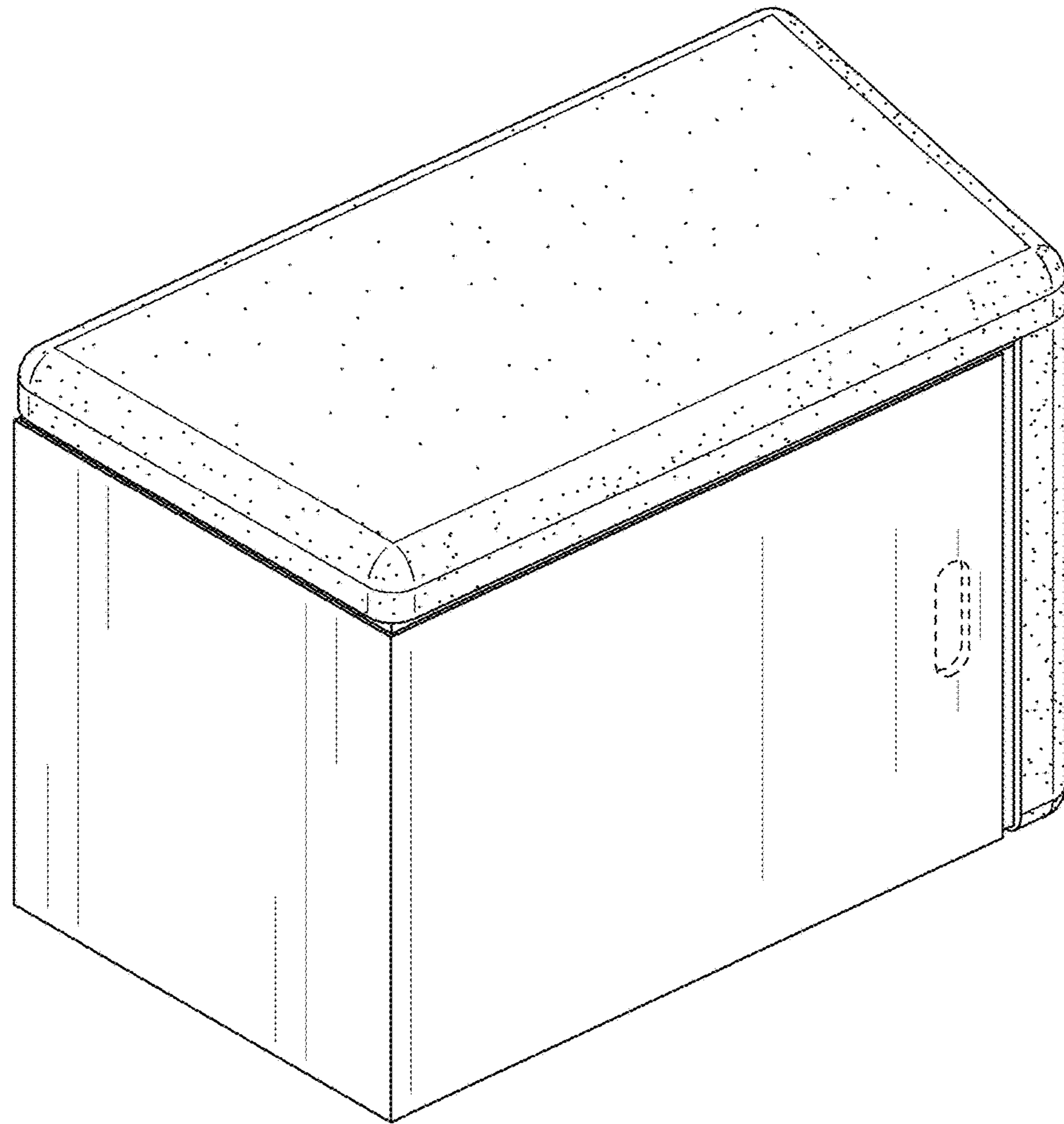

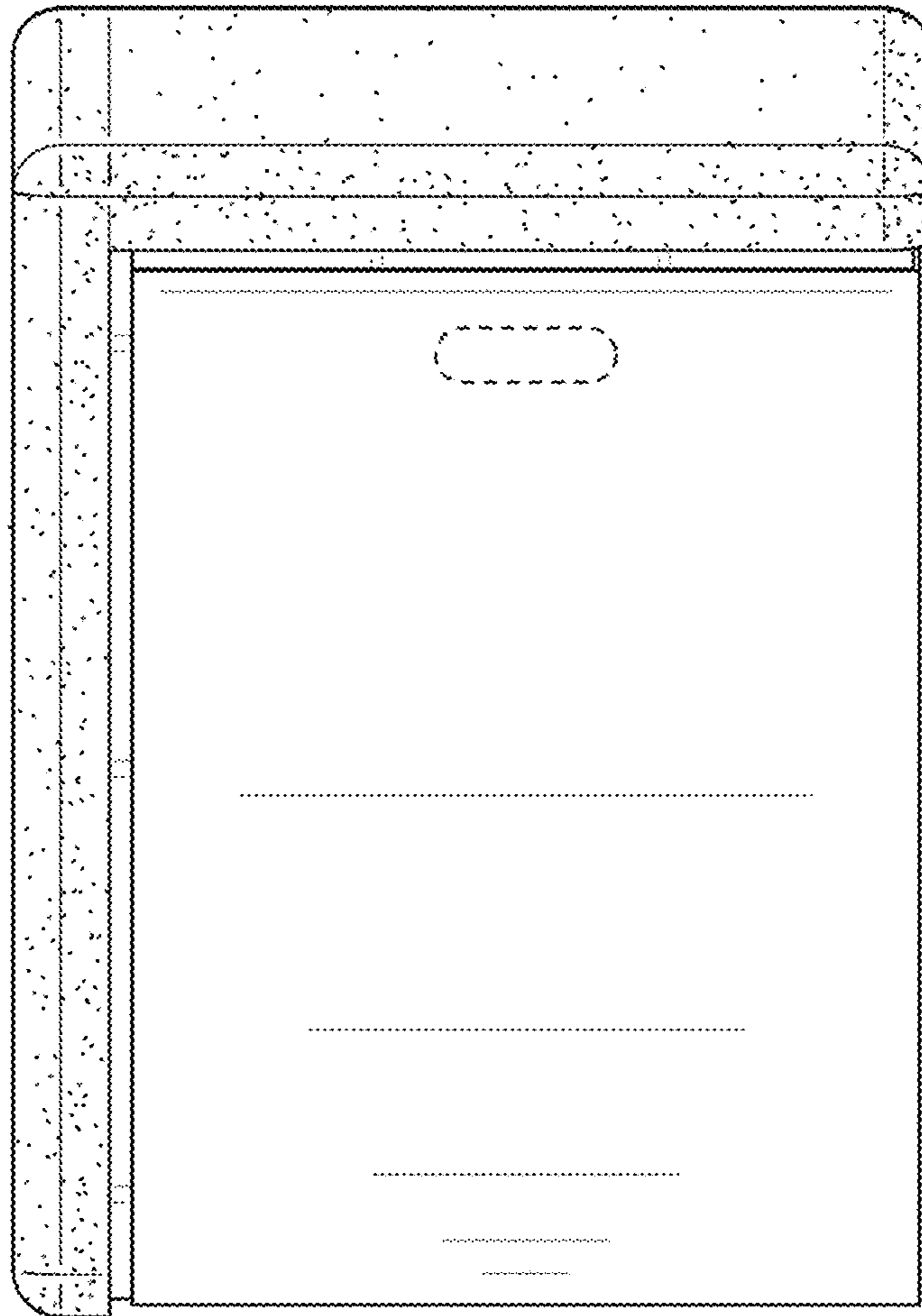

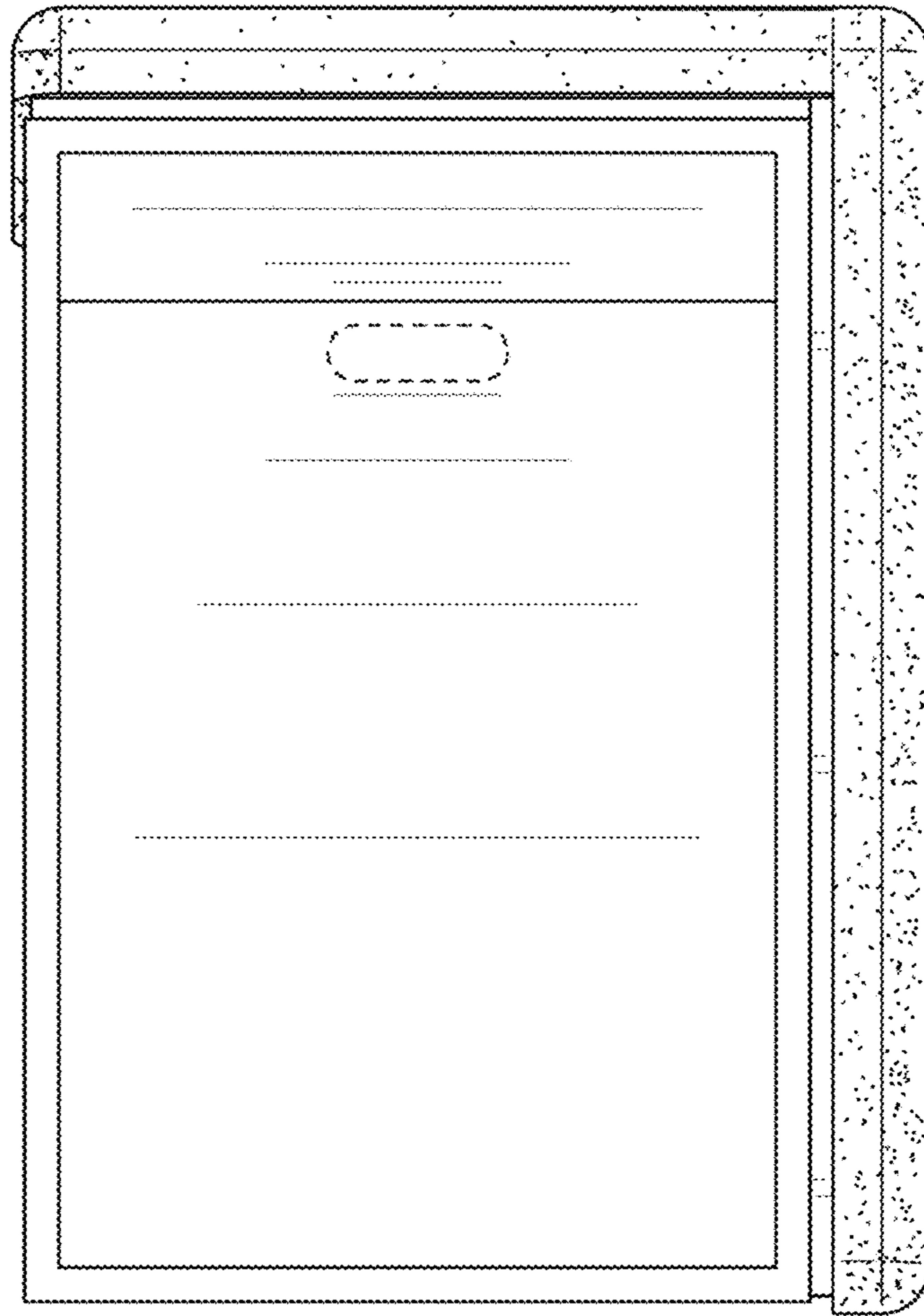

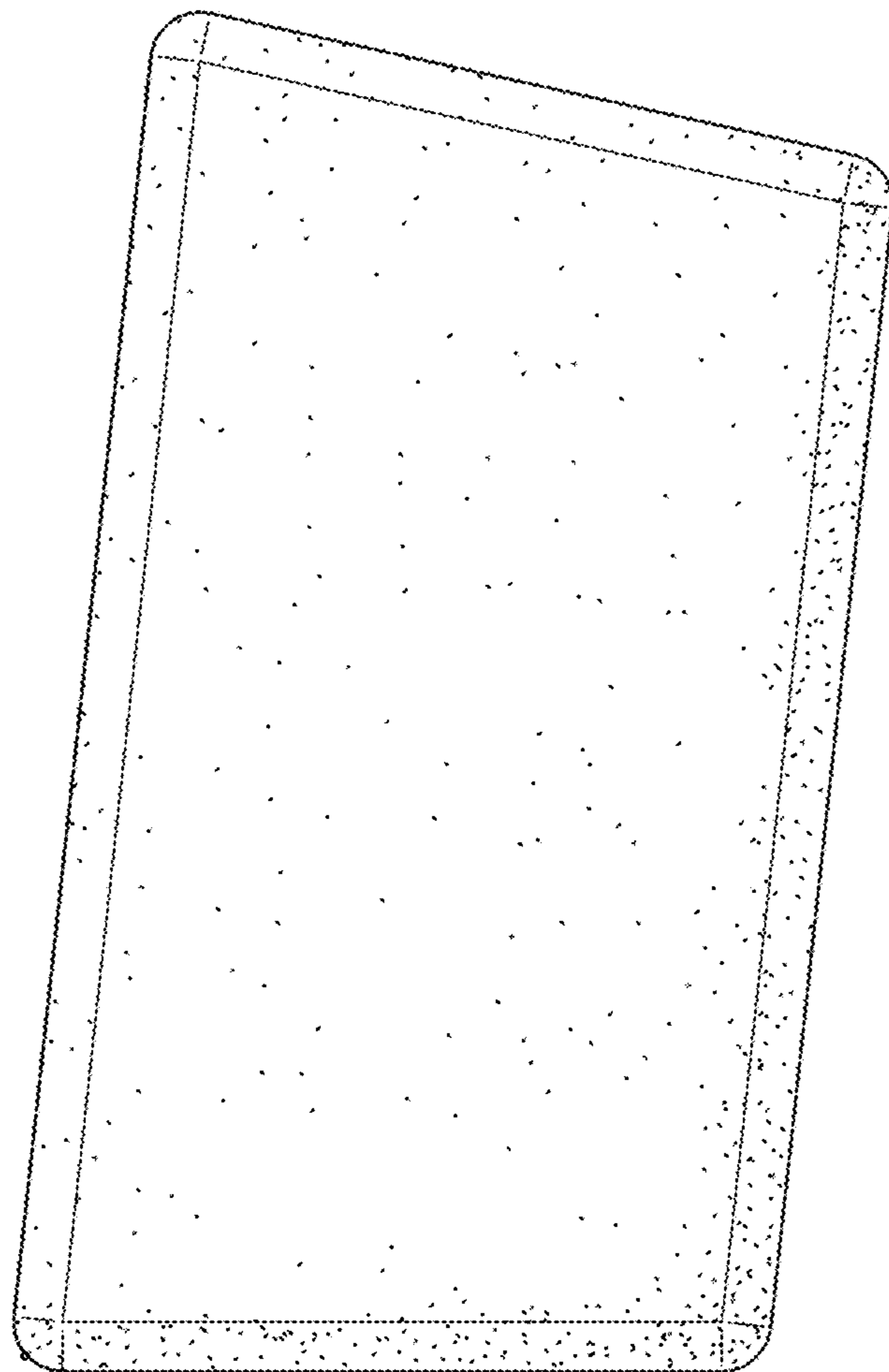

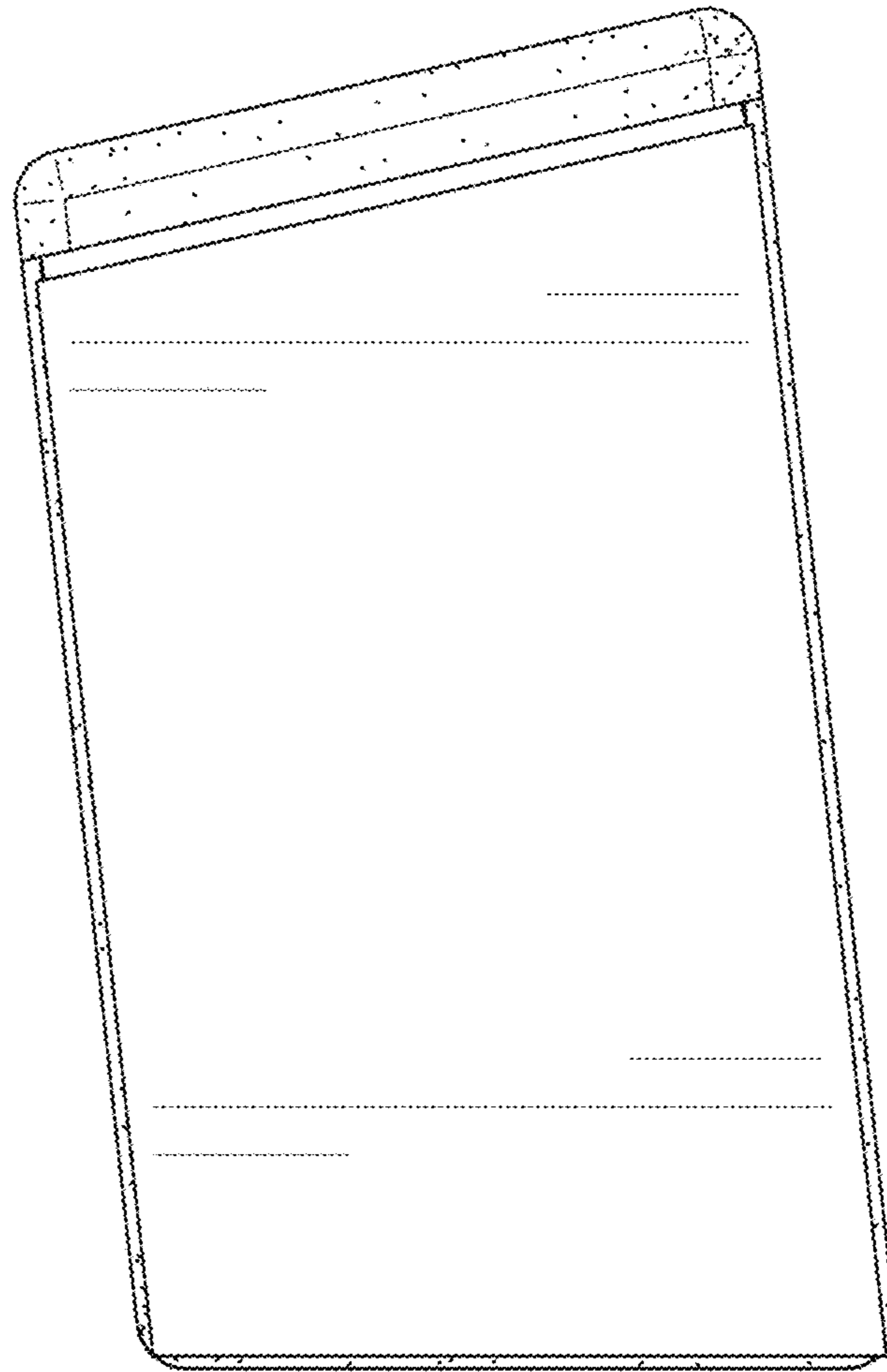

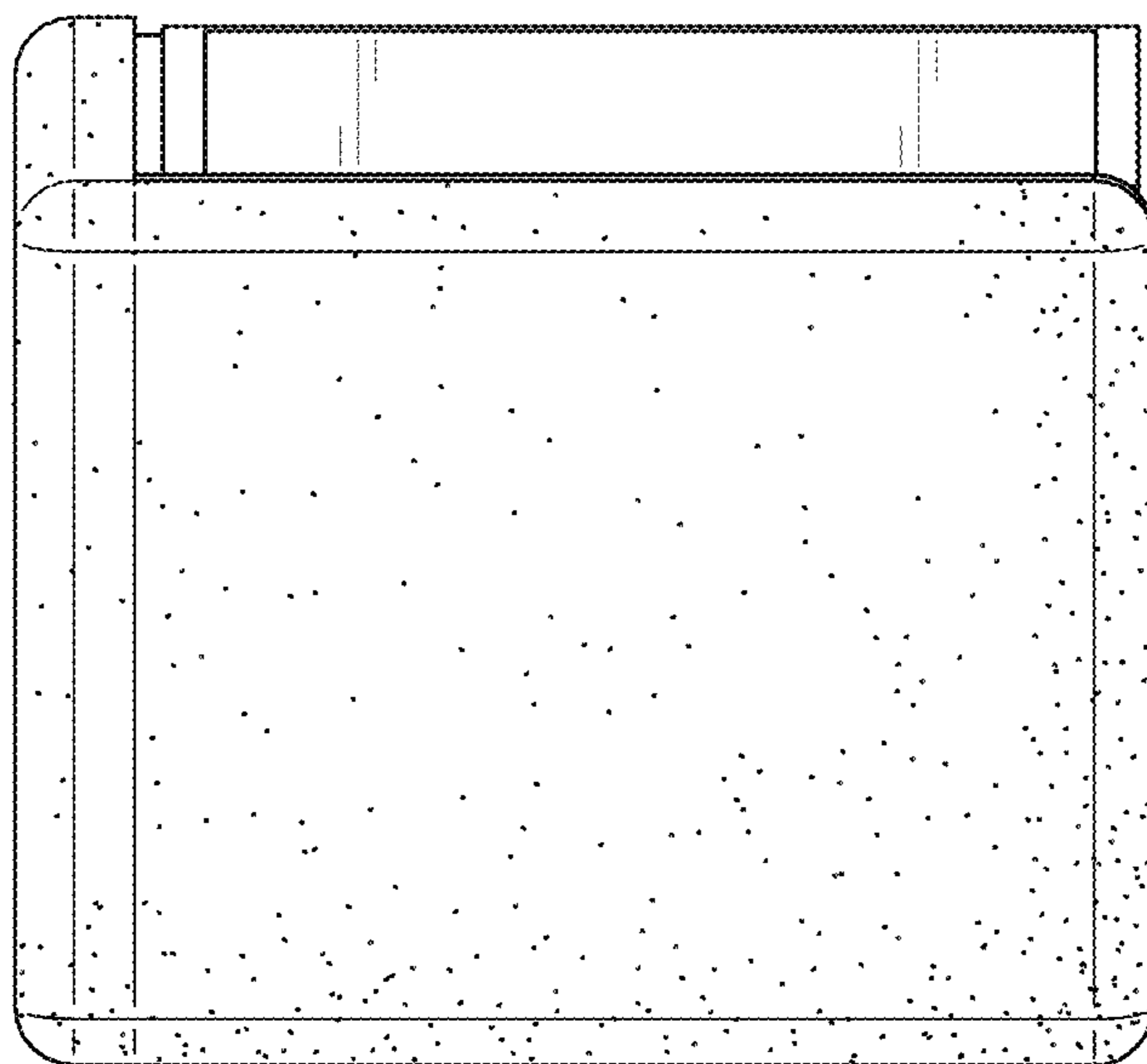

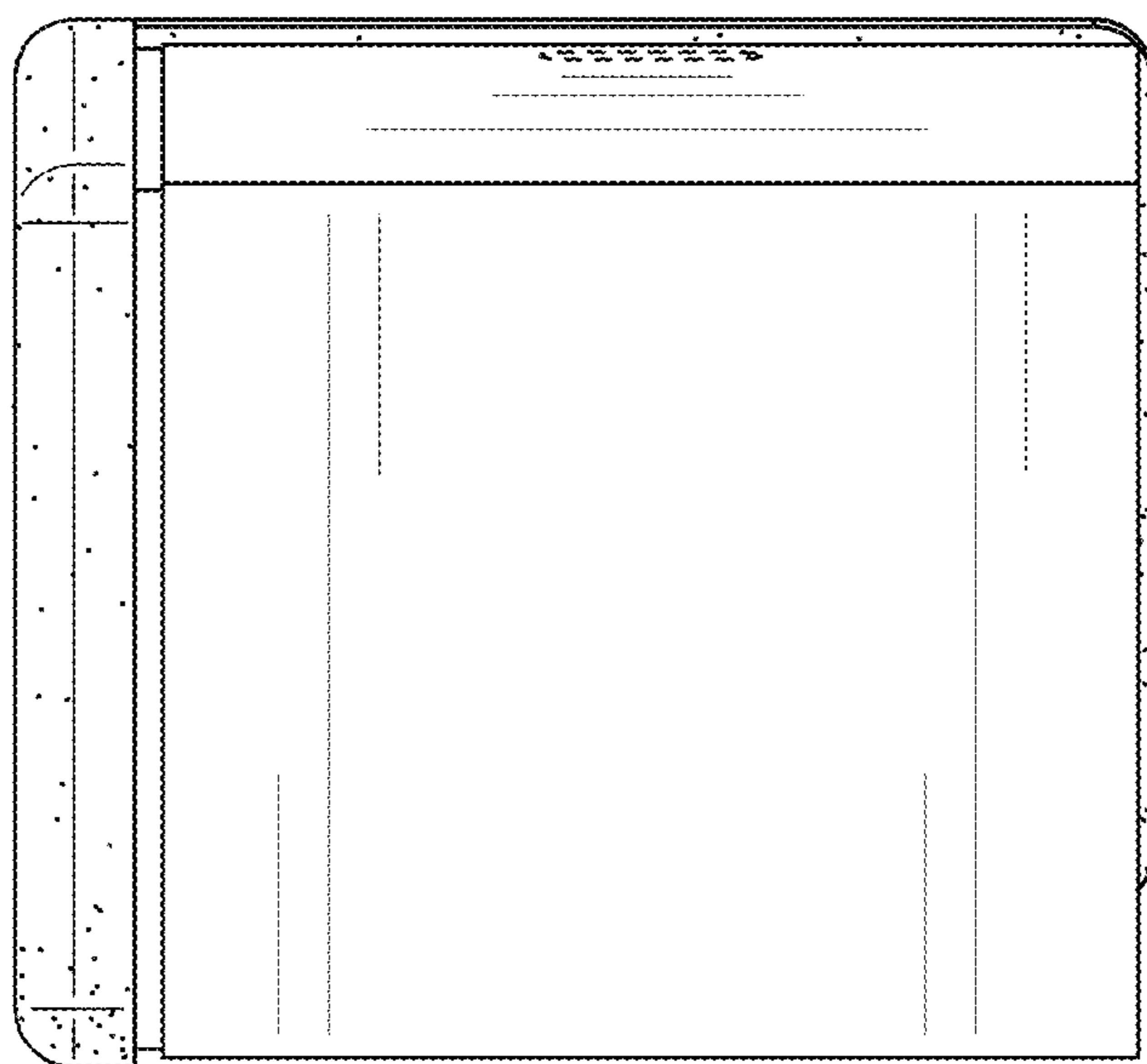

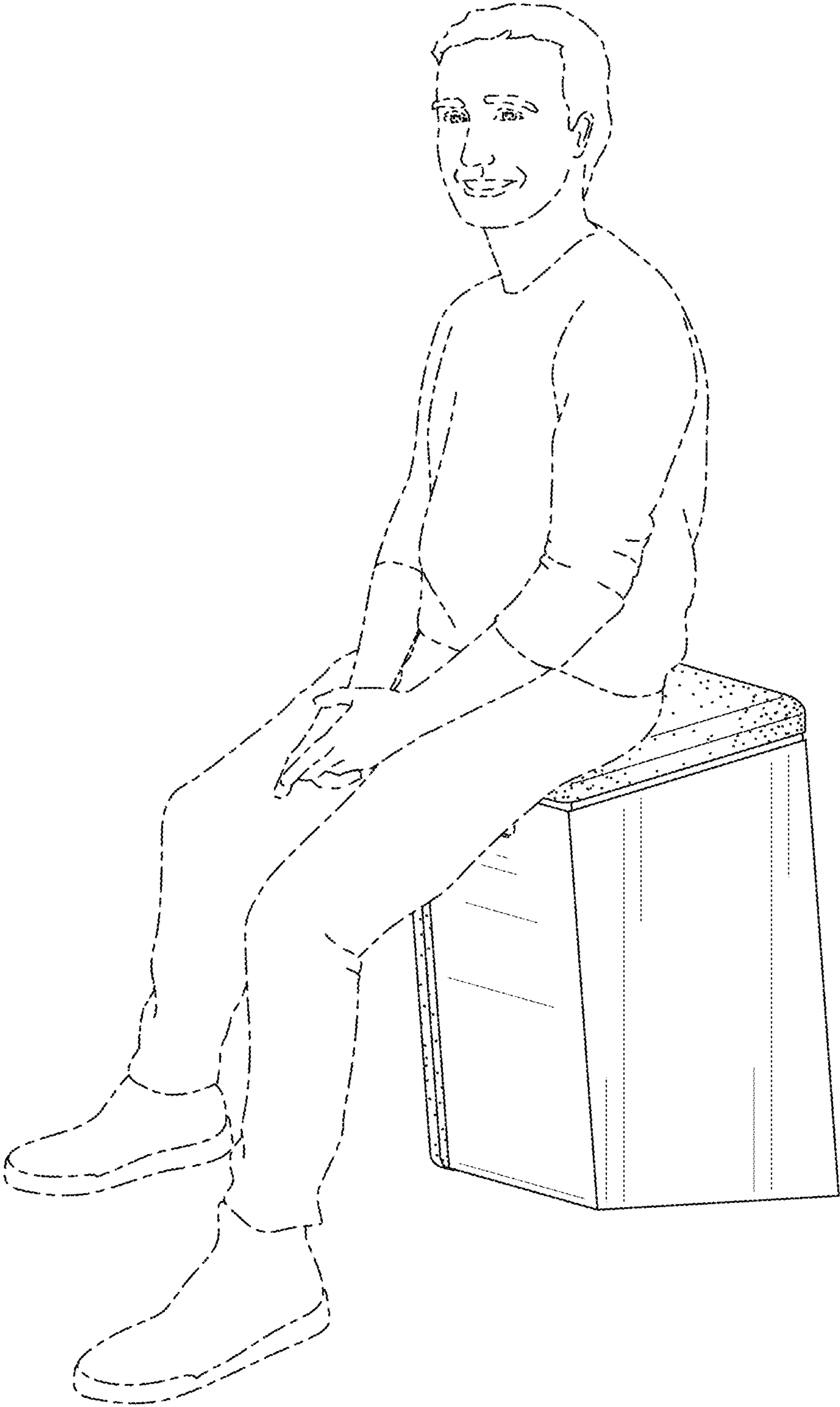

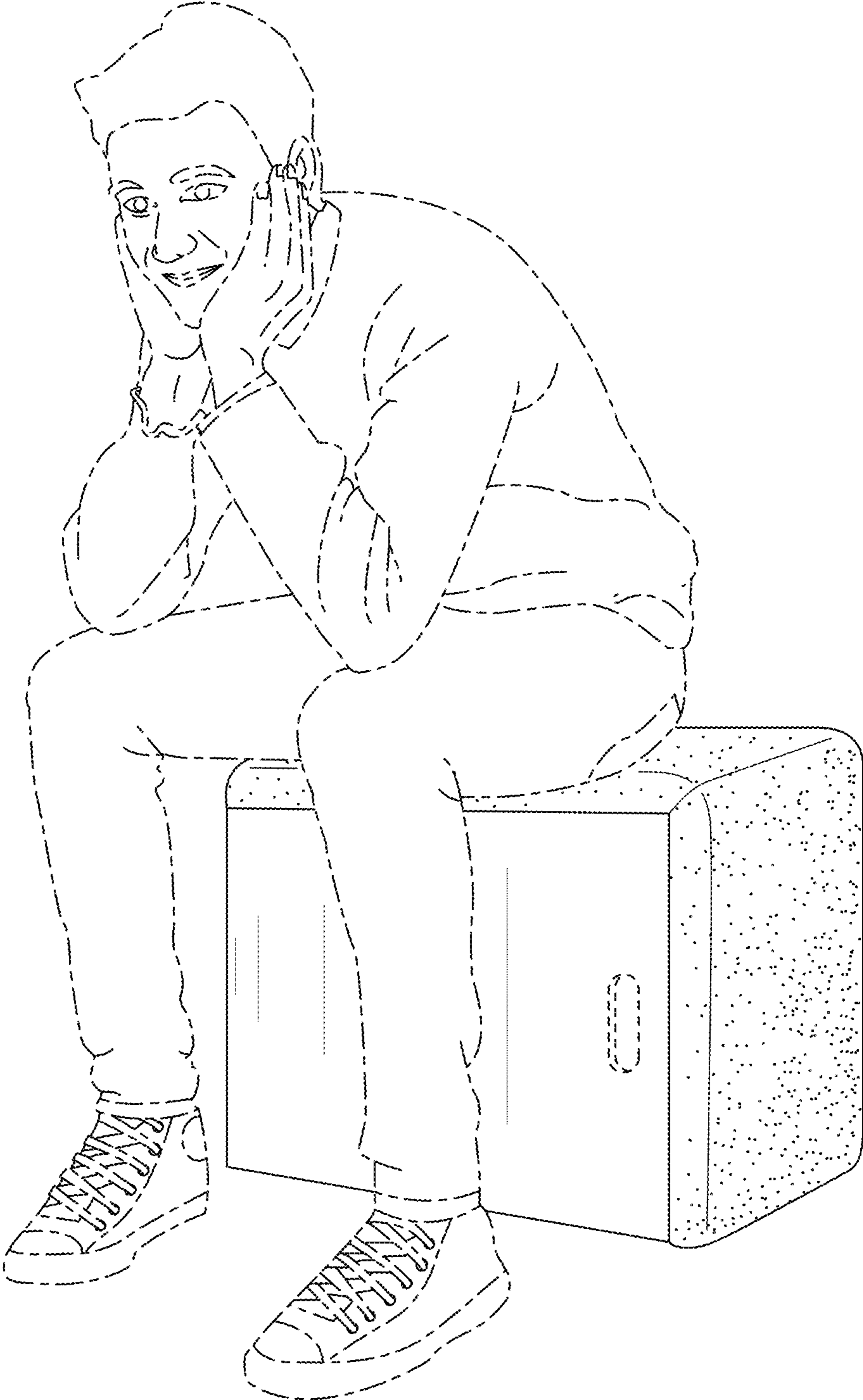

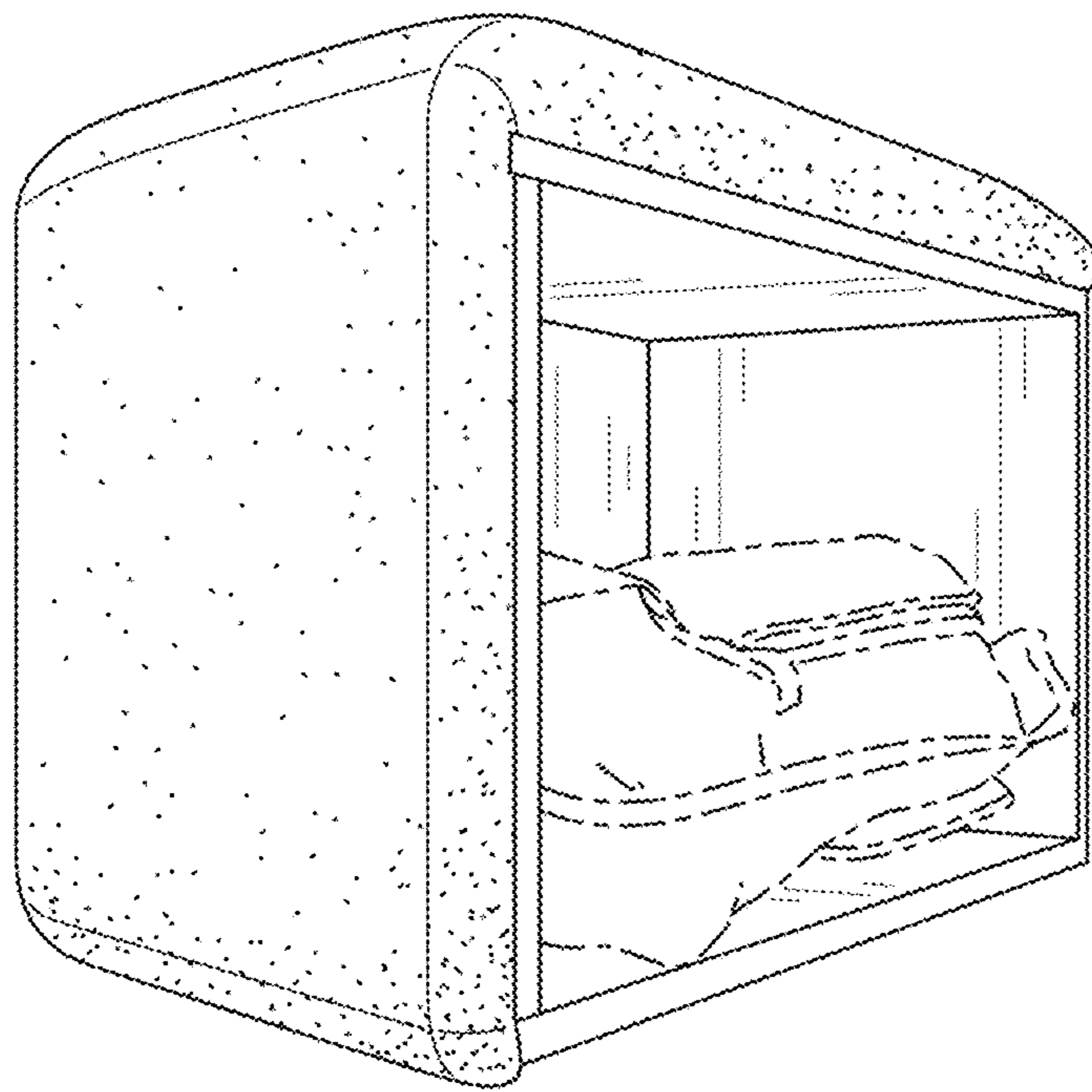
