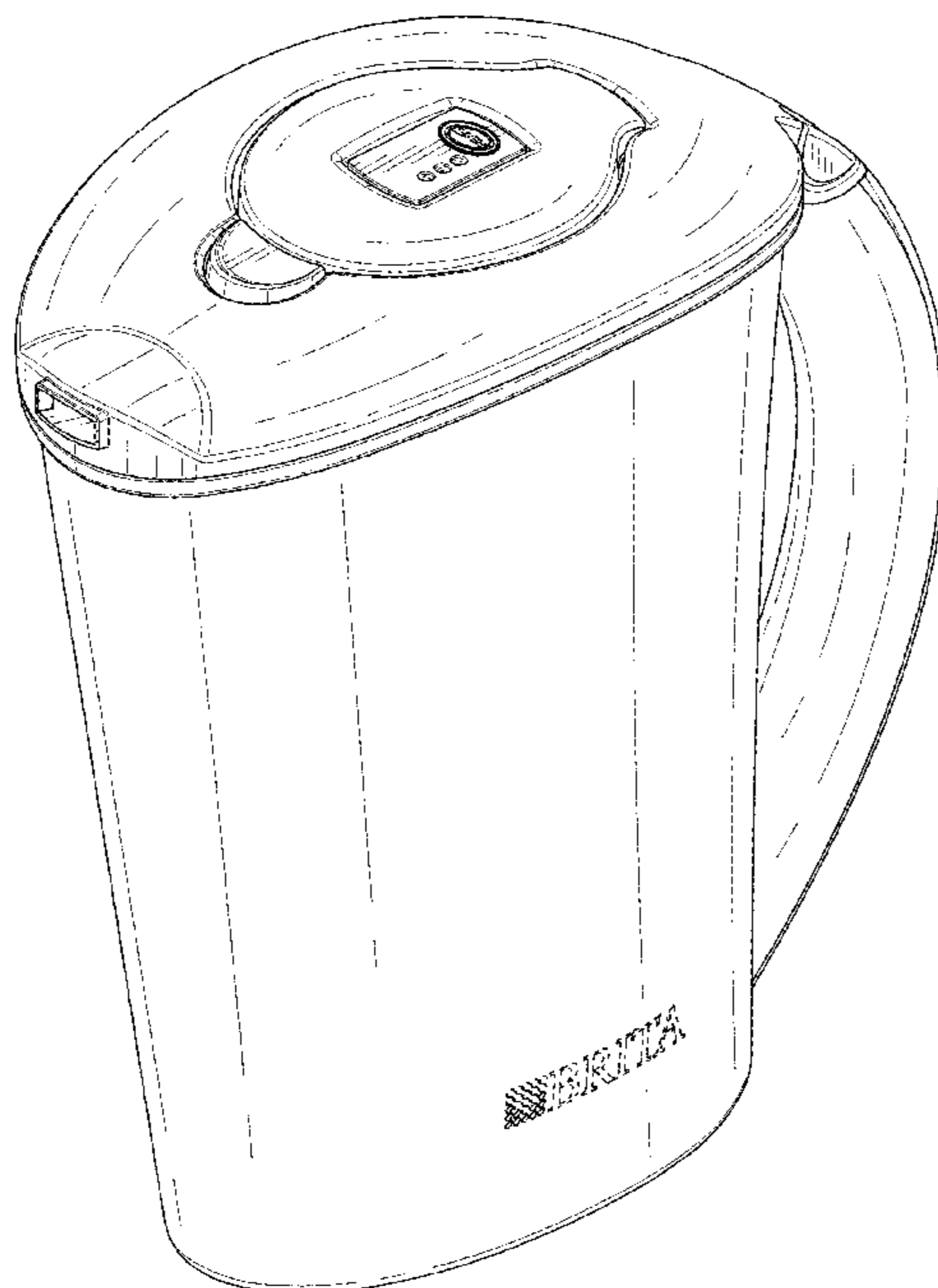
(57) **CLAIM**

The ornamental design for a pitcher with drop configuration, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a pitcher;  
FIG. 2 is a rear perspective view of the pitcher of FIG. 1;

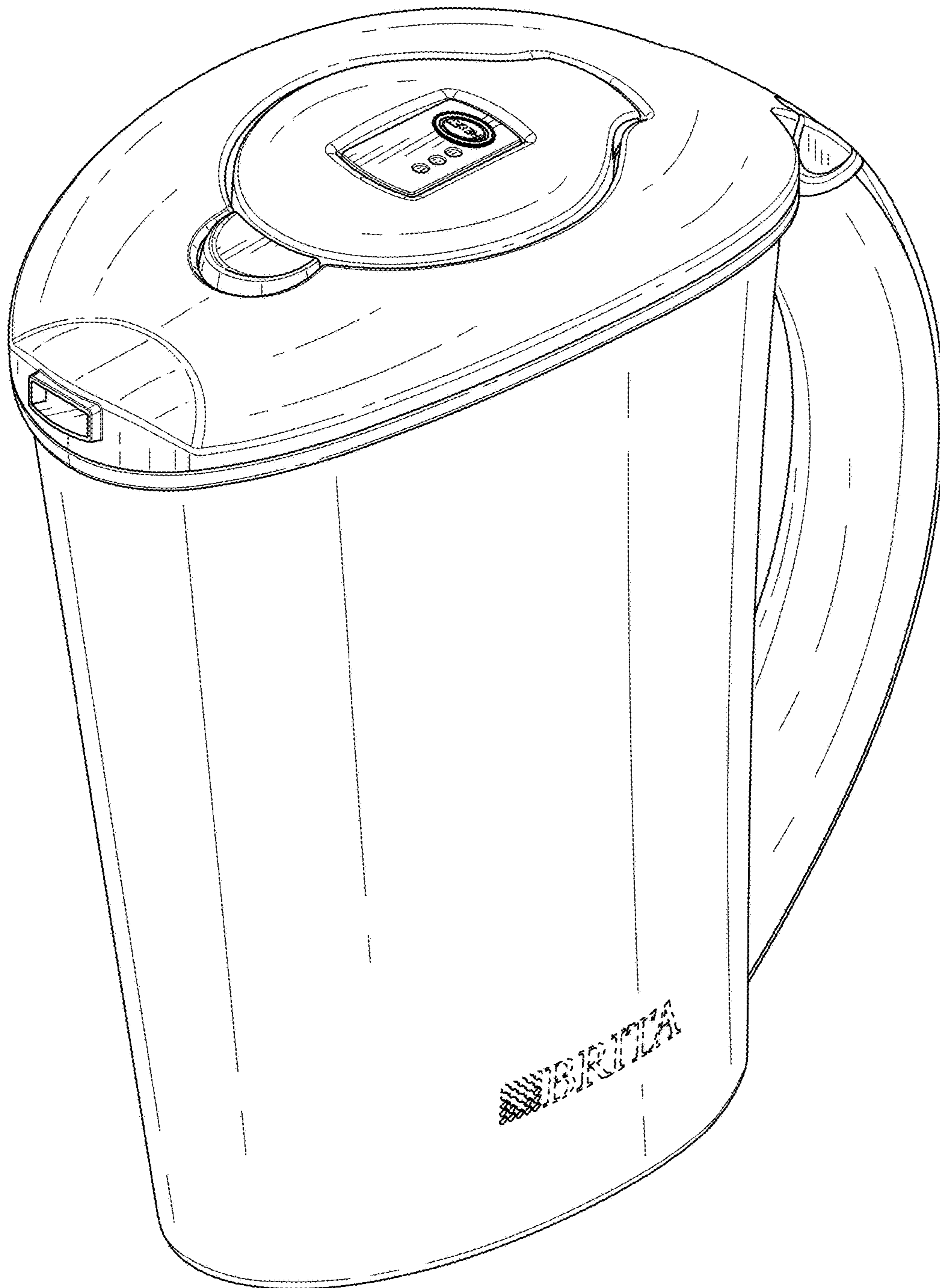

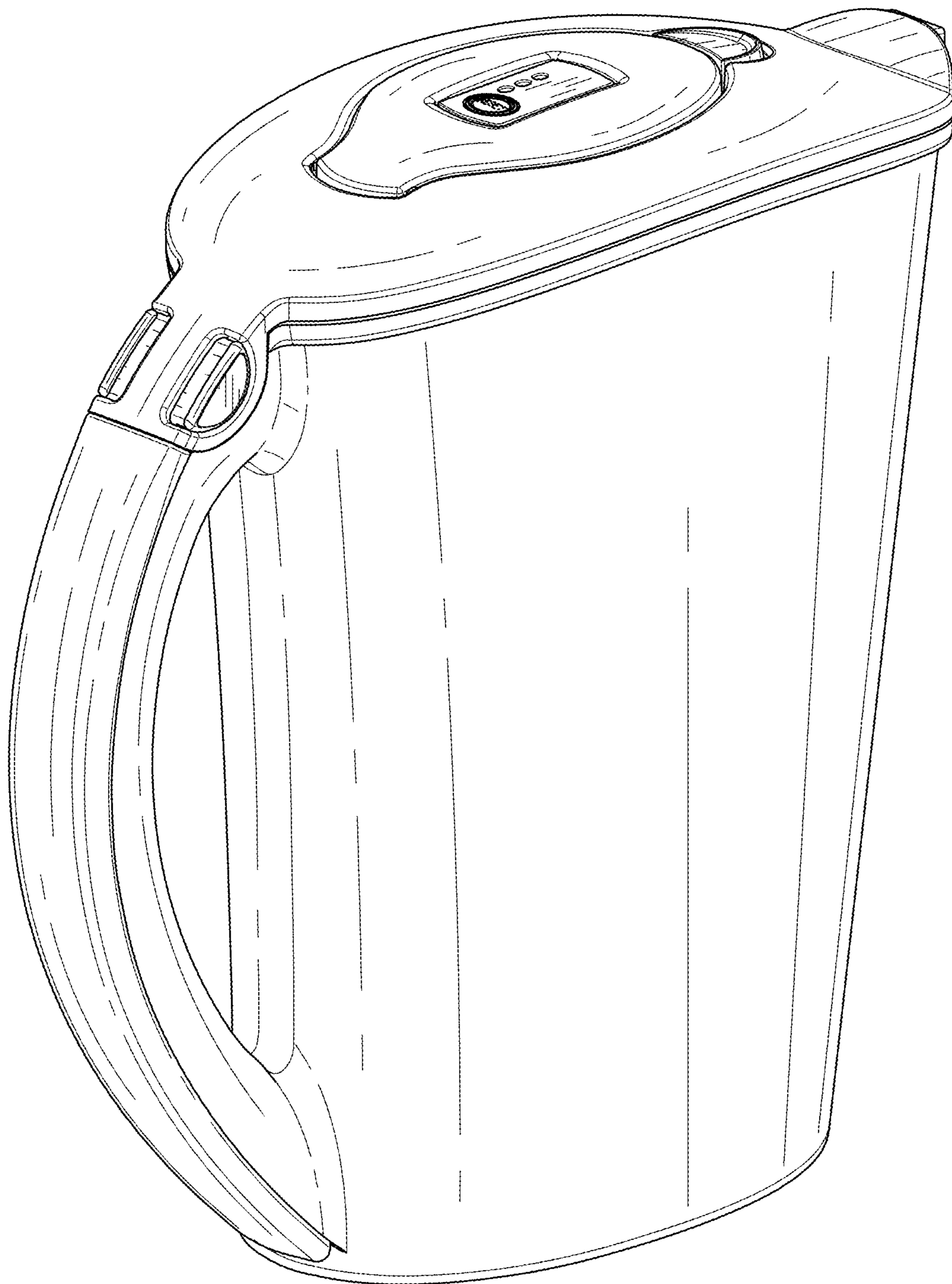

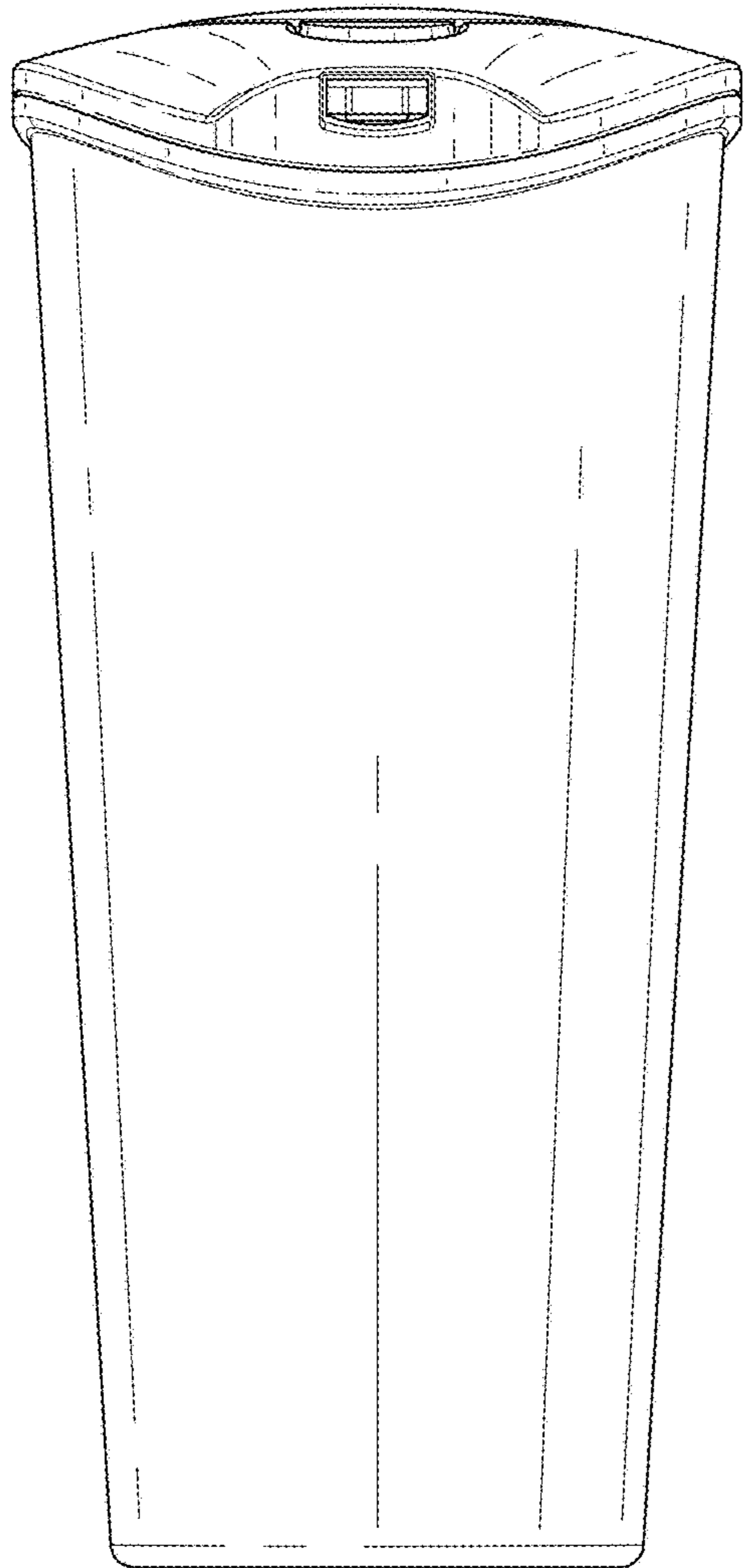

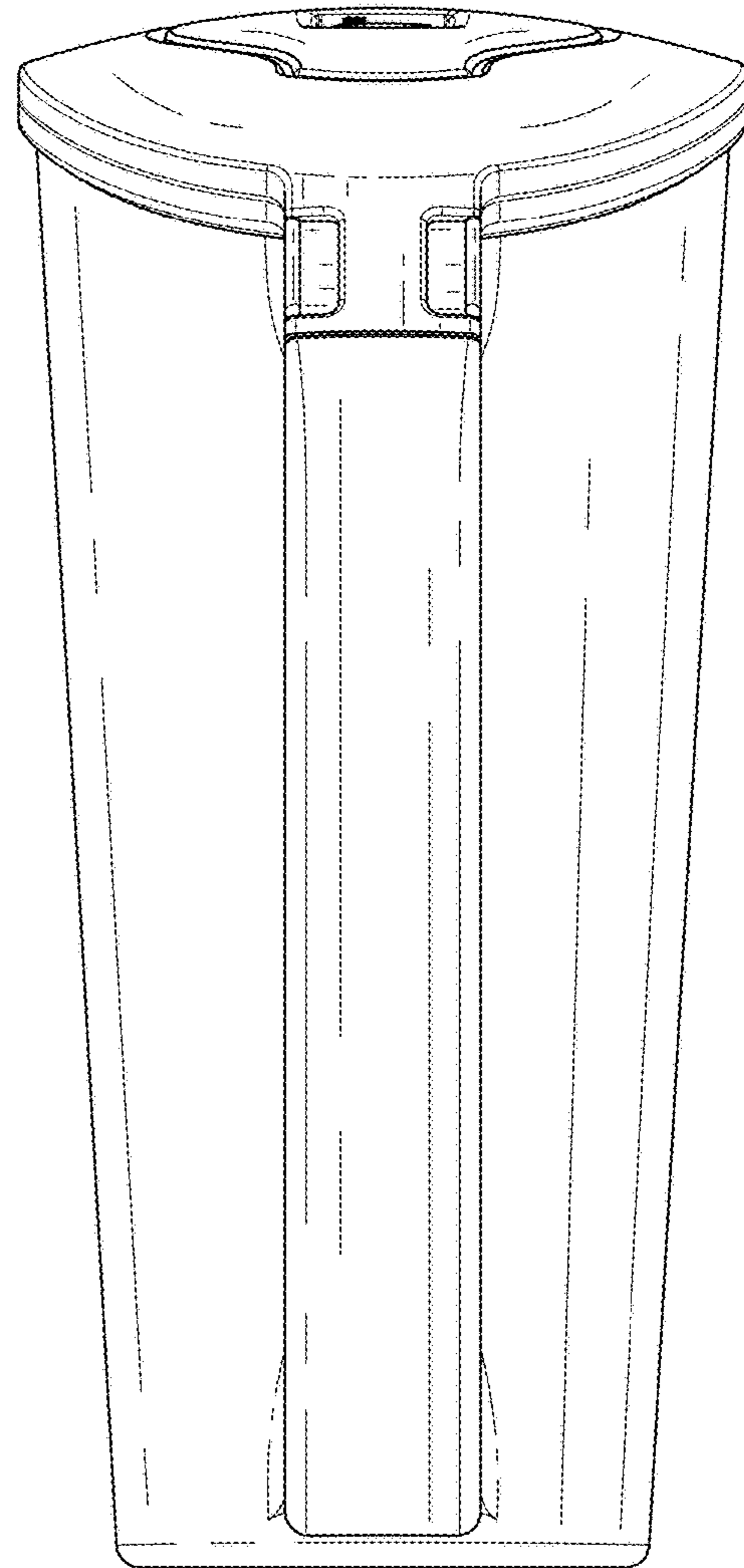

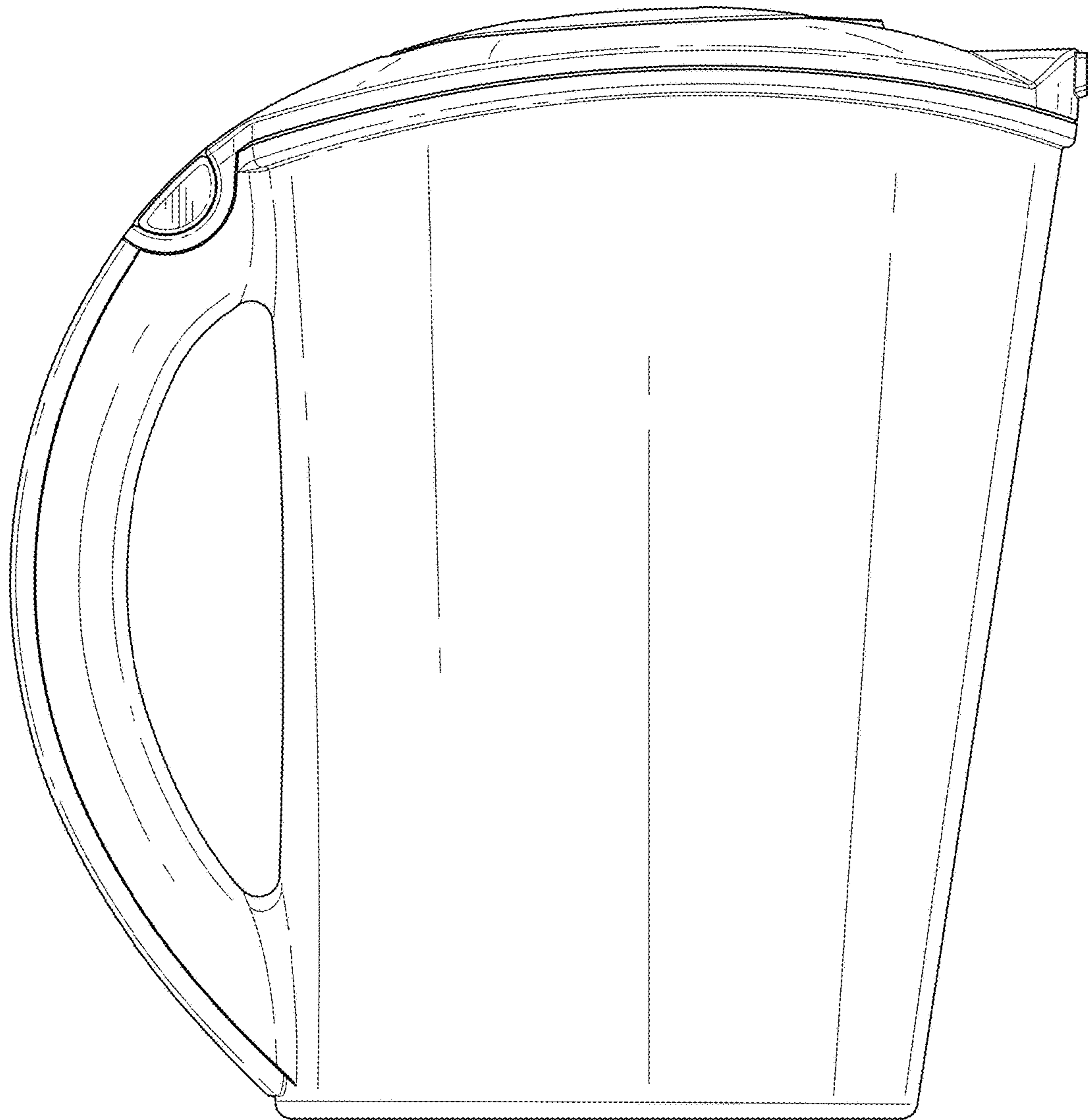

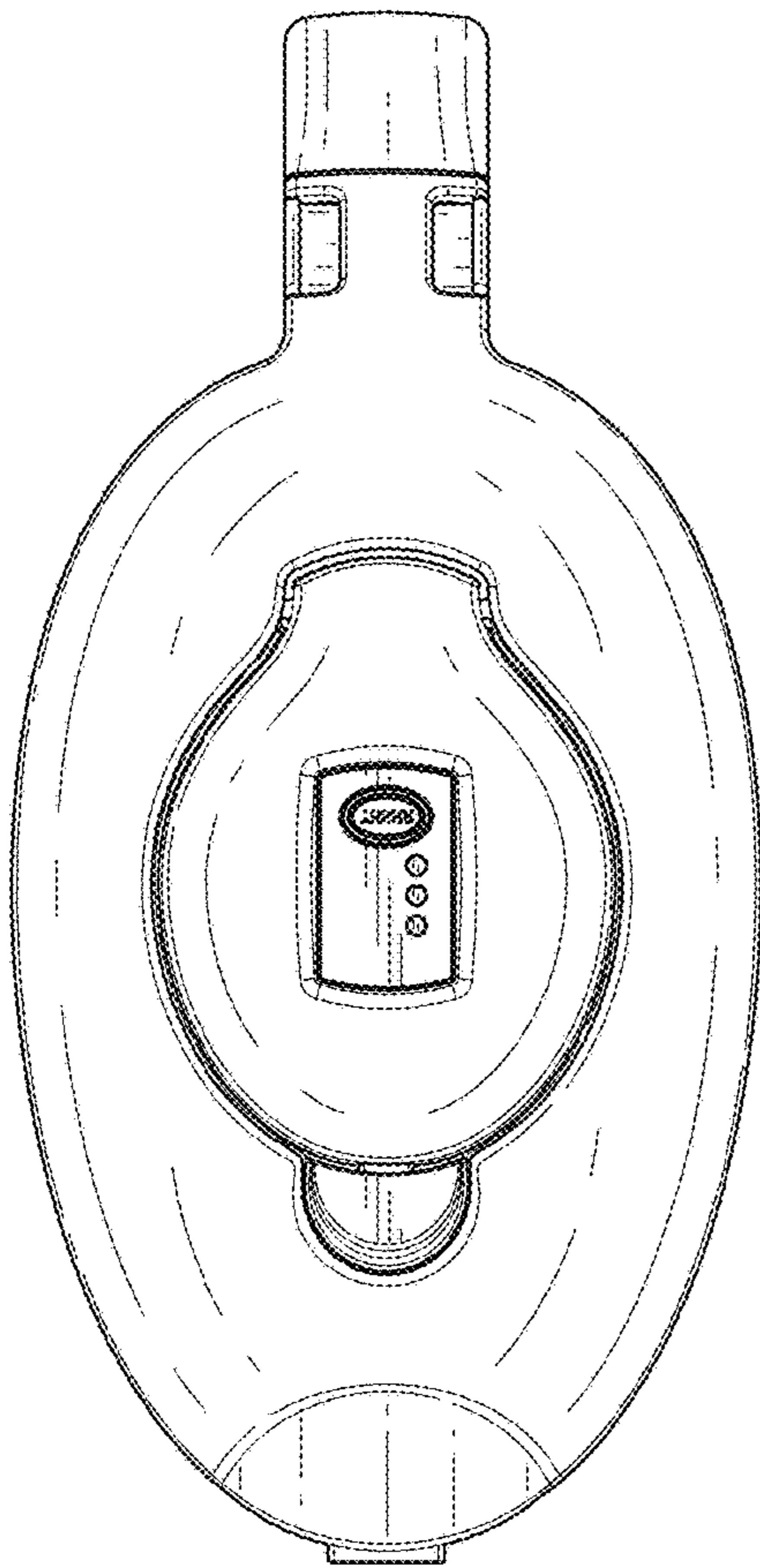

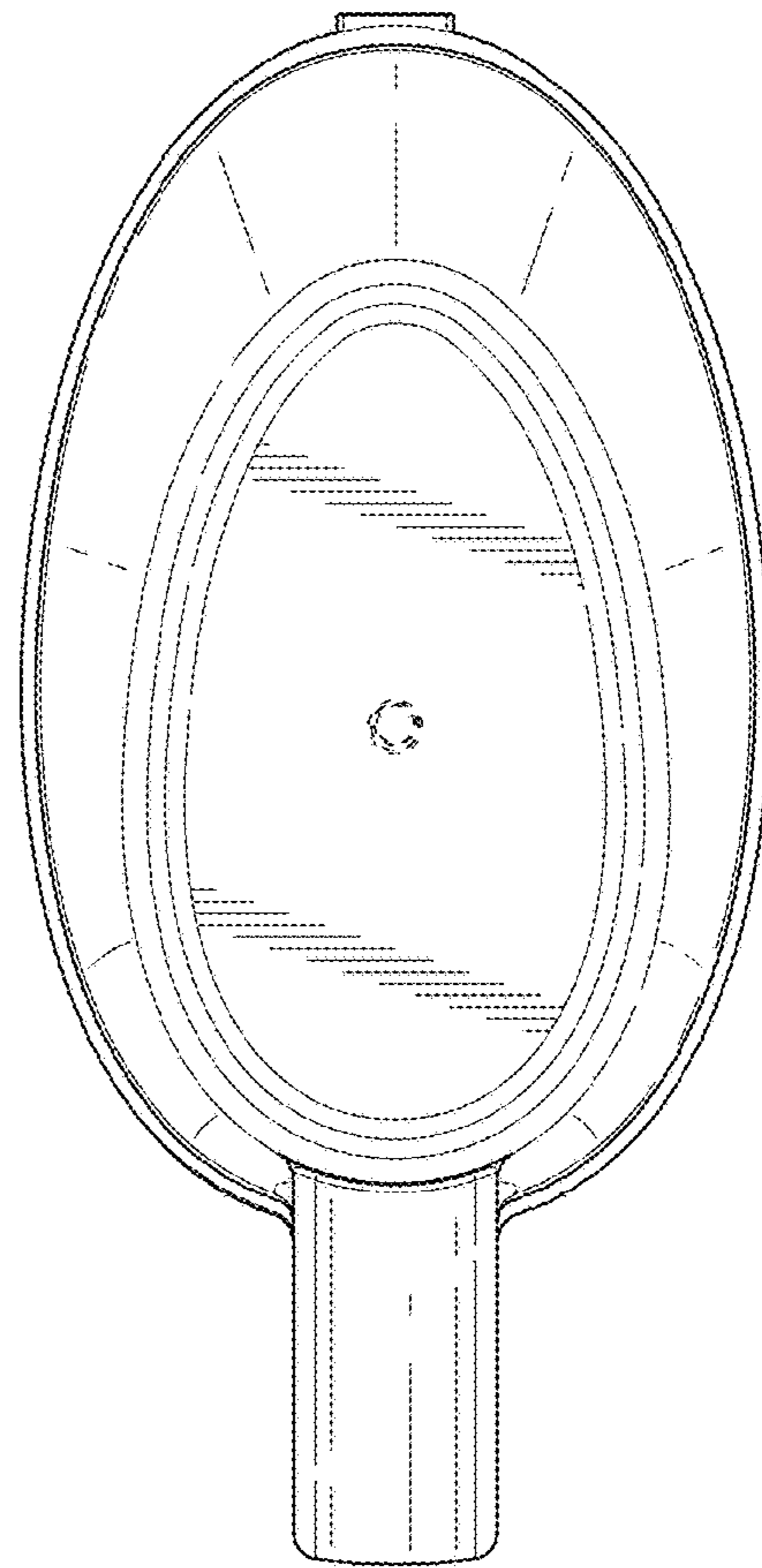
