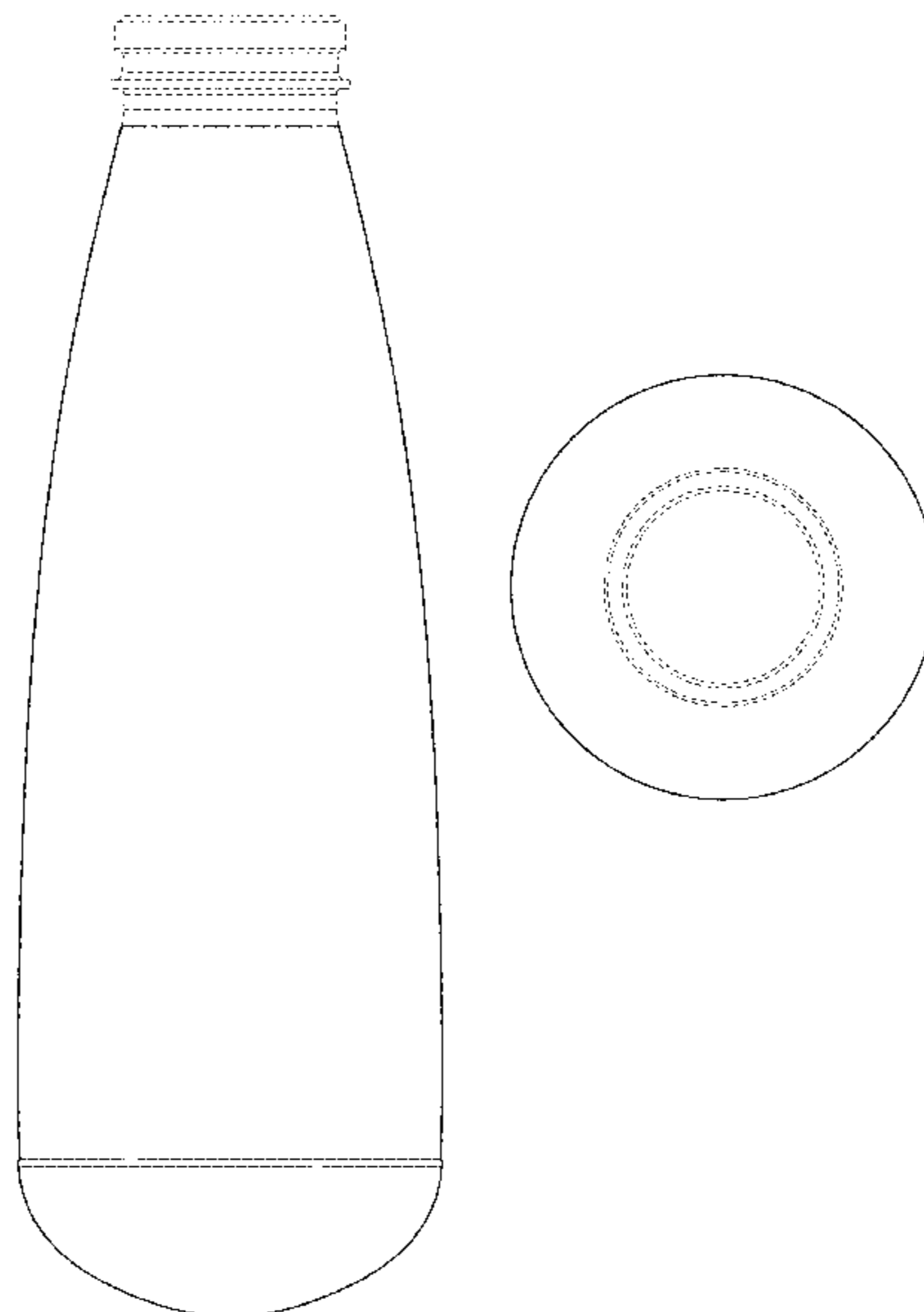
(57) **CLAIM**

The ornamental design for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of a top and front side of an ornamental design for a container; FIG. 2 is a front elevational view of the container of FIG. 1; FIG. 3 is a top plan view of the container of FIG. 1; and, FIG. 4 is a bottom plan view of the container of FIG. 1. The dash-dash-dash-dash broken lines are included for the purpose of illustrating portions of the container that form no part of the claimed design. The dash-dot-dash-dot broken lines shown in the drawings define an upper boundary of the container.

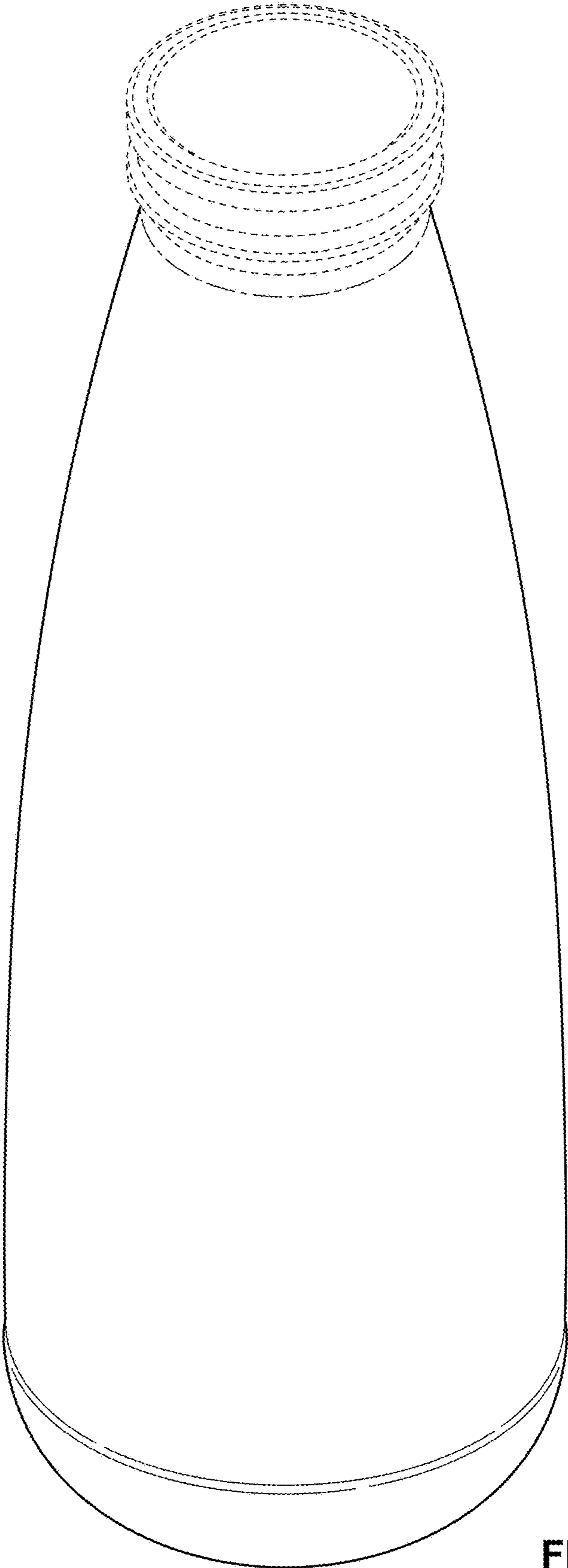

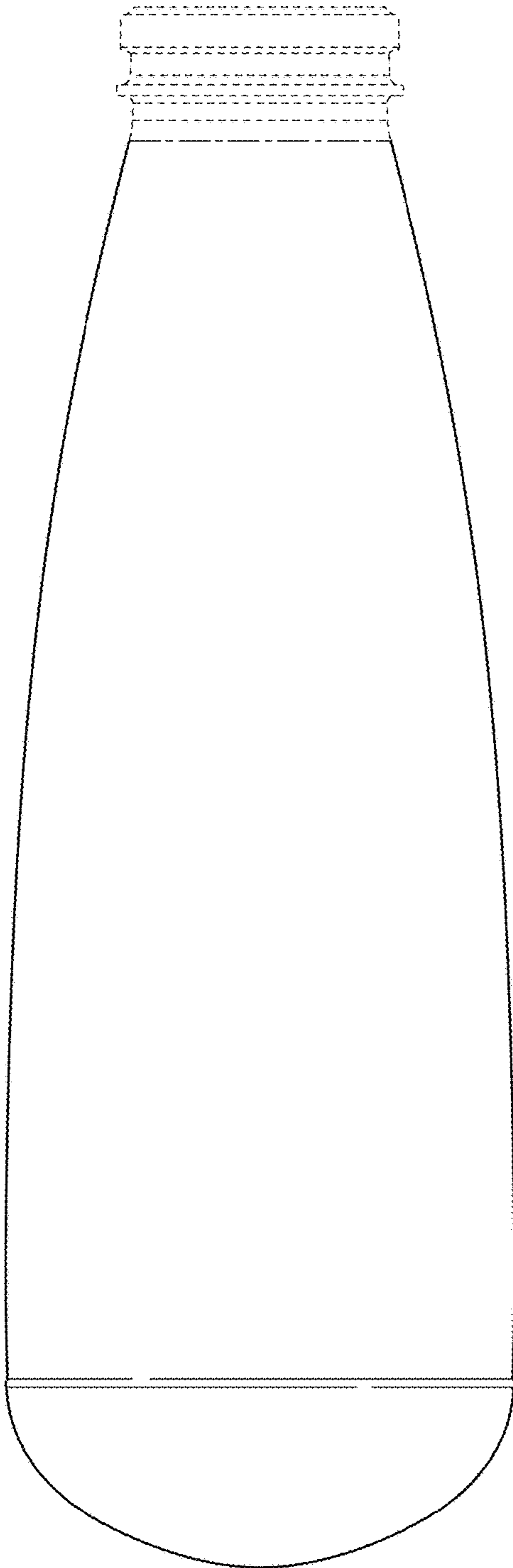

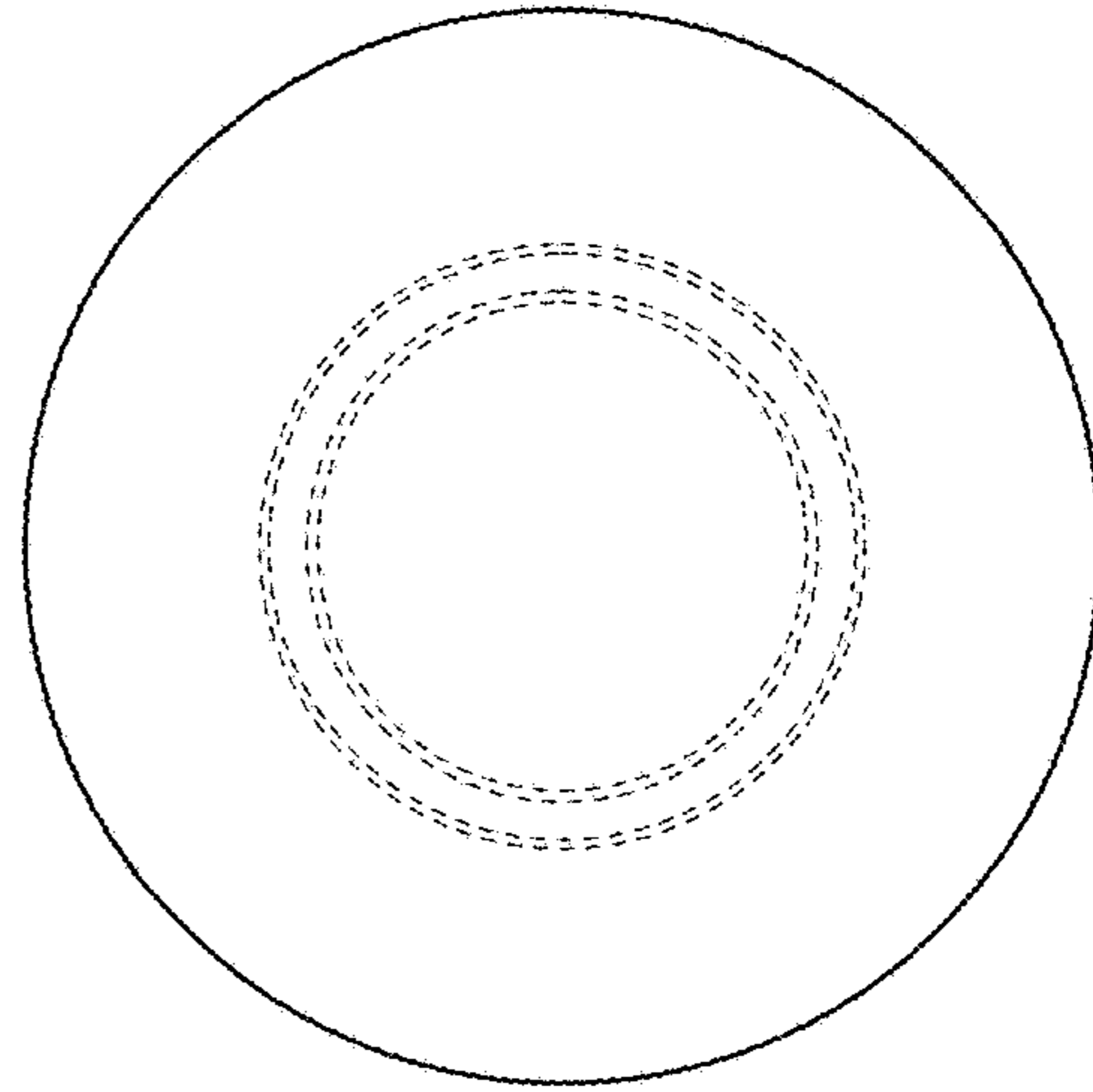

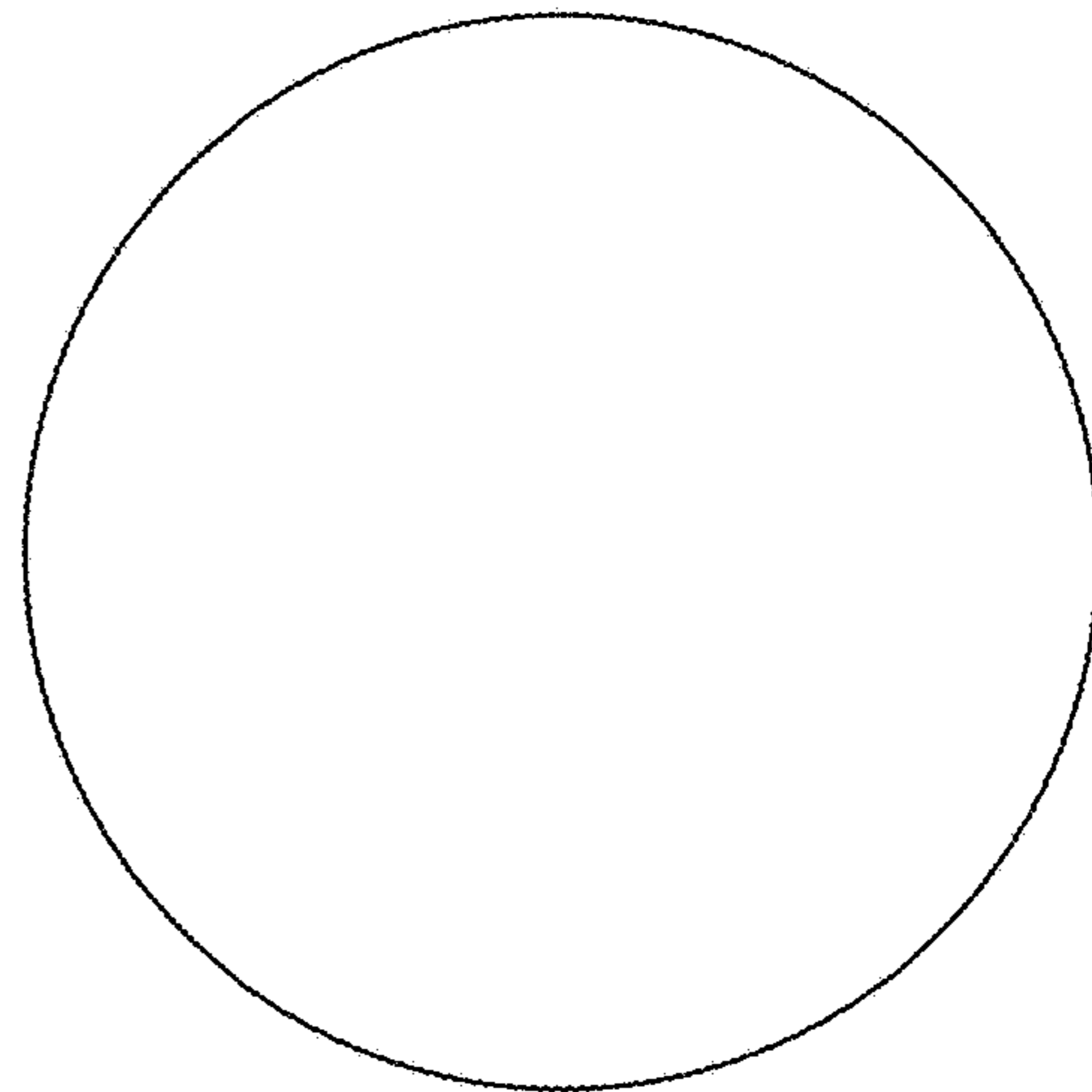
