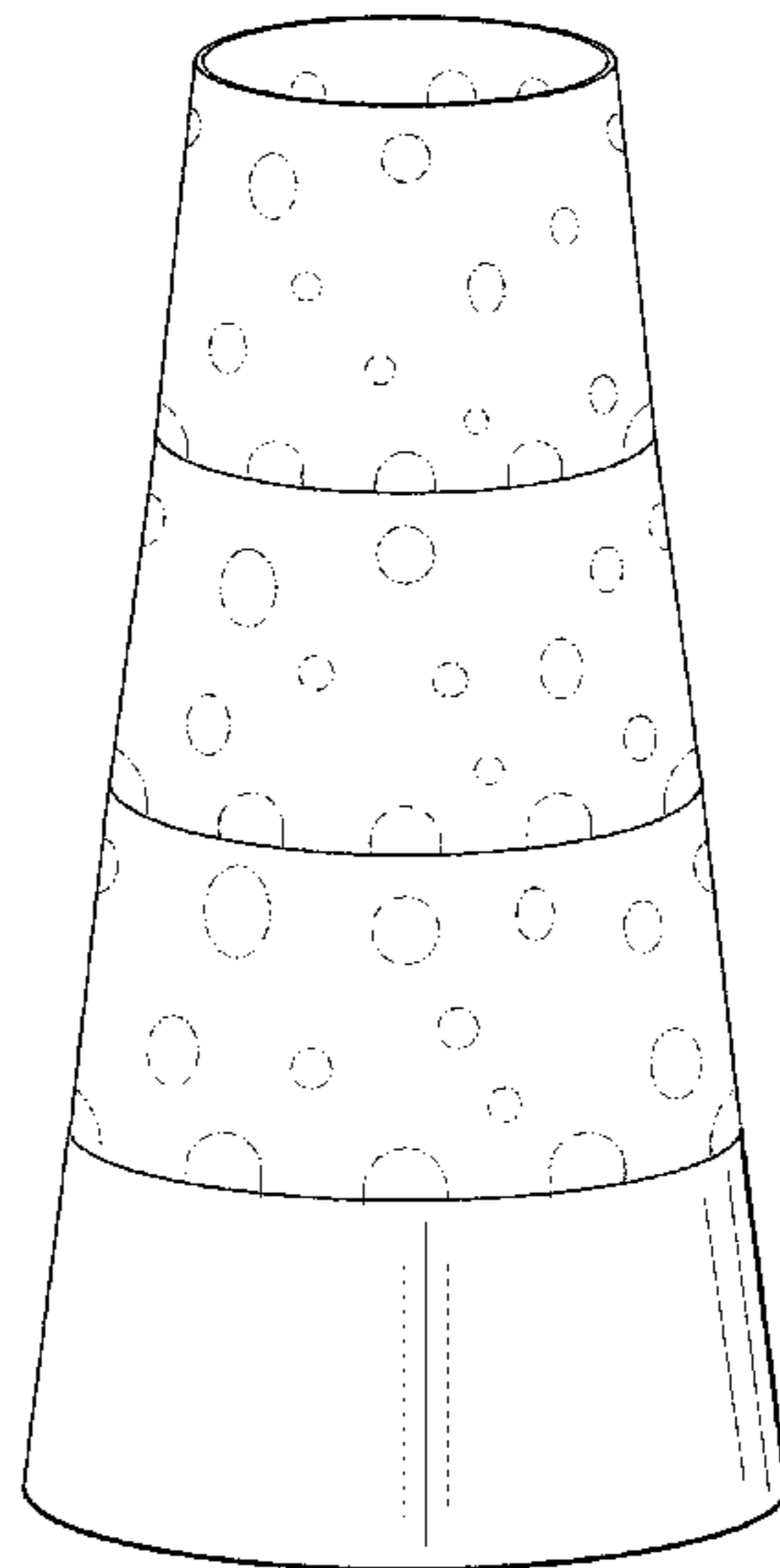
The ornamental design for a segmented vase, as shown and described.

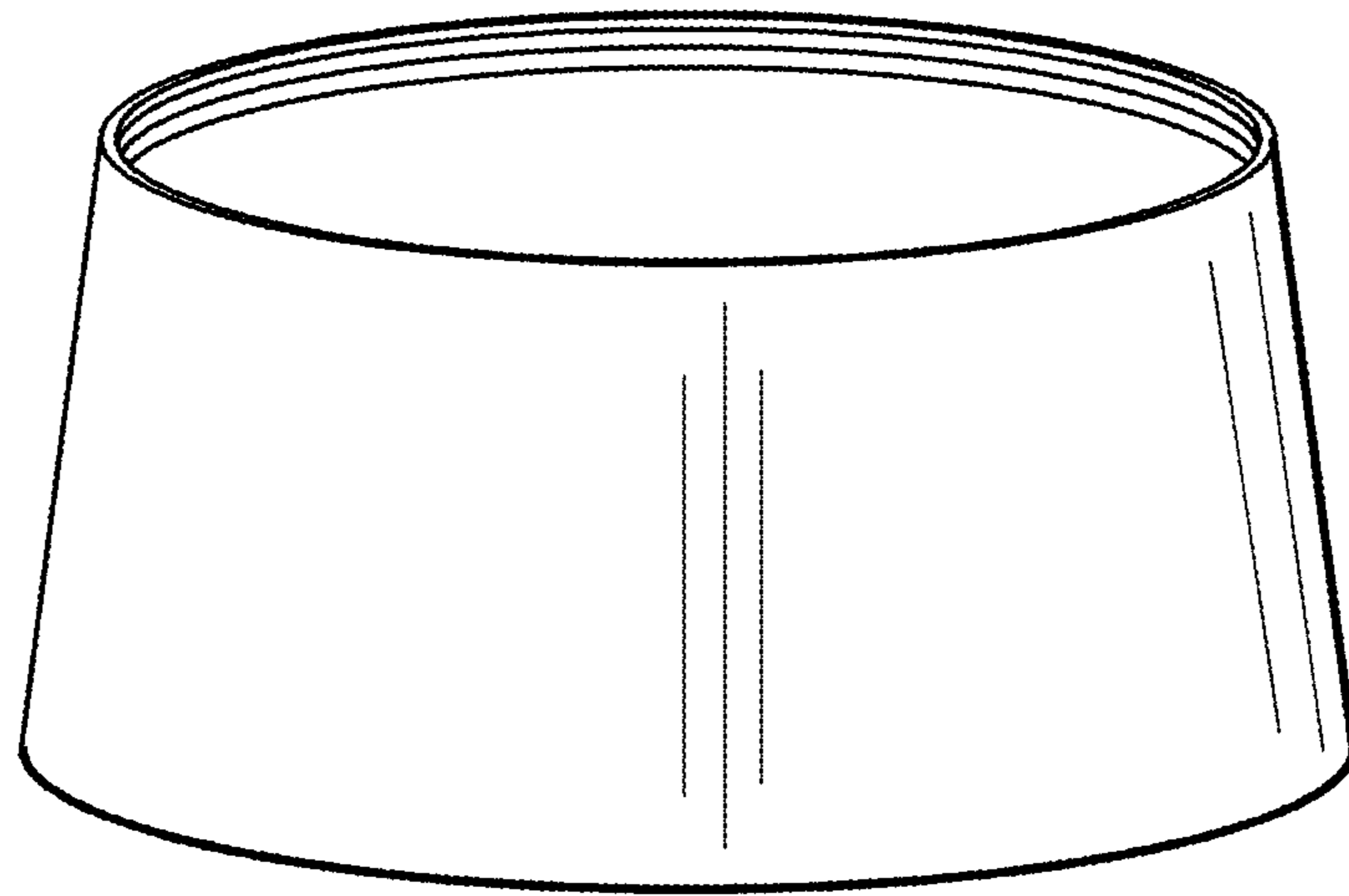

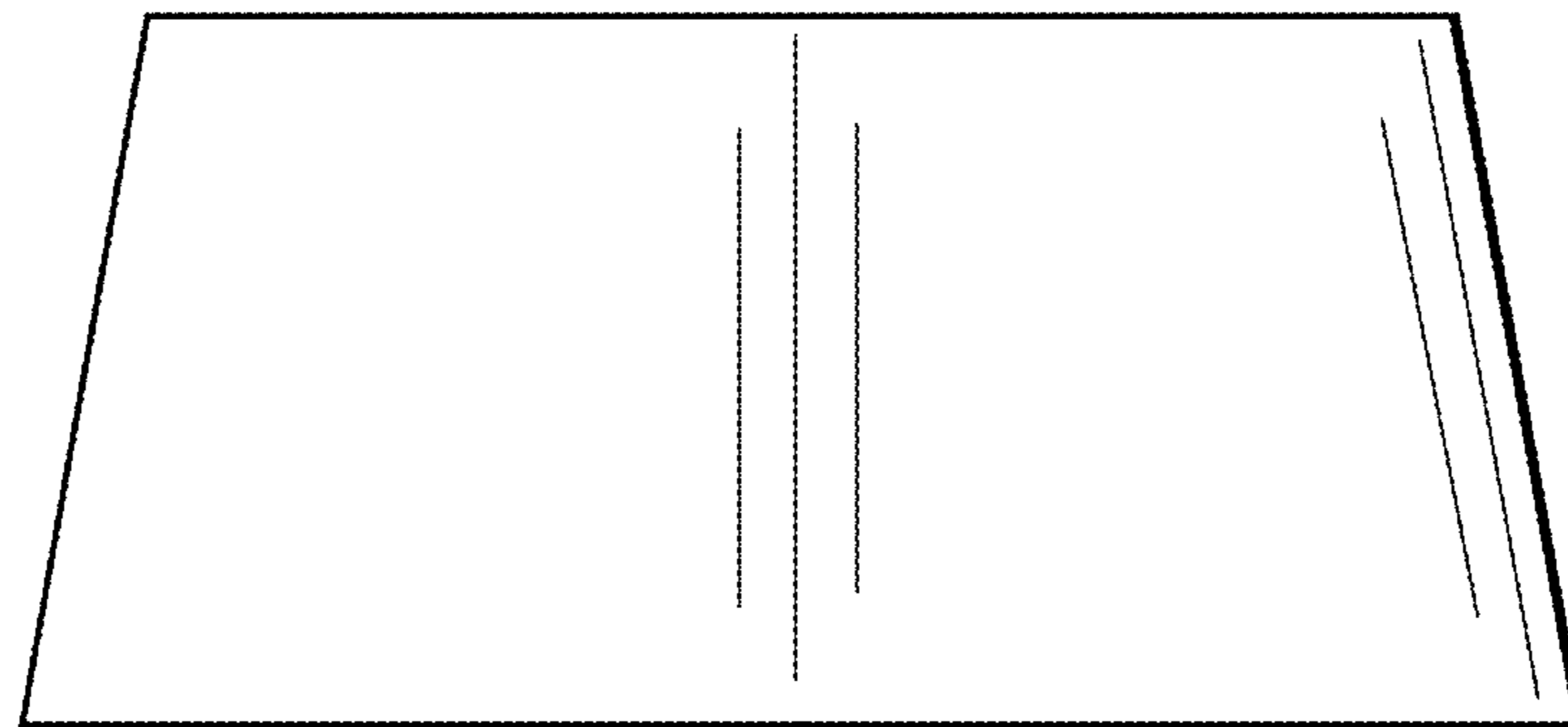

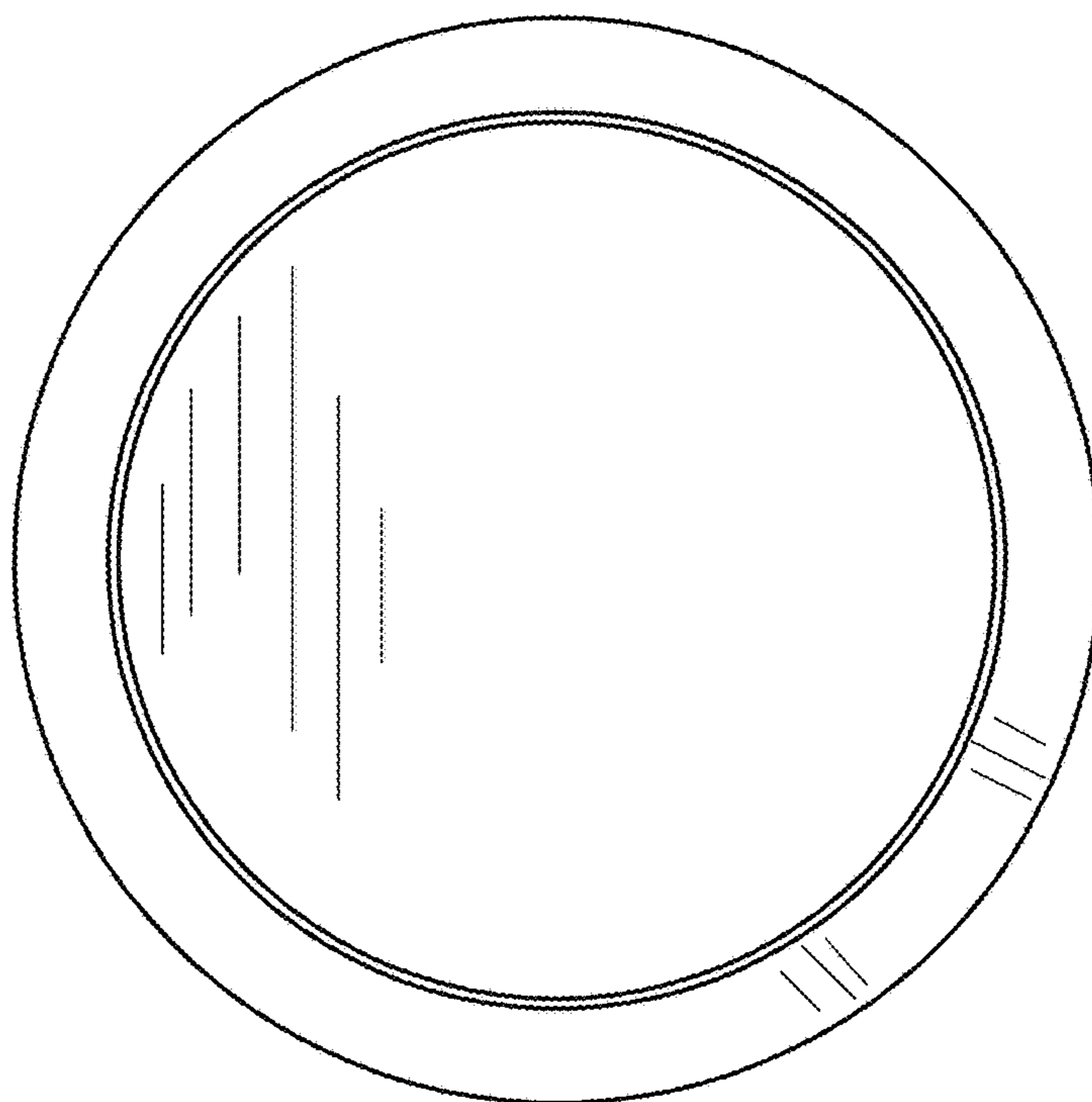

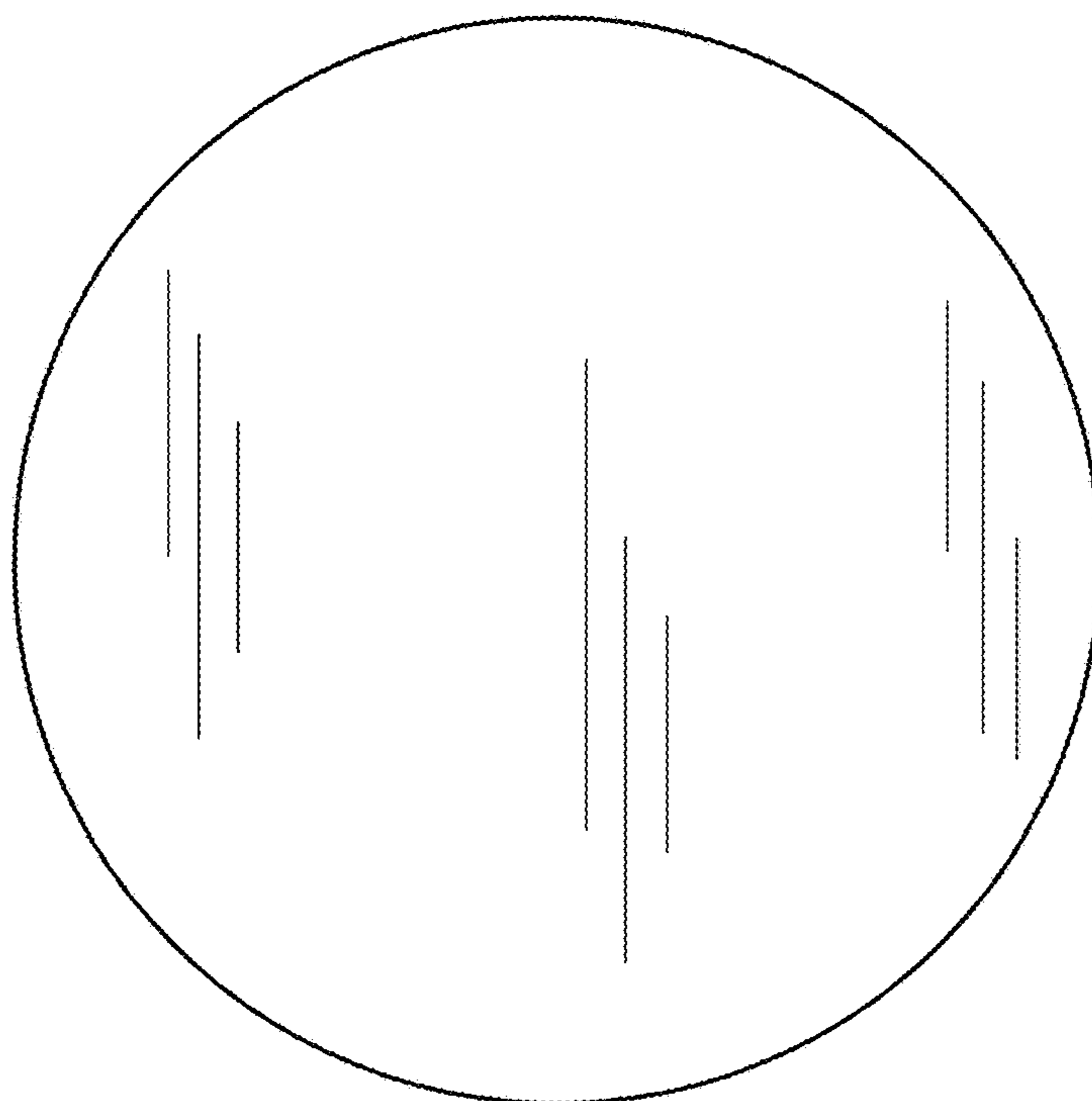

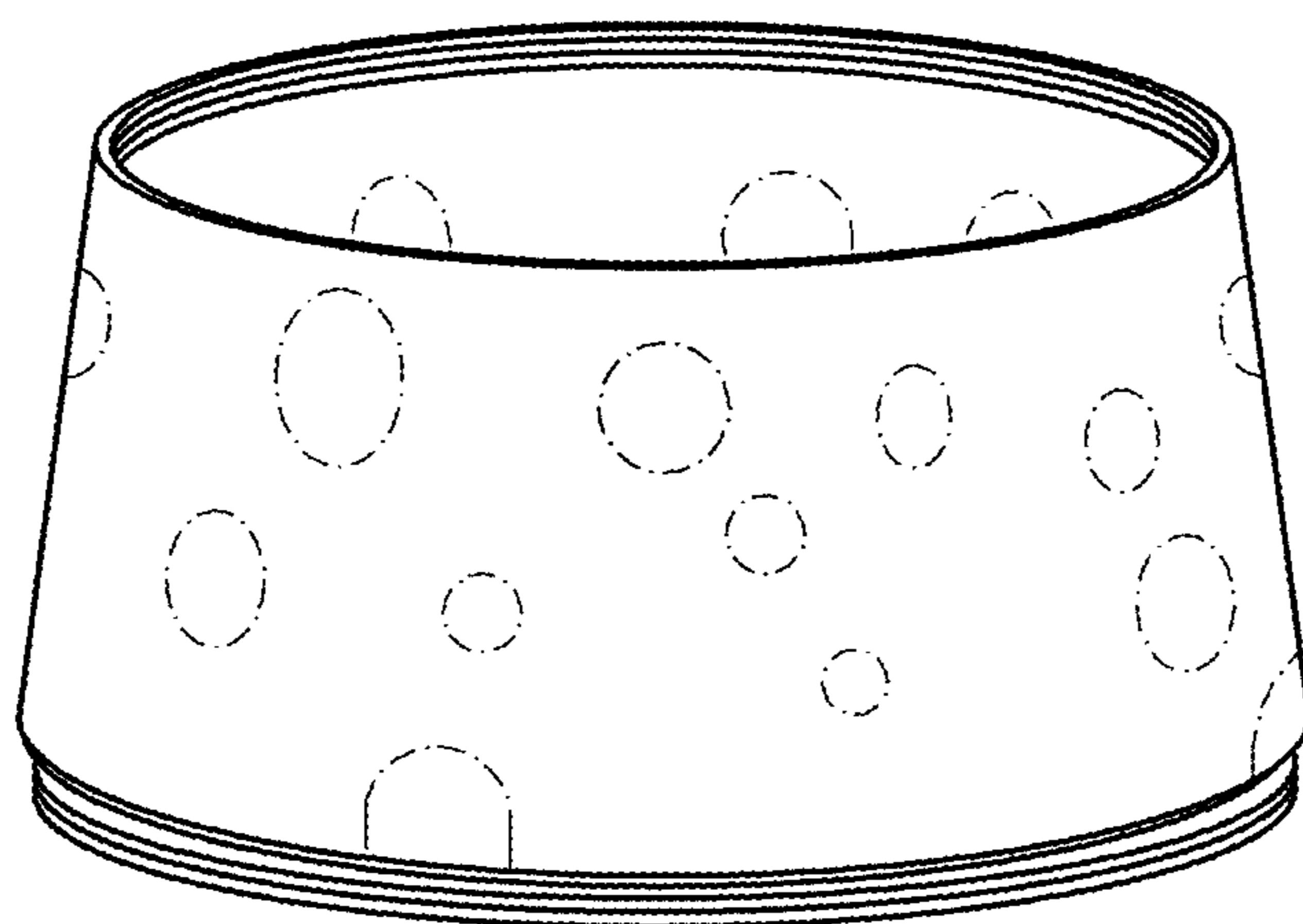

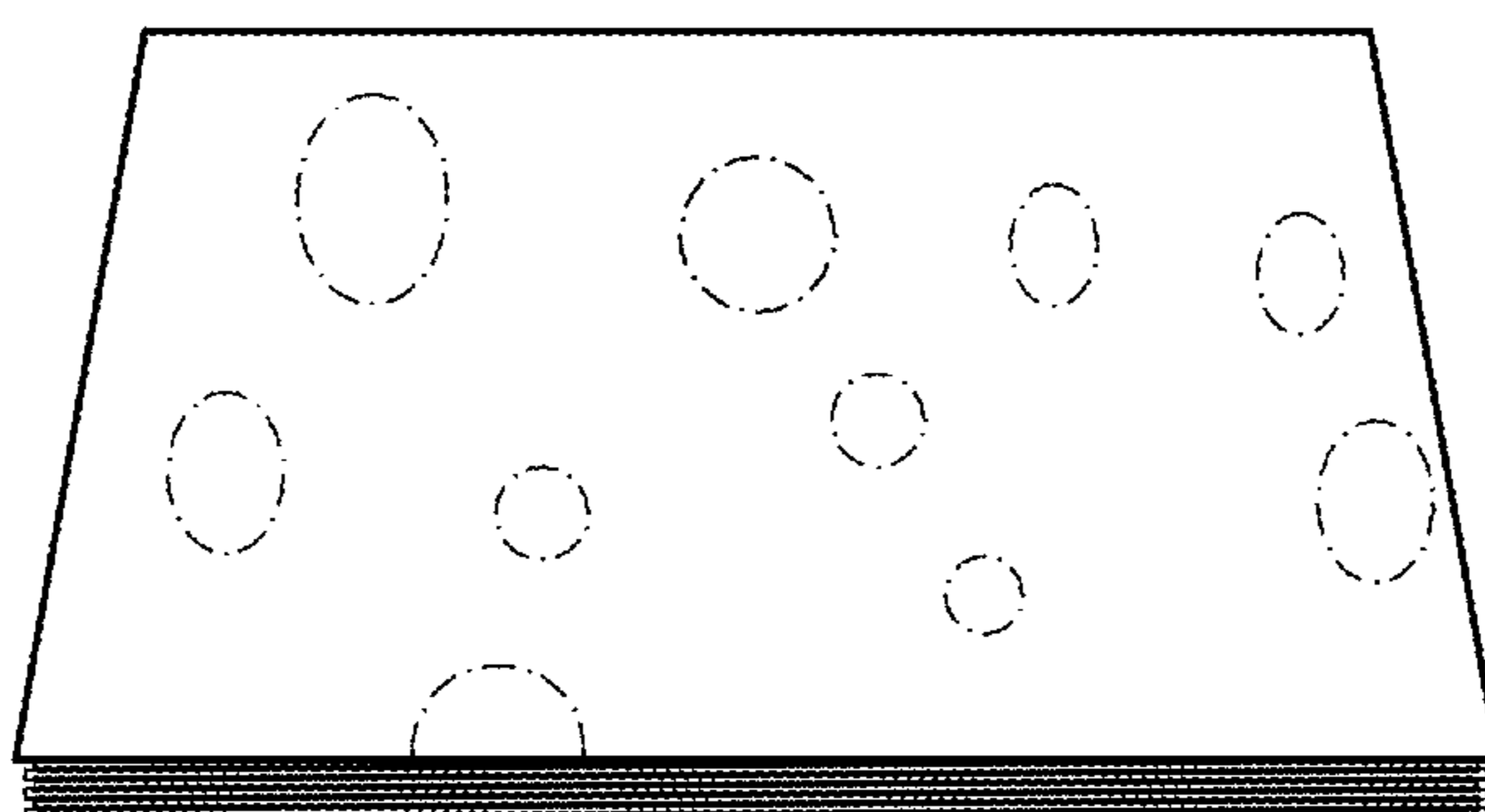

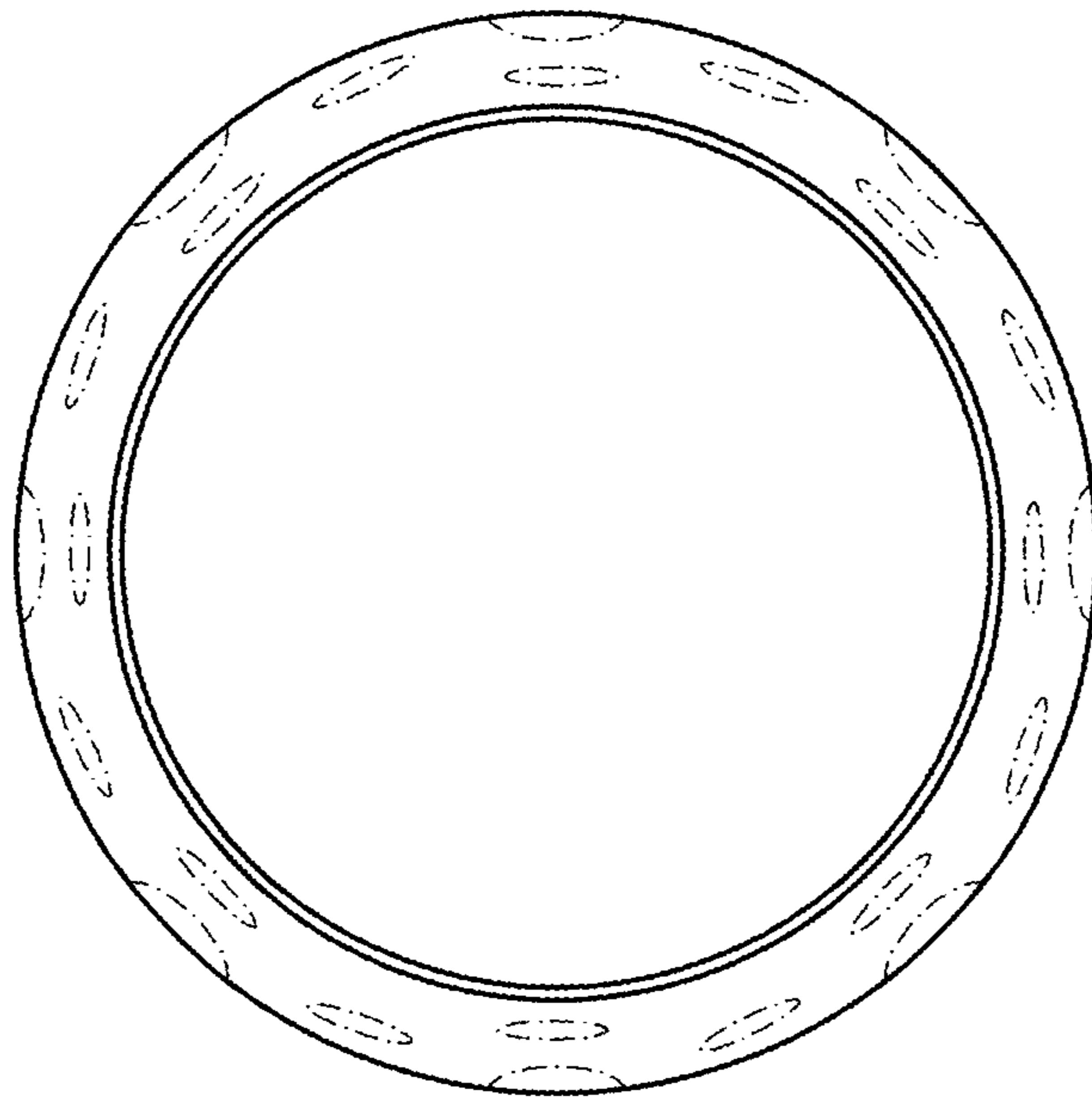

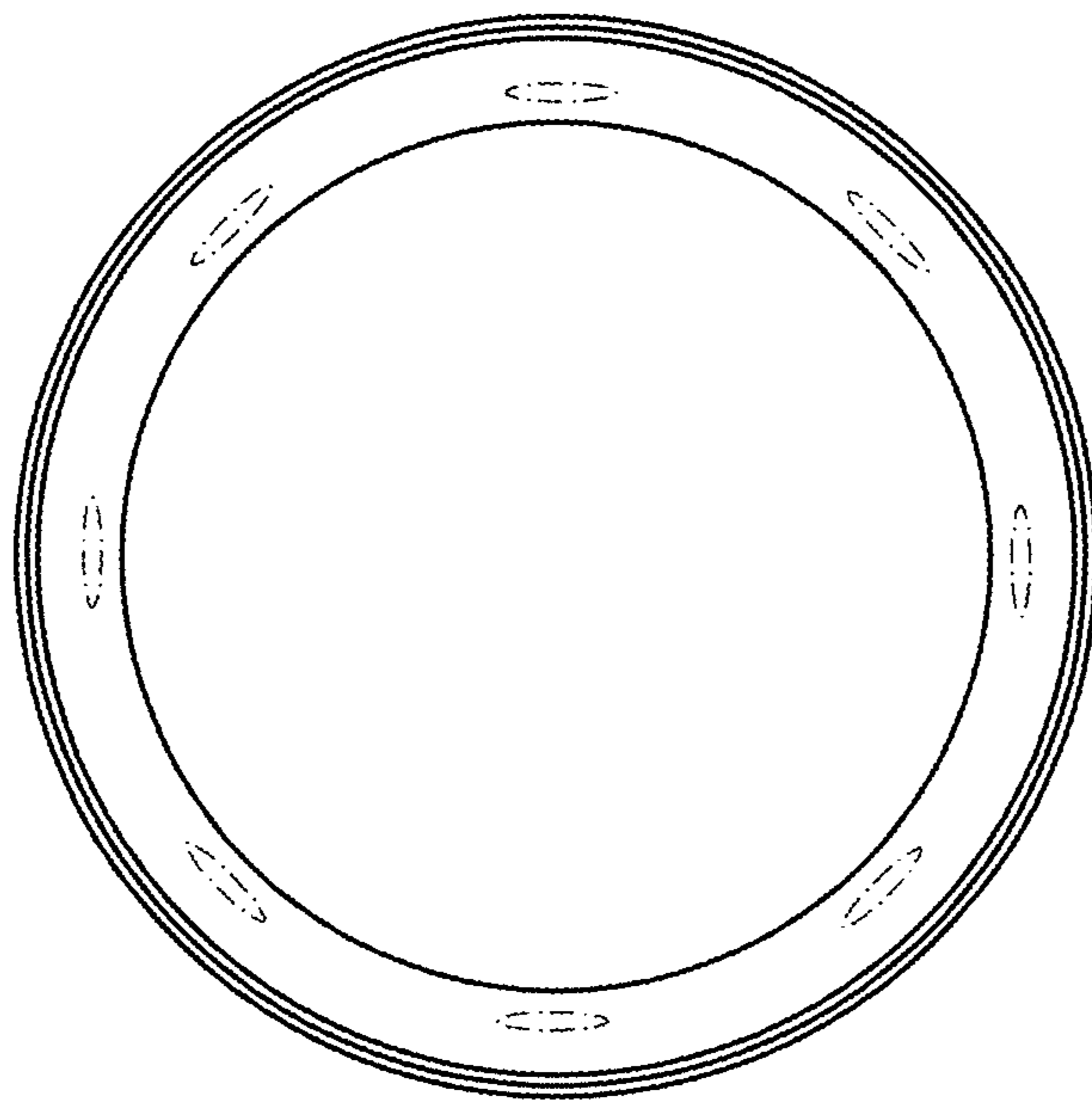

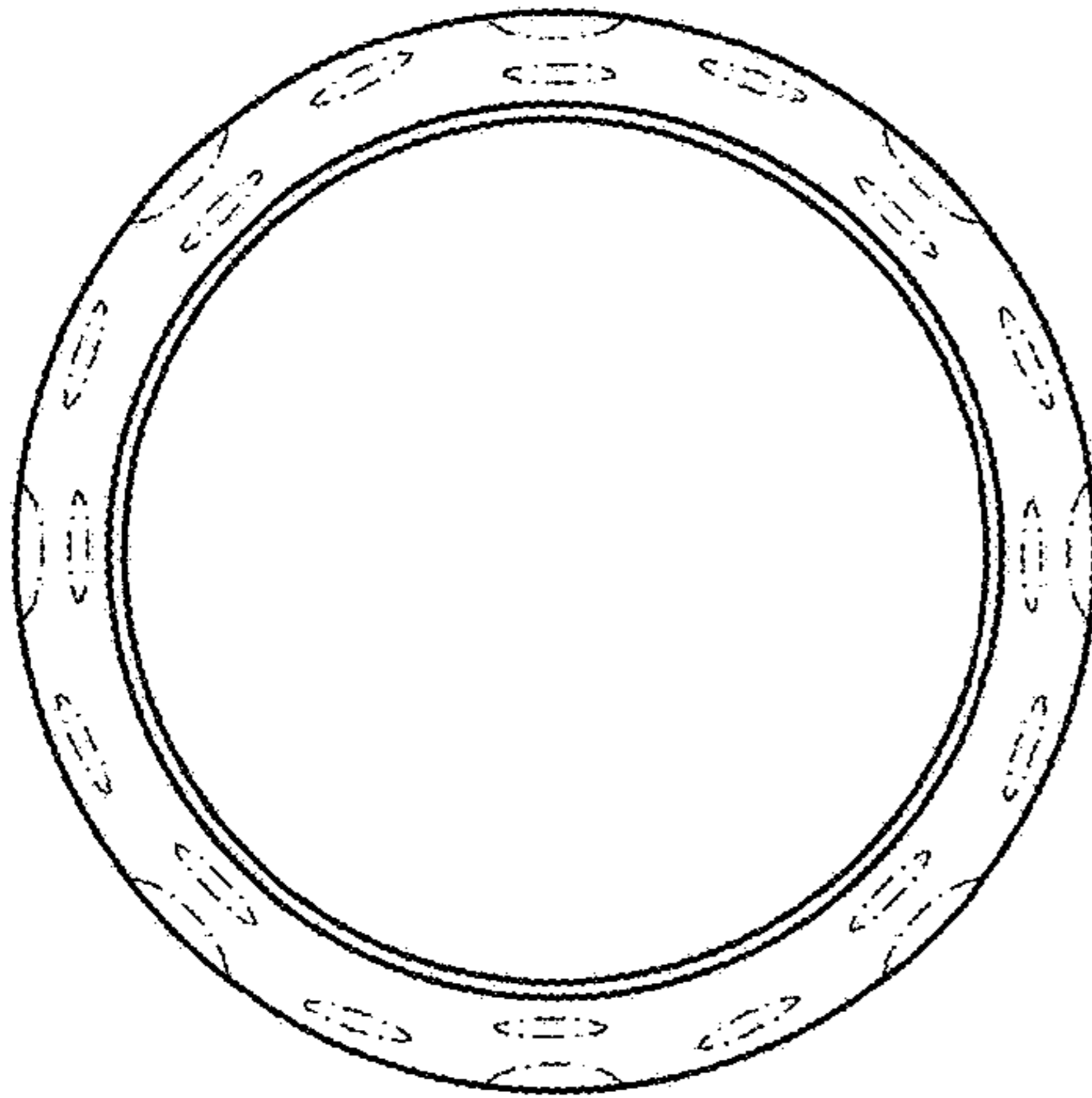

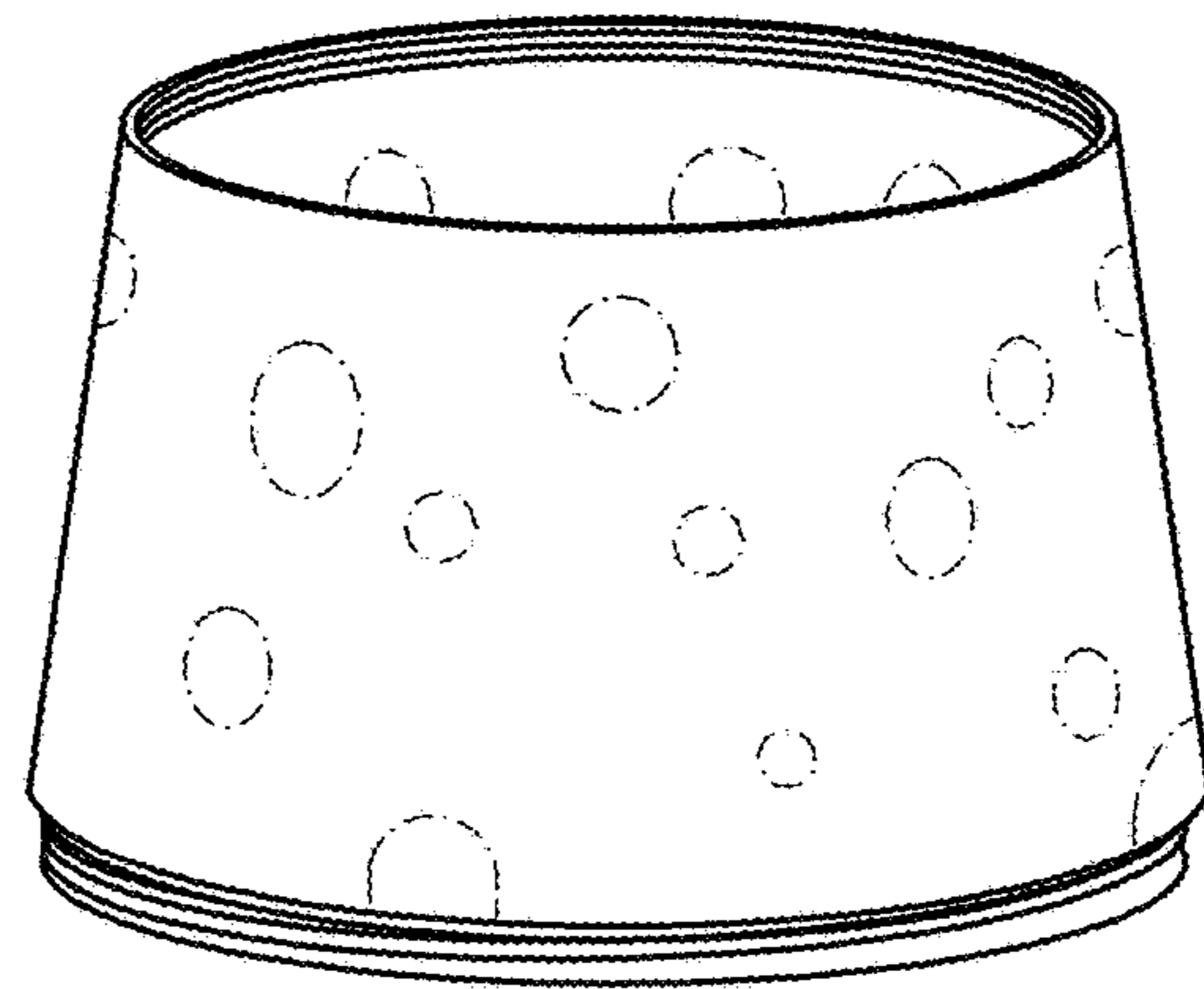

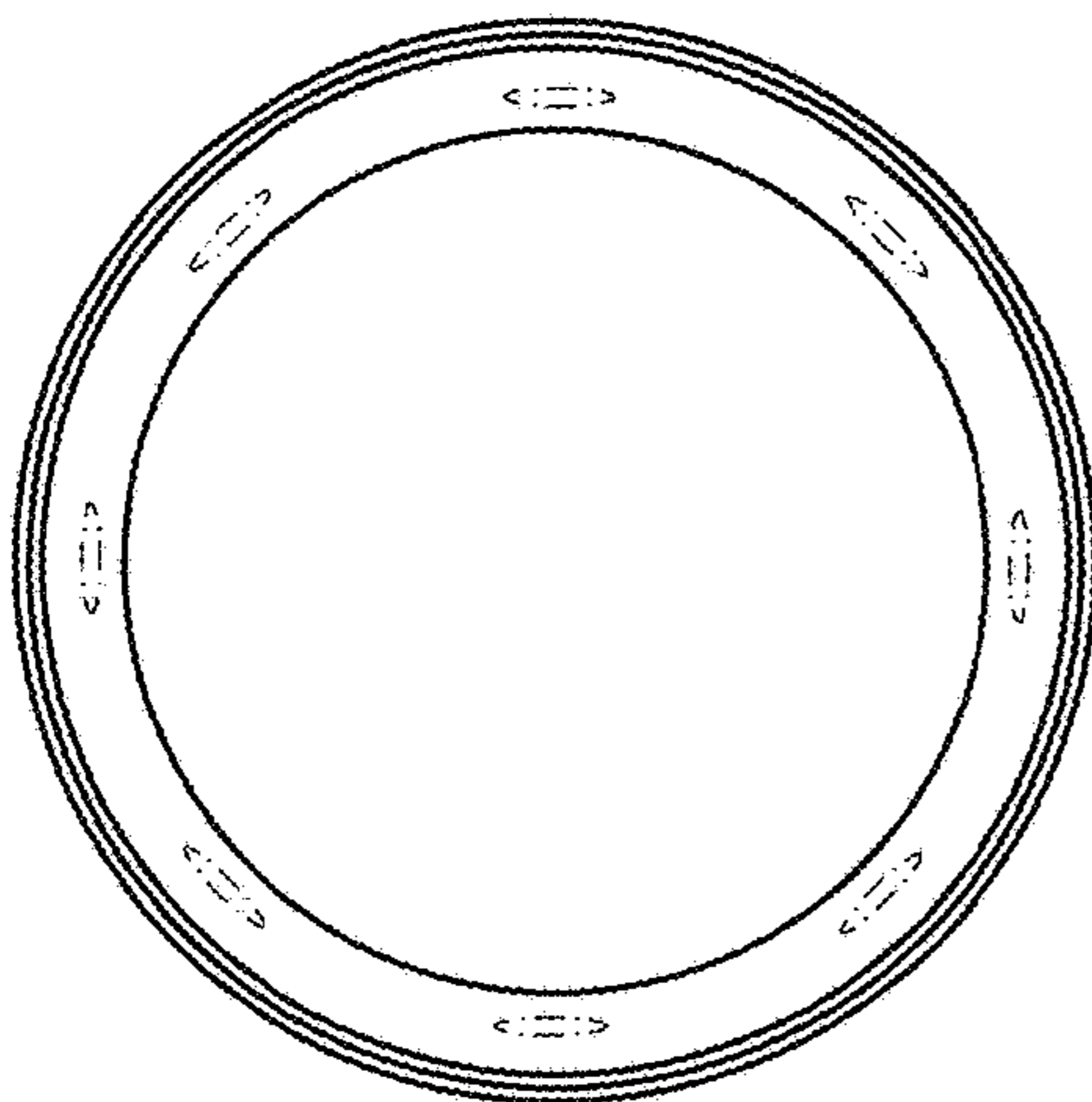

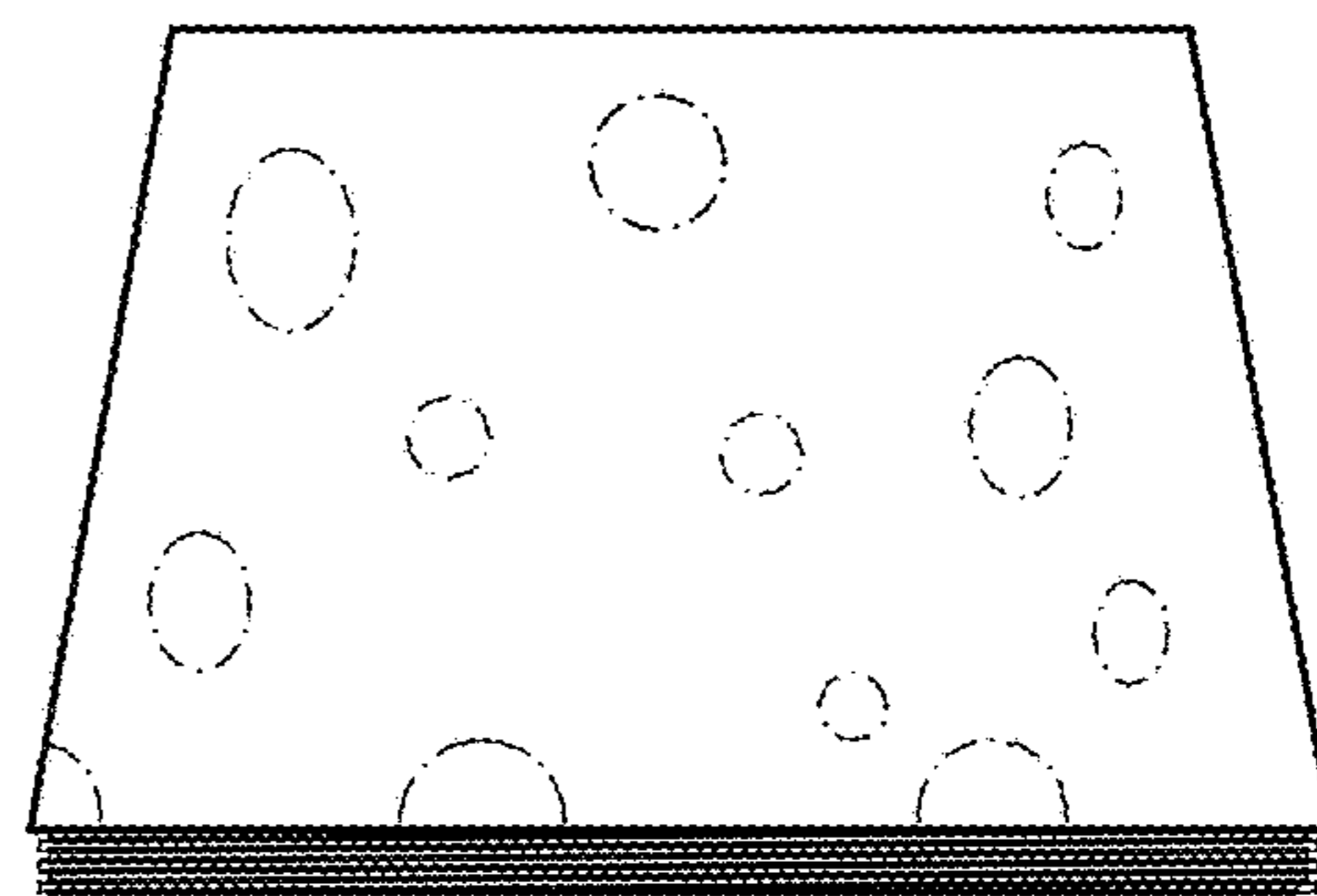

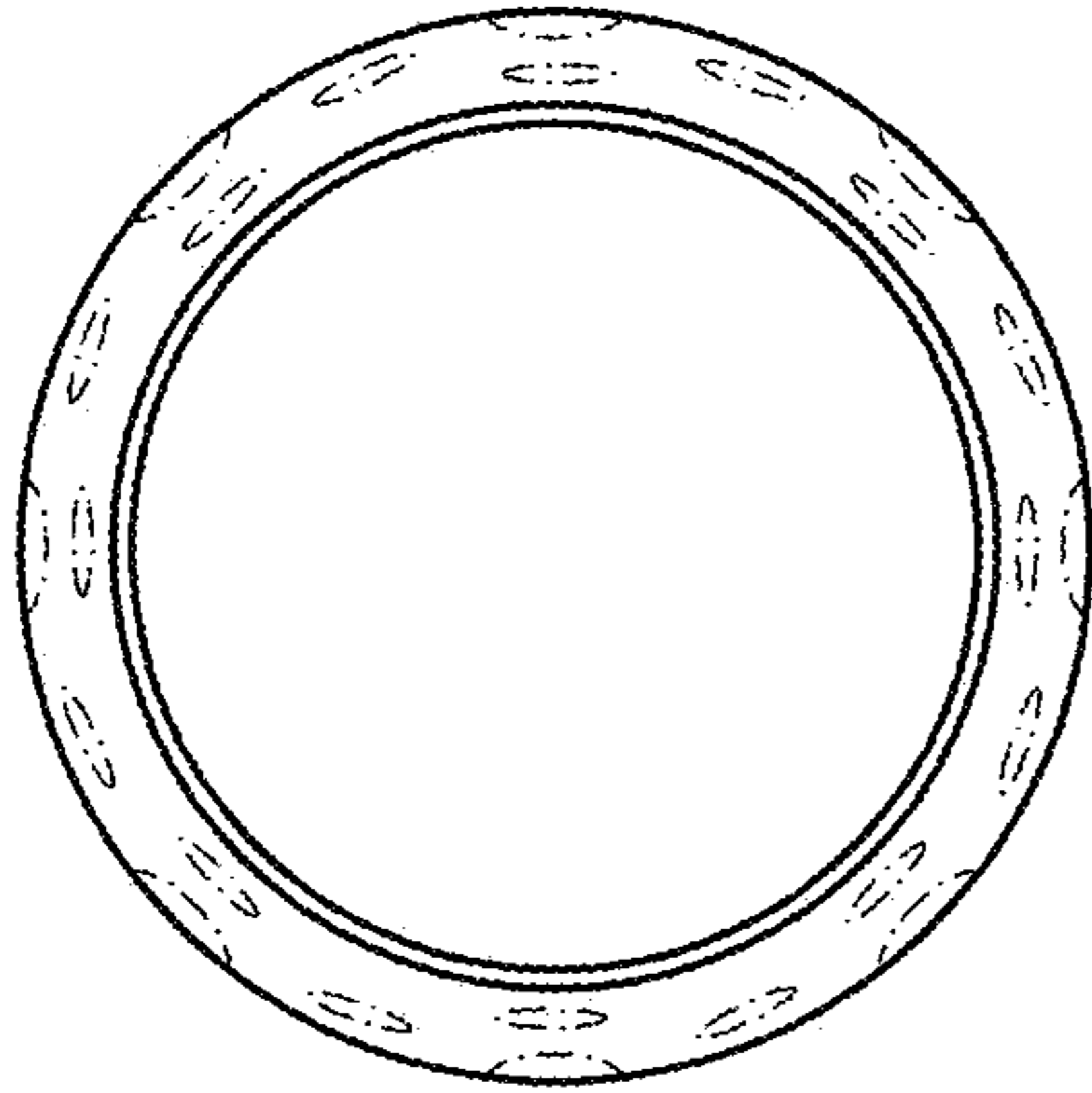

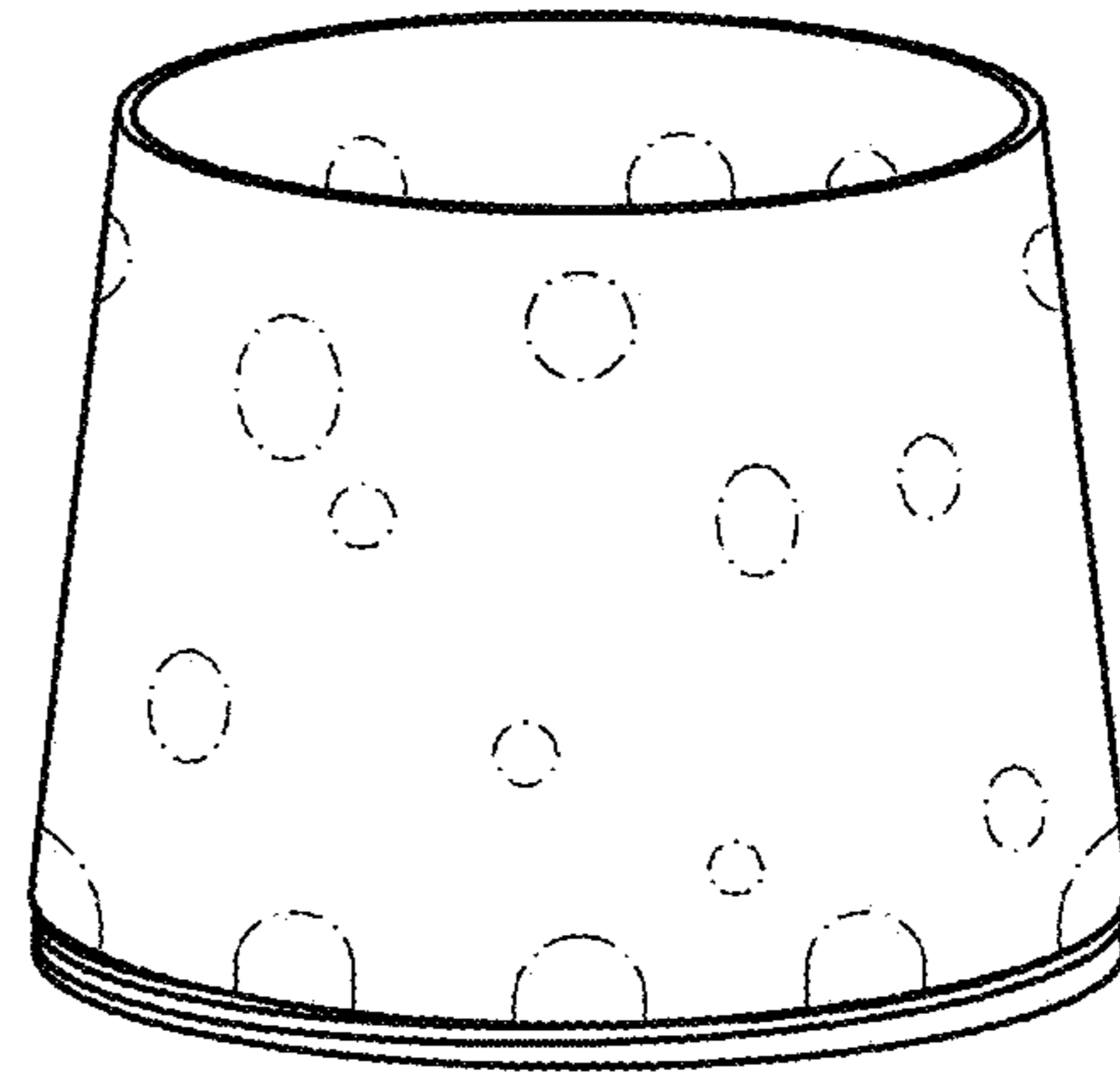

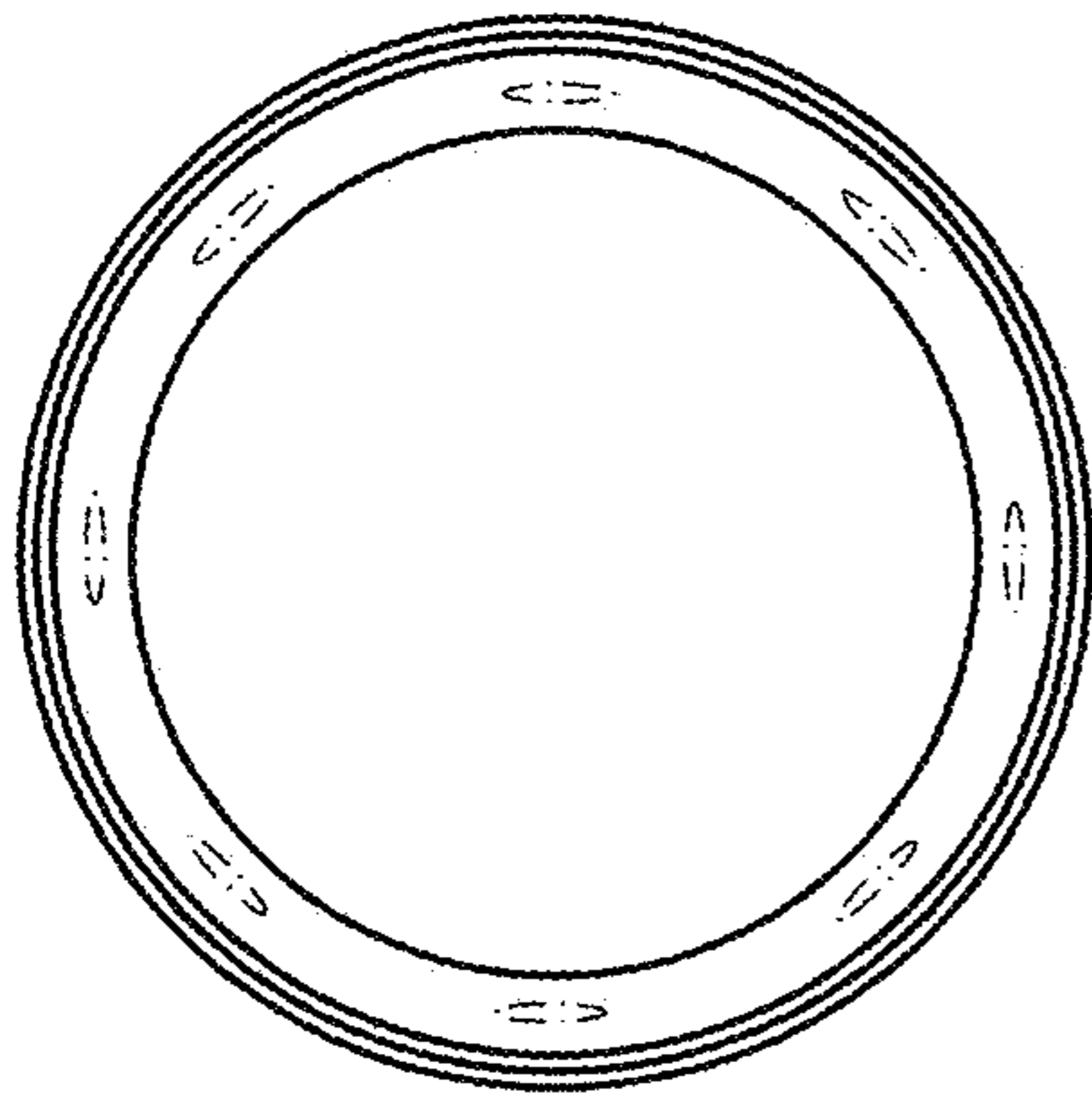

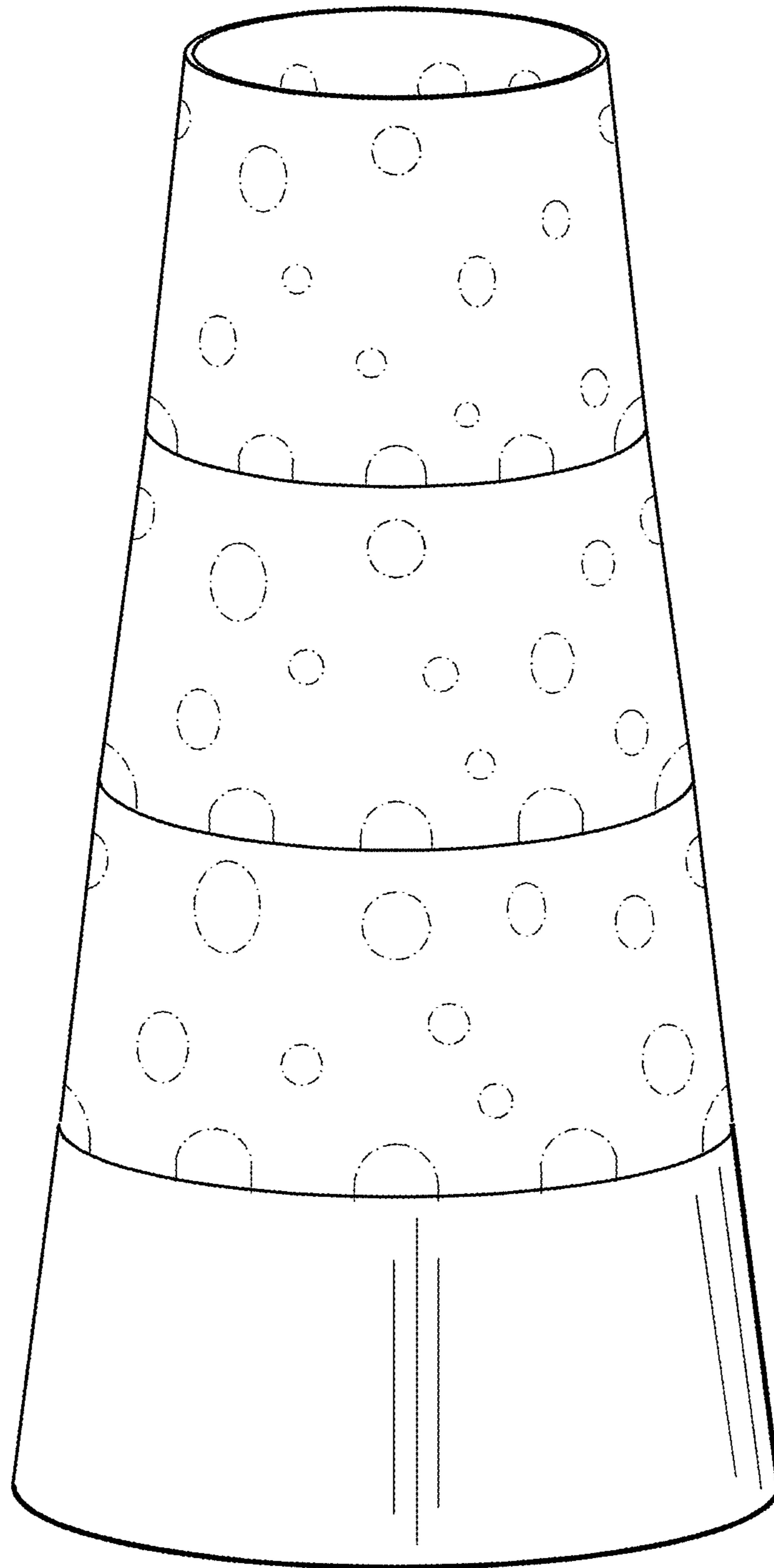

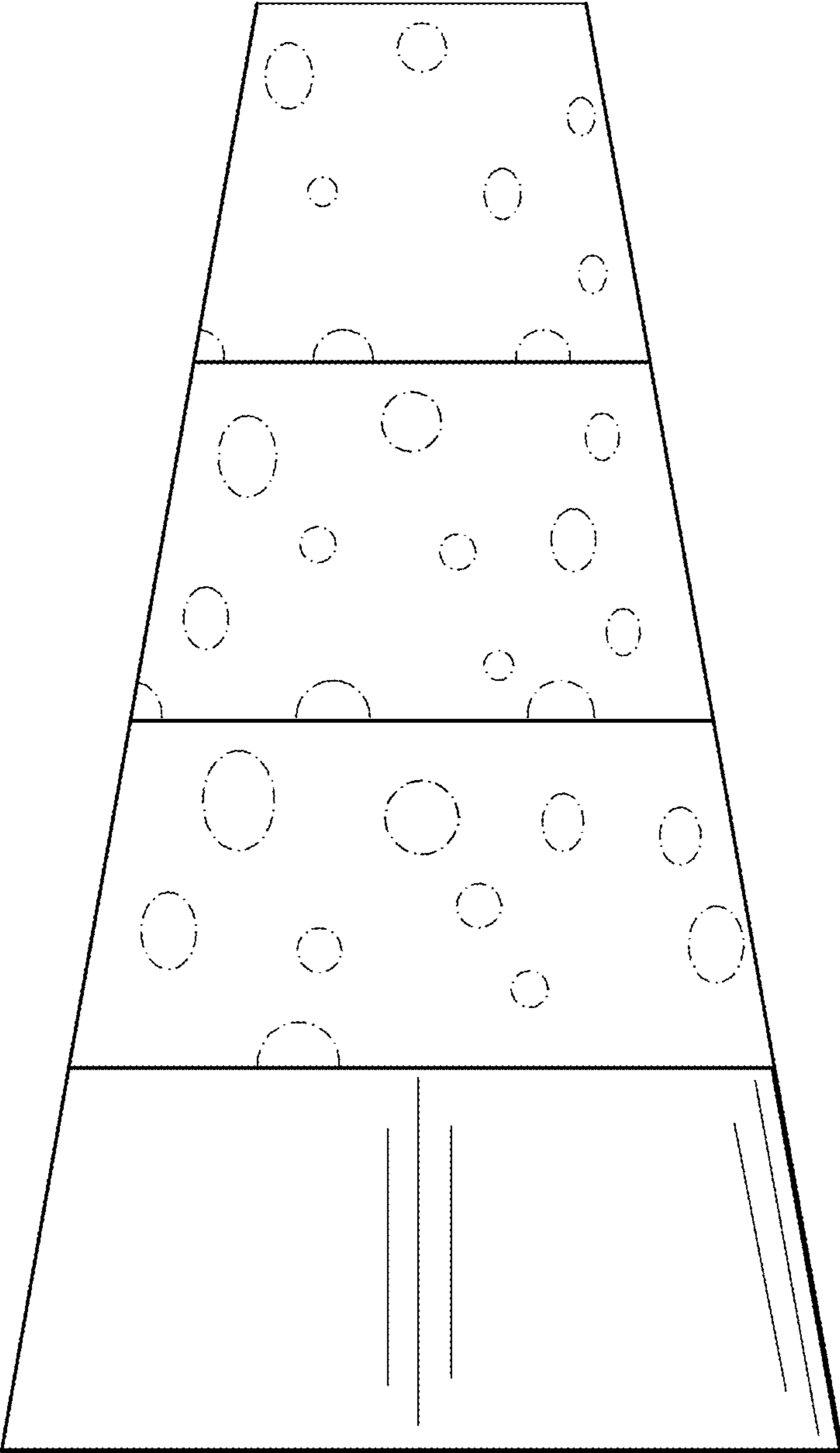

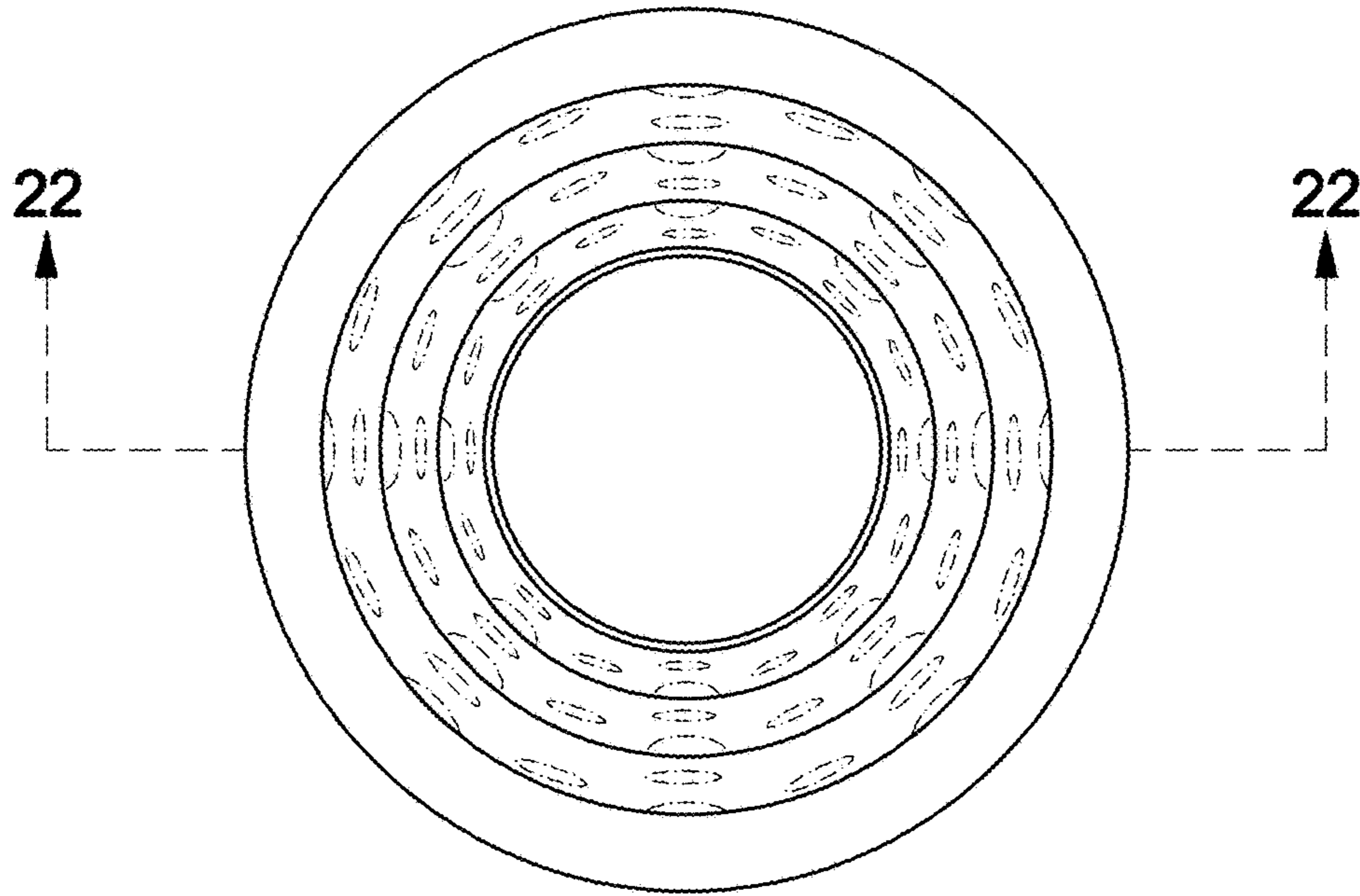




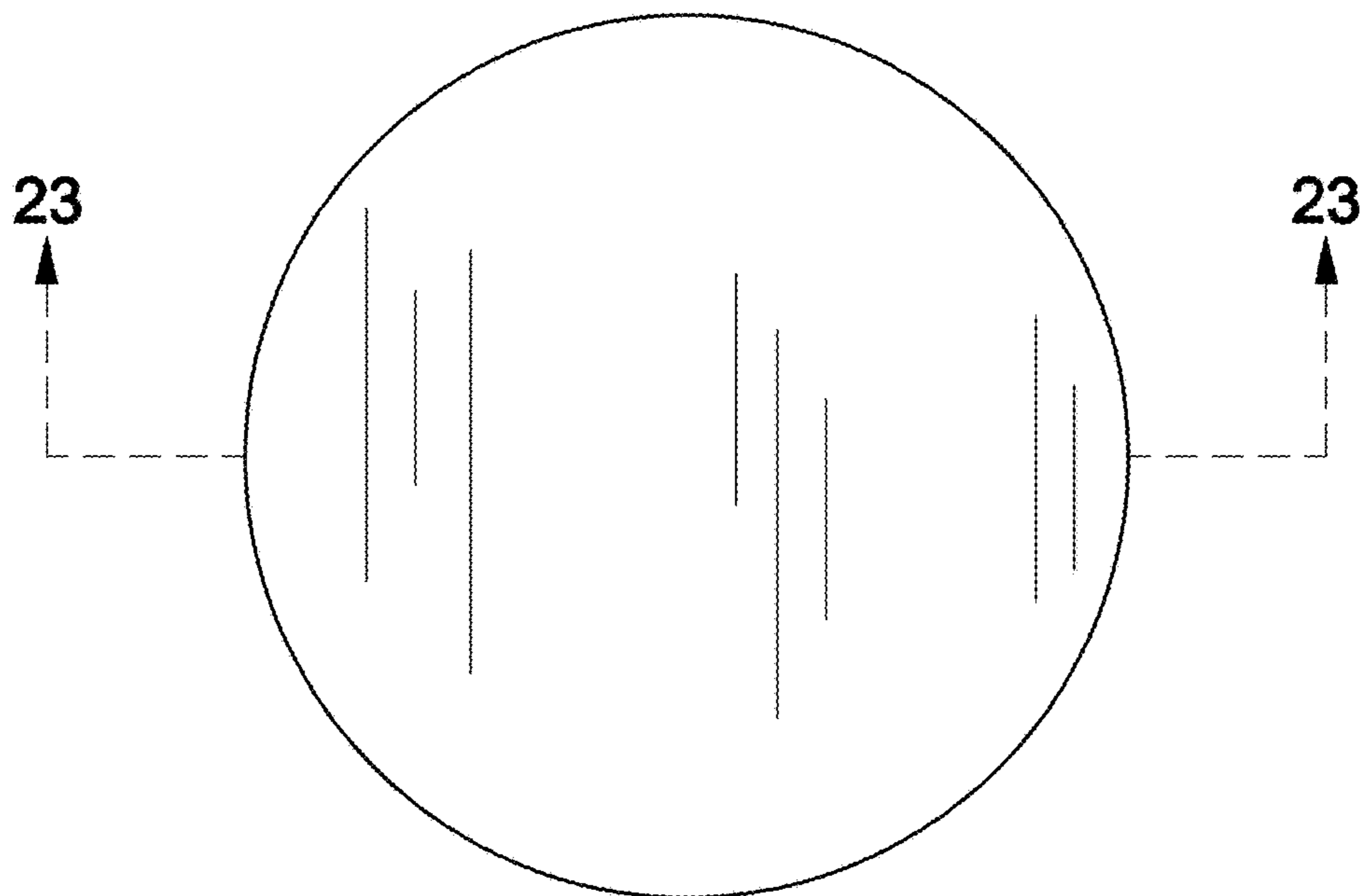

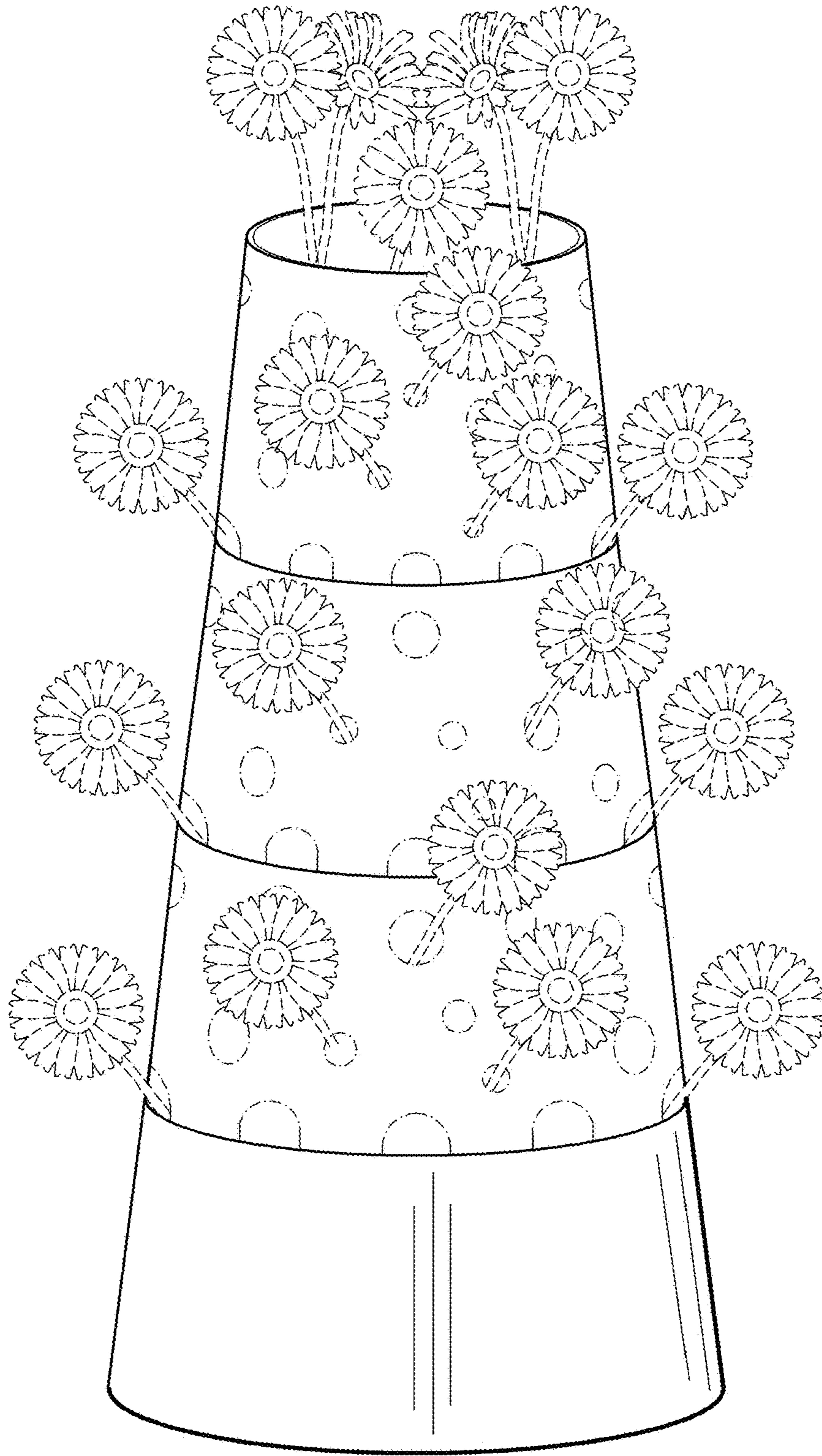

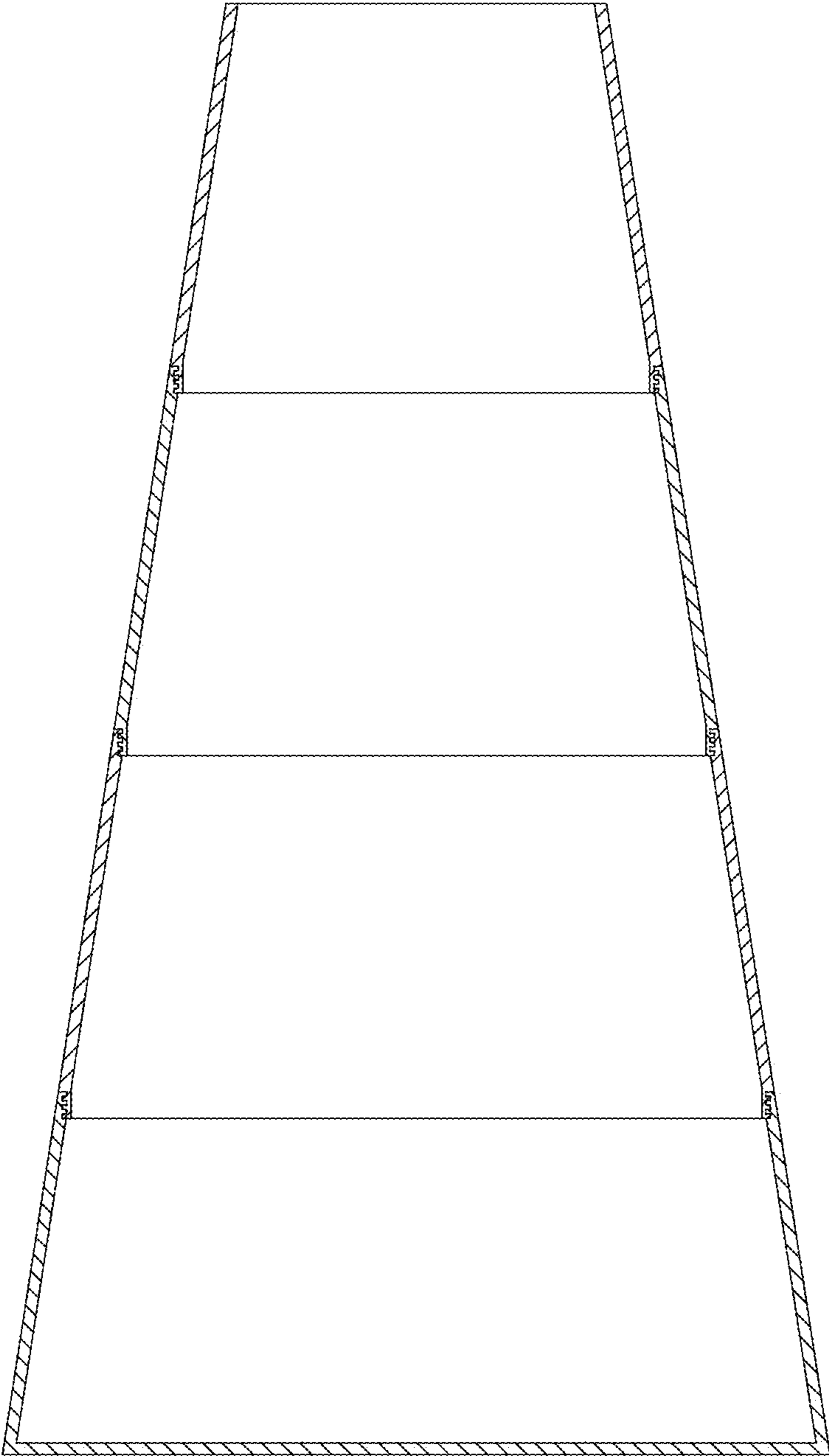

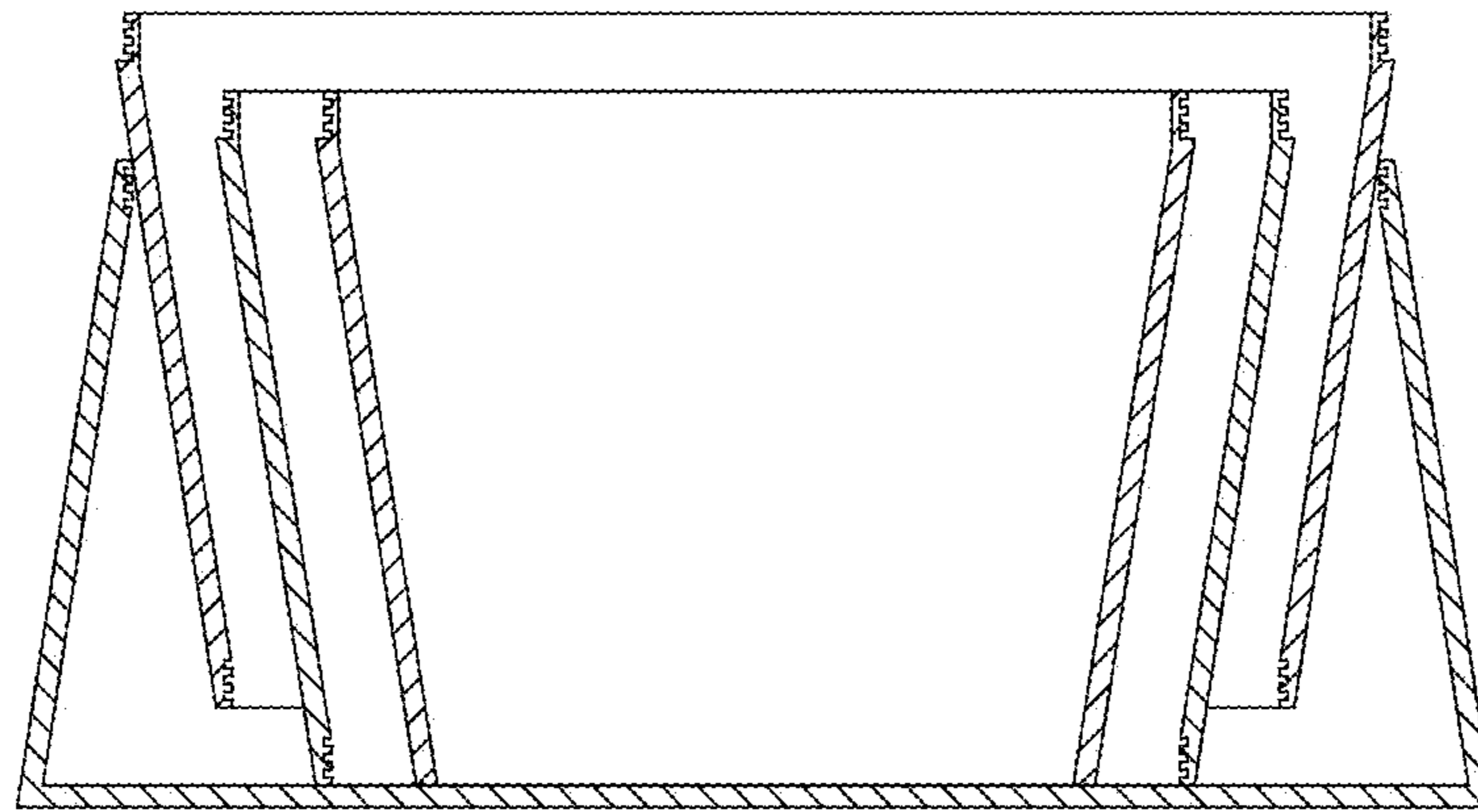
