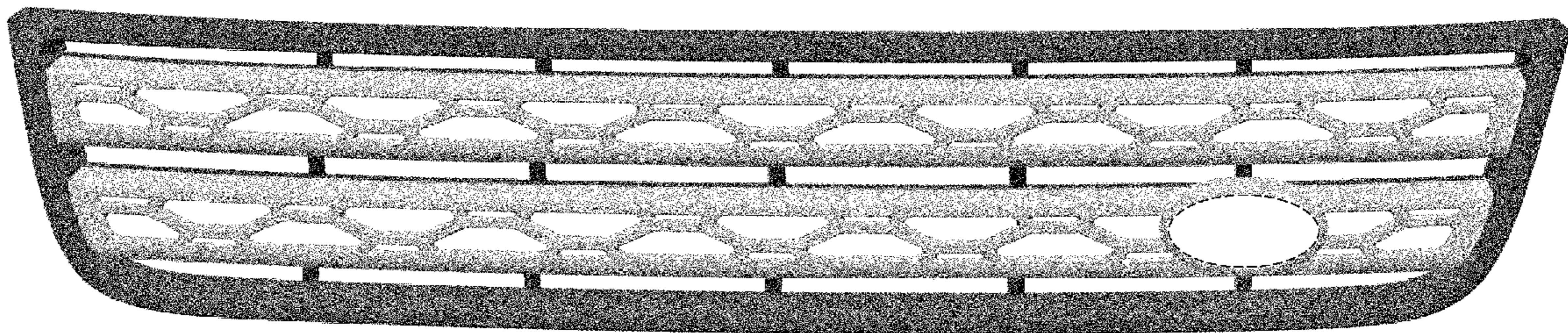
(57) **CLAIM**

The ornamental design for a grille, as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view of a grille for a vehicle according to the present invention.
FIG. 2 is a front right perspective view thereof.
FIG. 3 is a front view thereof.
FIG. 4 is a rear view thereof.
FIG. 5 is a rear left perspective view thereof.
FIG. 6 is a rear right perspective view thereof.
FIG. 7 is a top view thereof.
FIG. 8 is an enlarged left side view thereof.
FIG. 9 is an enlarged right side view thereof; and,
FIG. 10 is a left front perspective view of the grille shown in FIGS. 1-9, with the grille mounted on a vehicle shown in de-emphasized and half-tone portions so as to illustrate environmental structures for the vehicle. These portions form no part of the claimed invention. More particularly, in FIG. 10, the grille of the present invention is shown within the larger broken line, and any elements shown outside of the larger broken line form no part of the claimed invention, but are instead included to show environmental aspects of the claimed invention.
In all of the Figures the broken line showing of the front and rear ovular portion of the grille is included for the purpose of illustrating environment and forms no part of the claimed design.

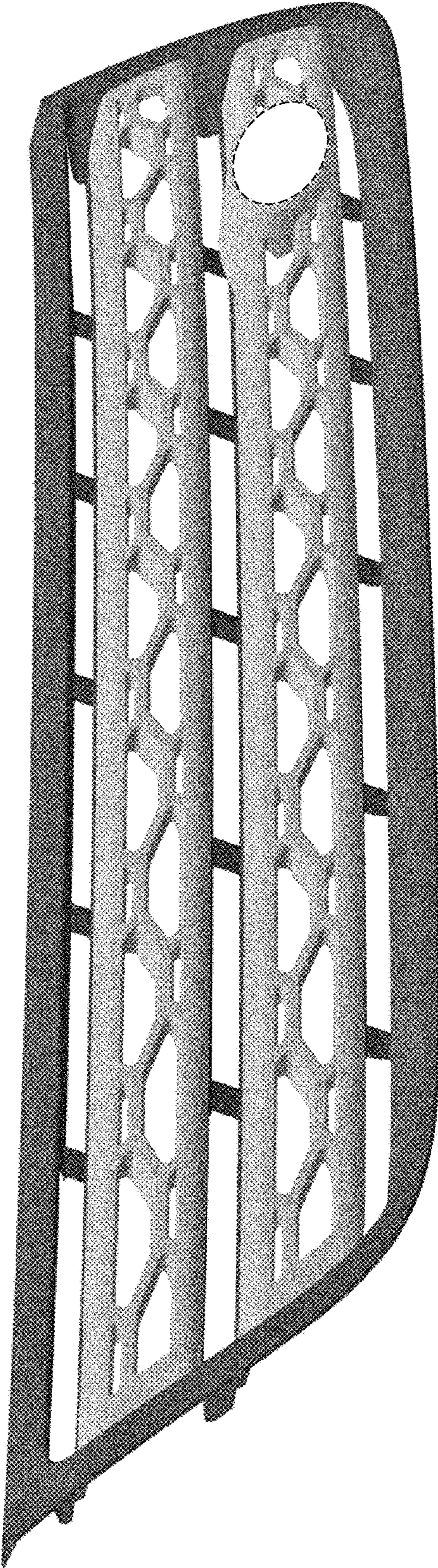

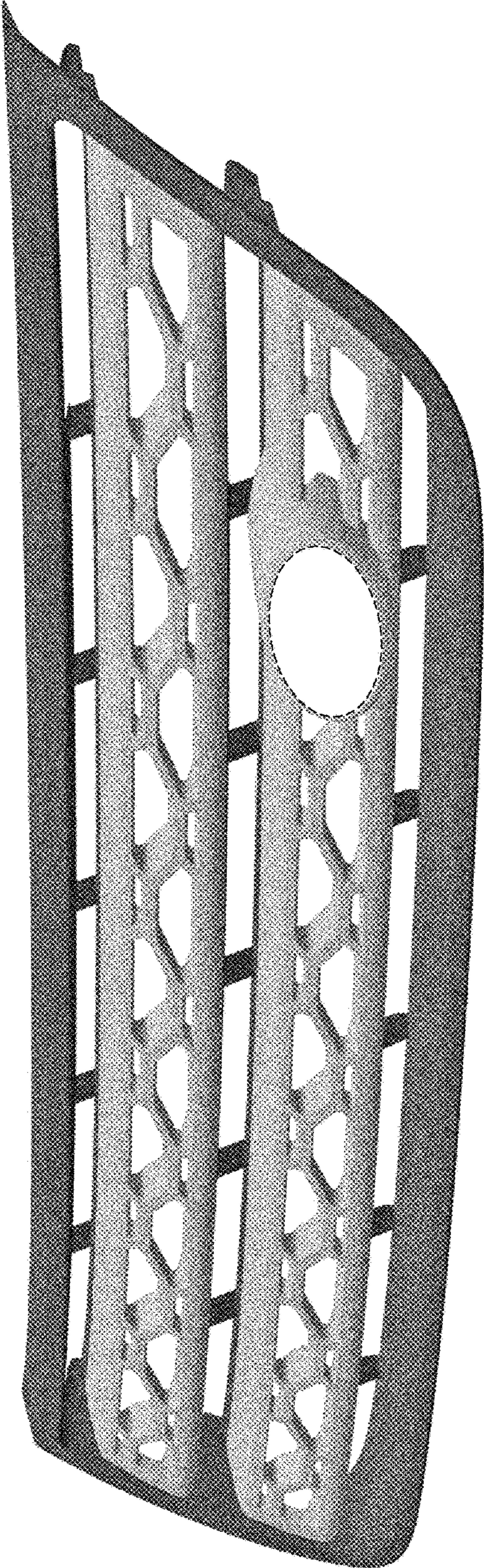

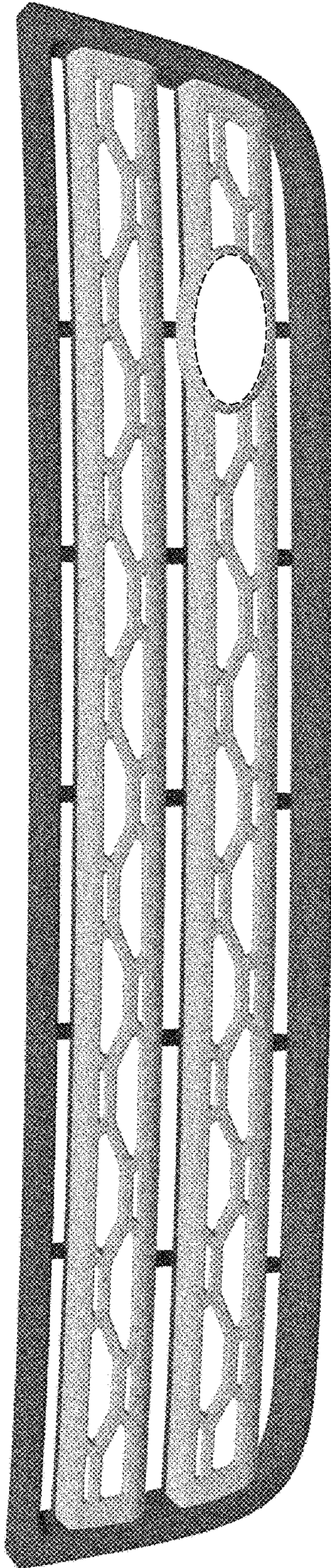

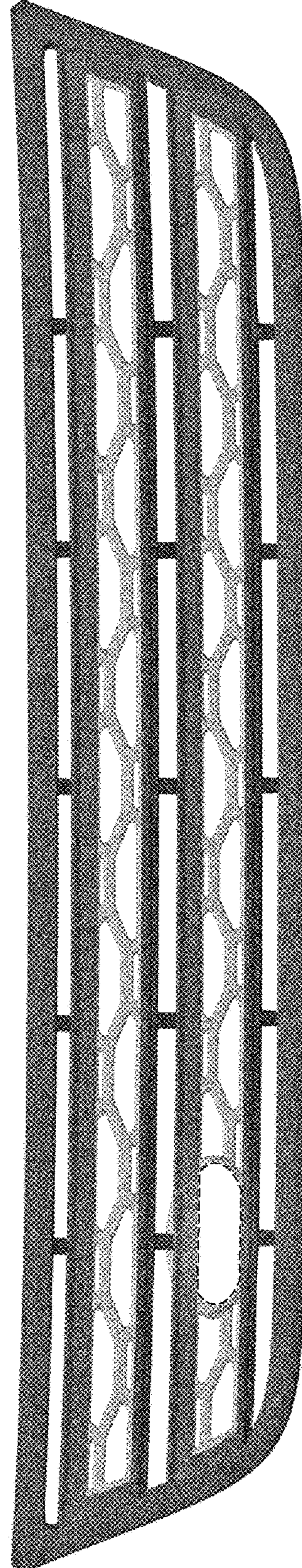

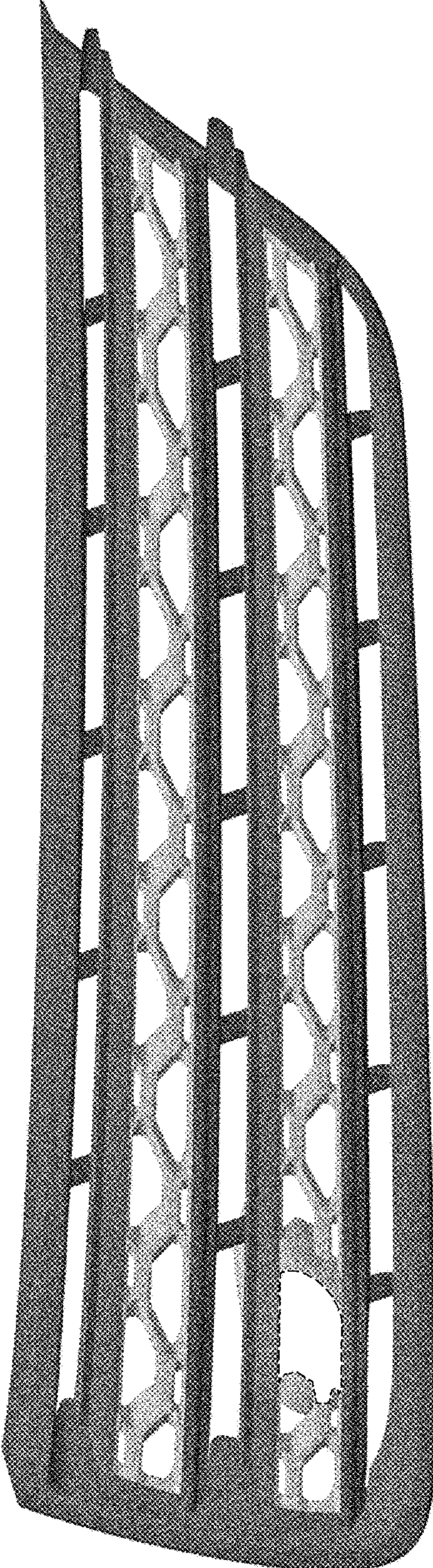

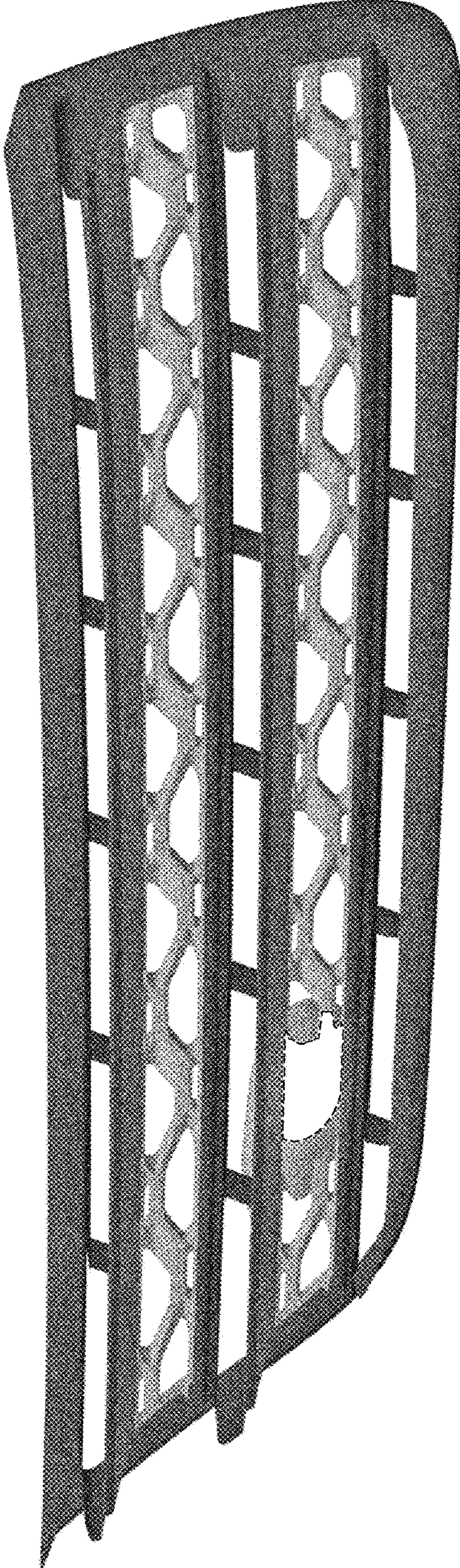

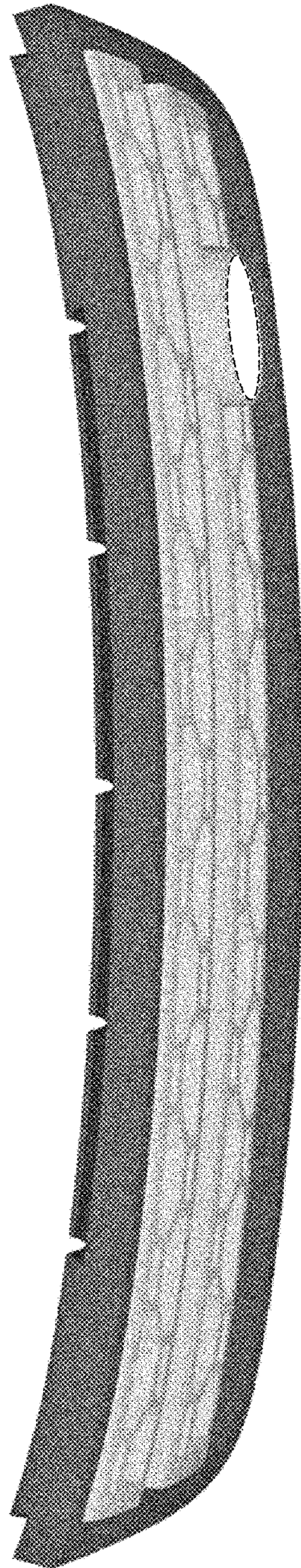

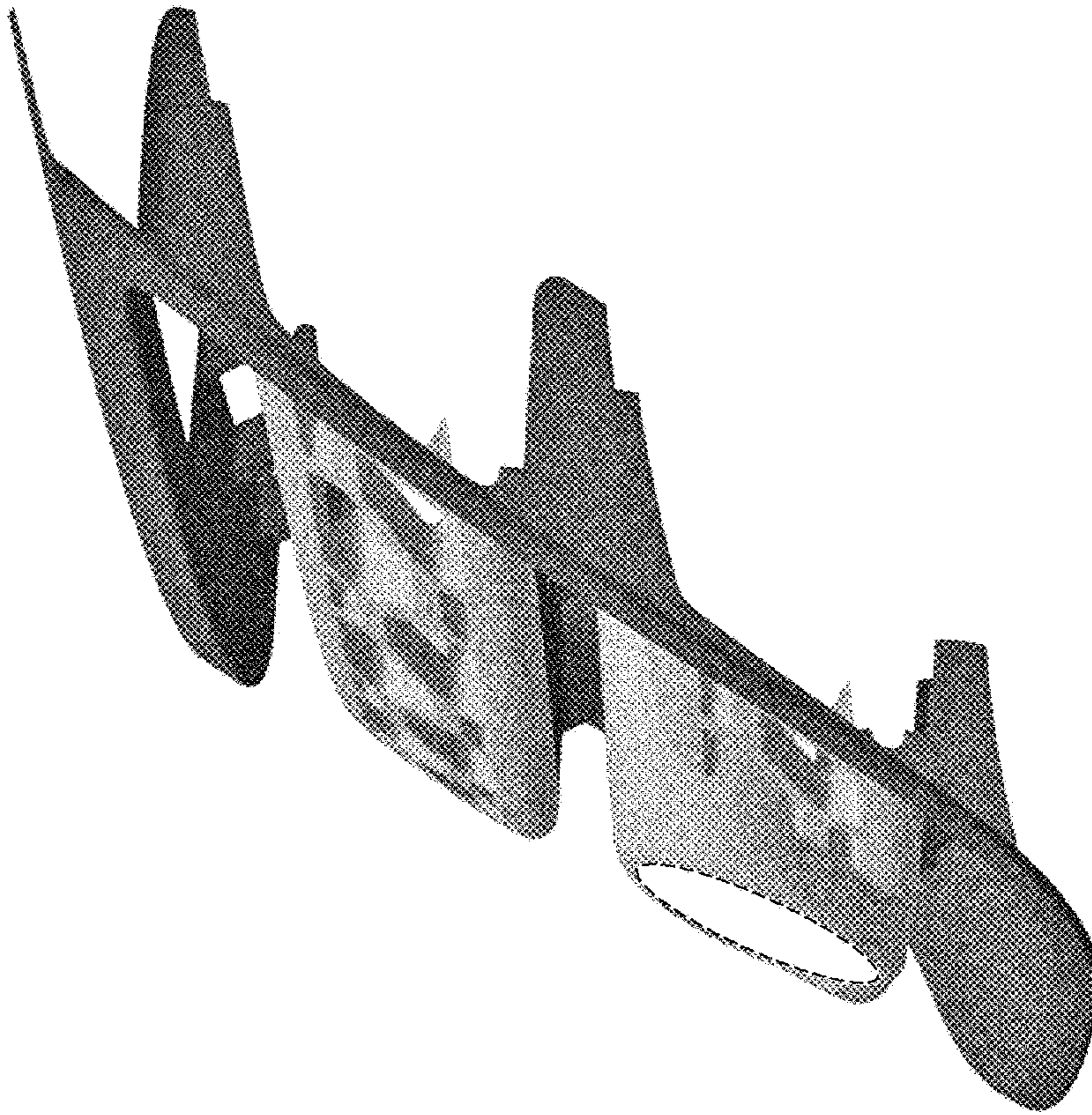

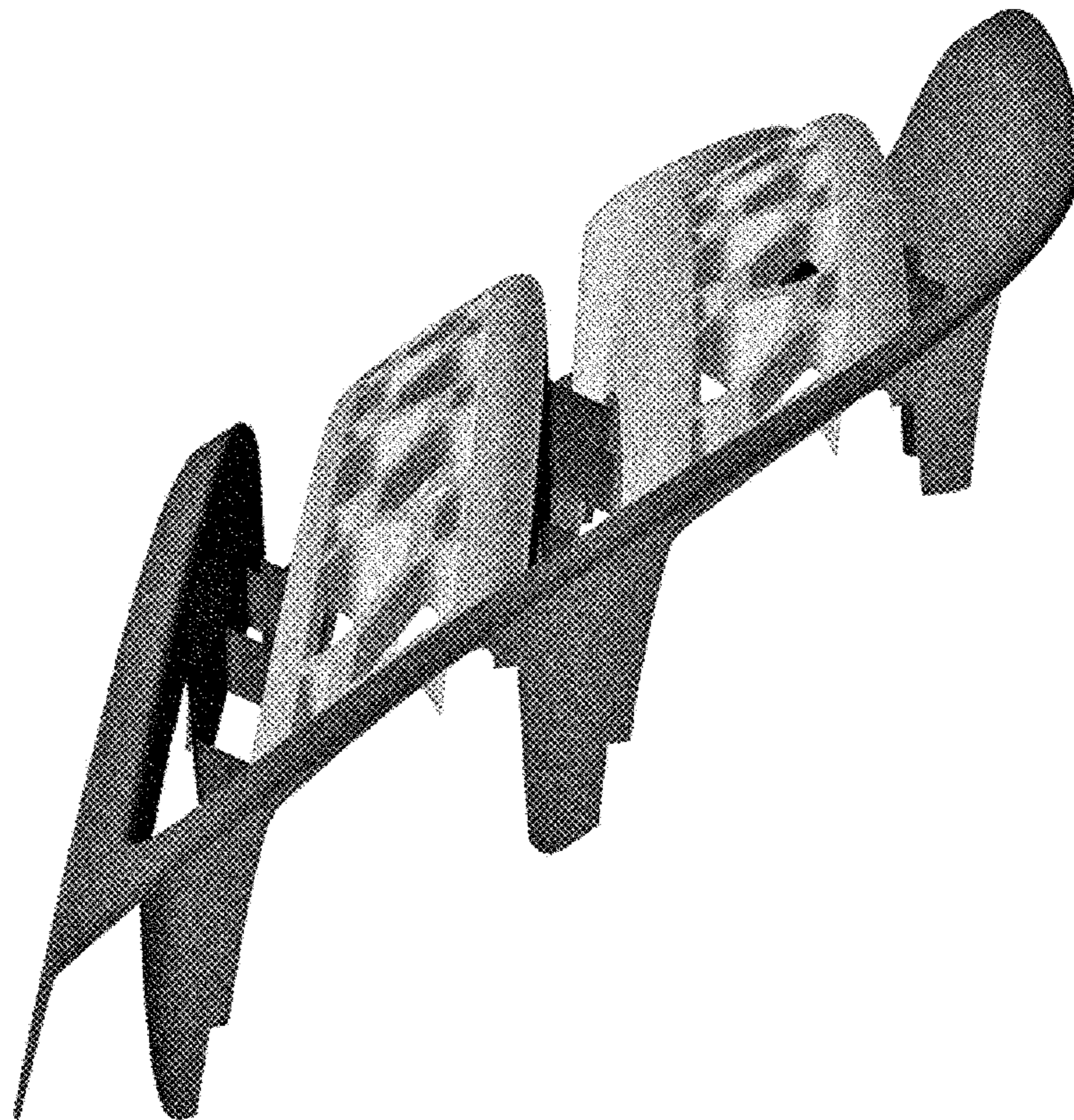

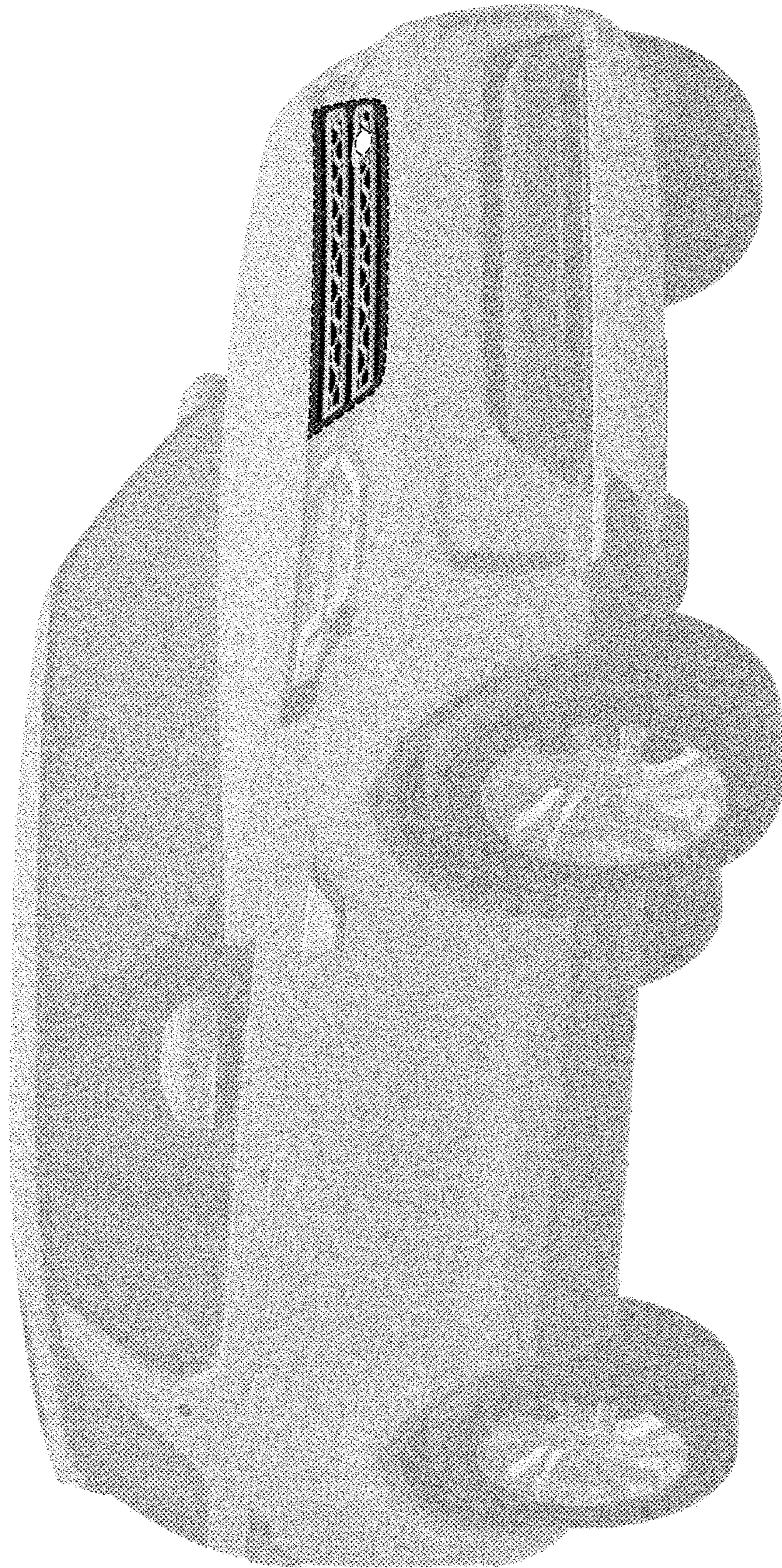
