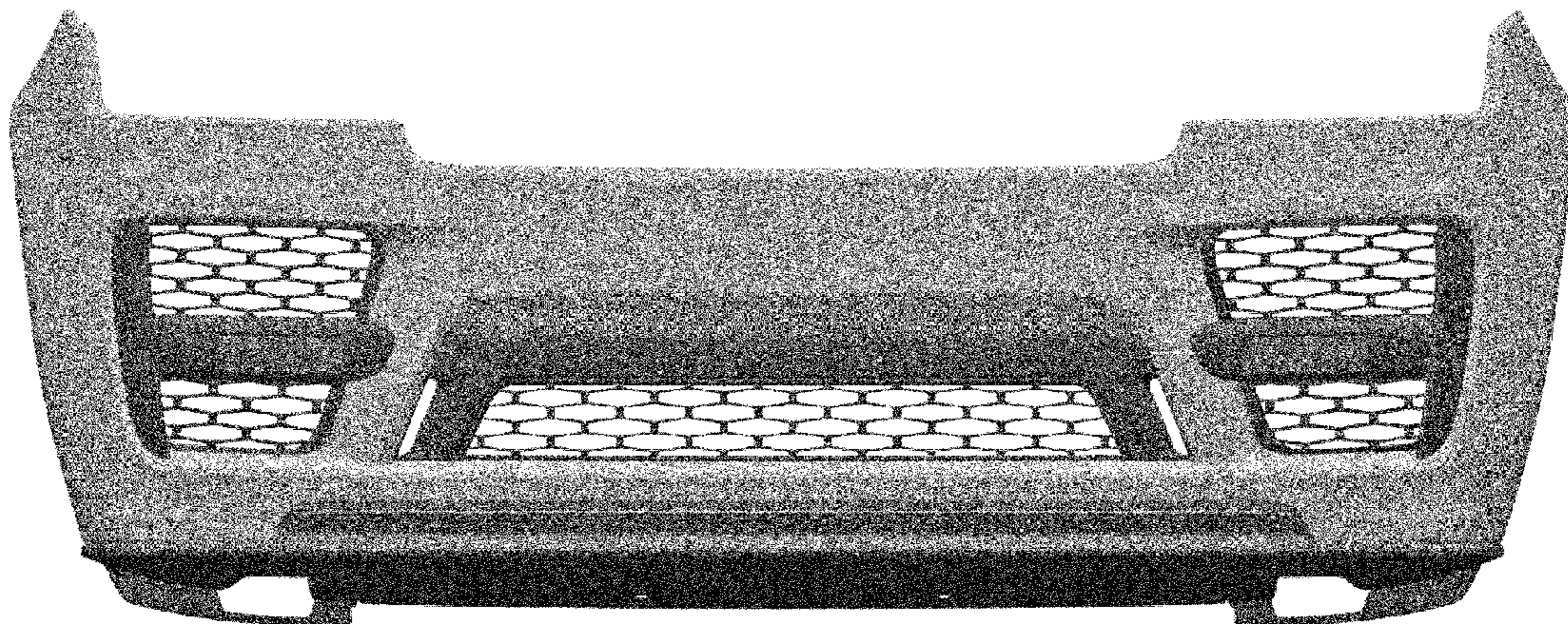

The ornamental design for a front bumper, as shown and described.

DESCRIPTION
FIG. 1 is a right, front perspective view of a front bumper showing my new design;
FIG. 2 is a left, front perspective view thereof;
FIG. 3 is a left, rear perspective view thereof;
FIG. 4 is a right, rear perspective view thereof;
FIG. 5 is a front view thereof;
FIG. 6 is a rear view thereof;
FIG. 7 is a left side view thereof;

FIG. 10 is a bottom view thereof; and,

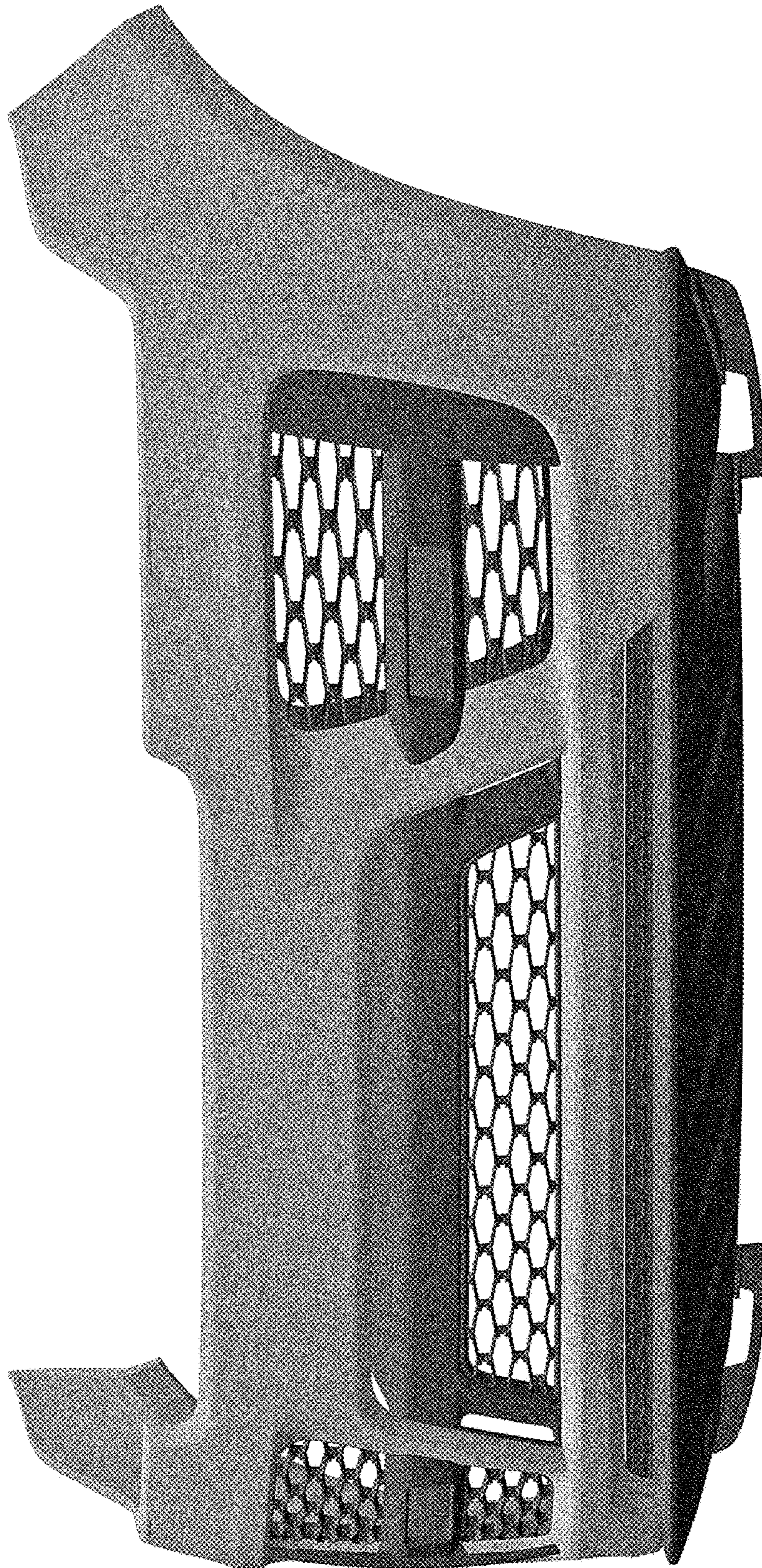

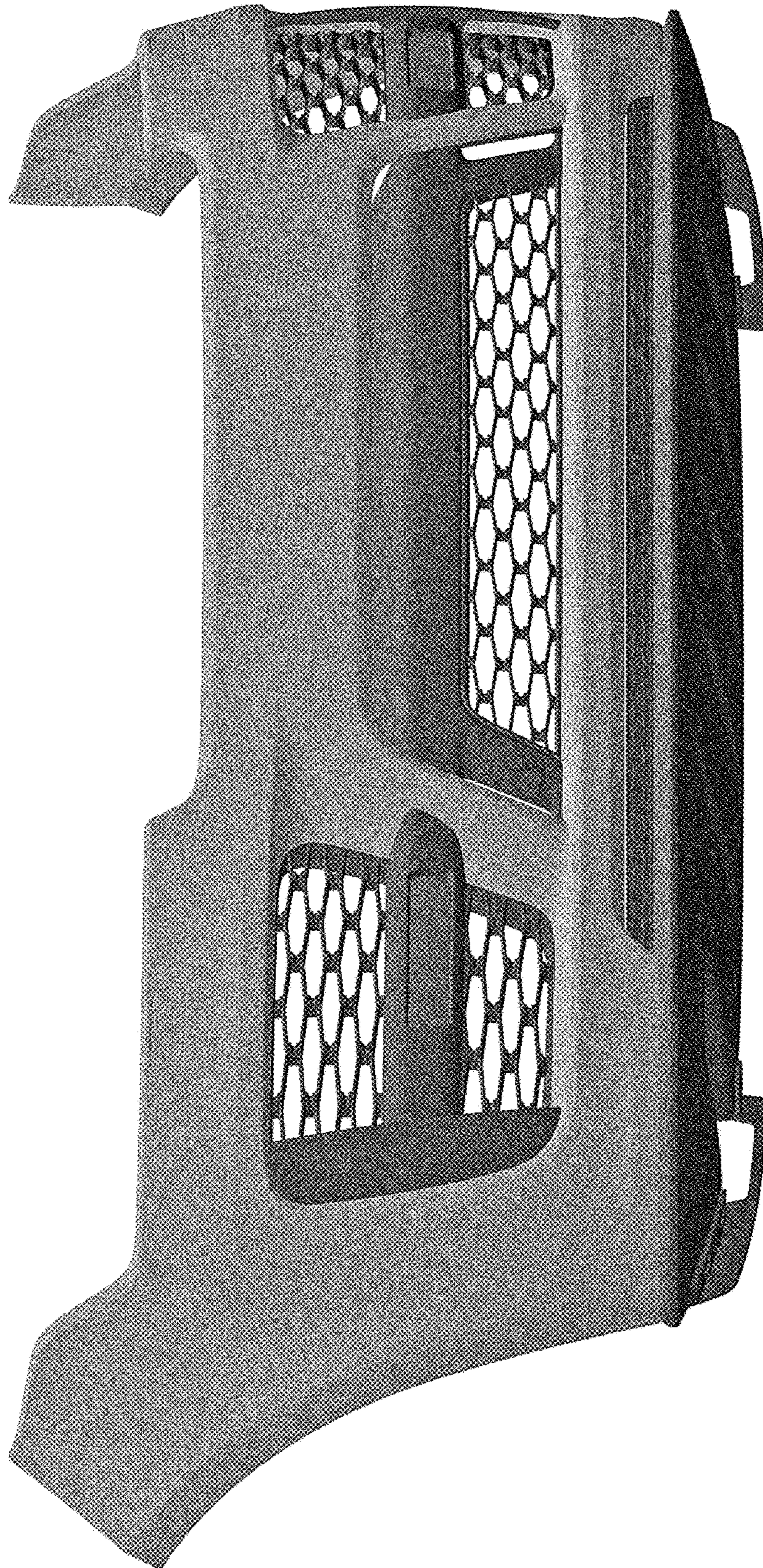

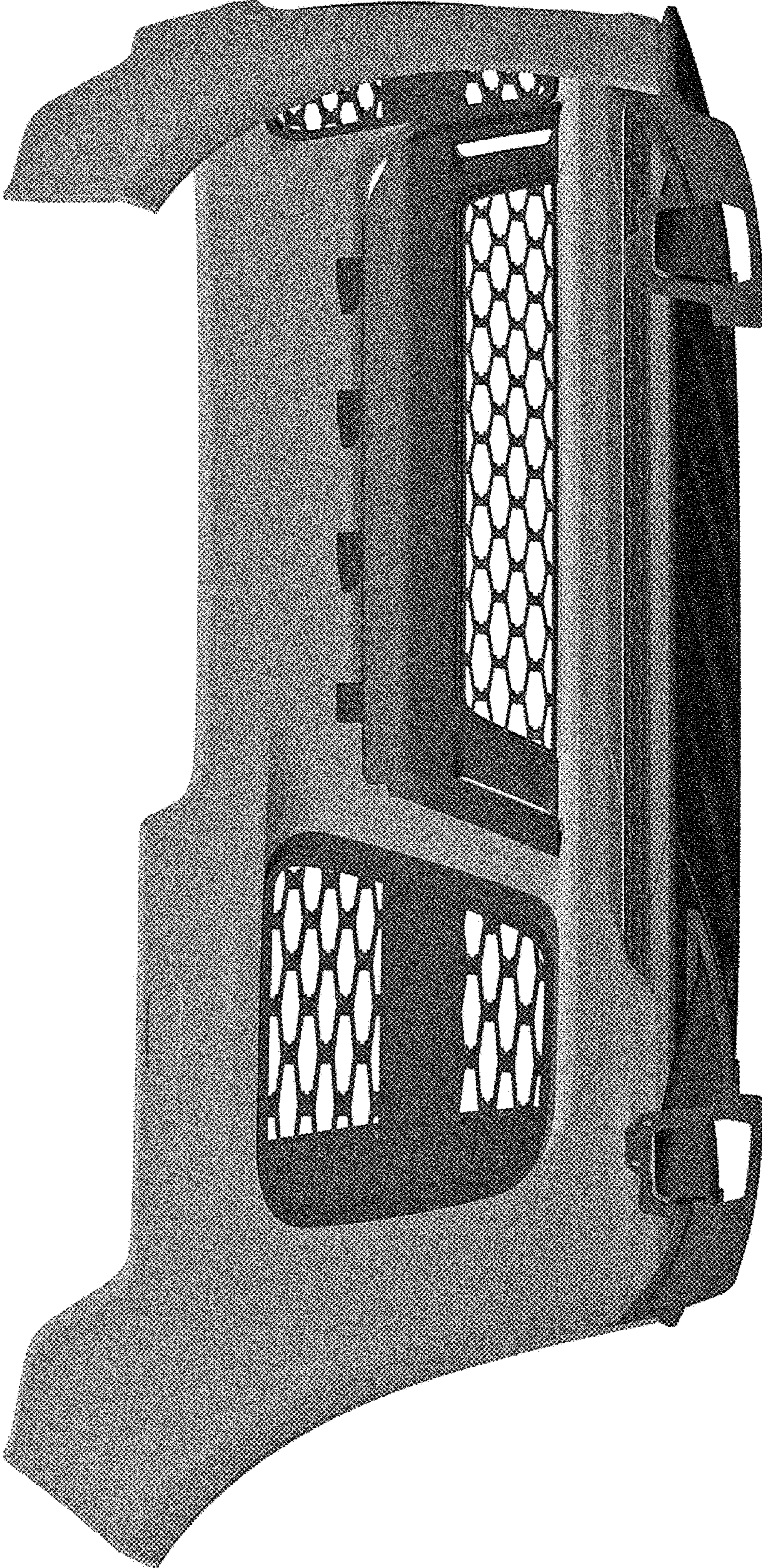

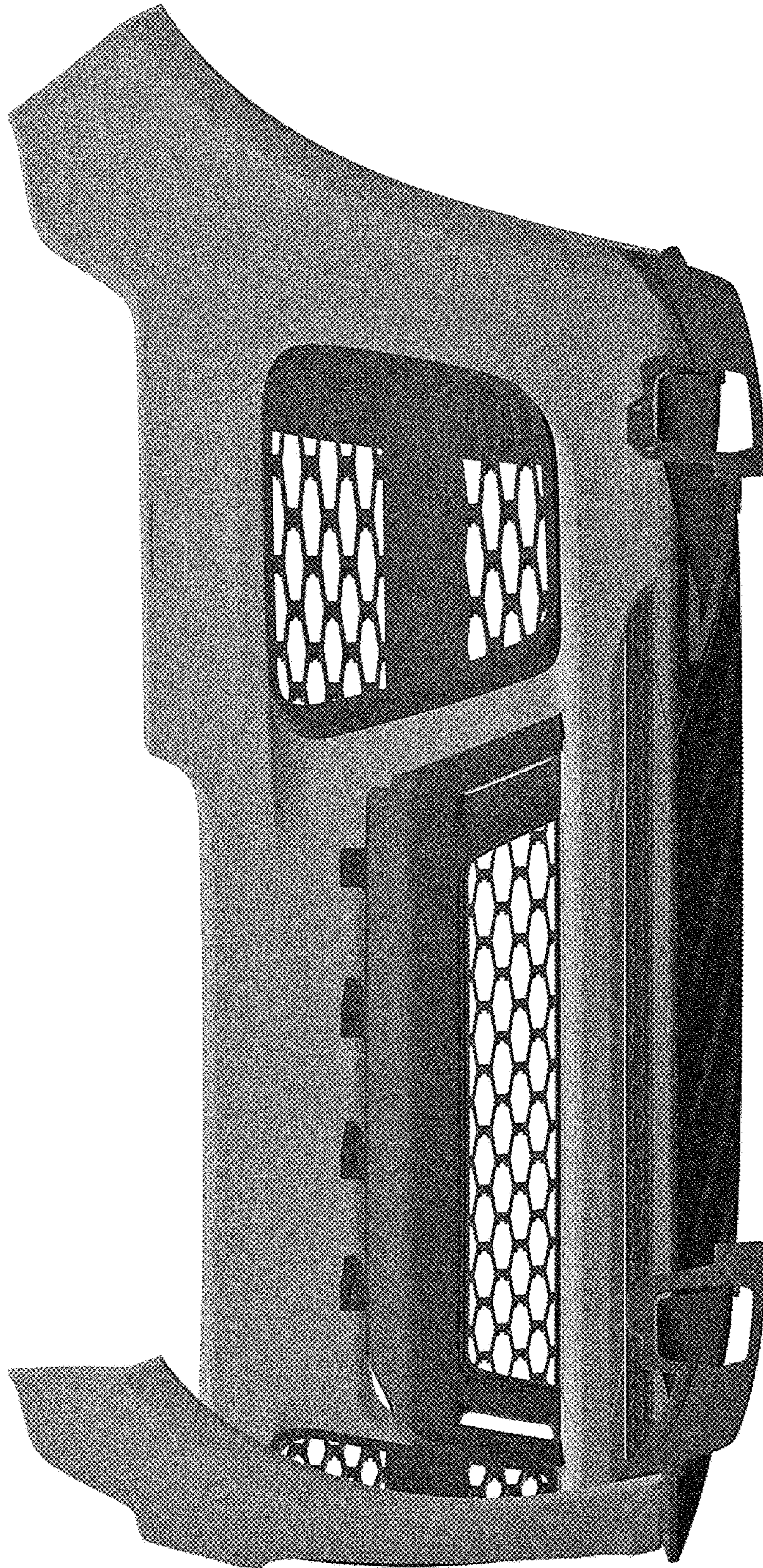

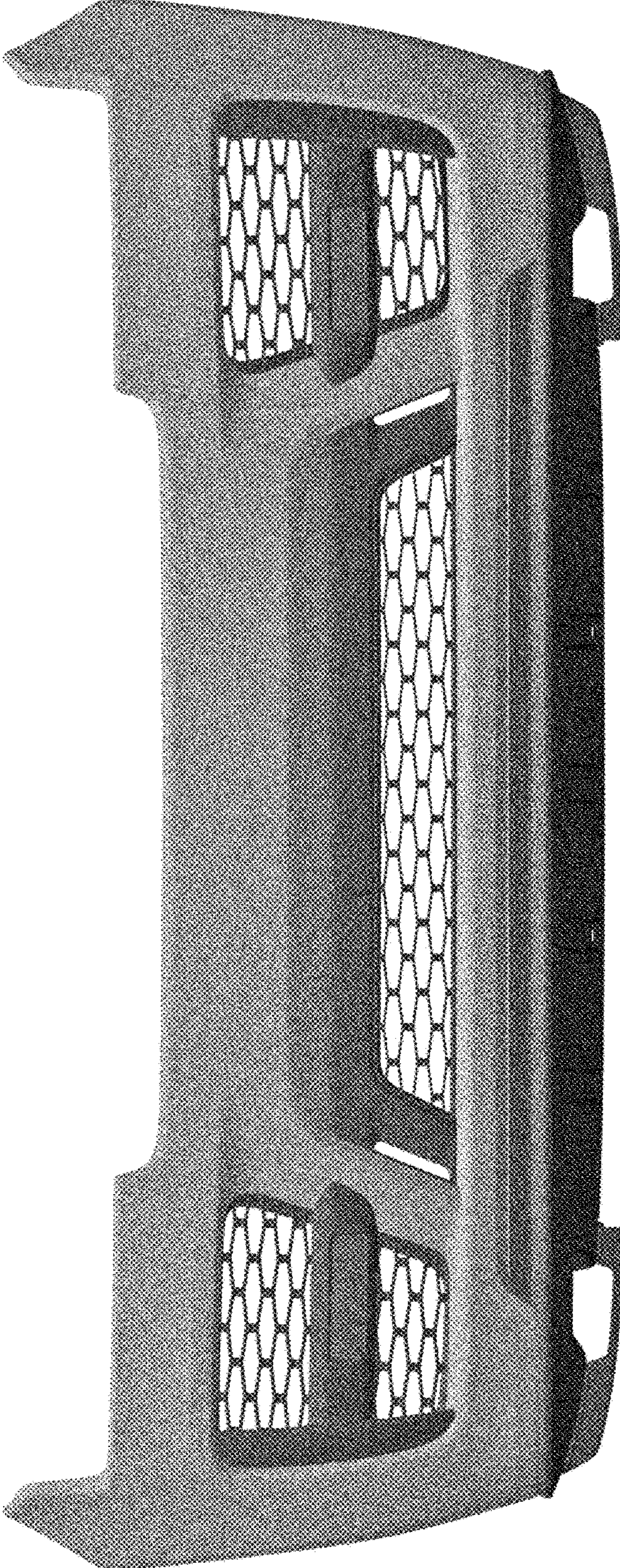

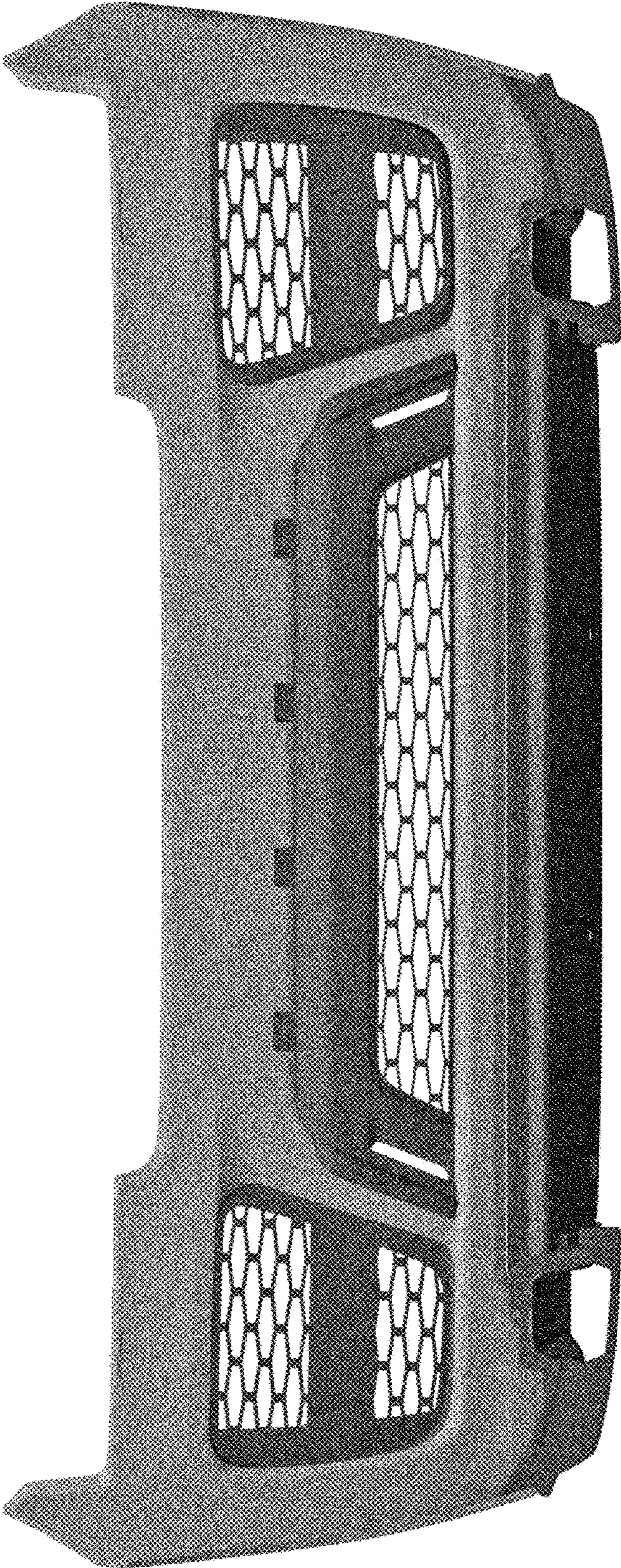

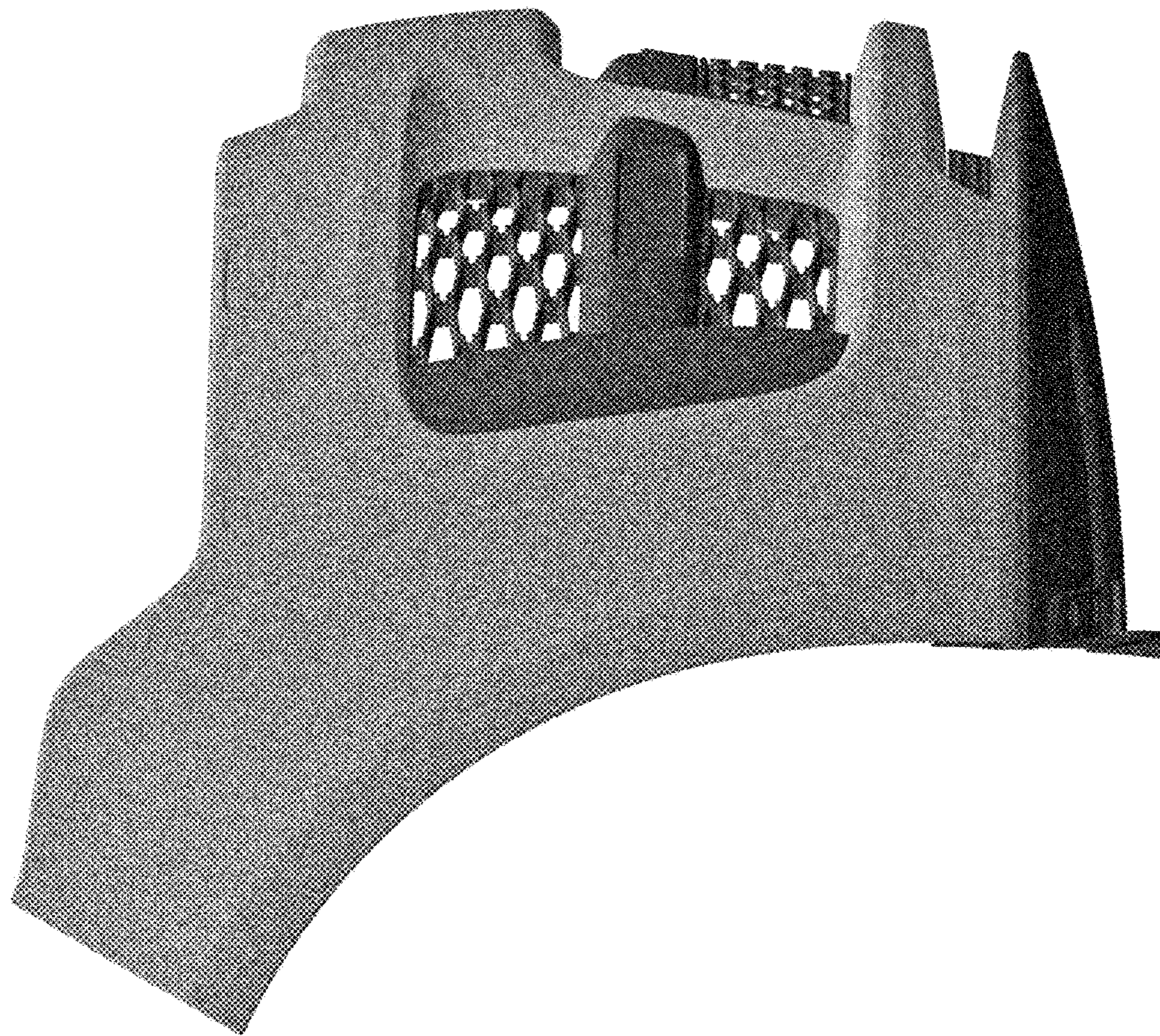

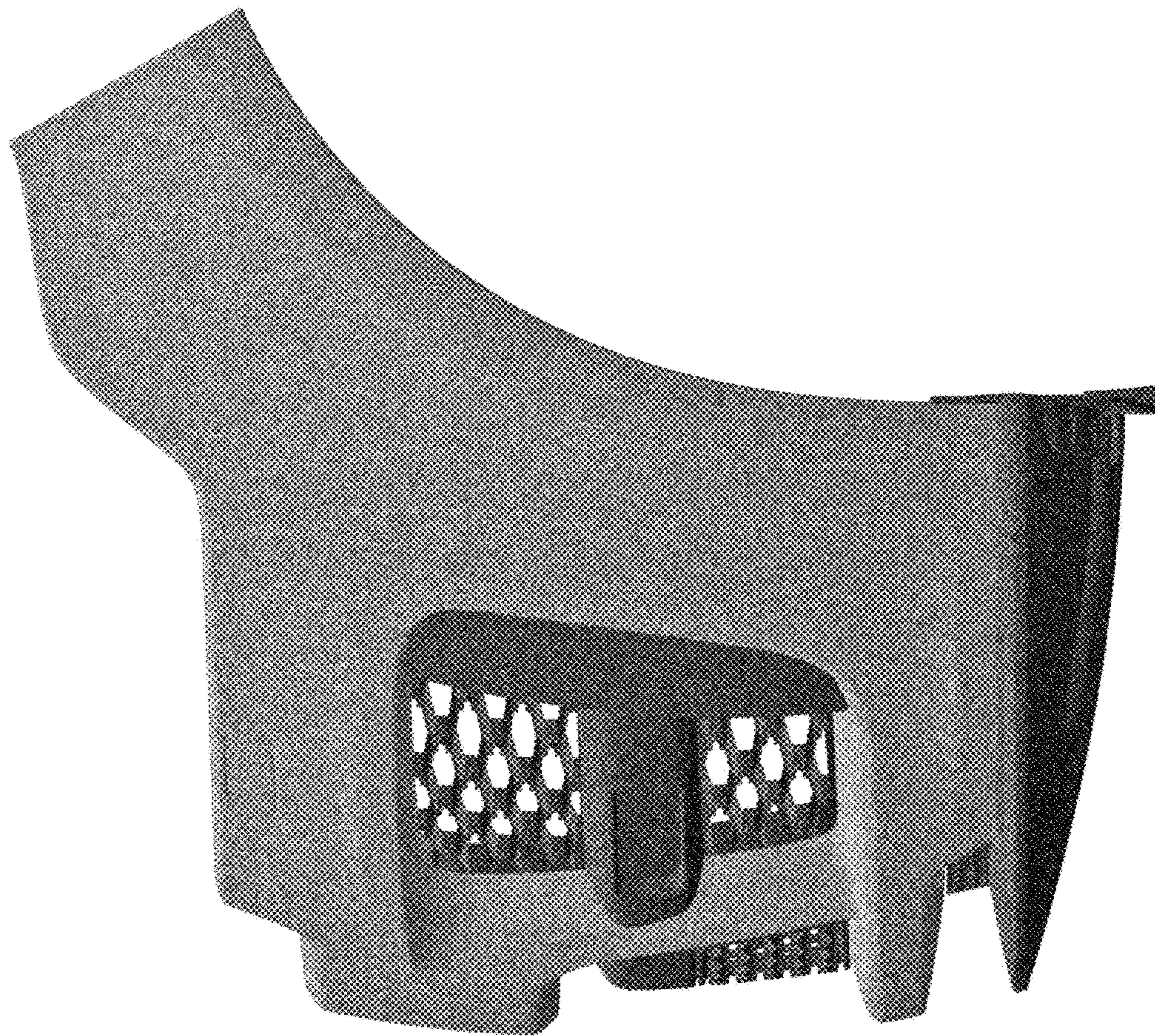

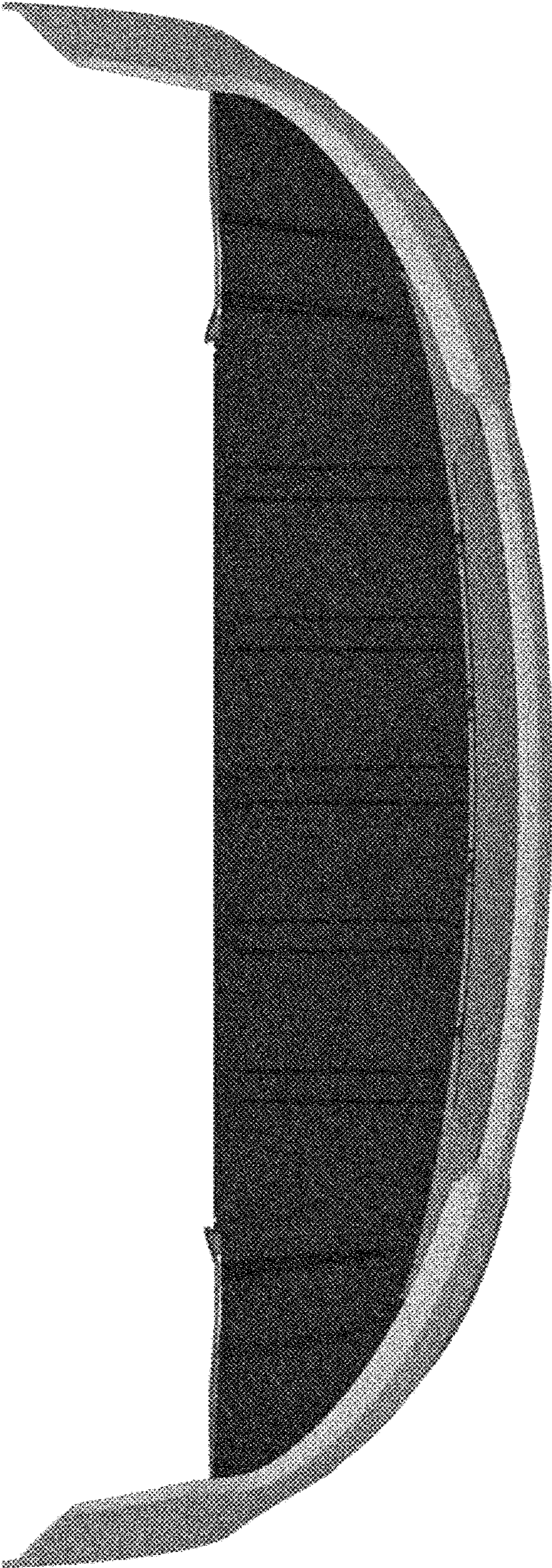

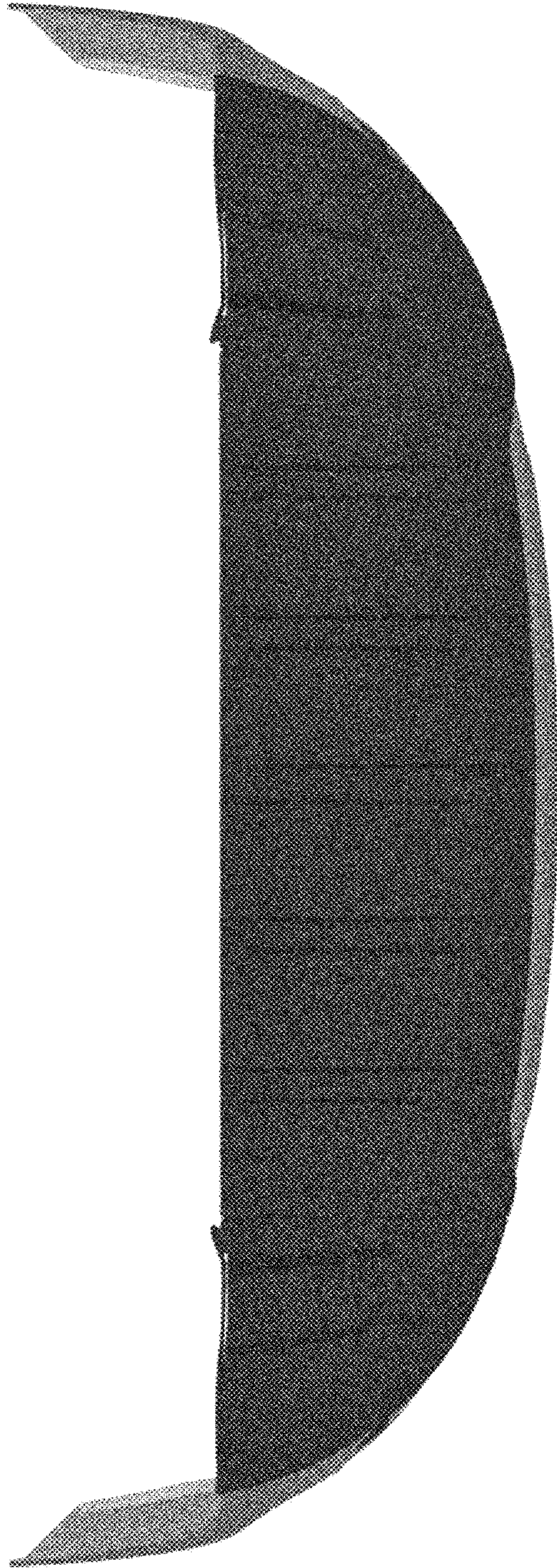

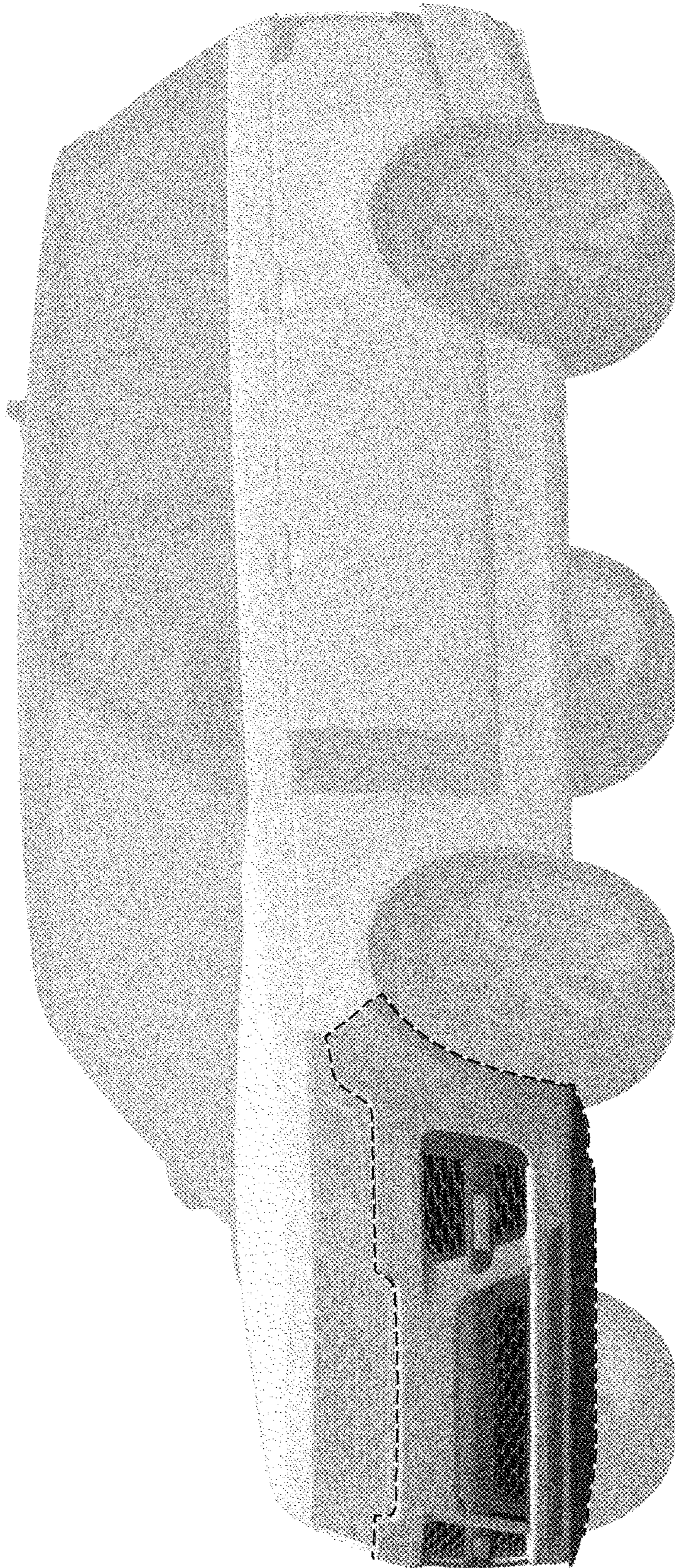
