(57) **CLAIM**

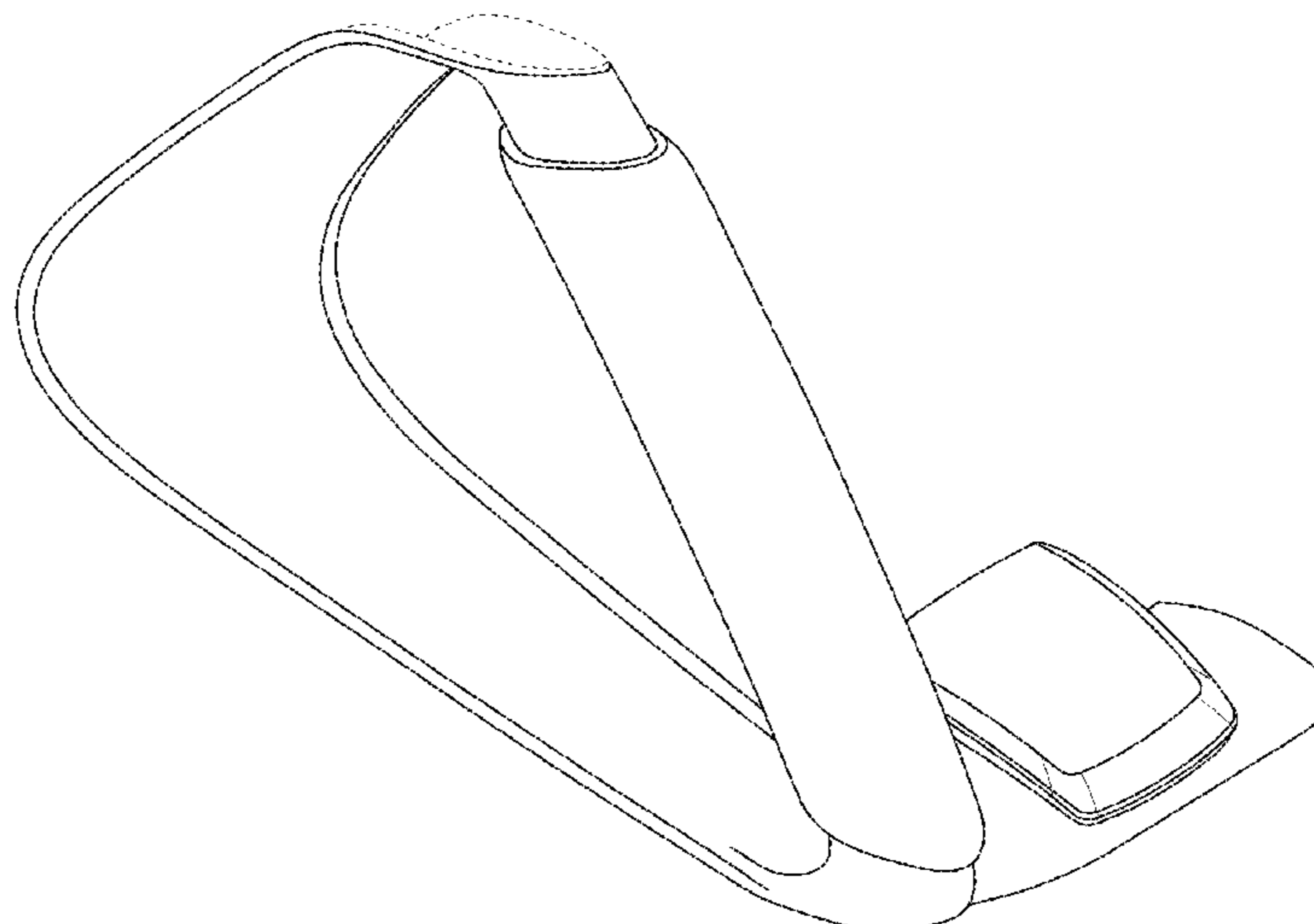
The ornamental design for an inner handle for a door of a car, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an inner handle for a door of a car showing the present design;  
 FIG. 2 is a front view thereof;  
 FIG. 3 is a rear view thereof;  
 FIG. 4 is a first lateral view thereof;  
 FIG. 5 is a second lateral view thereof;  
 FIG. 6 is a top plan view thereof;  
 FIG. 7 is a bottom view thereof;  
 FIG. 8 is a perspective view thereof in a position of use in a car door;  
 FIG. 9 is an enlarged perspective view thereof in the position of use in a car door taken from area 9 of FIG. 8; and,  
 FIG. 10 is a front view thereof used in a car door as shown in FIG. 9.

Broken lines showing portions of the inner handle, portions of the car and the boundaries of the detail areas depict environment that forms no part of the claimed design. Dash dot broken lines illustrate the boundaries of the claim. The dash dot broken lines and the area within do not form part of the claimed design.

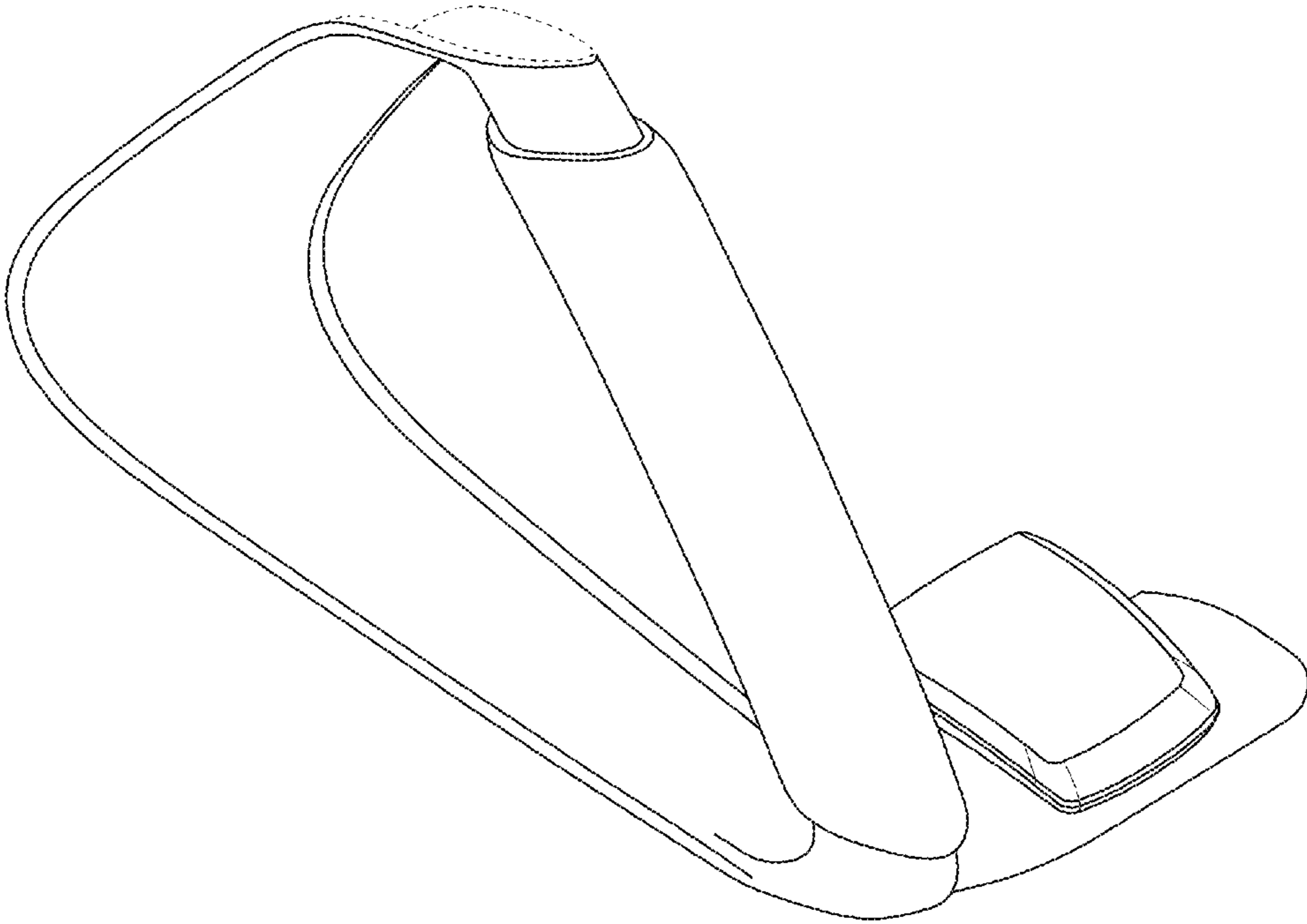

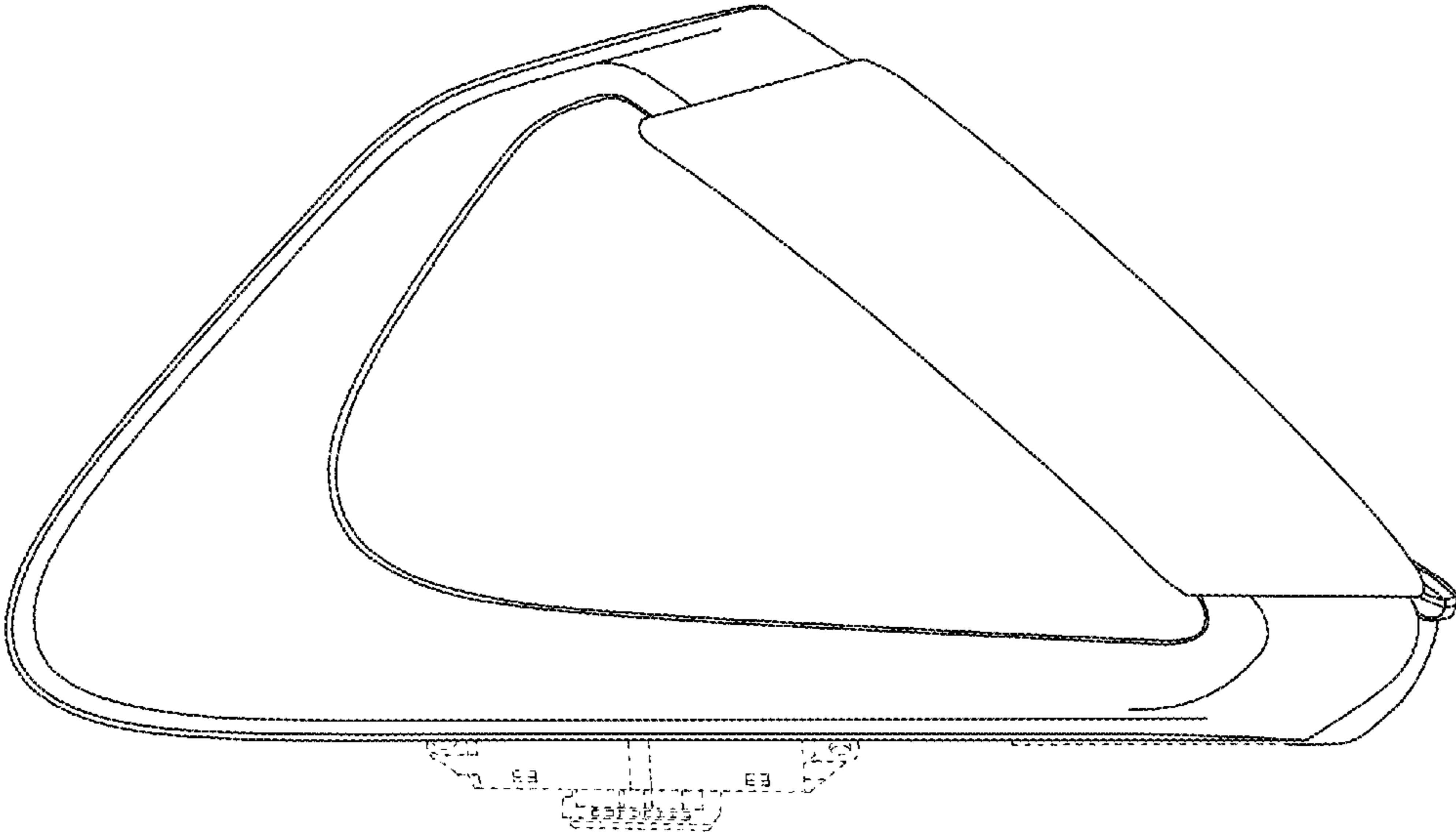

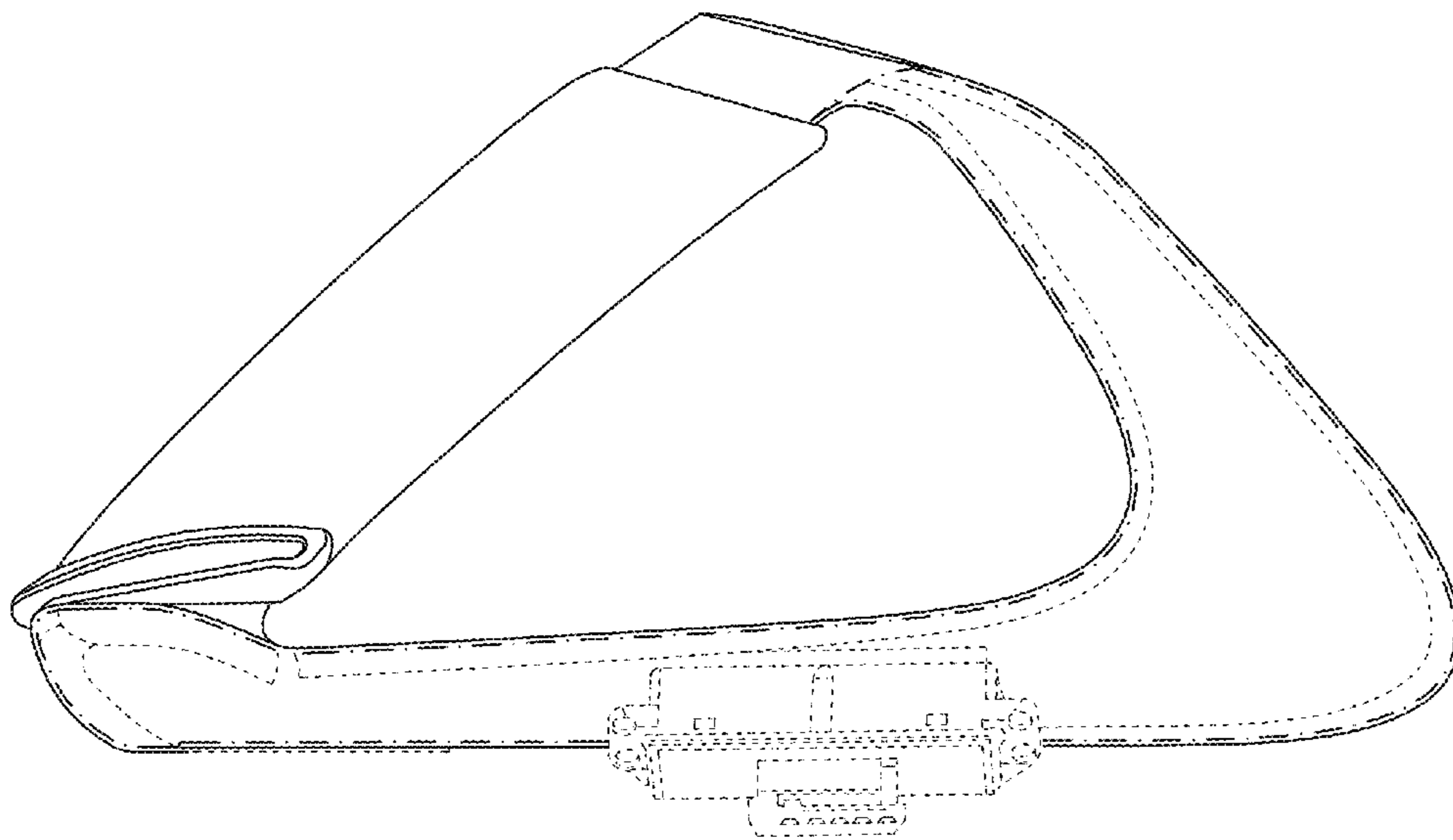

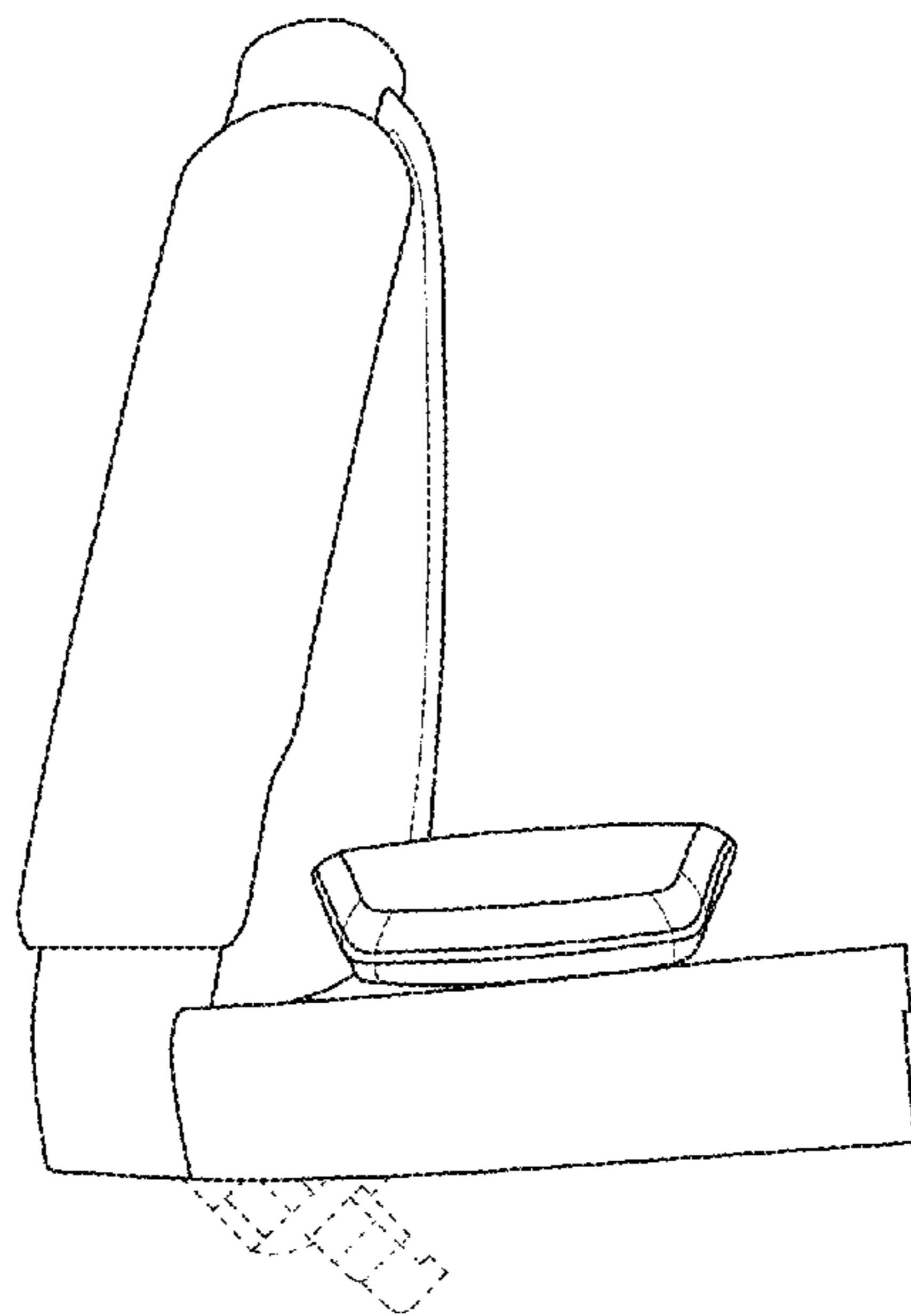

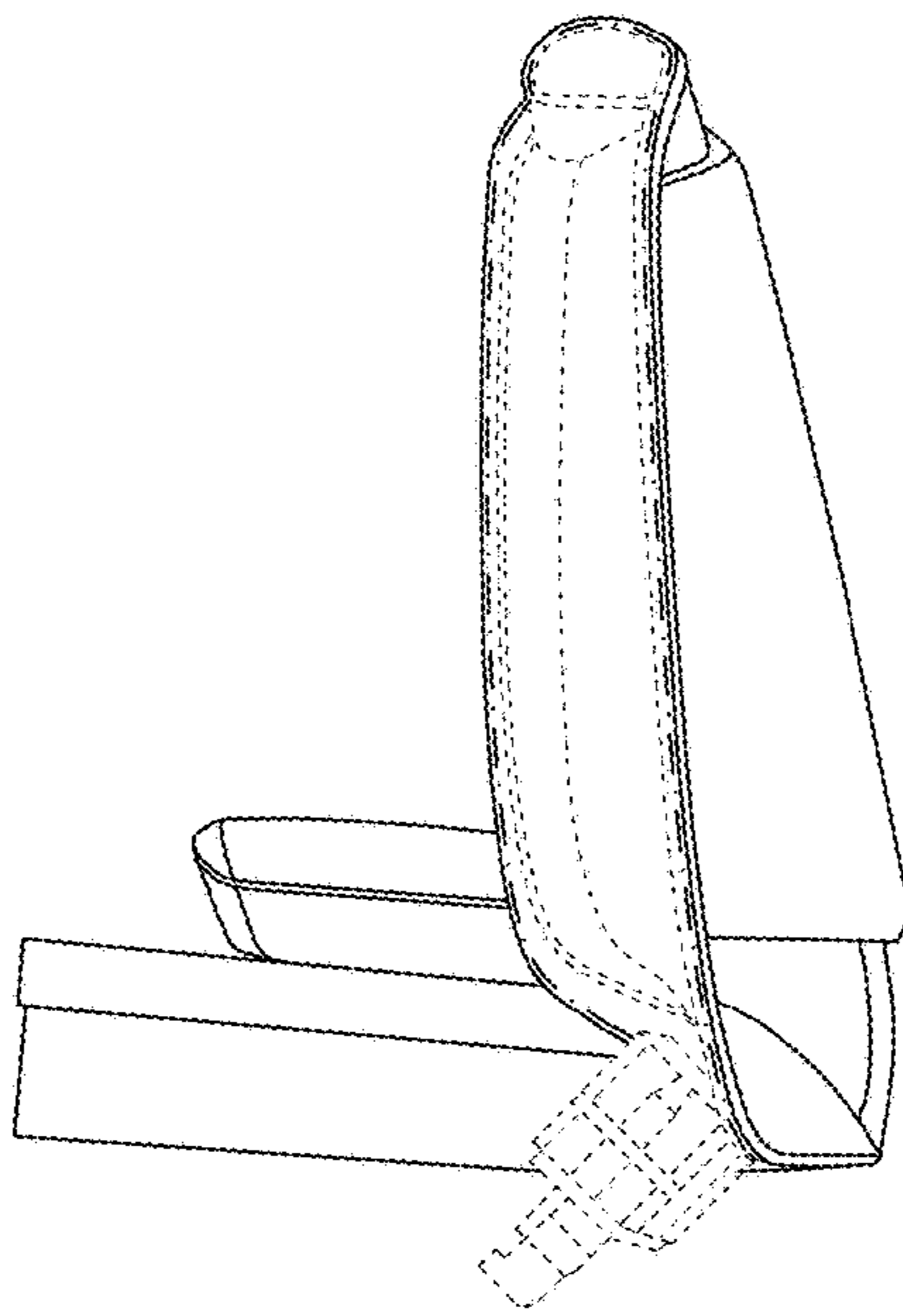

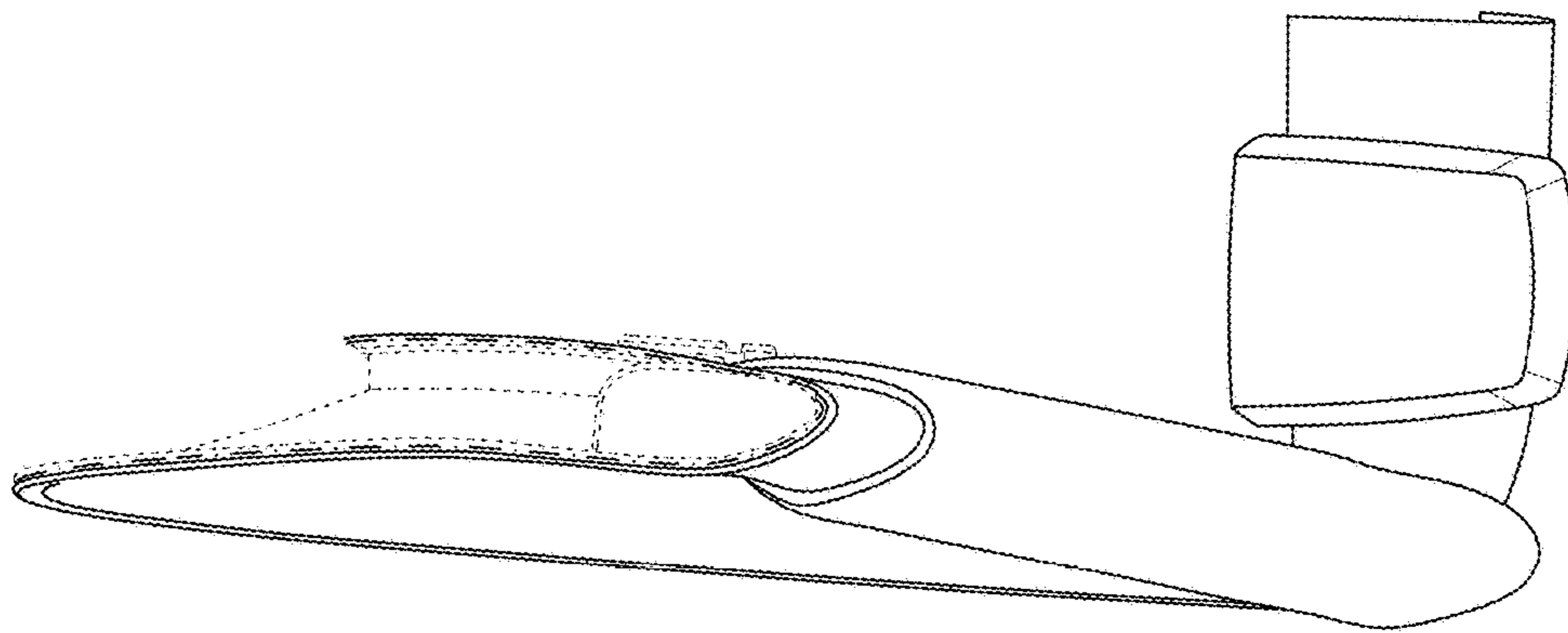

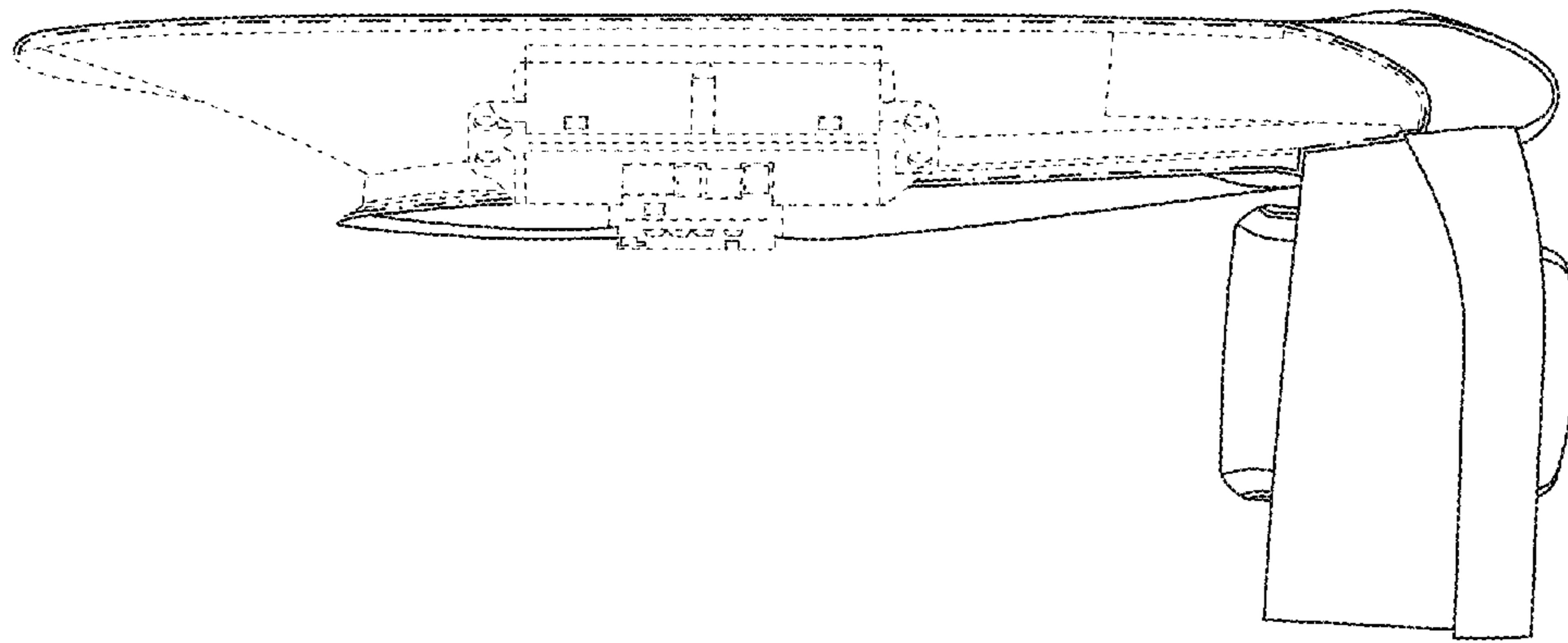
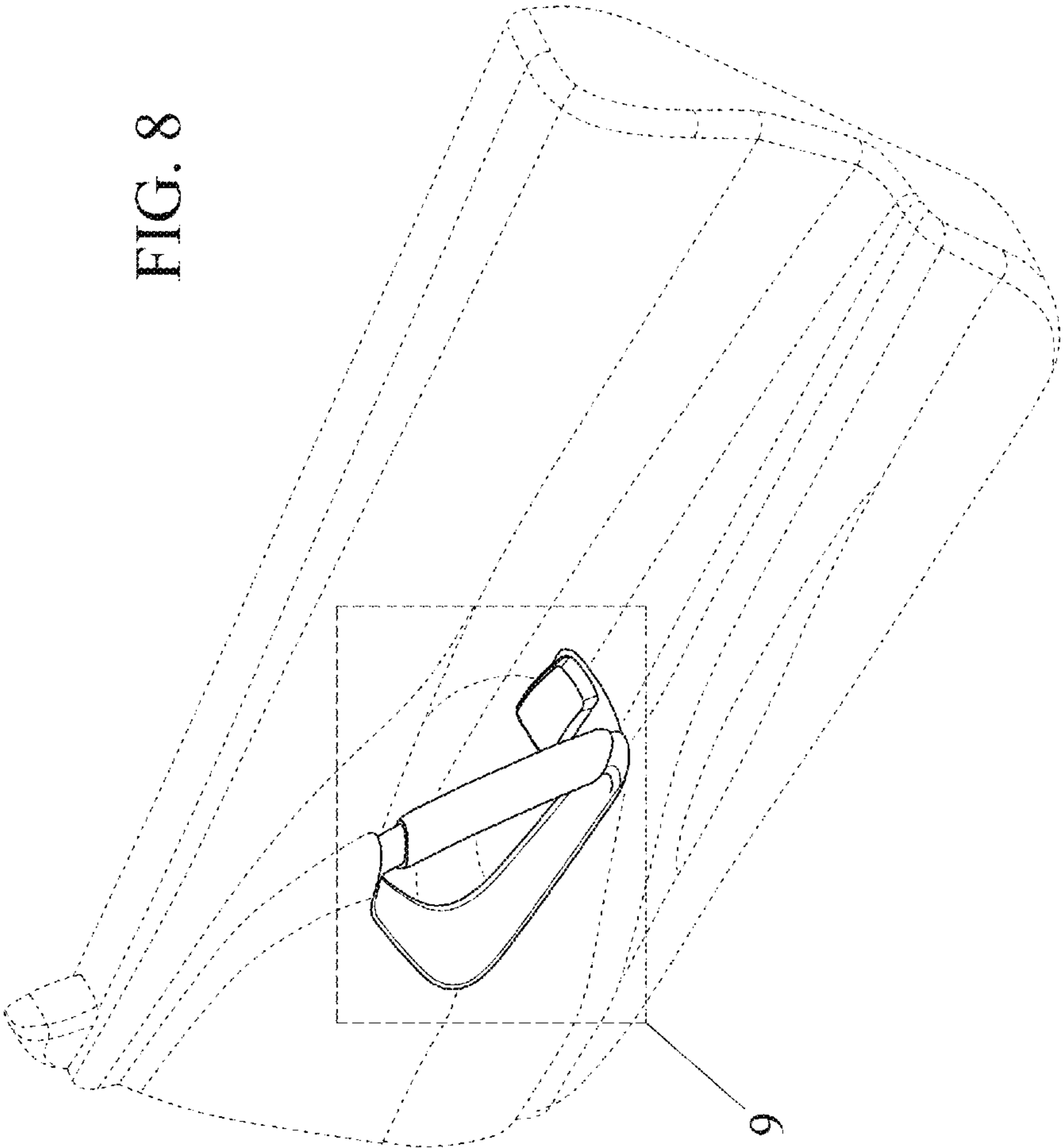

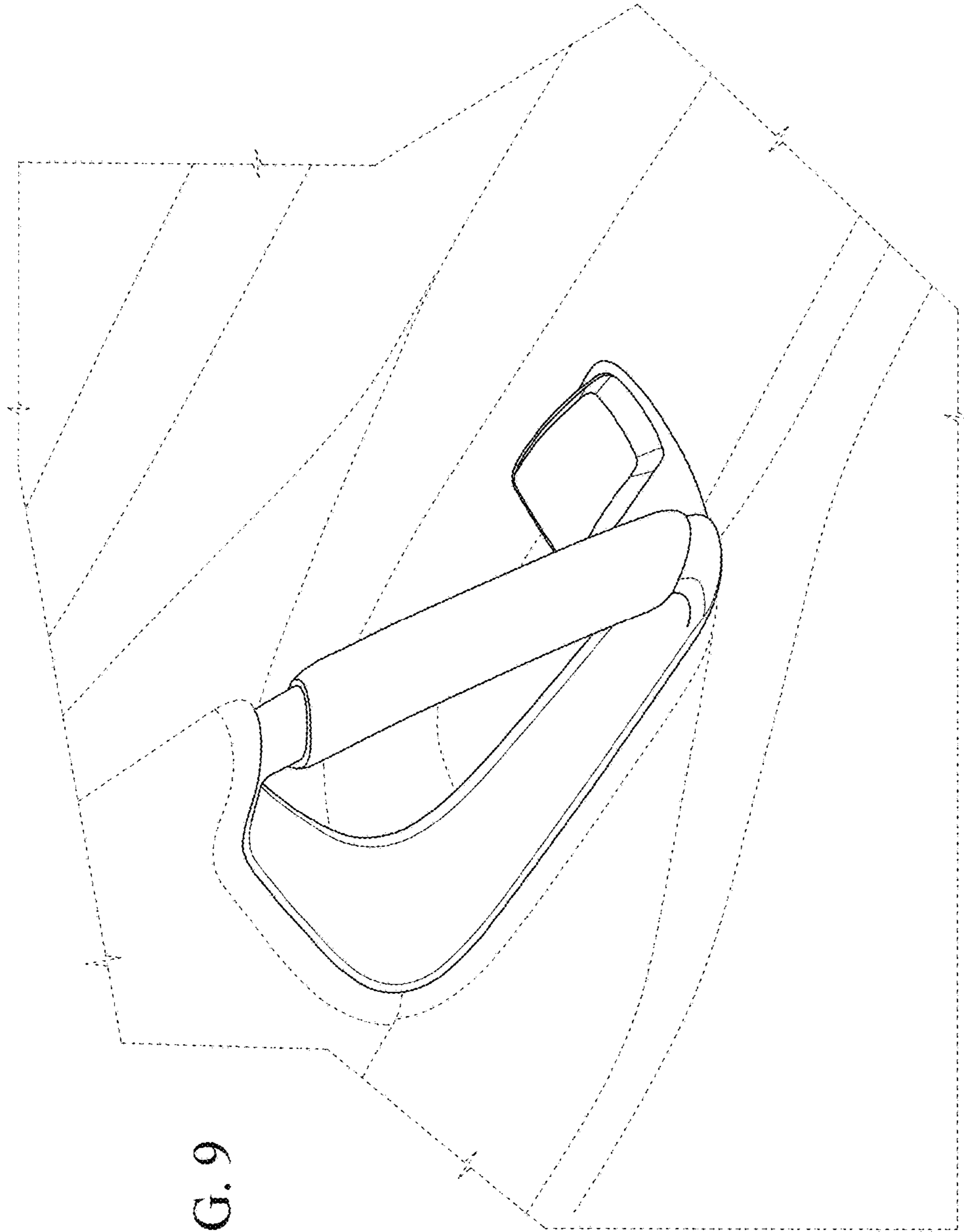

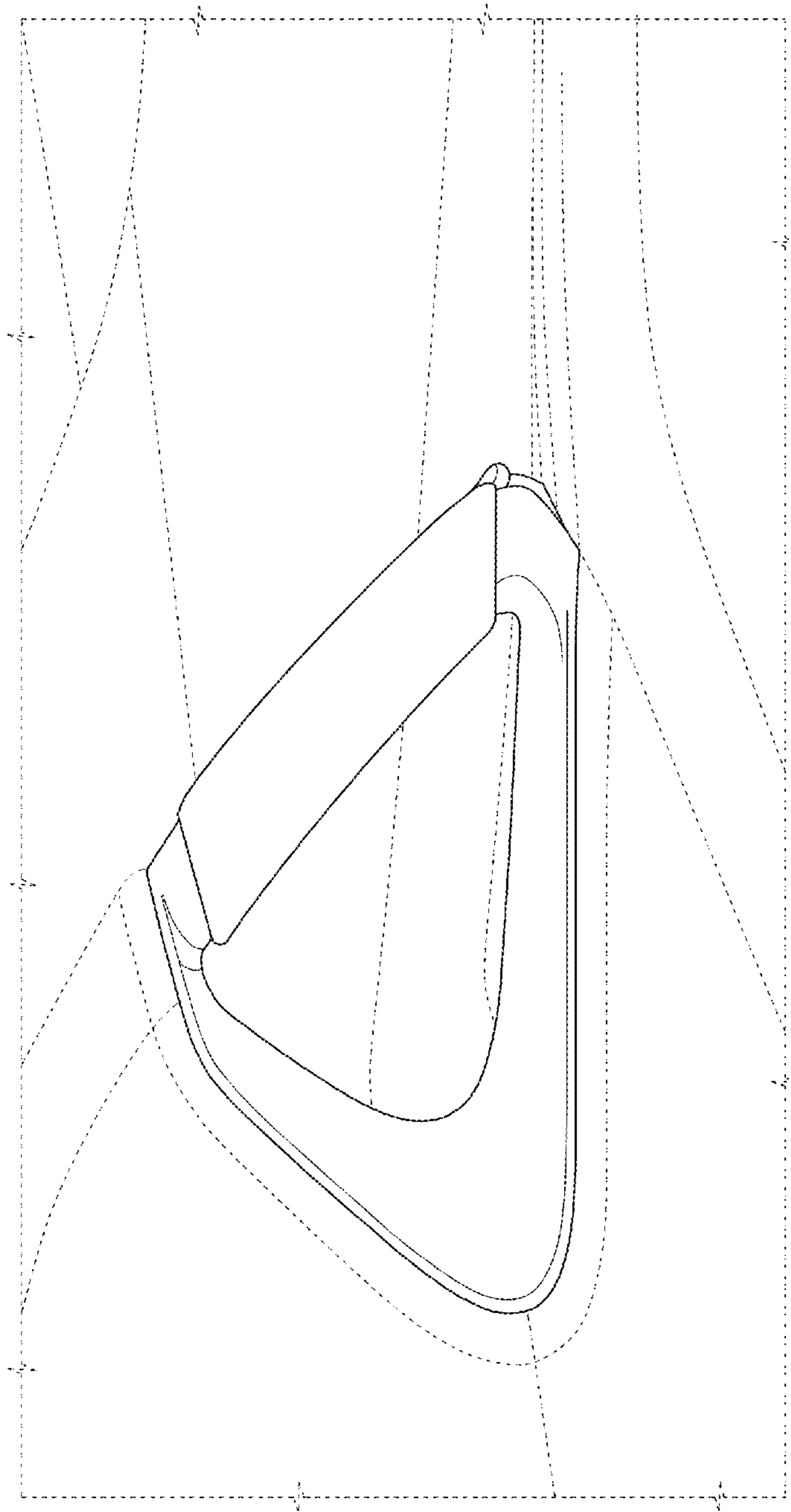
