DESCRIPTION

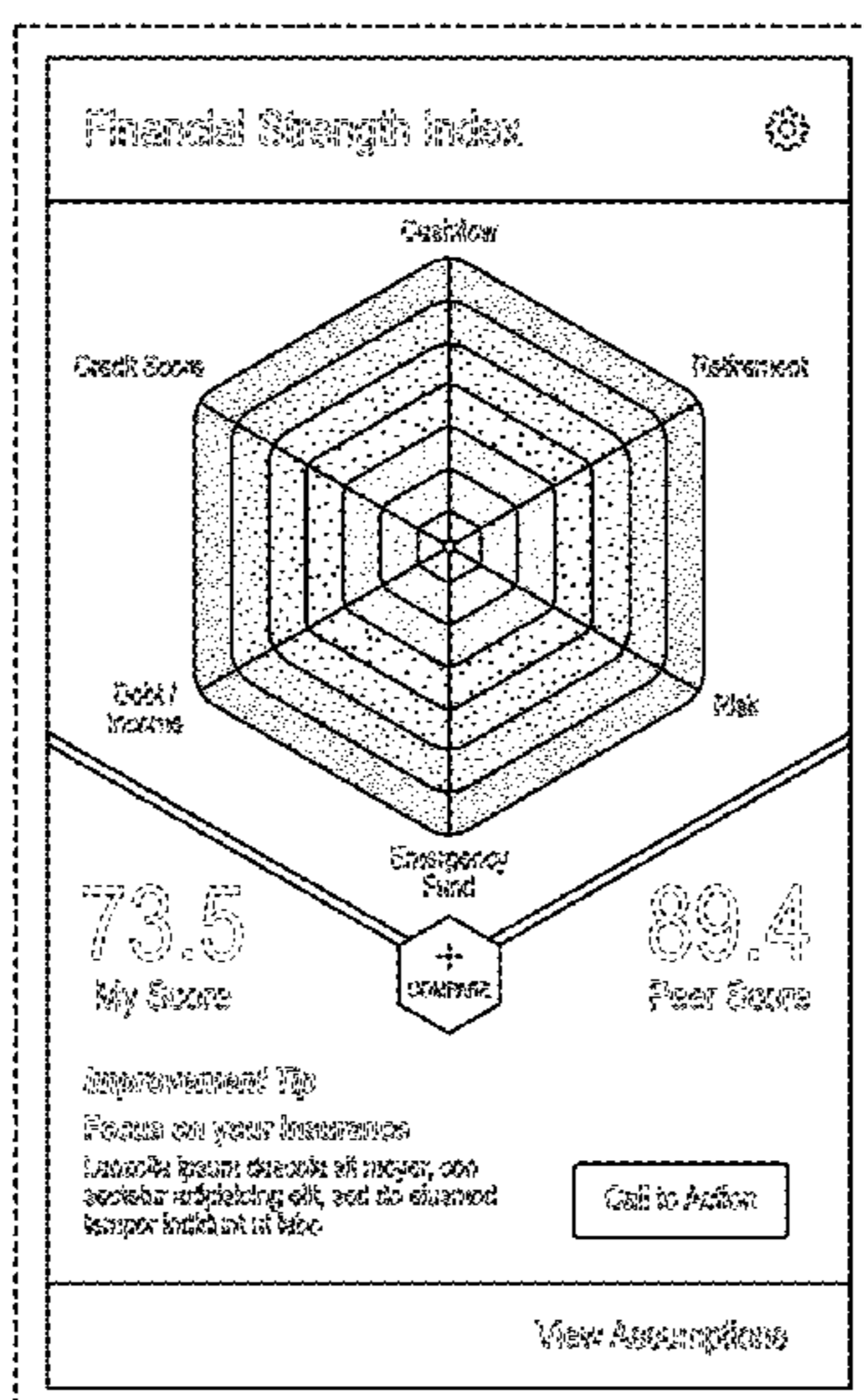
FIG. 1 is a front view of a display screen or portion thereof
with graphical user interface showing our new design; and,
FIG. 2 is a front view of a second embodiment thereof.

The stippling patterns shown in portions of FIG. 2 illustrate
different areas of contrasting appearance.

display screen portion and forms no part of the claimed
design.

The remaining broken lines illustrate portions of a graphical

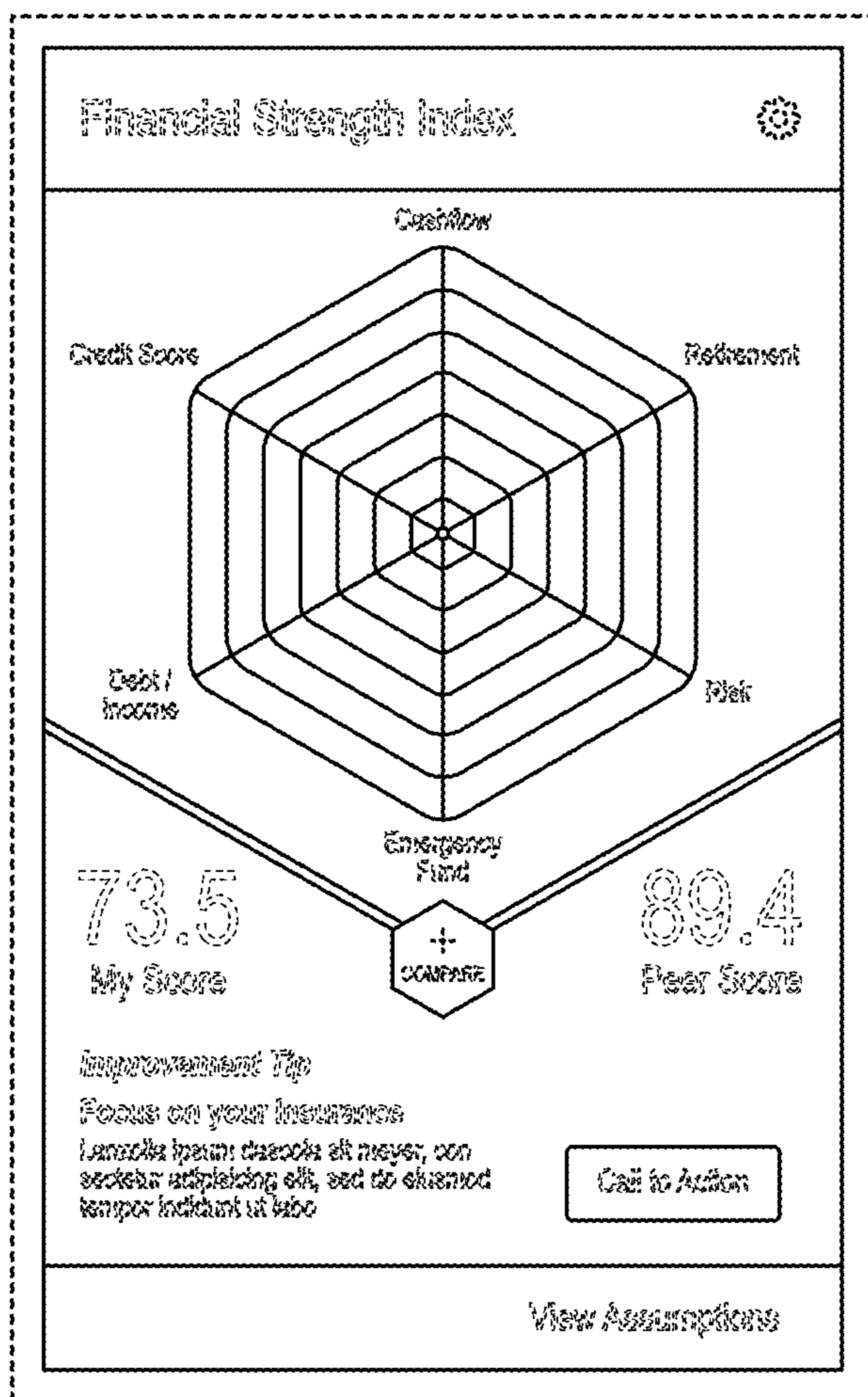

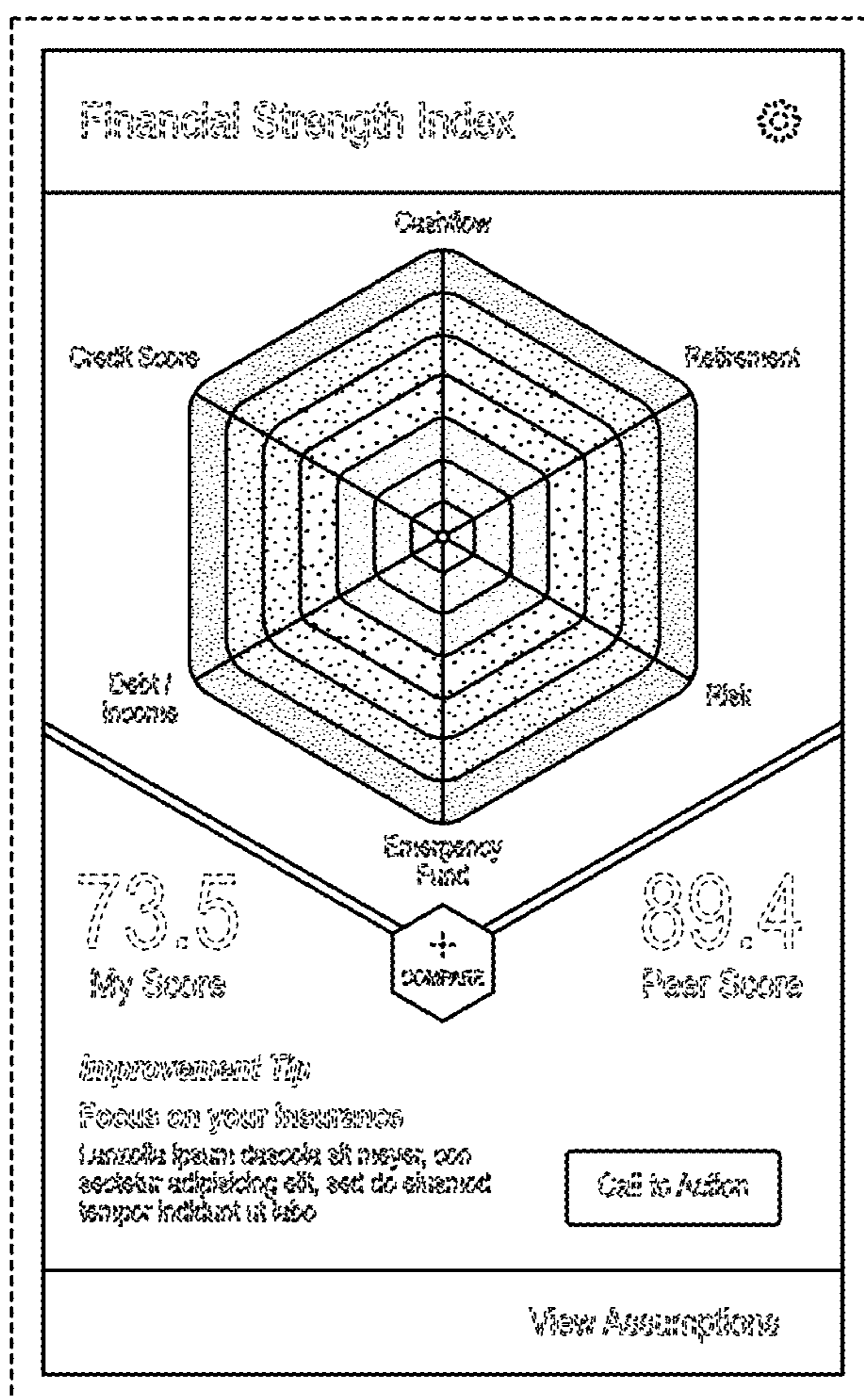
