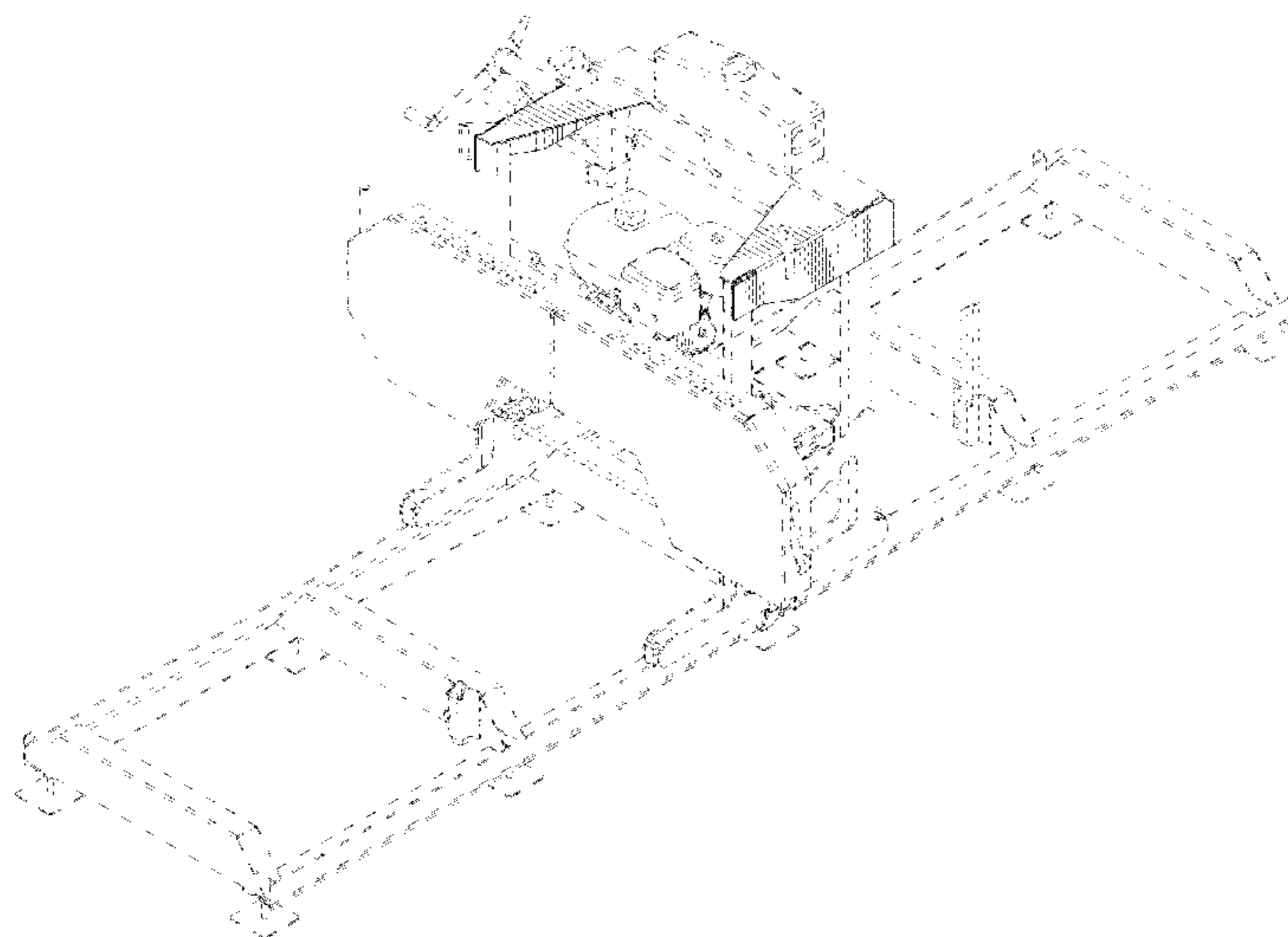
FIG. 1 is a top front perspective view of a portable sawmill

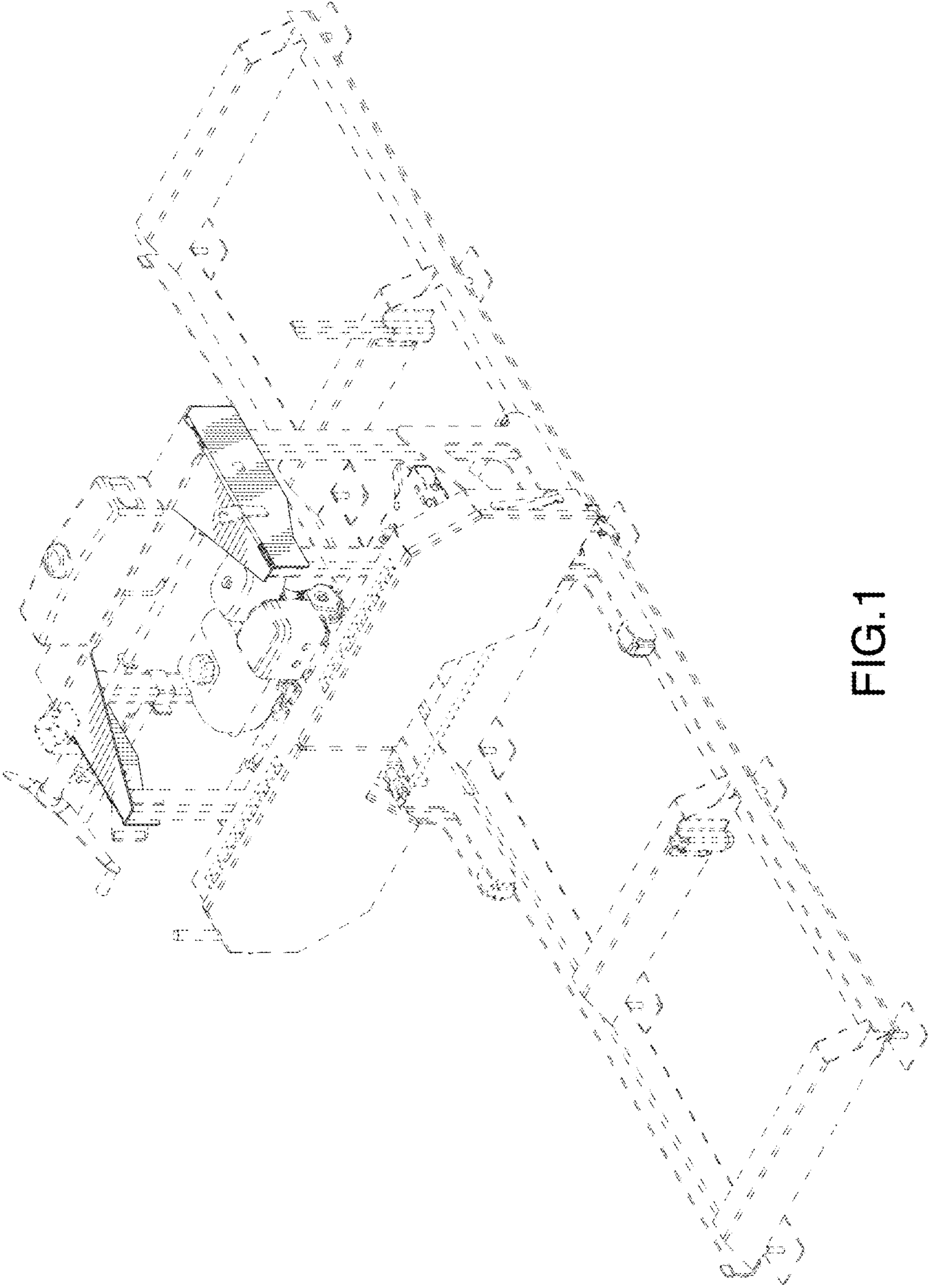

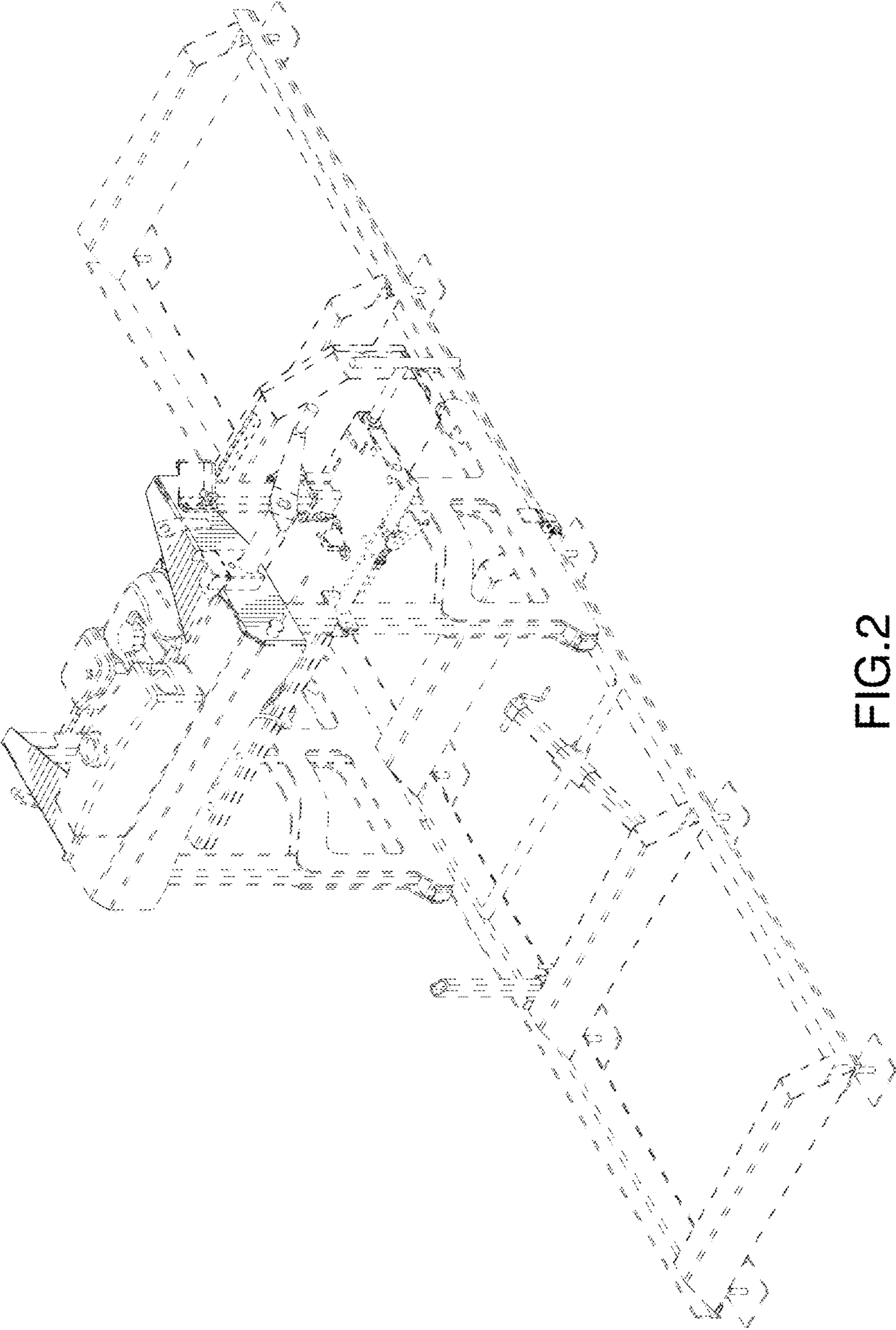

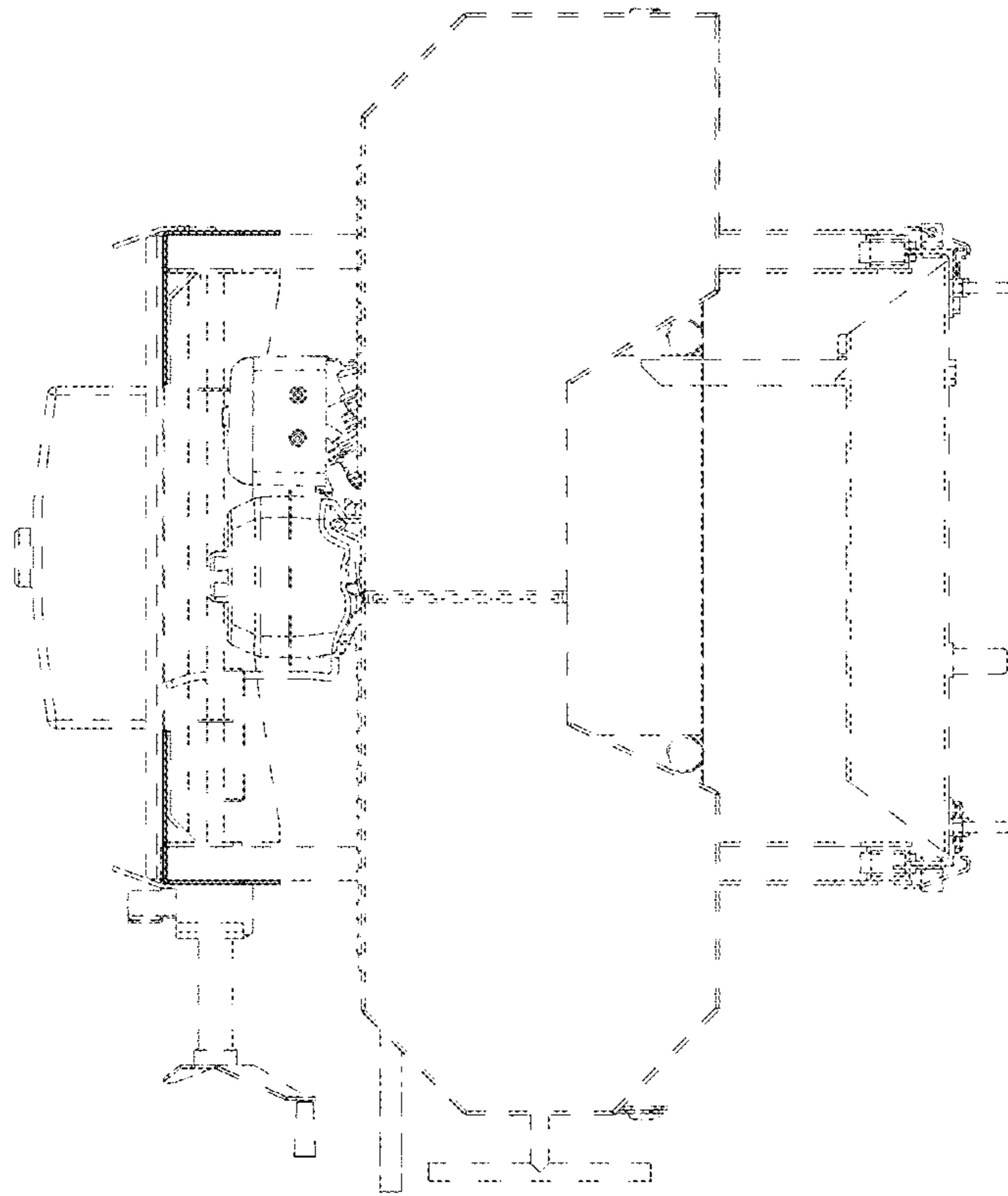

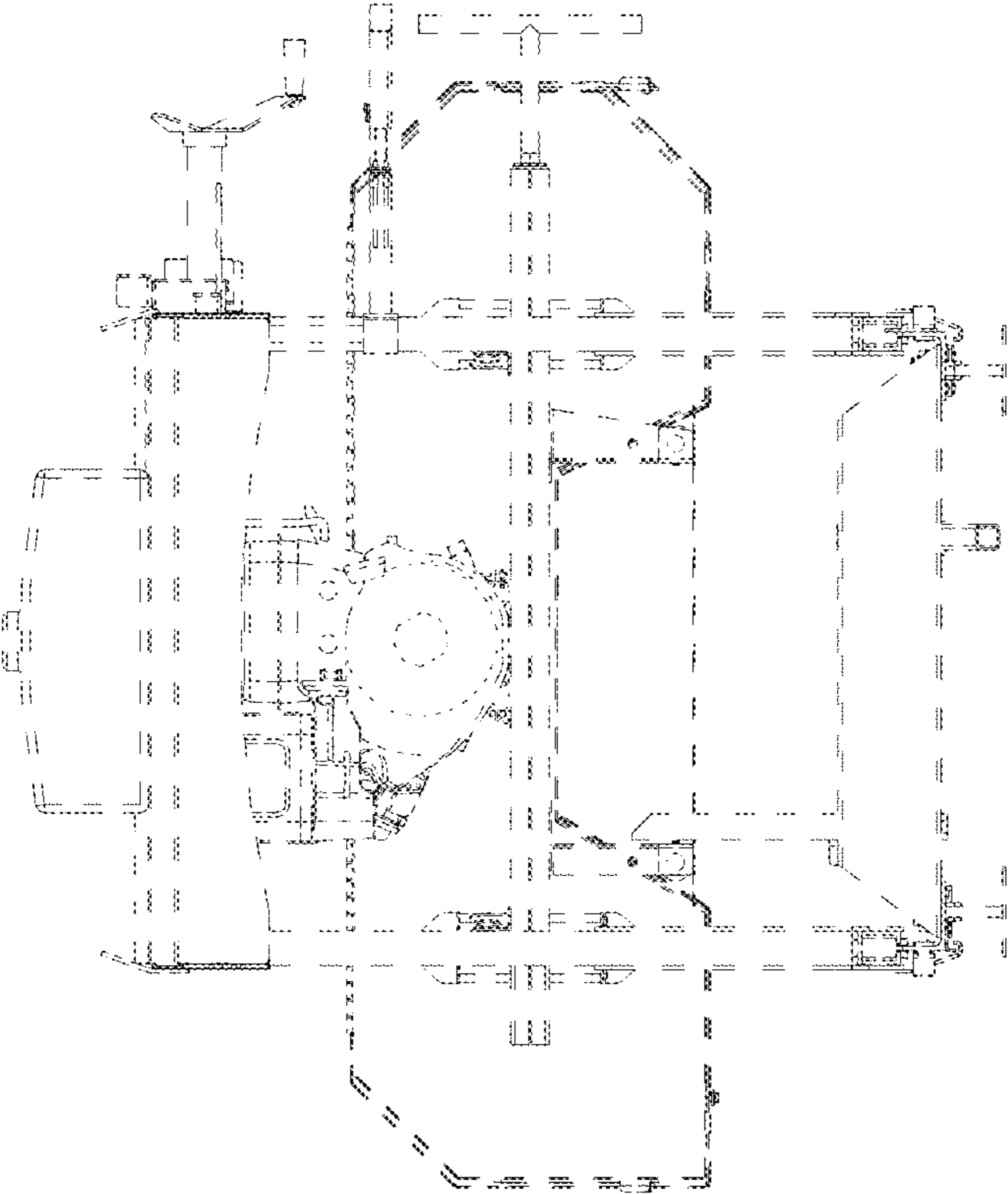

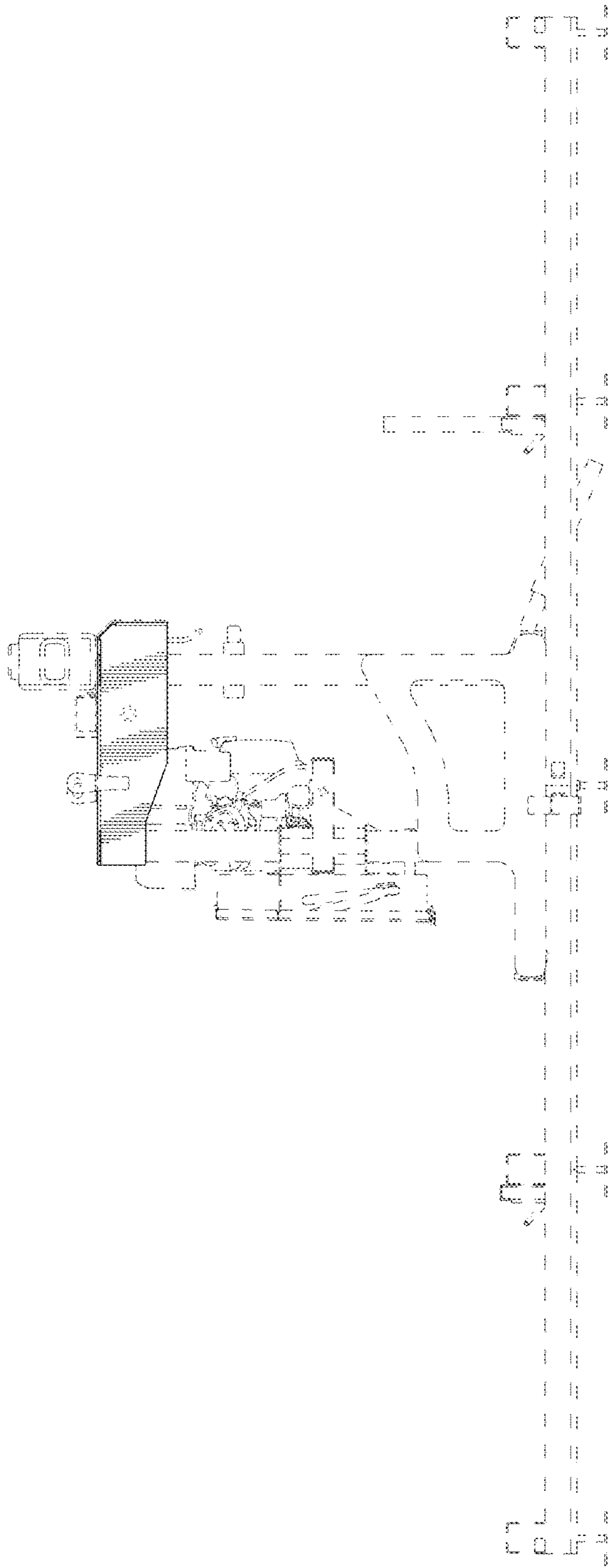

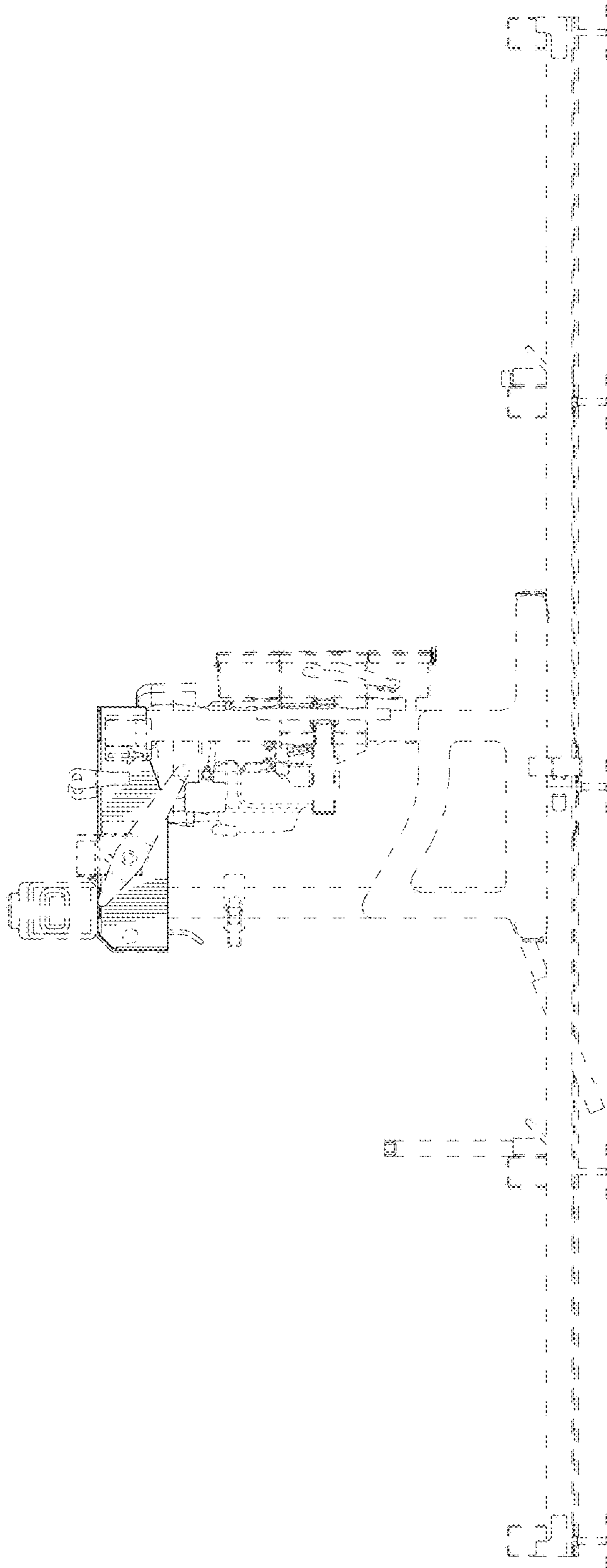

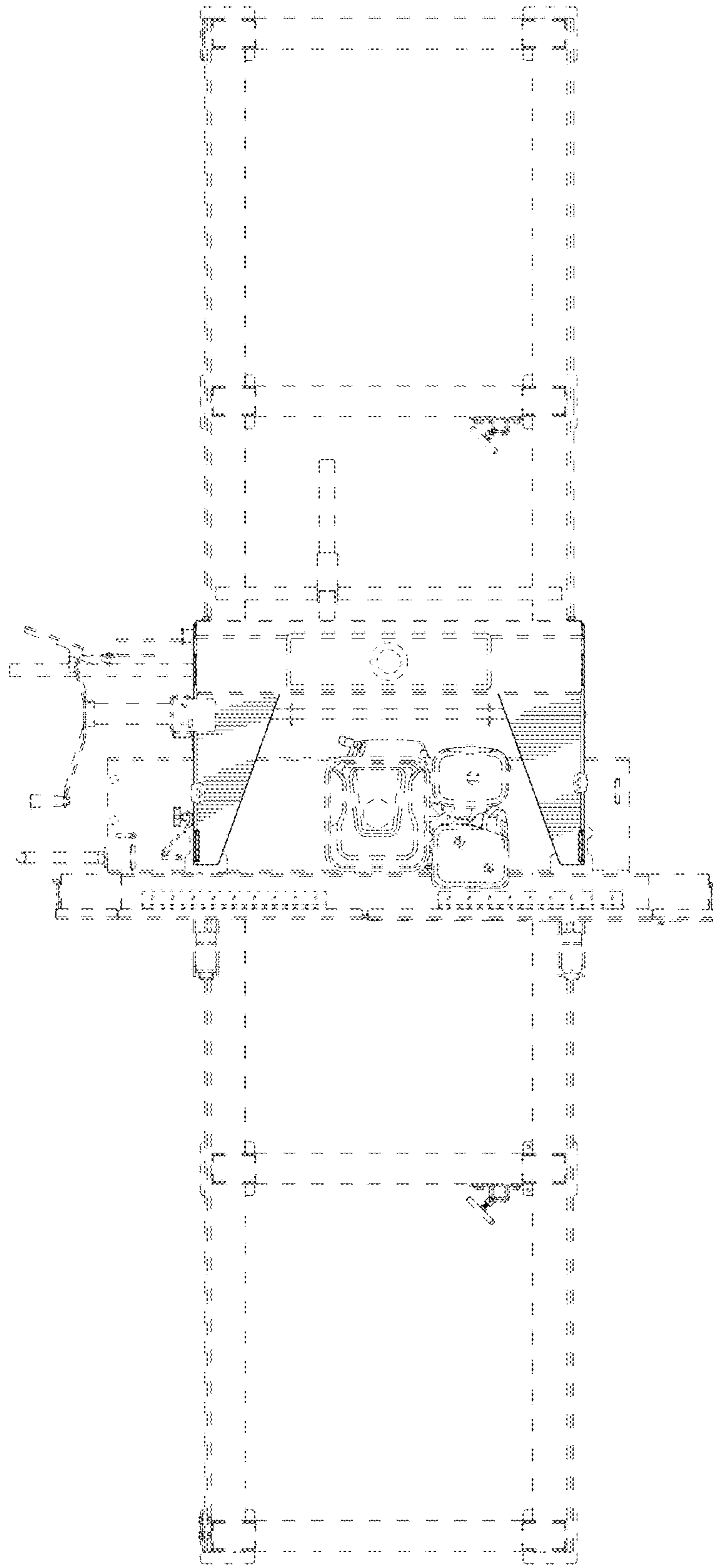

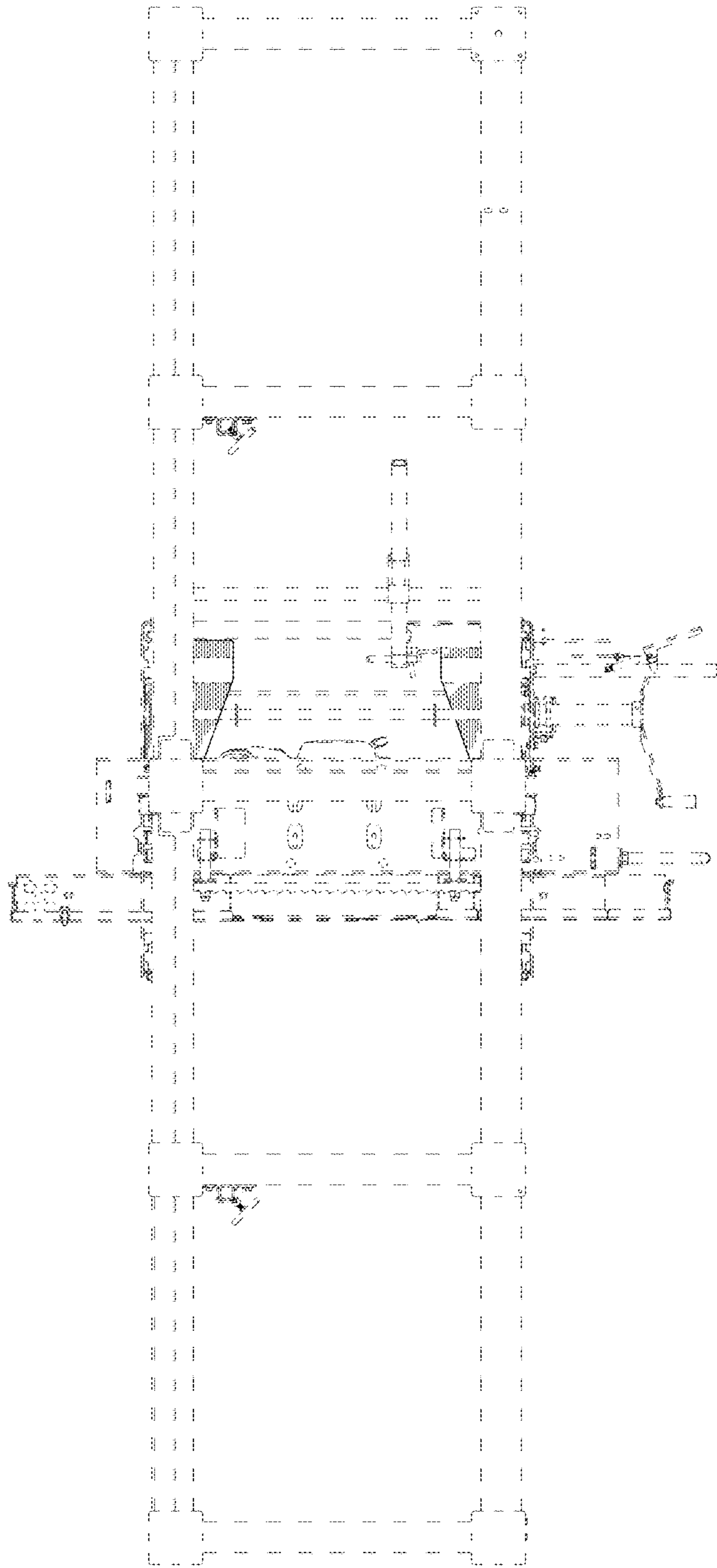
